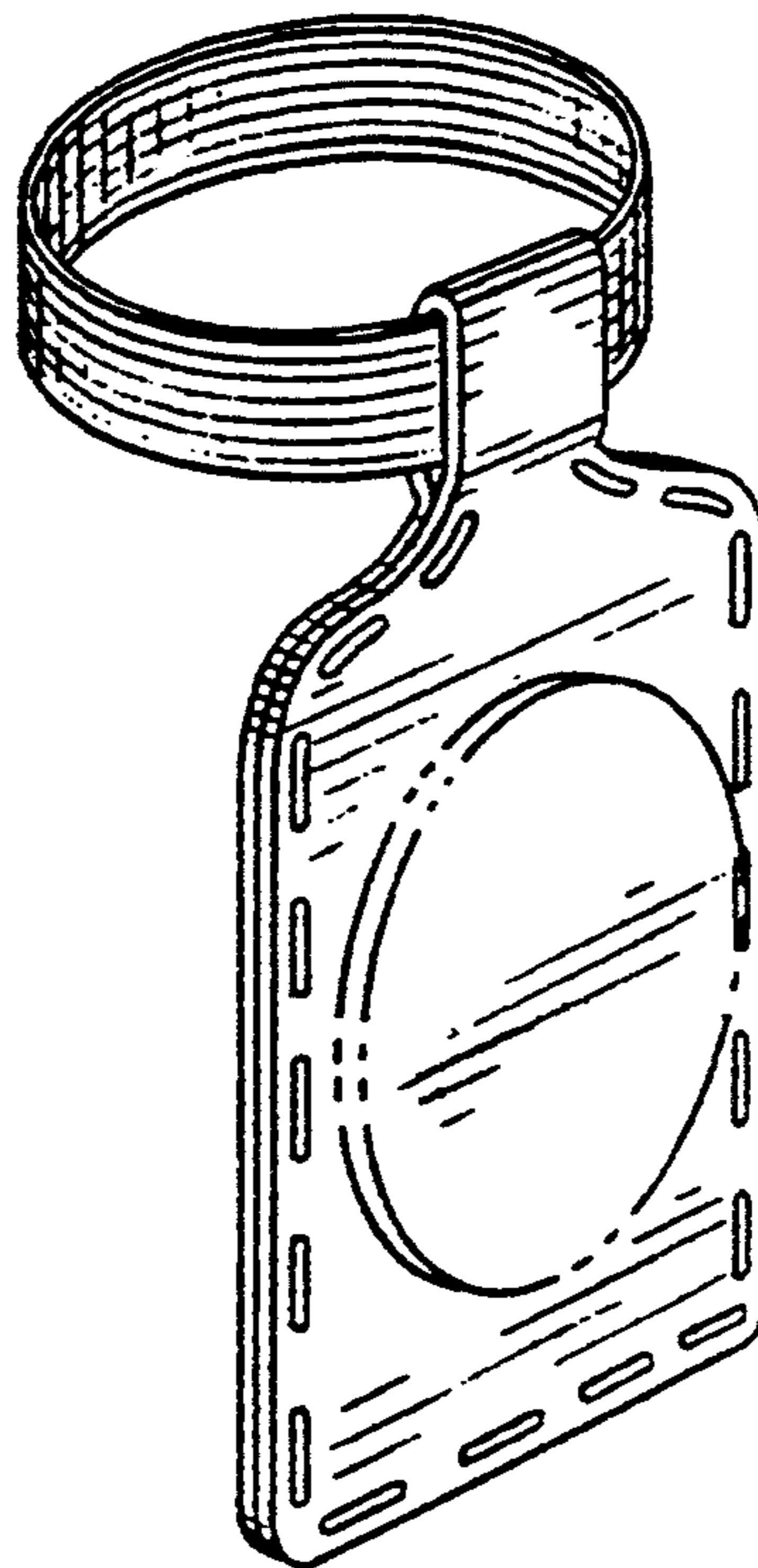

The ornamental design for a headlight reminder indicating tag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a headlight reminder indicating tag showing my new design and showing in broken lines a fob included for illustrative purposes only;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a bottom view thereof.



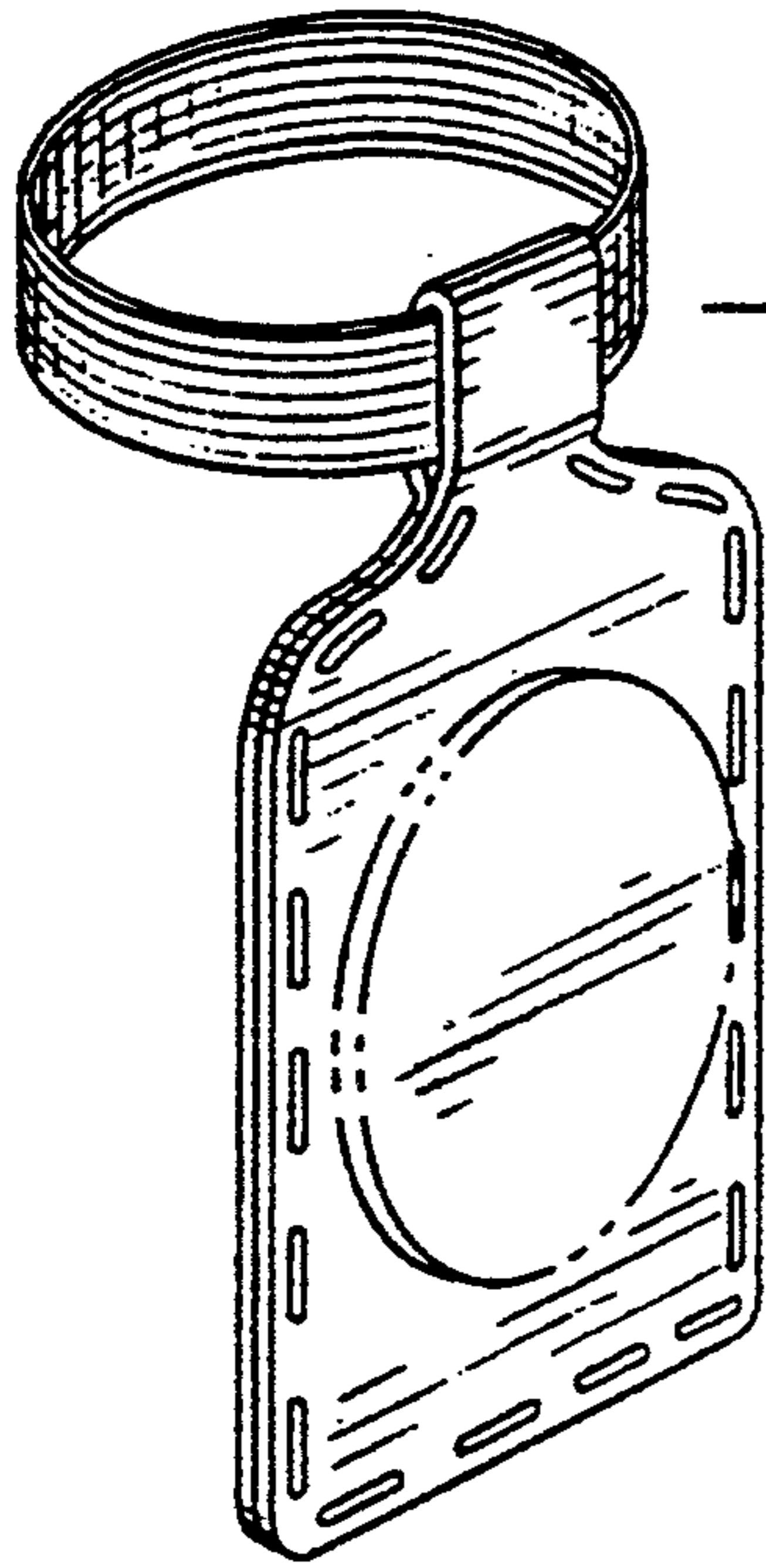

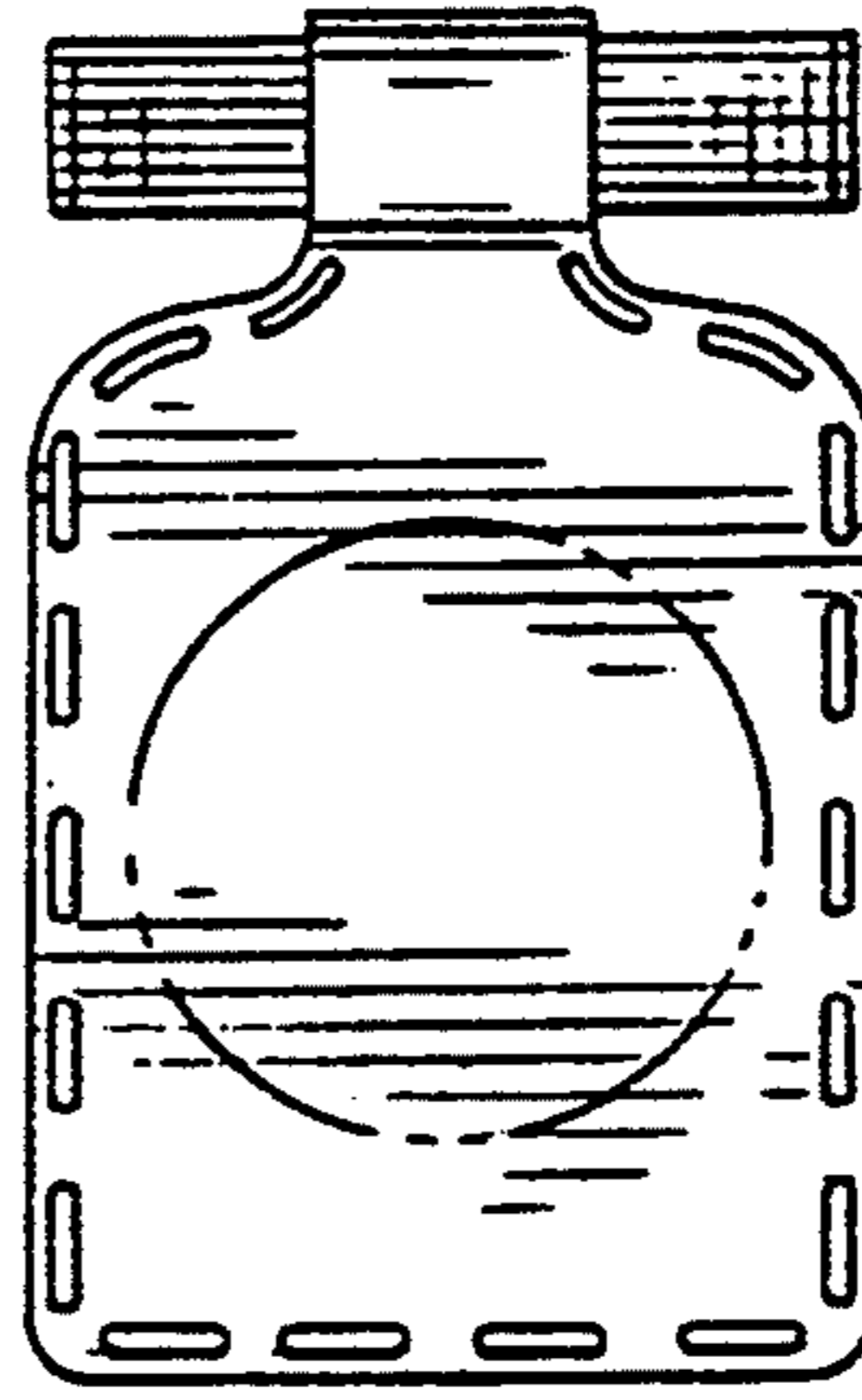

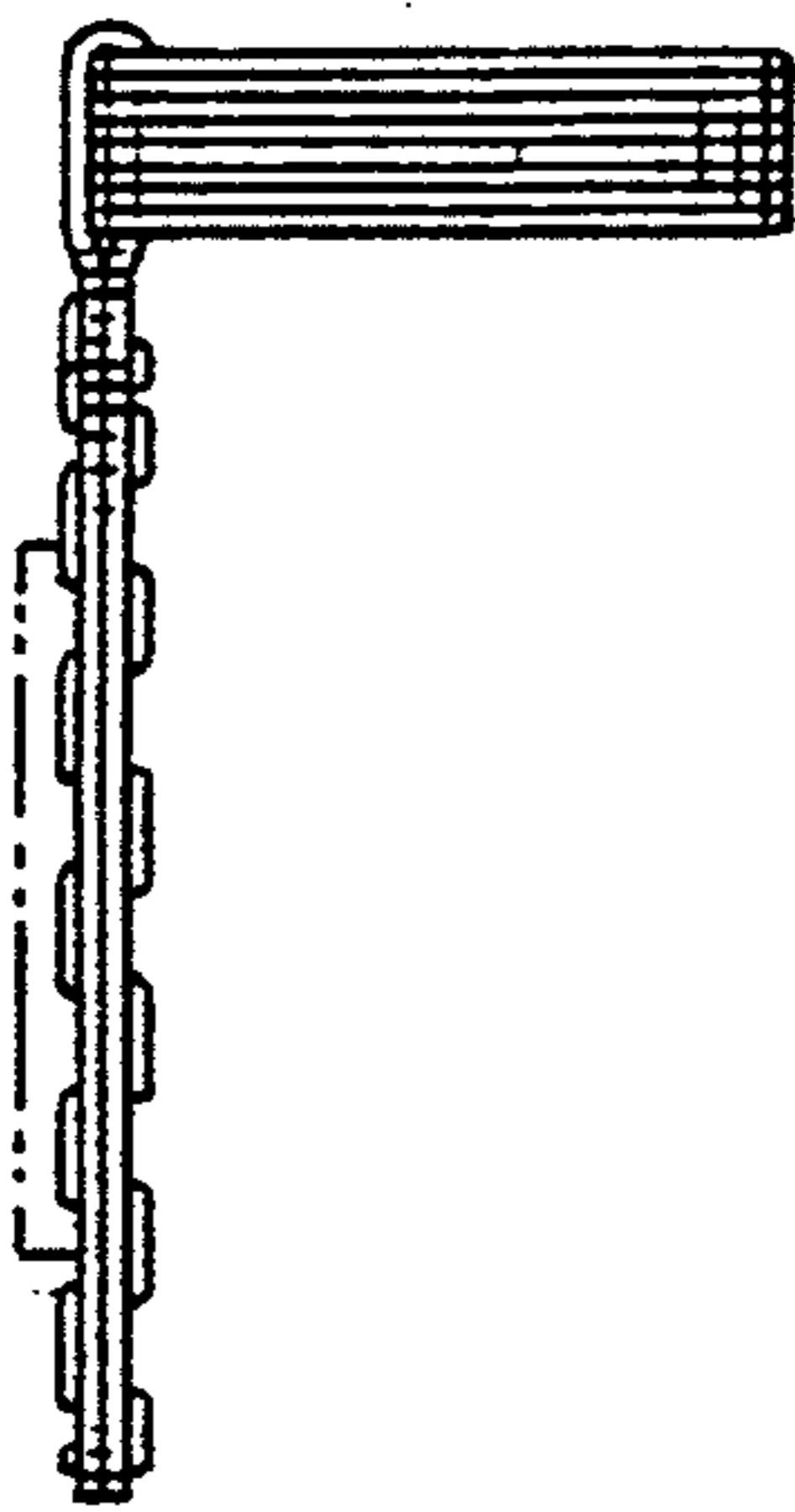

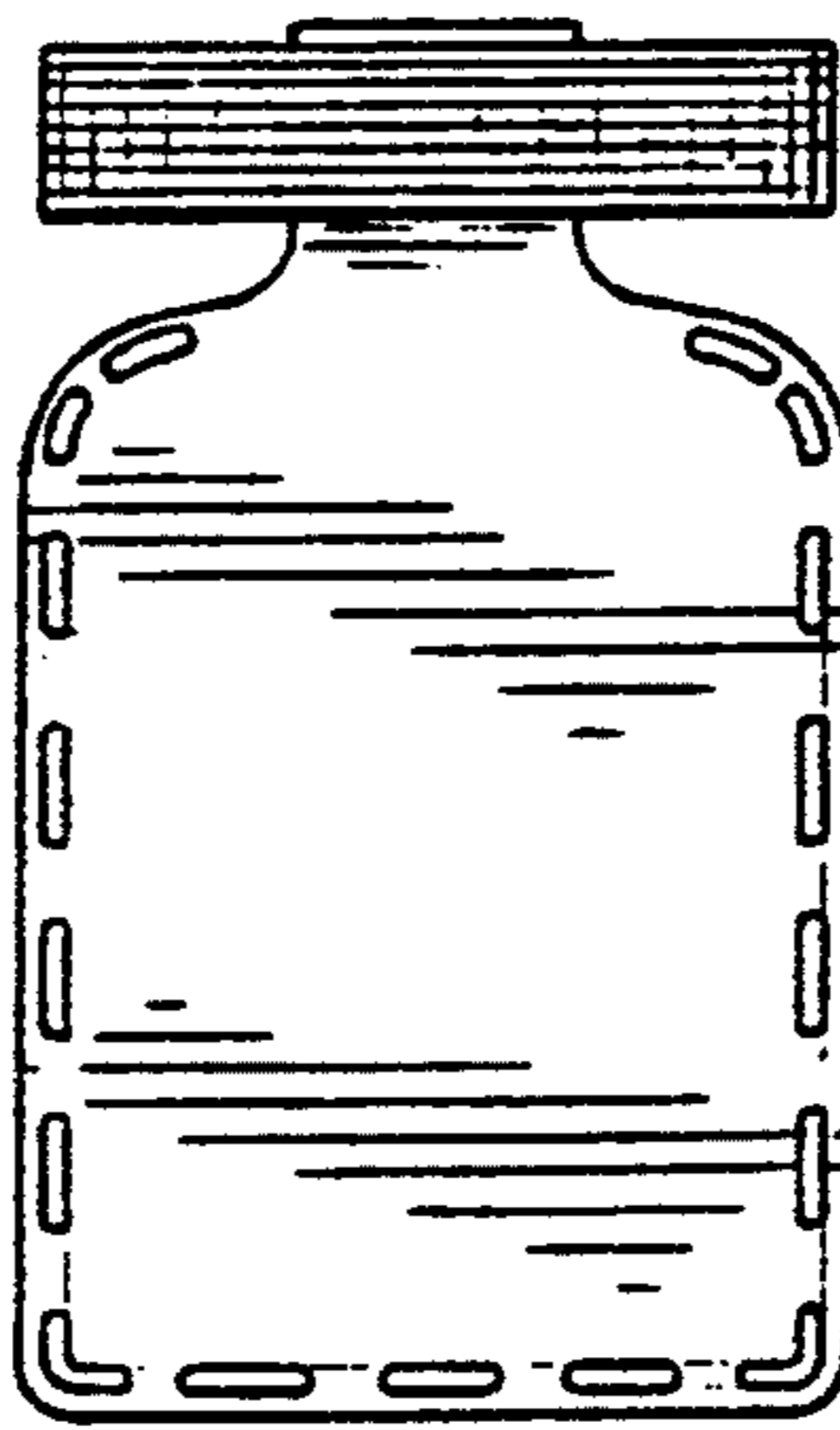

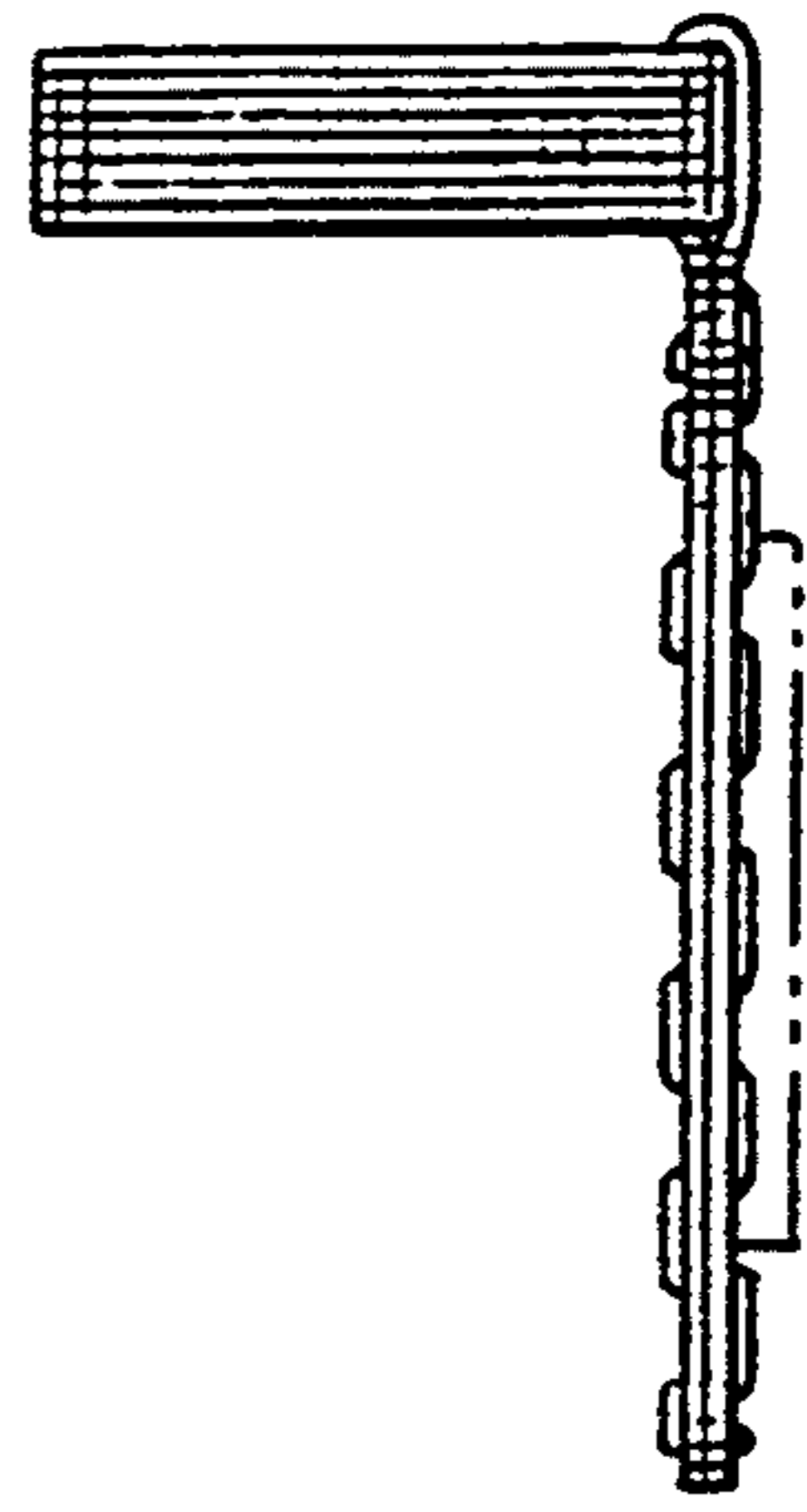

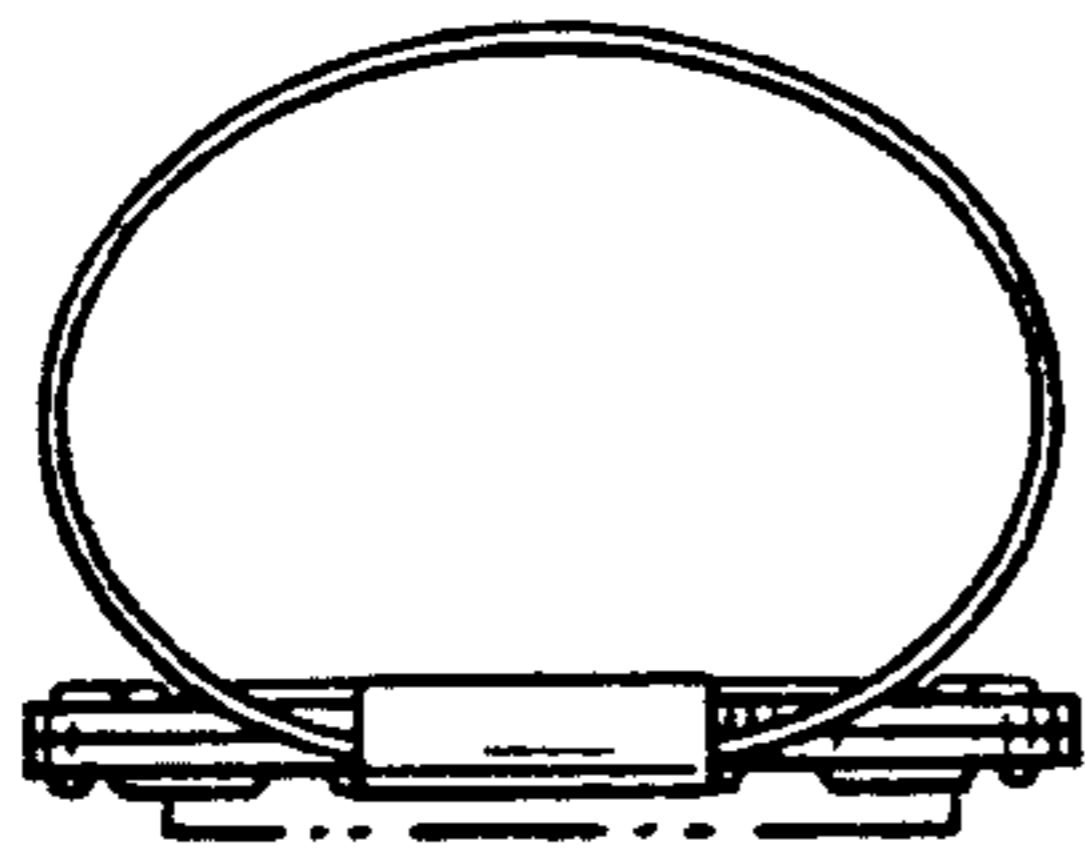

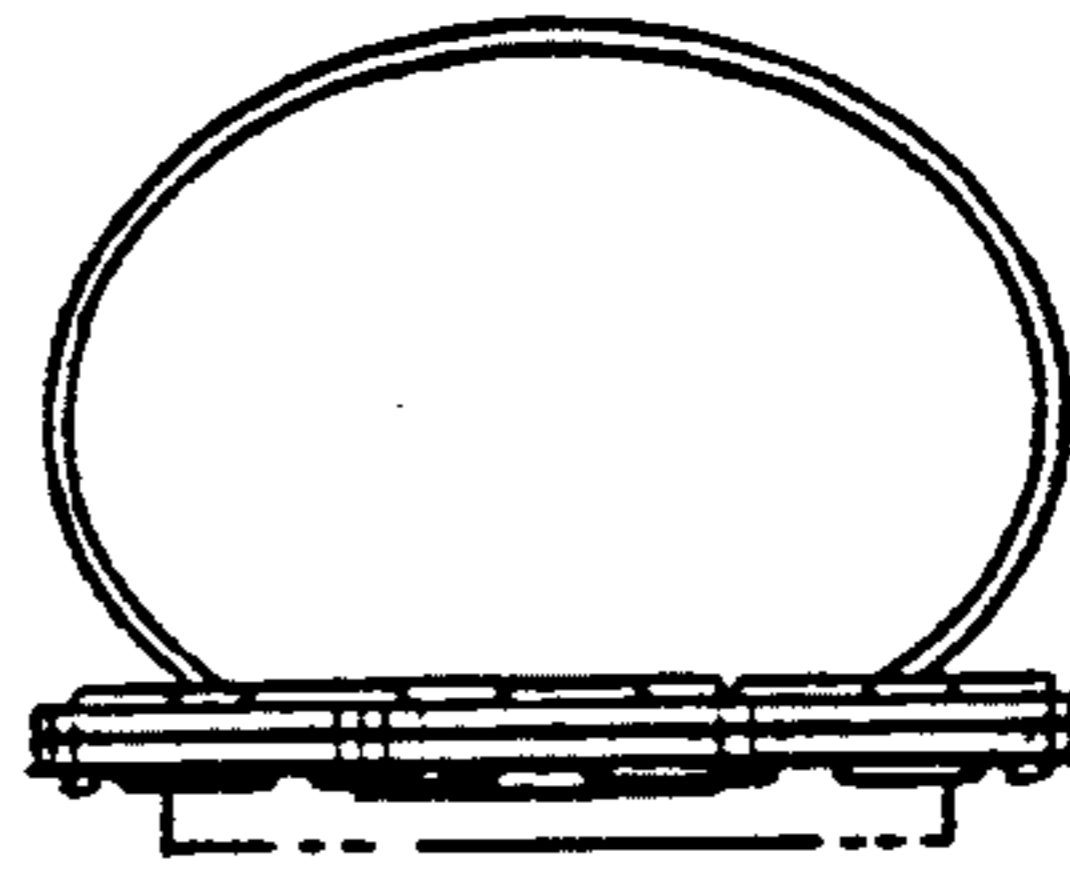
