[57] CLAIM

The ornamental design for a rugby football, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a rugby football showing my new design;
FIG. 2 is a side view thereof, rotated about 90°, about a longitudinal centerline with respect to FIG. 1;
FIG. 3 is an end view thereof;
FIG. 4 is a side view thereof, rotated about 135°;
FIG. 5 is an end perspective view thereof;
FIG. 6 is an end perspective view thereof, rotated 45°;
FIG. 7 is a side view thereof, rotated about 30°;
FIG. 8 is a side view thereof, rotated about 120°; and
FIG. 9 is a side view thereof, rotated about 45°;
FIG. 10 is a bottom end perspective view of a second alternate embodiment;
FIG. 11 is a side view thereof, rotated about 45°;
FIG. 12 is an end view thereof; and
FIG. 13 is a side view thereof, rotated about 90°. The stipple shading on the football depicts color.

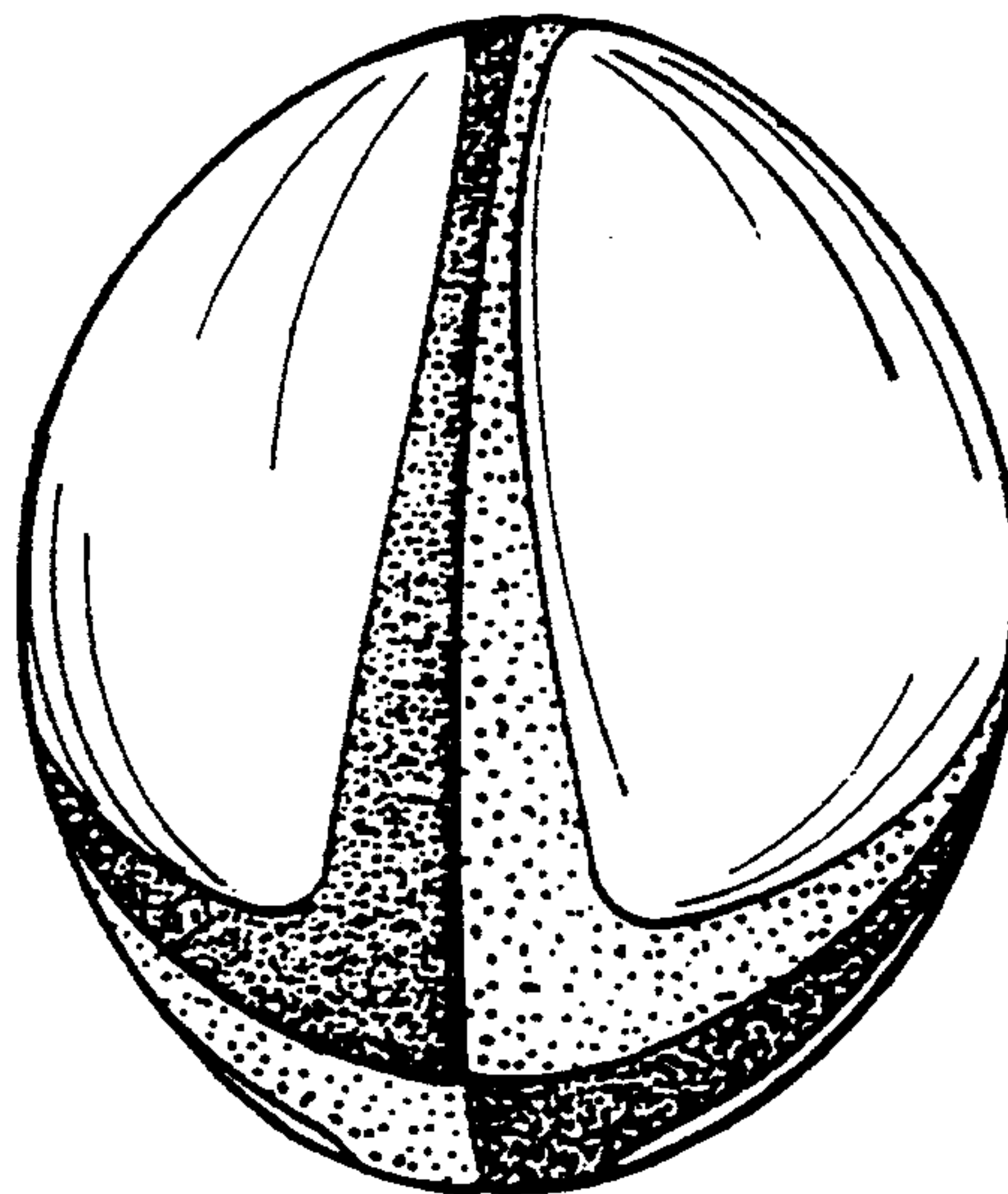
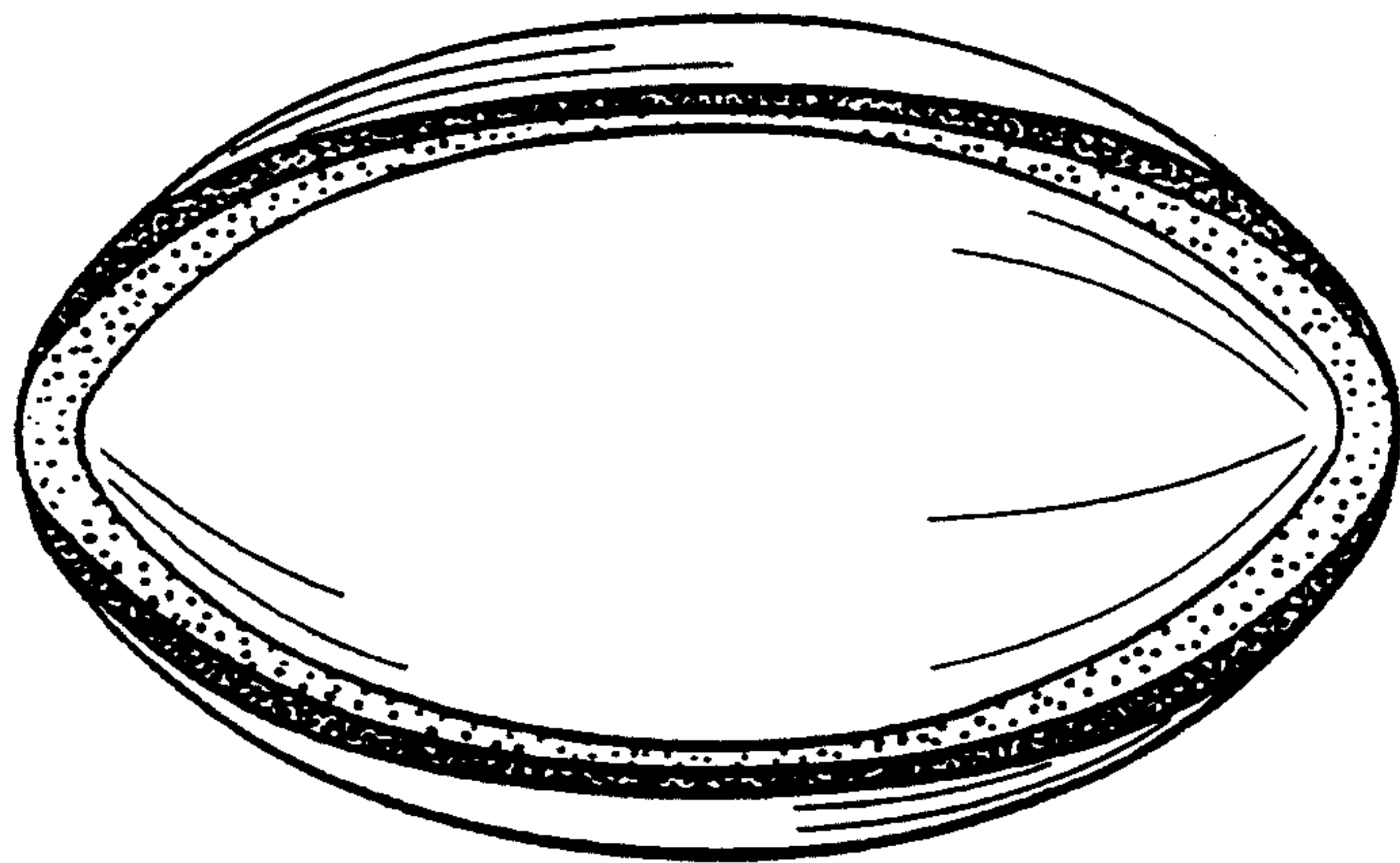

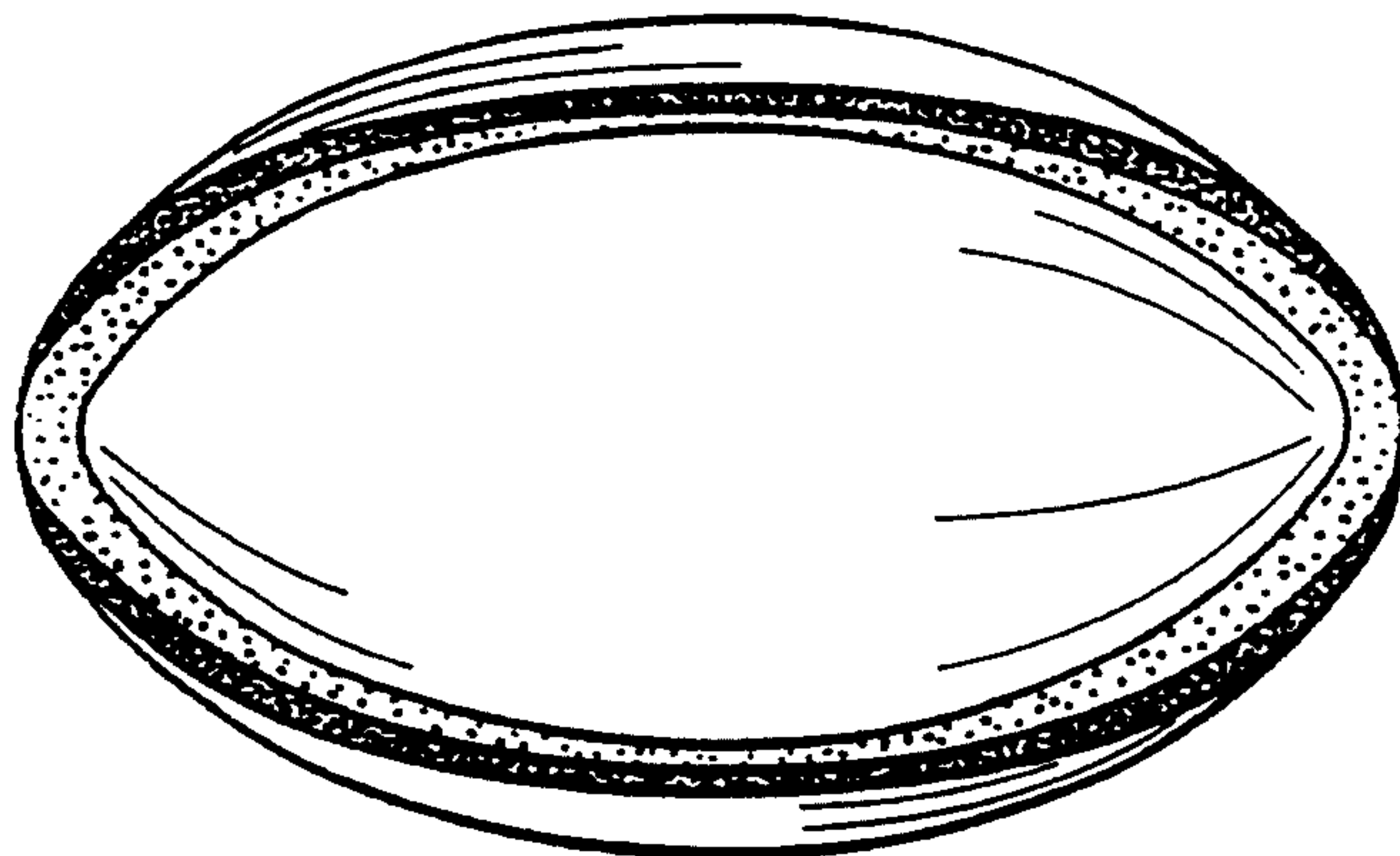

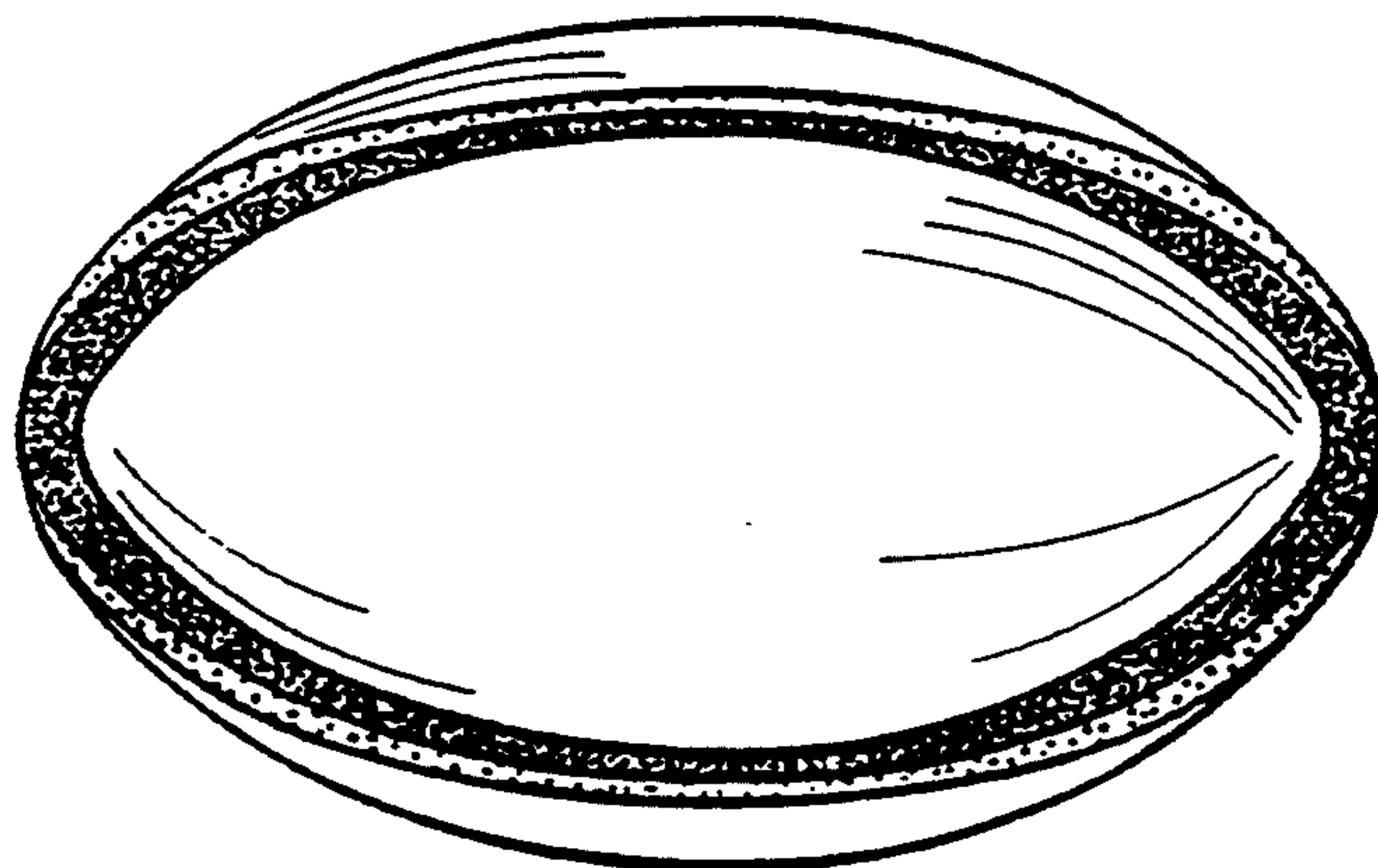

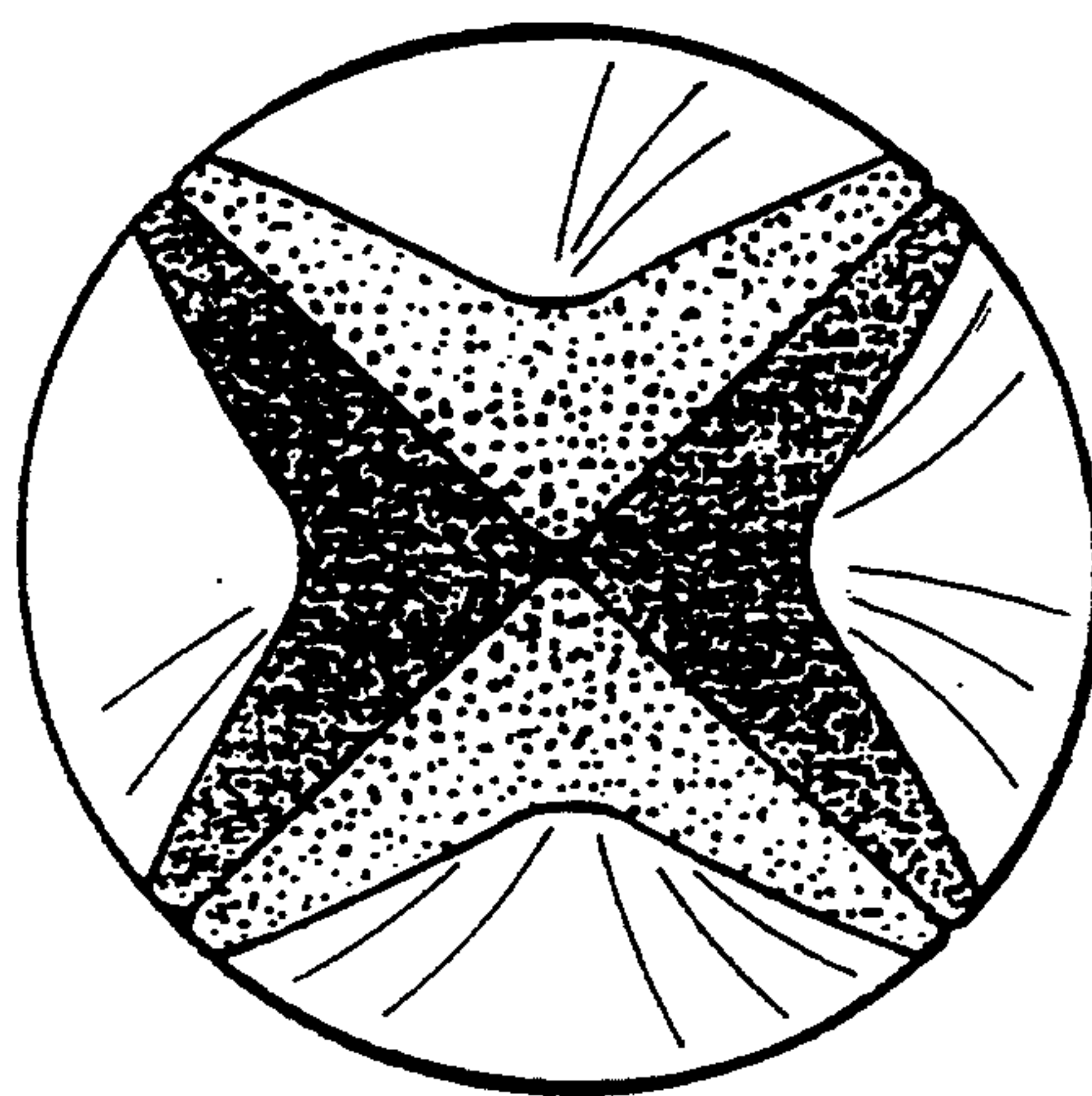

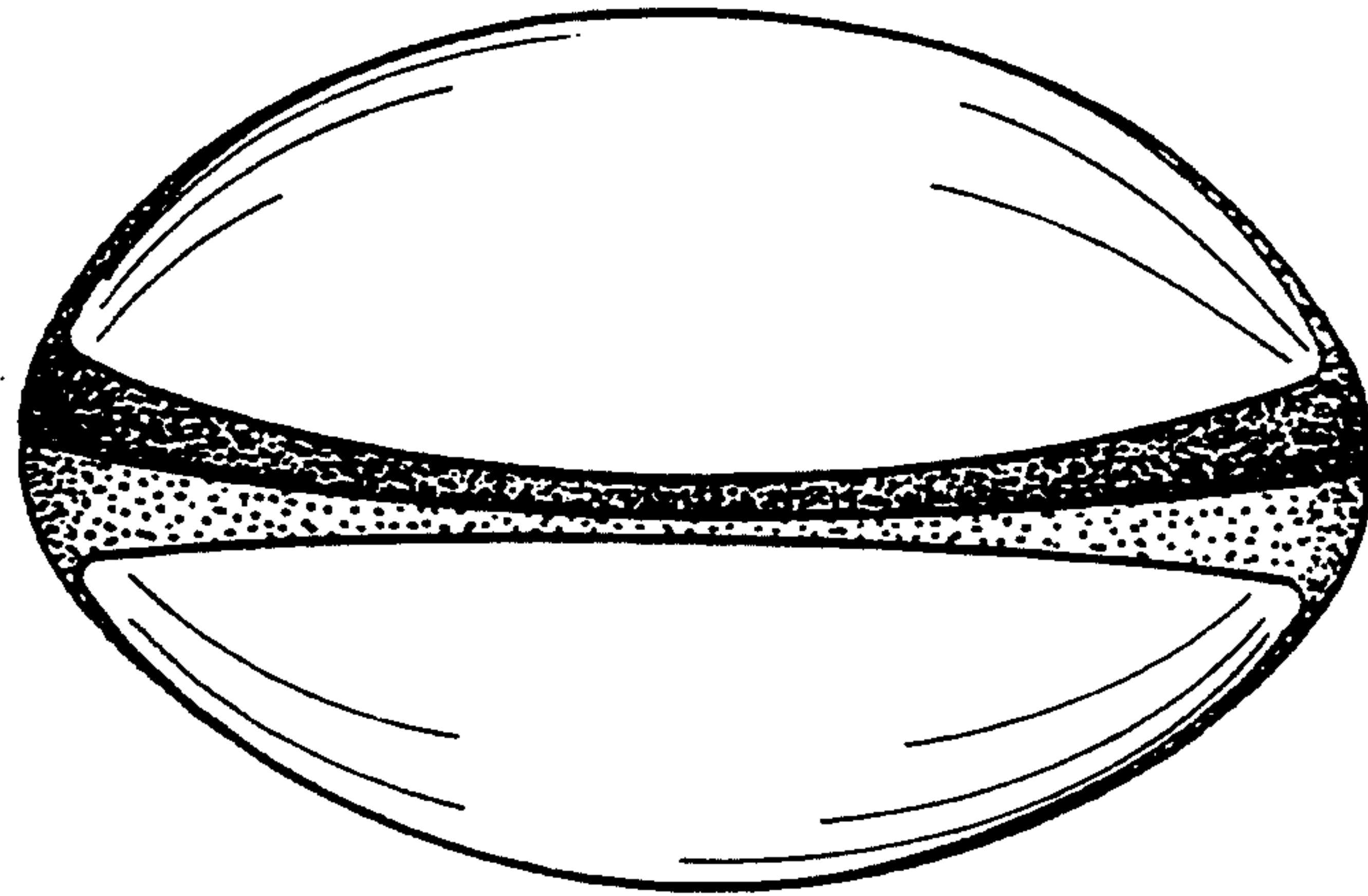

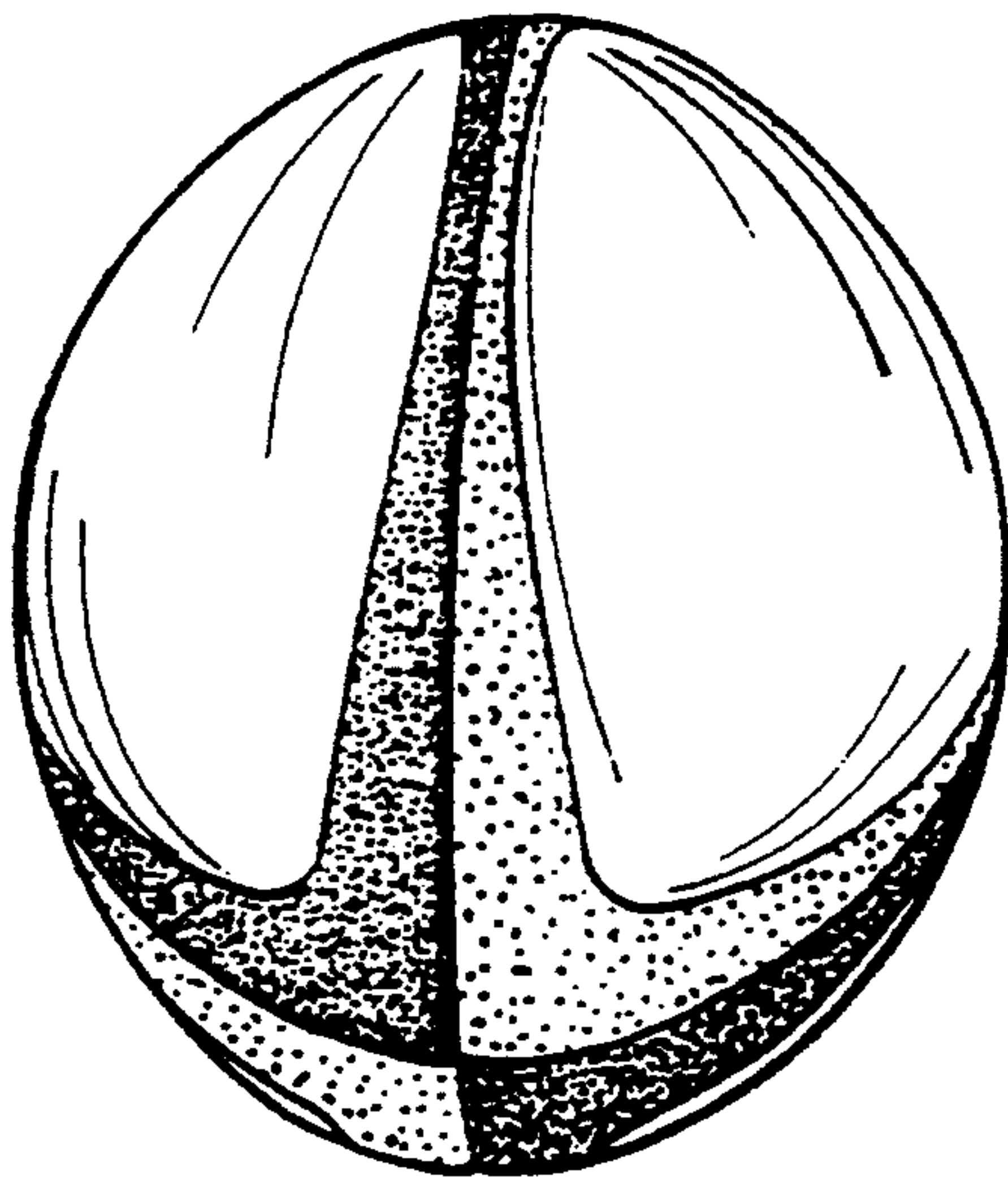

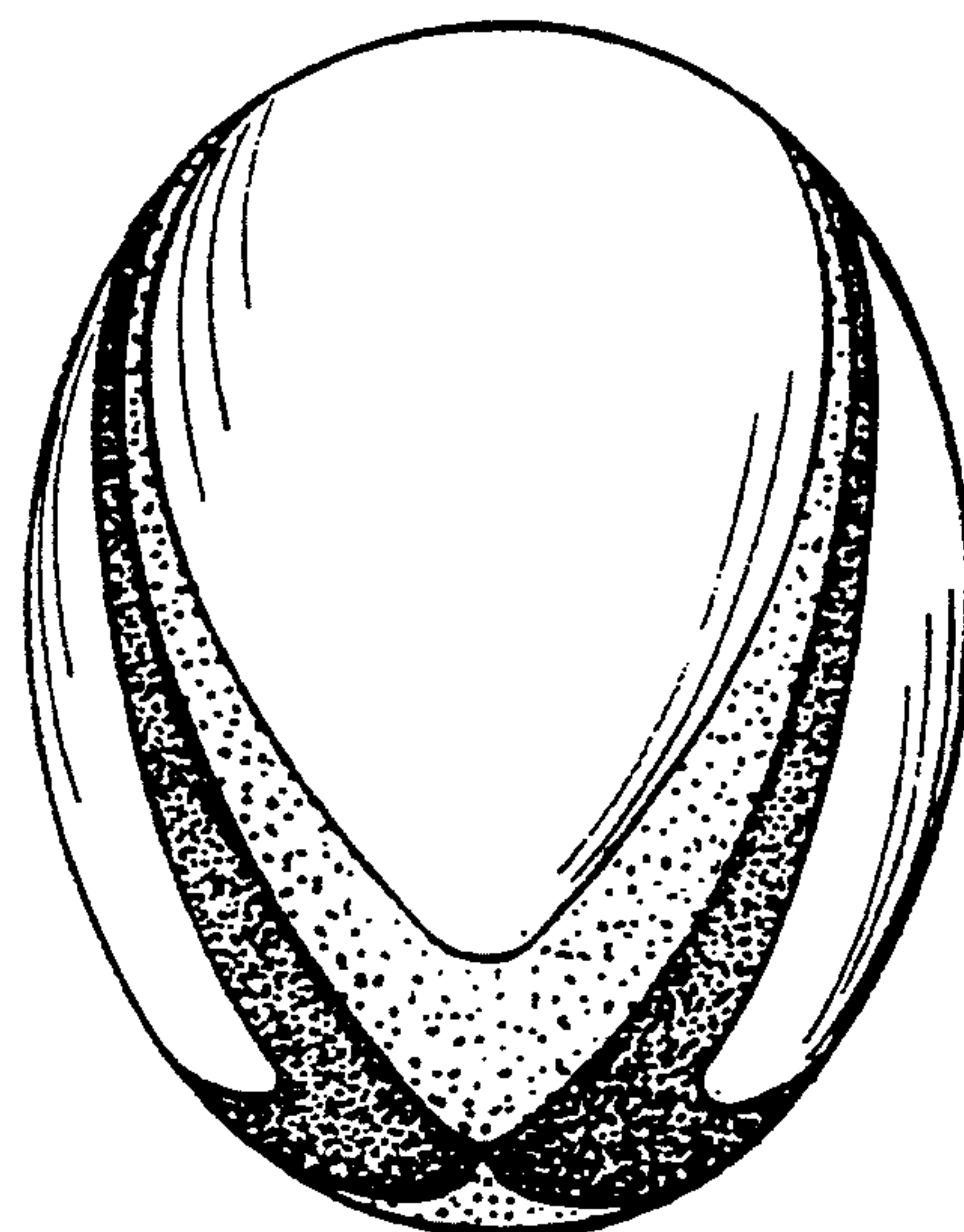

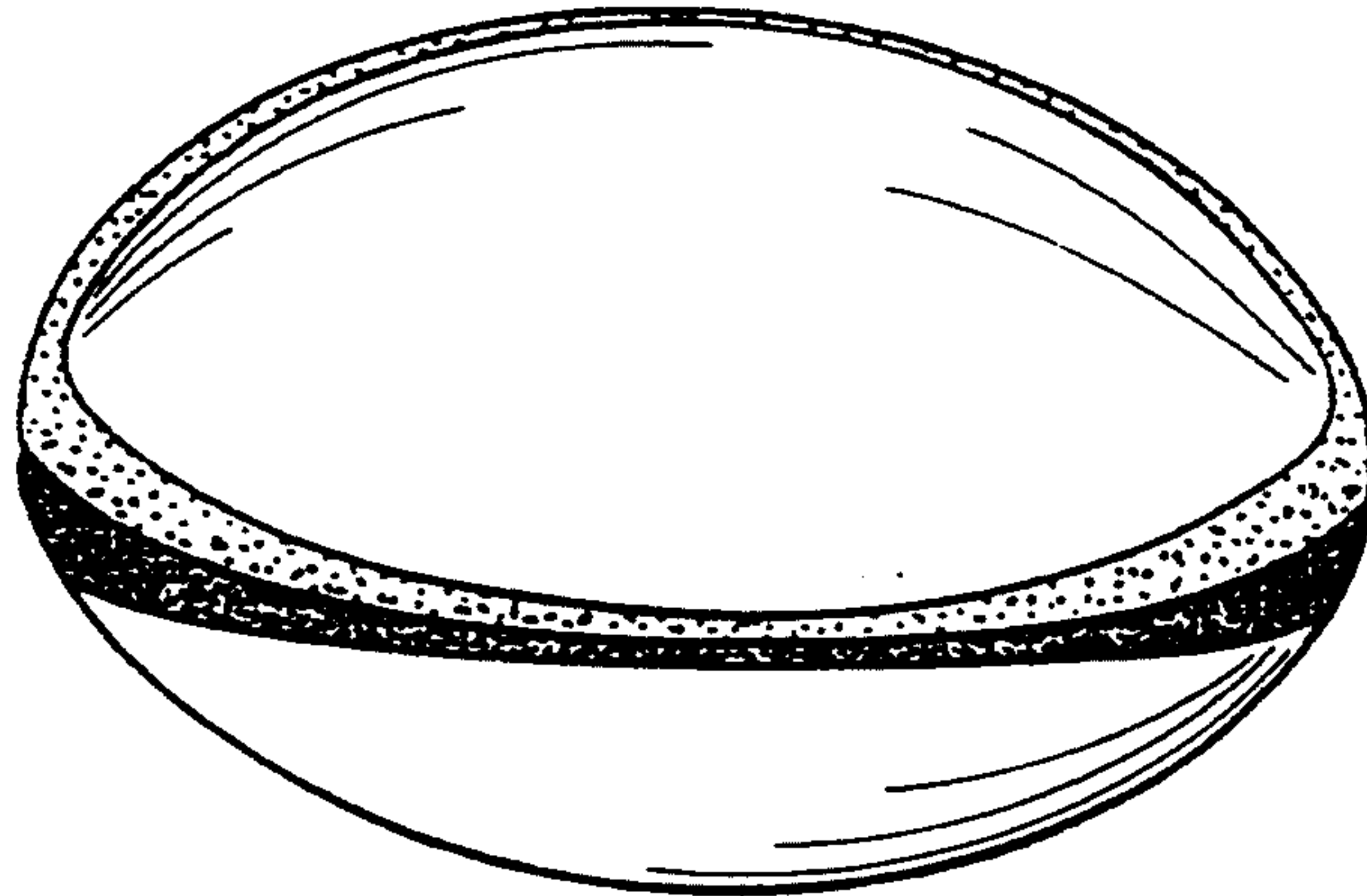

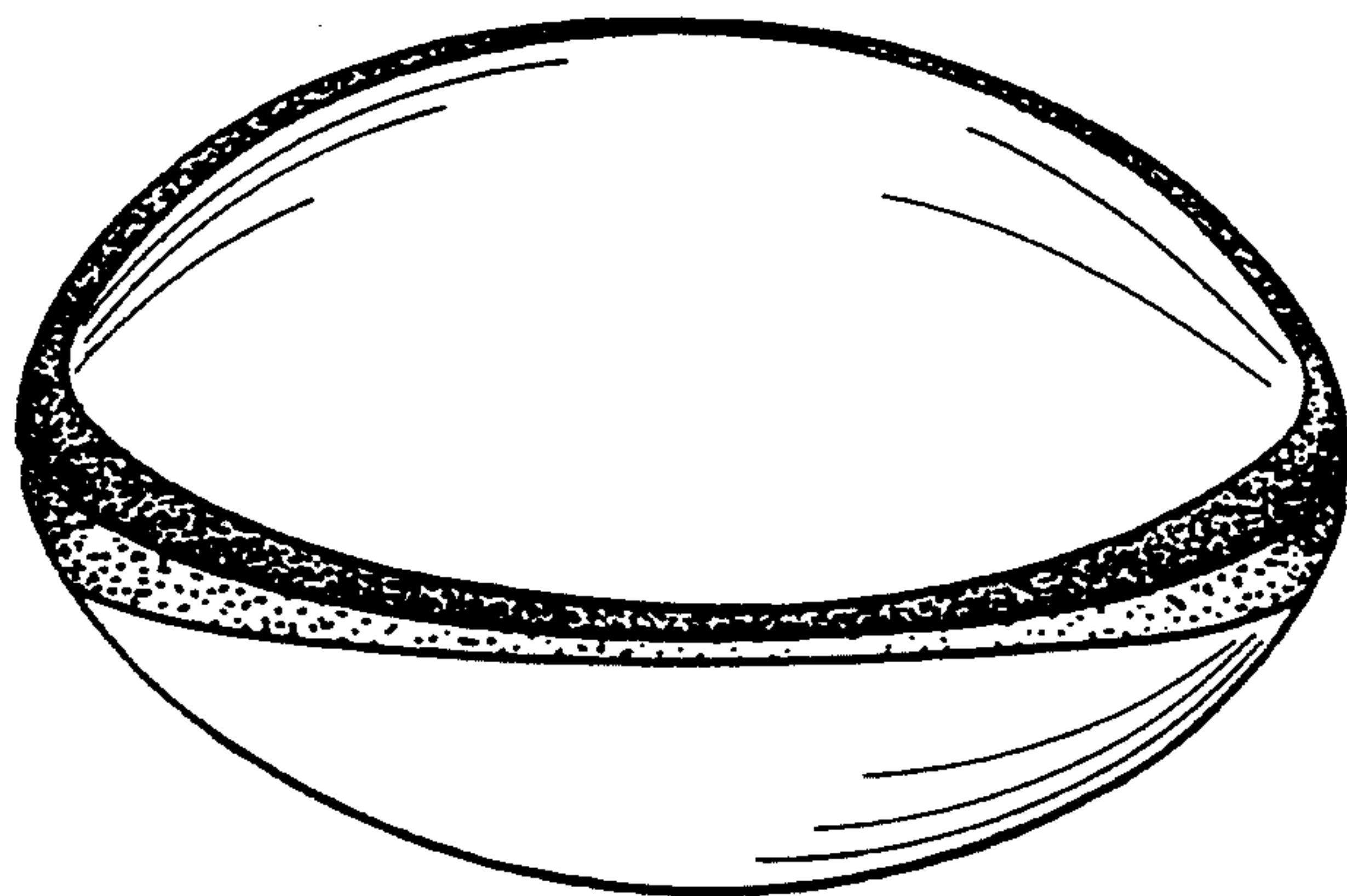
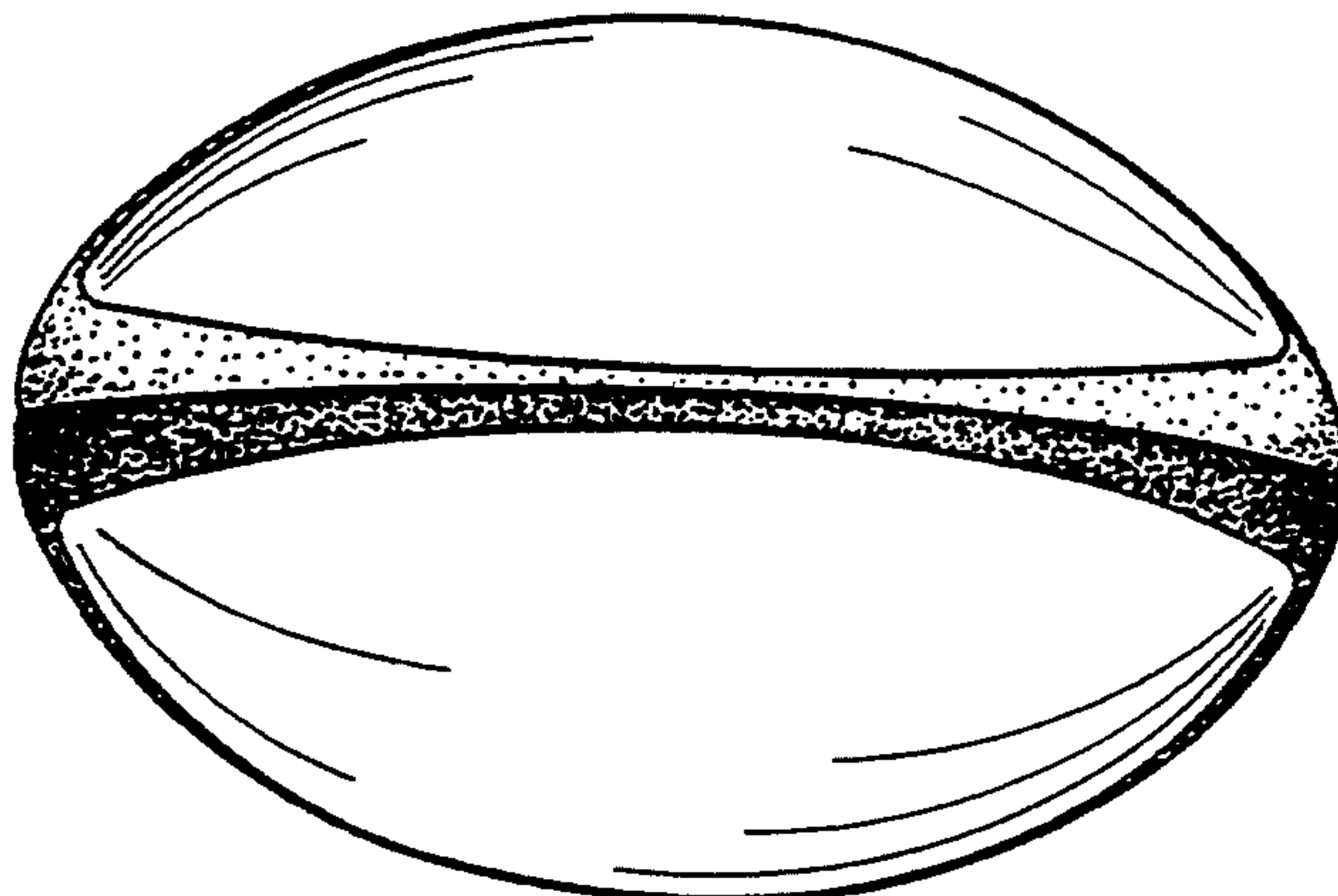

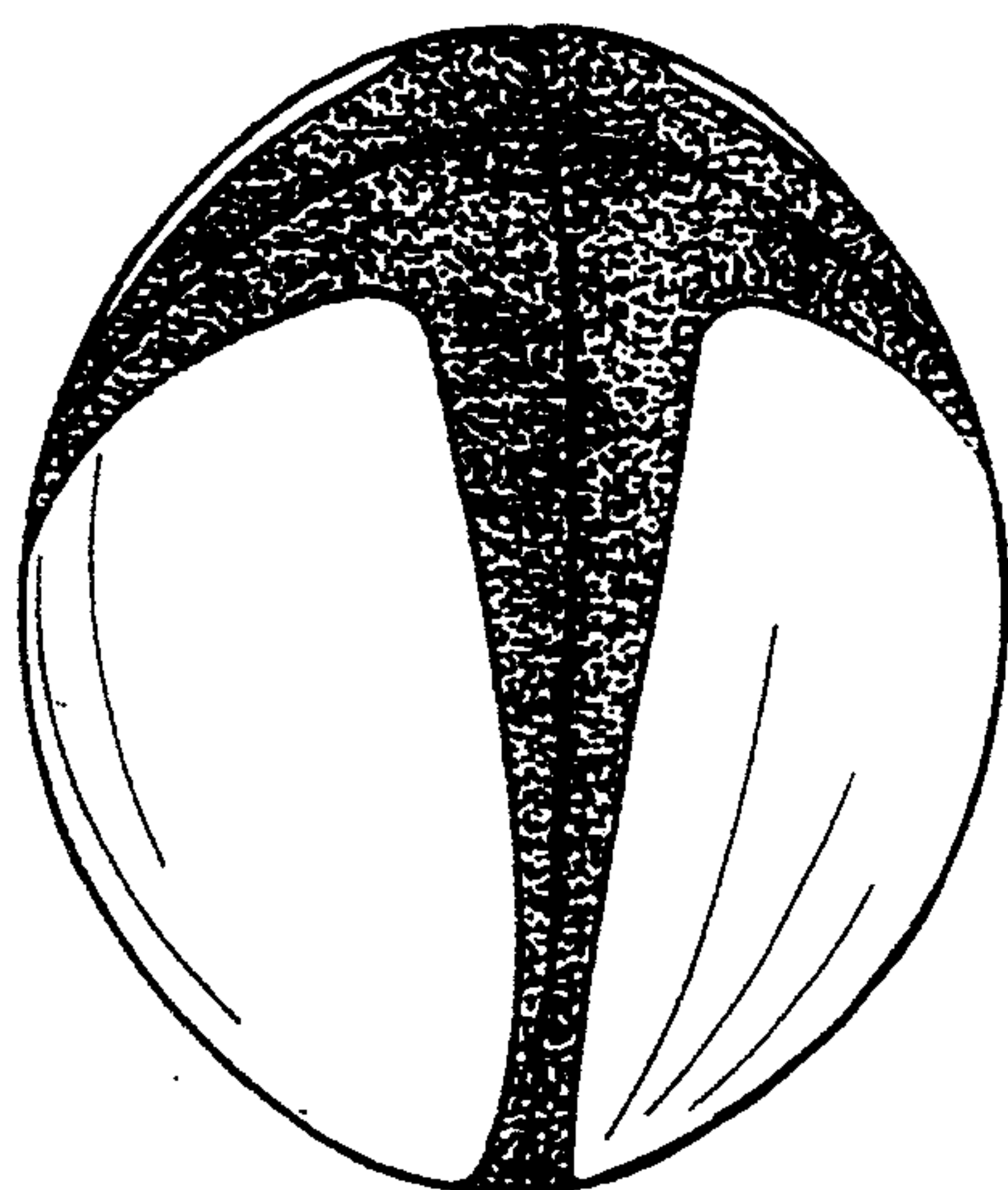

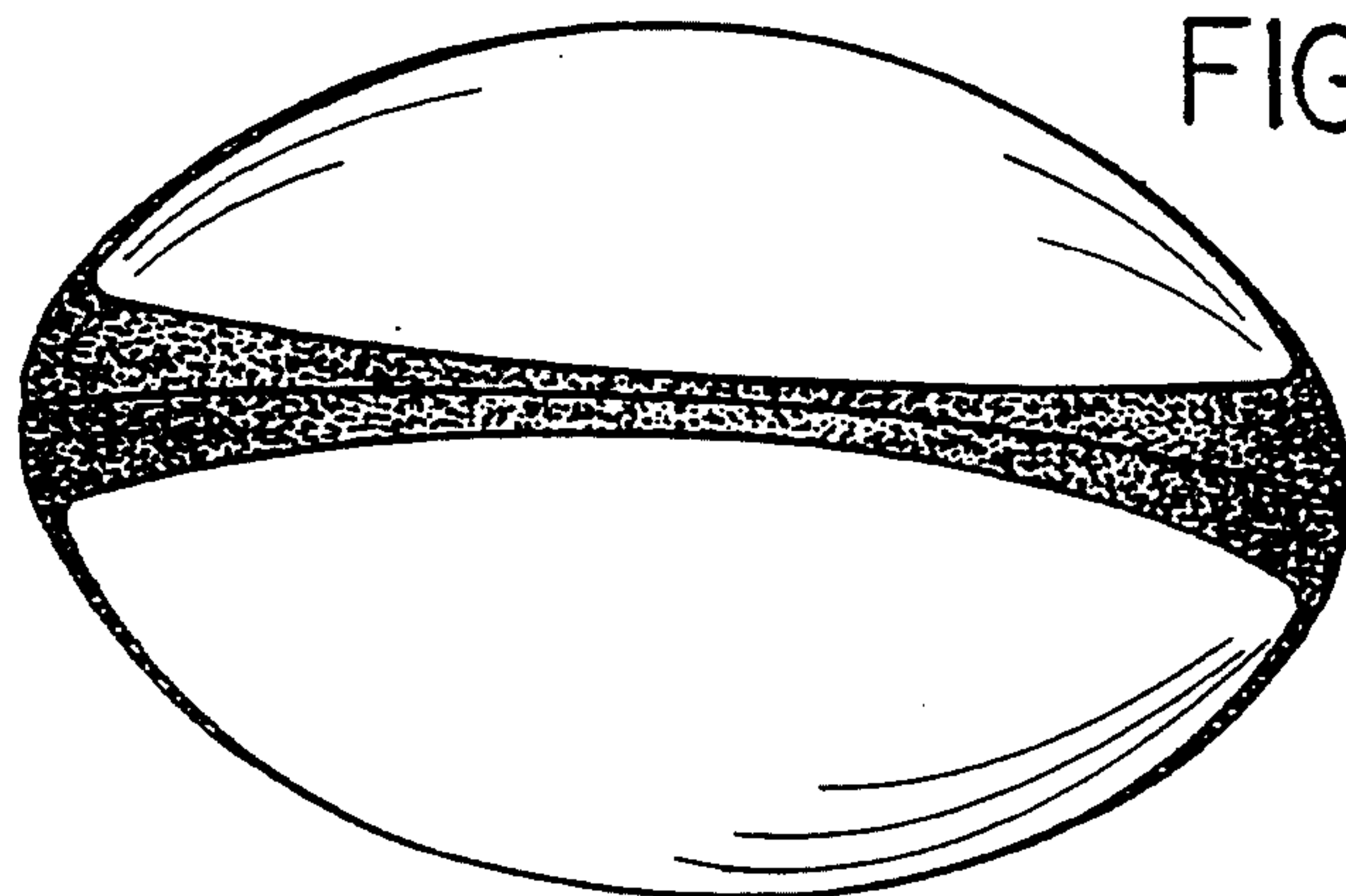

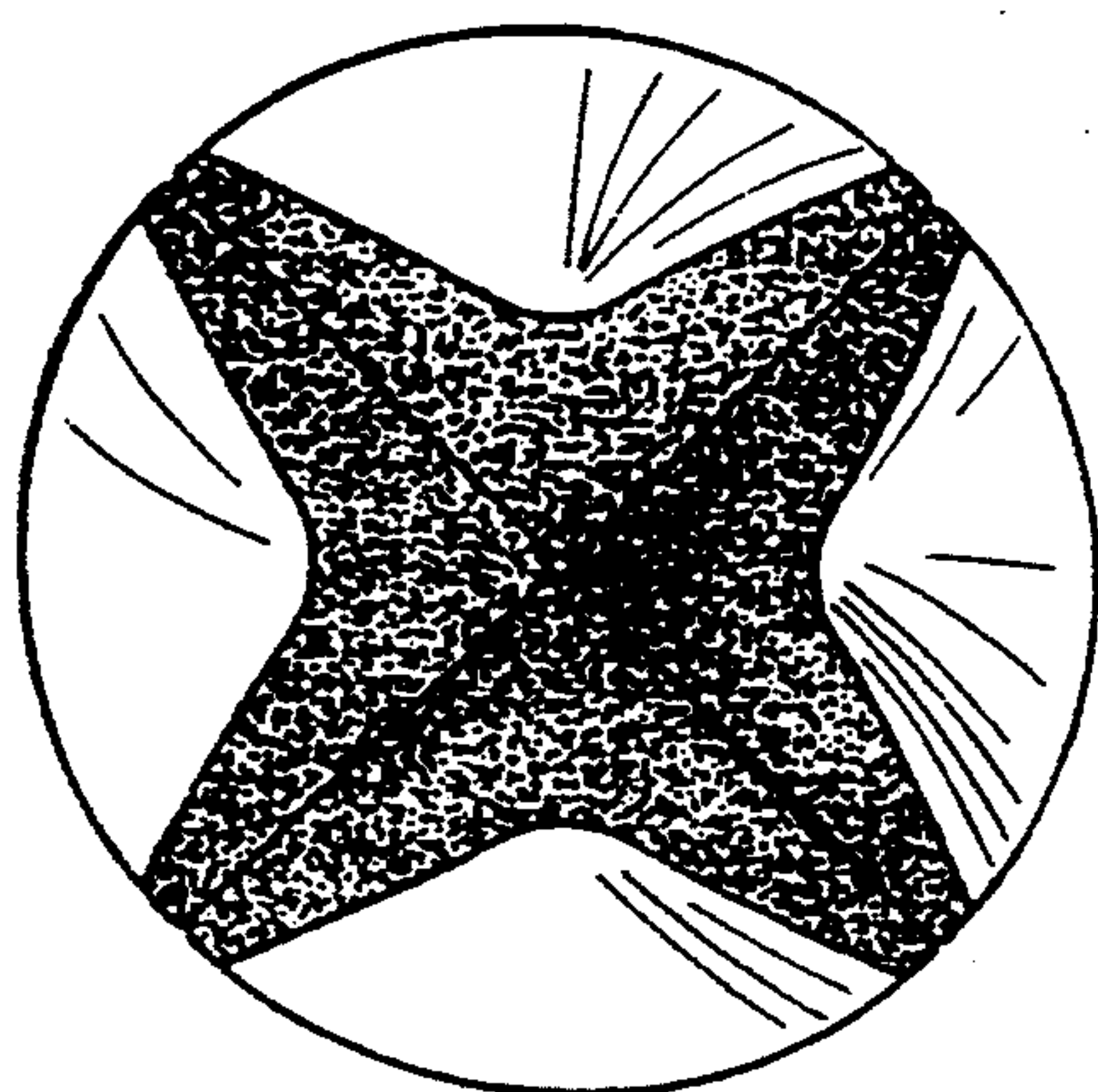
