 FIG. 8 is a side elevational view of the heel of the golf clubhead.

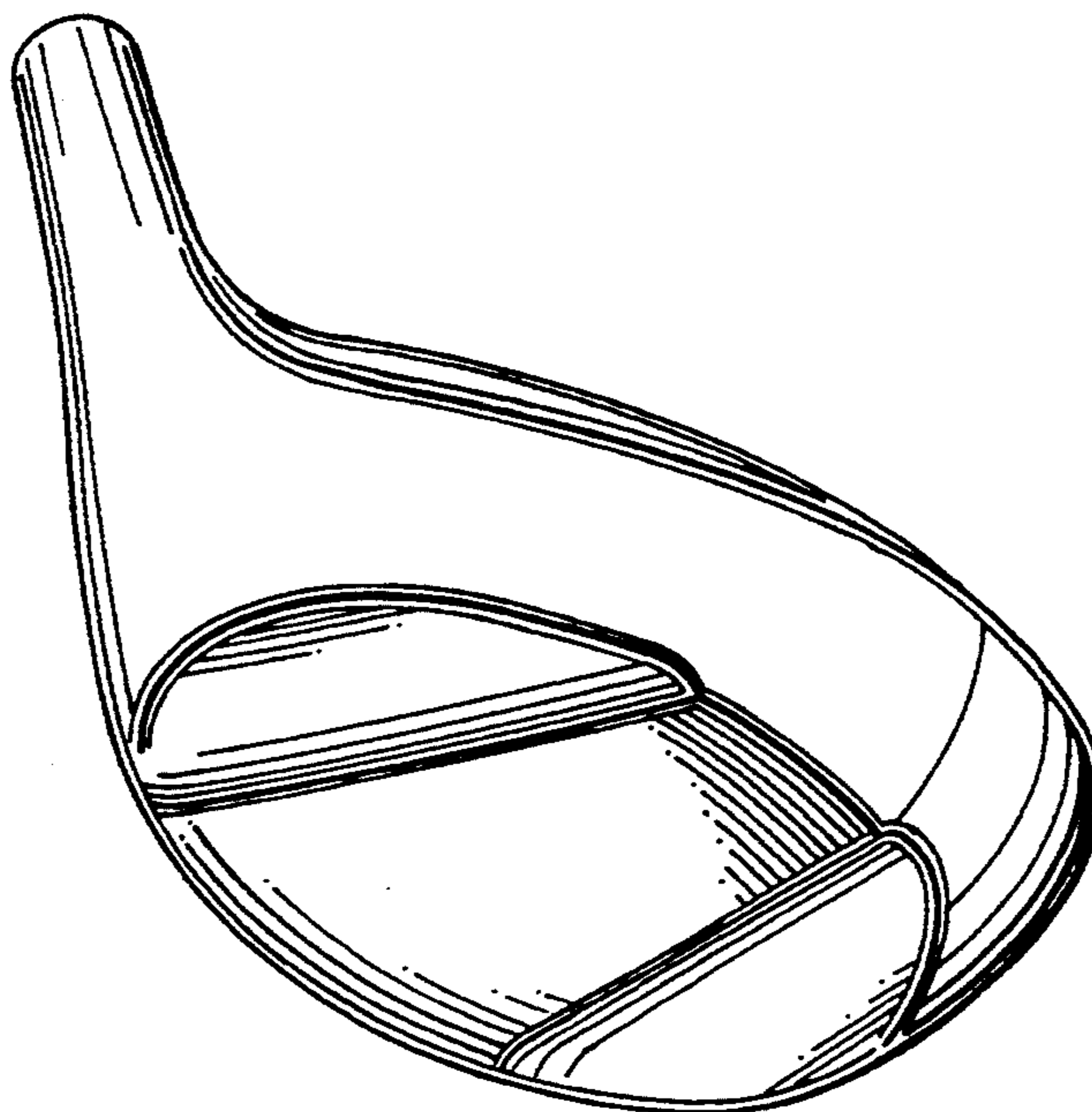

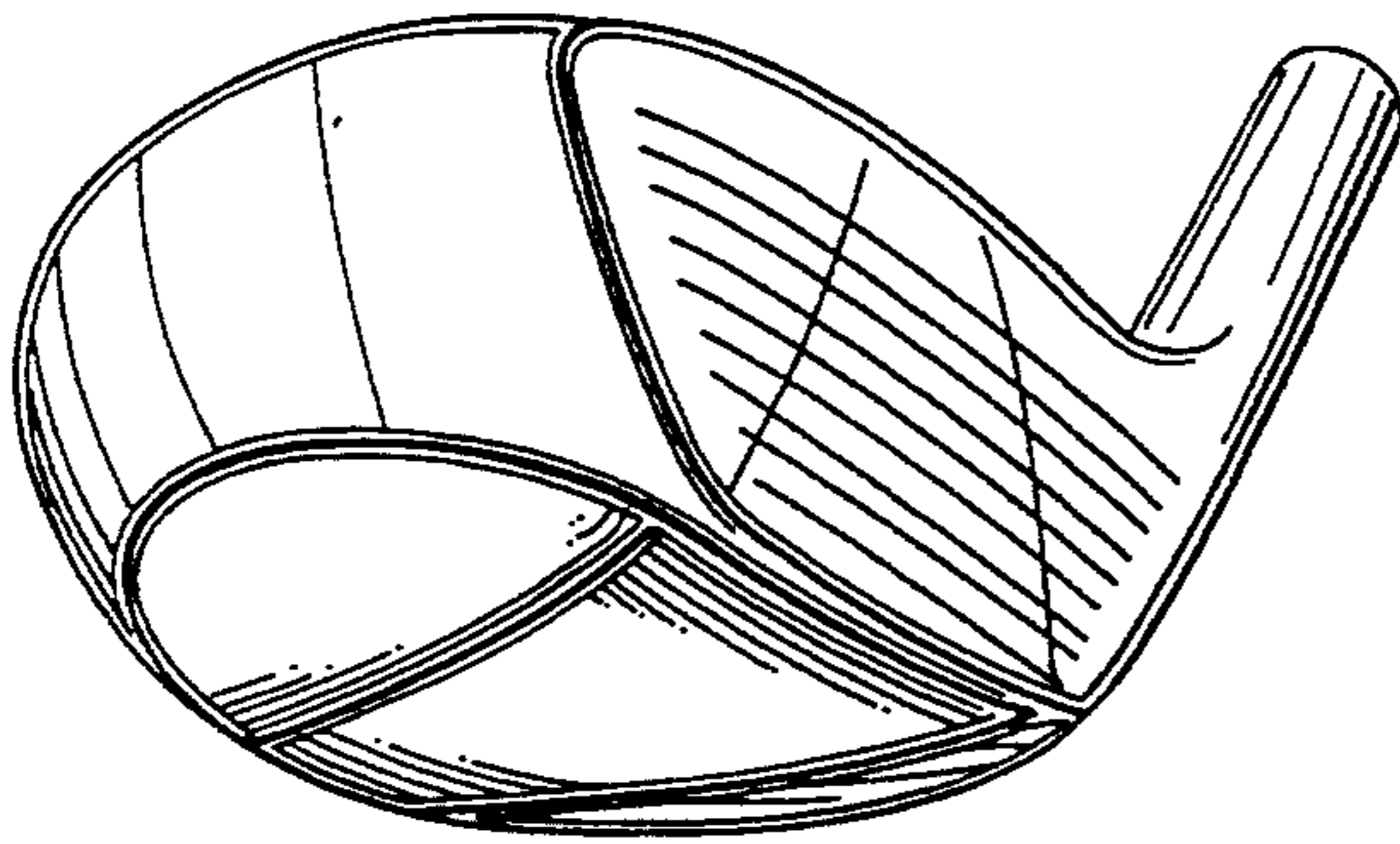

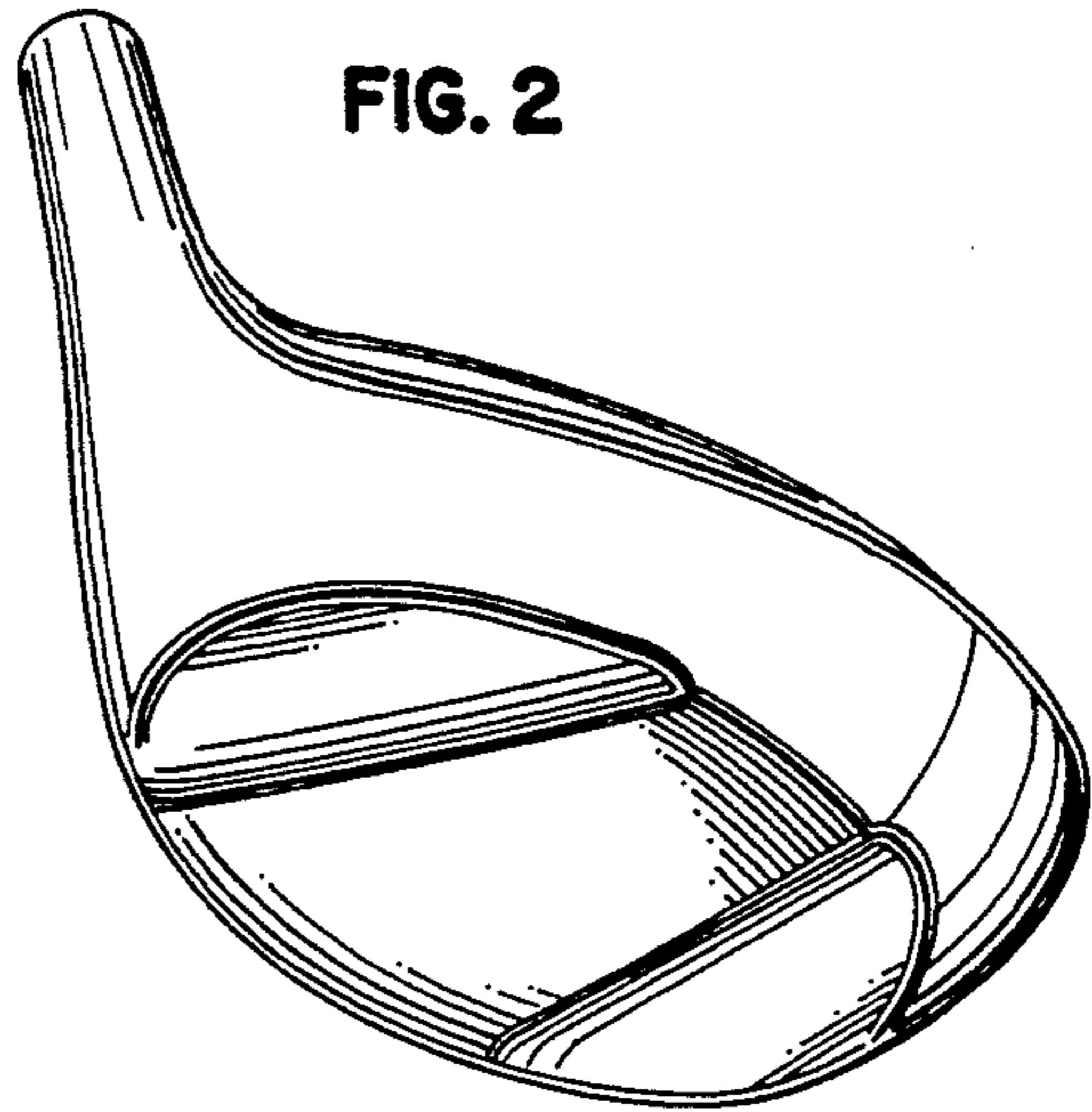

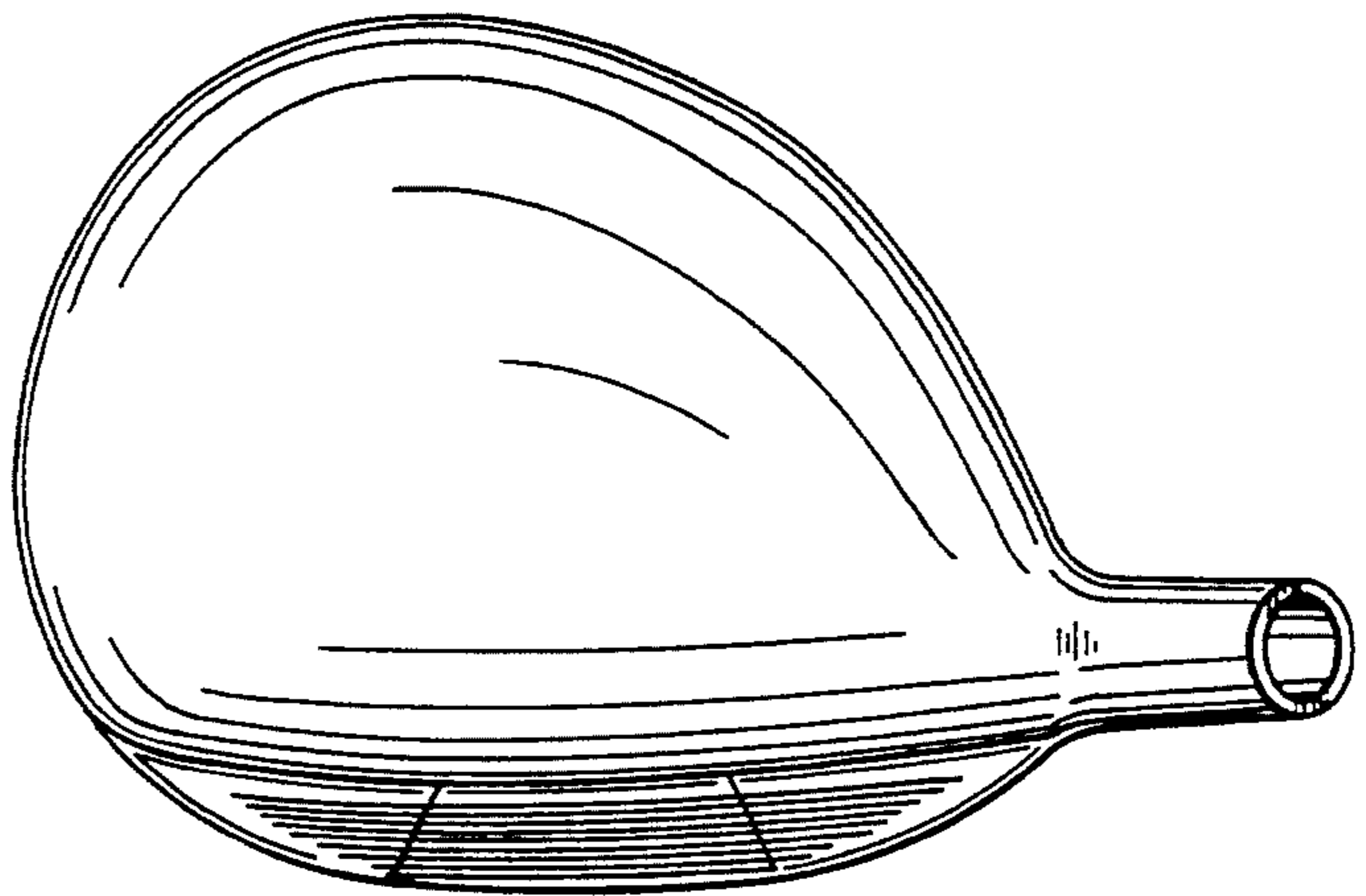

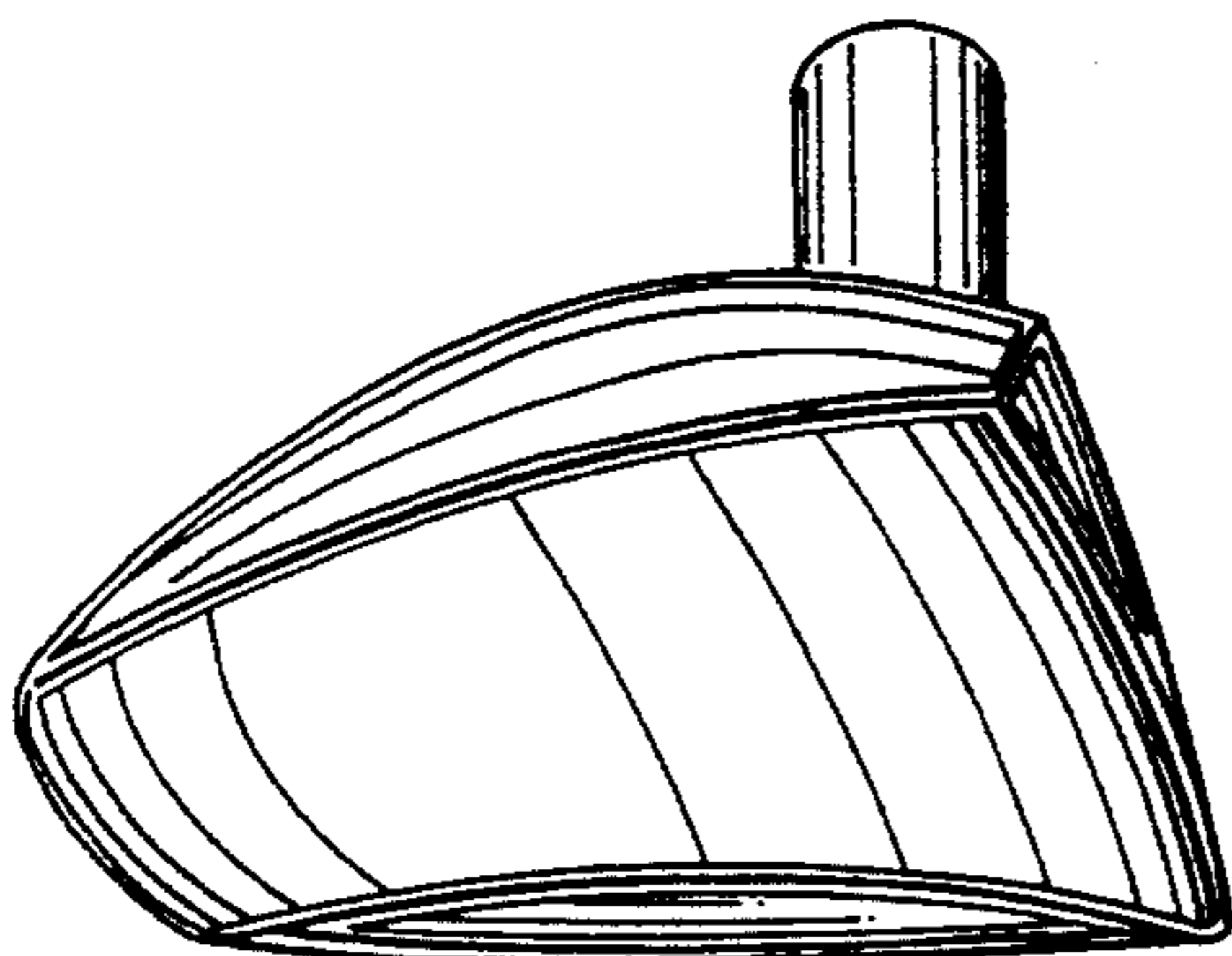

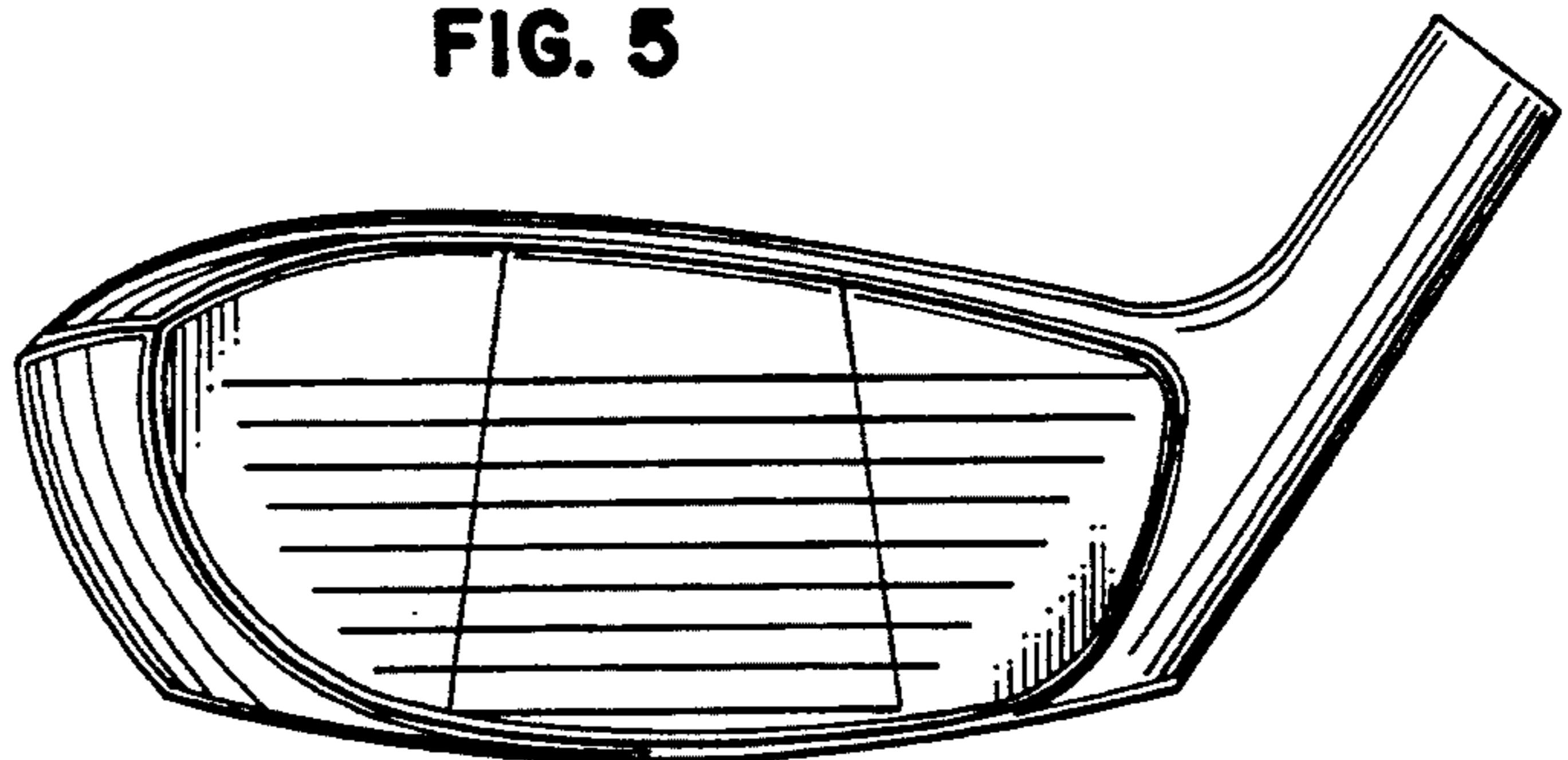

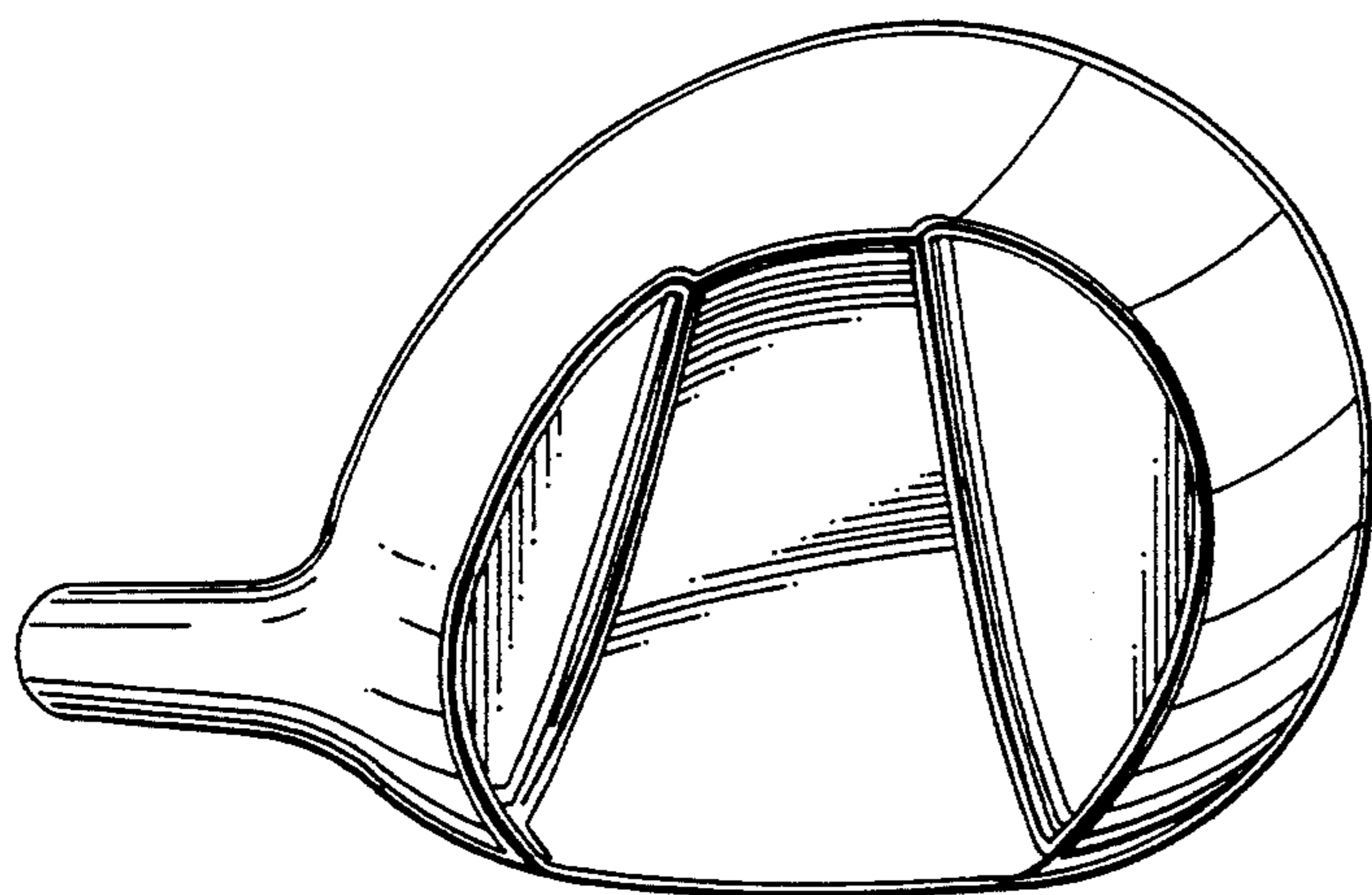

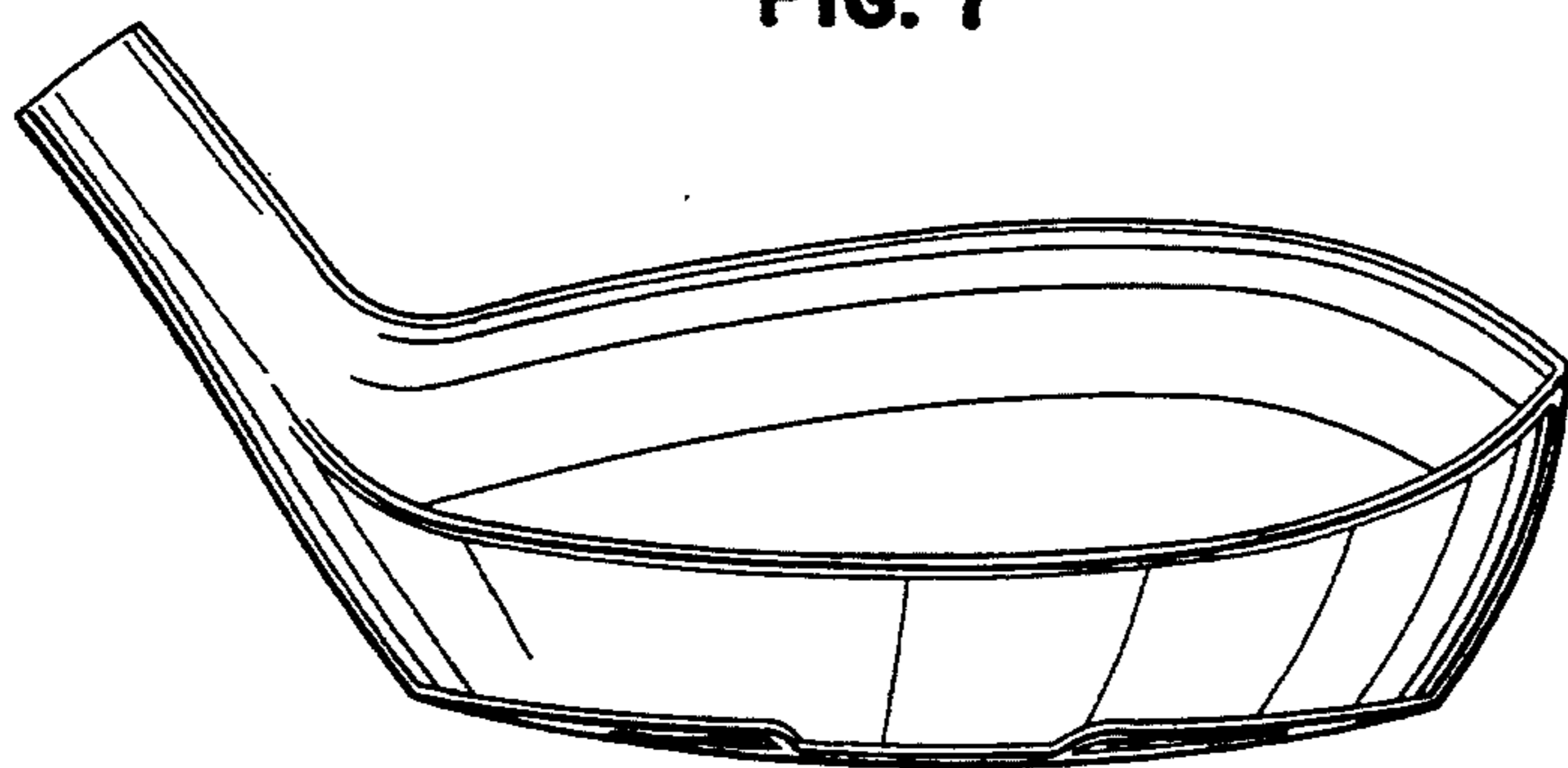
