## [57] CLAIM

The ornamental design for a combined bucket with

nested containers and lid therefor, as shown and described.

## DESCRIPTION

FIG. 1 is an exploded perspective view of a combined bucket with nested containers and lid therefor showing our new design;

FIG. 2 is a perspective view thereof in its assembled condition.

FIG. 3 is a top view thereof;

FIG. 4 is a bottom view of the lid;

FIG. 5 is a side view thereof, the opposite side, front and rear being the same in appearance as the side shown;

FIG. 6 is a top view of the first container;

FIG. 7 is a bottom view thereof;

FIG. 8 is a side view thereof, the opposite side, front and rear being the same in appearance as the side shown;

FIG. 9 is a top view of the second container;

FIG. 10 is a bottom view thereof;

FIG. 11 is a side view thereof, the opposite side, front and rear being the same in appearance as the side shown;

FIG. 12 is top view of the third container;

FIG. 13 is bottom view thereof;

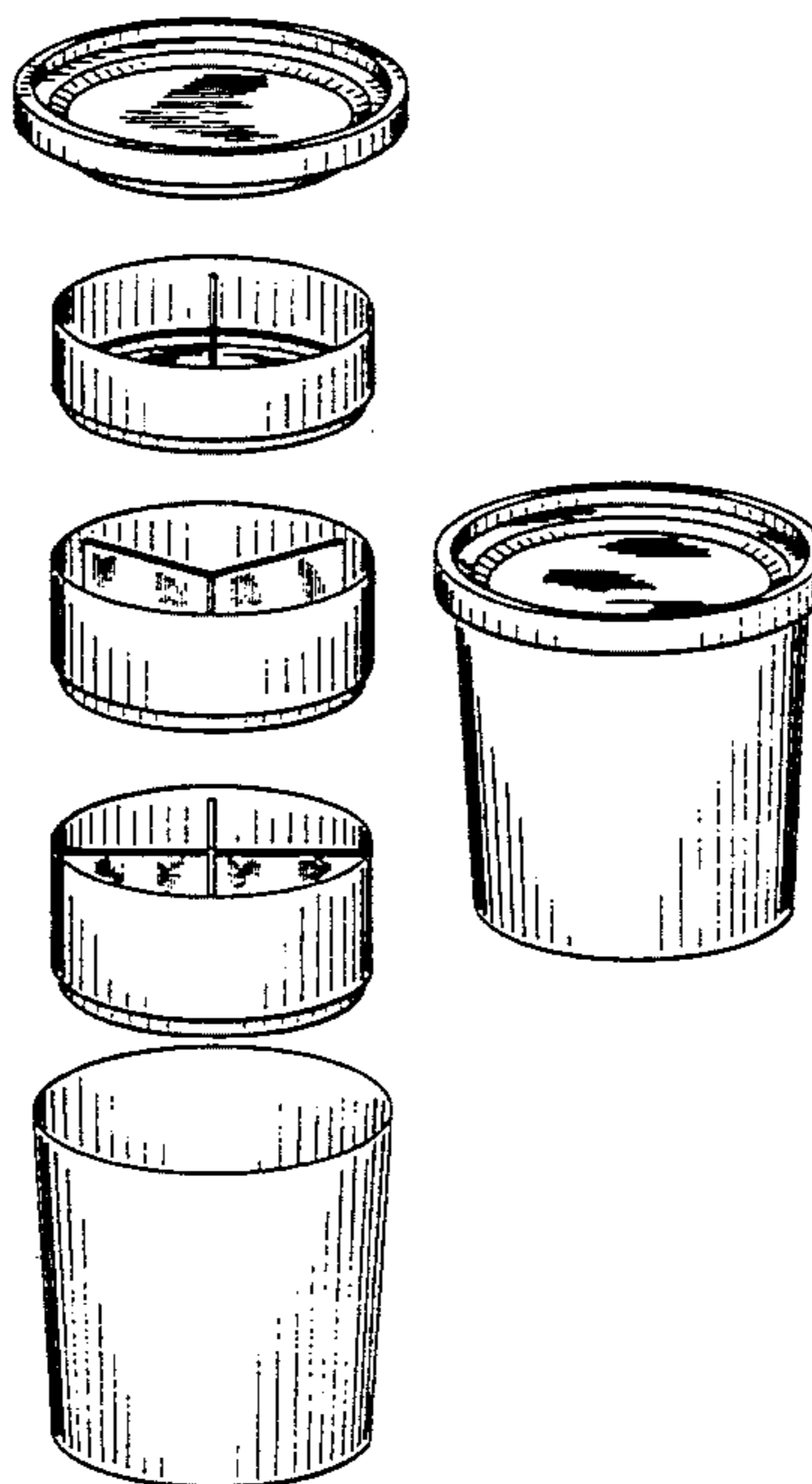
FIG. 14 is a side view thereof, the opposite side, front, and rear being the same in appearance as the side shown;

FIG. 15 is a top view of the bucket;

FIG. 16 is a bottom view thereof; and,

The portions of the claimed design shown in FIGS. 4-17 are shown separately for clarity of illustration only.



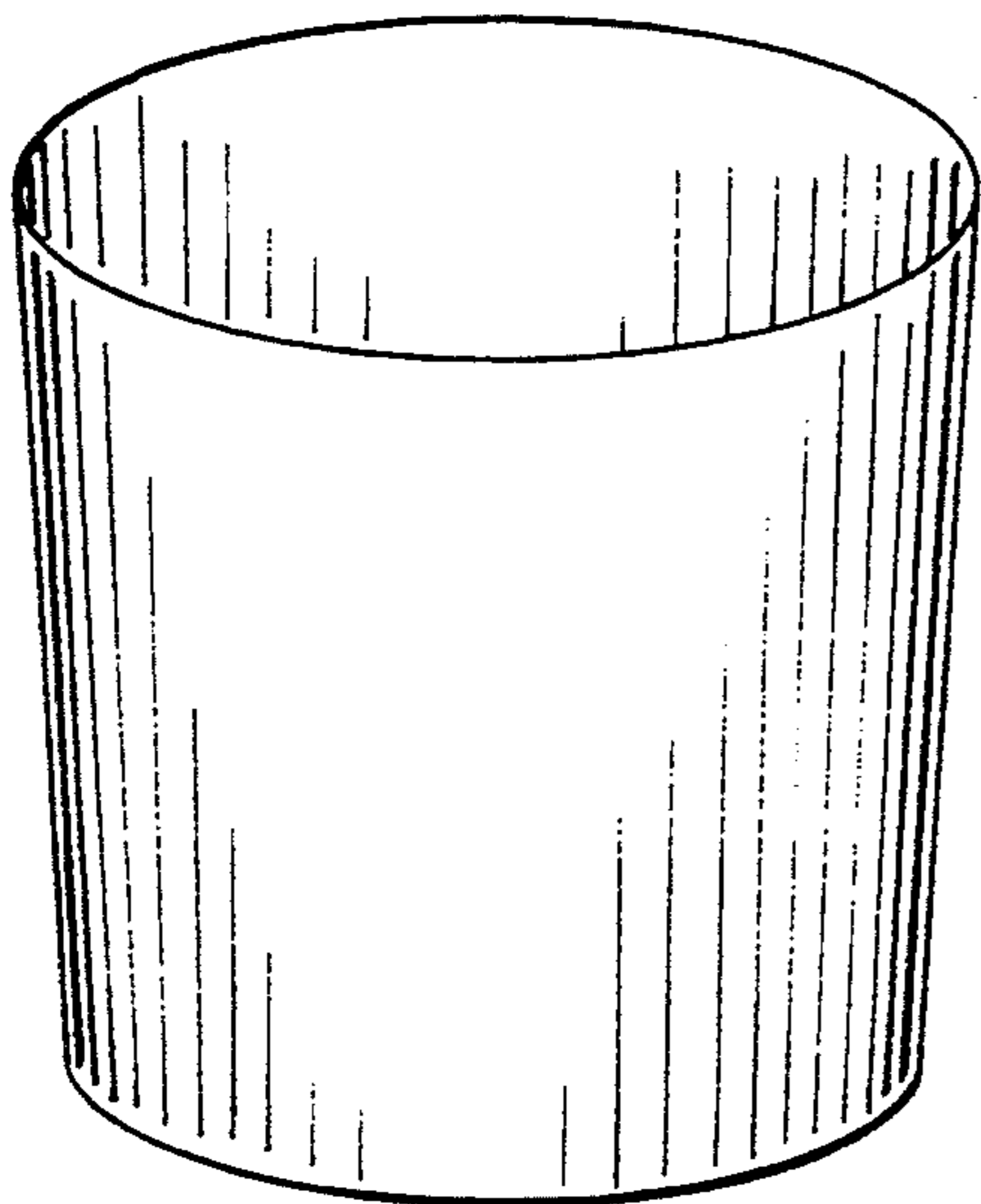
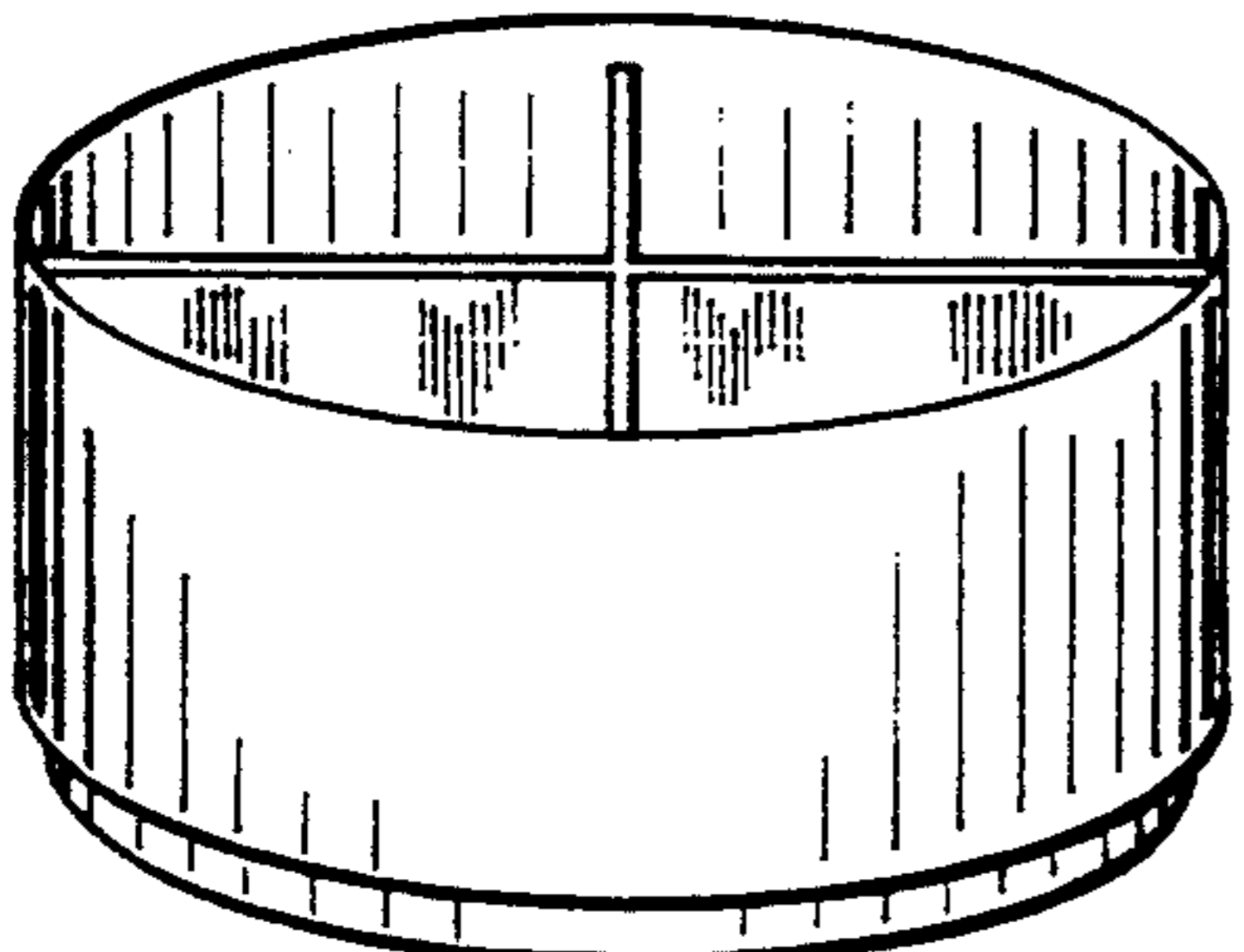
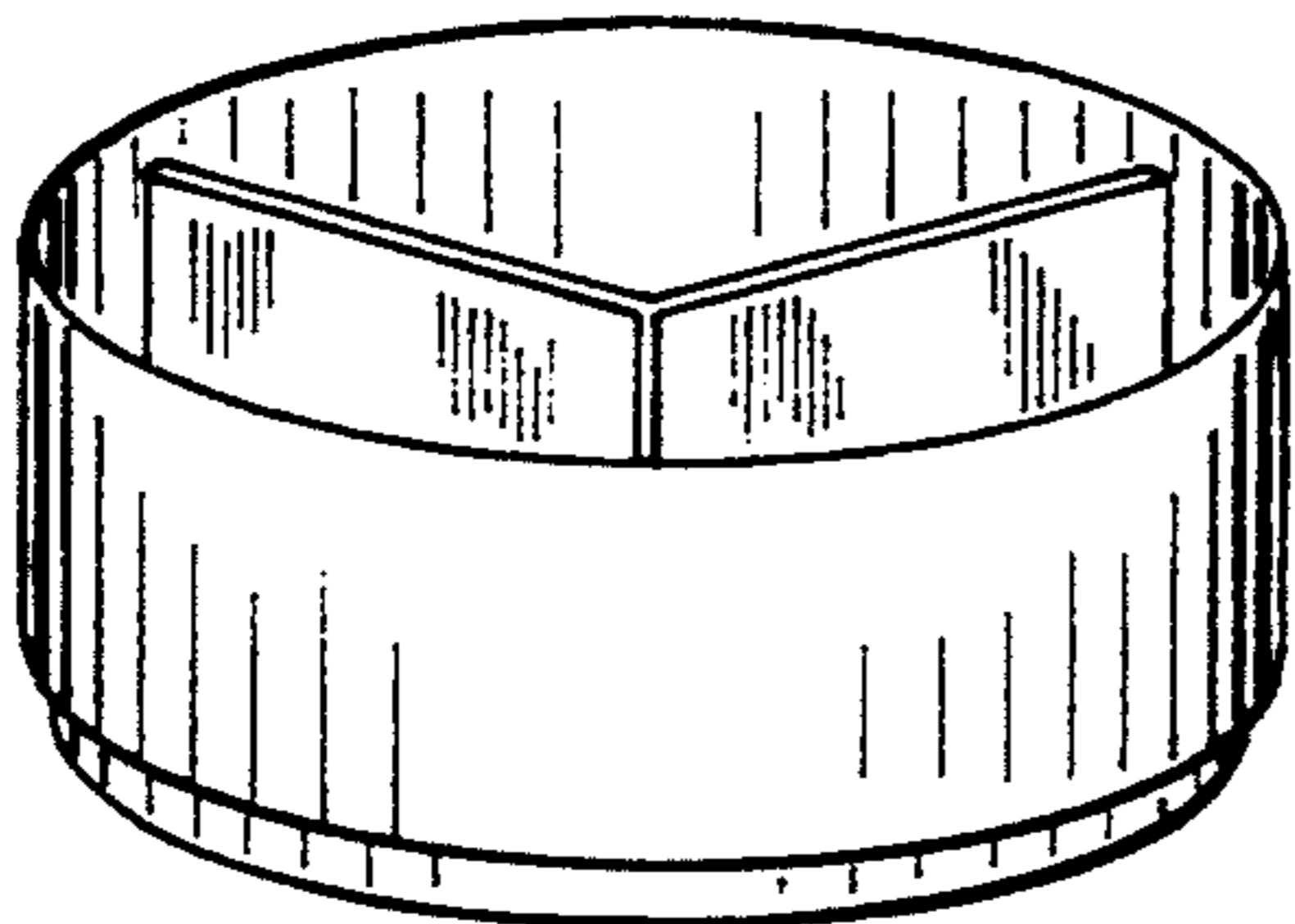
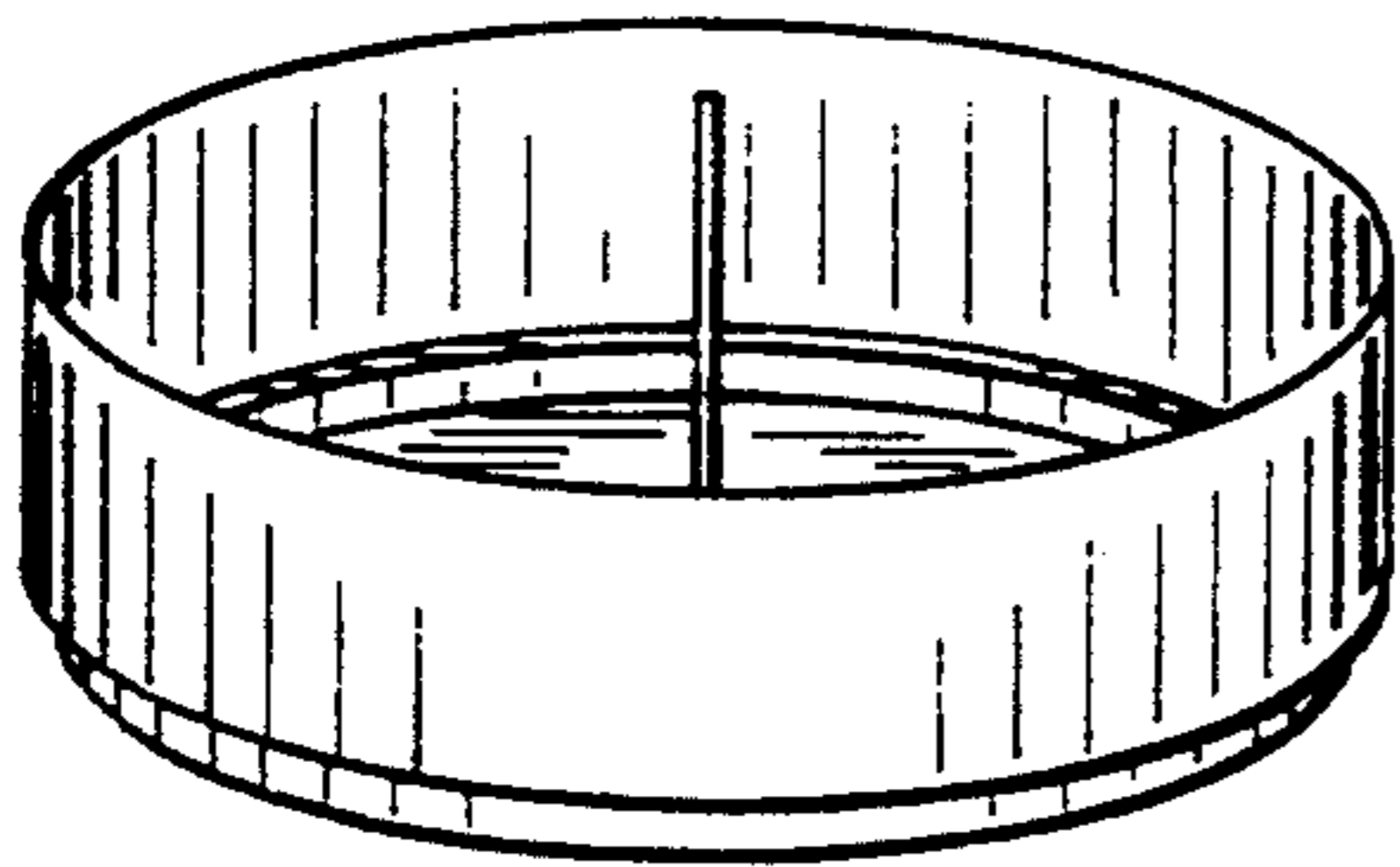
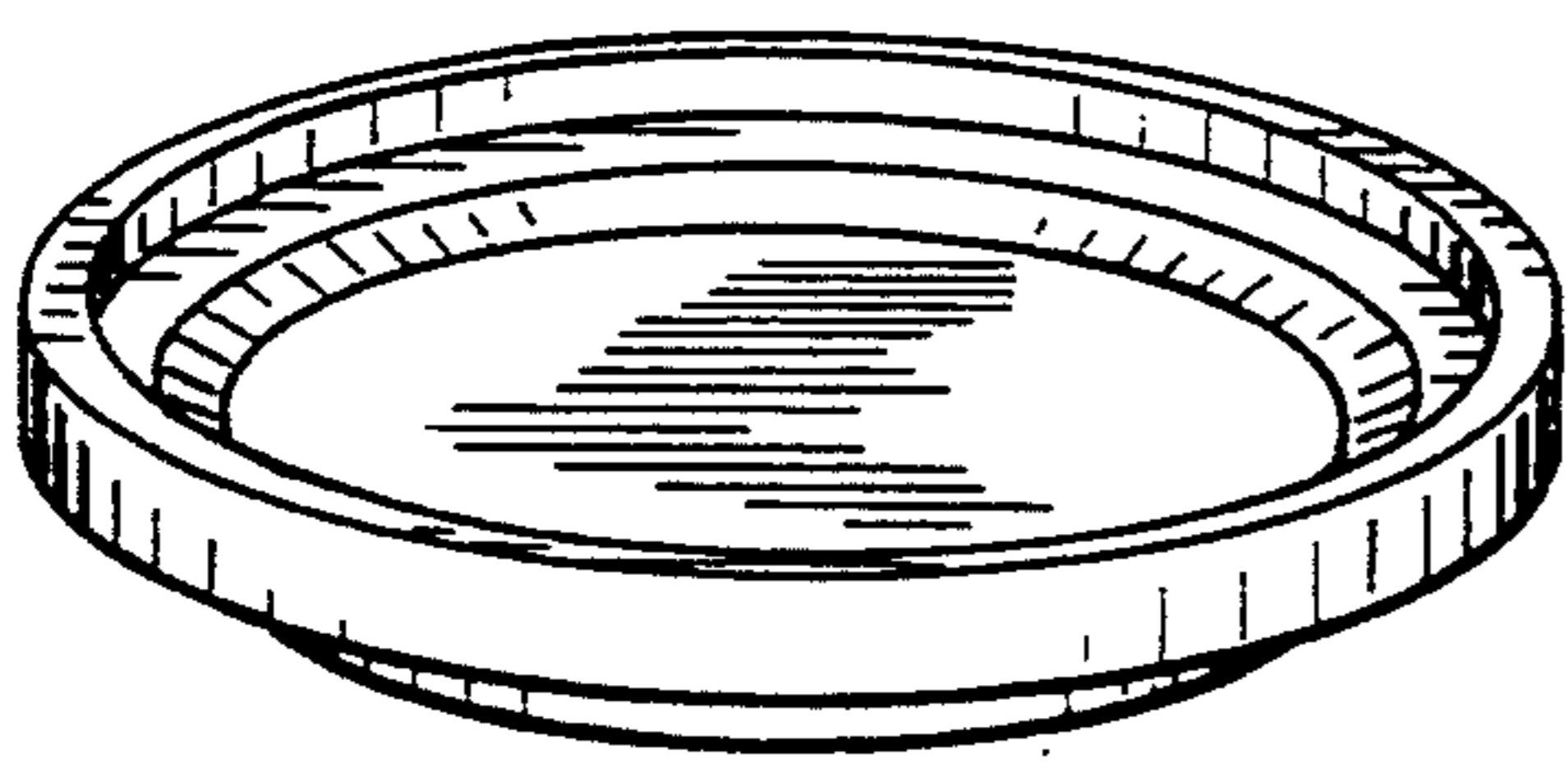

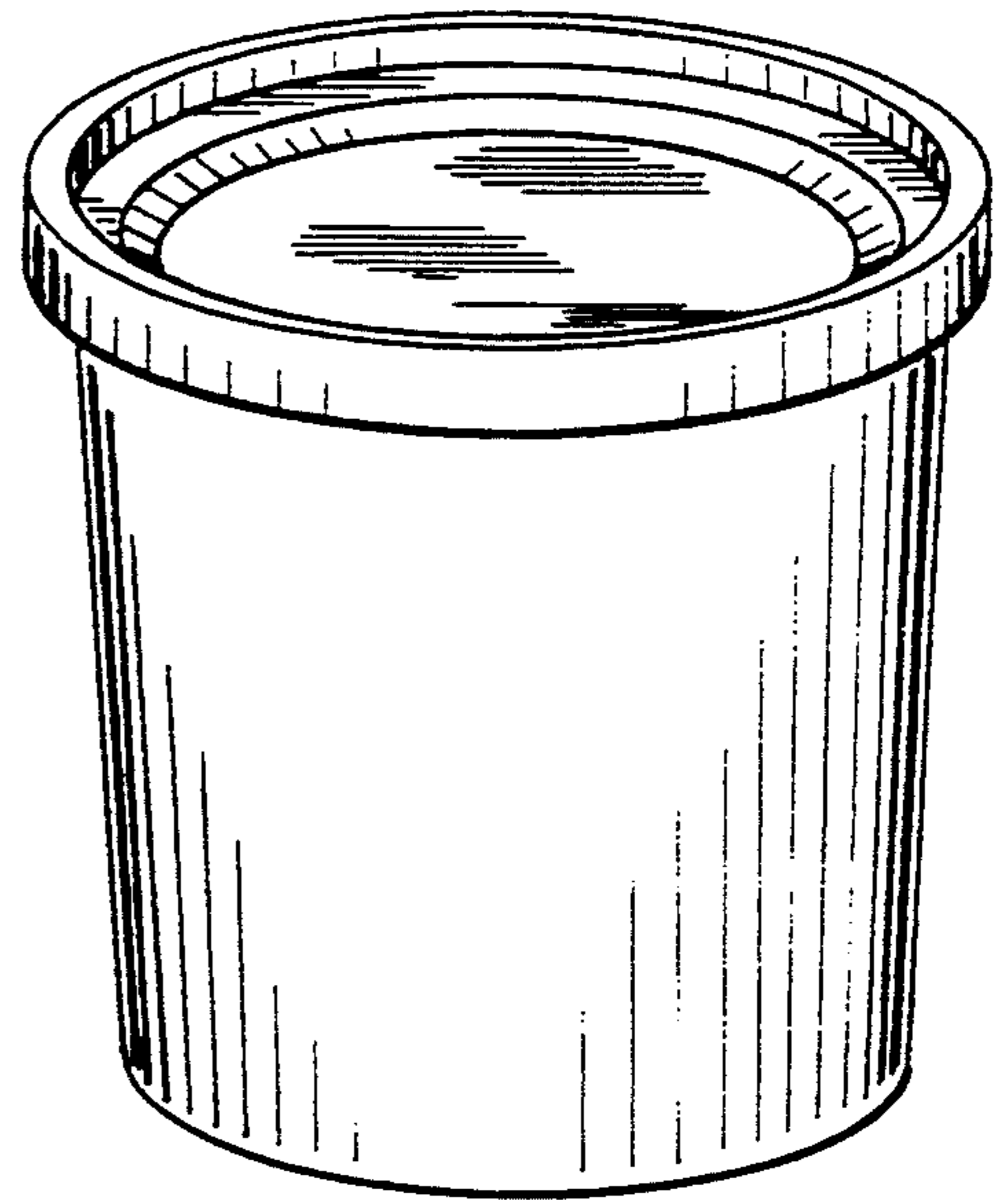

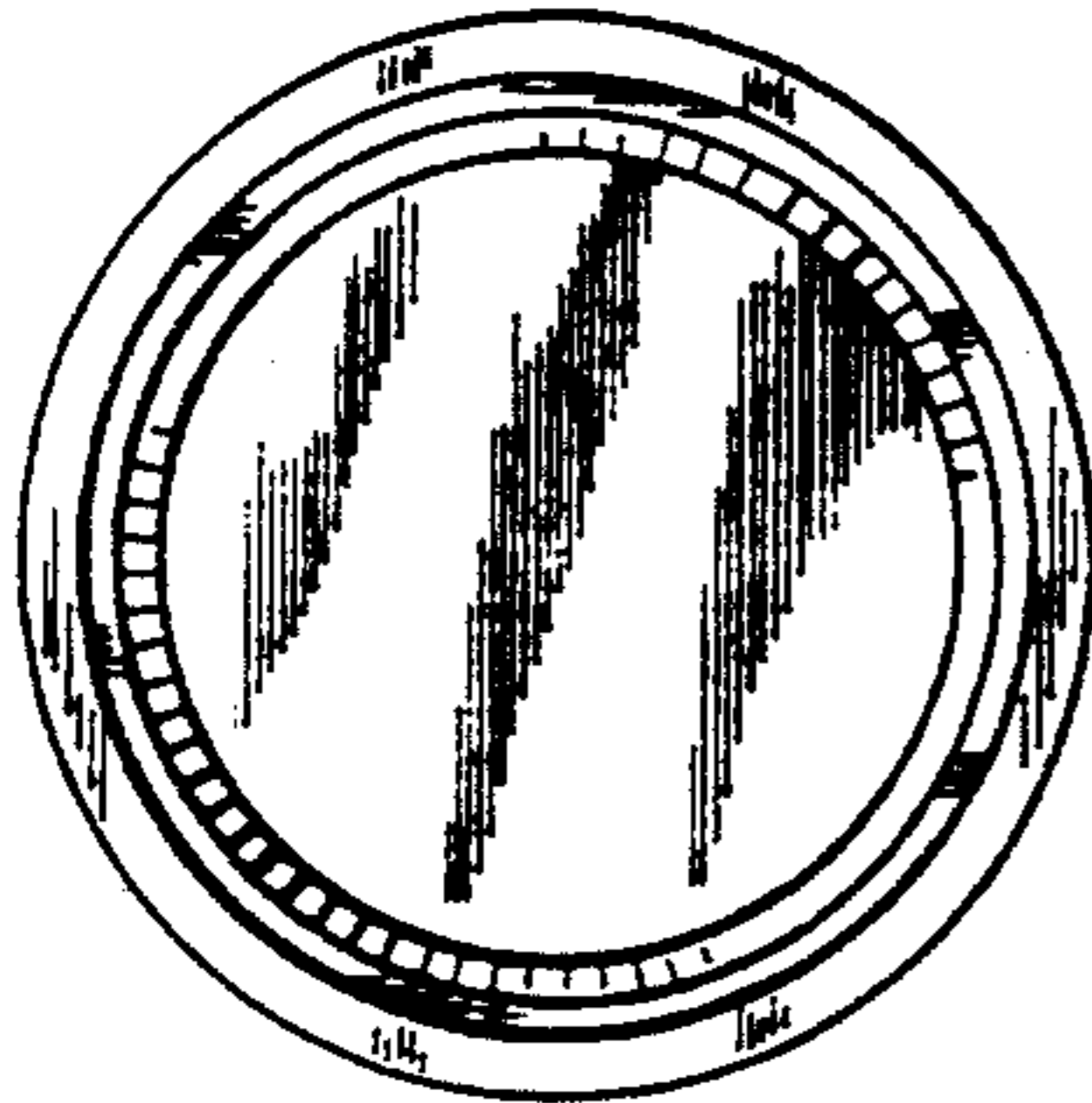

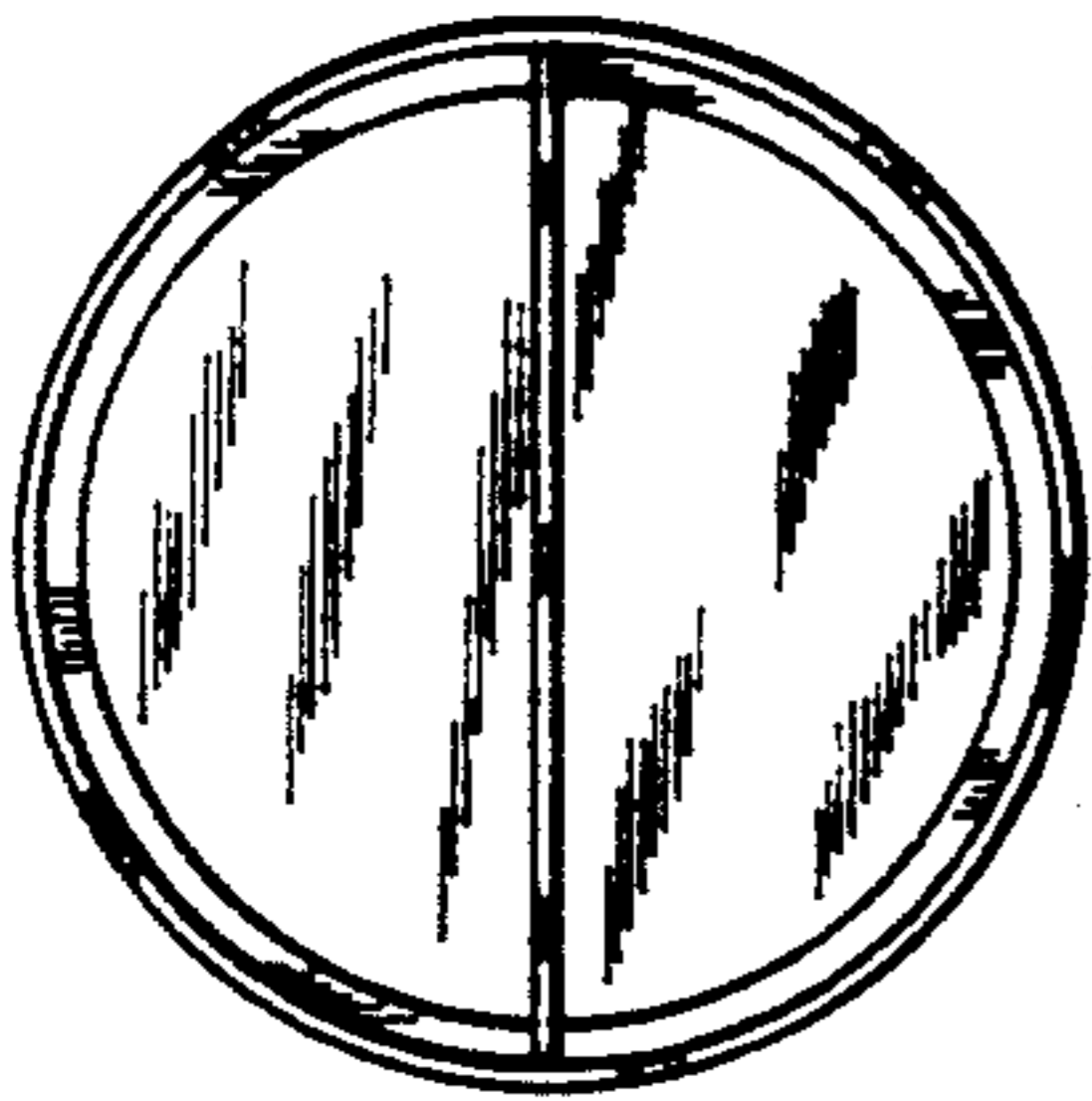

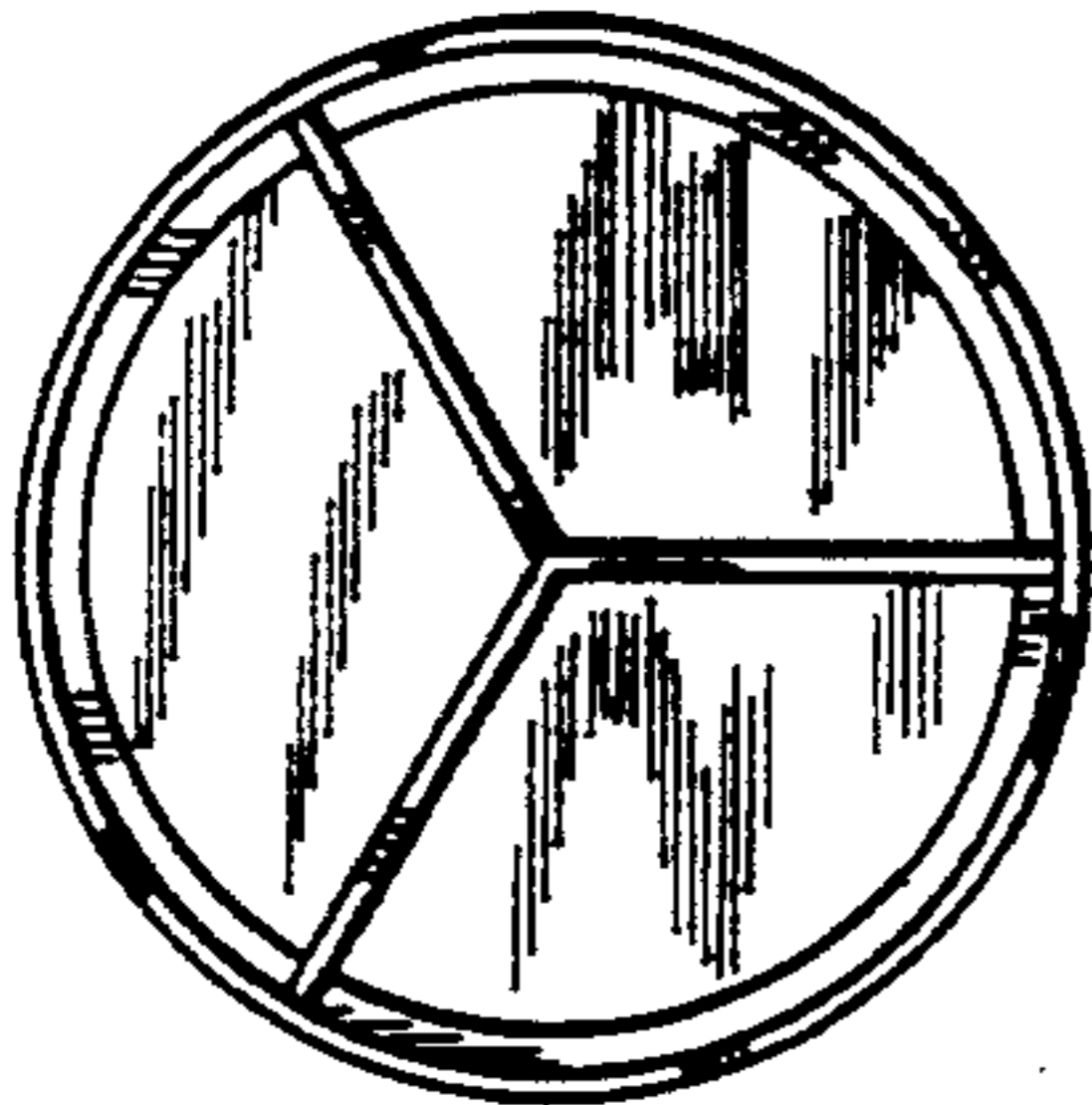

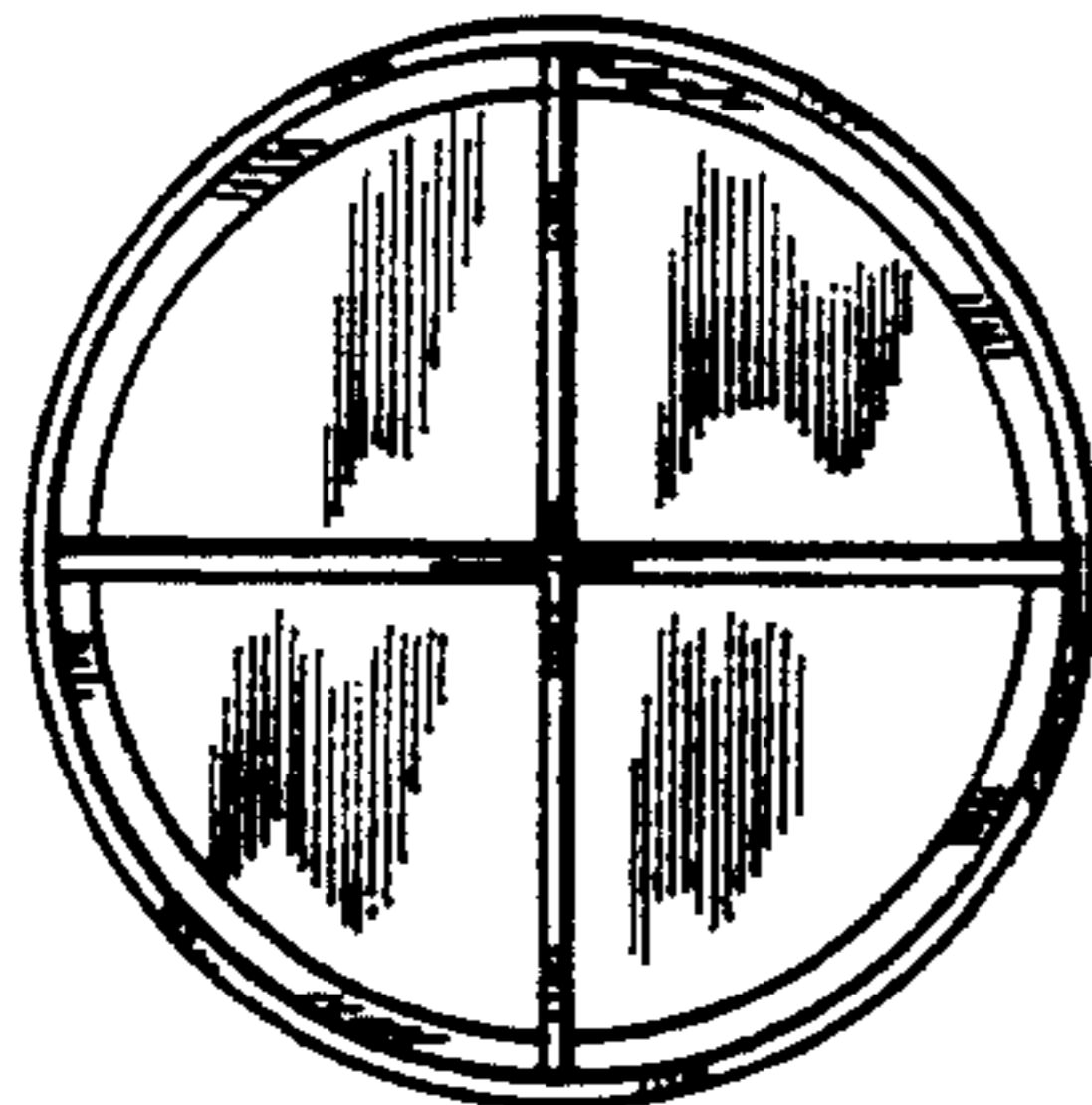

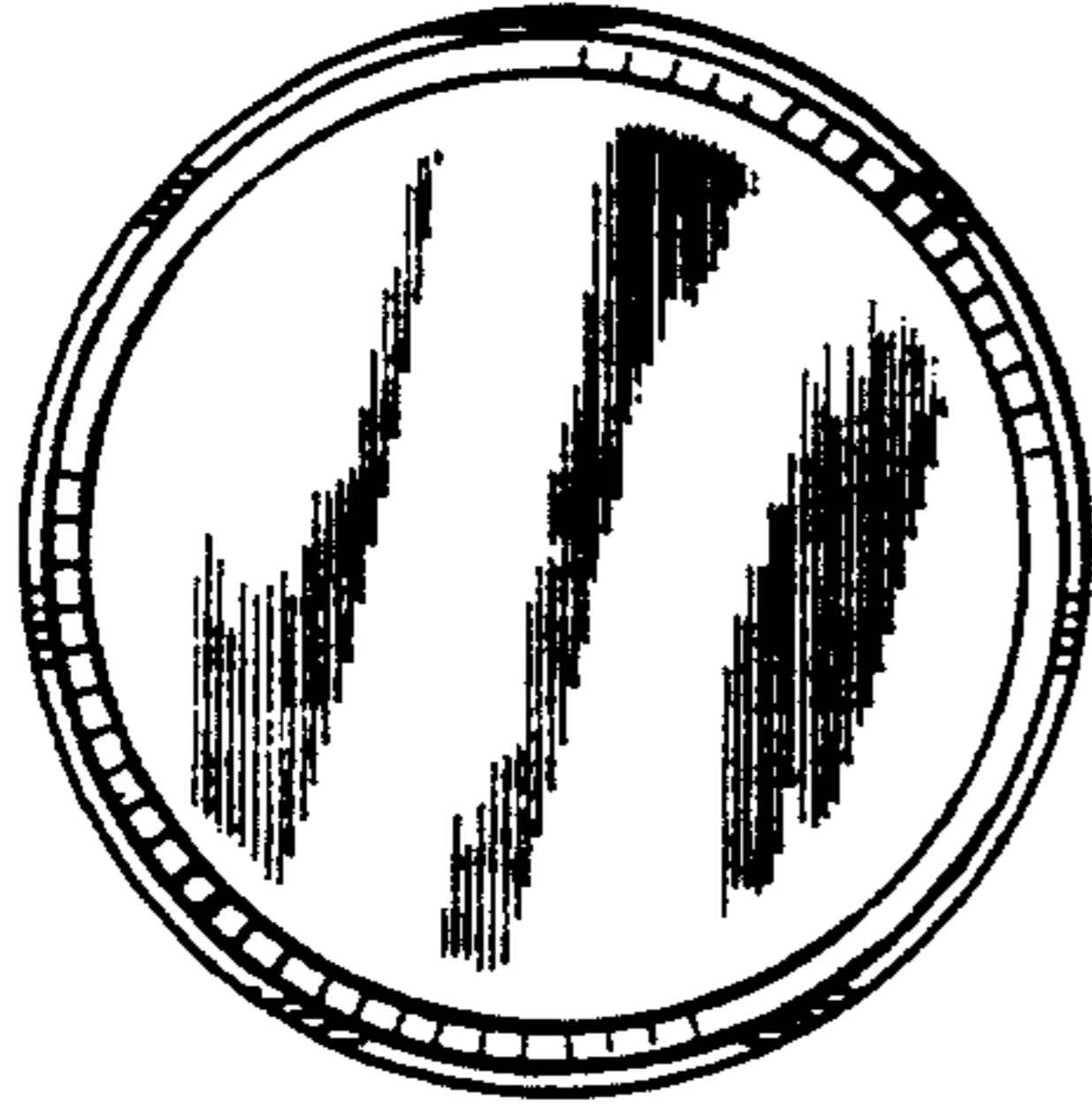

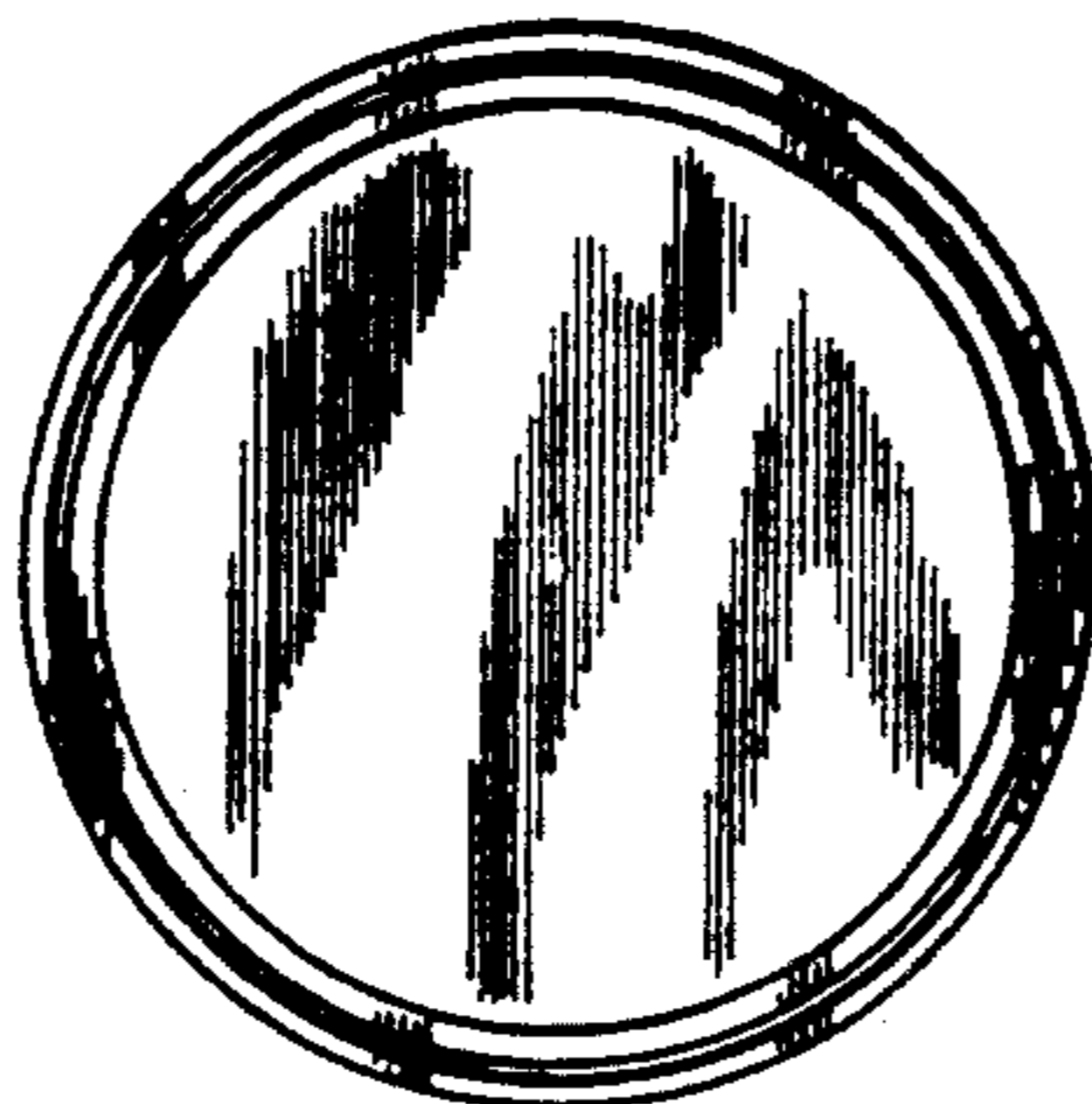

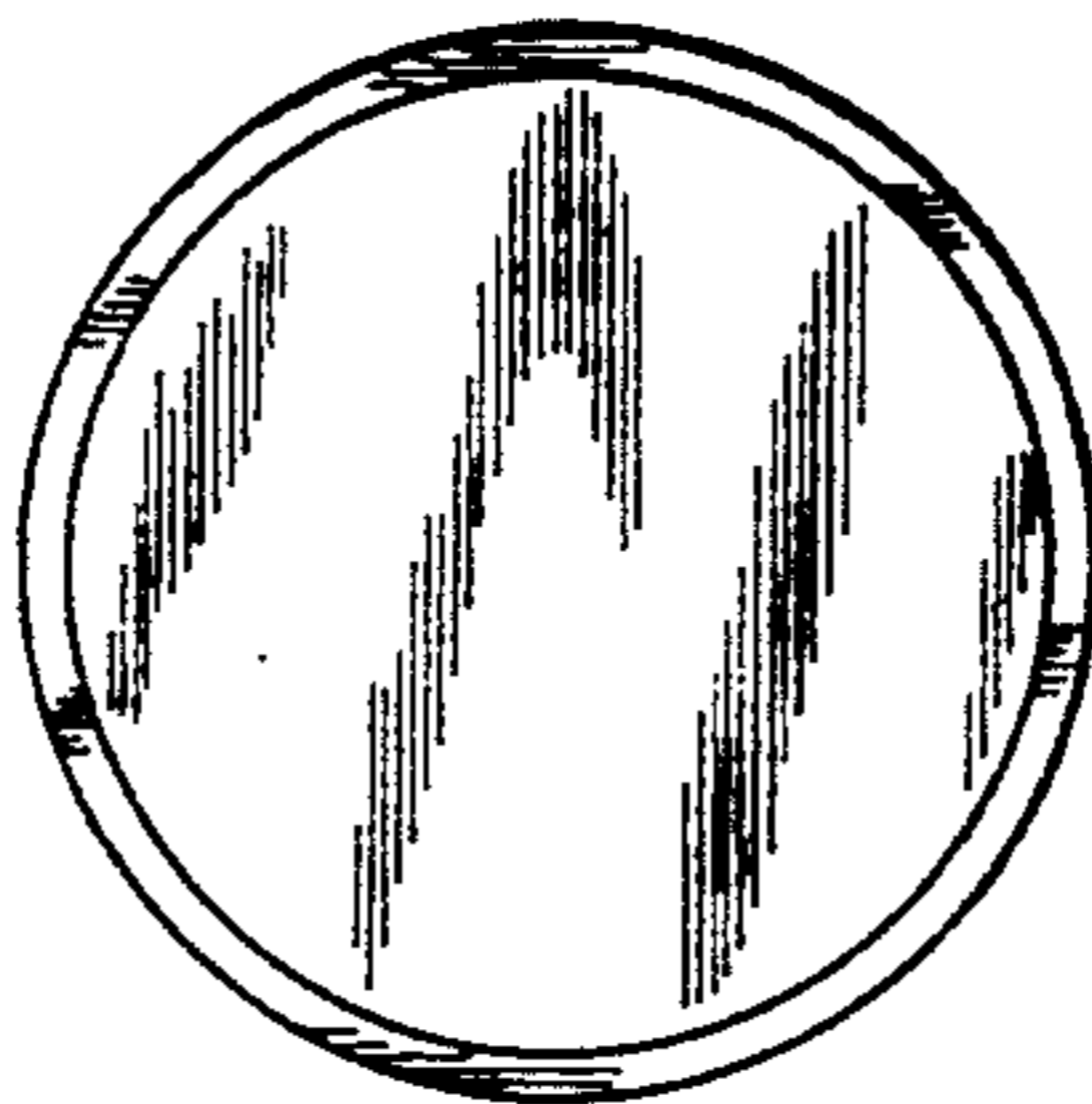

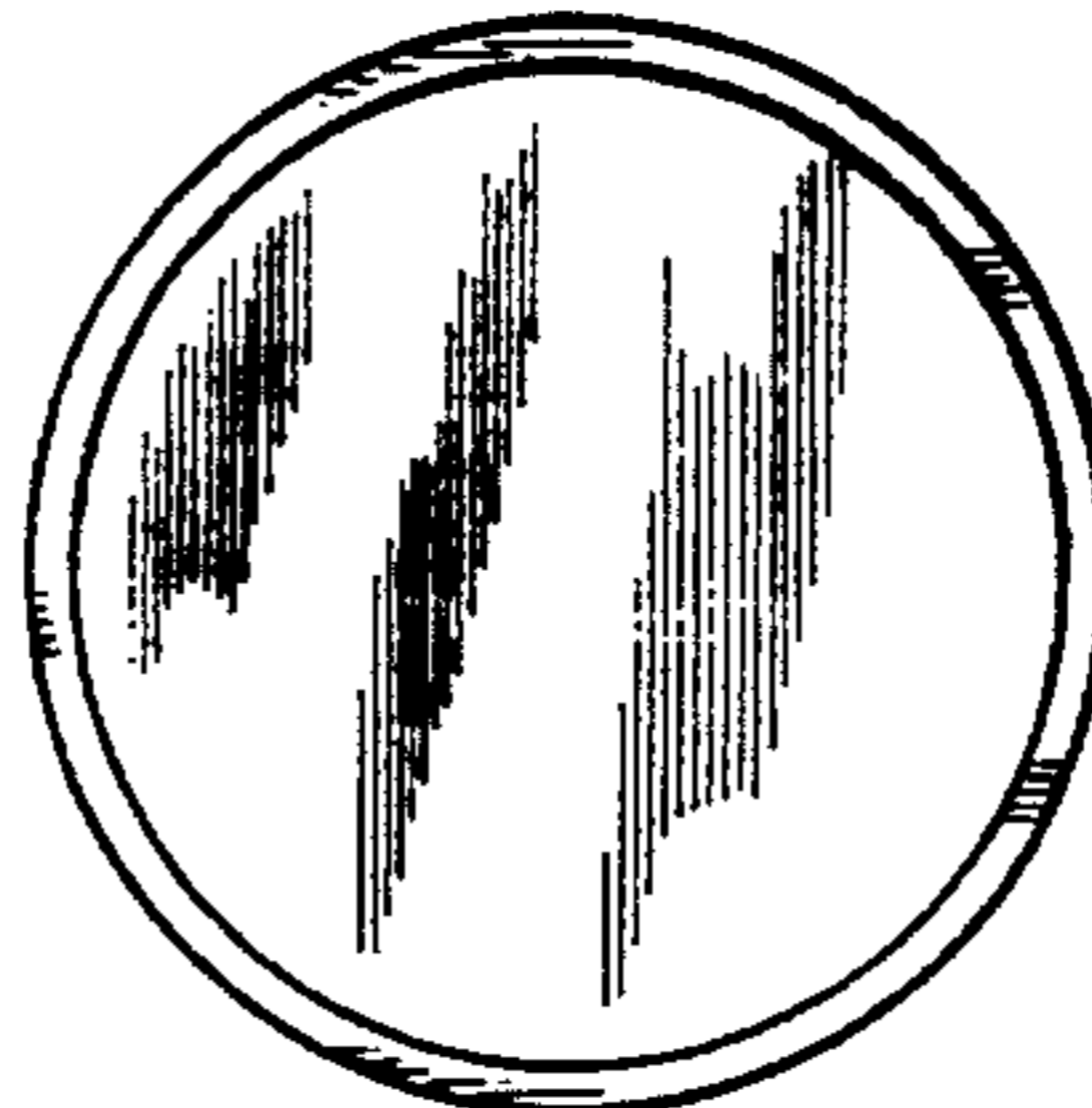

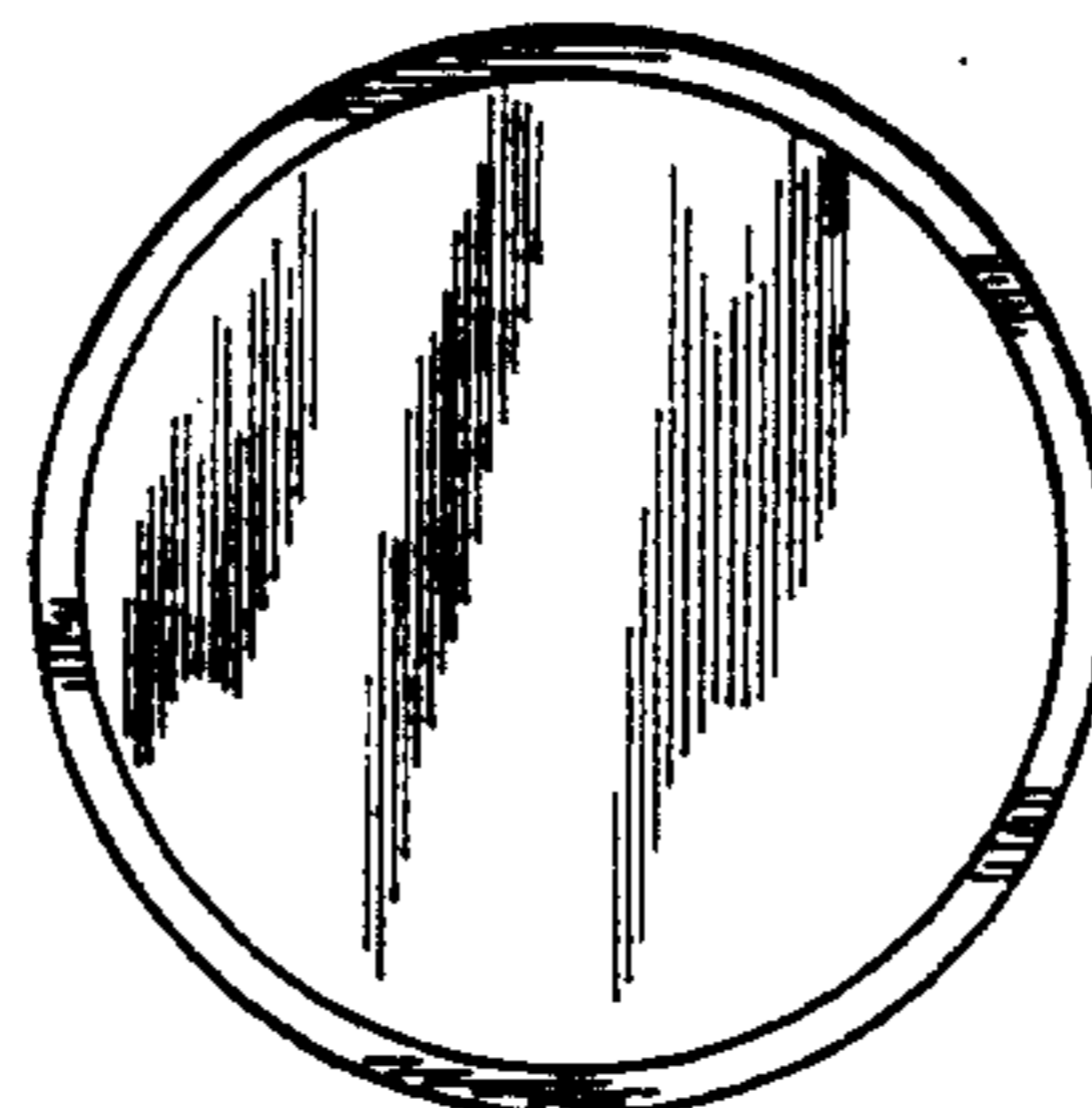

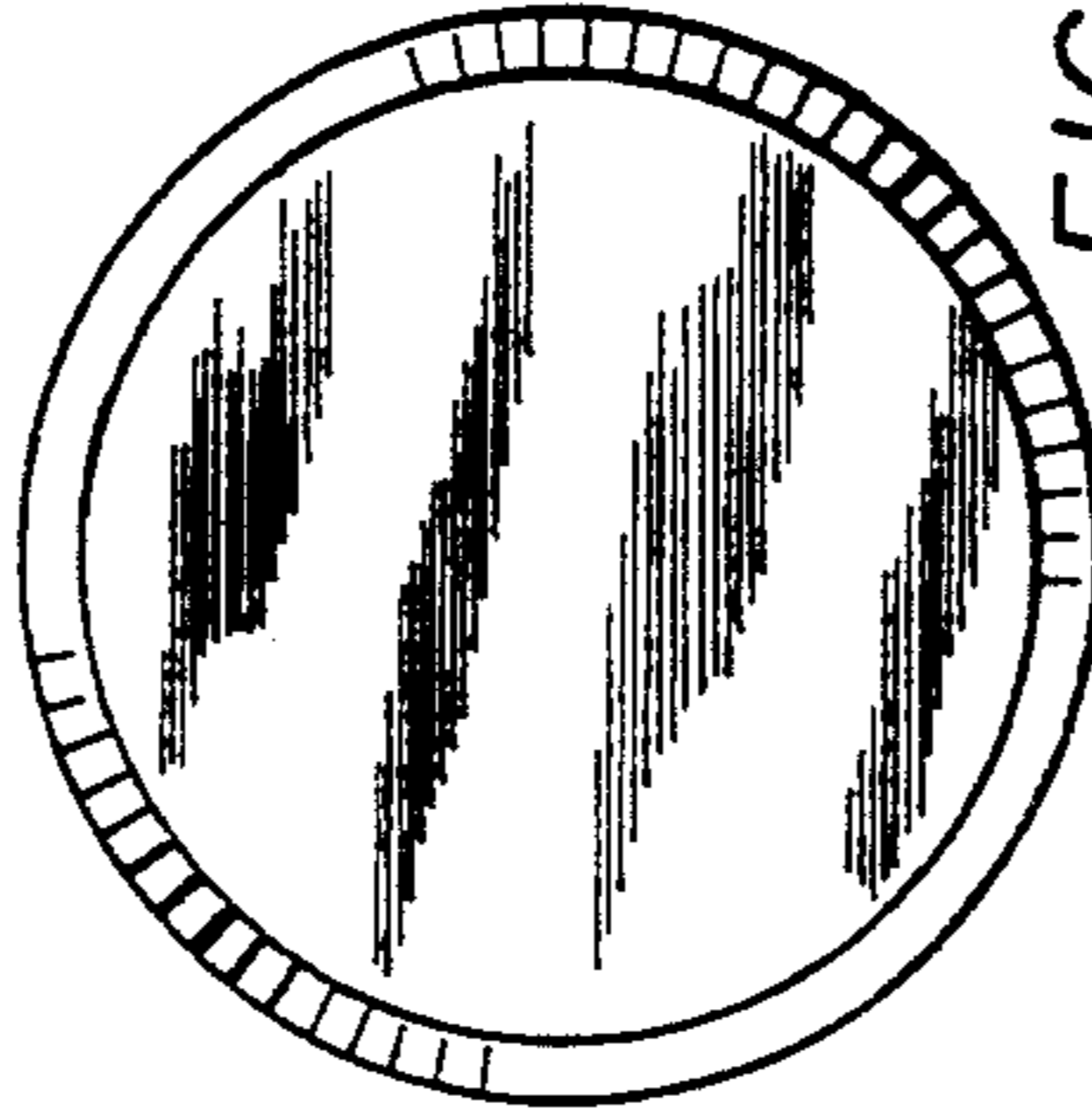

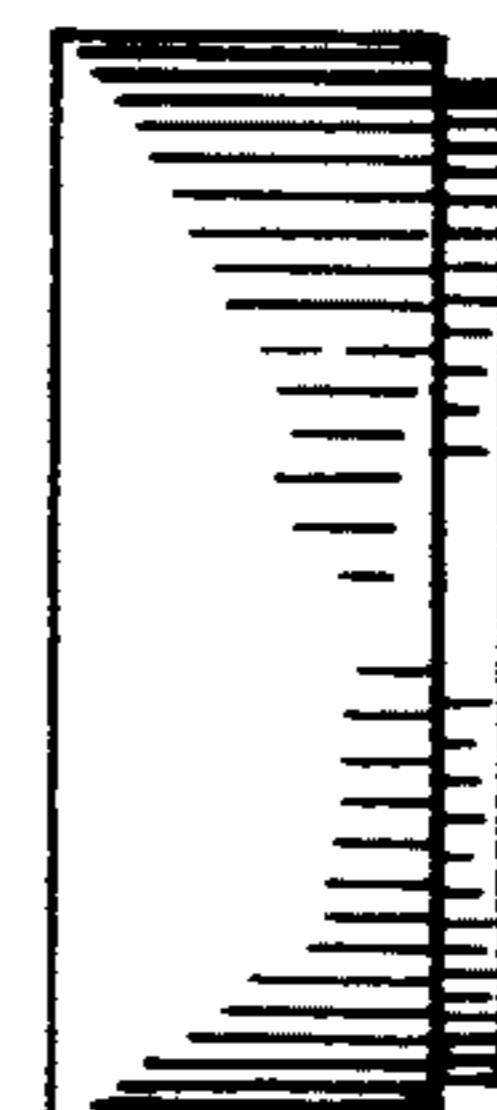

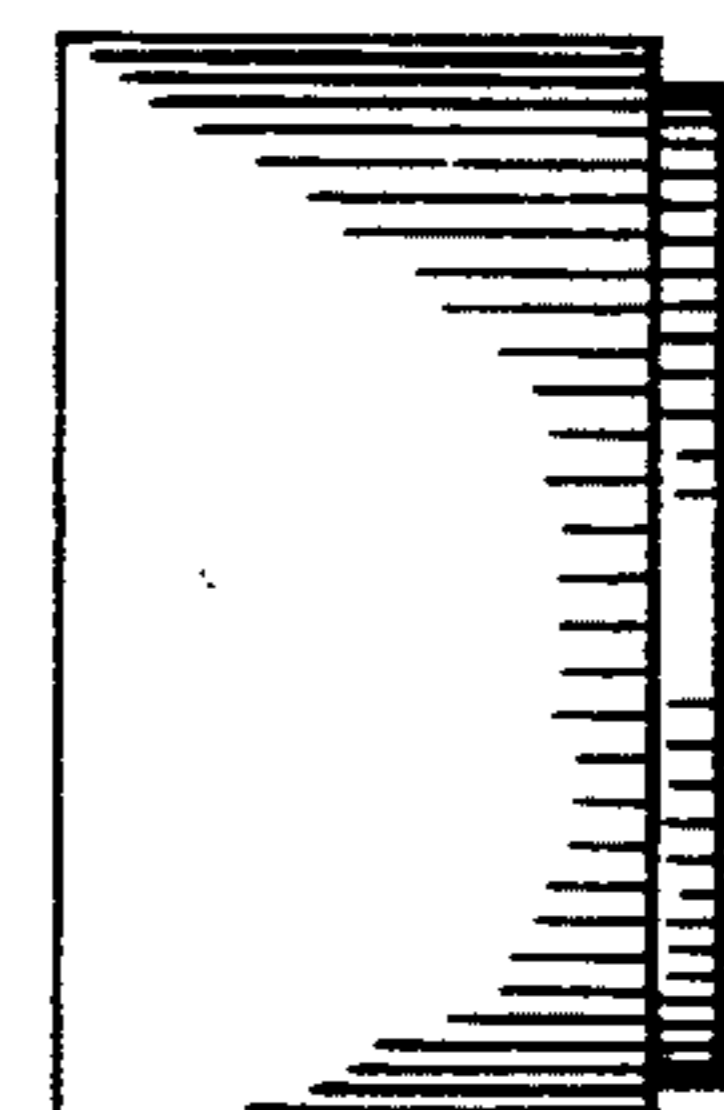

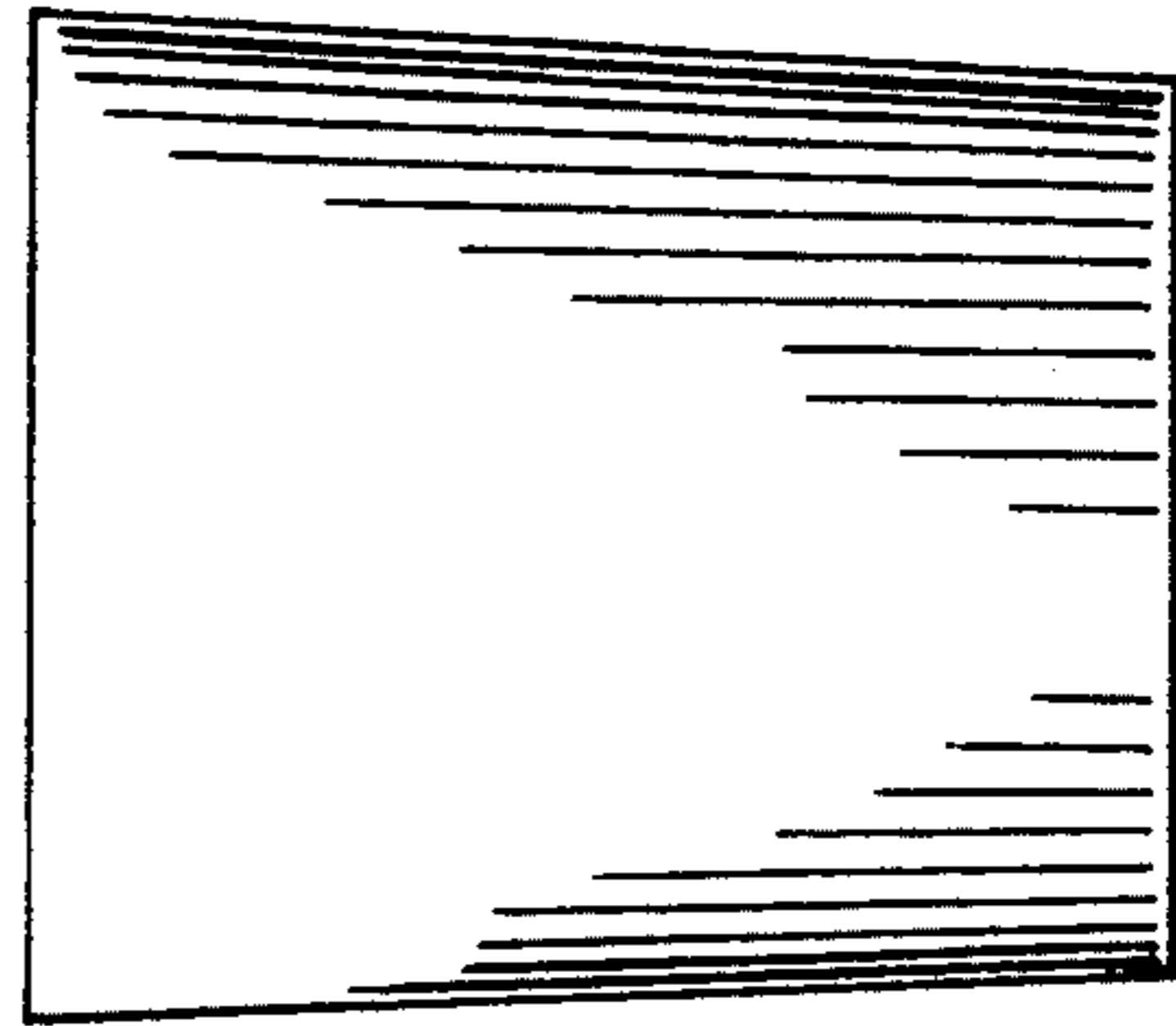
