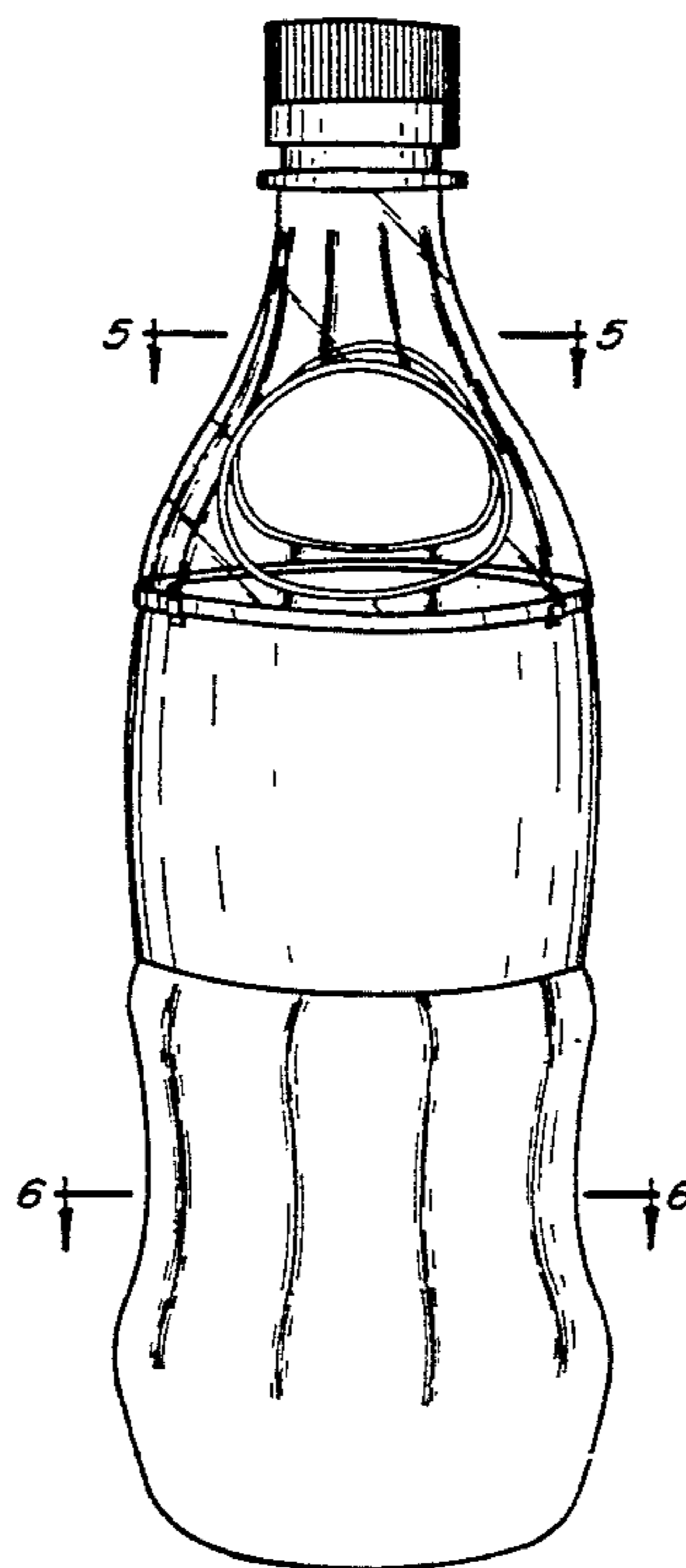

[57] **CLAIM**

The ornamental design for a contour bottle merchandiser and display cooler, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a contour bottle merchandiser and display cooler showing my new design the rear elevation view being a mirror thereof; FIG. 2 is a side elevational view thereof, the opposite side being a mirror image thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a cross-sectional view taken through line 5—5 of FIG. 1; and, FIG. 6 is a cross-sectional view taken through line 6—6 of FIG. 1.



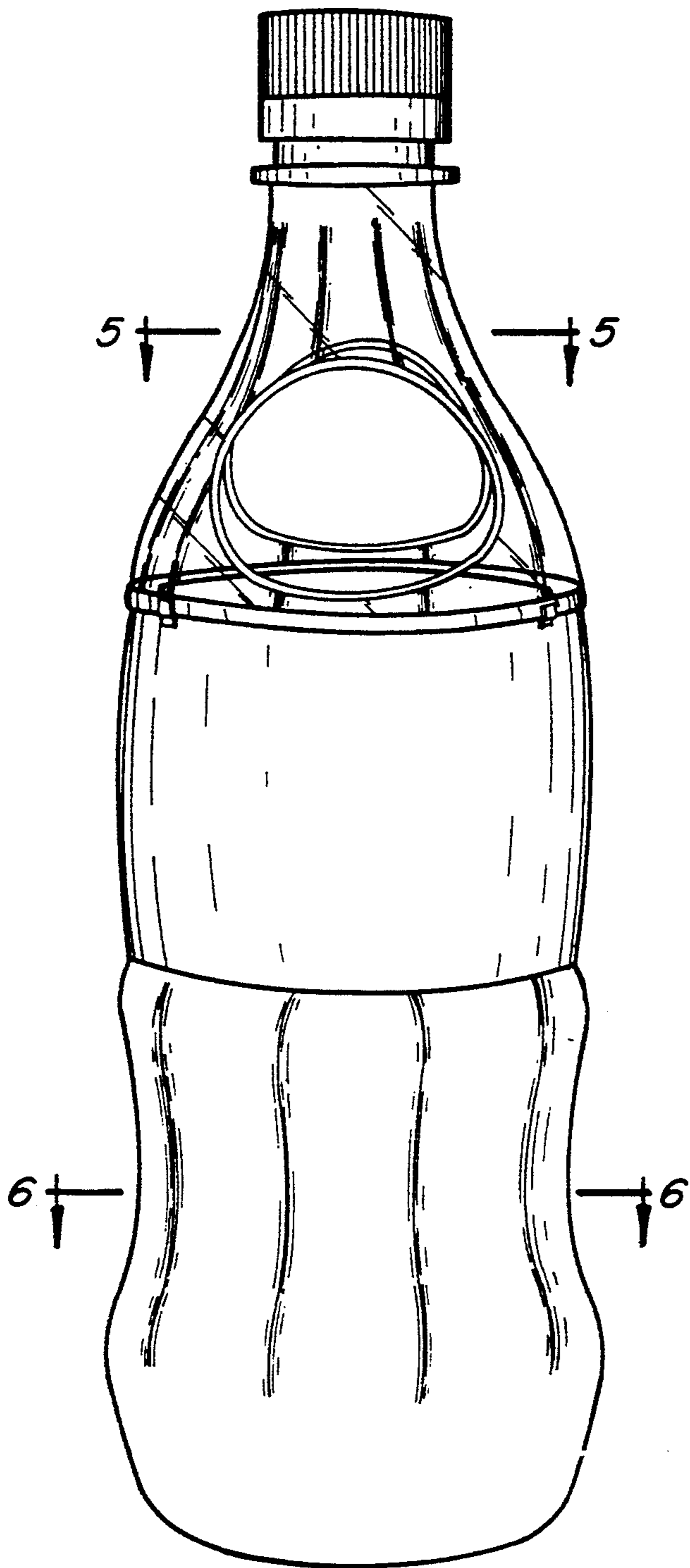

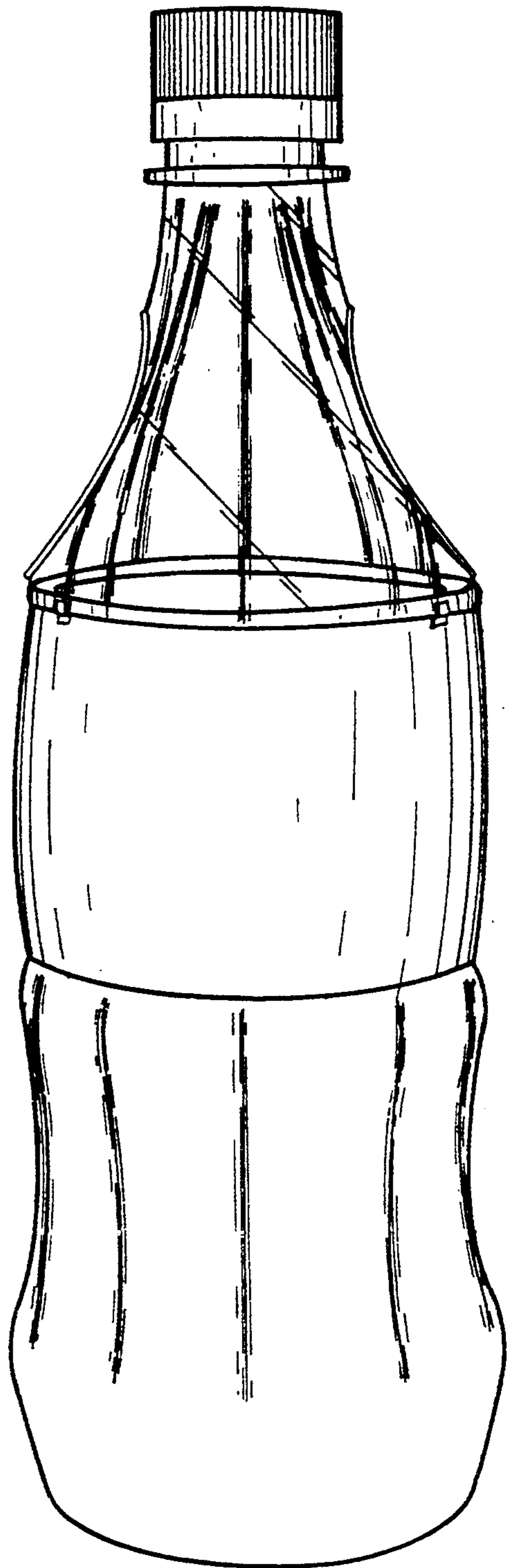

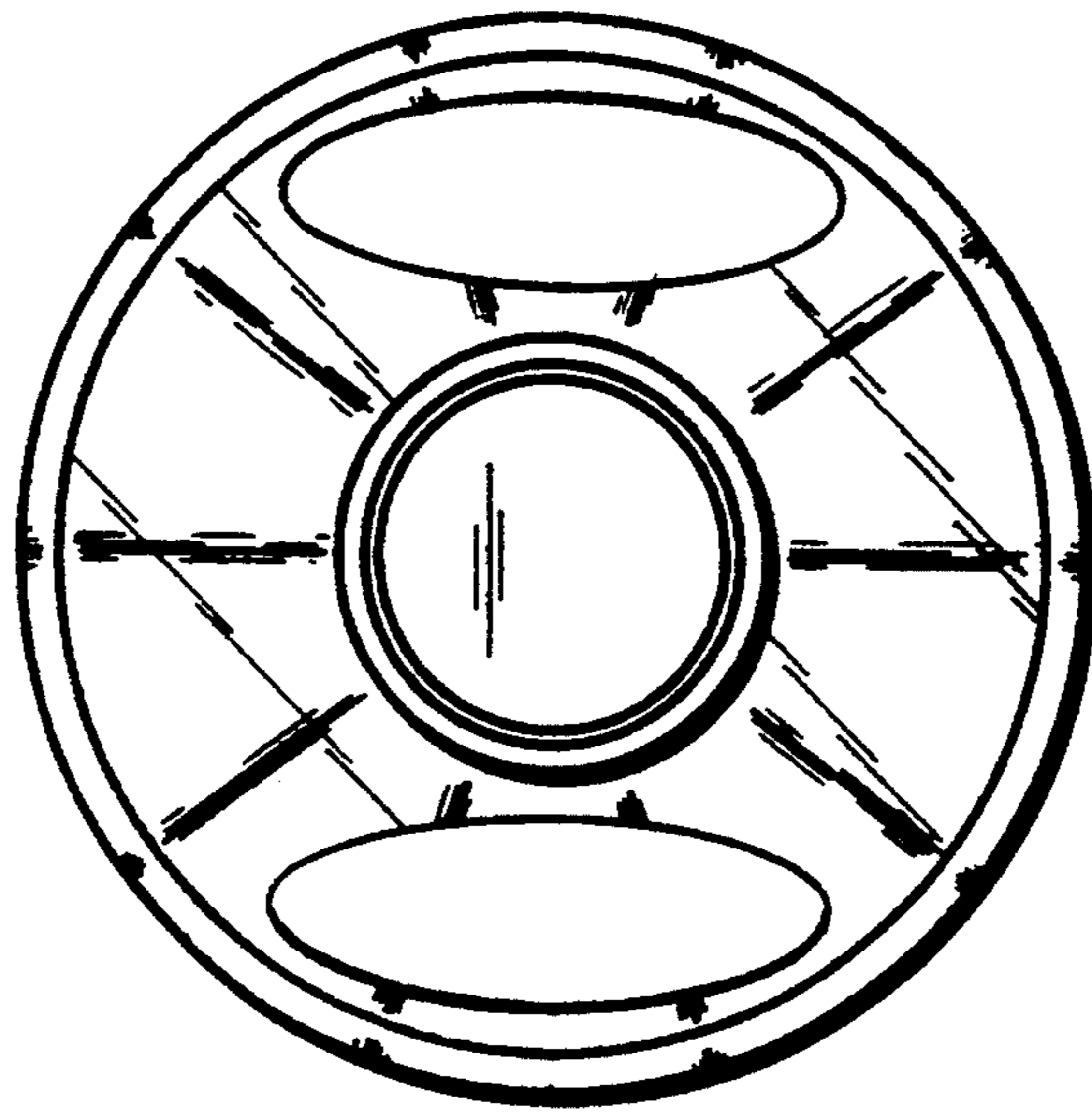

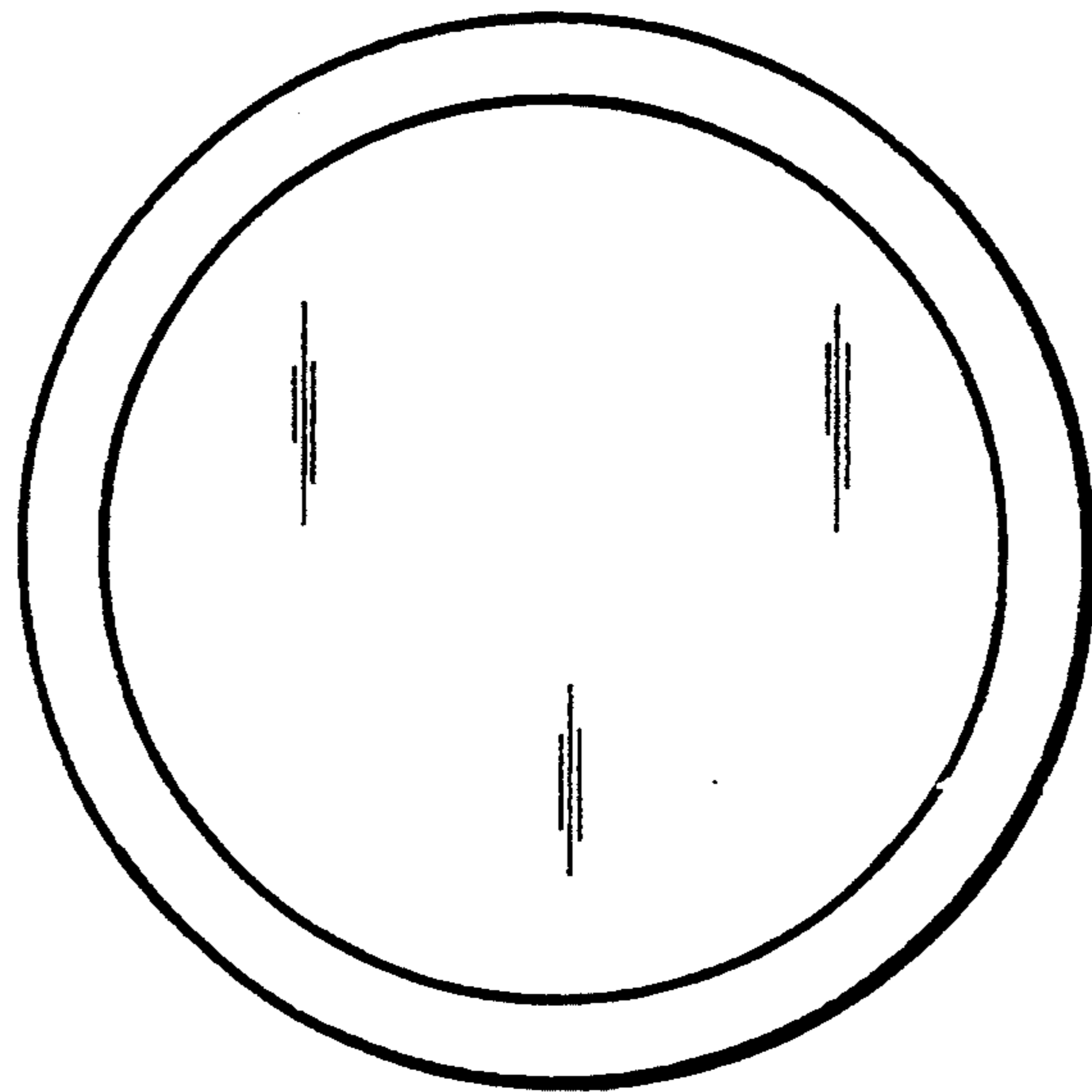

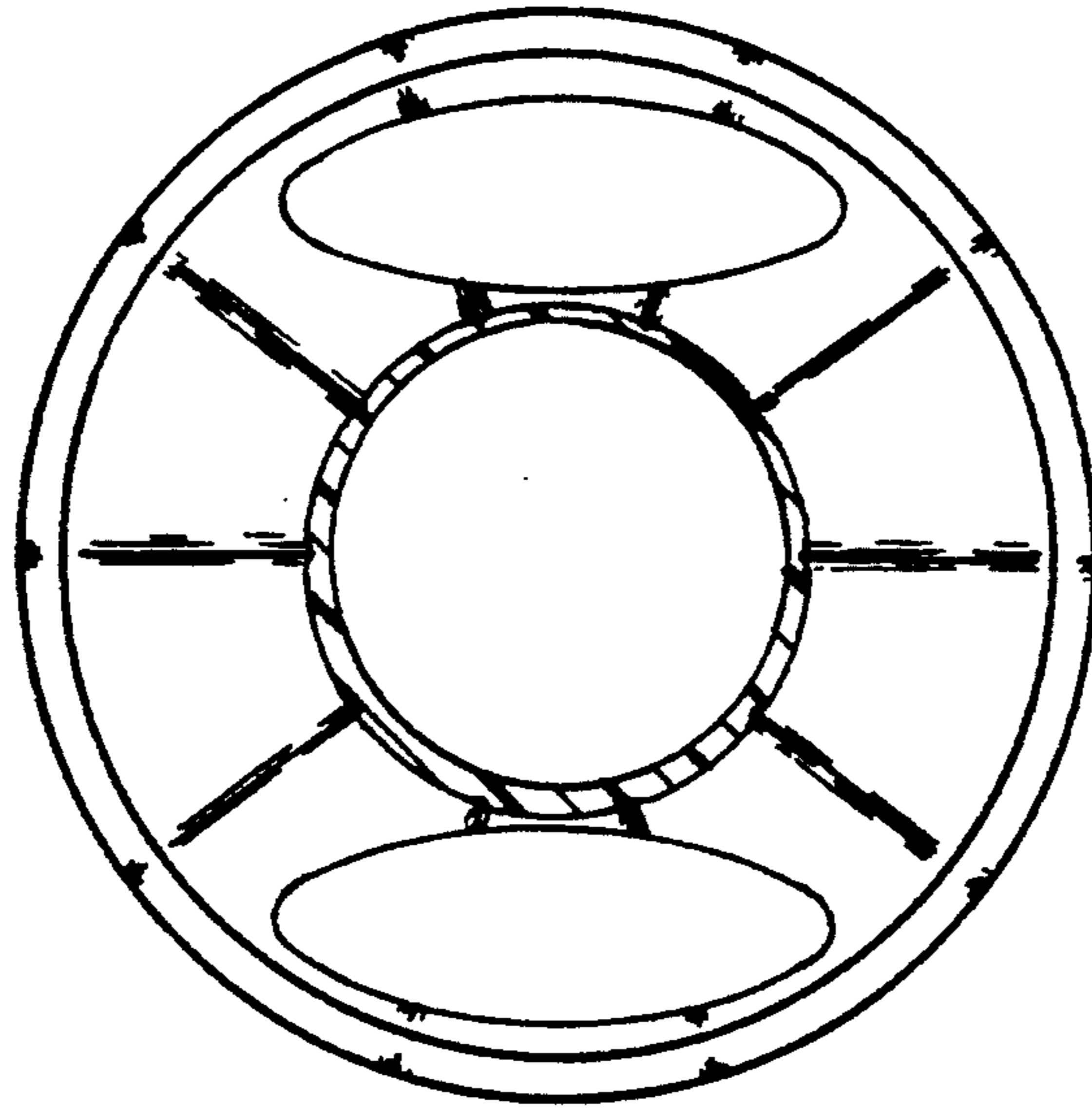

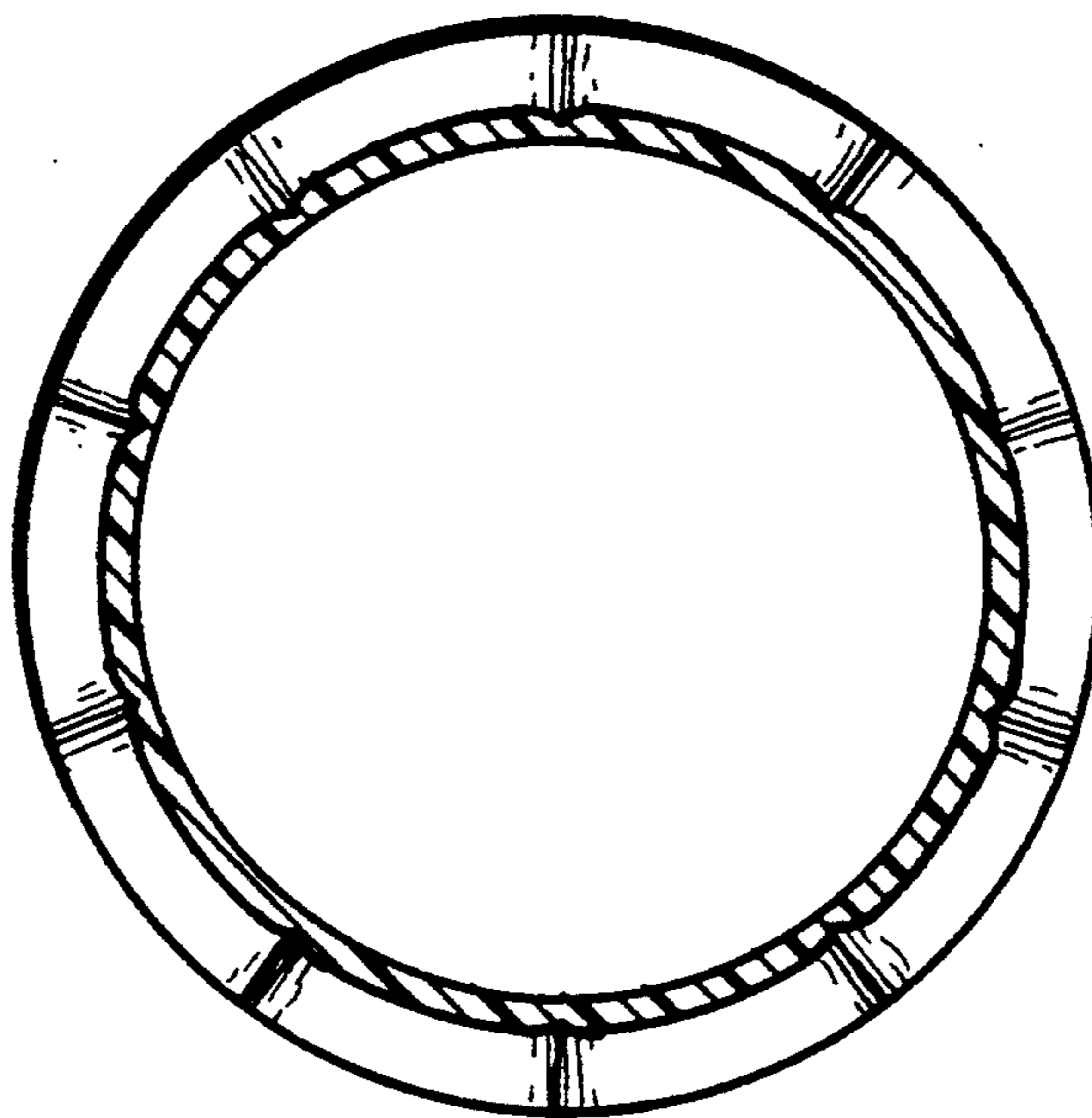
