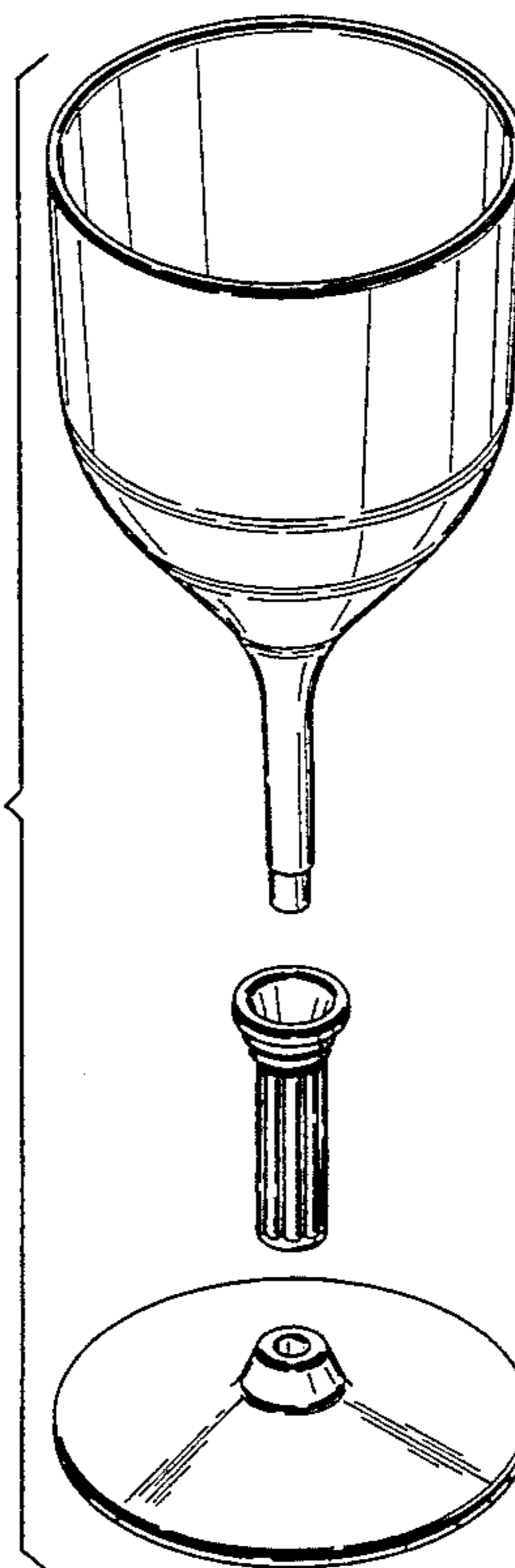
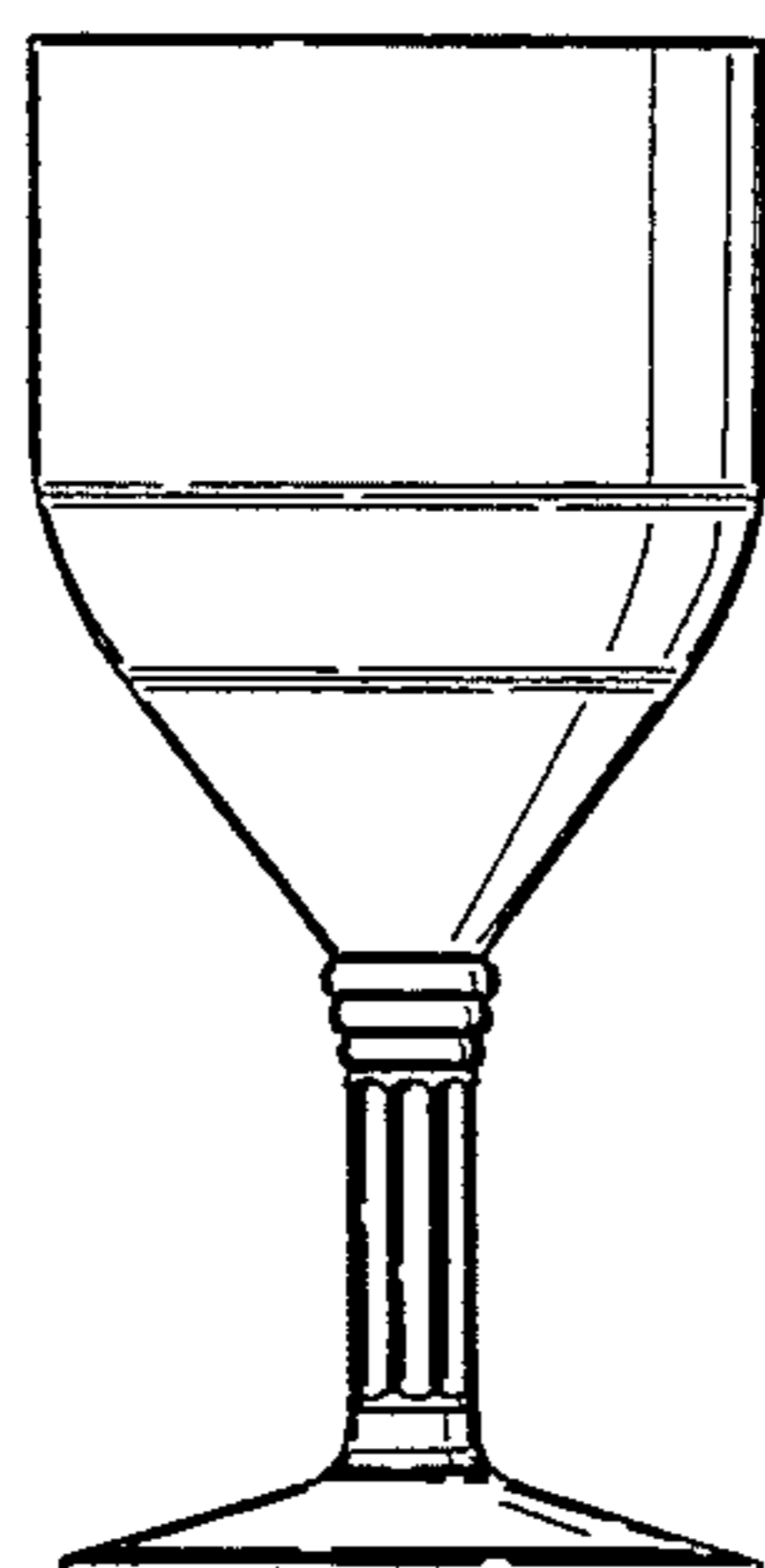

[57] CLAIM

The ornamental design for a beverage glass with a stem and base, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of a beverage glass with a stem and base showing my new design; FIG. 2 shows a bottom plan view thereof; FIG. 3 shows a side elevation view; FIG. 4 shows a top plan view thereof; and, FIG. 5 shows an exploded perspective view thereof.



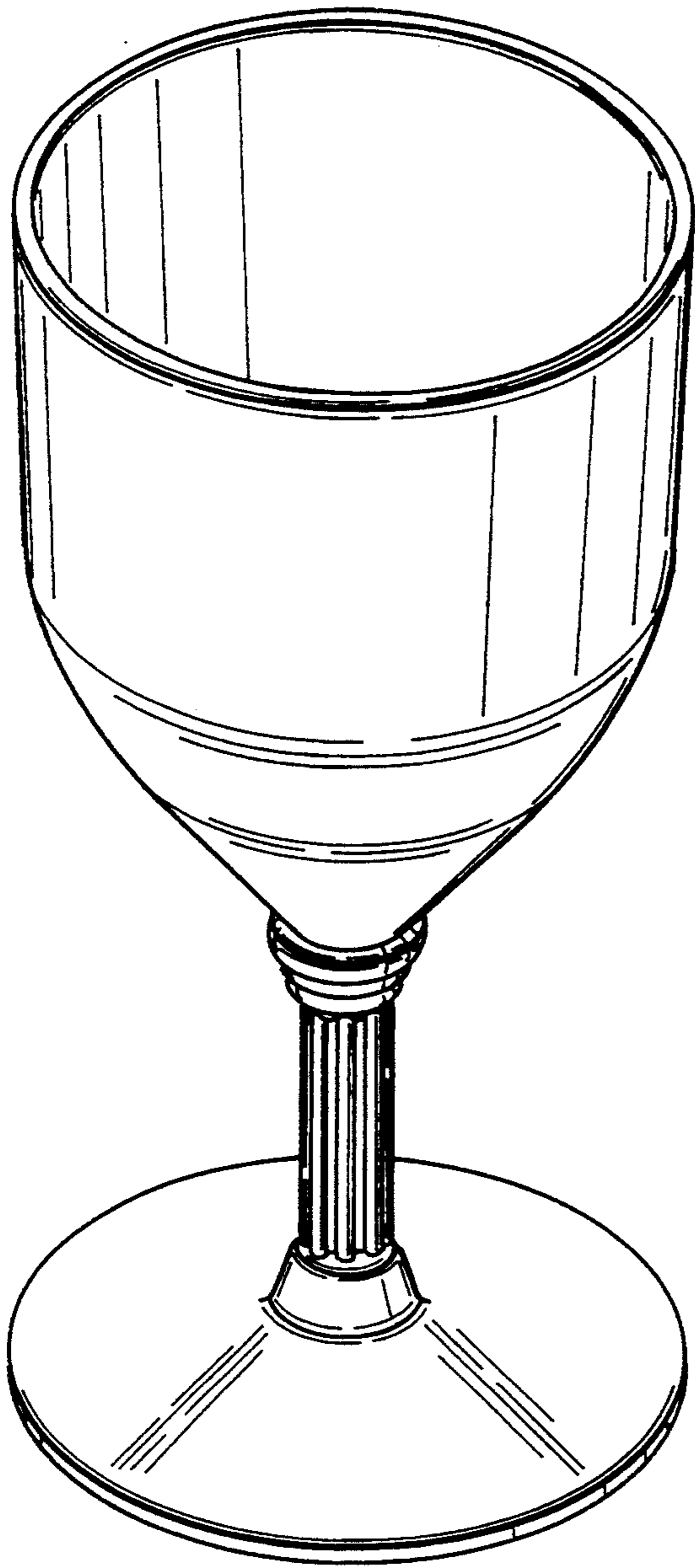

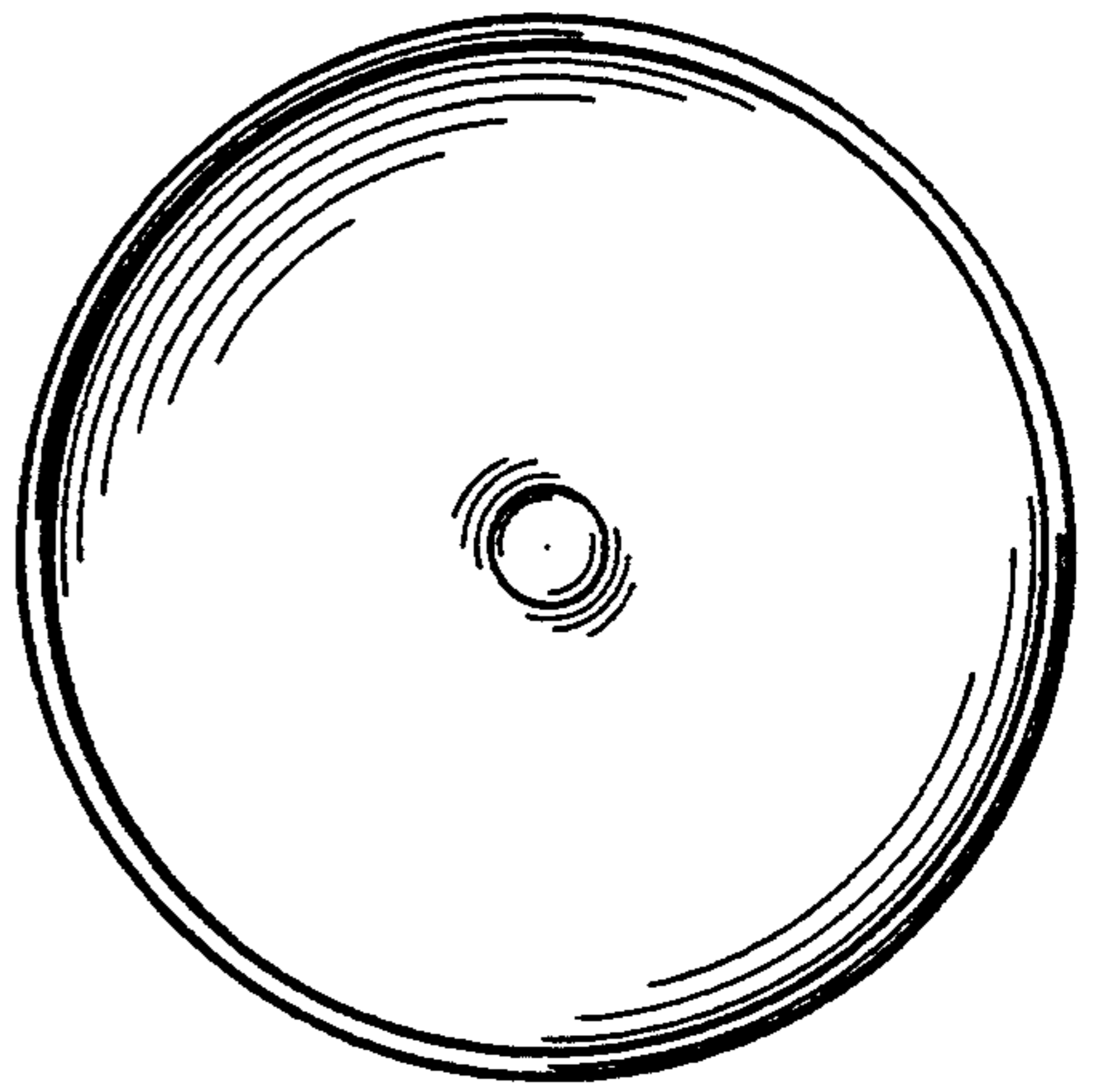

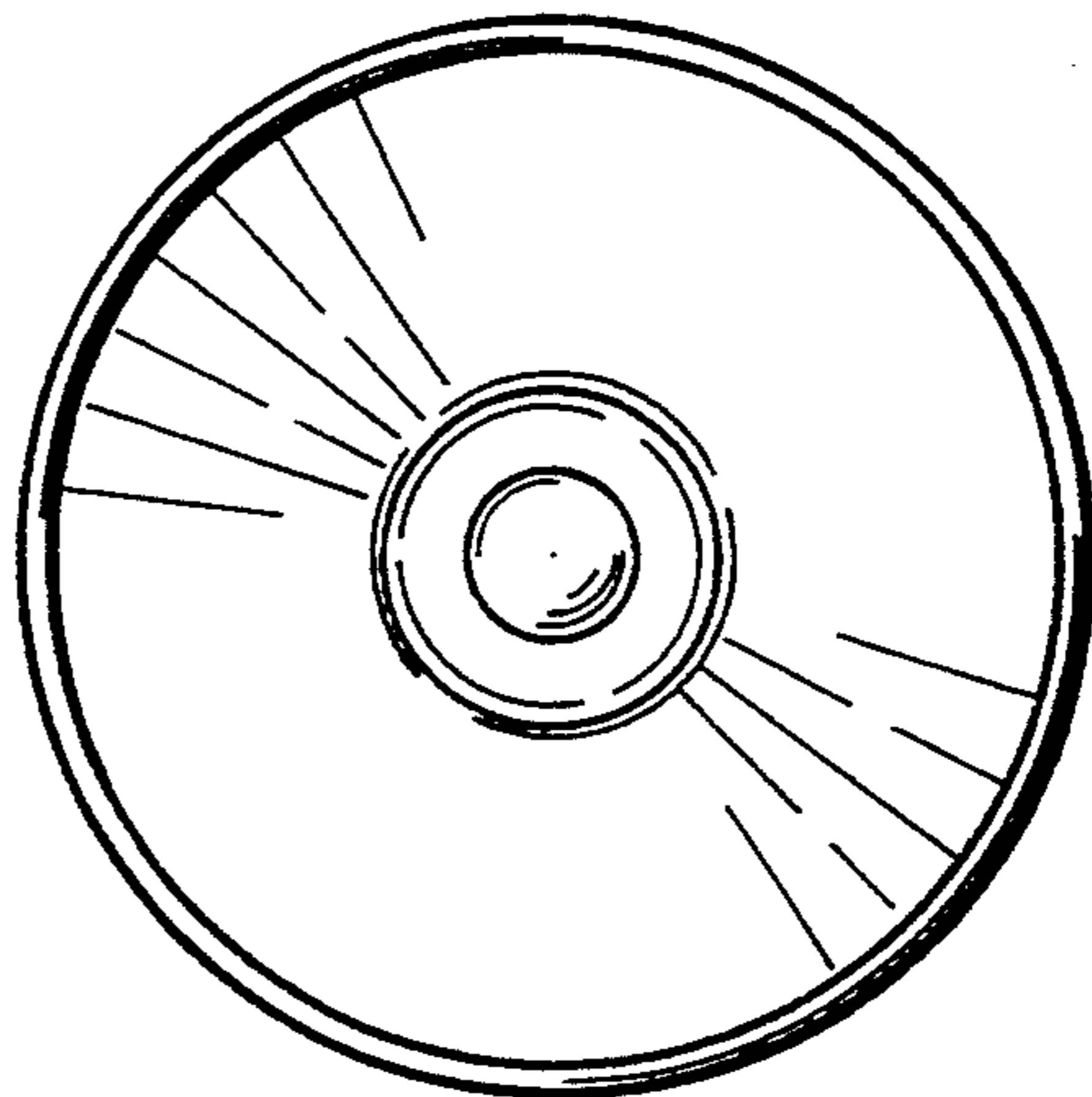

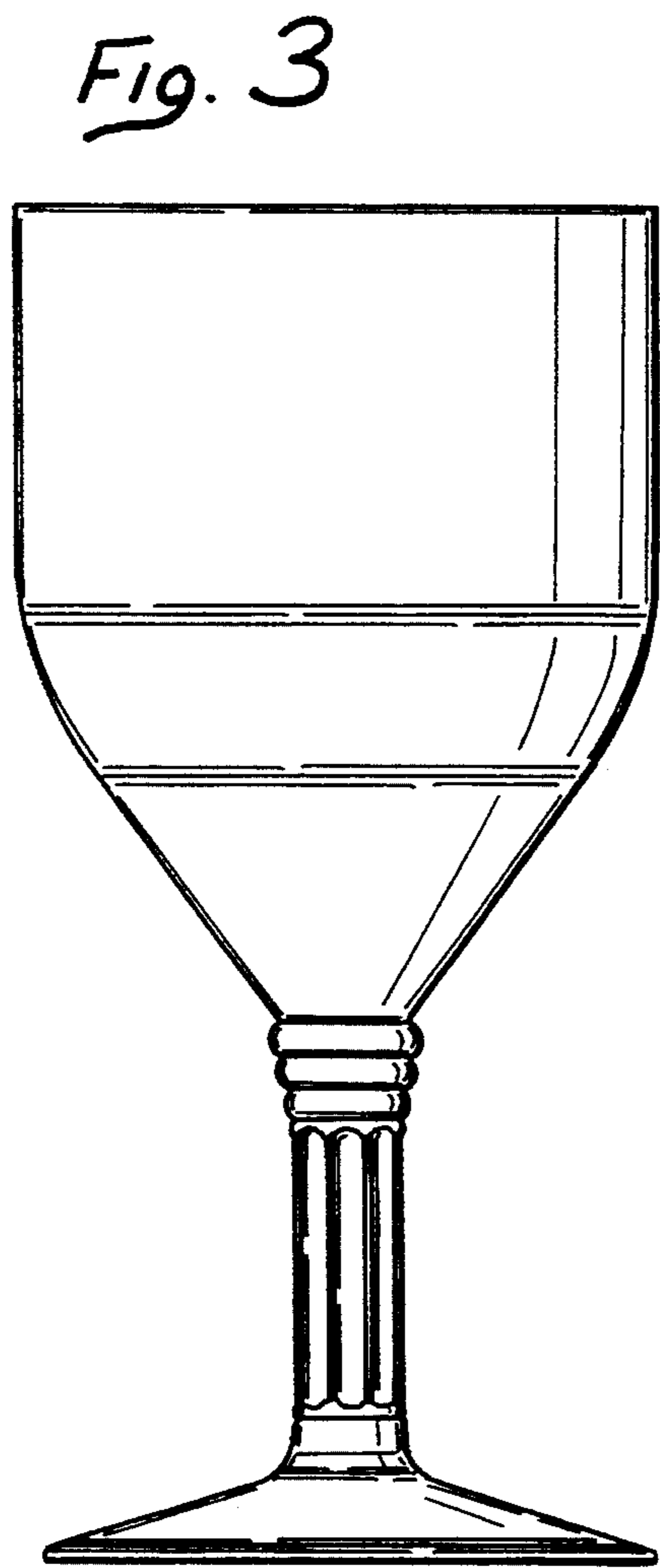
