DESCRIPTION

FIG. 1 is a side elevational view of a food storage container showing our new design, the opposite side being a mirror image;

FIG. 2-4 are side elevational views of alternate embodiments of FIG. 1, the opposite side being a mirror image;

FIG. 5 is a top plan view thereof;

FIGS. 6-8 are top plan views of FIGS. 2-4;

FIG. 9 is a front elevational view thereof, the opposite side being a mirror image;

FIGS. 10- are front elevational views of FIGS. 2-4, the opposite side being a mirror image;

FIG. 13 is a bottom plan view thereof;

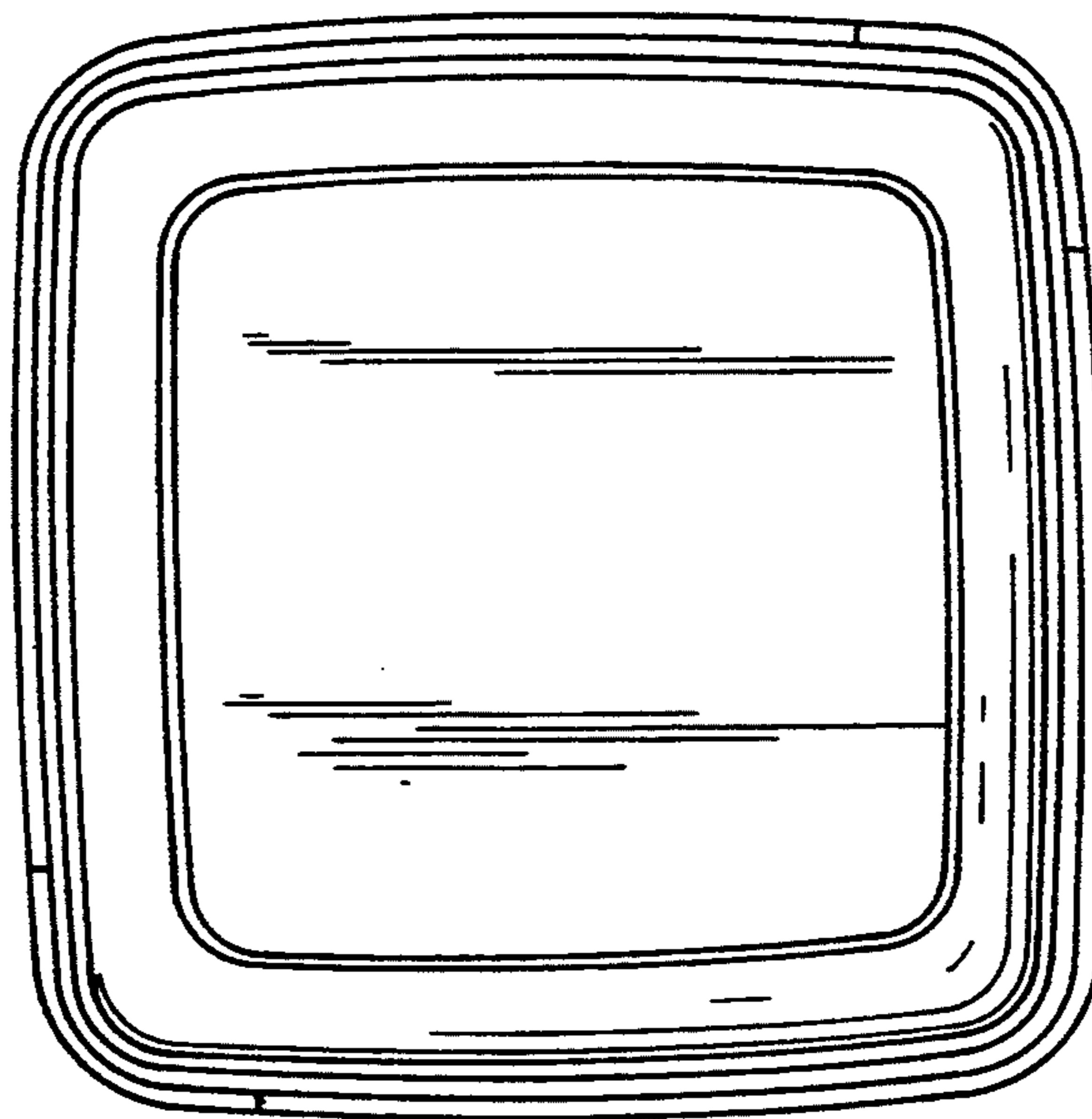
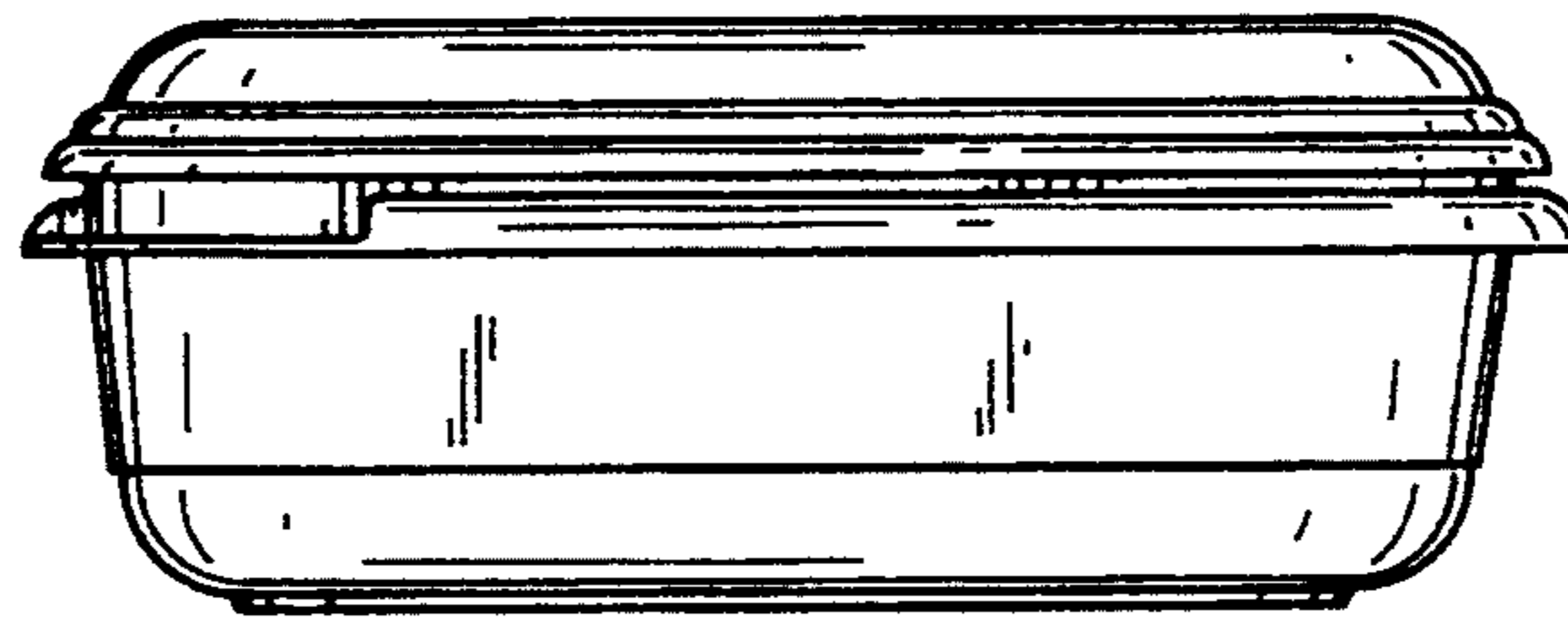
FIGS. 14-16 are bottom plan views of FIGS. 2-3;

FIG. 20 is a bottom plan view of FIG. 17.



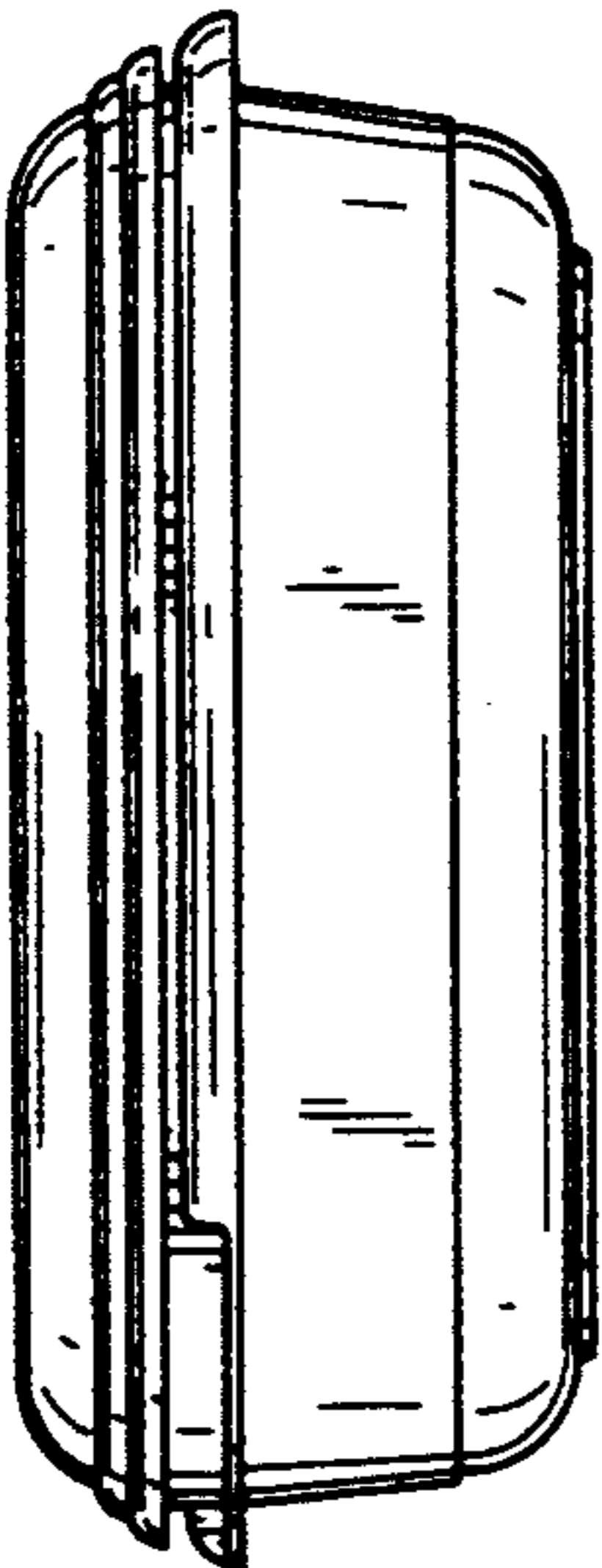

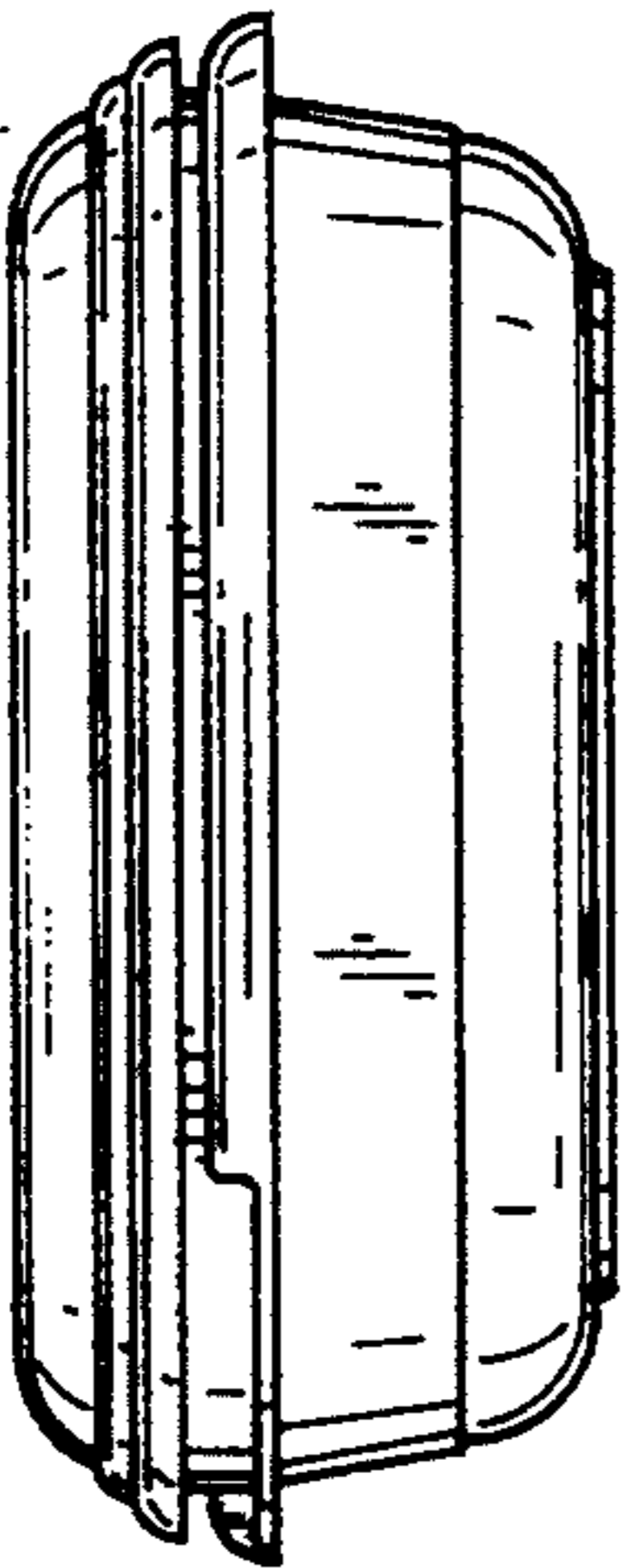

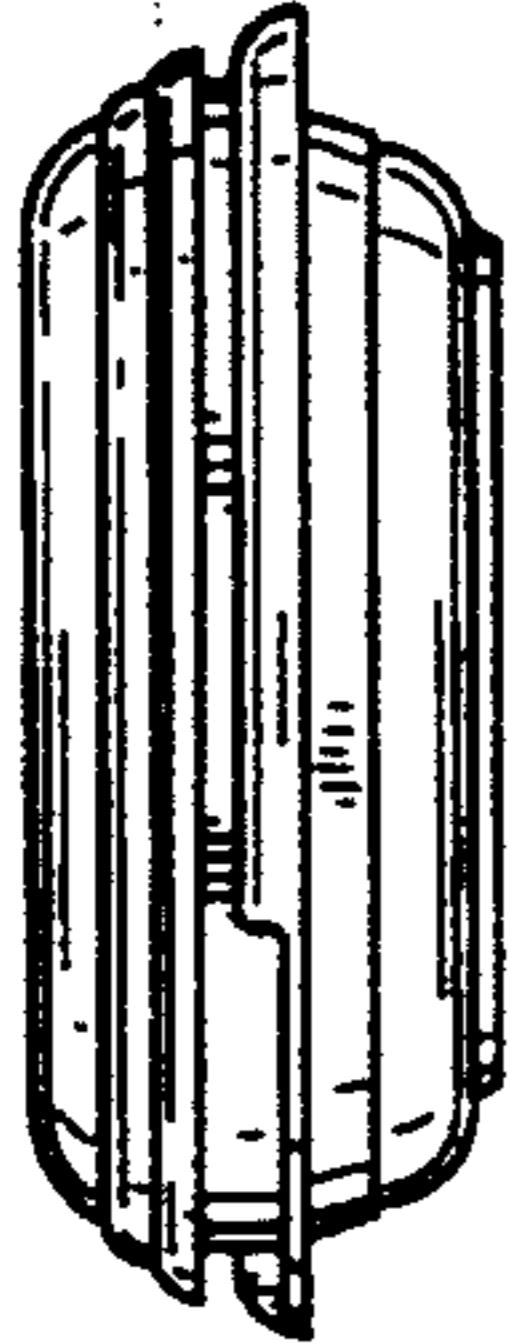

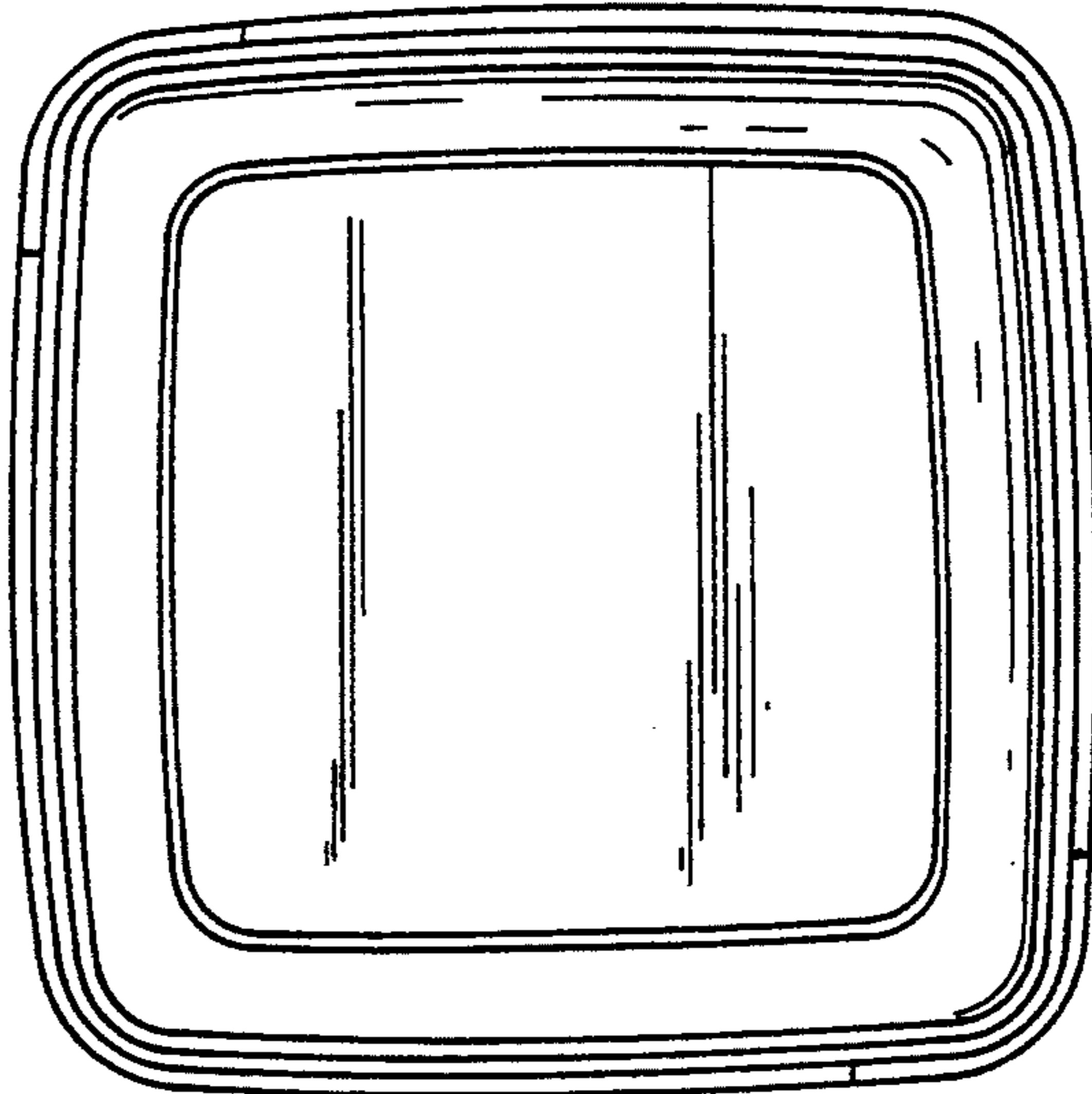

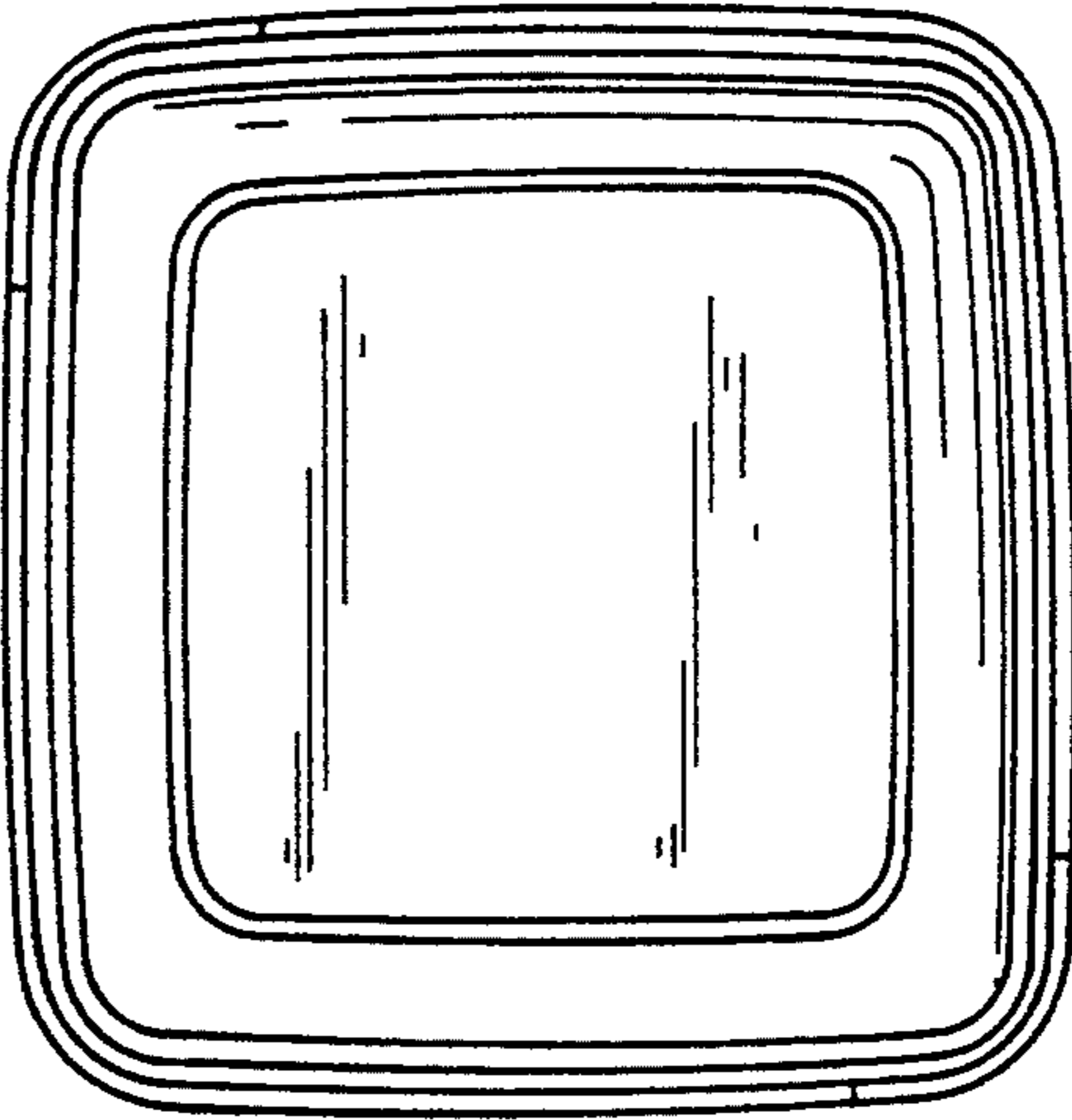

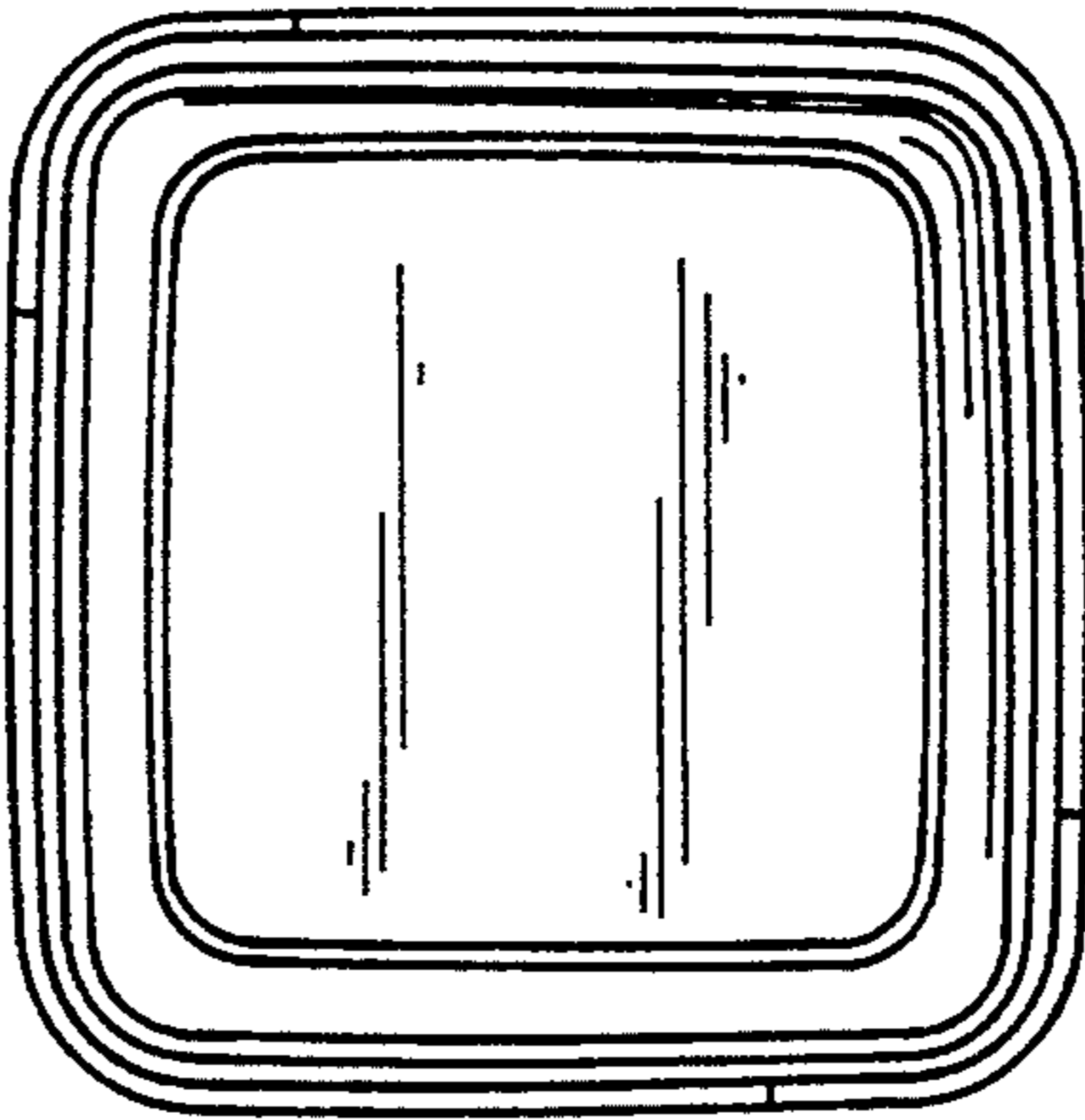

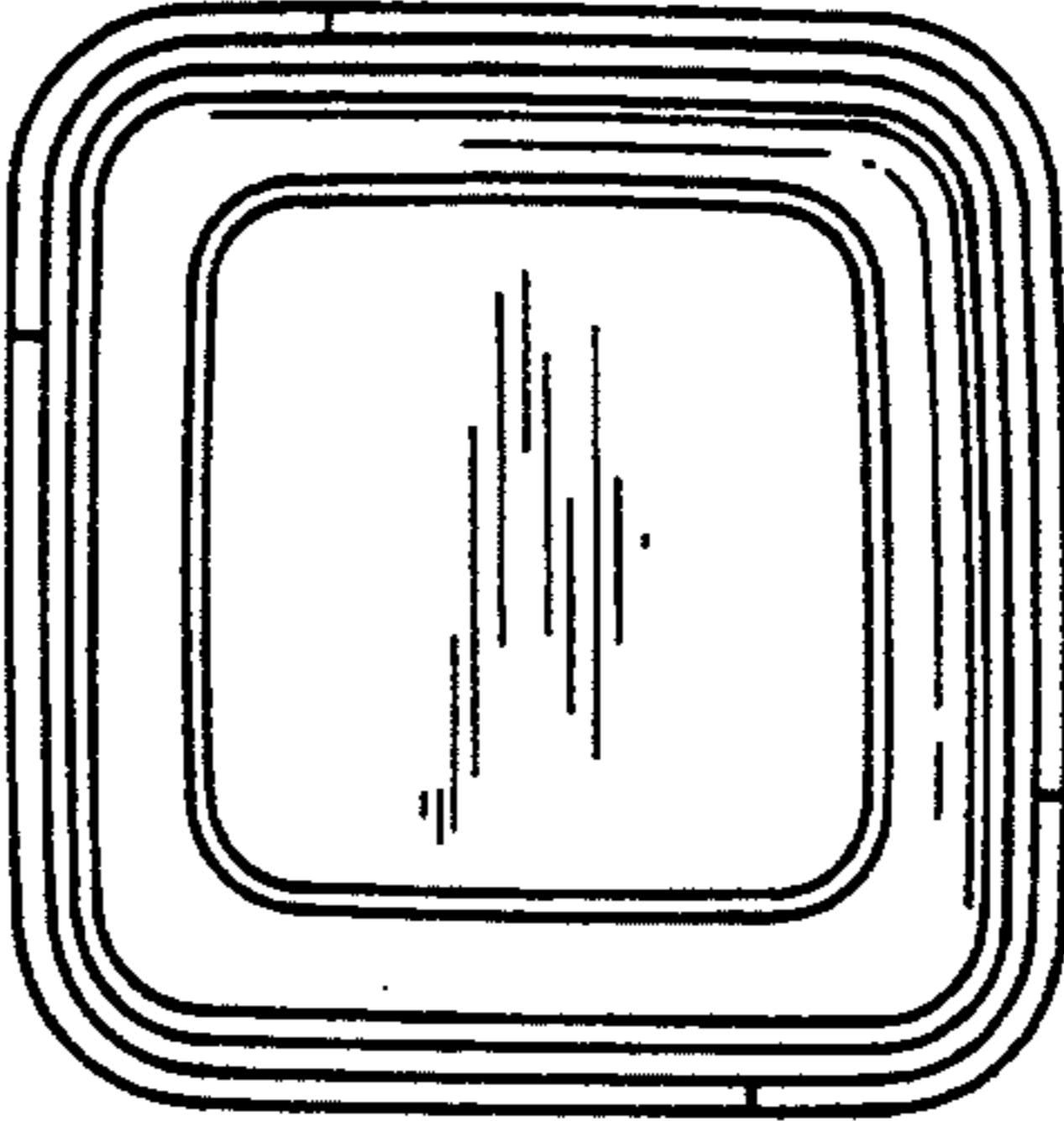

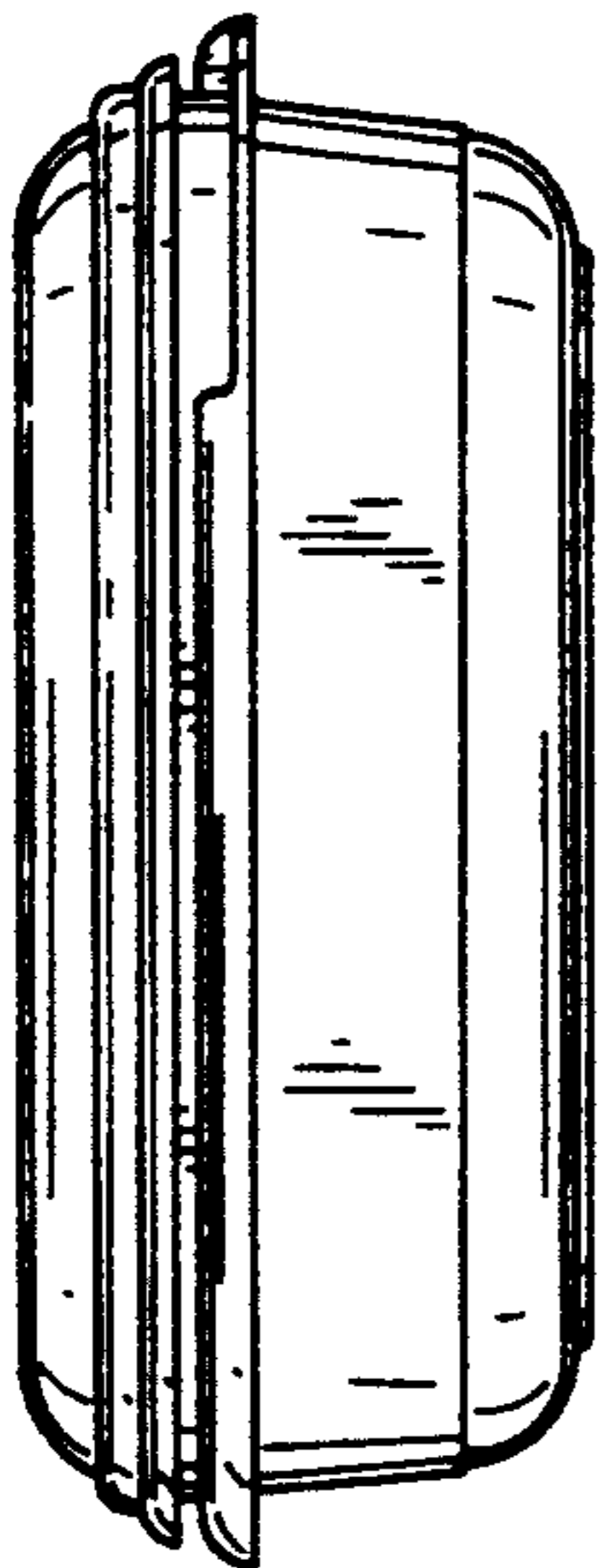

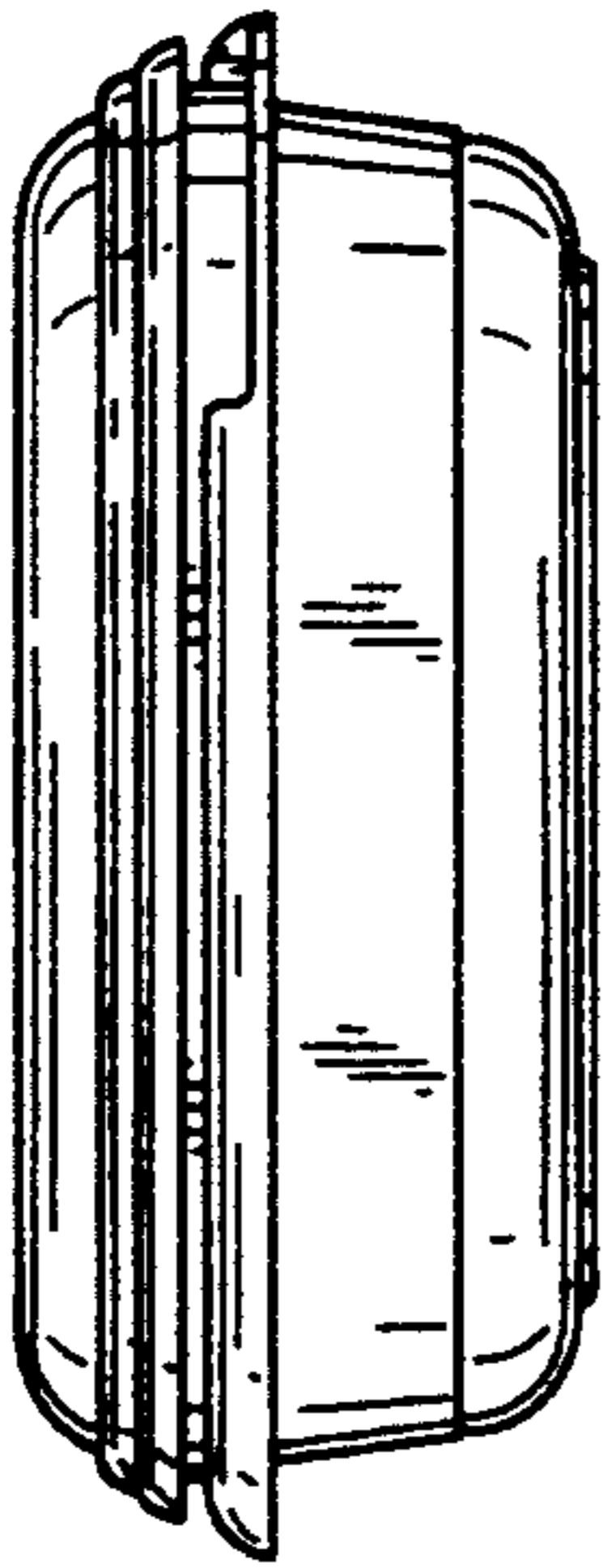

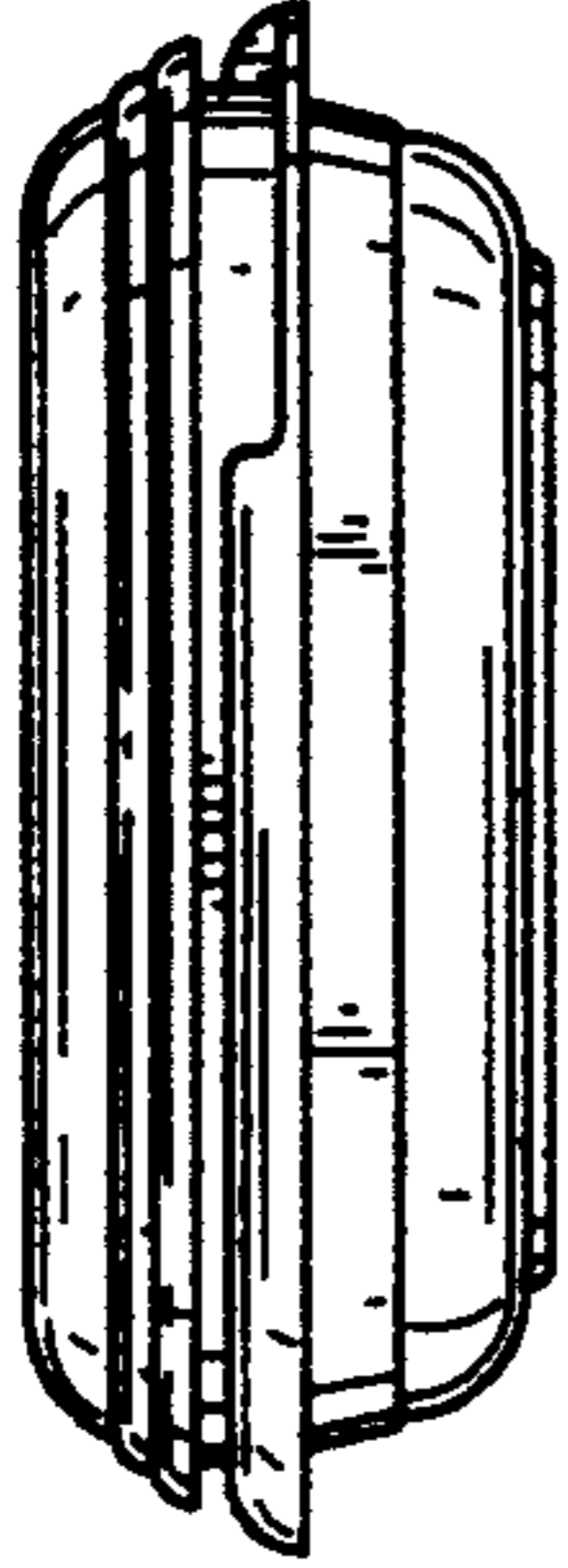

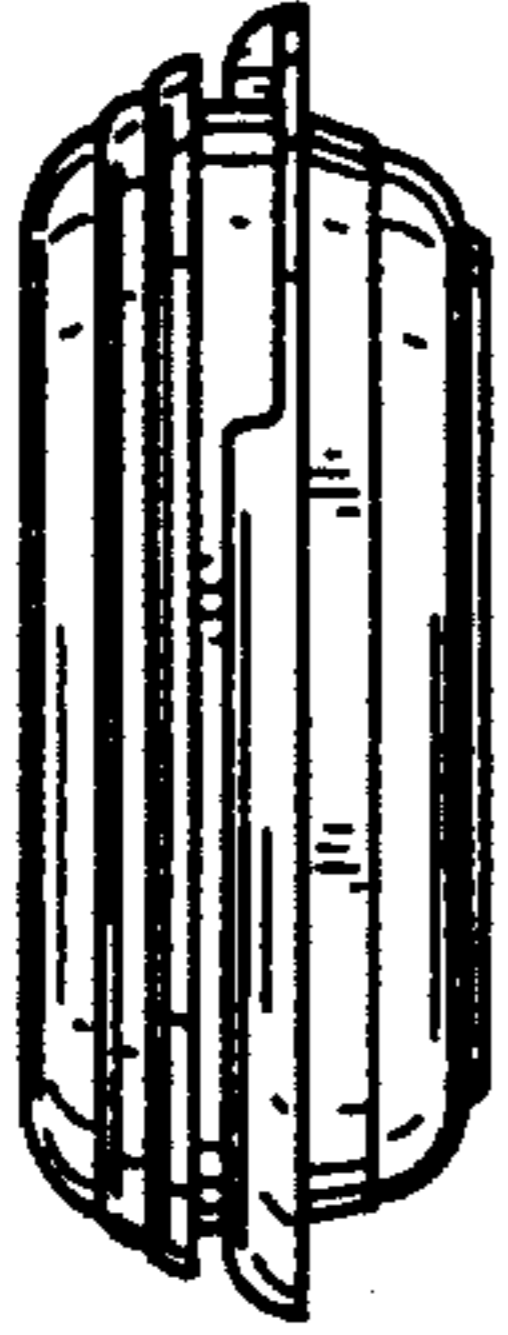

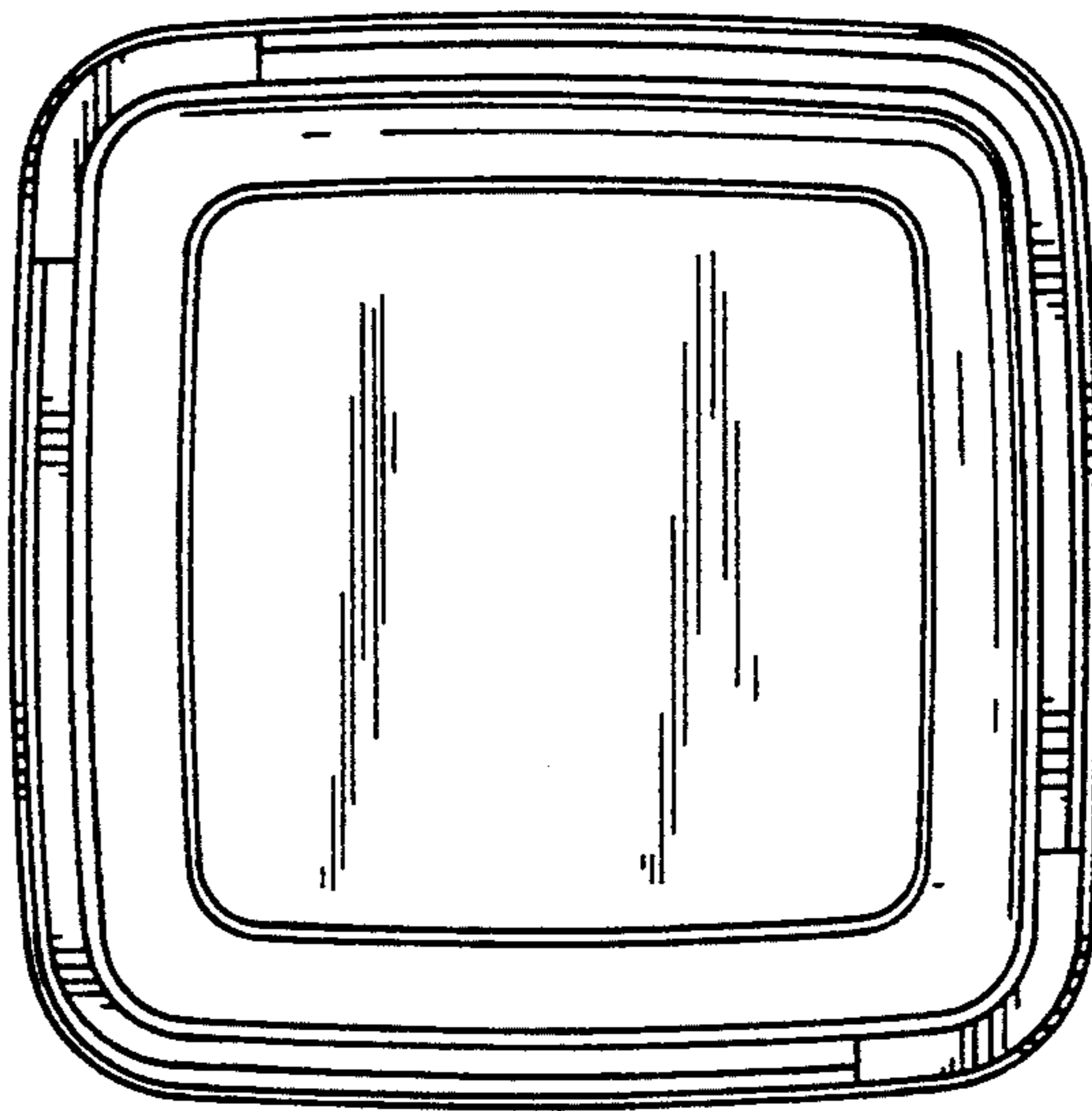

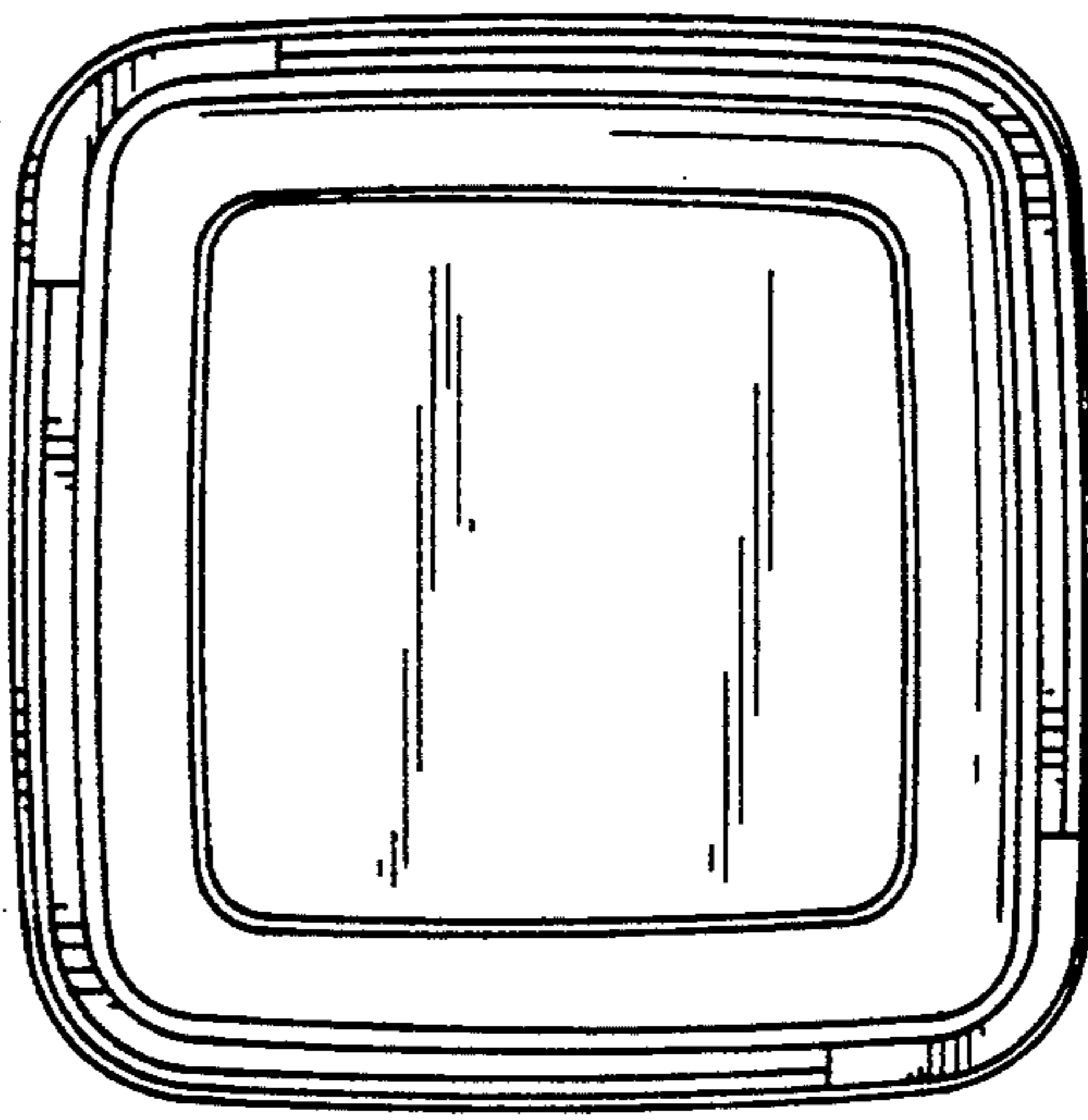

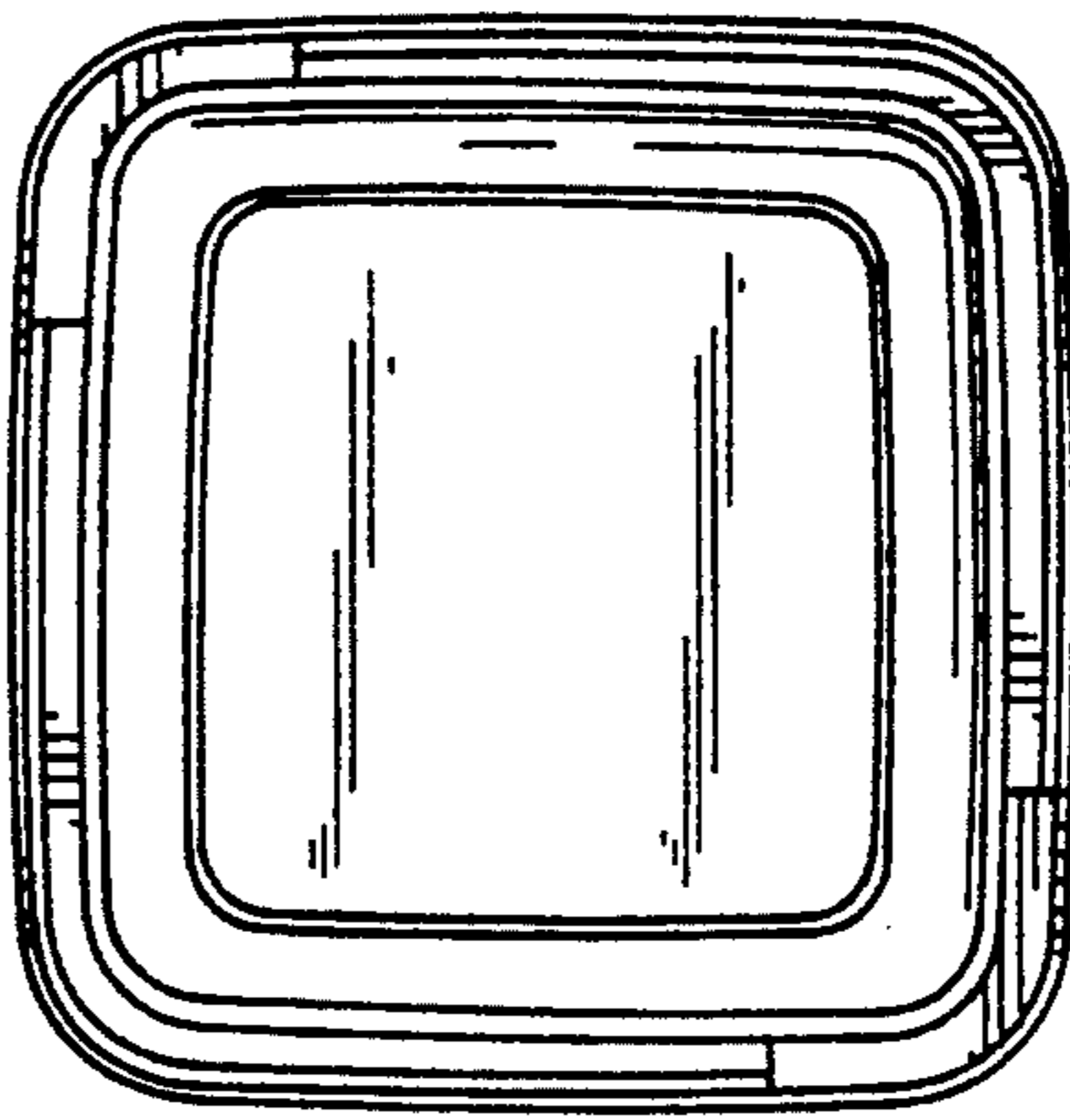

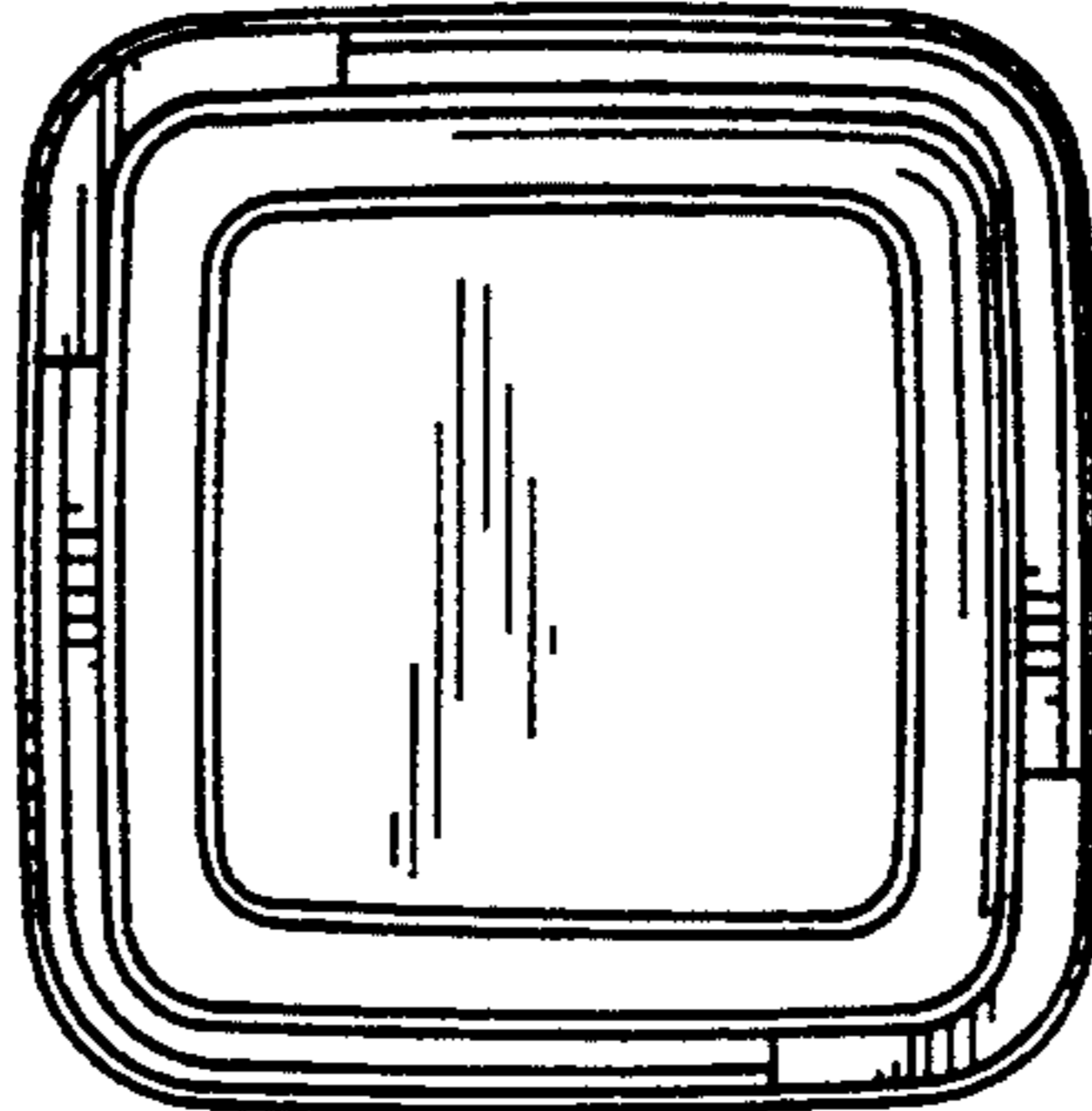

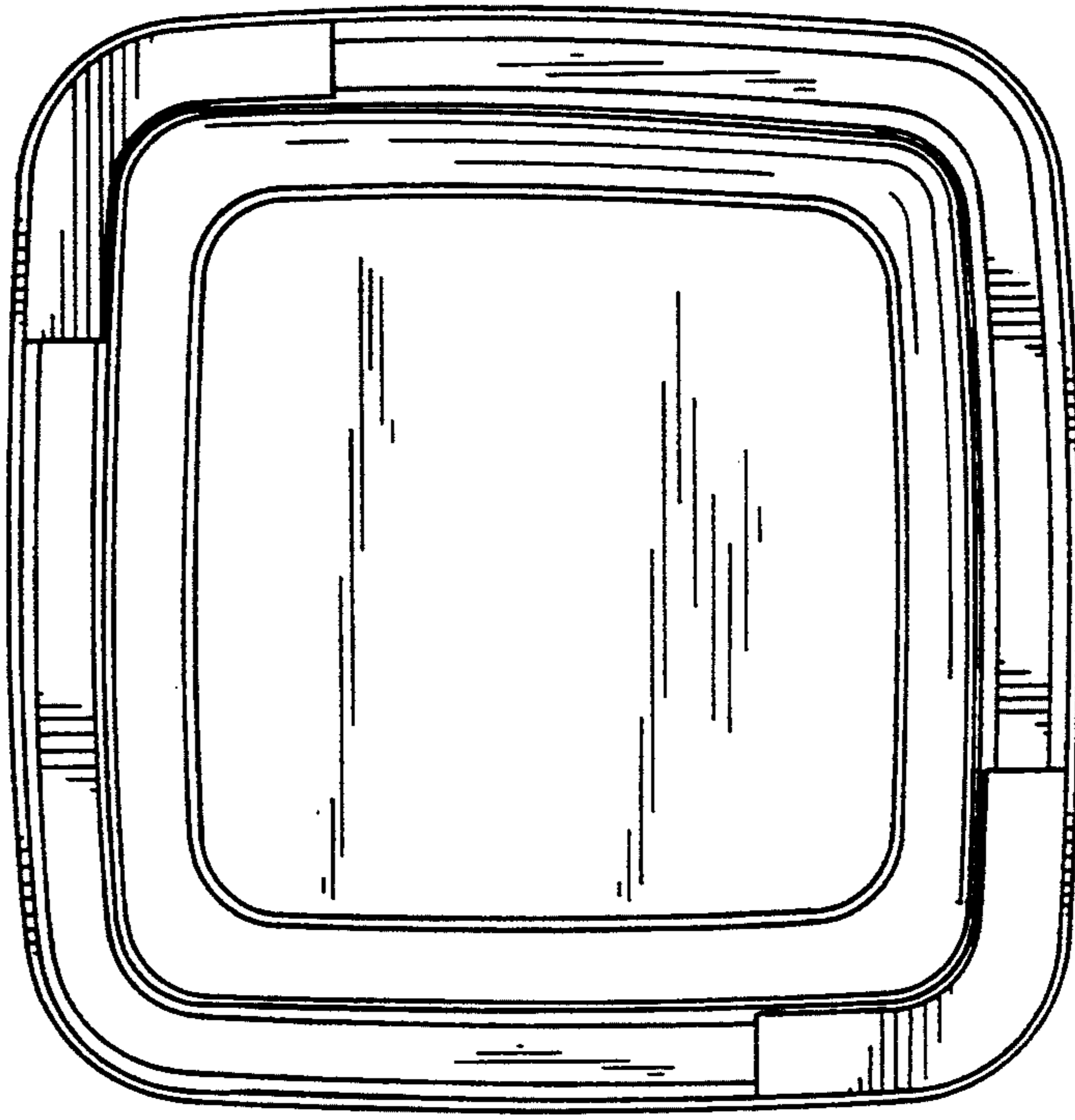
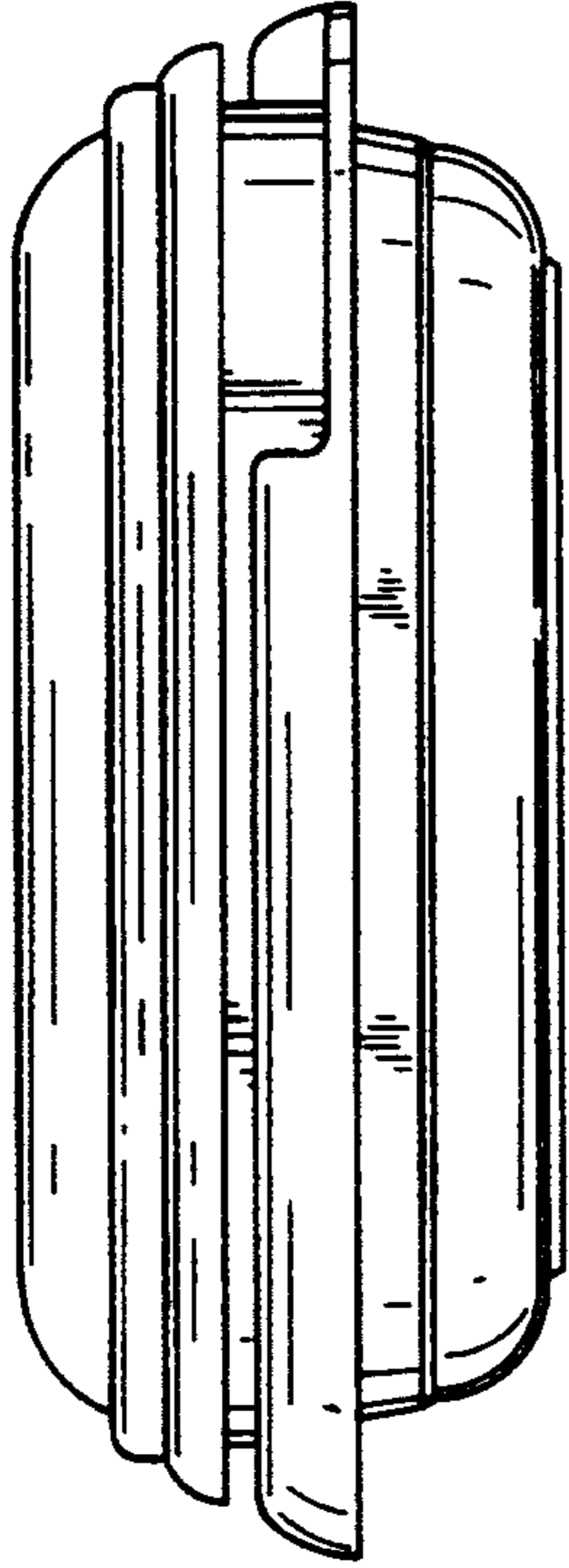

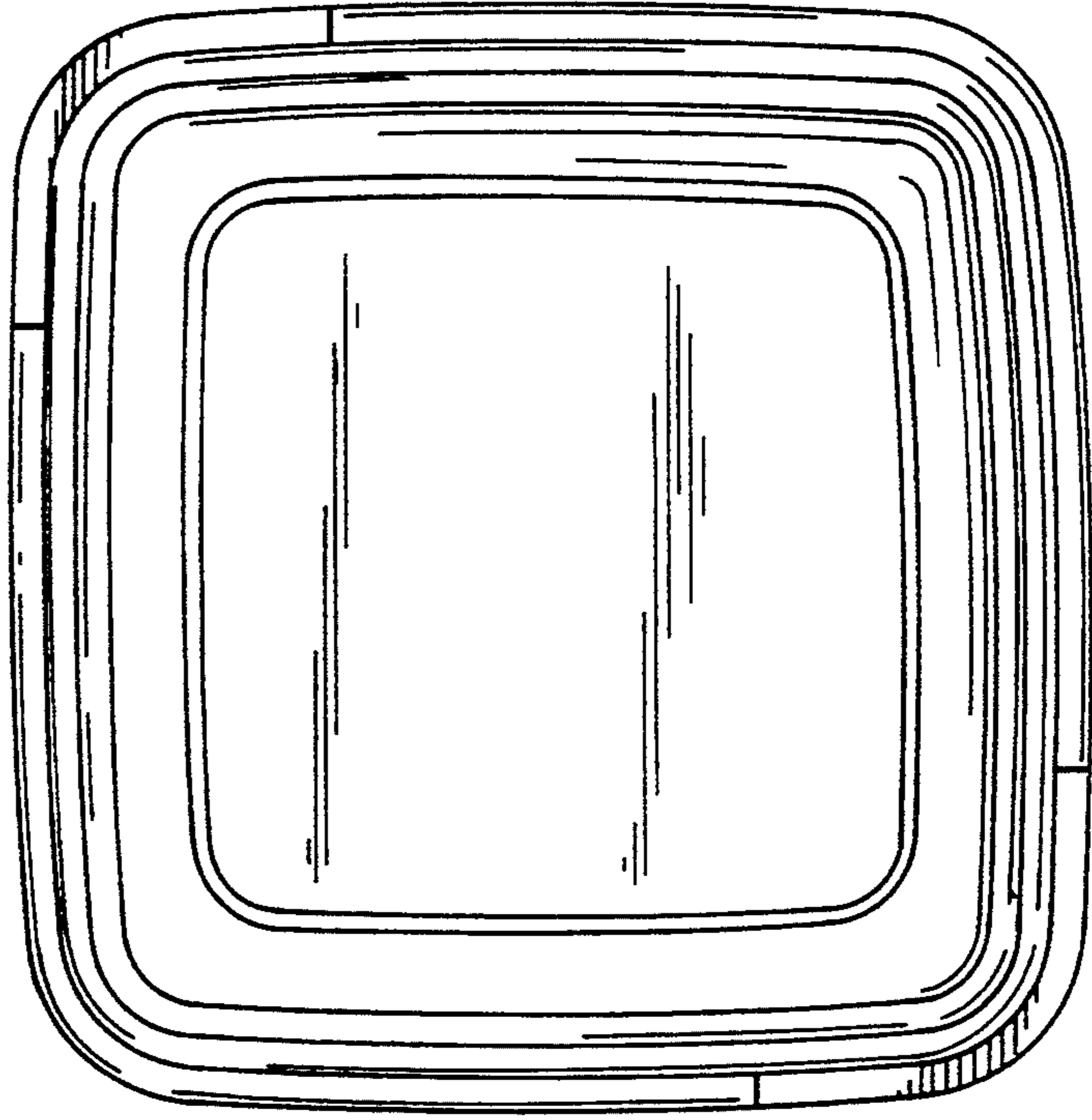
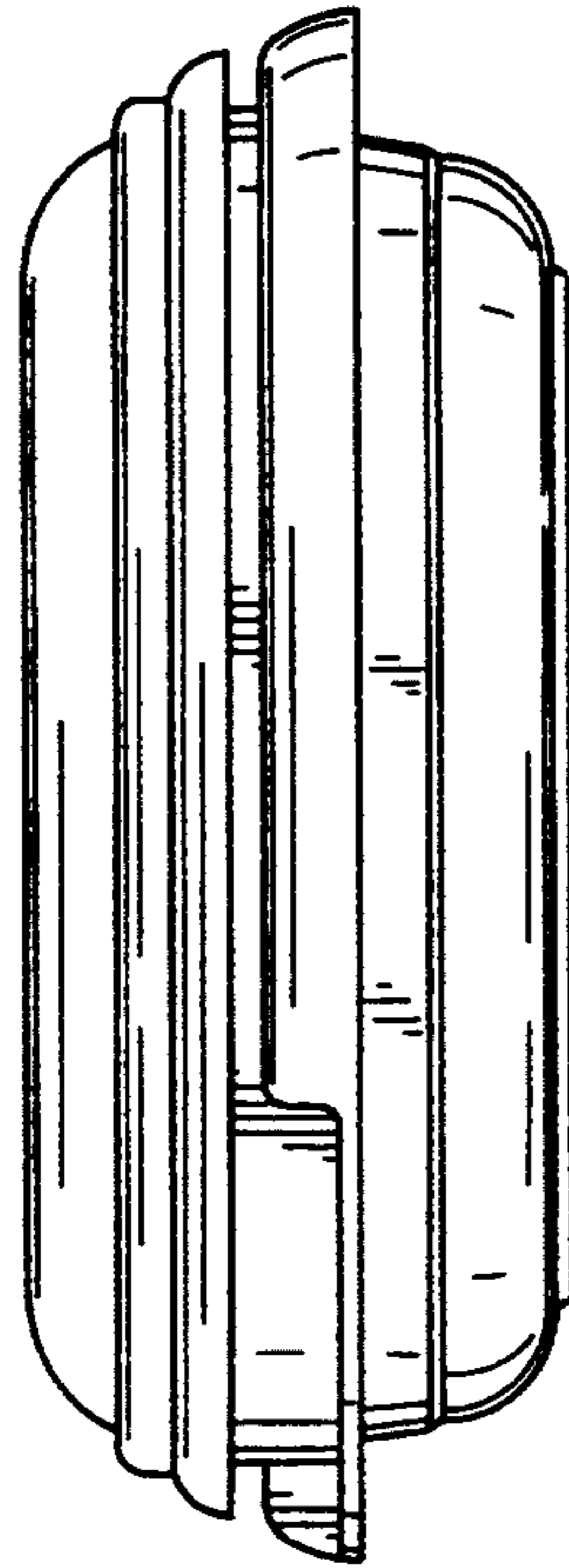
