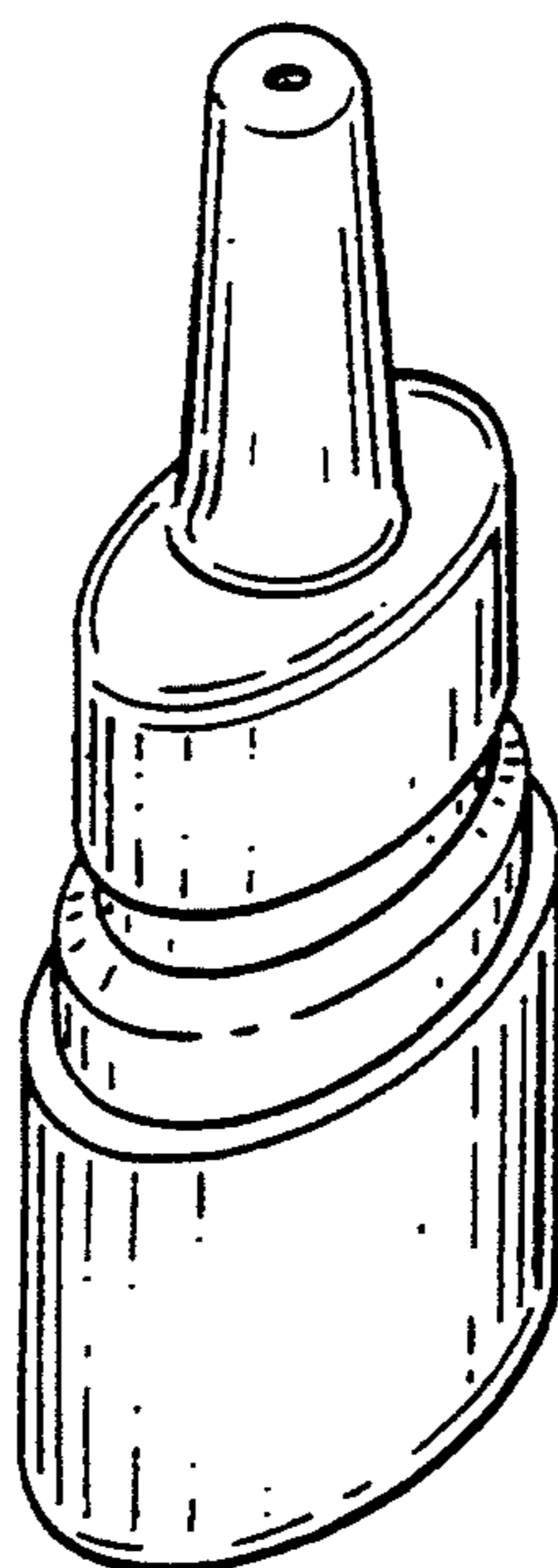

[57] **CLAIM**

The ornamental design for a spray bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the bottle showing our new design;
 FIG. 2 is a front view thereof, the undisclosed opposite side being identical;
 FIG. 3 is a side view thereof, the undisclosed opposite side being identical;
 FIG. 4 is a bottom view thereof;
 FIG. 5 is a top view thereof;
 FIG. 6 is a perspective view thereof, with the cover removed for clarity of illustration;
 FIG. 7 is a front view of FIG. 6, the undisclosed opposite side being identical;
 FIG. 8 is a side view of FIG. 6, the undisclosed opposite side being identical;
 FIG. 9 is a top view of FIG. 6;
 FIG. 10 is a perspective view of a second embodiment of the bottle as disclosed in FIG. 1;
 FIG. 11 is a front view of FIG. 10, the undisclosed opposite side being identical;
 FIG. 12 is a perspective view of FIG. 10, with the cover removed for clarity of illustration; and,
 FIG. 13 is a front view of FIG. 12, the undisclosed opposite side being identical.



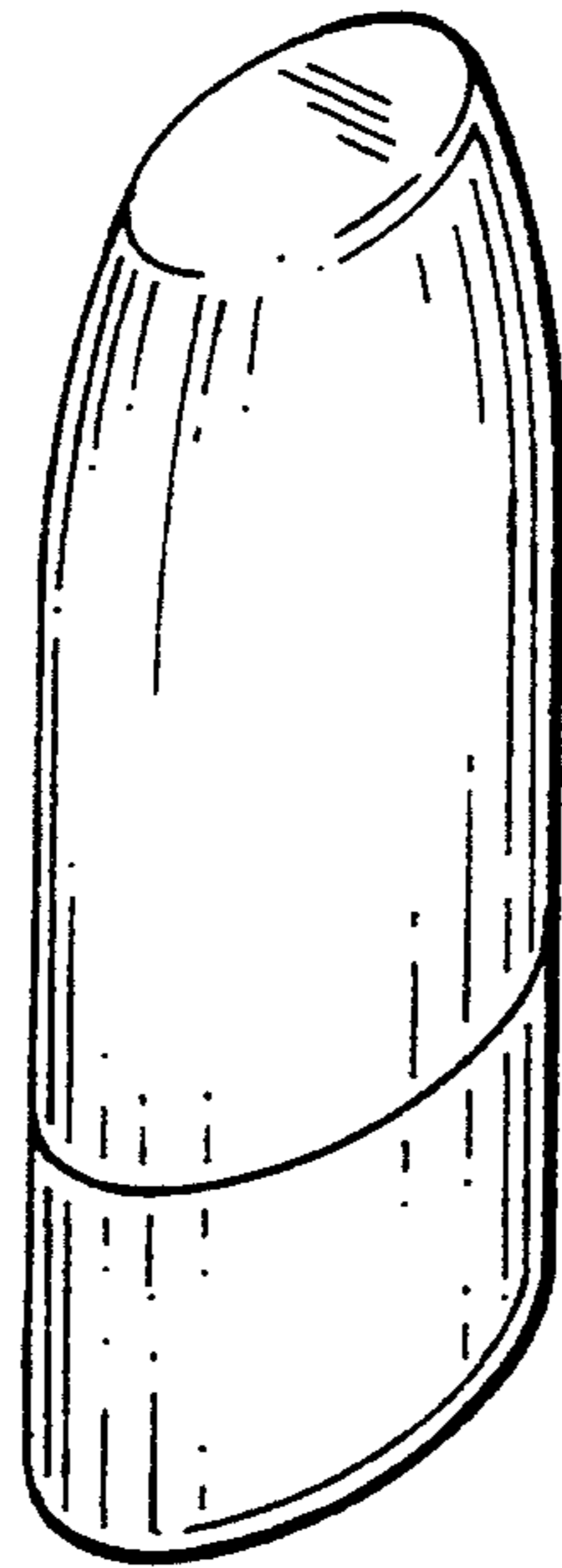

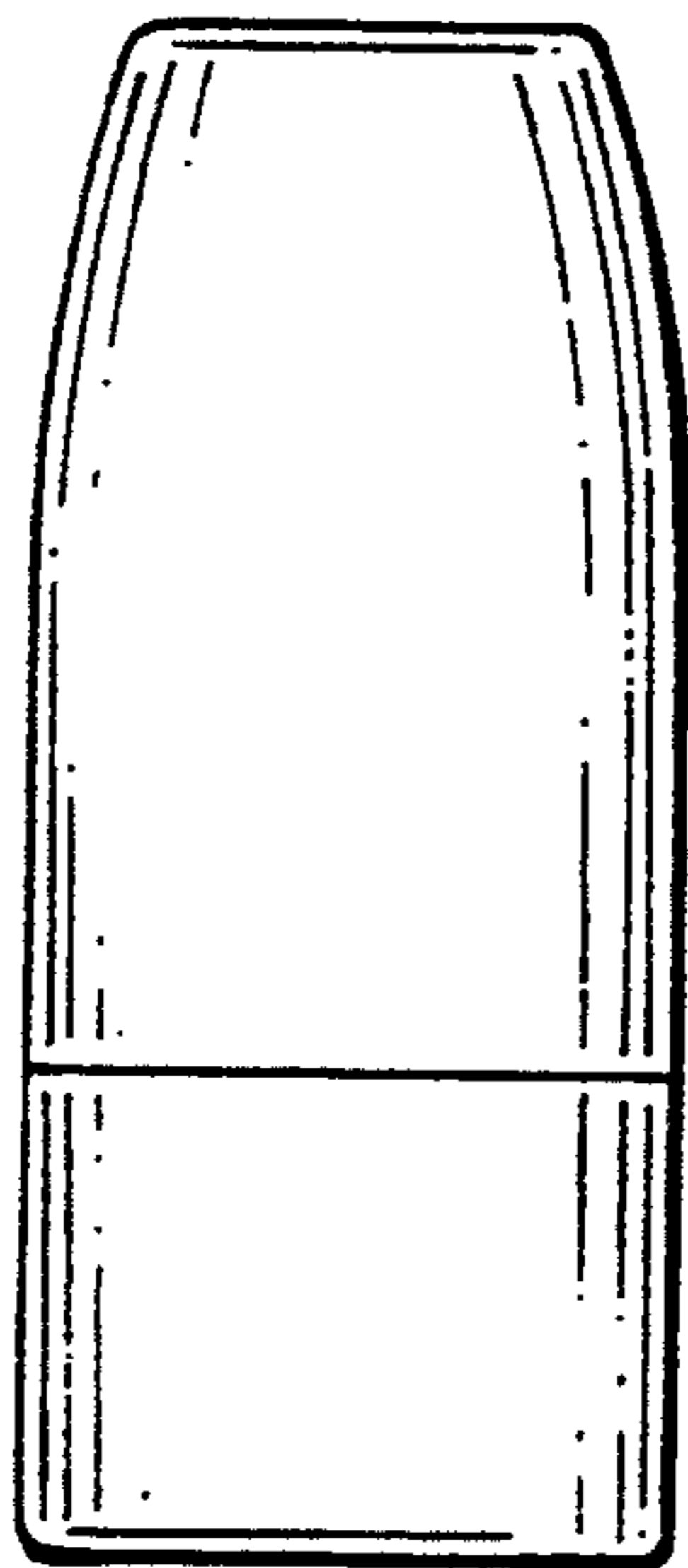

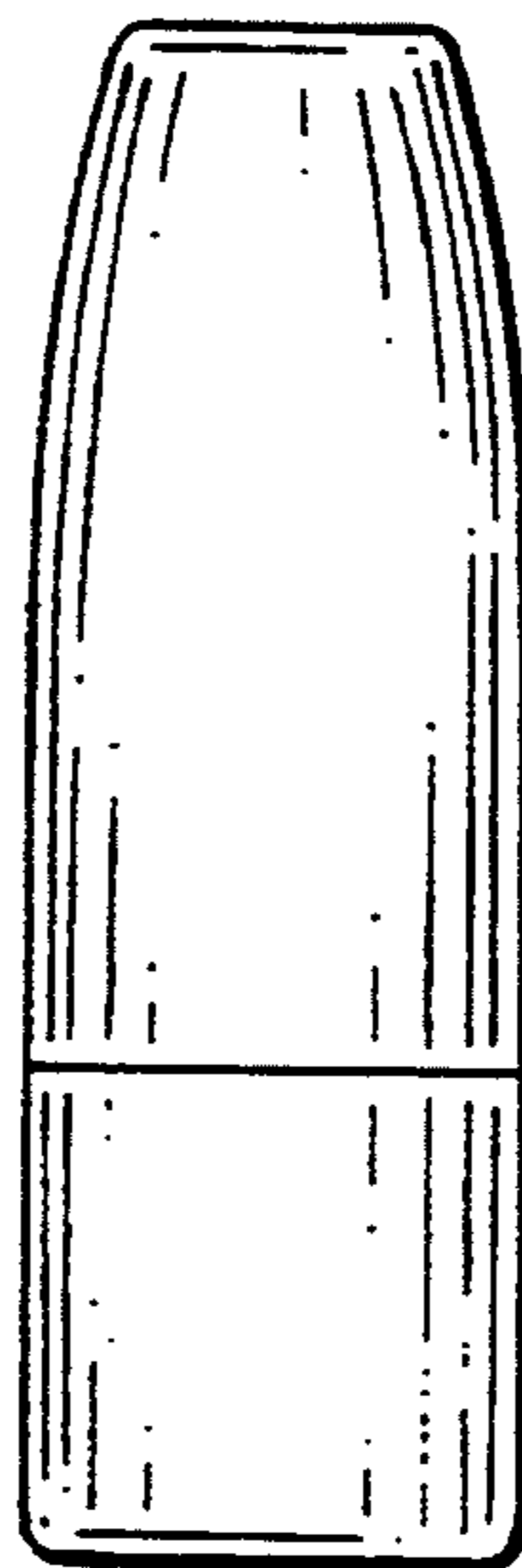

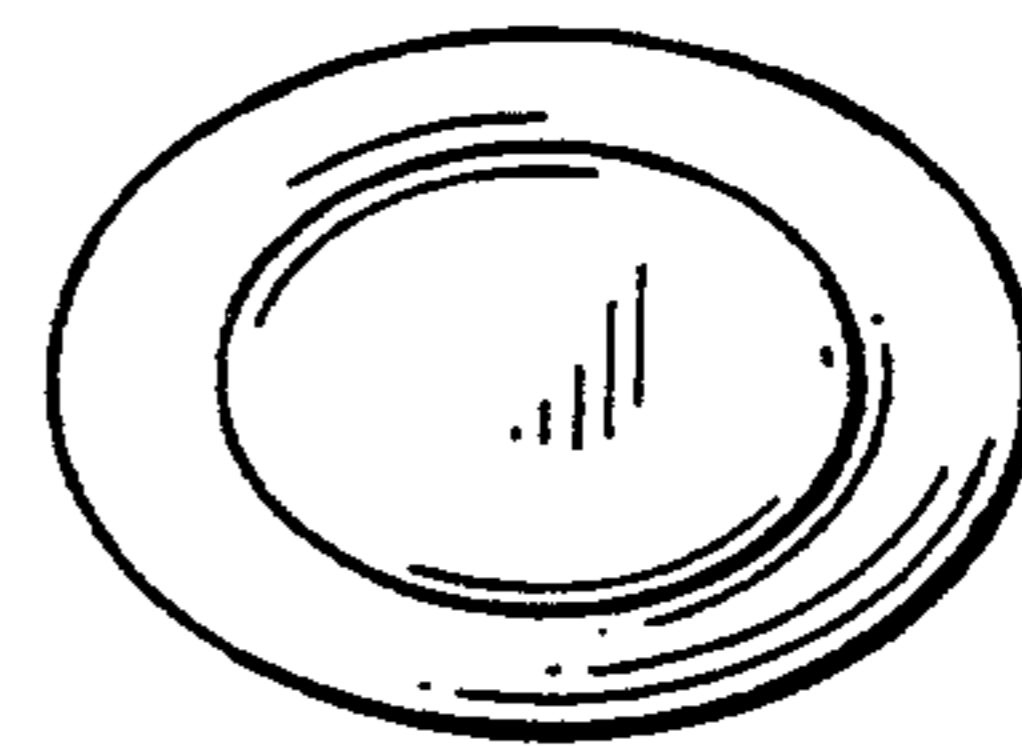

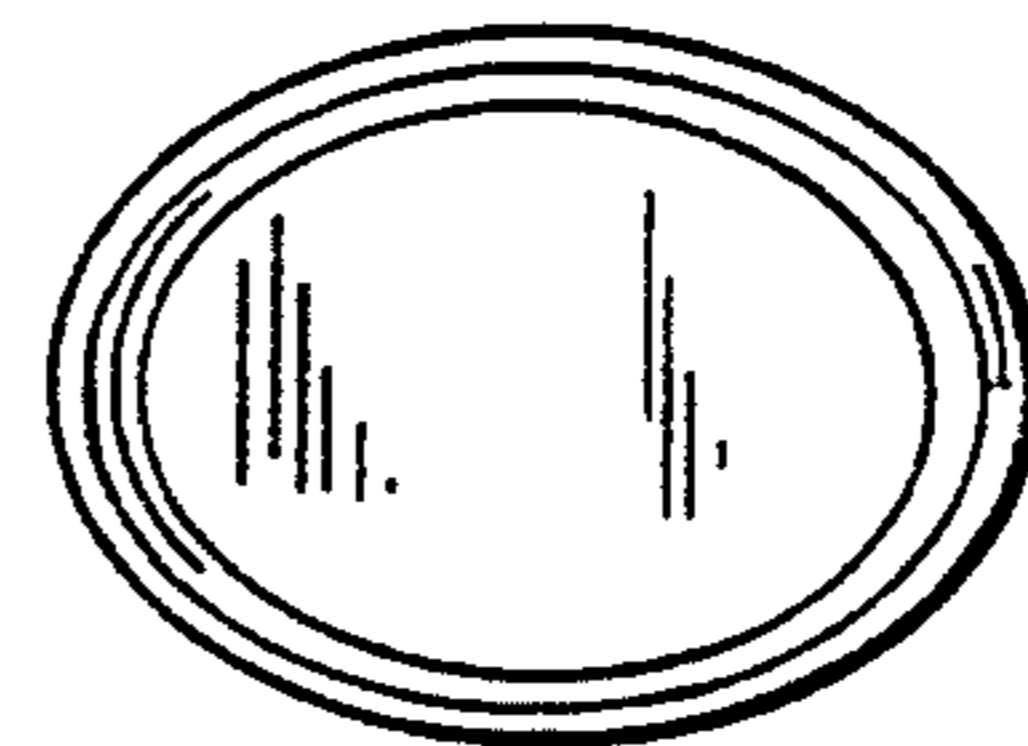

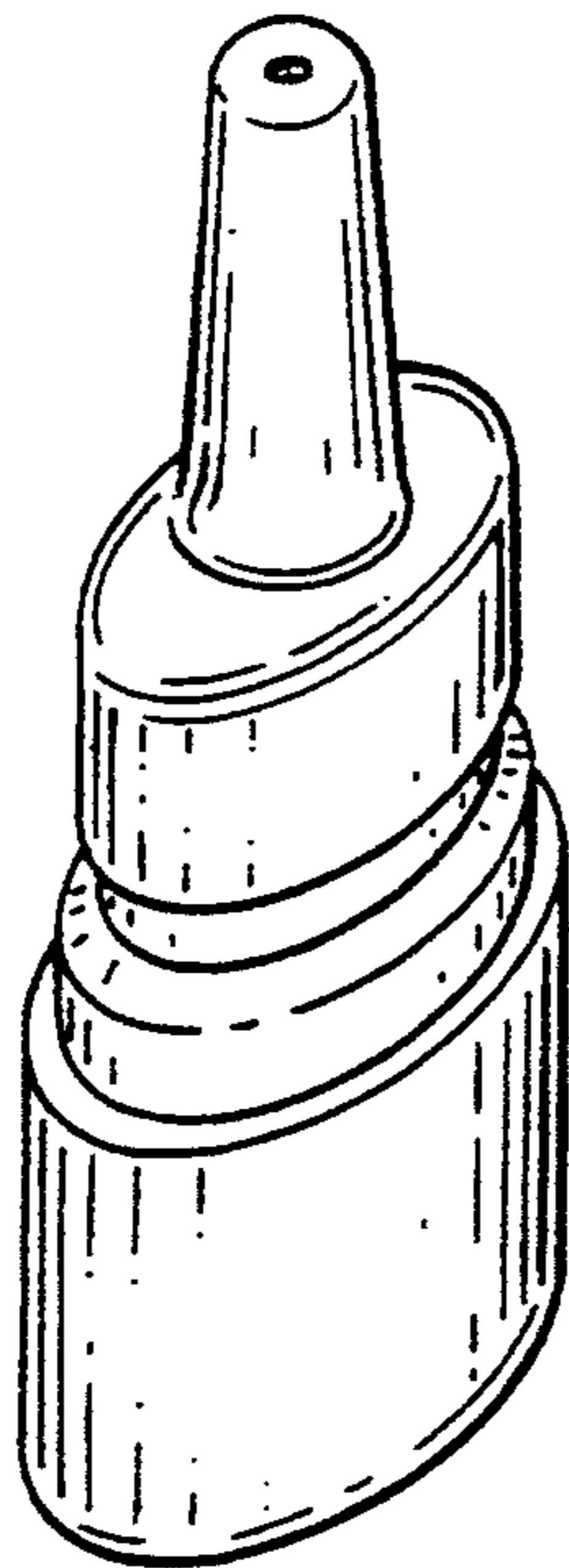

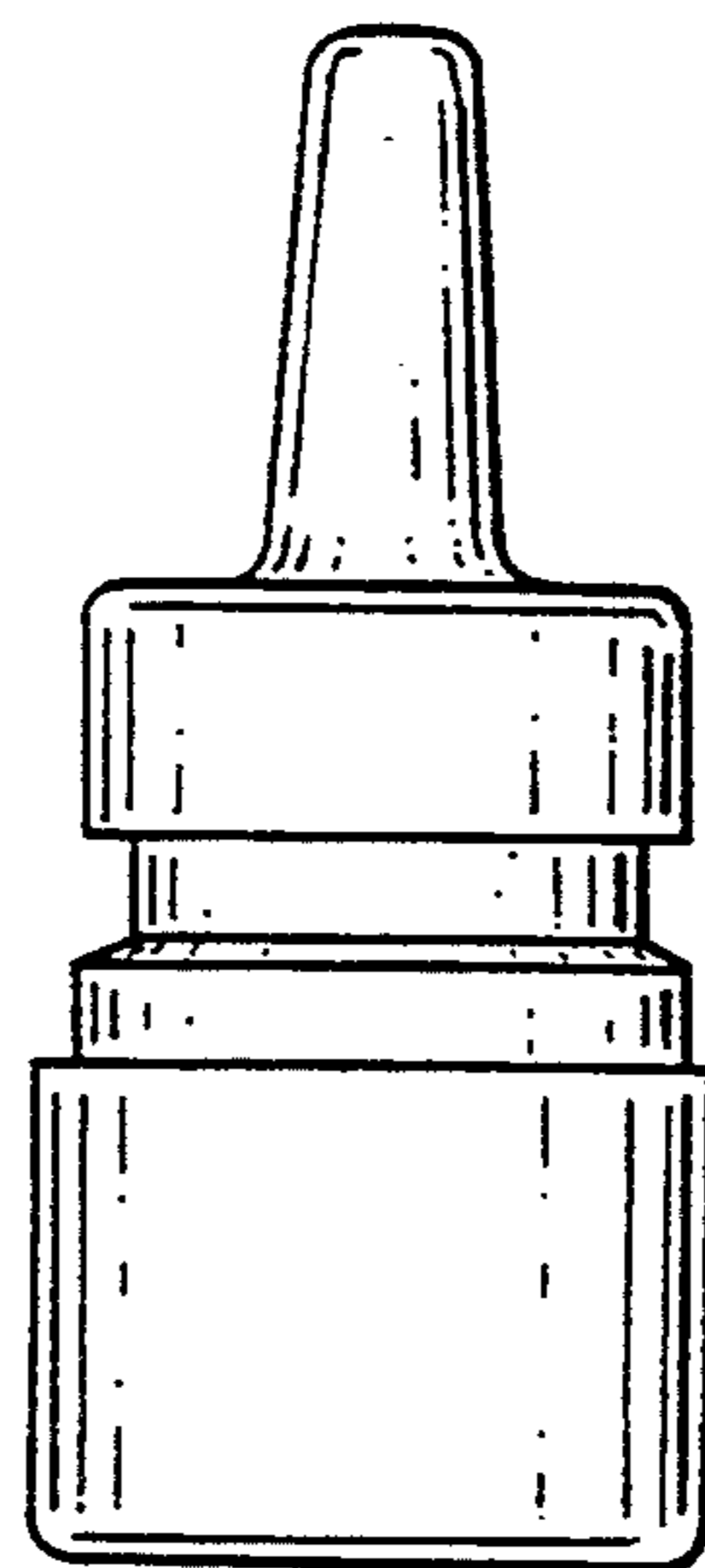

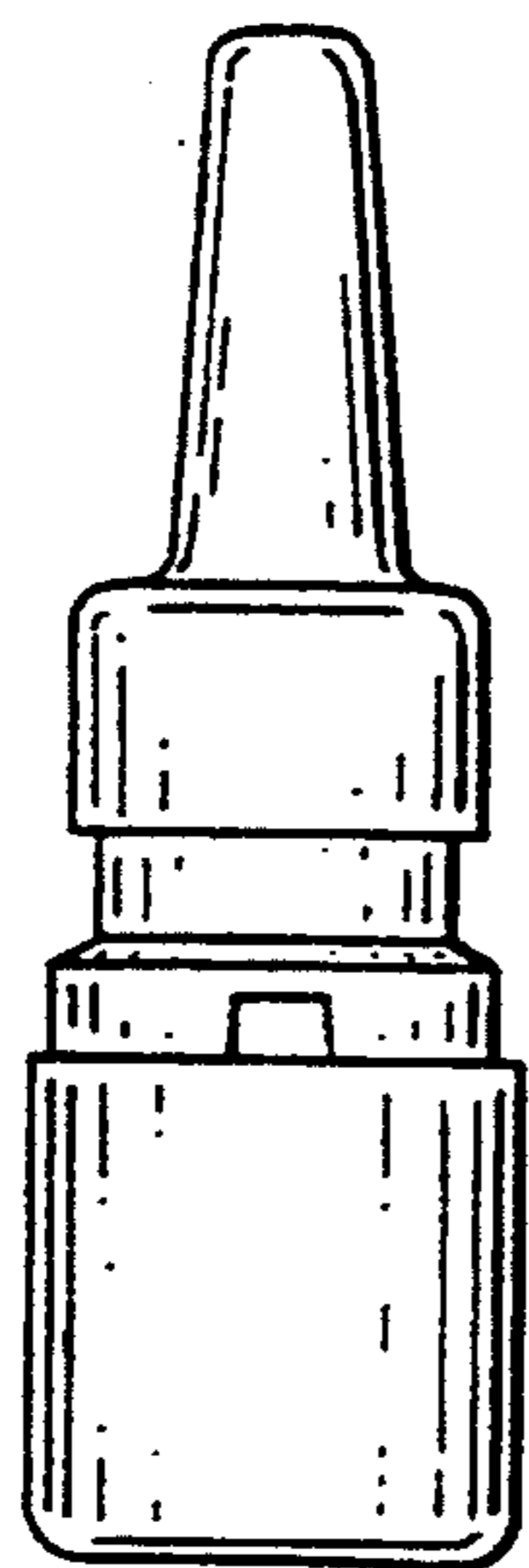

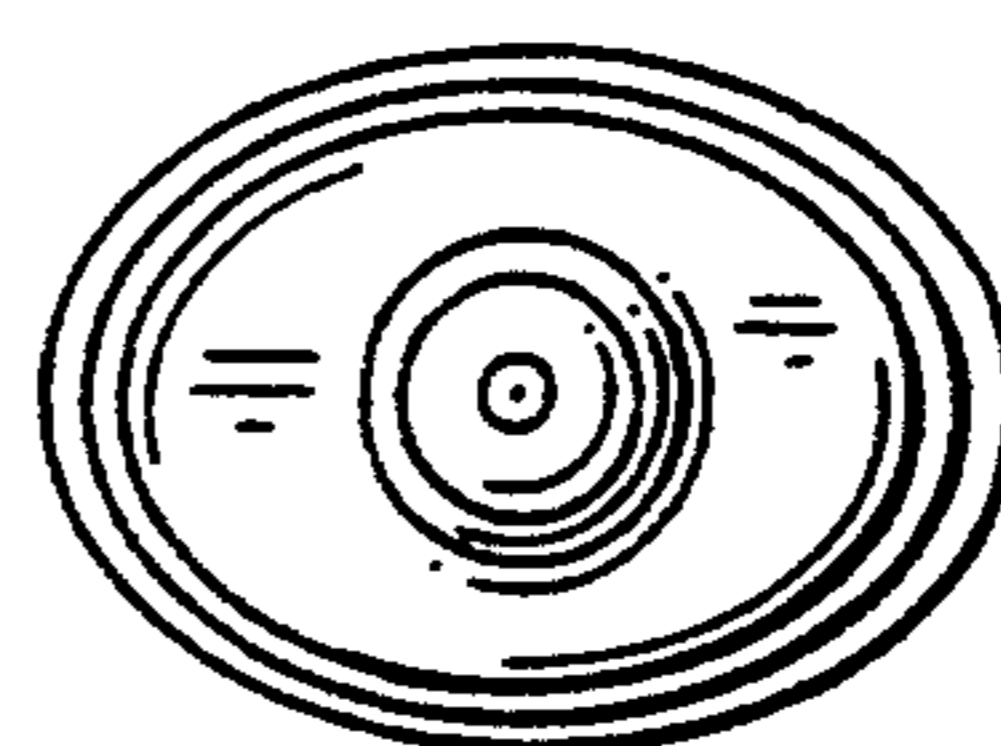

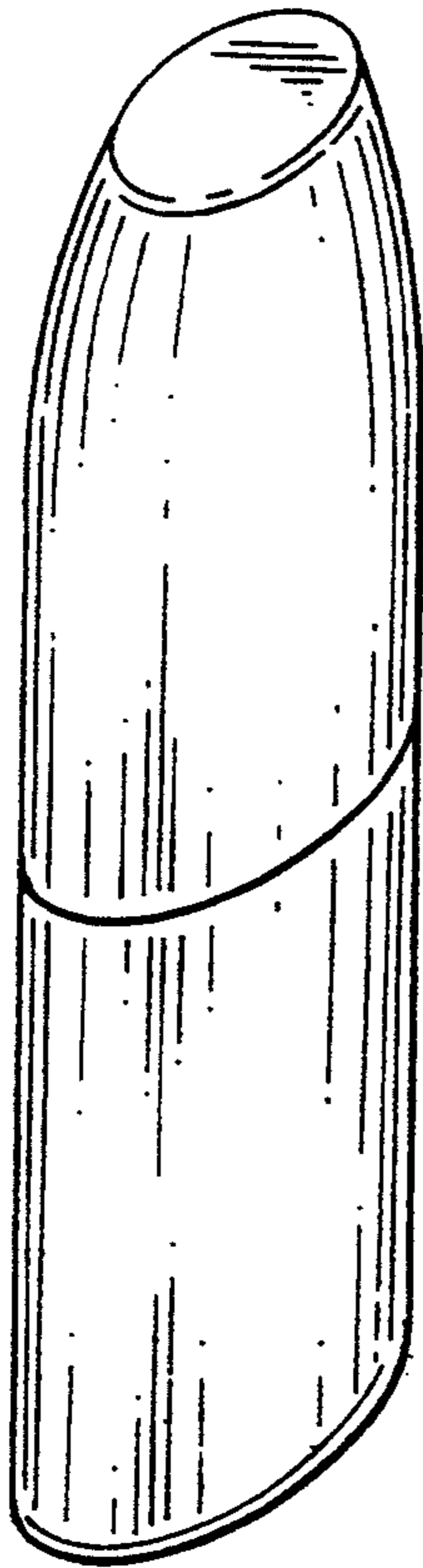

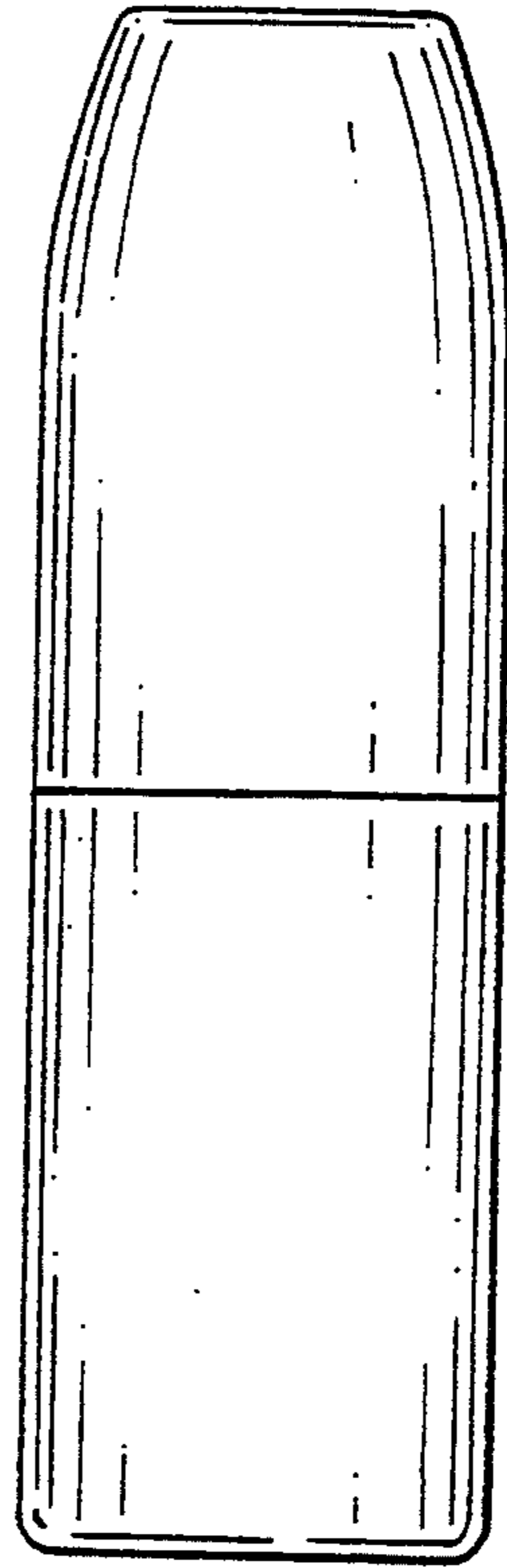

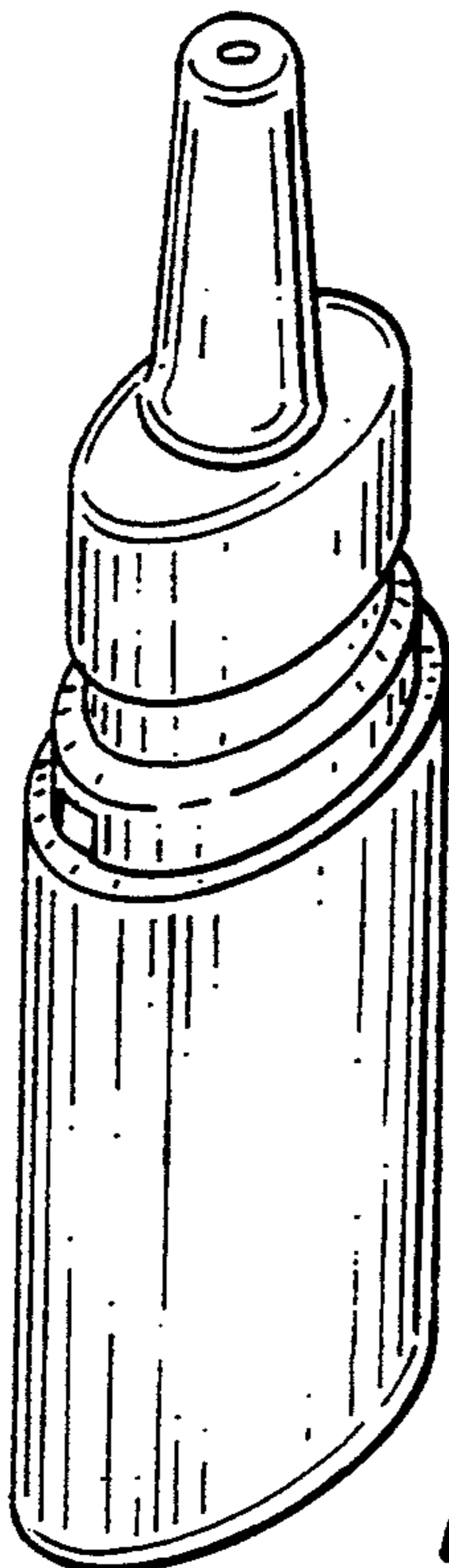

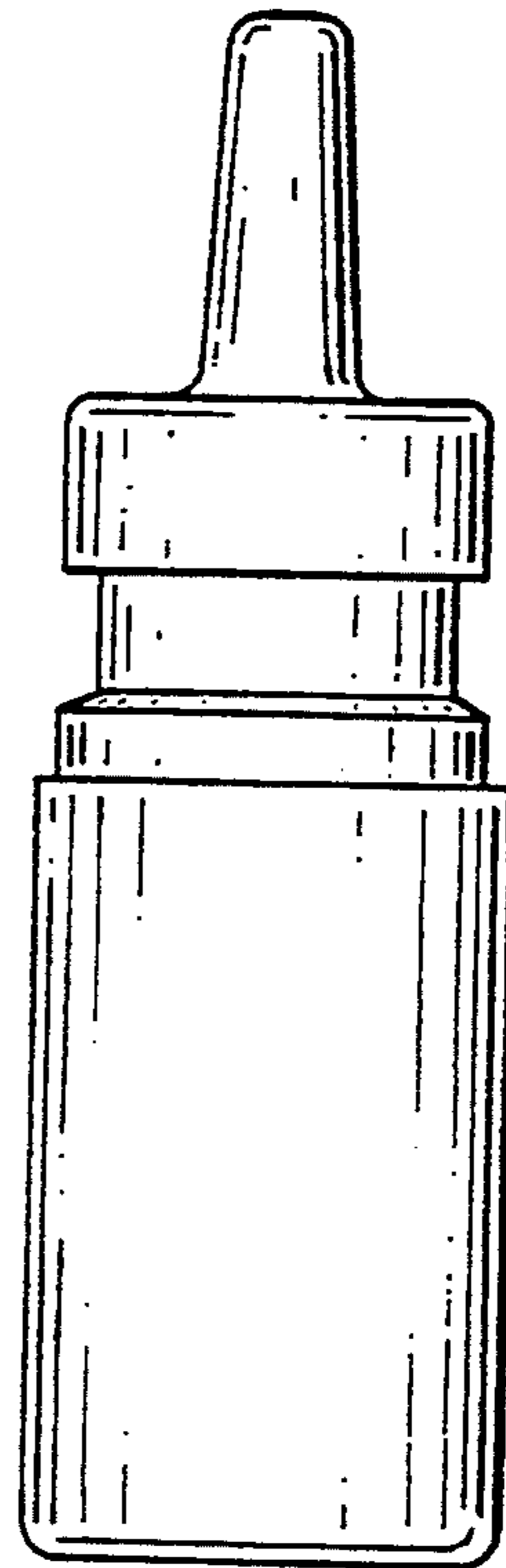
