[57] **CLAIM**

The ornamental design for the container for showing a roll of bags for collecting cat waste, as shown and described.

**DESCRIPTION**

FIG. 6 is a bottom plan view thereof.

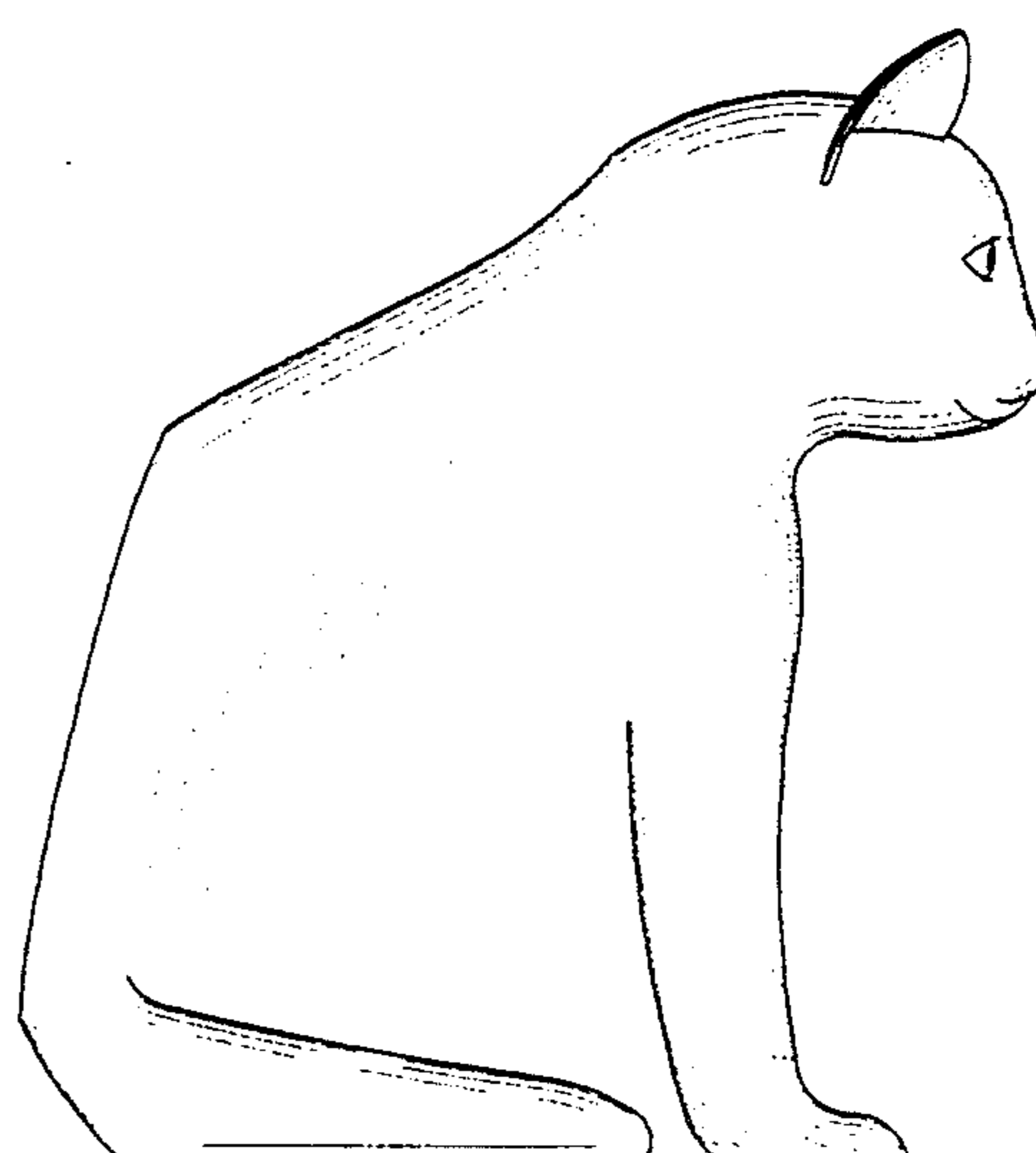
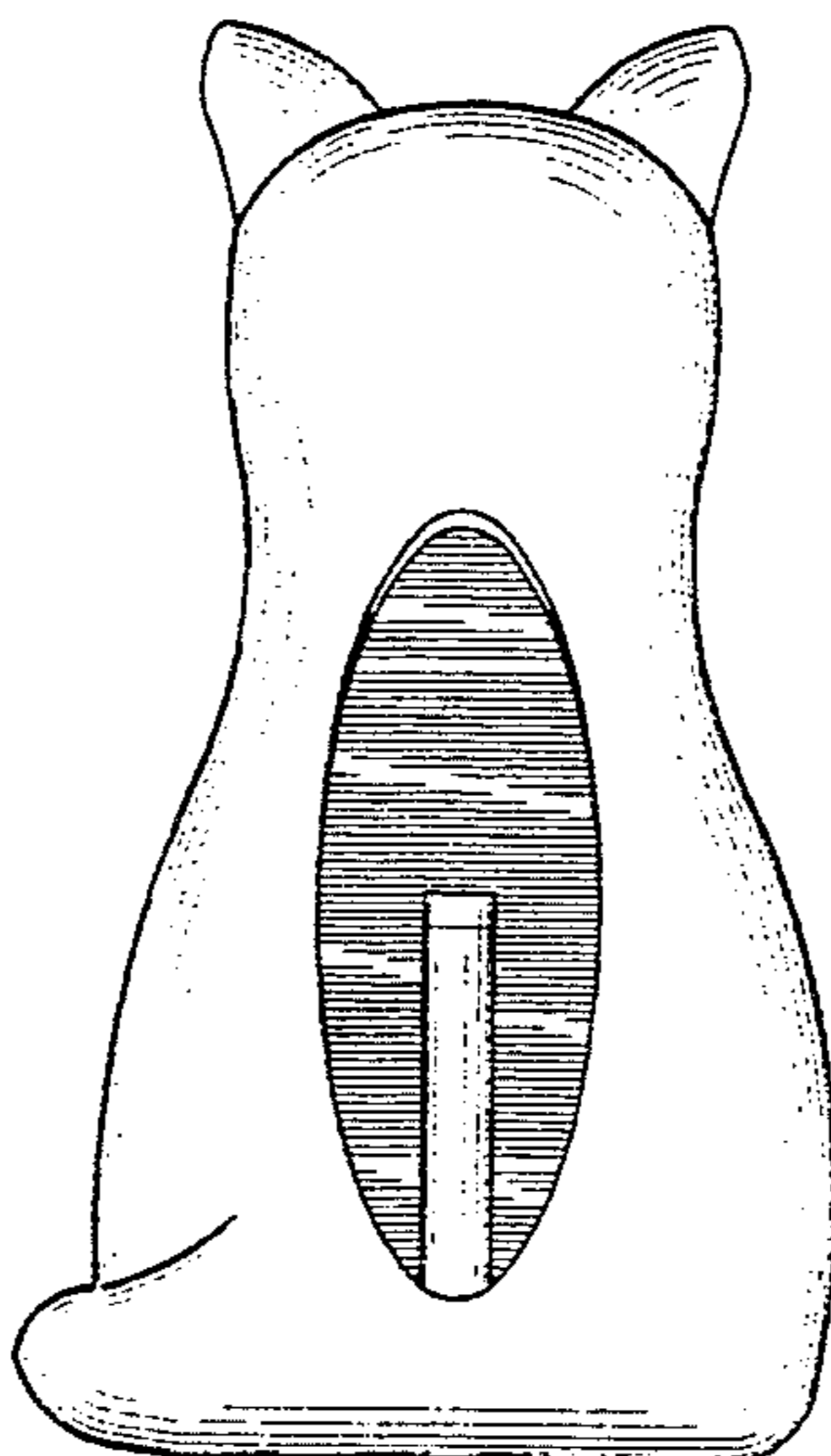
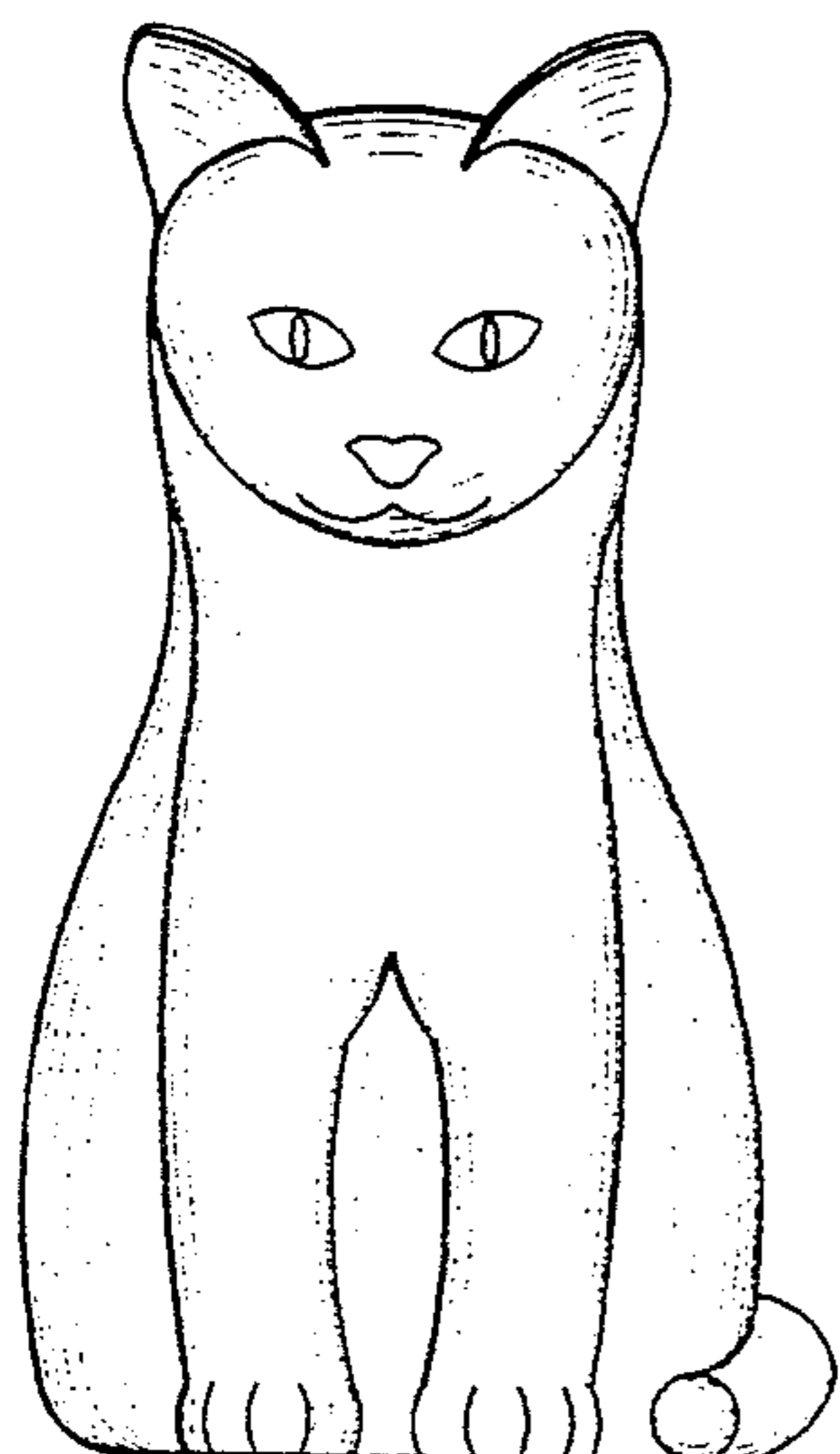

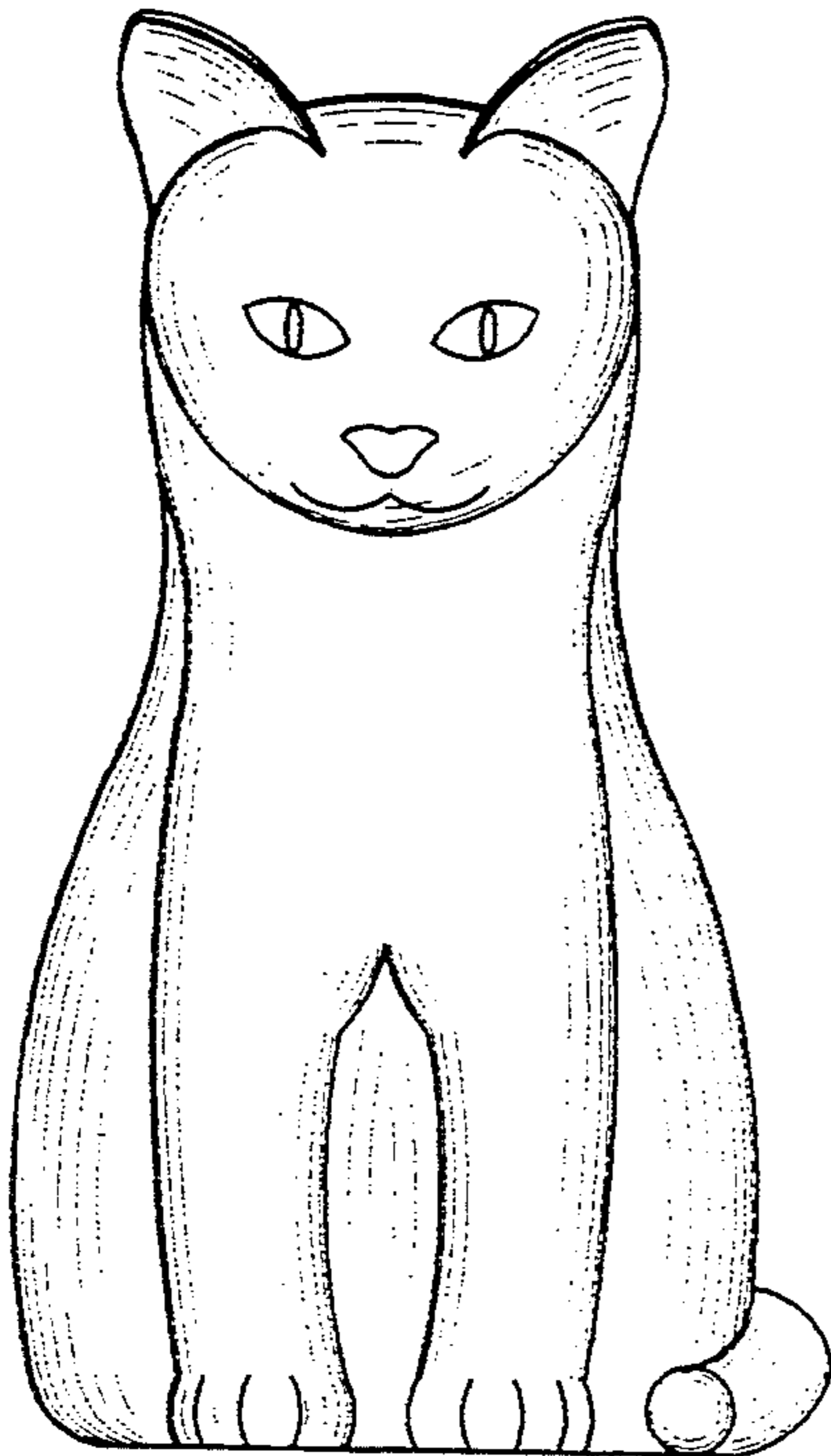

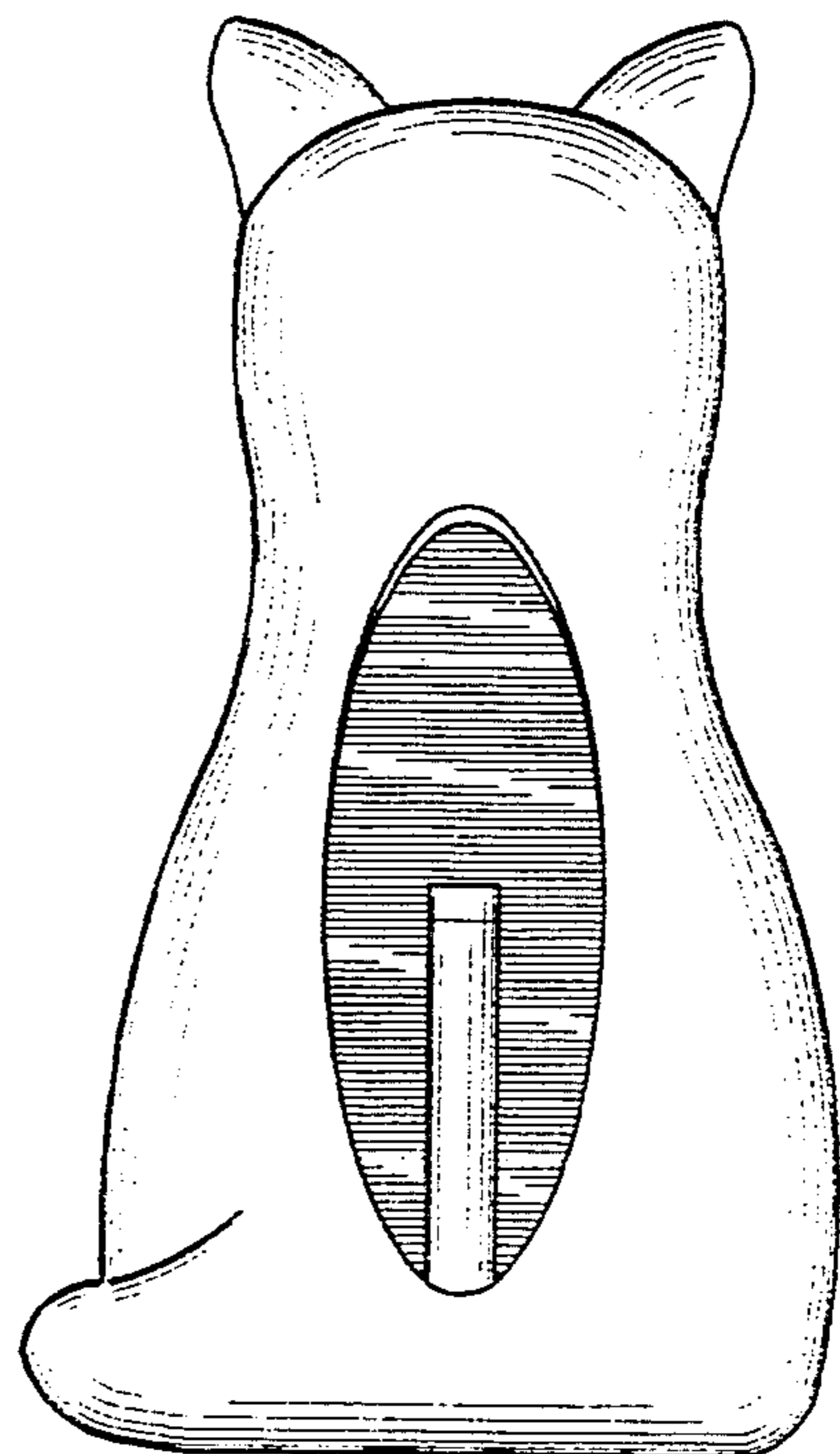

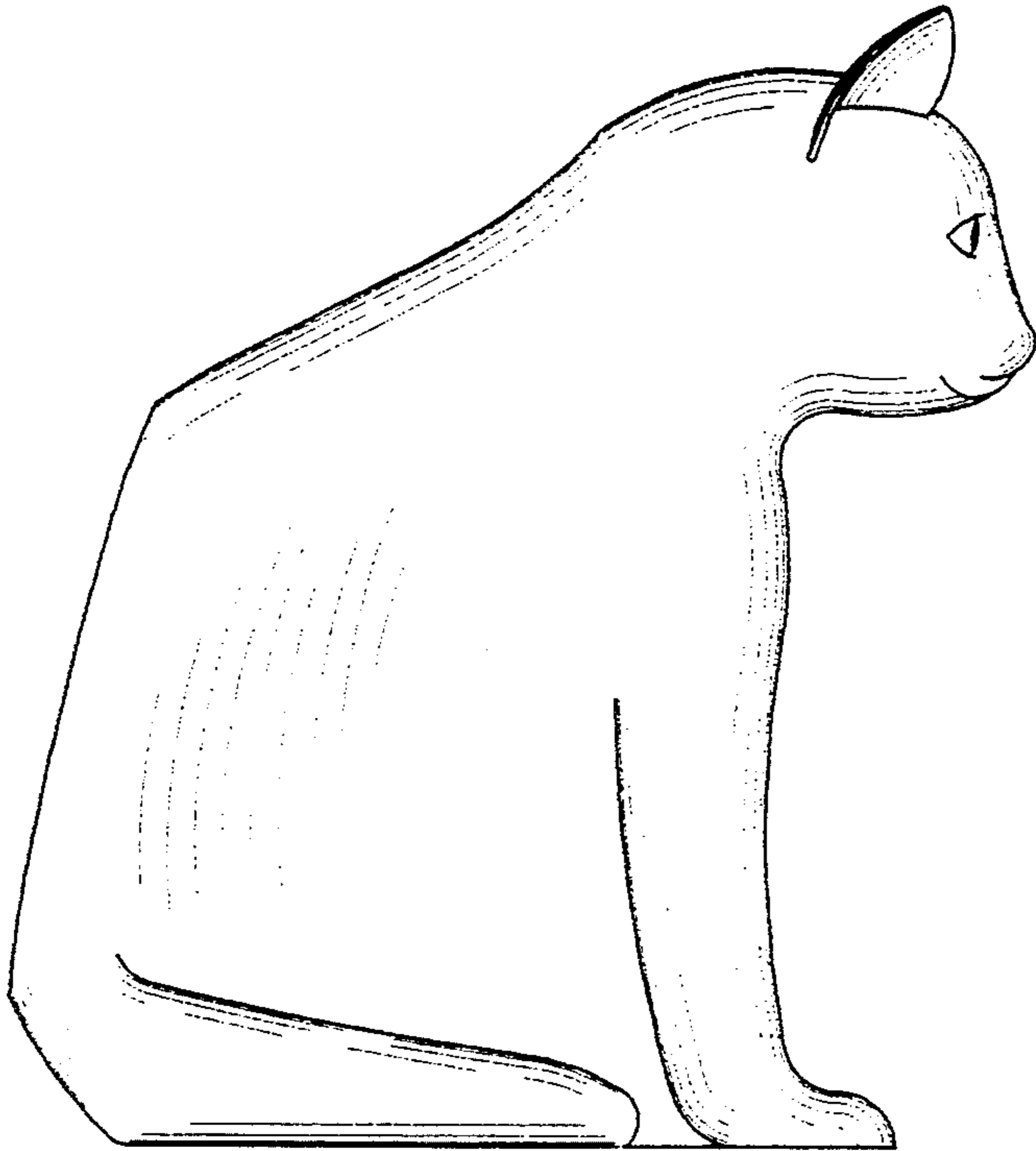

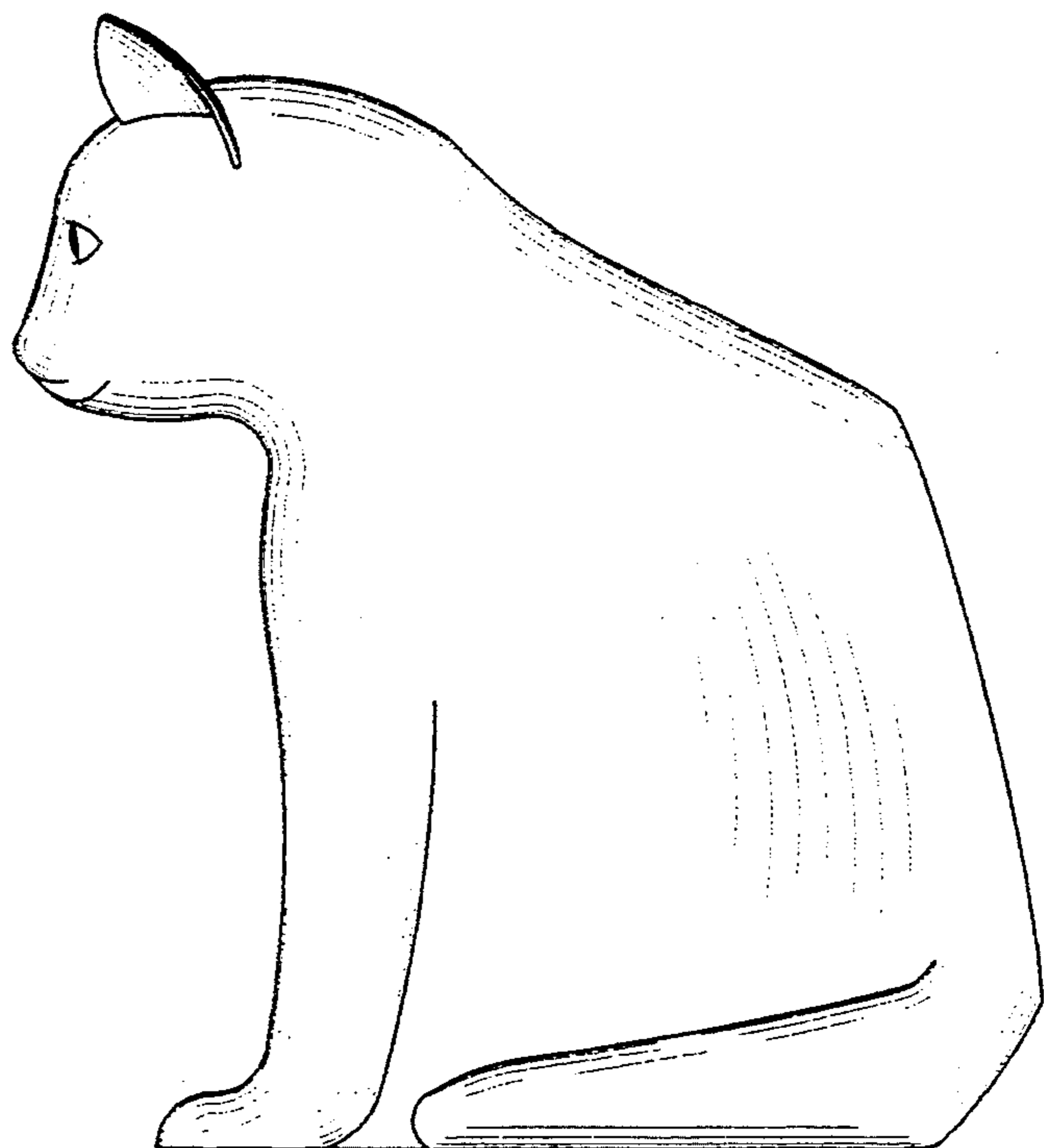

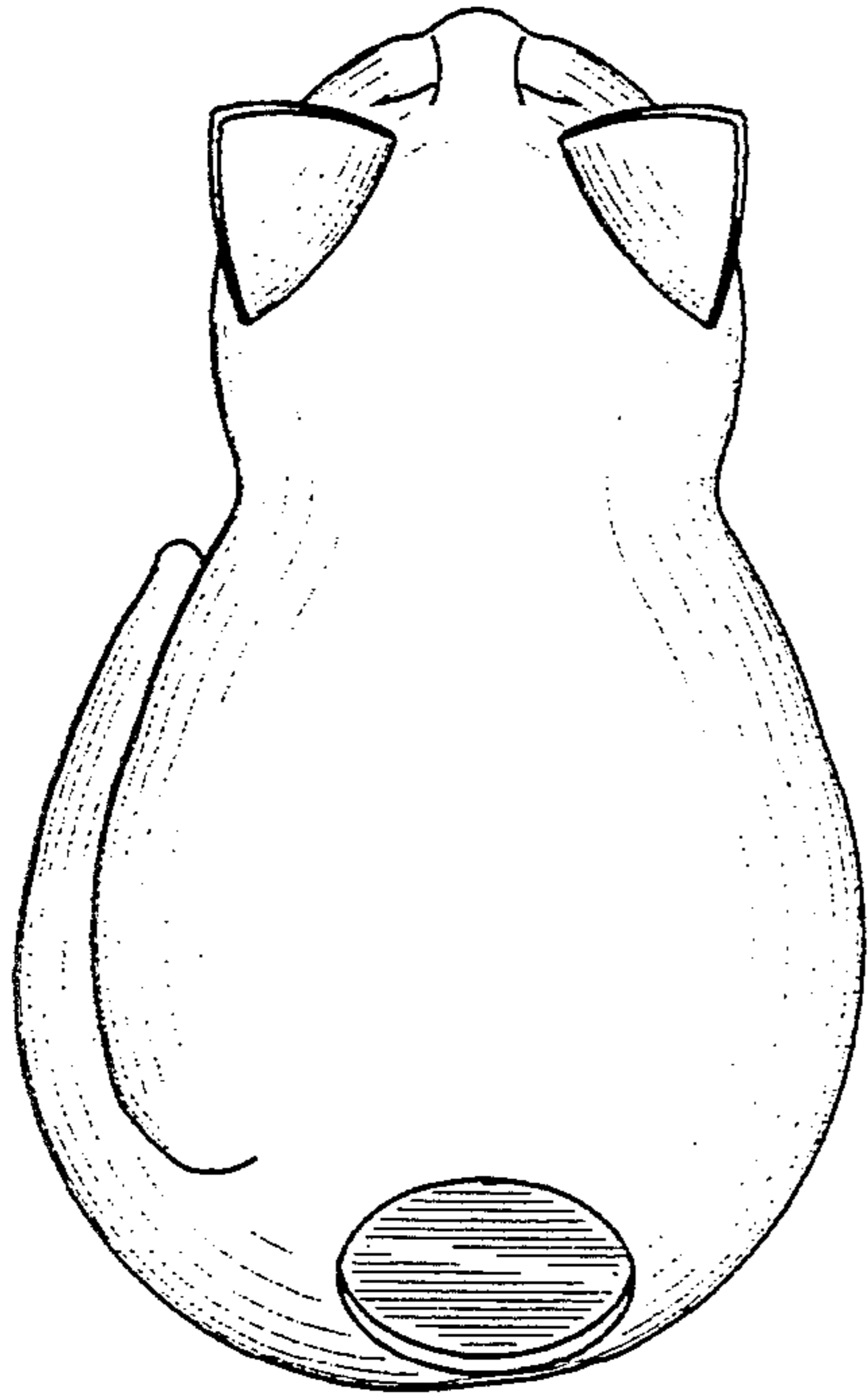
