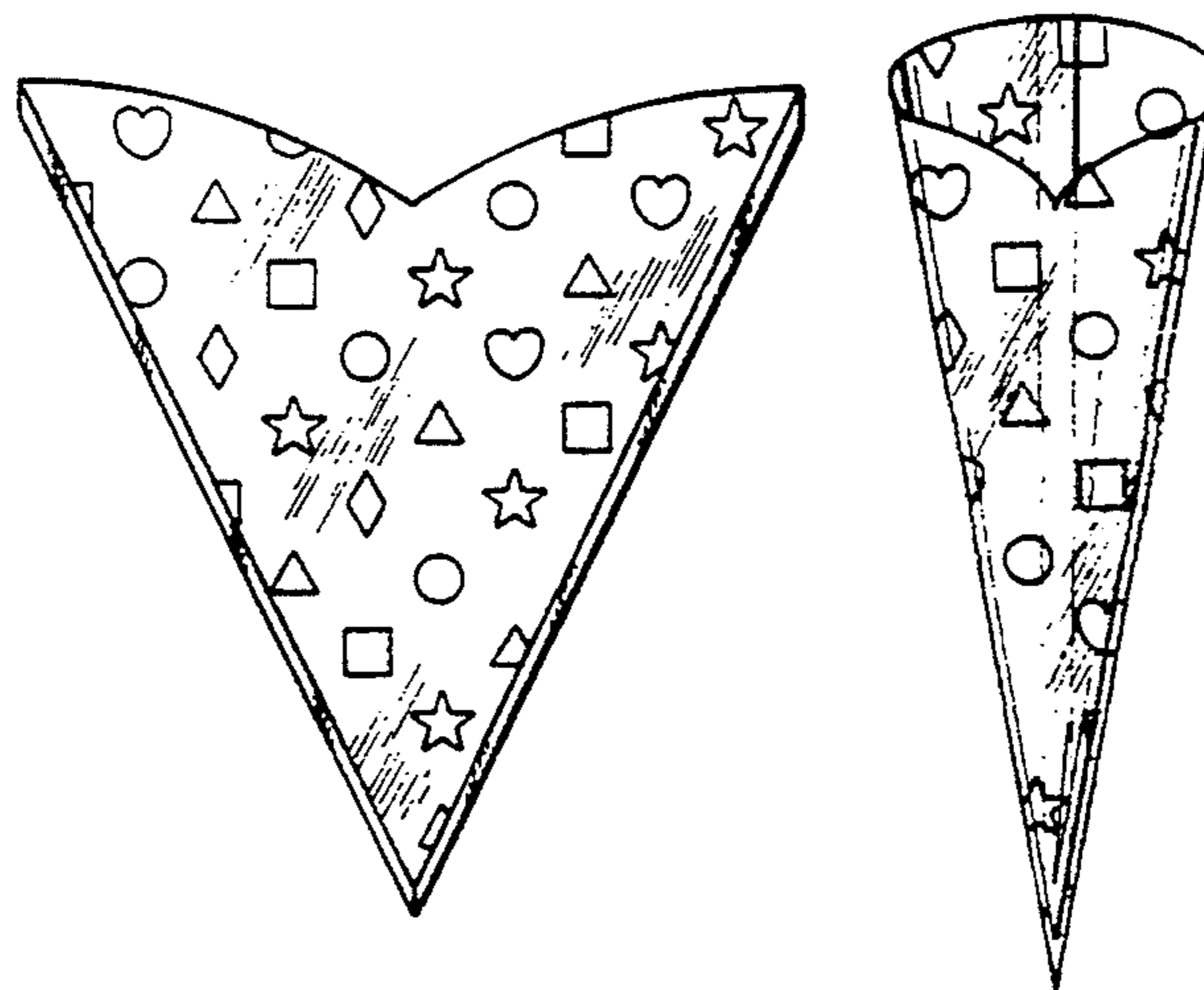

[57] **CLAIM**

The ornamental design for a floral wrapping material, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of floral wrapping material showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top edge view thereof;
FIG. 7 is a rear perspective view shown in an alternate position;
FIG. 8 is a front perspective view of FIG. 1; and,
FIG. 9 is an enlarged plan view of the pattern as shown in FIG. 1.
The floral wrapping material has no substantial thickness.



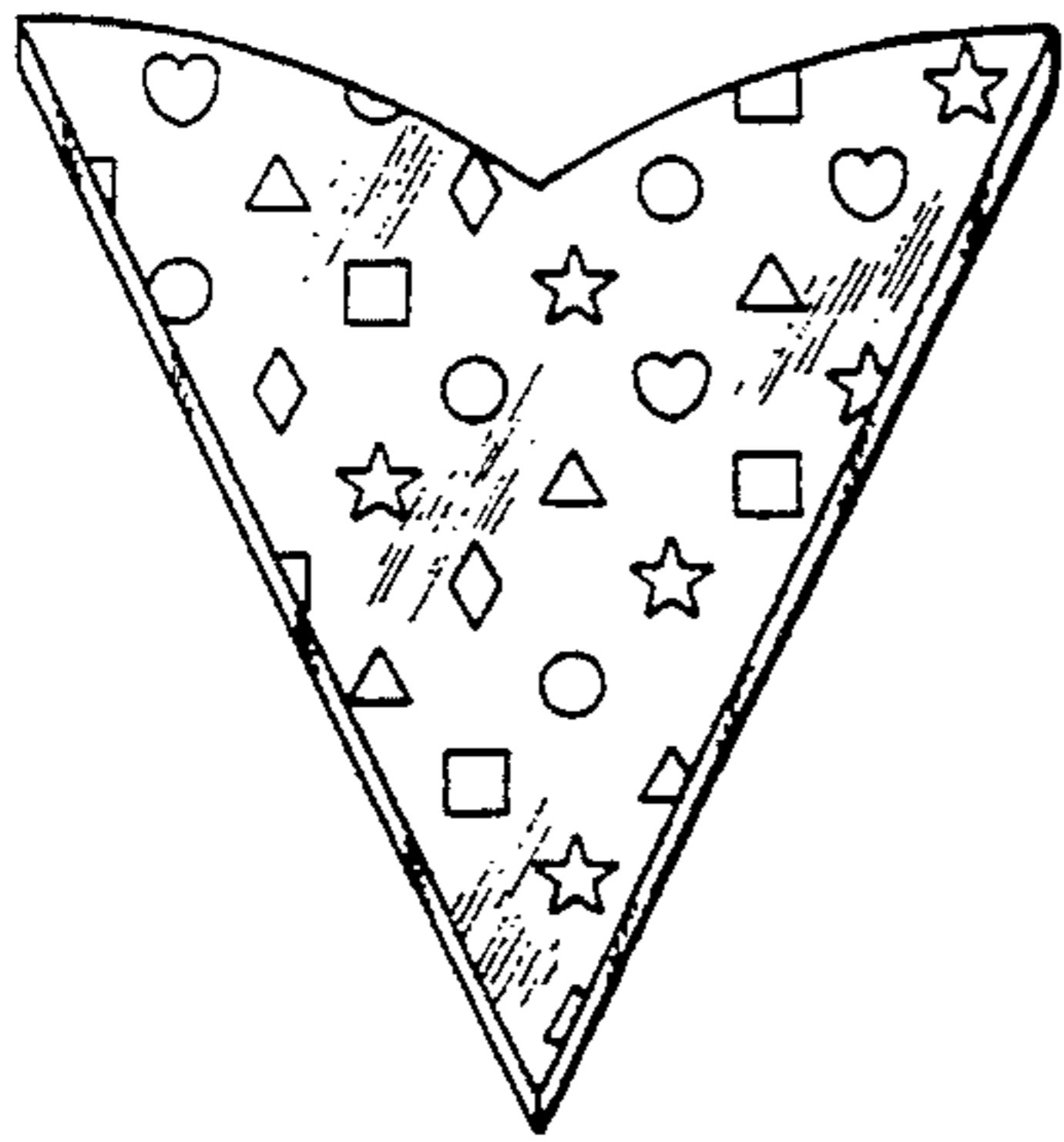

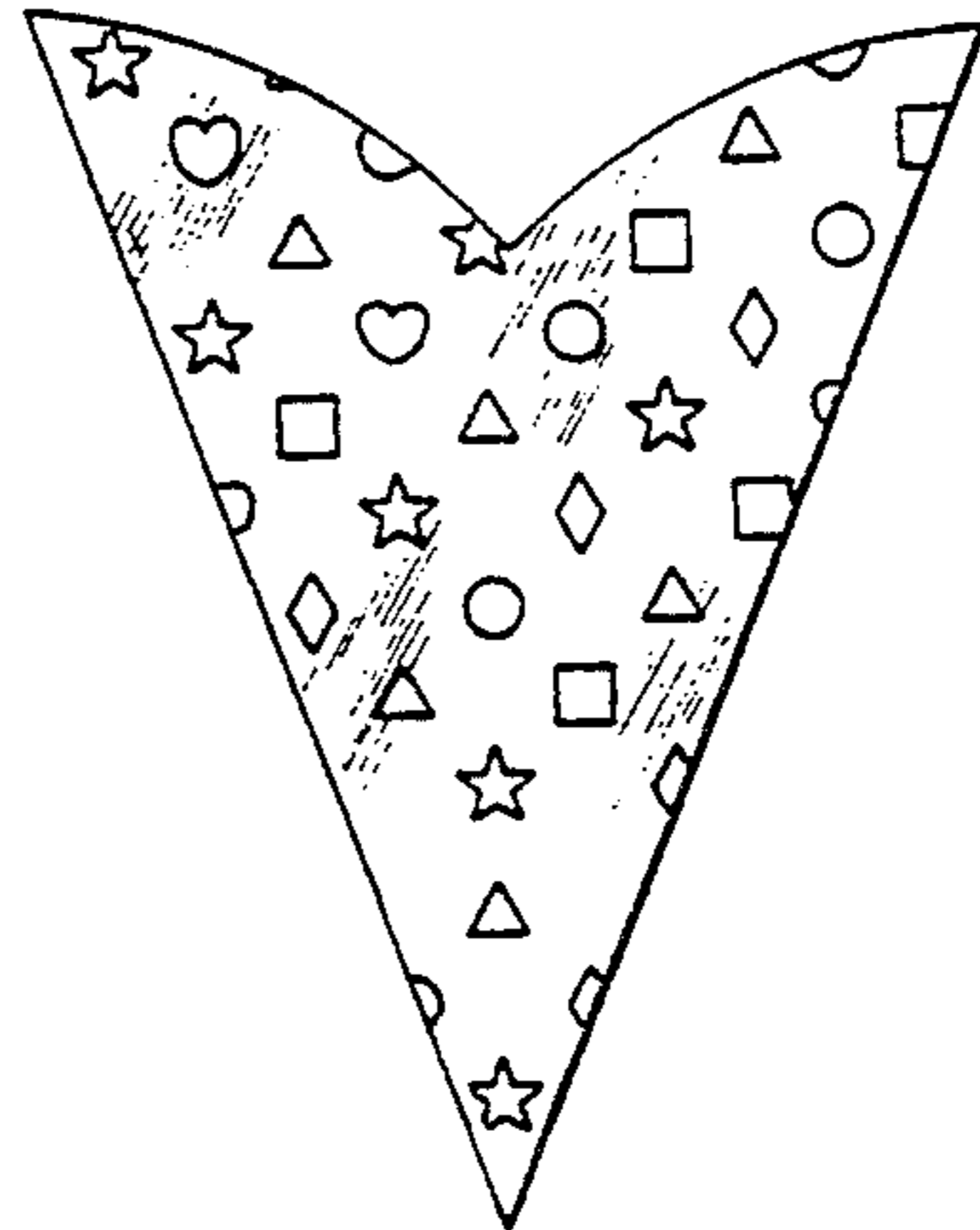

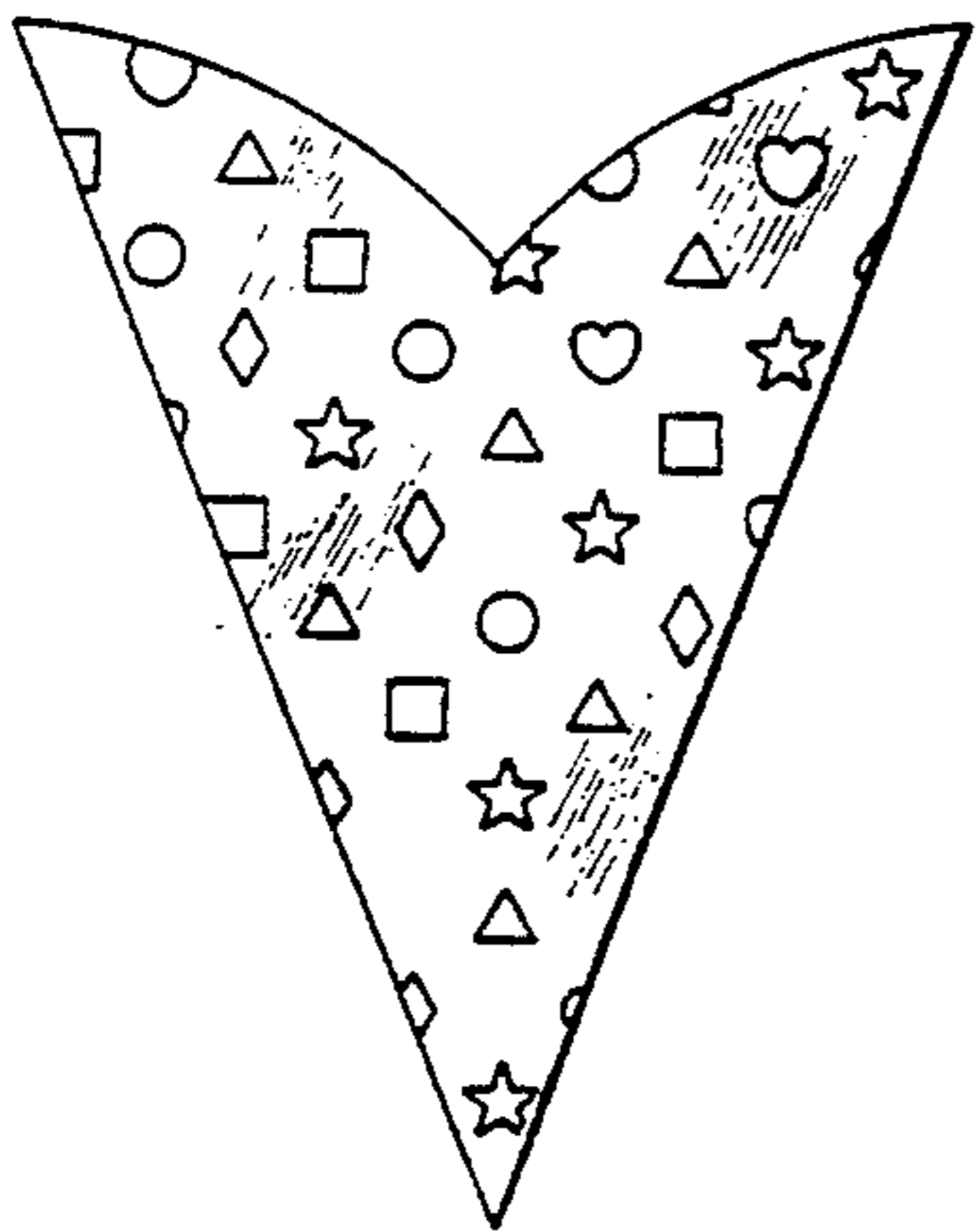

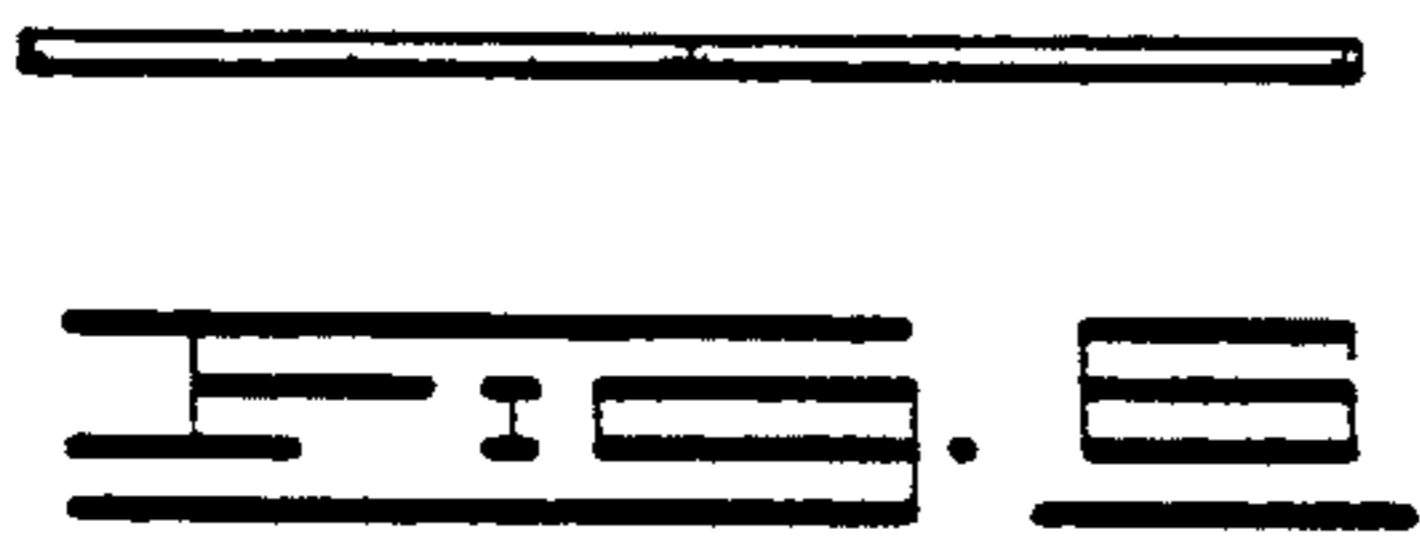

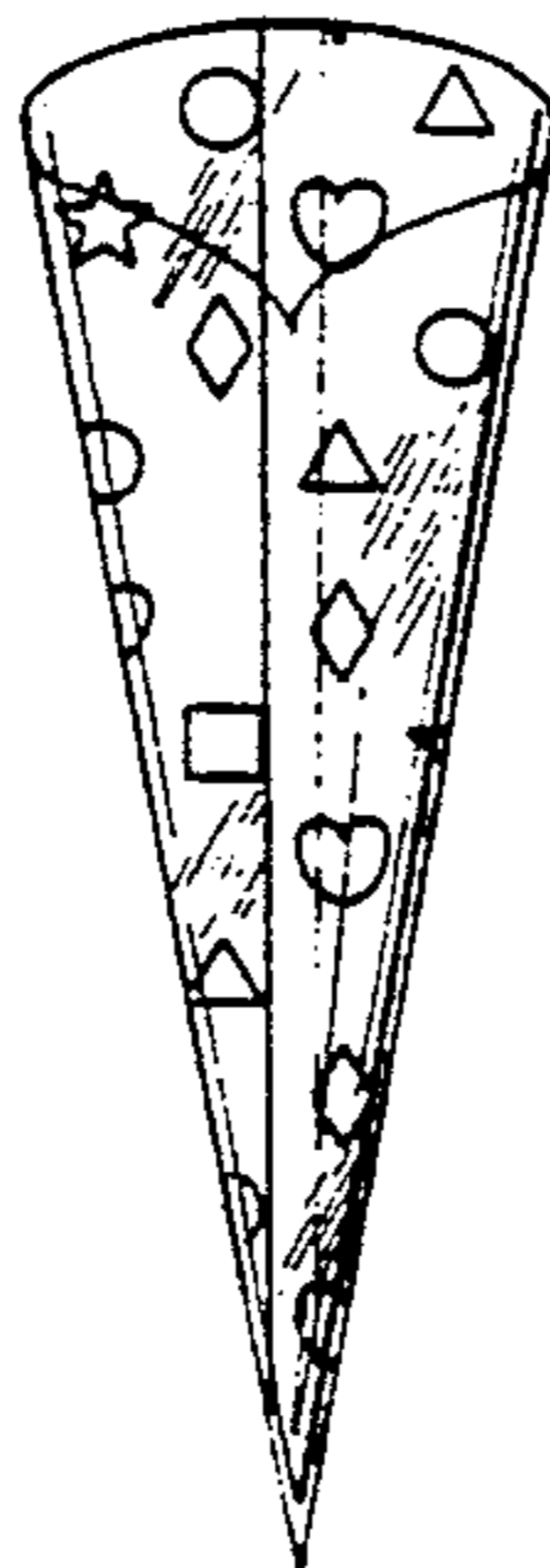

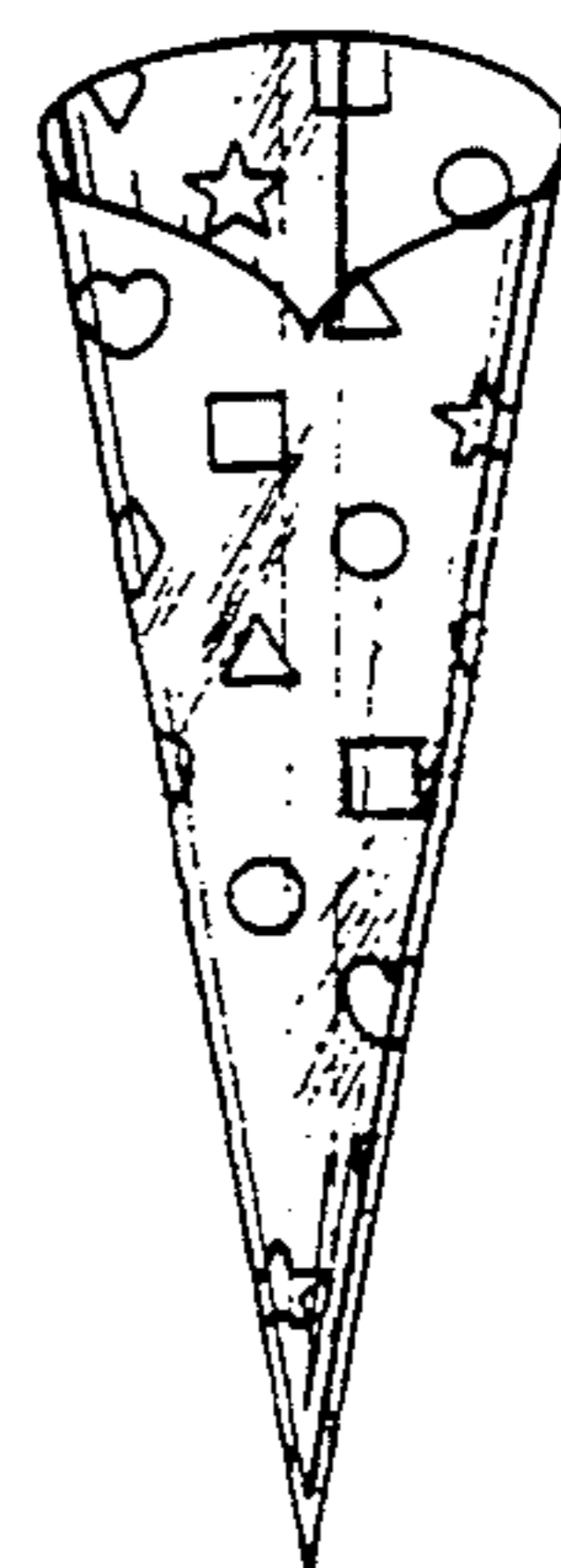
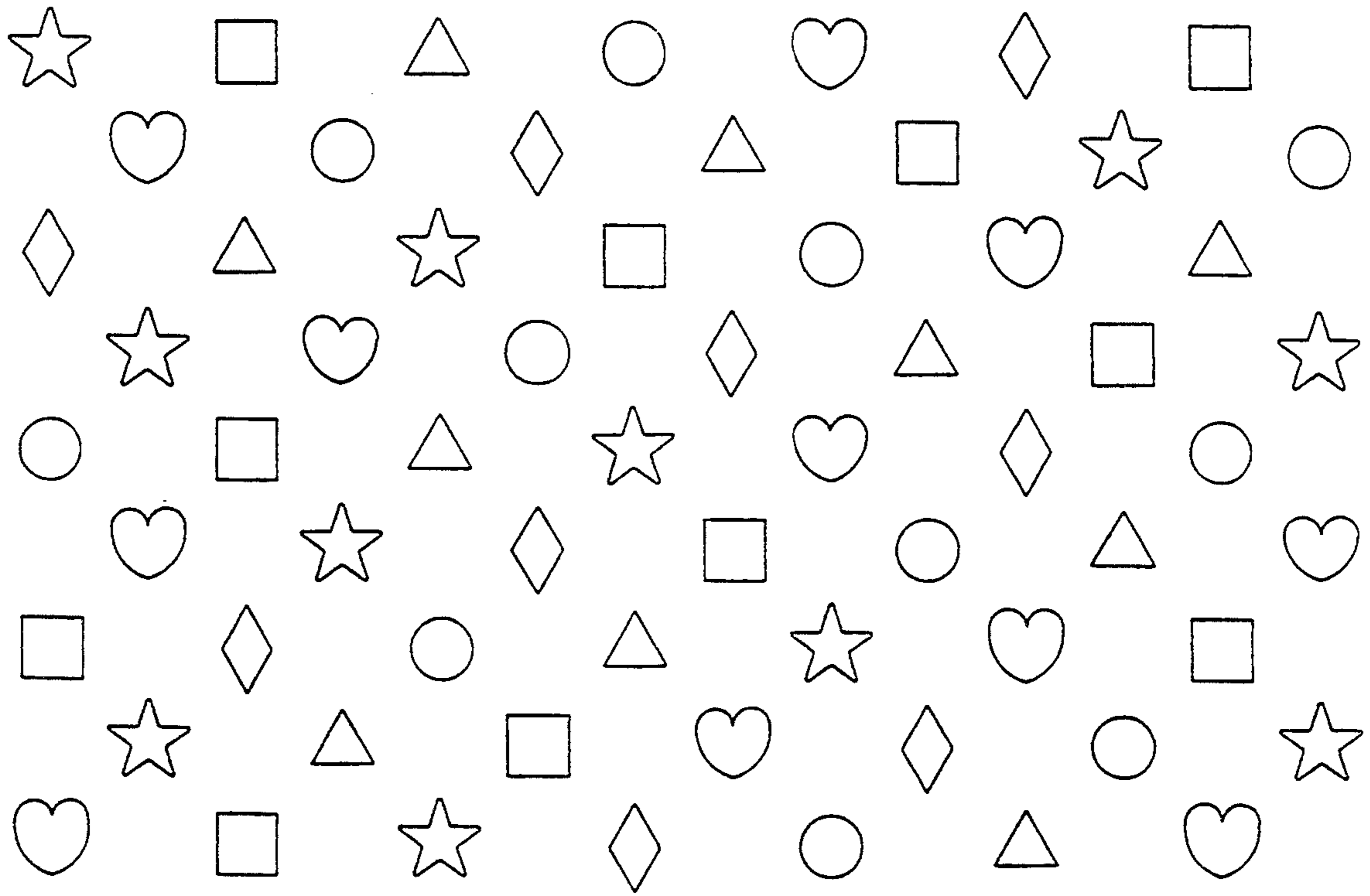
