[57] **CLAIM**

The ornamental design for a double chain collar keeper, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a double chain collar keeper showing my new design; FIG. 2 is a top plan view; FIG. 3 is a side elevational view; and, FIG. 4 is a partial rear elevational view, with part of the collar keeper removed for ease of illustration, the portion not shown being a mirror image.



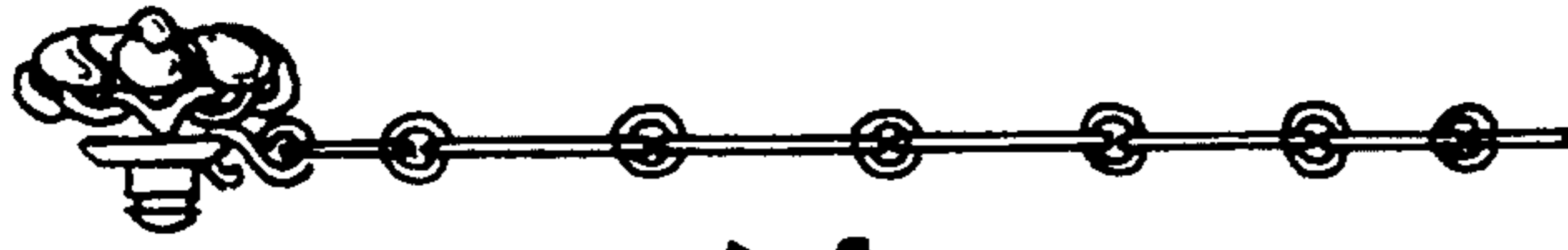

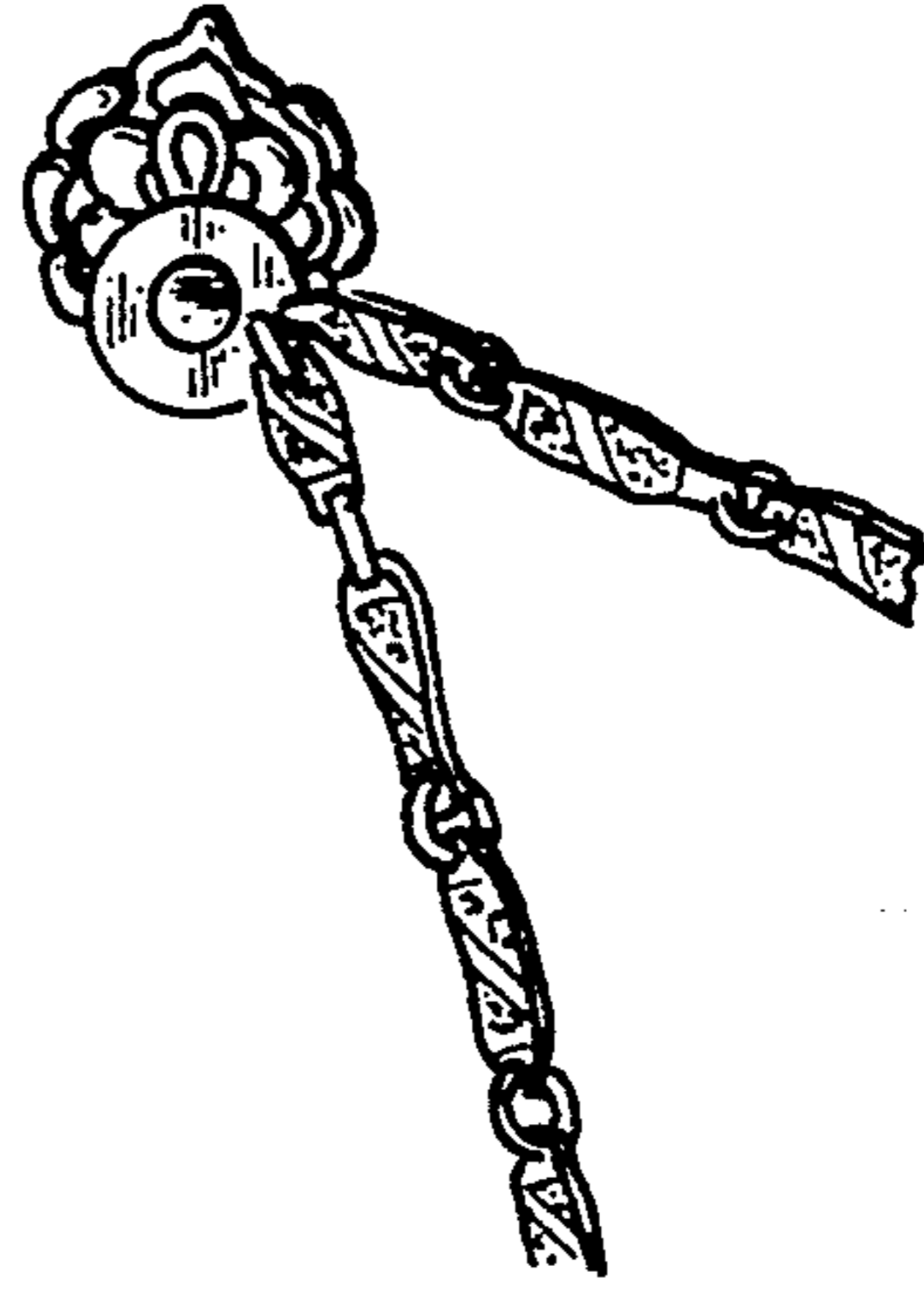

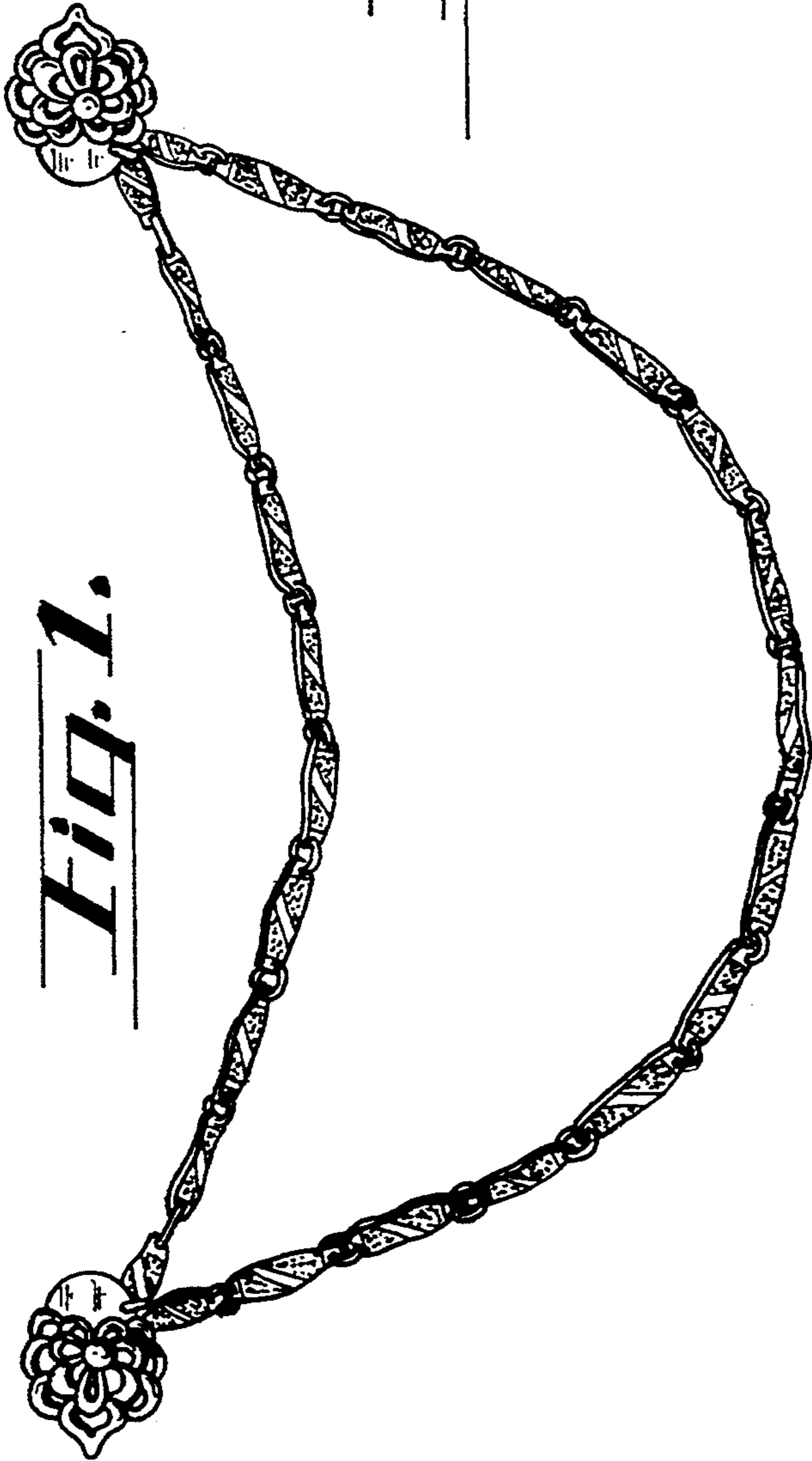

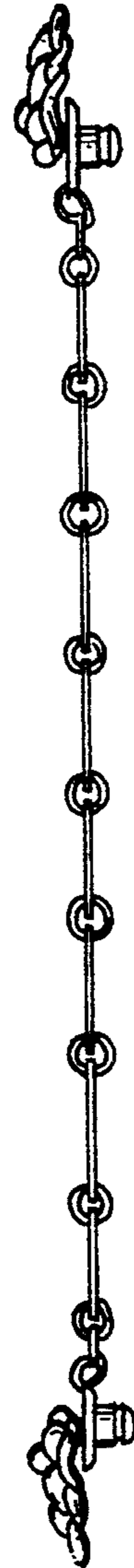
