[57] **CLAIM**

The ornamental design for a combined writing instrument and hemp leaf pocket clip, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a combined writing instrument and hemp leaf pocket clip showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right side elevation view;

FIG. 4 is a left side elevation view;

FIG. 5 is a rear elevation view thereof;

FIG. 7 is a bottom view thereof;

FIG. 9 is a front elevation view of FIG. 8;

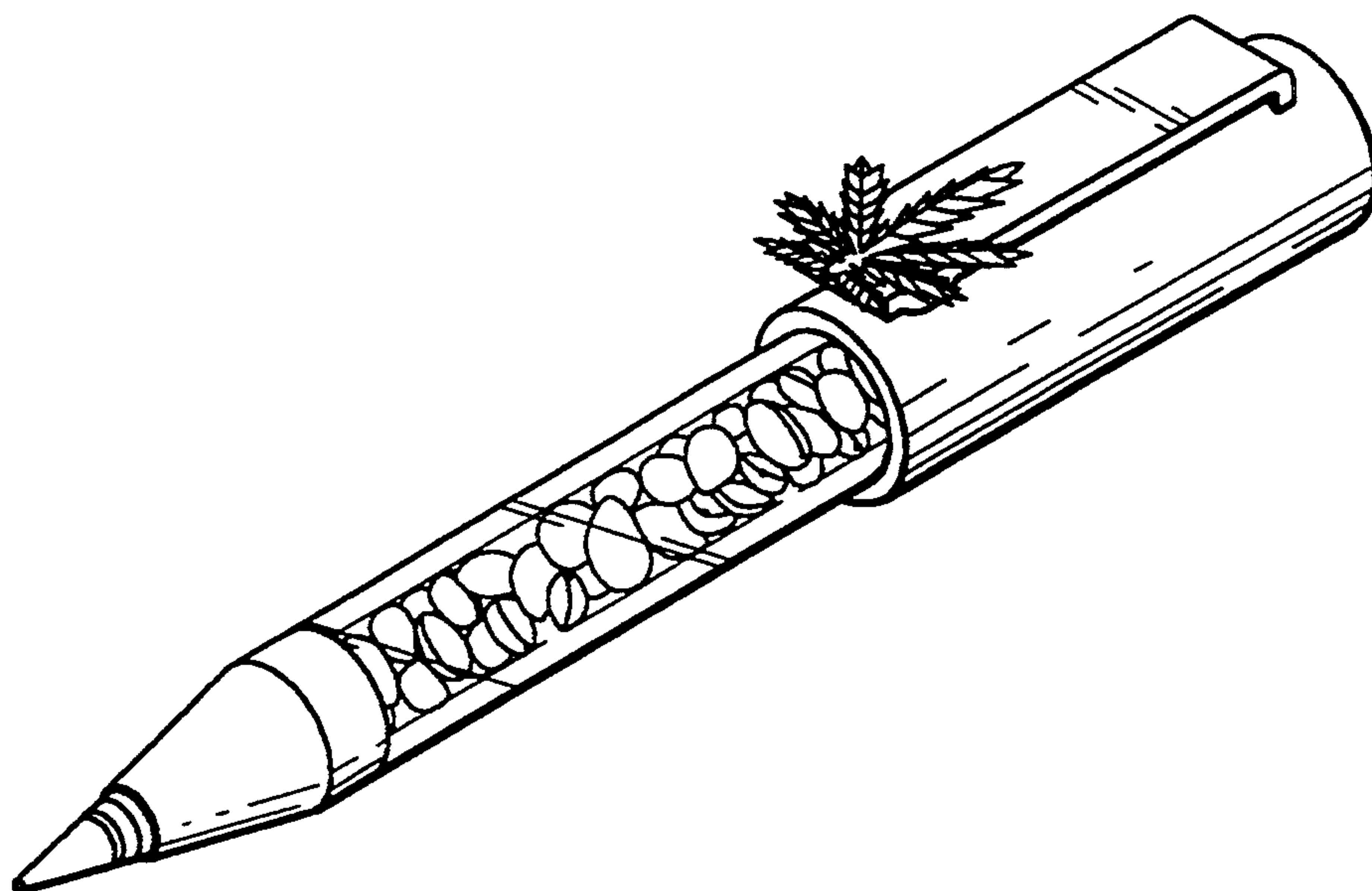
FIG. 10 is a right side elevation view of FIG. 8;

FIG. 14 is a bottom plan view of FIG. 8.



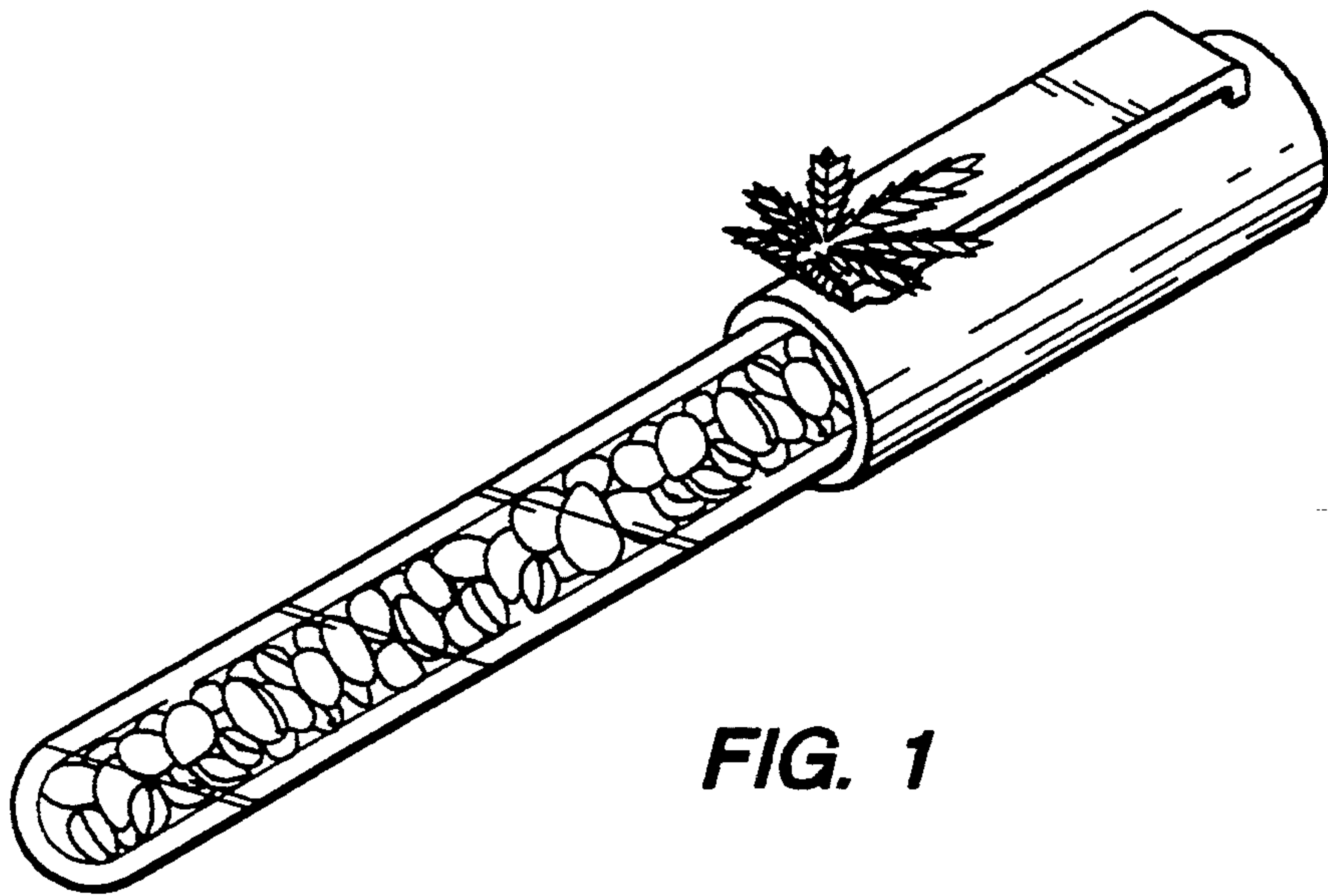

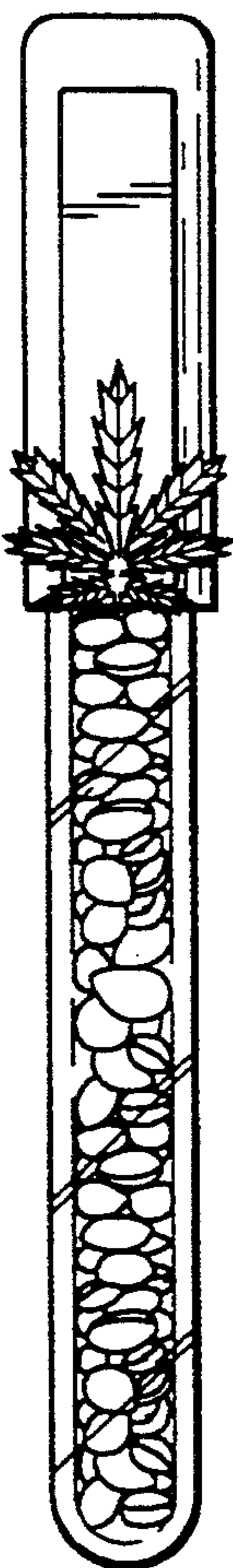

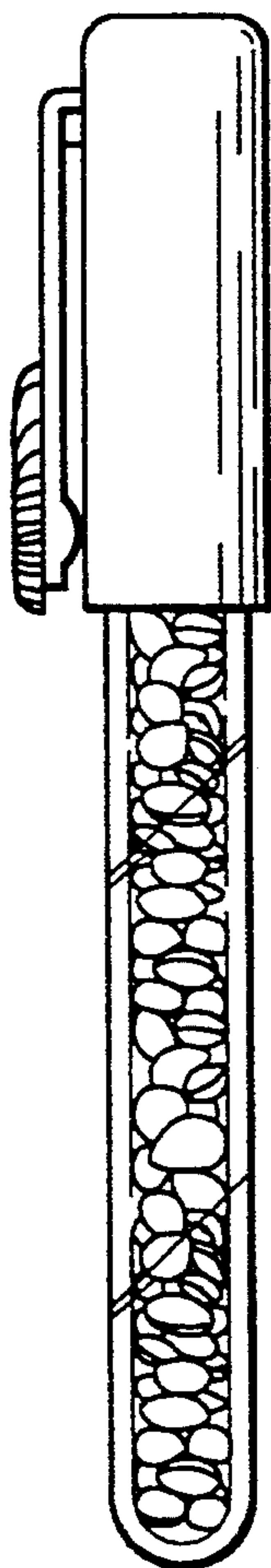

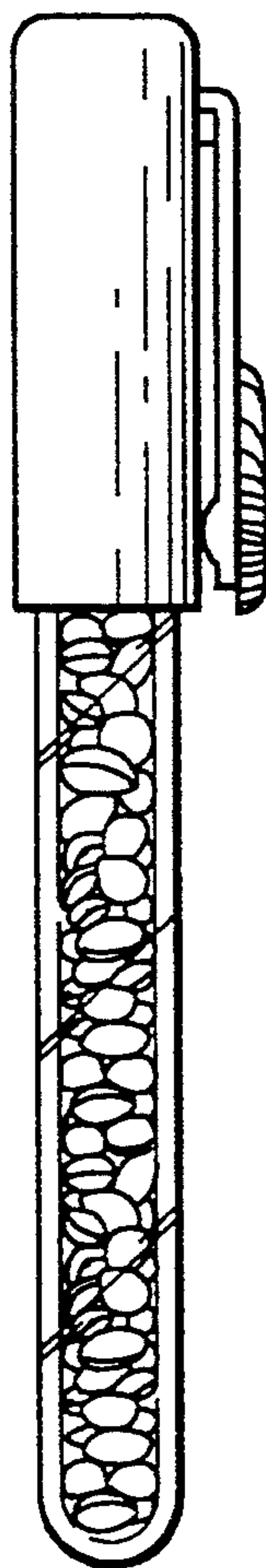

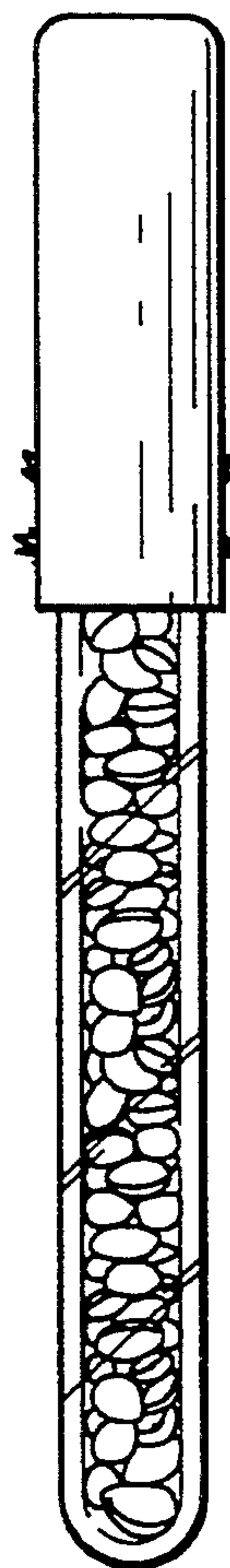

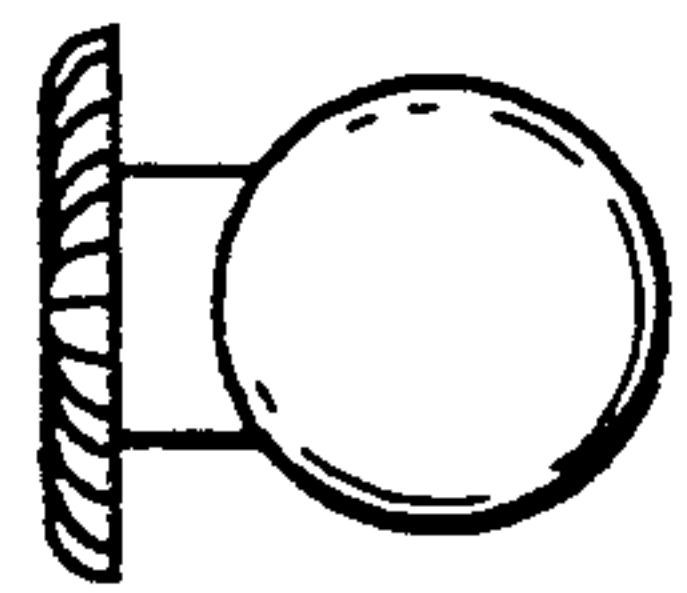

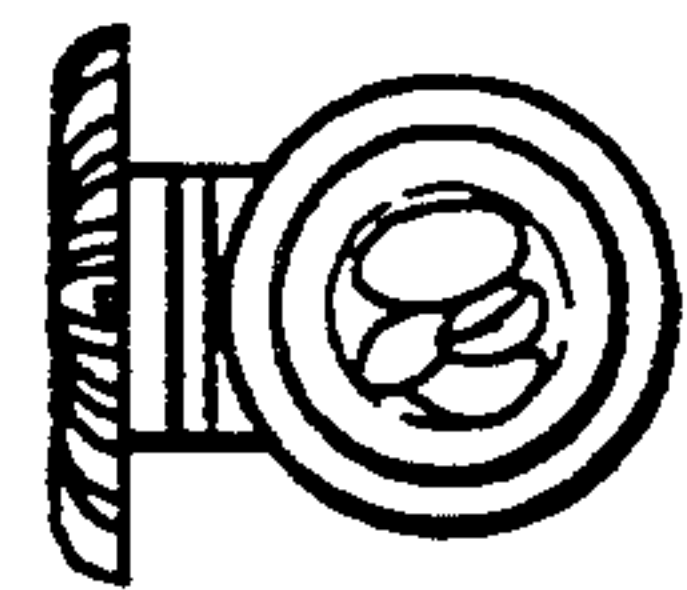

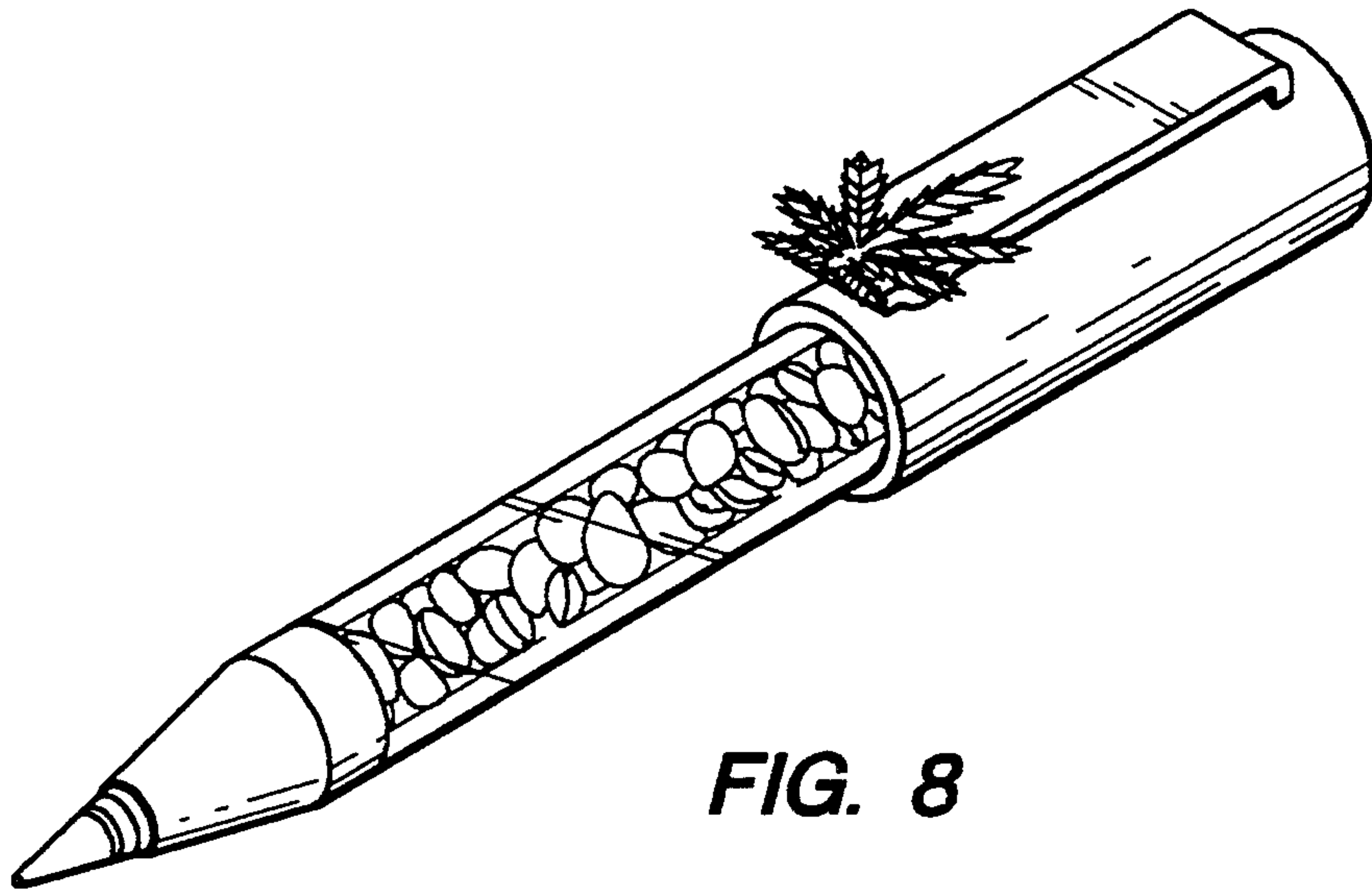

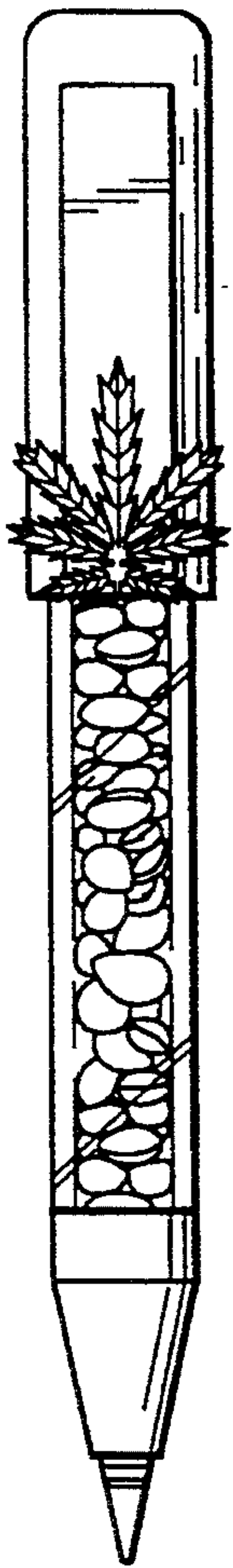

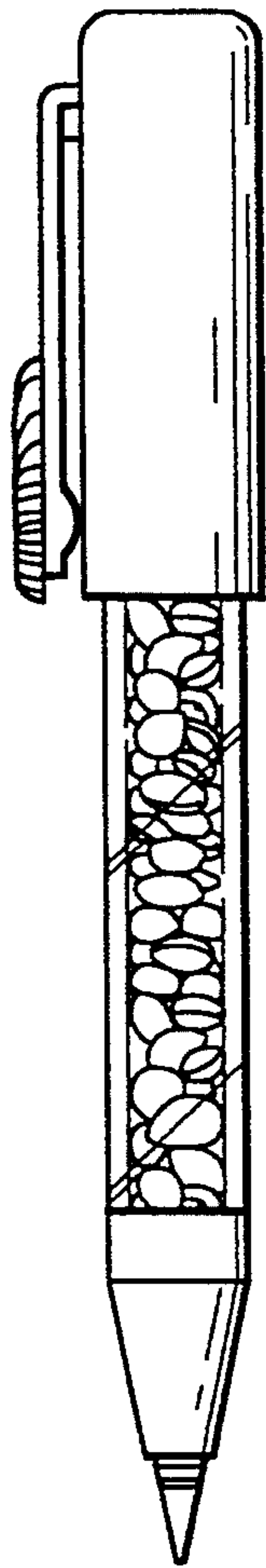

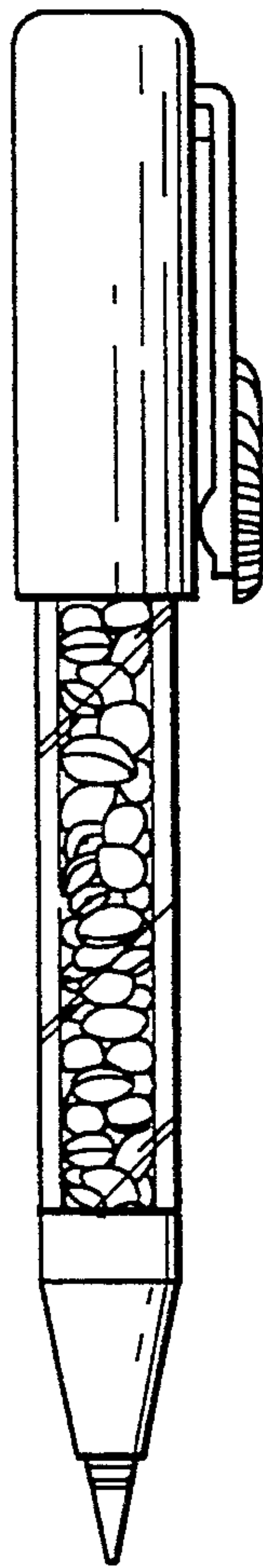

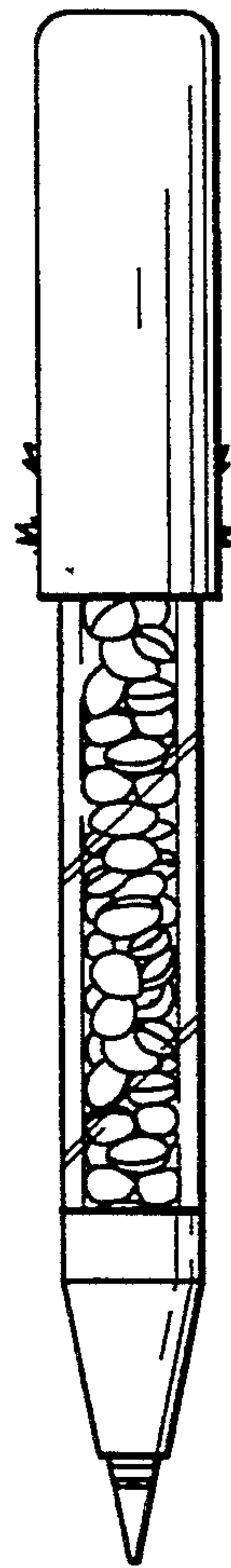

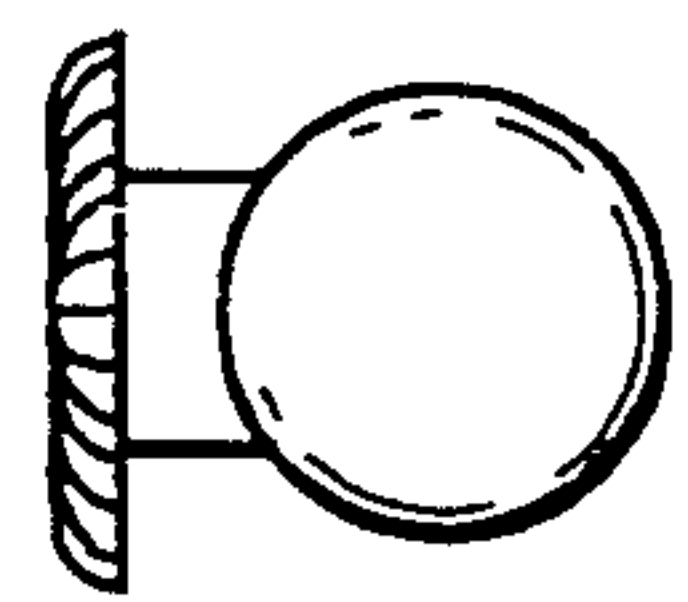

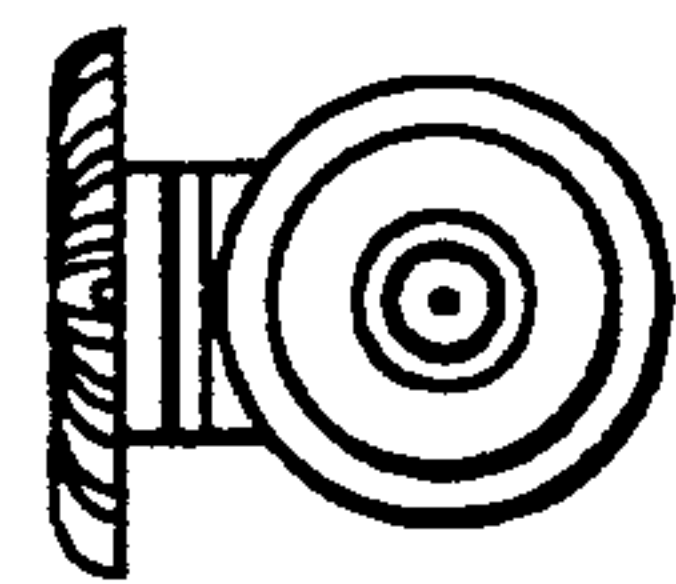
