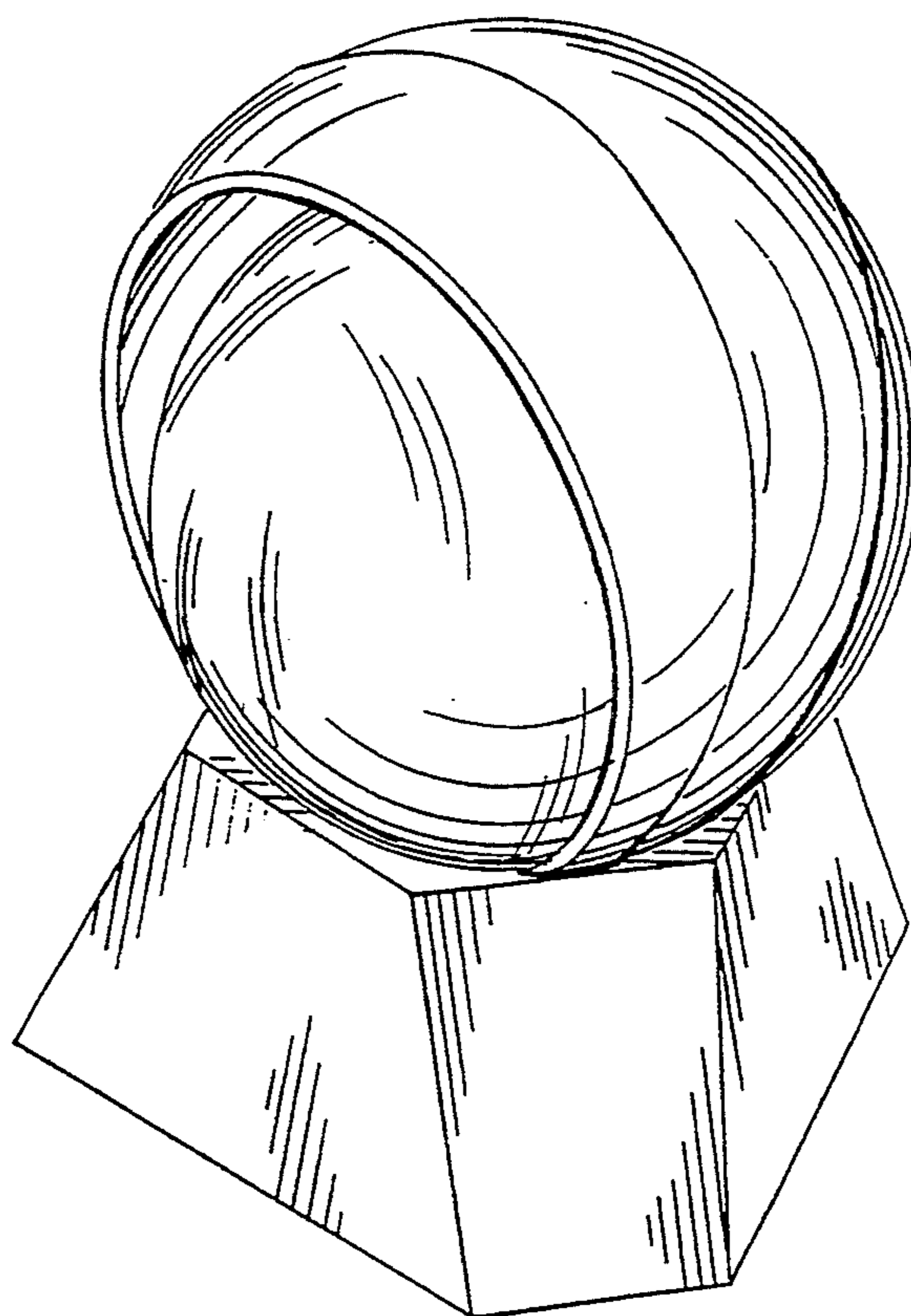

[57] **CLAIM**

The ornamental design for an illuminable display, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an illuminable display showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is an exploded right side elevational view thereof; and,
 FIG. 8 is an exploded right side elevational view of a second embodiment thereof, wherein the only difference resides in the omission of the layering hood portion.
 The broken lines are for illustrative purposes only and form no part of the claimed design.



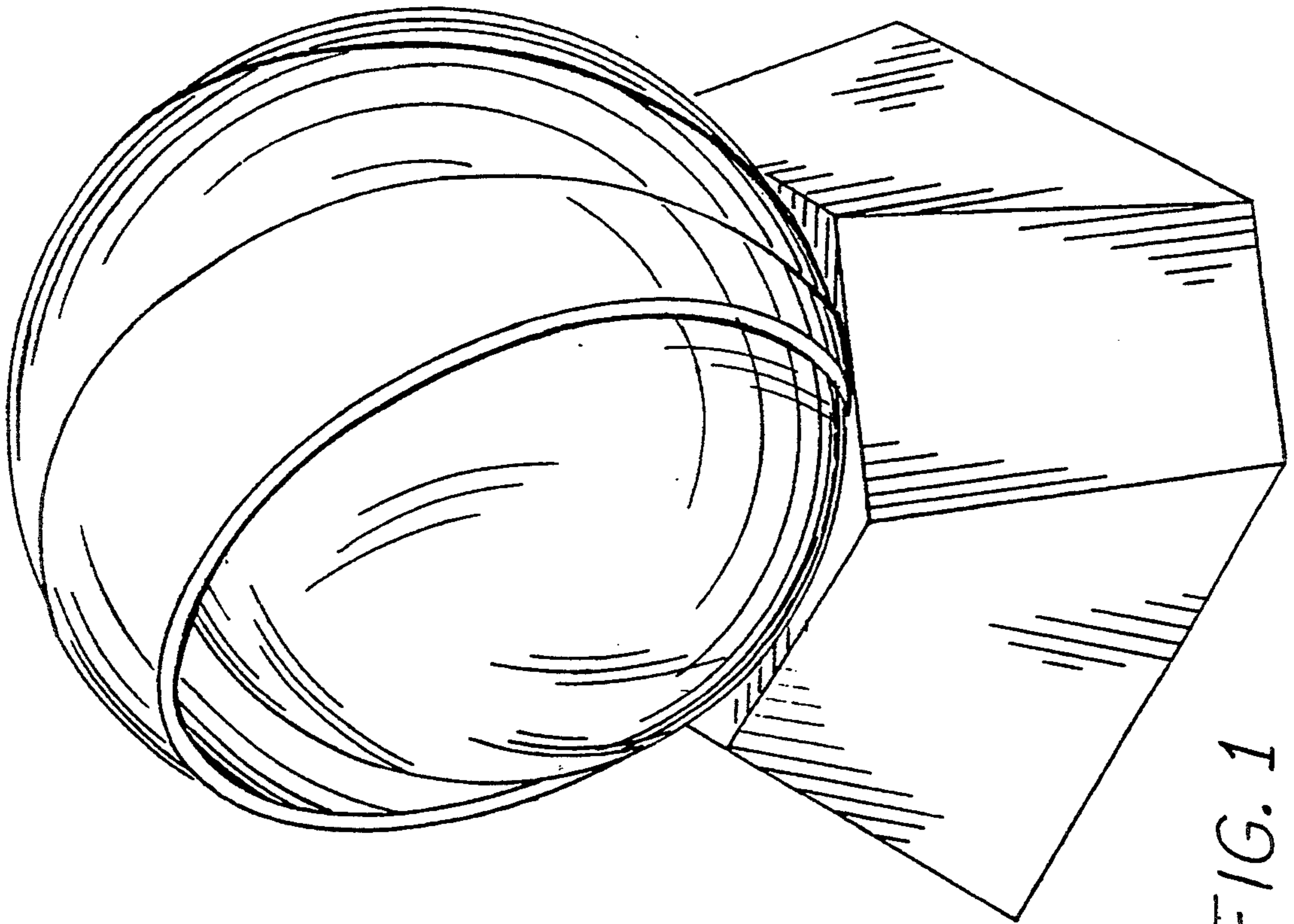

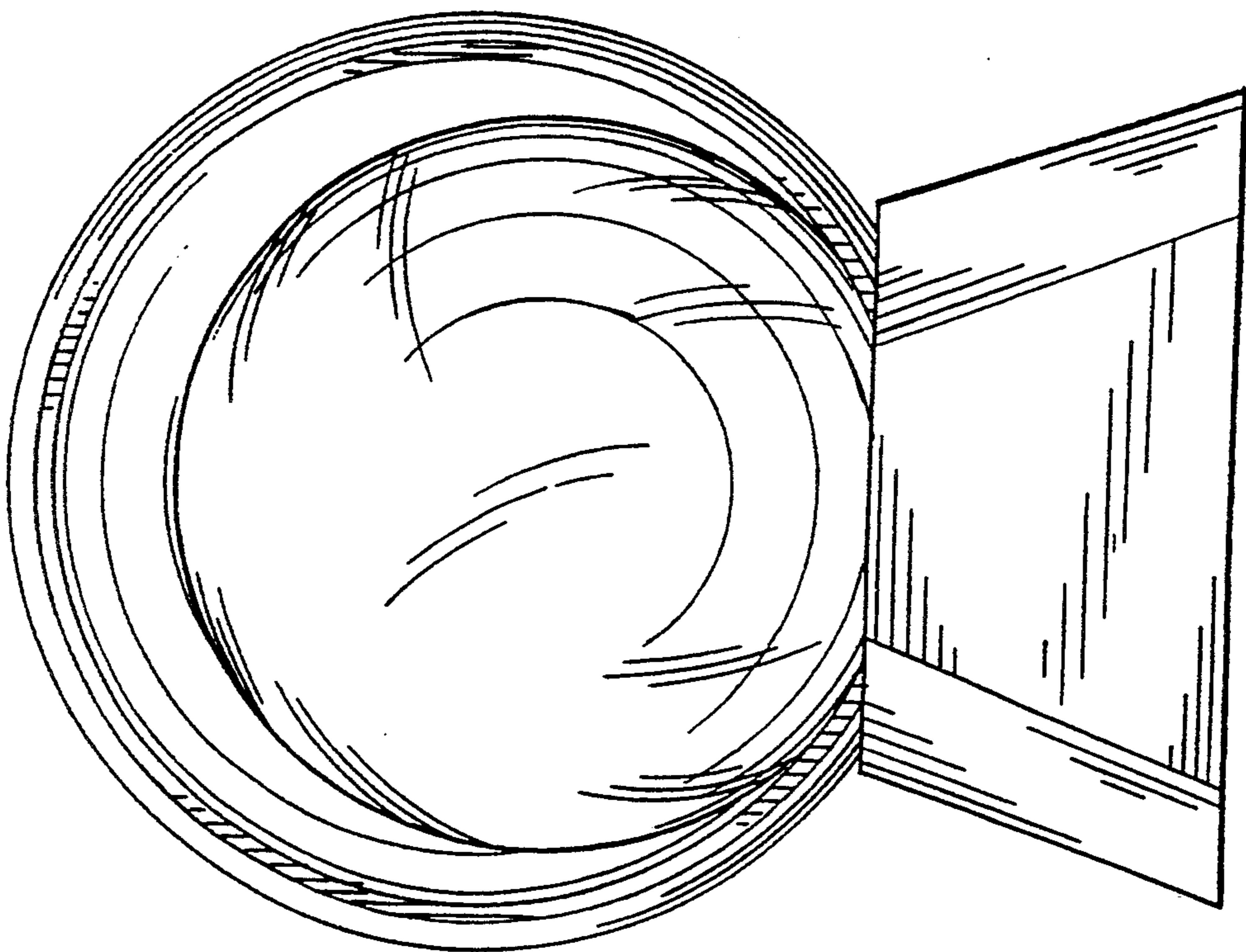

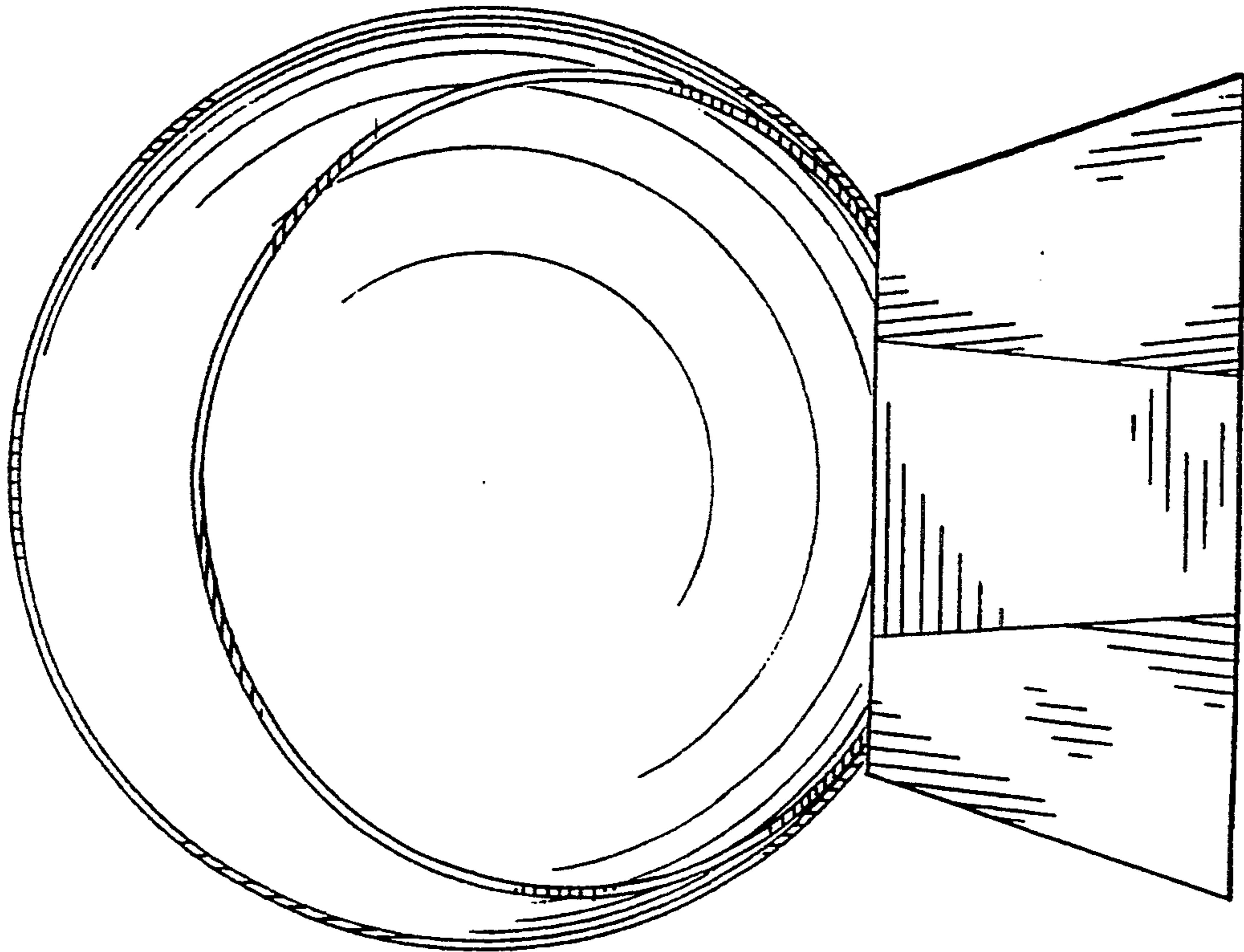

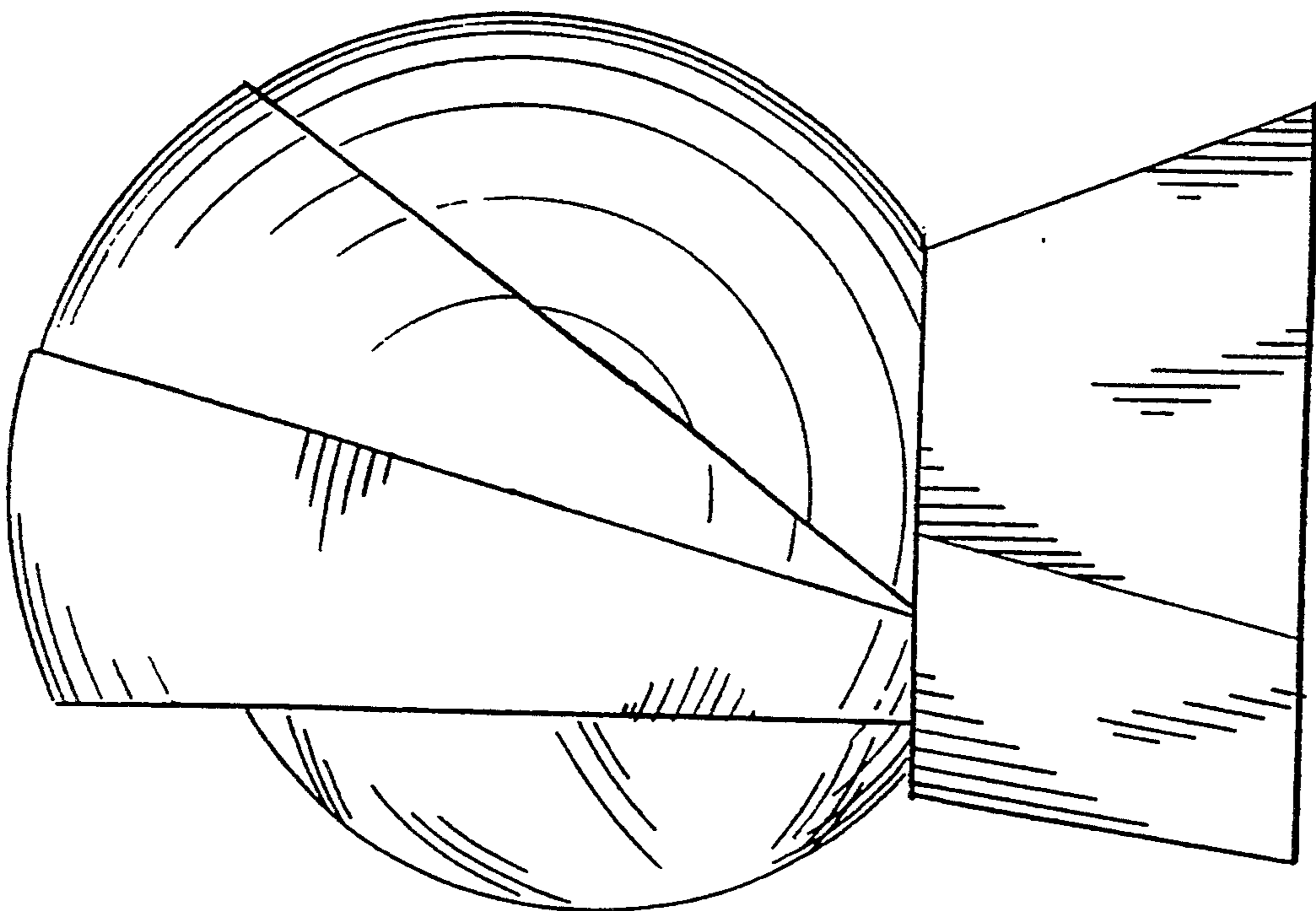

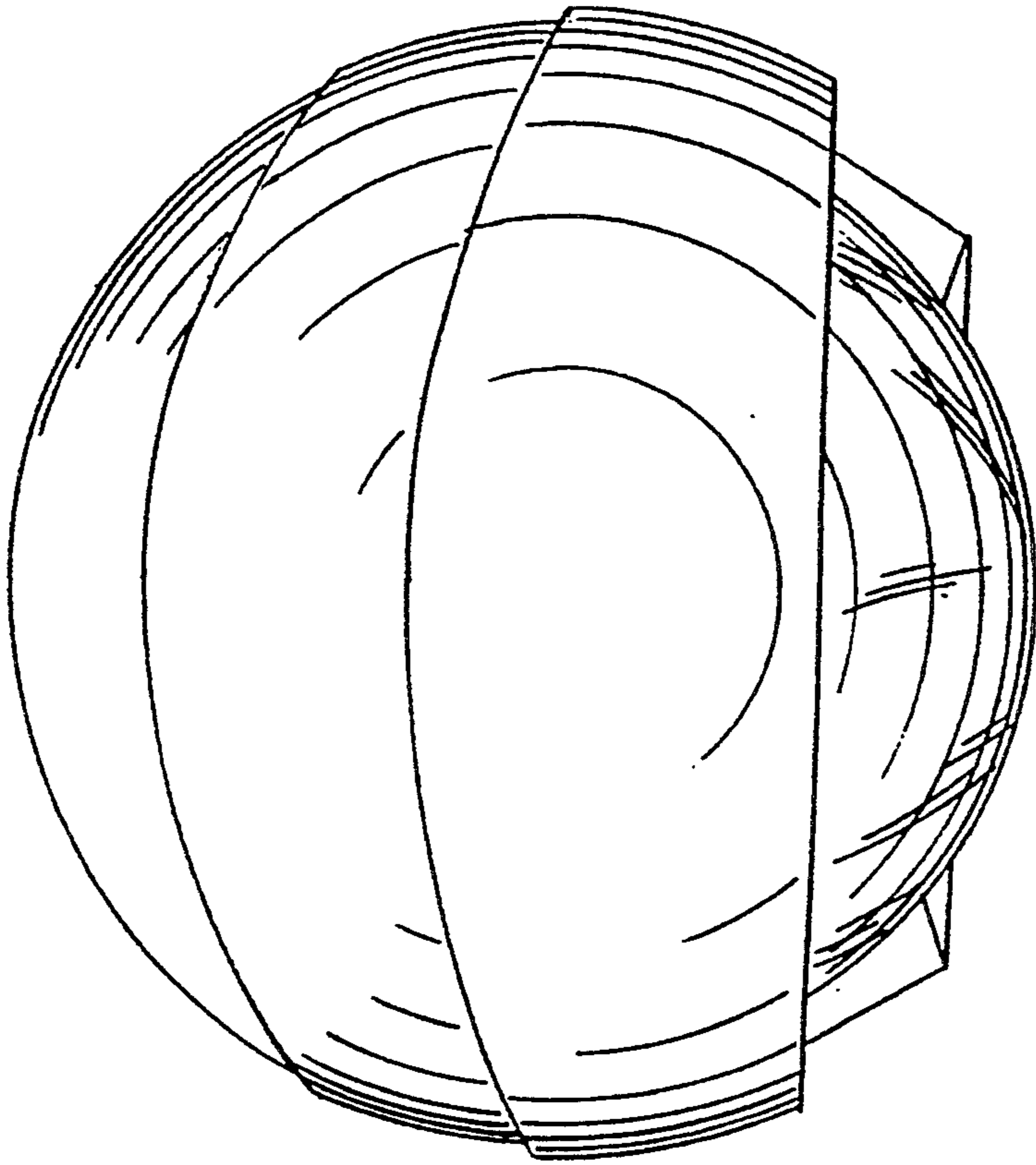

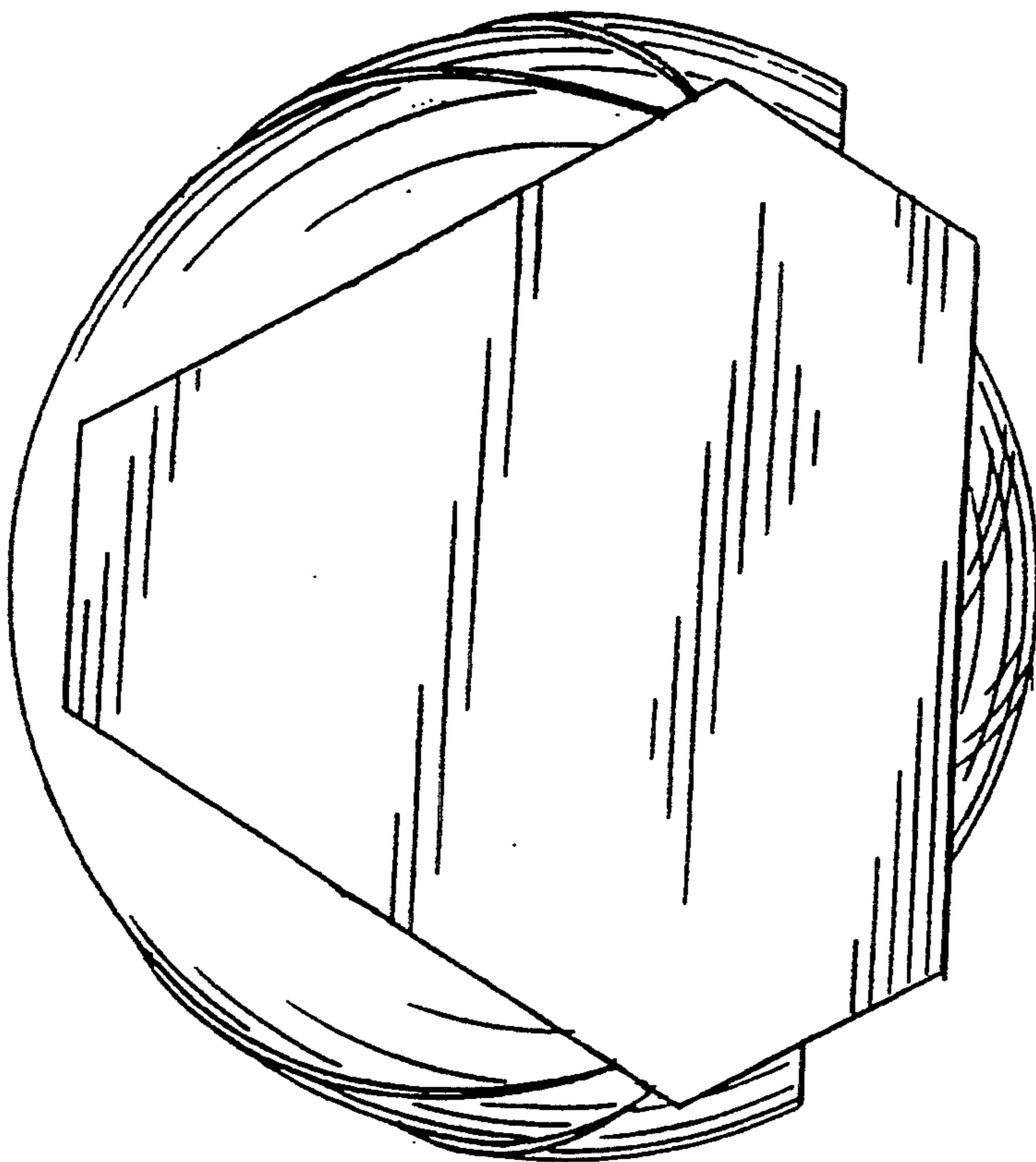
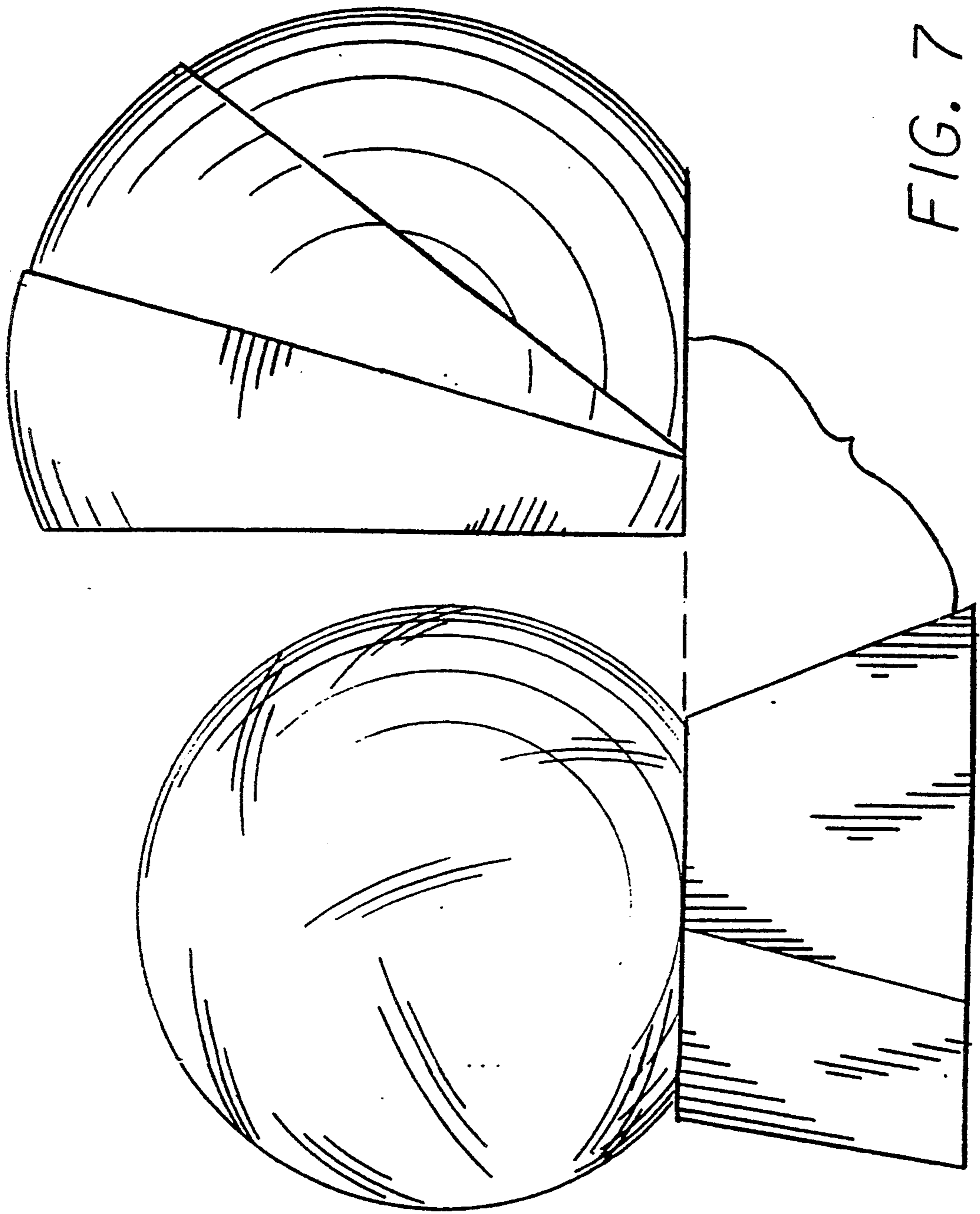
