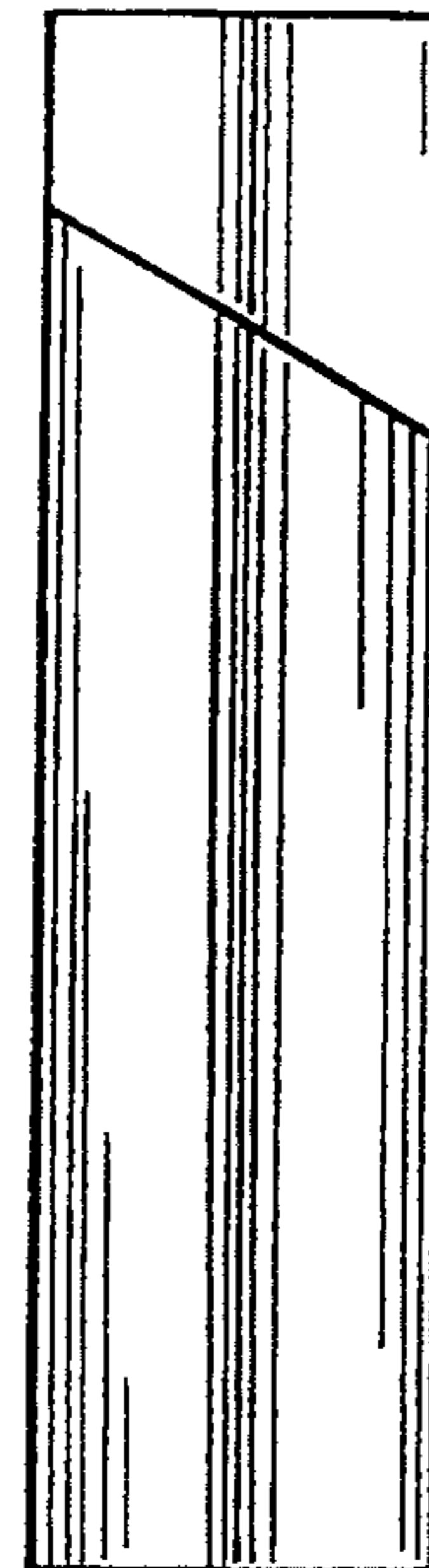
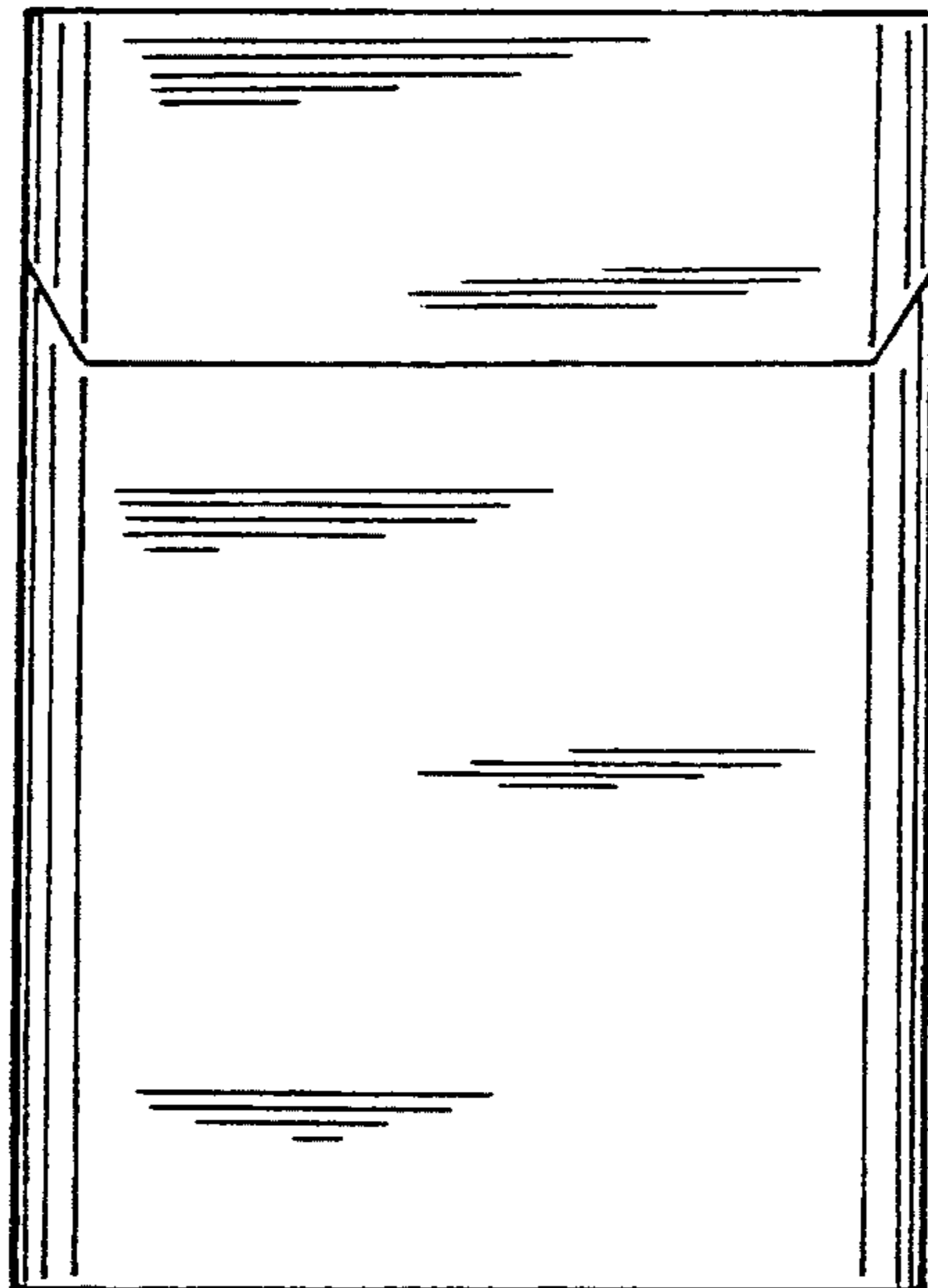

[57] **CLAIM**

The ornamental design for a rigid hinged-lid cigarette packet, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of one embodiment of a rigid hinged-lid cigarette packet showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a top plan view of a second embodiment of the design shown in FIG. 1; FIG. 8 is a front elevational view thereof; FIG. 9 is a right side elevational view thereof; FIG. 10 is a left side elevational view thereof; FIG. 11 is a rear elevational view thereof; FIG. 12 is a bottom plan view thereof; FIG. 13 is a top plan view of a third embodiment of the design shown in FIG. 1; FIG. 14 is a front elevational view thereof; FIG. 15 is a right side elevational view thereof; FIG. 16 is a left side elevational view thereof; FIG. 17 is a rear elevational view thereof; and, FIG. 18 is a bottom plan view thereof.



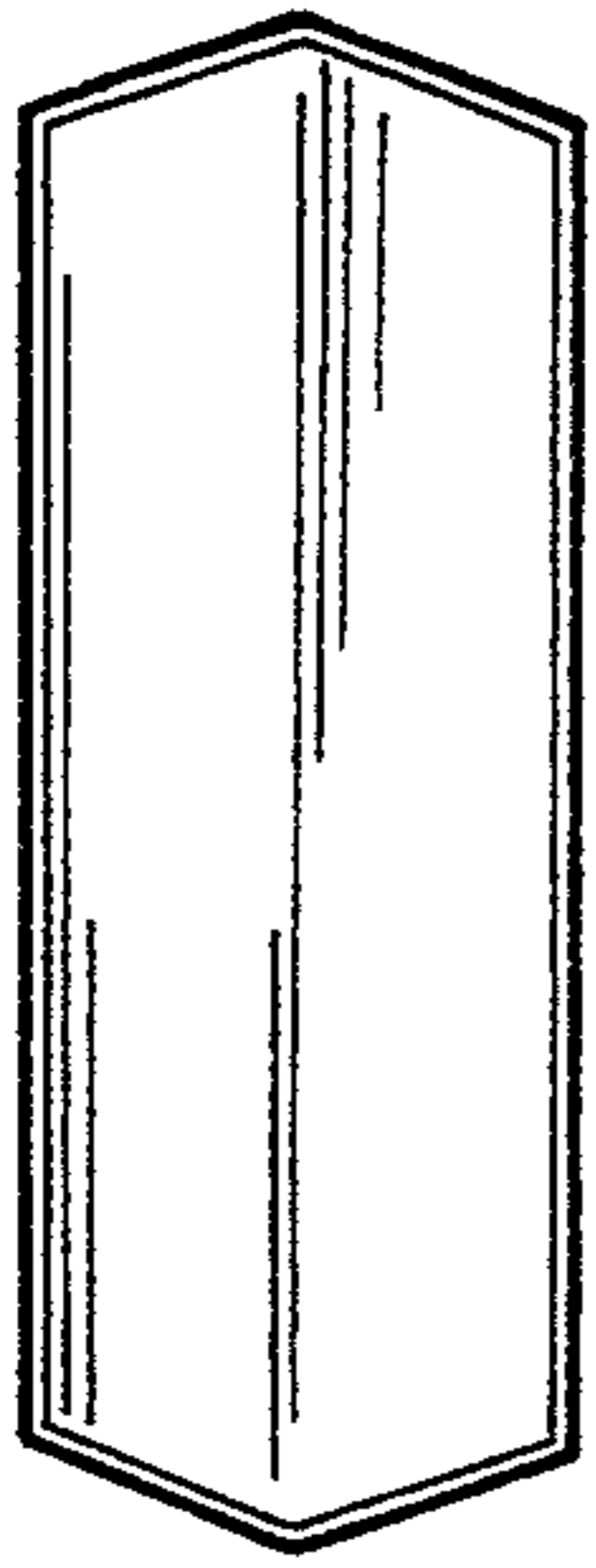

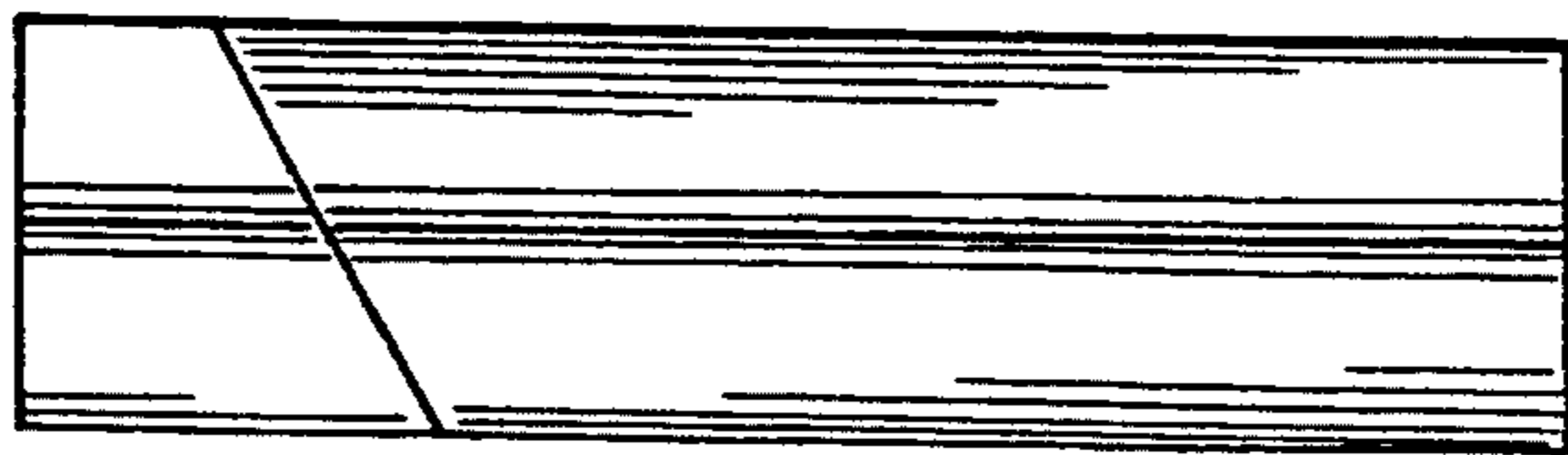

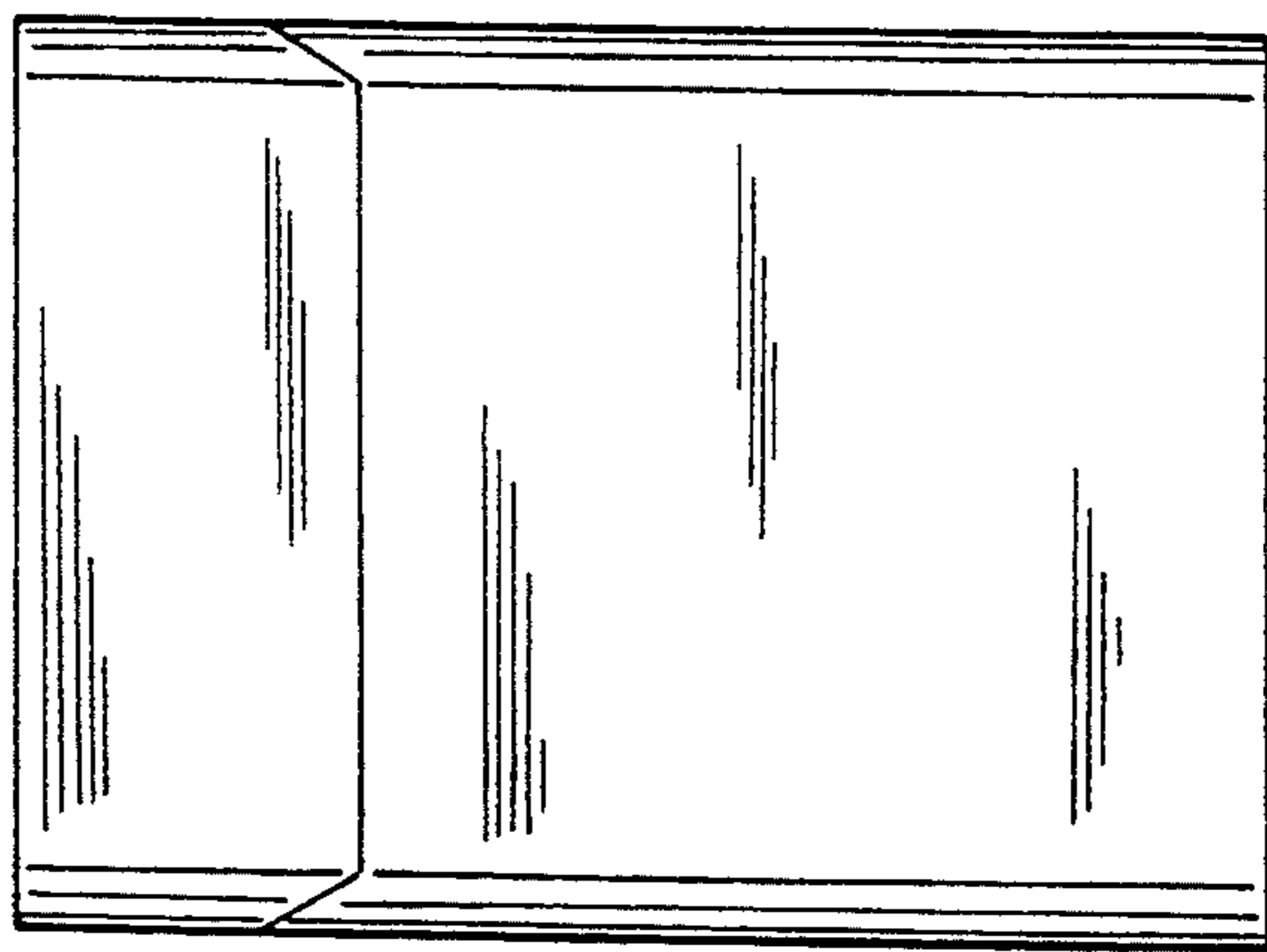

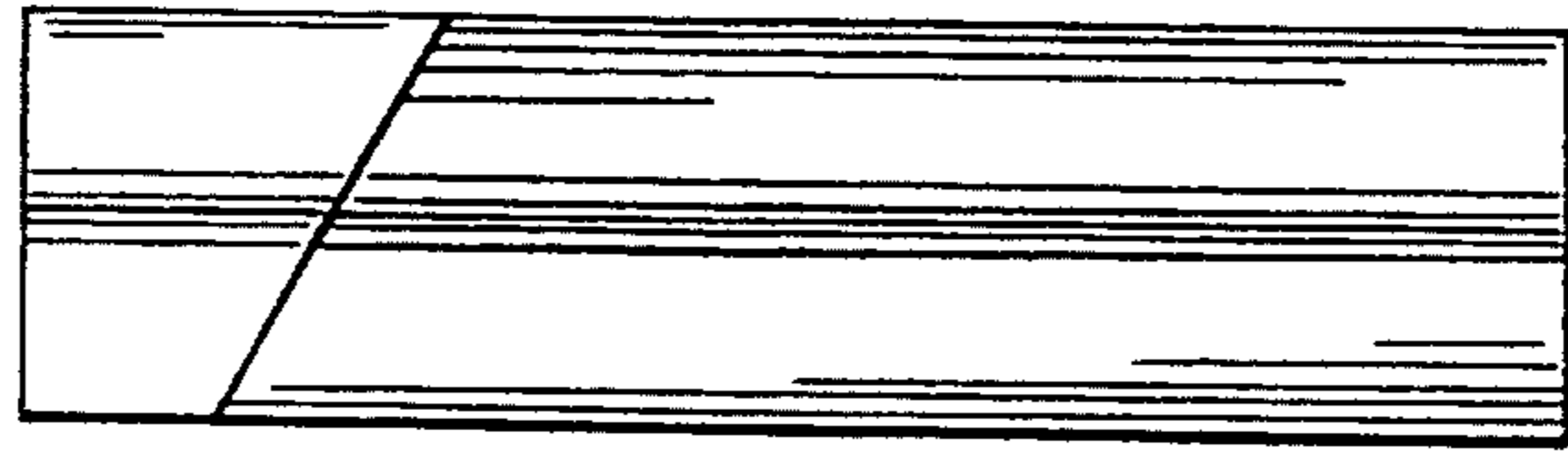

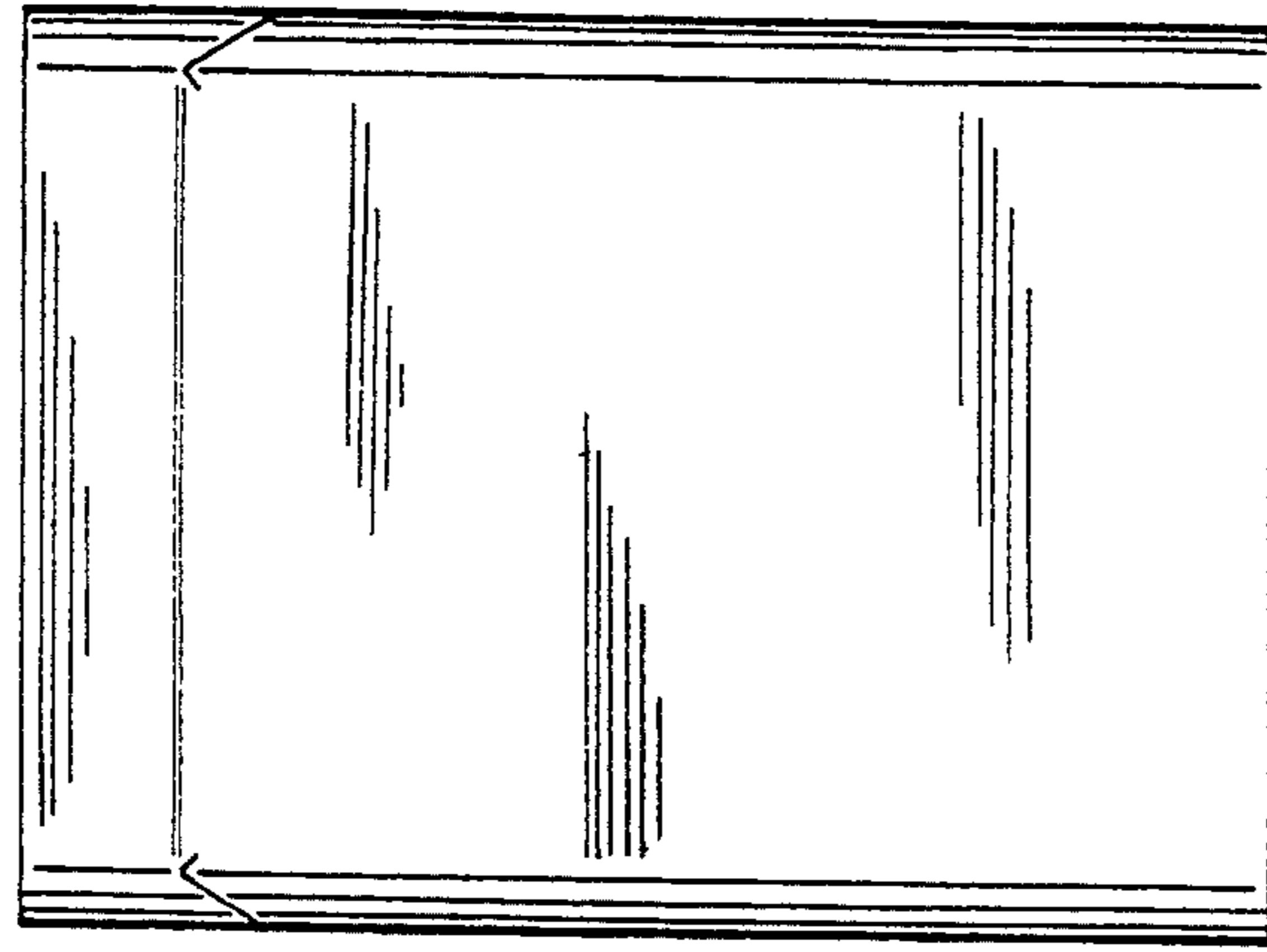

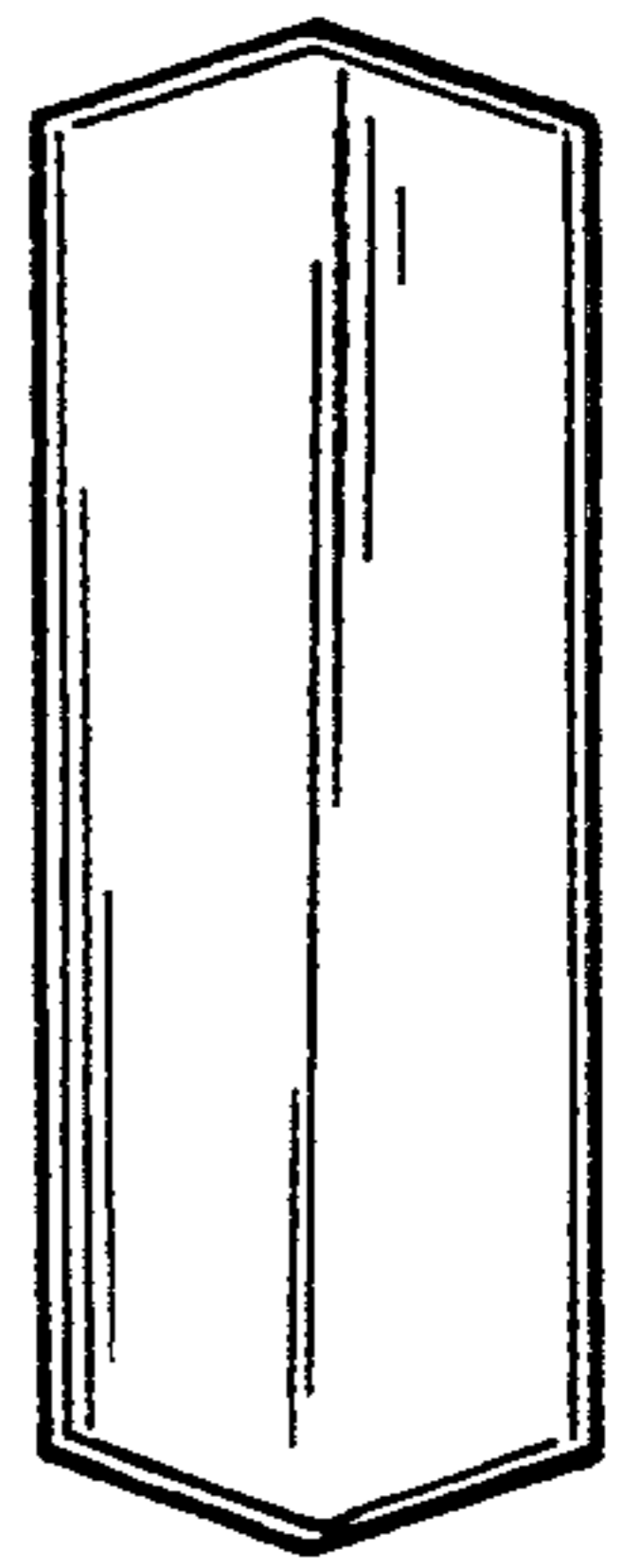

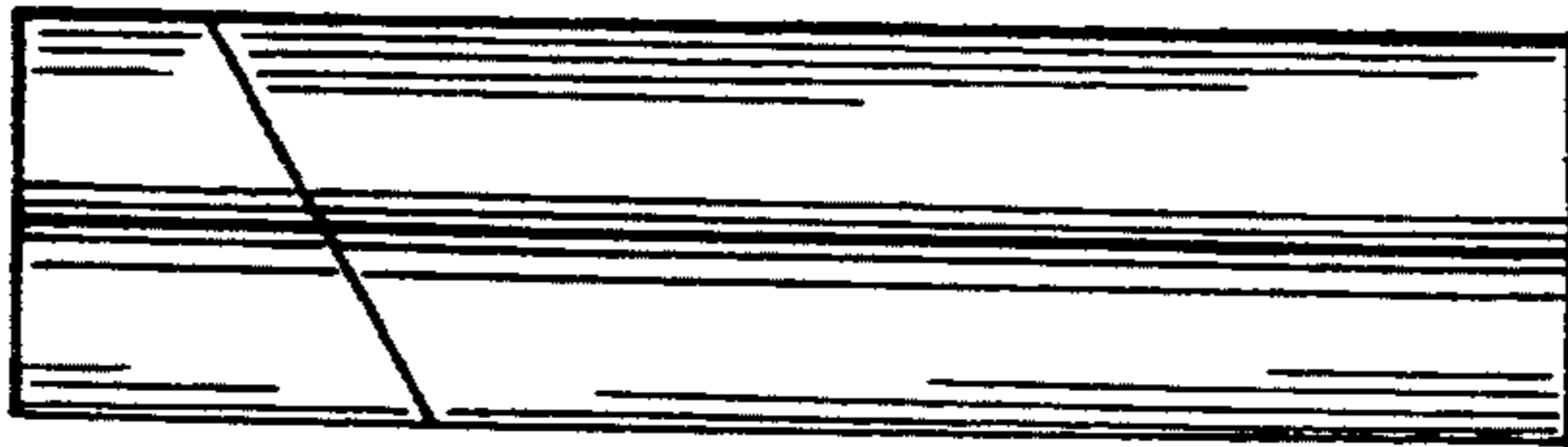

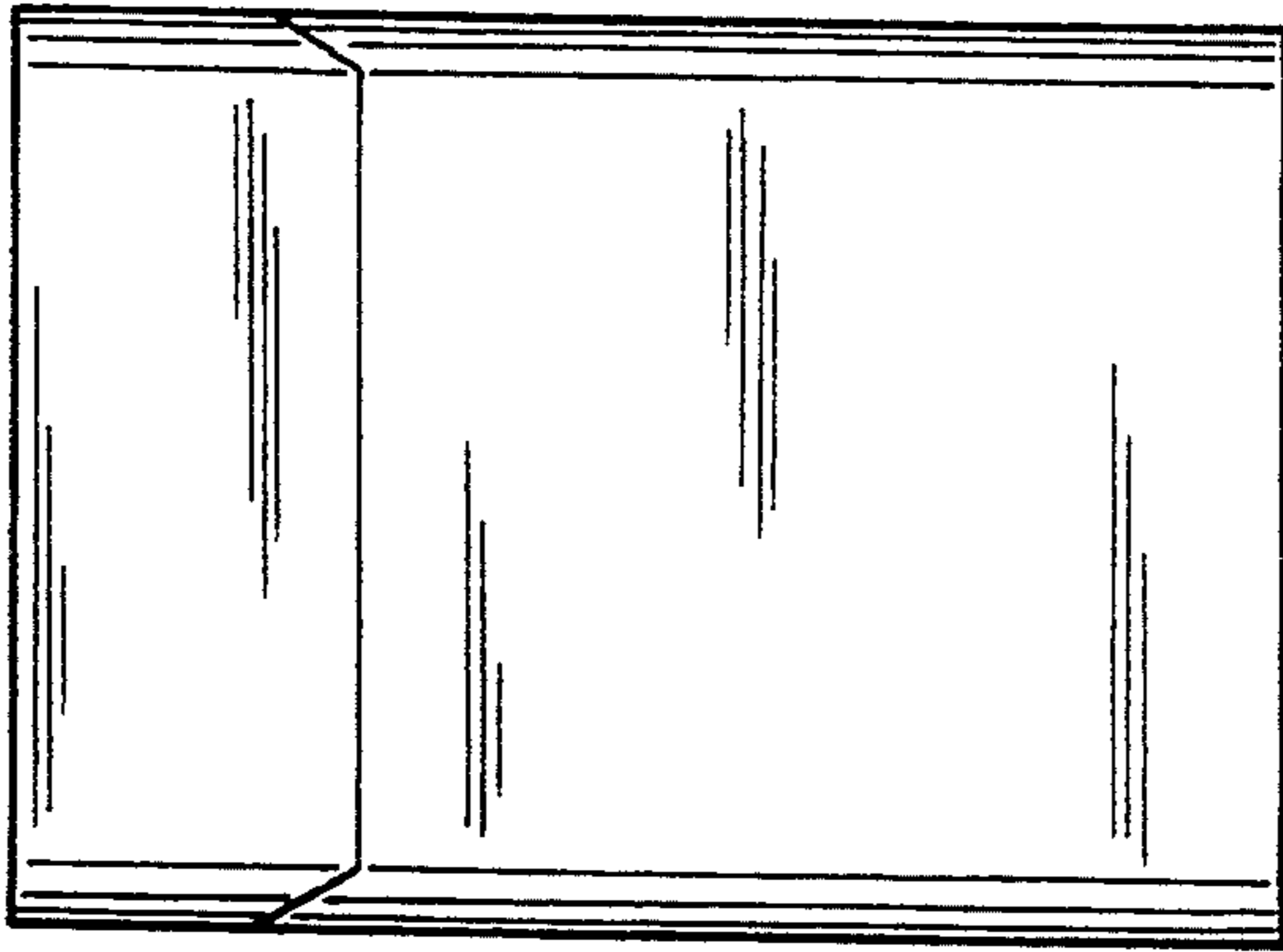

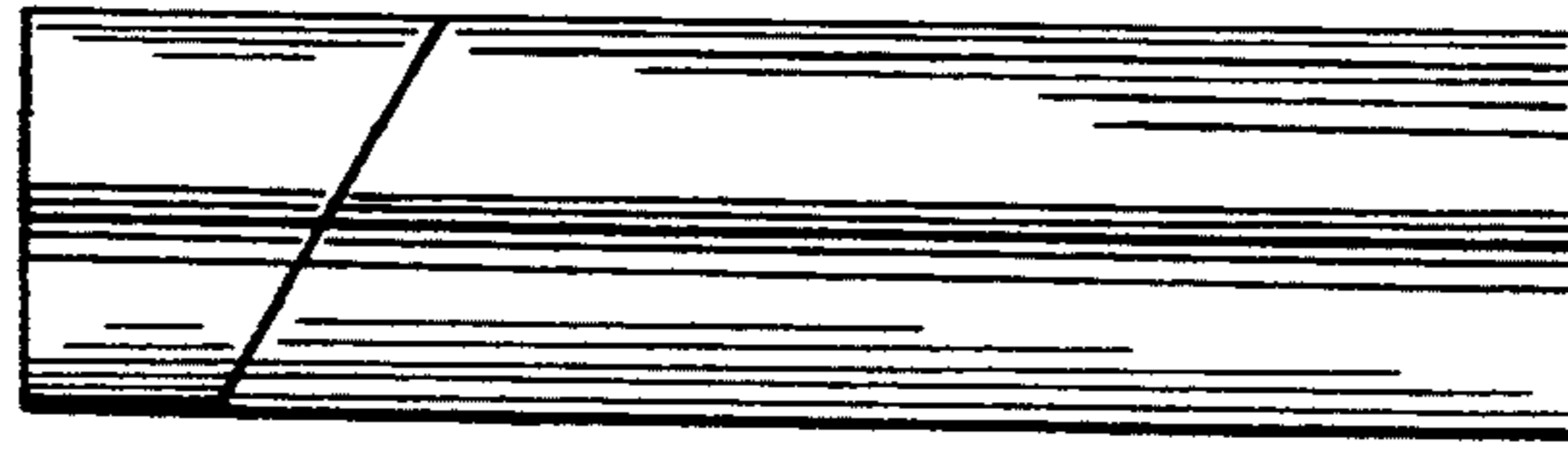

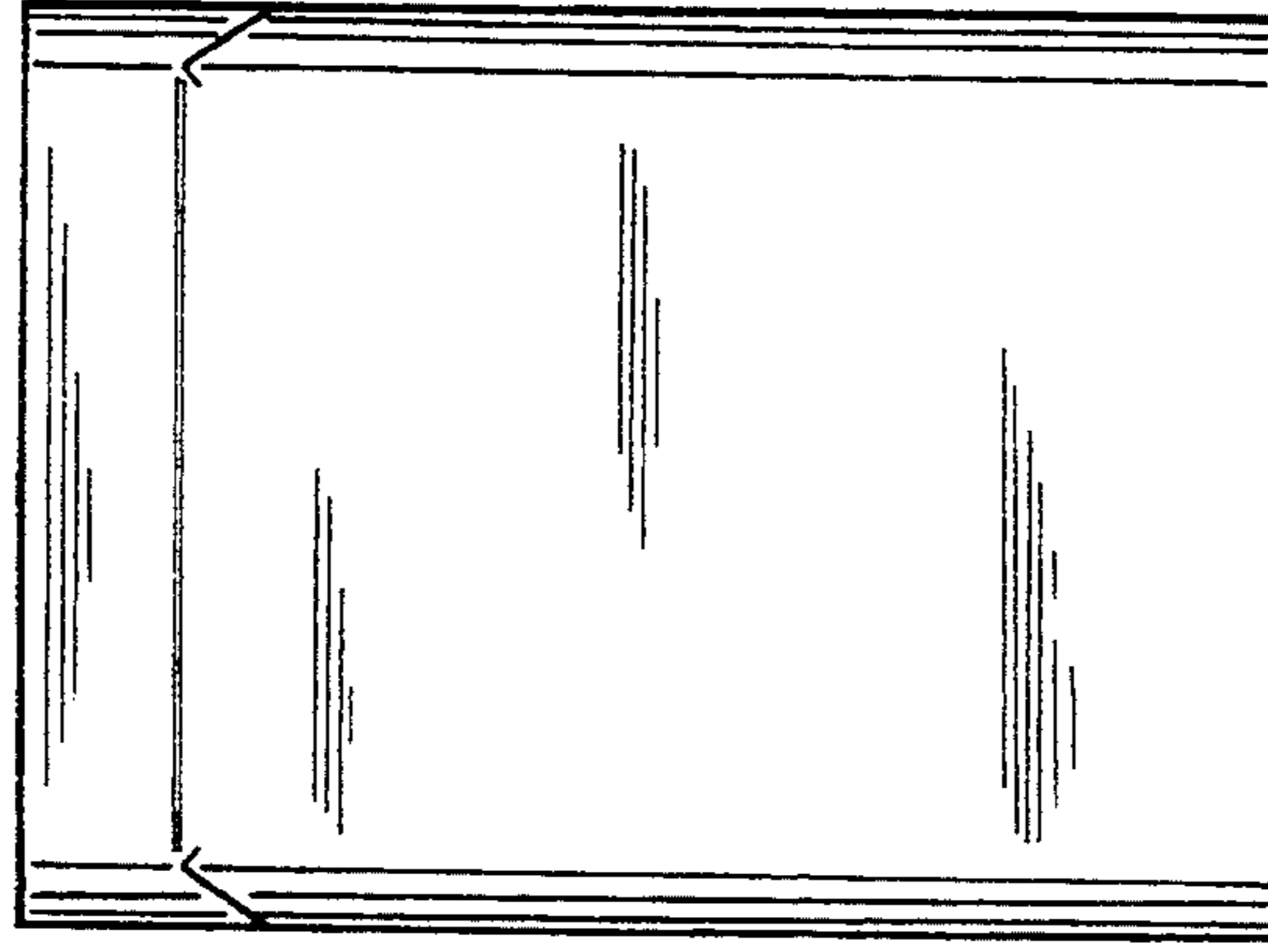

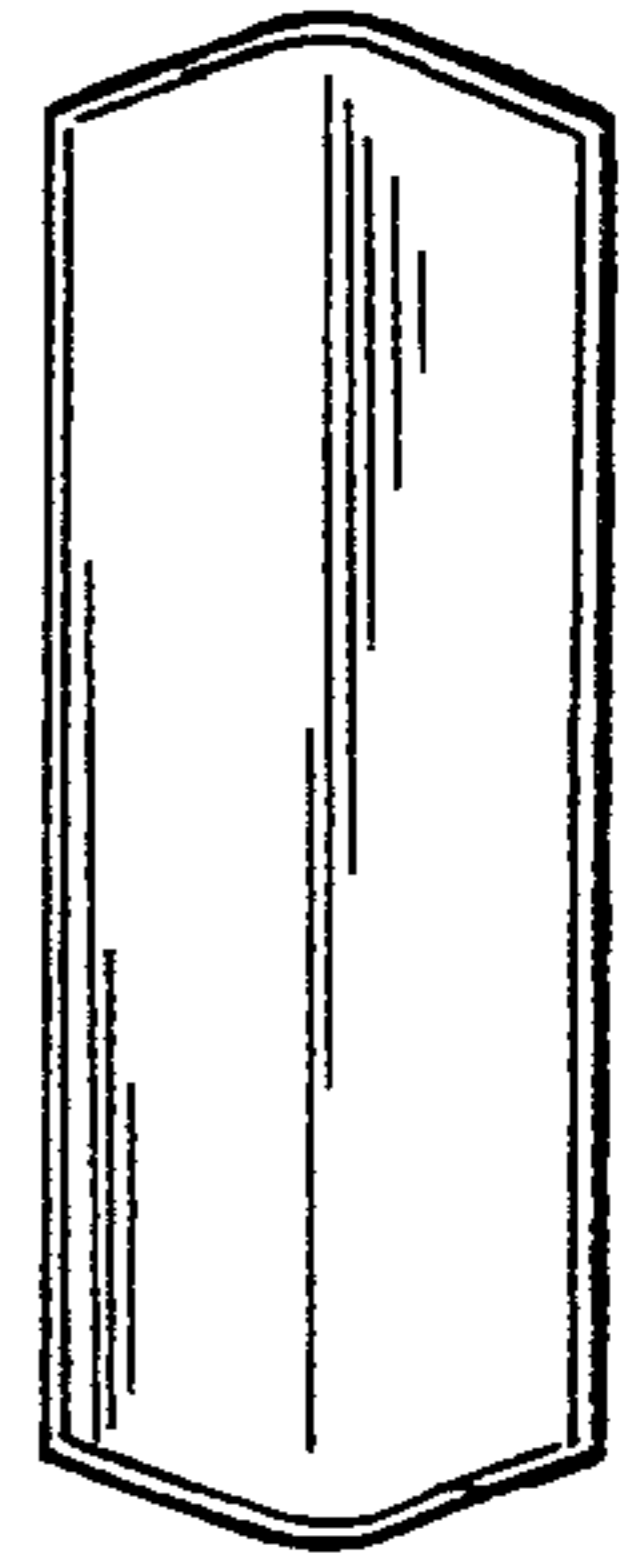

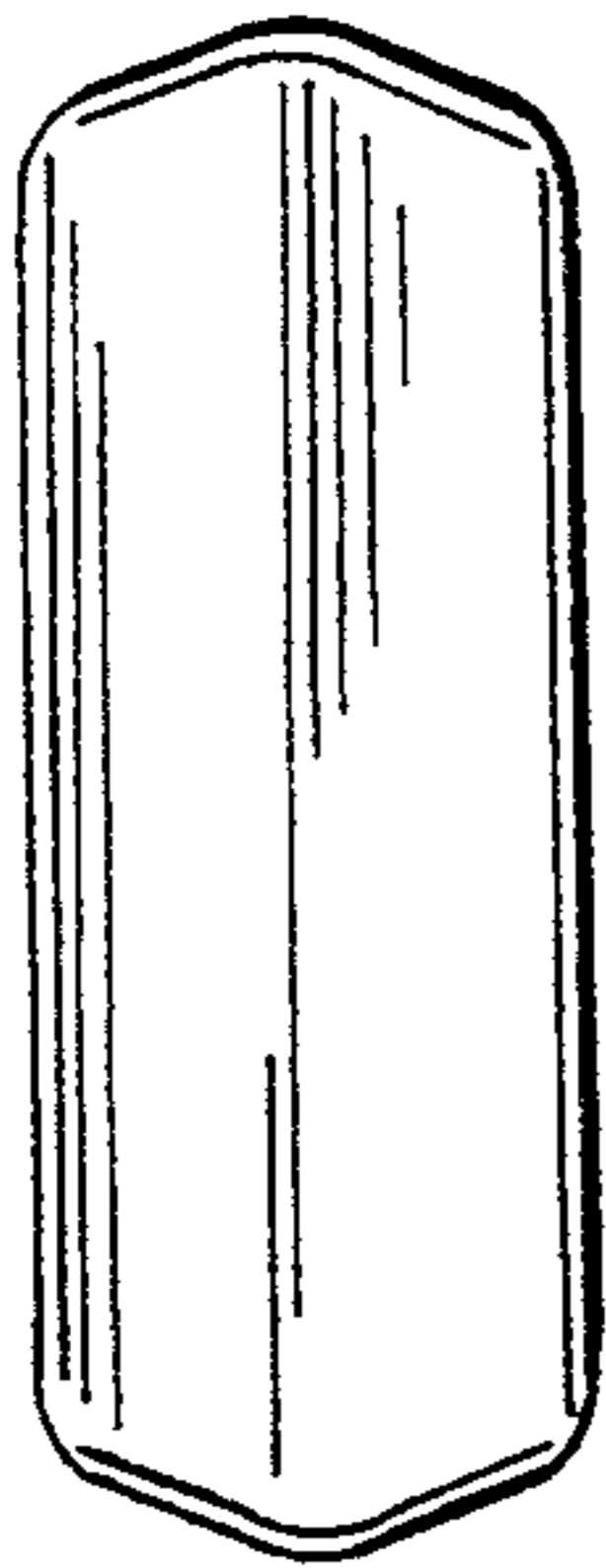

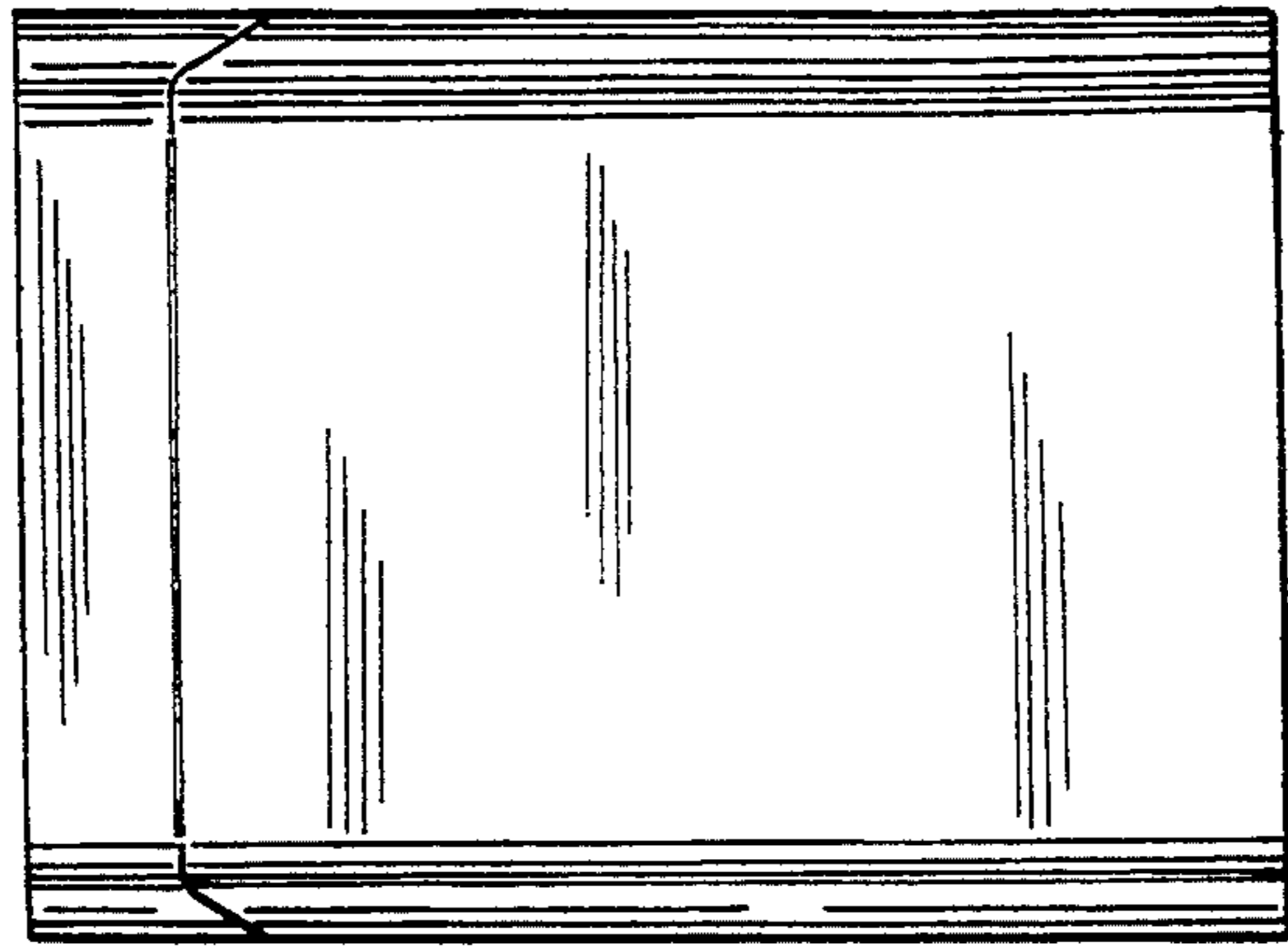

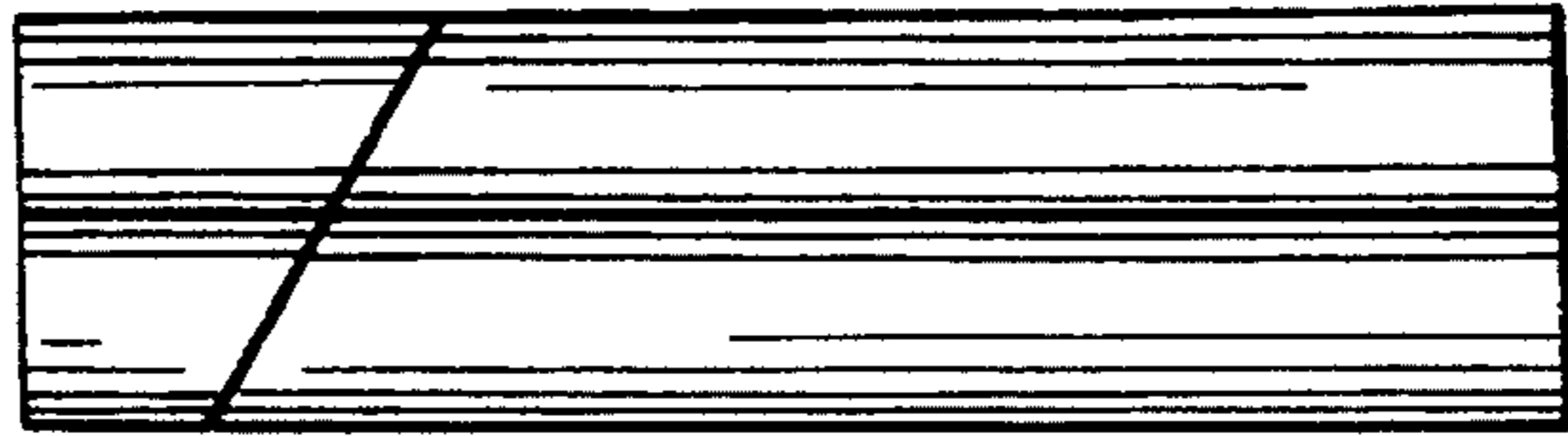

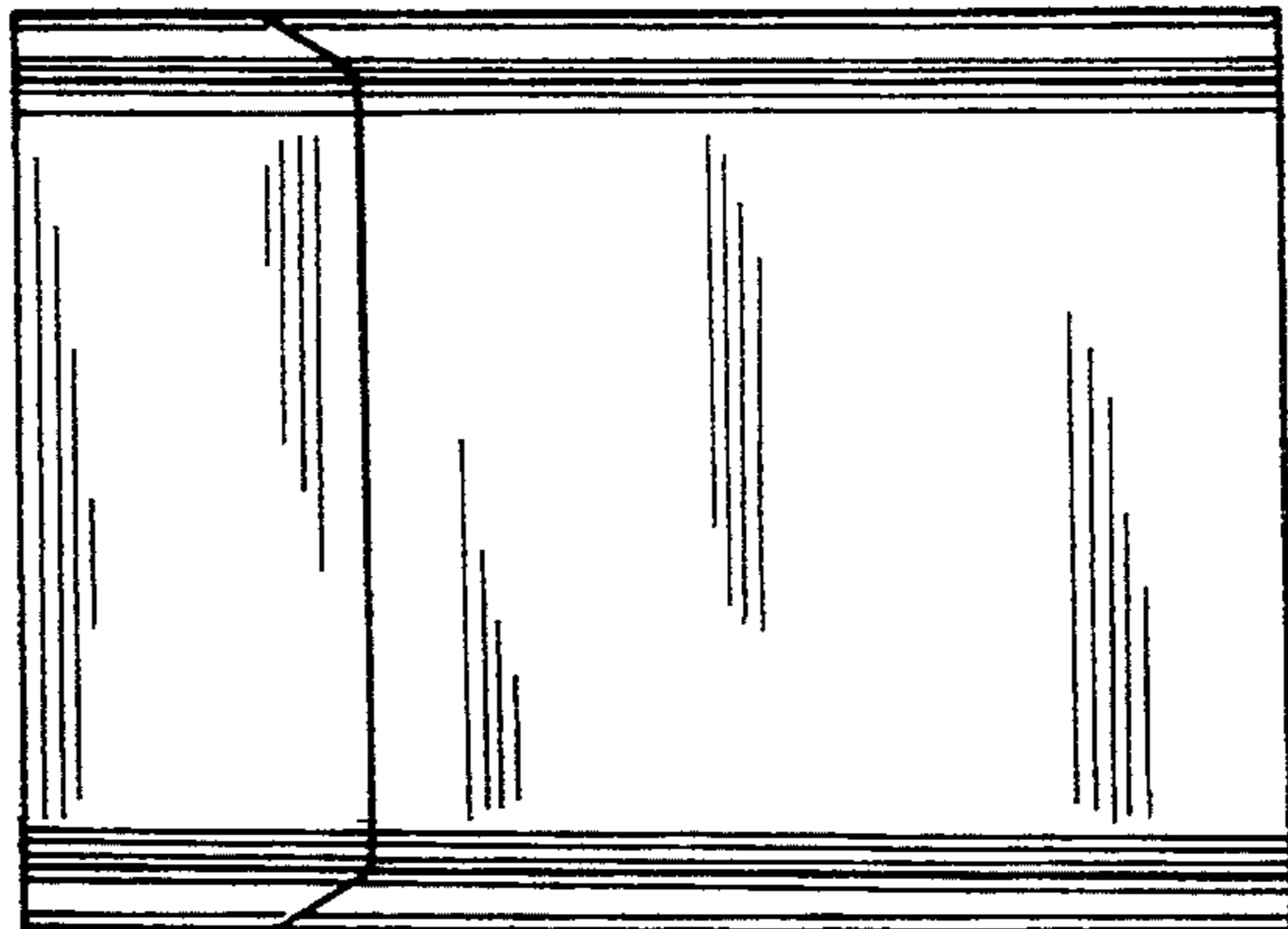

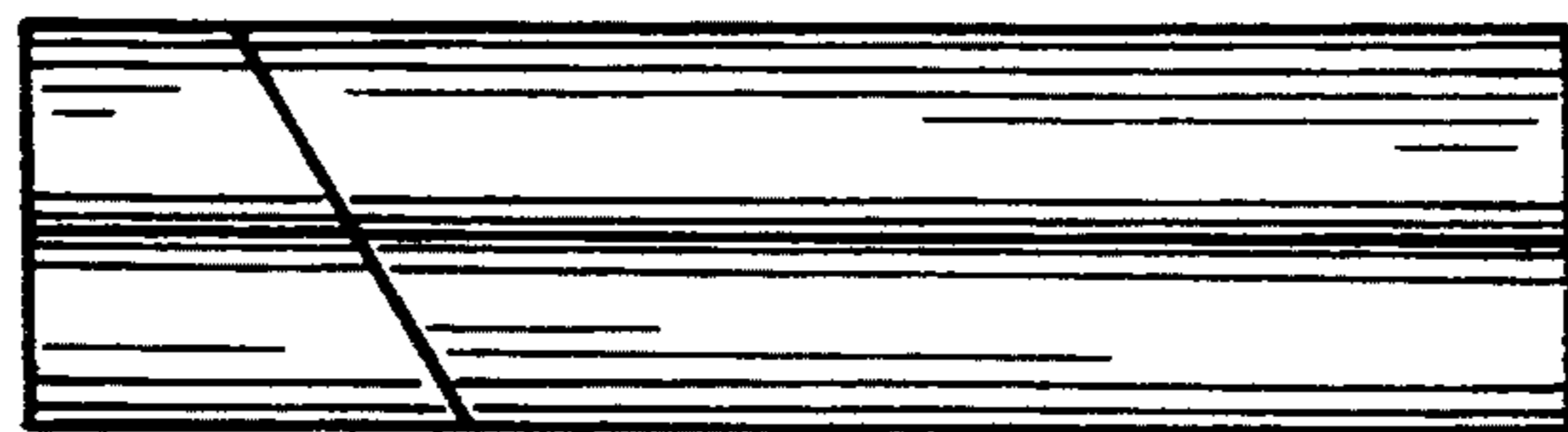

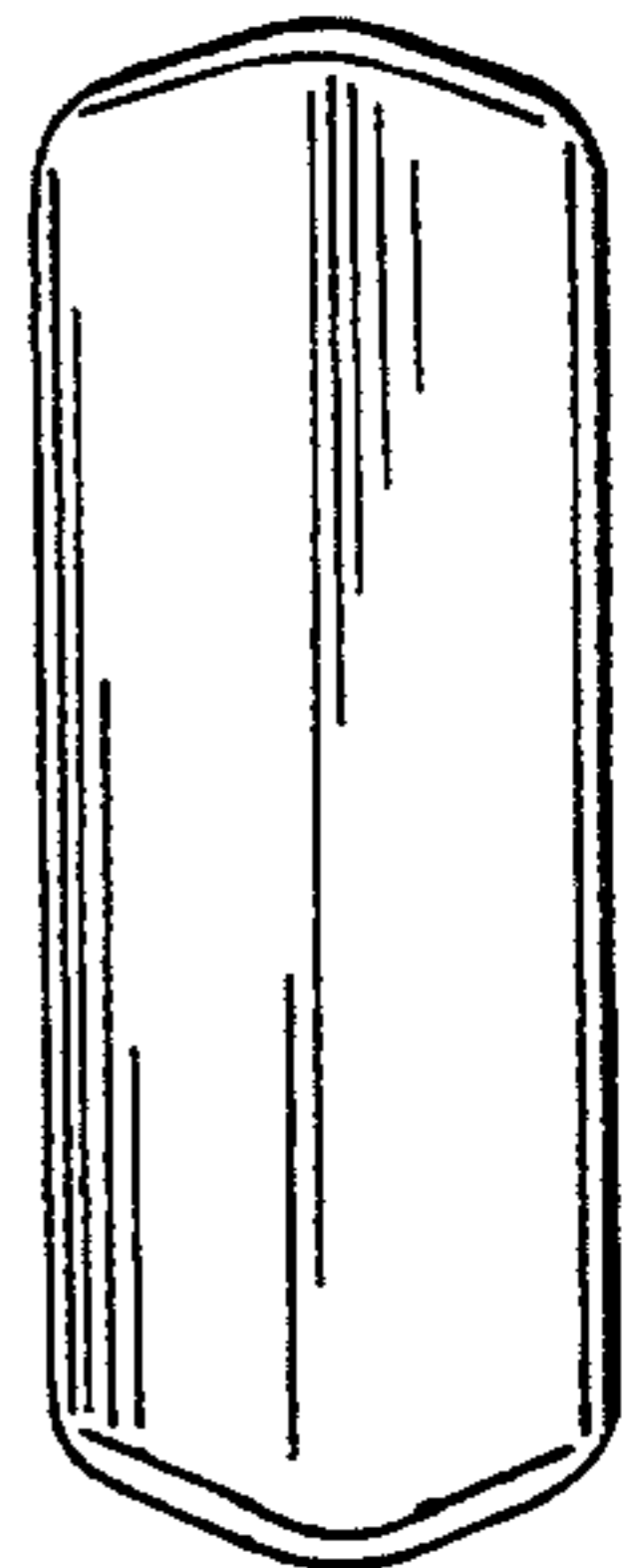
