[57] CLAIM

The ornamental design for a pedestal mounted drinking fountain, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the top, front and right sides of a pedestal mounted drinking fountain embodying my new design;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a perspective view of a pedestal mounted drinking fountain, showing a second embodiment of my new design;

FIG. 9 is a perspective view illustrating the top, rear and left sides of the embodiment of FIG. 8;

FIG. 10 is a right side elevational view of the embodiment of FIG. 8;

FIG. 11 is a rear elevational view of the embodiment of FIG. 8;

FIG. 12 is a front elevational view of the embodiment of FIG. 8;

FIG. 13 is a left side elevational view of the embodiment of FIG. 8;

FIG. 14 is a top plan view of the embodiment of FIG. 8; and,

FIG. 15 is a bottom plan view of the embodiment of FIG. 8.

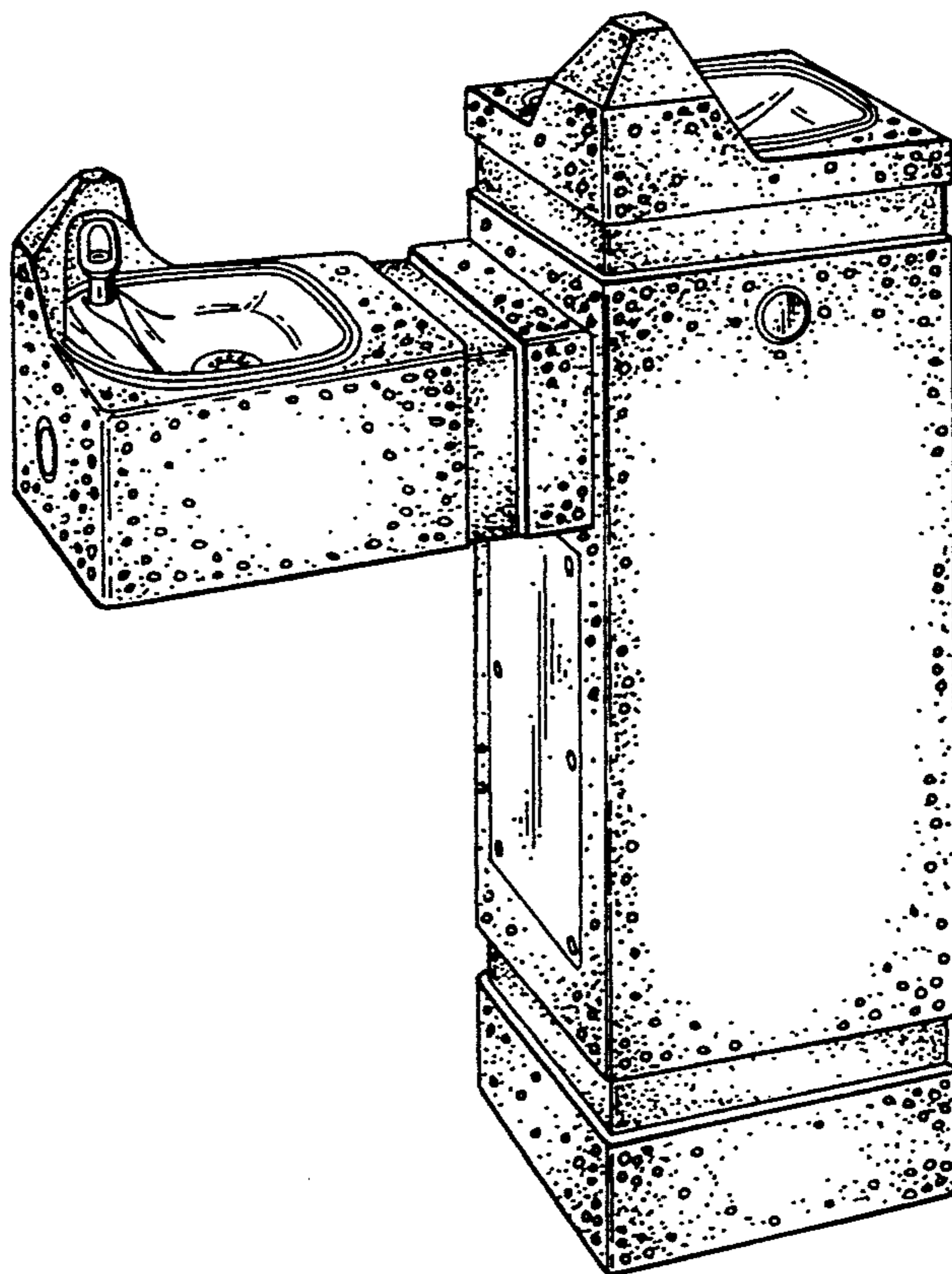

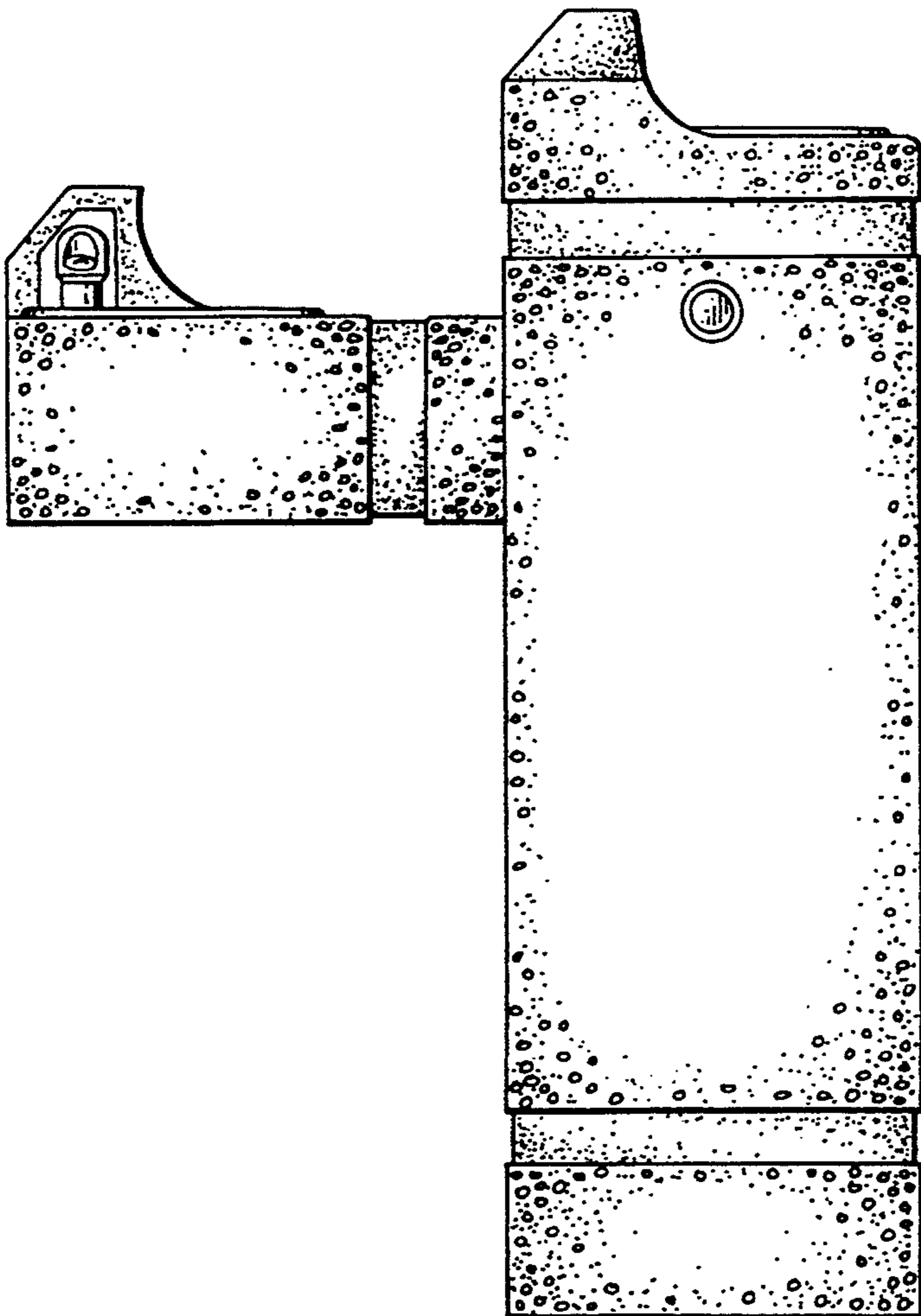
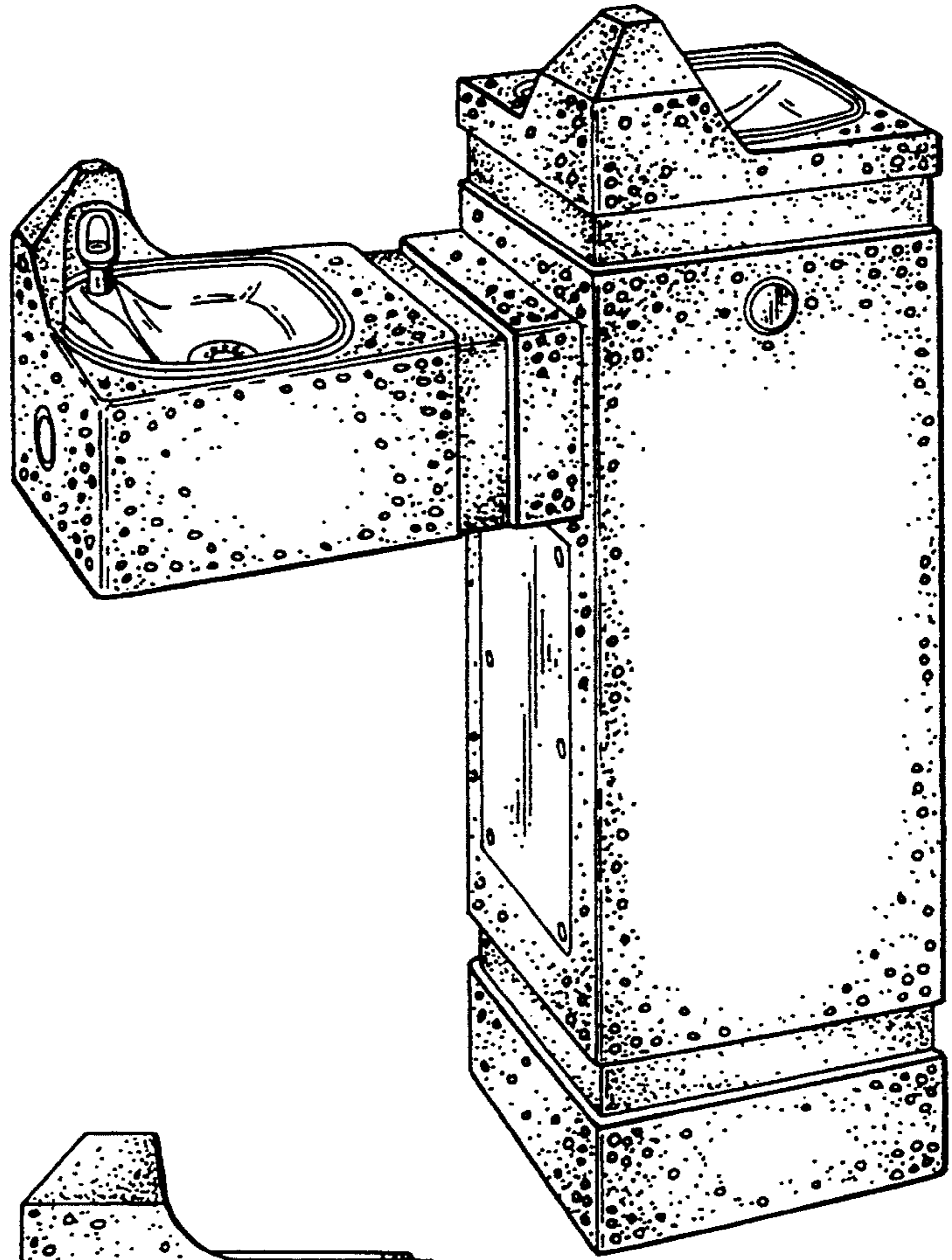

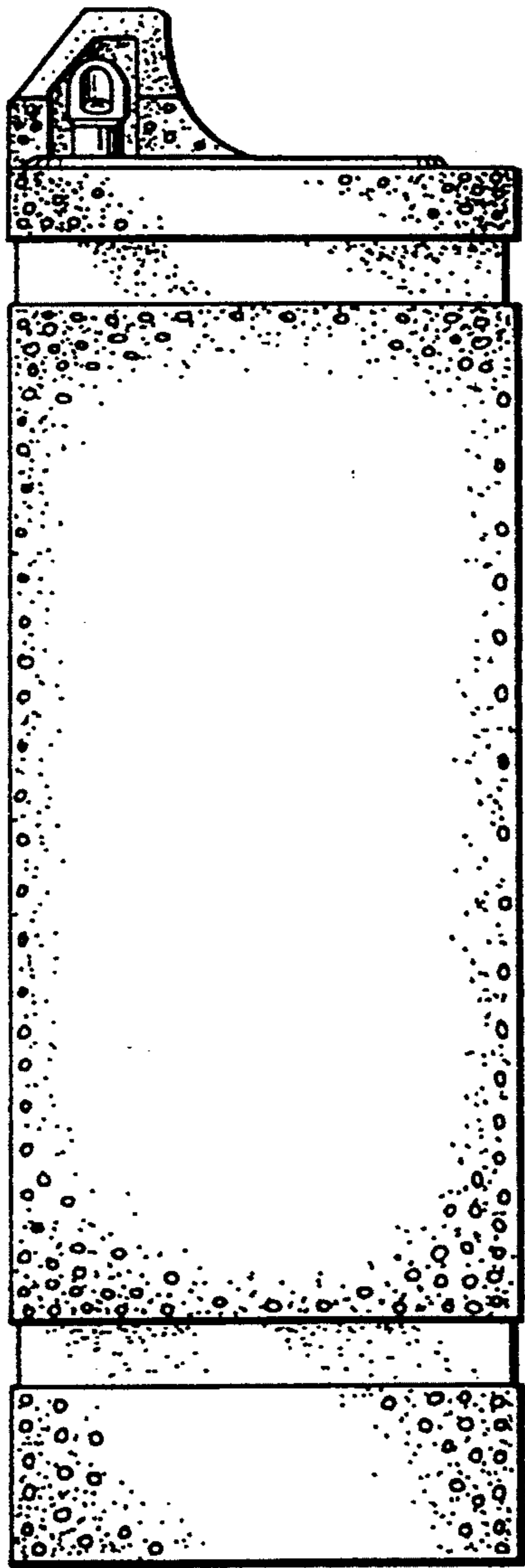

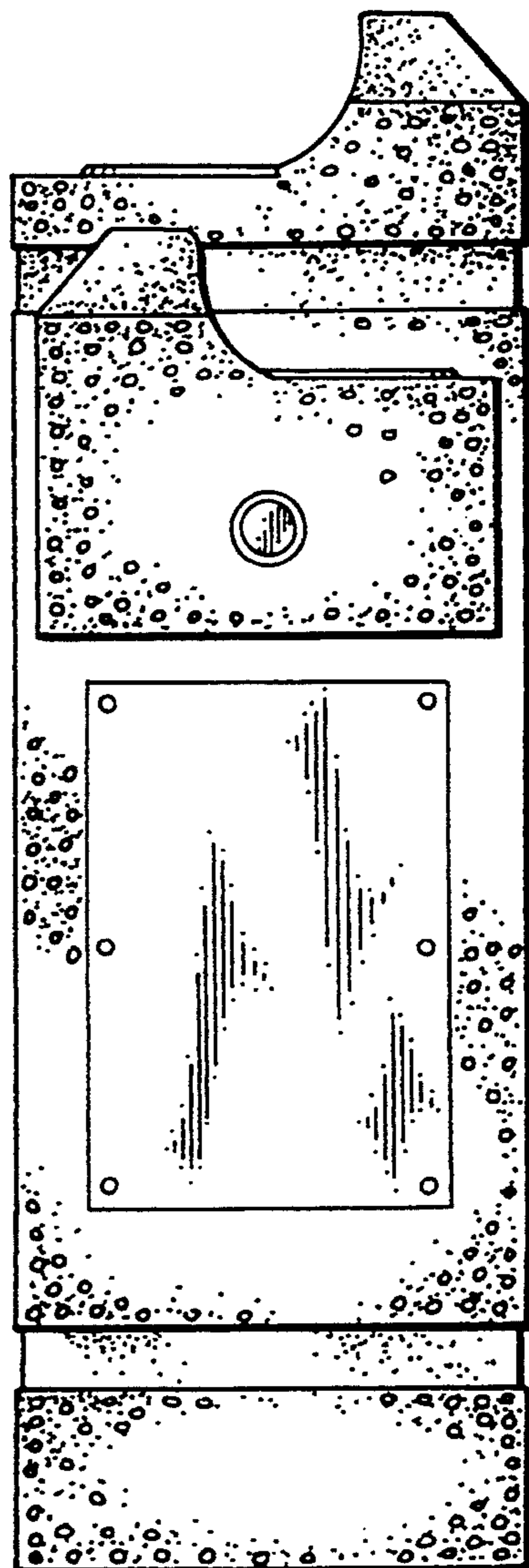

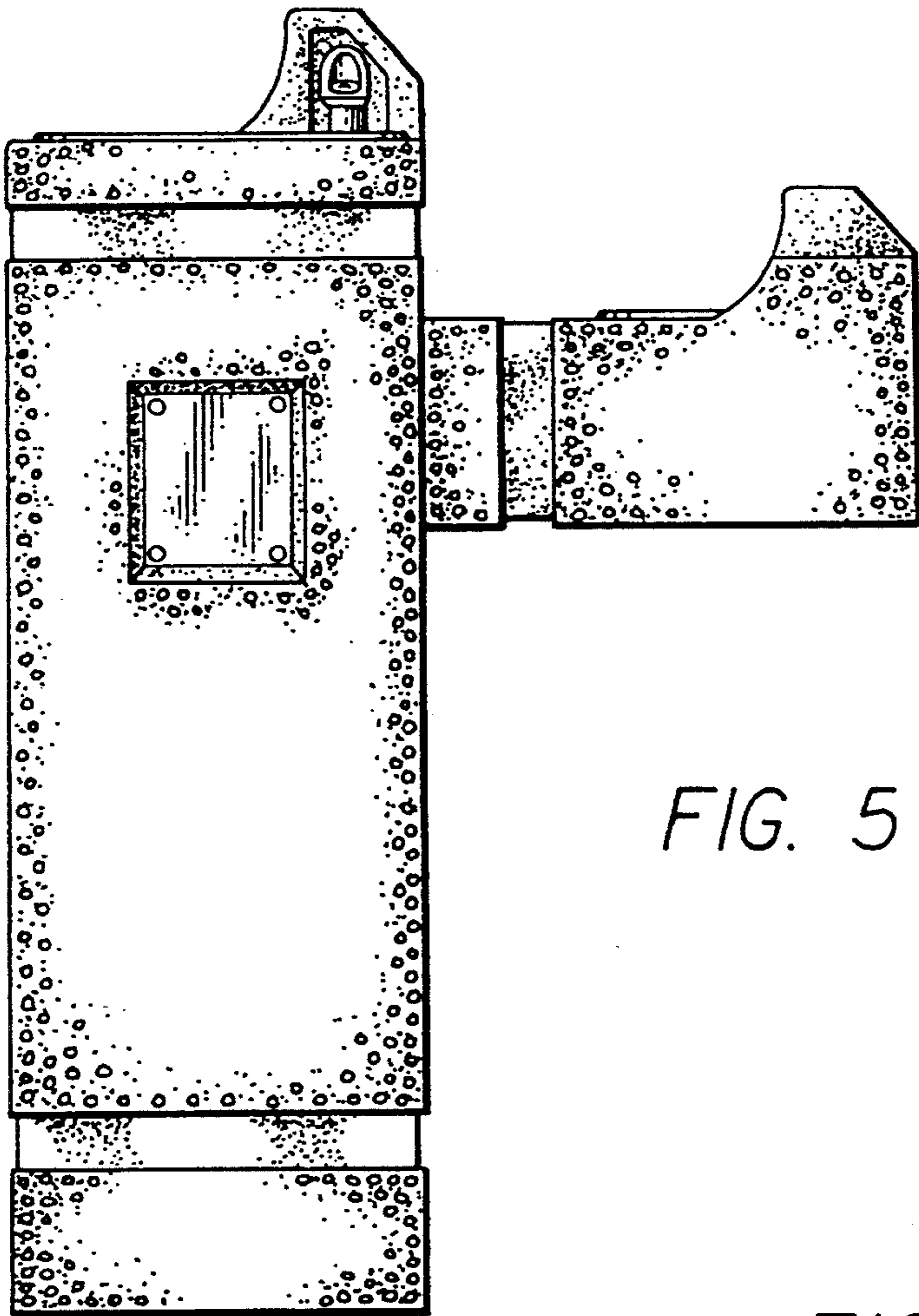

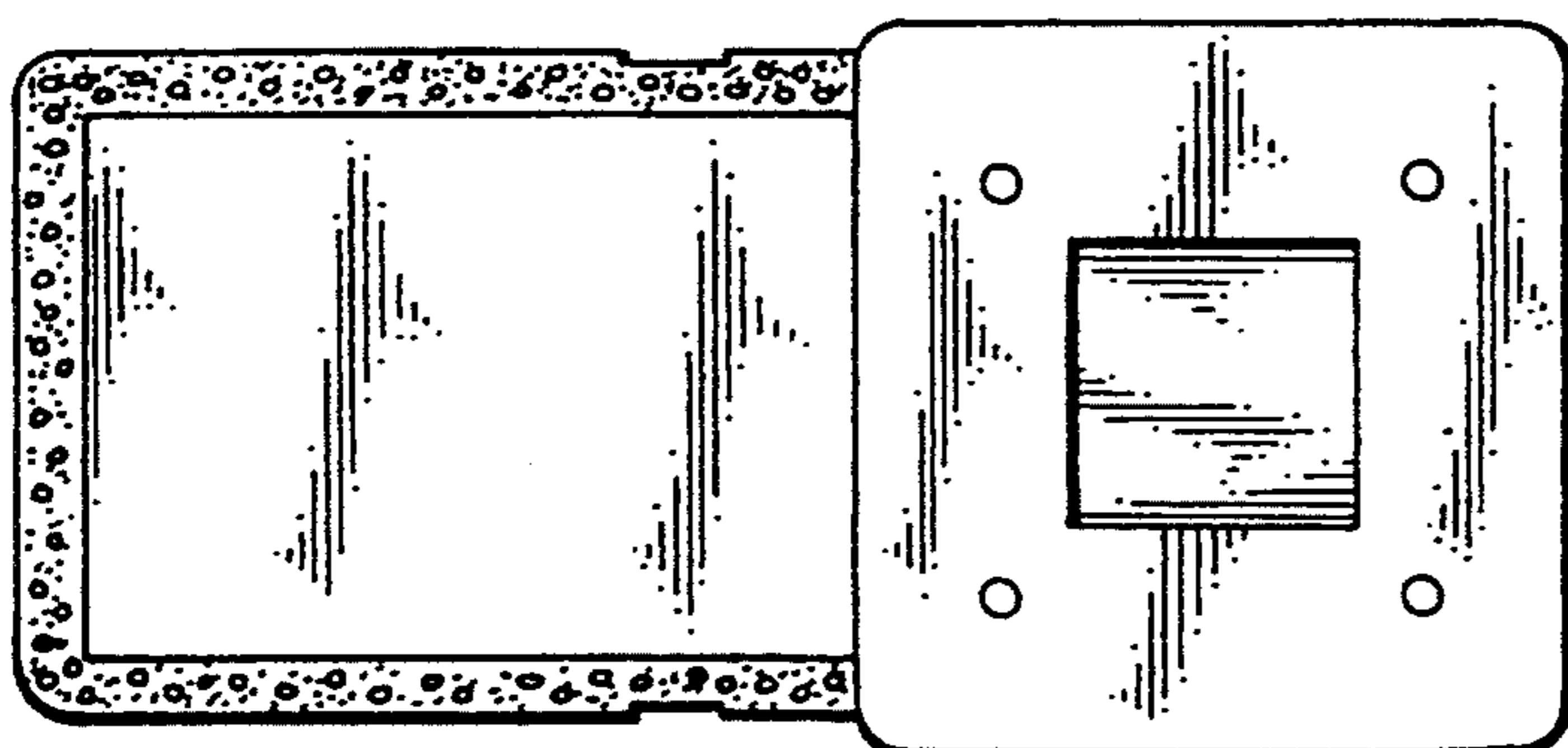
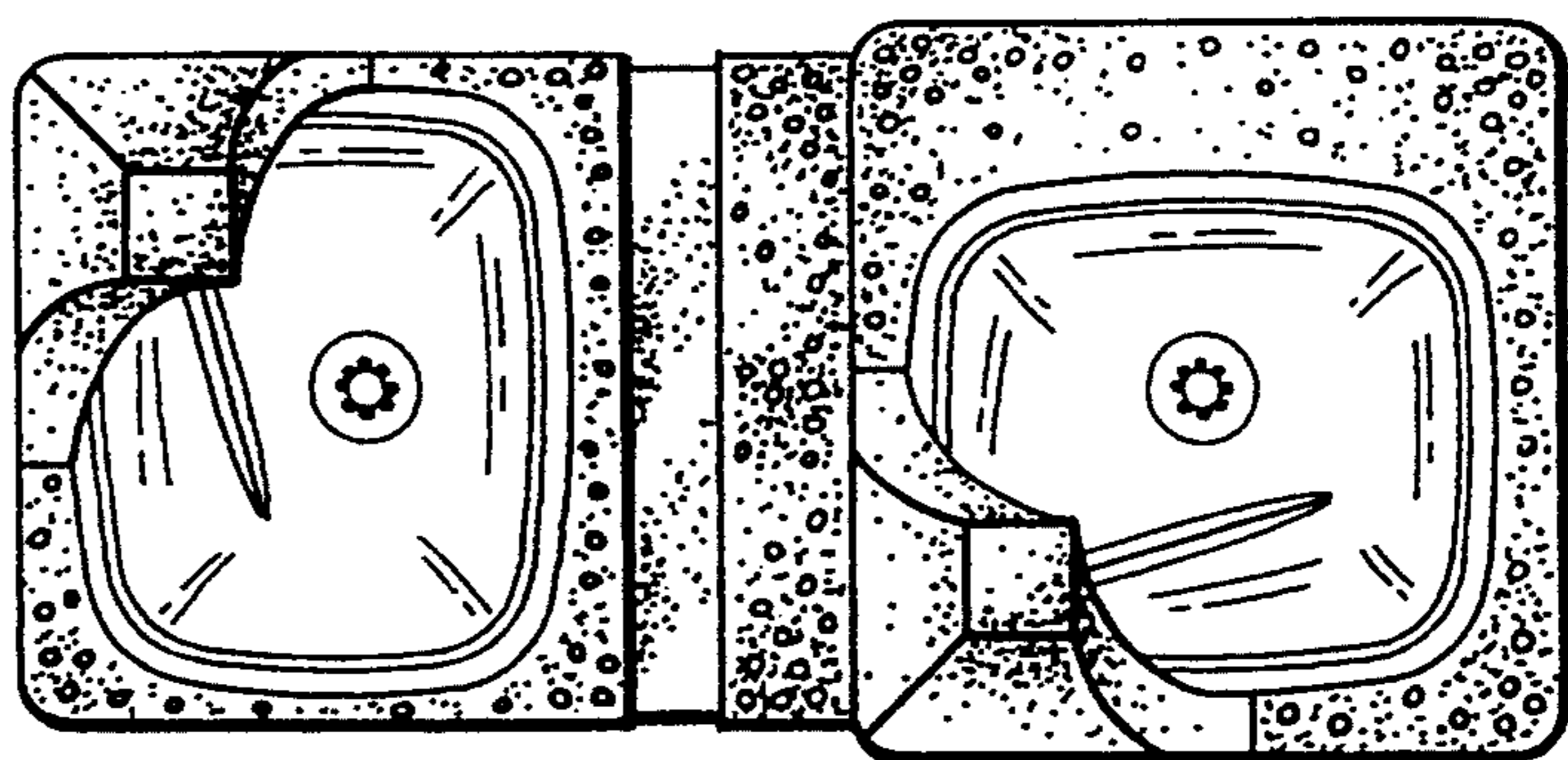

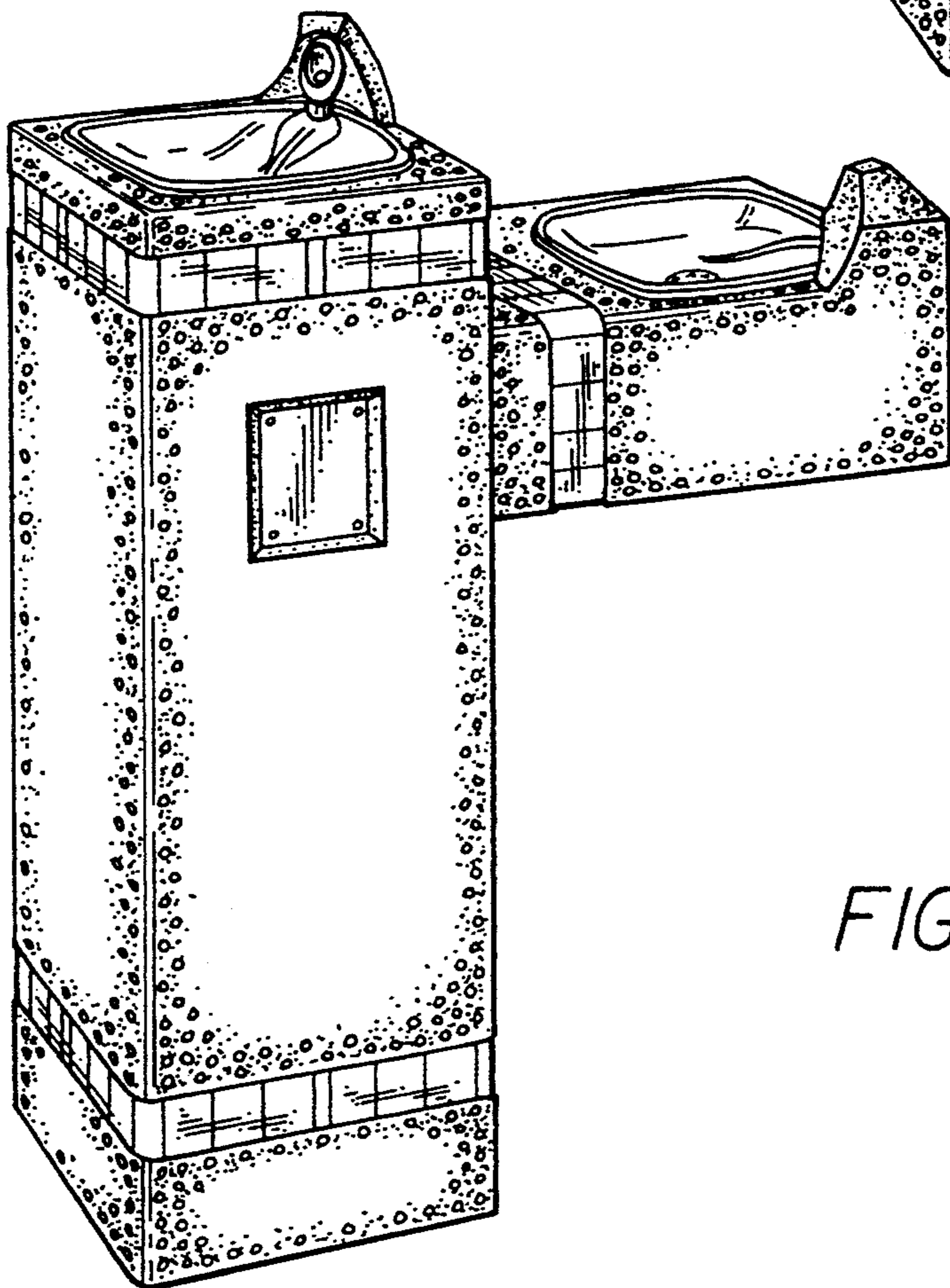
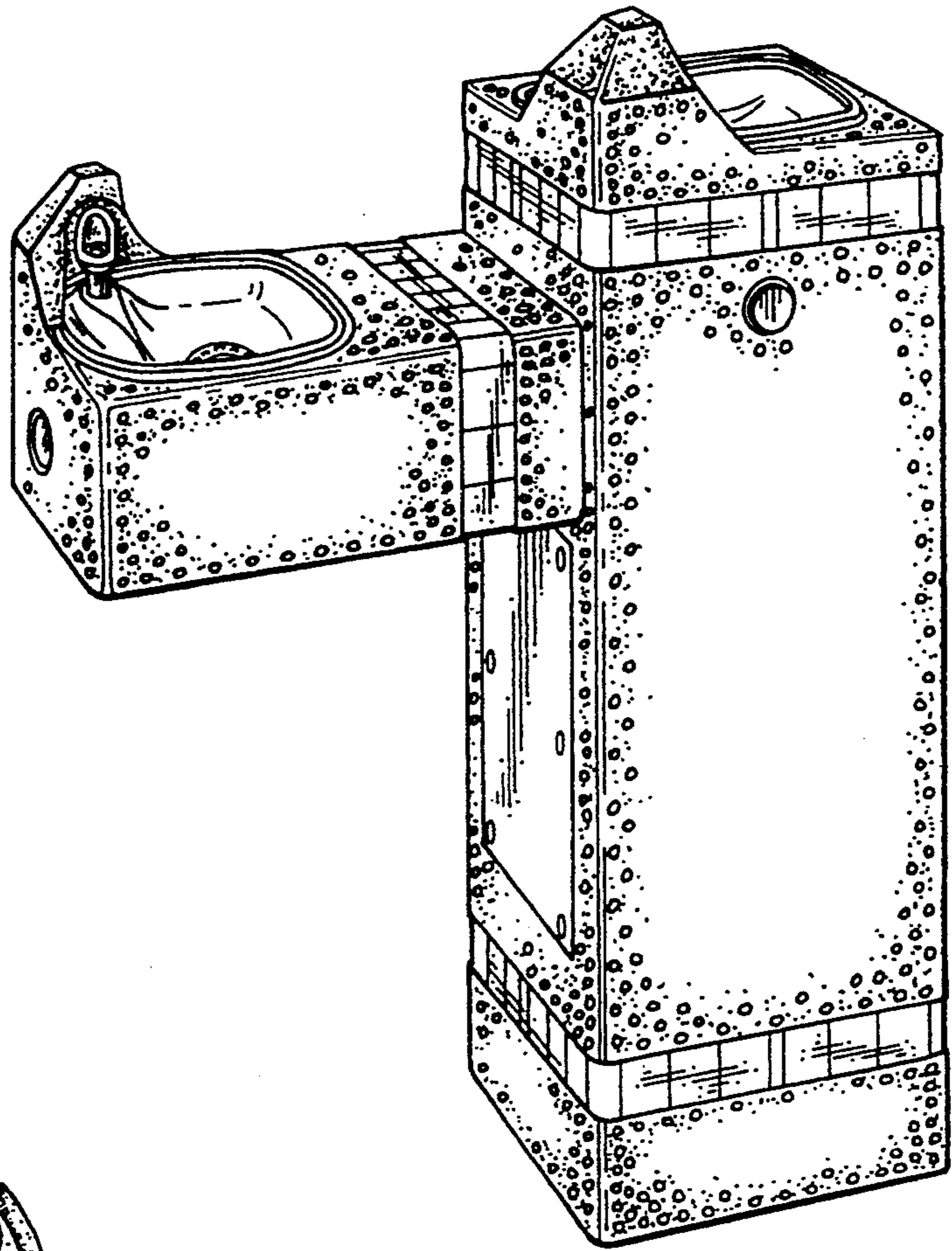

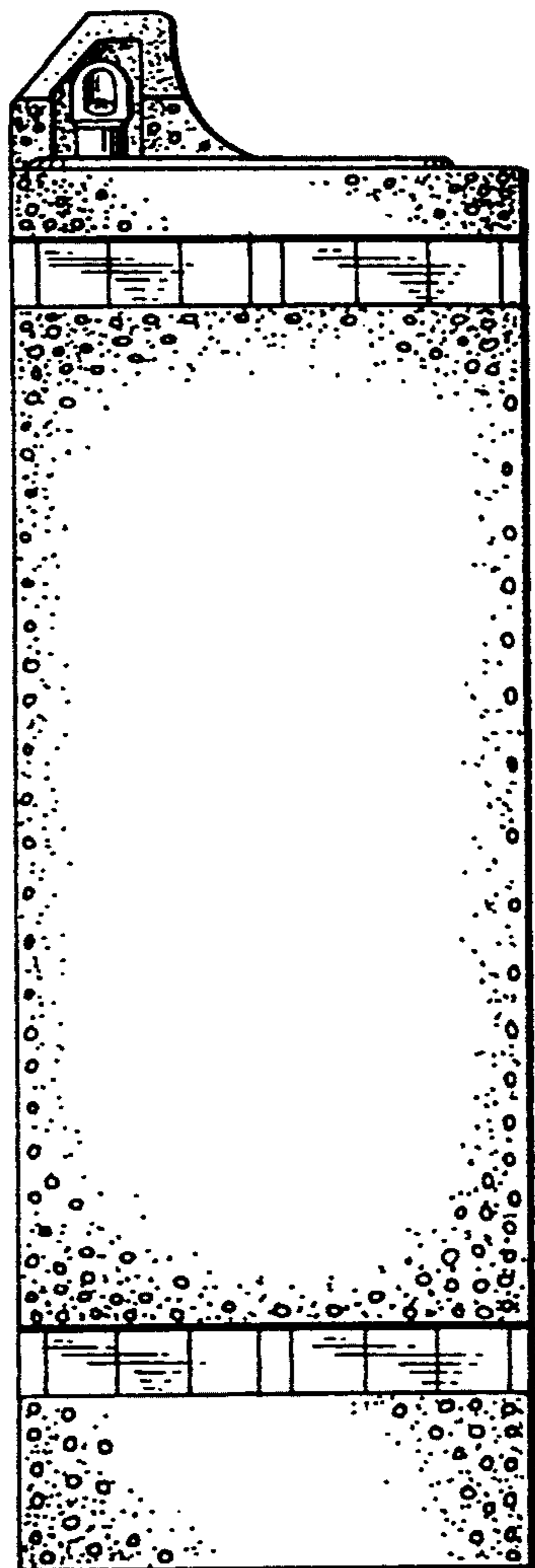
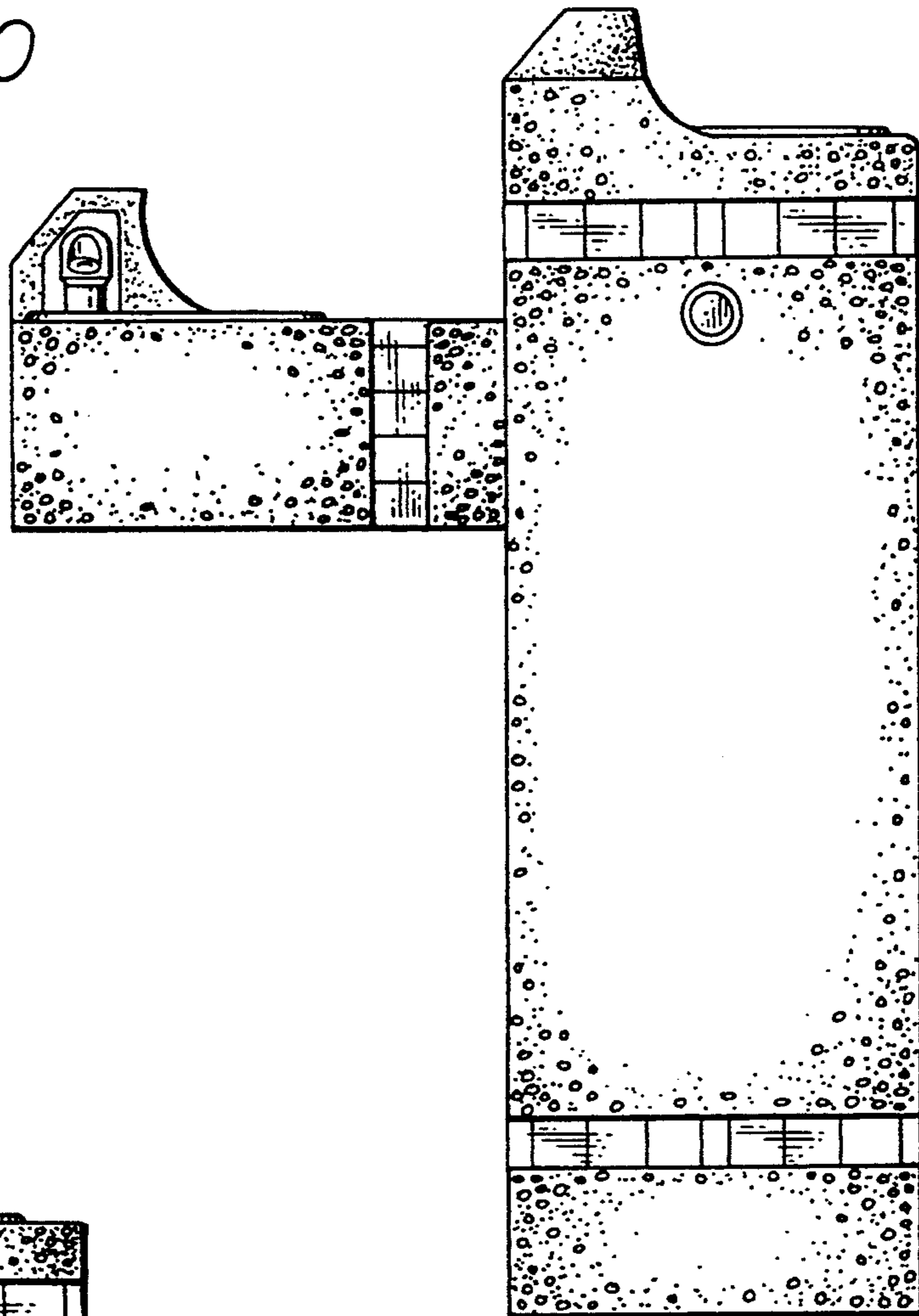

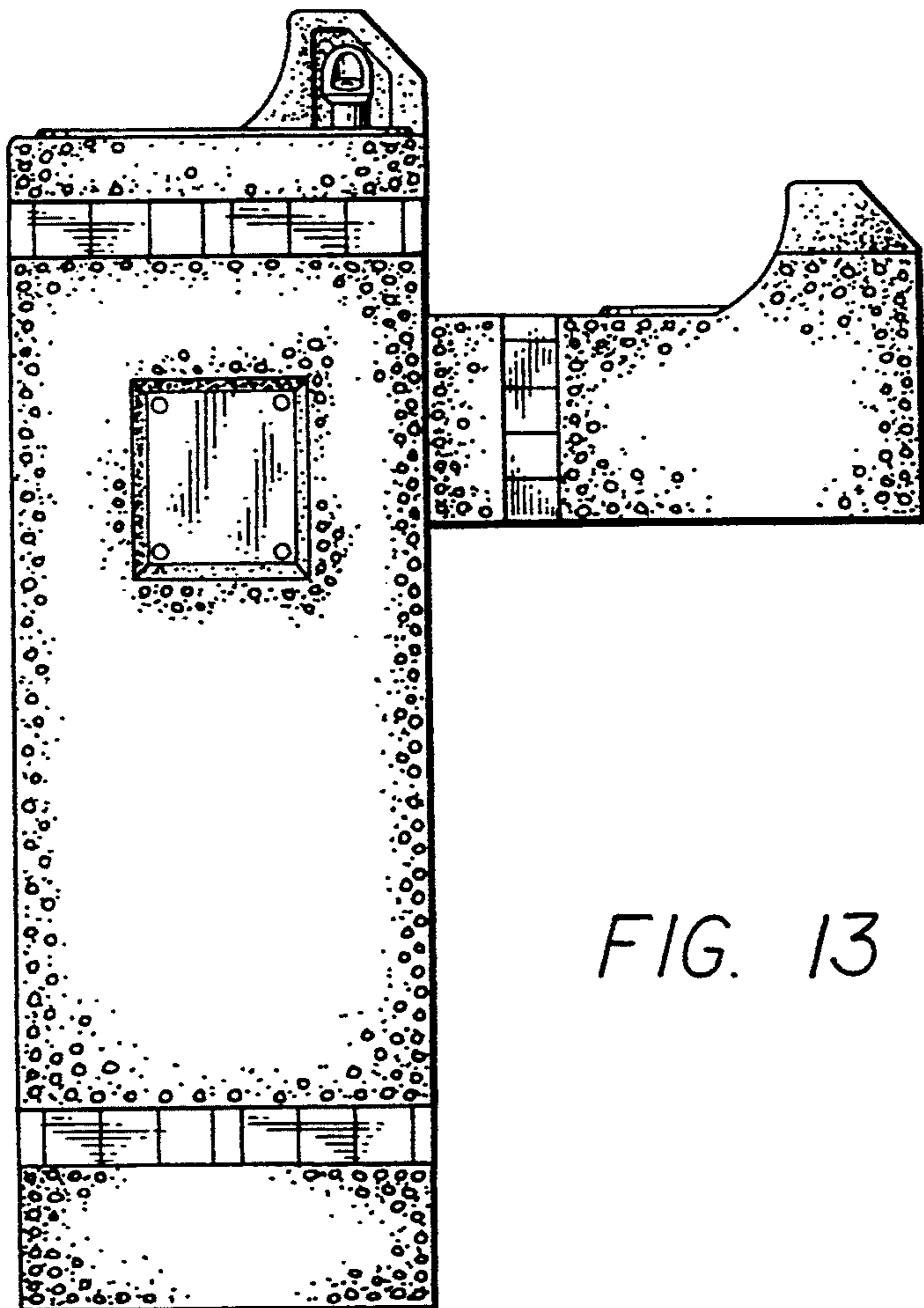
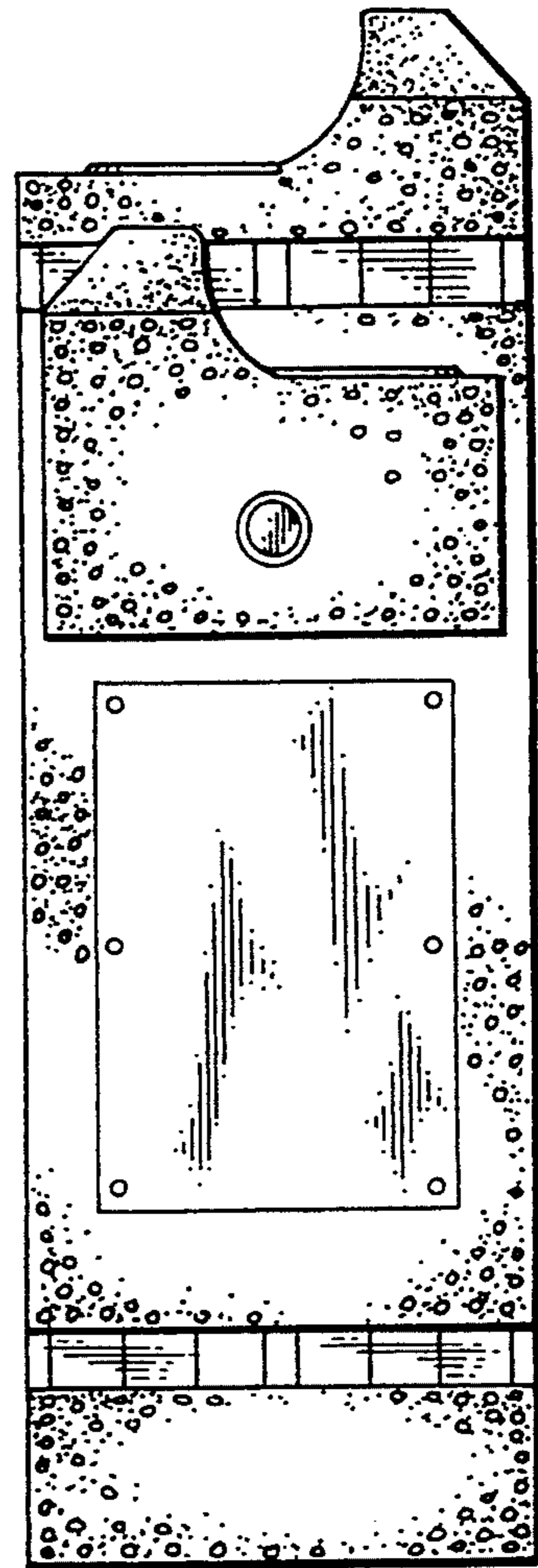

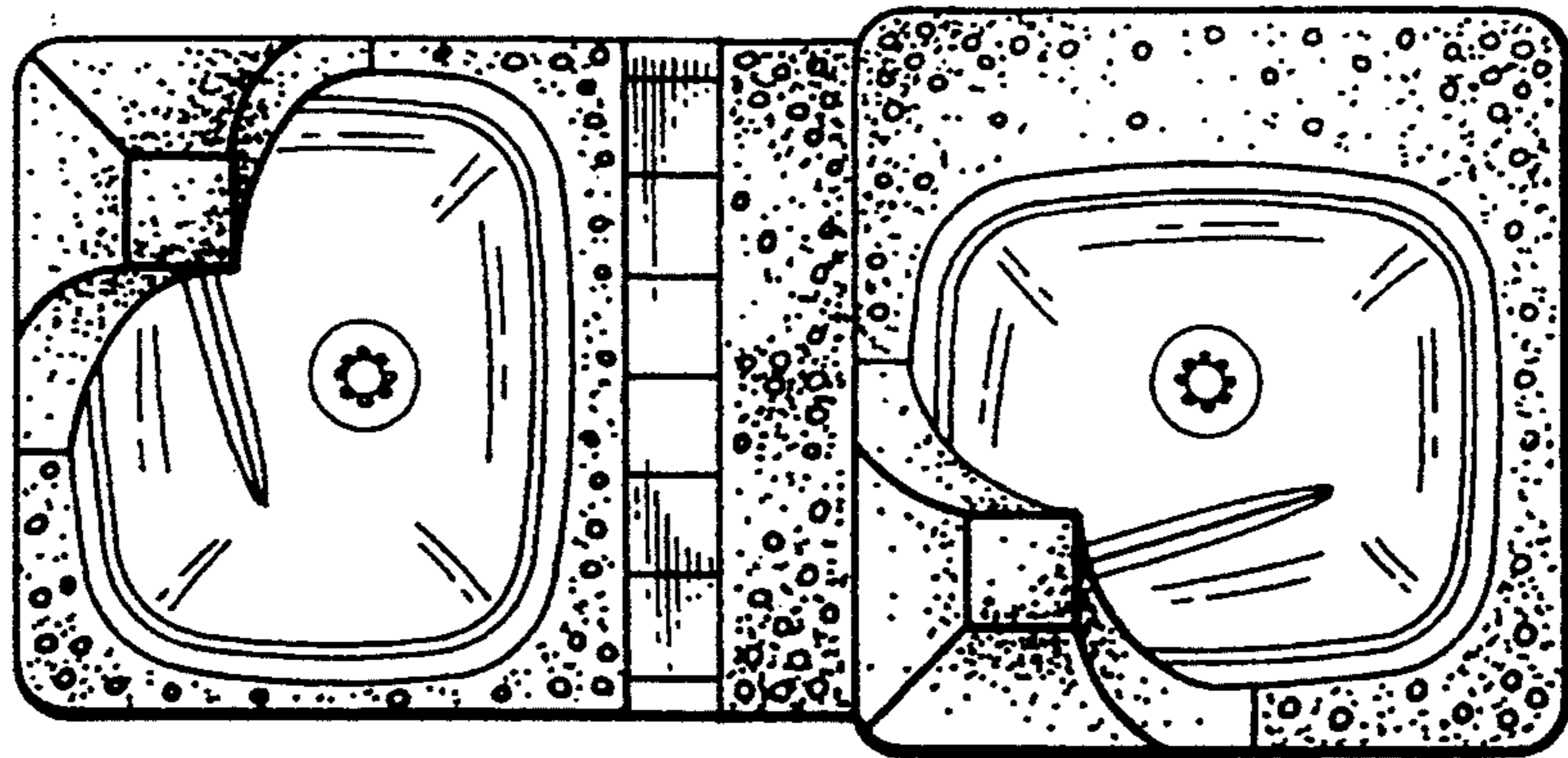
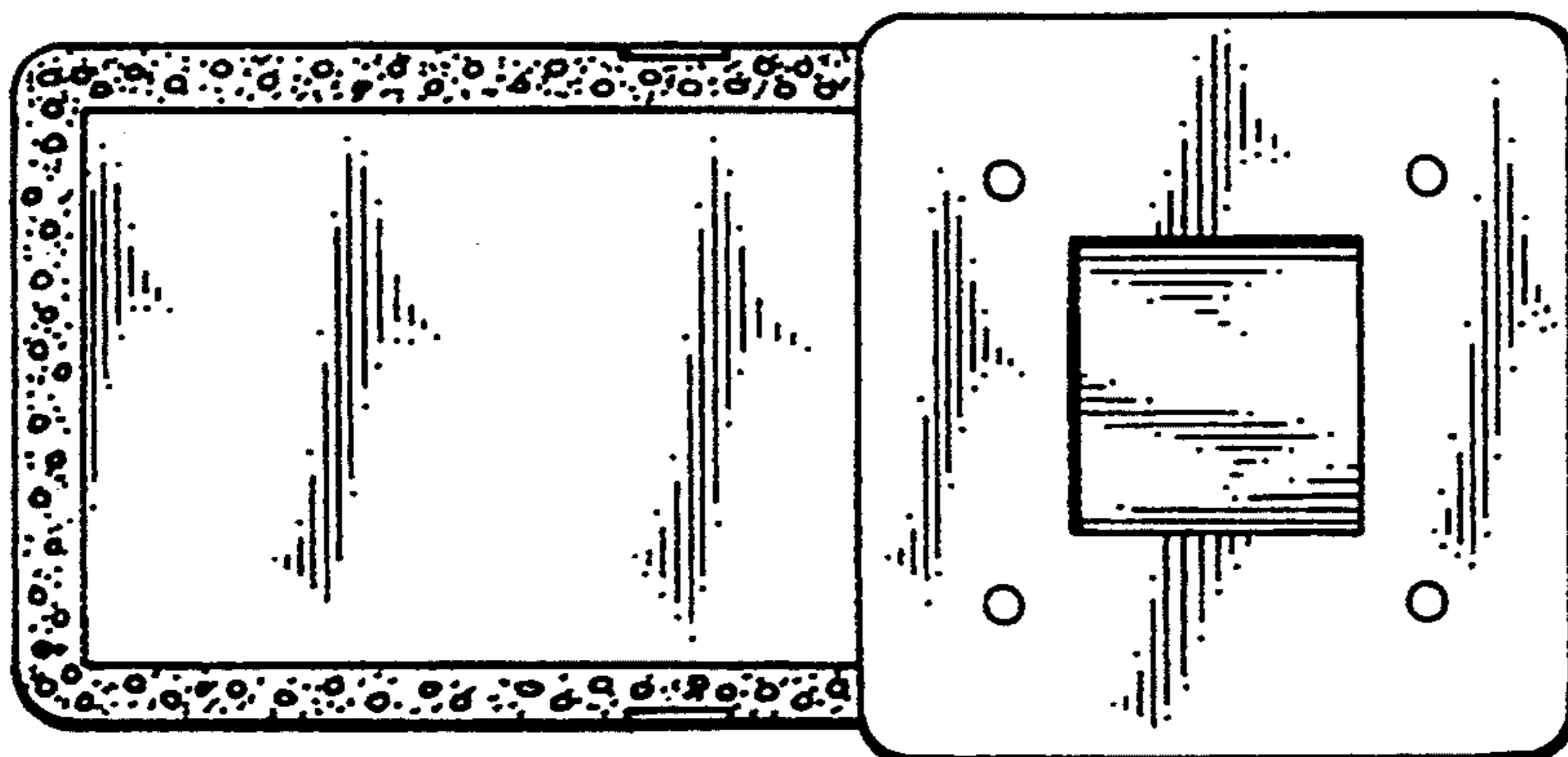
