[57] **CLAIM**

The ornamental design for a dual vesselled beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dual vesselled beverage container showing our new design;
 FIG. 2 is a front elevational view thereof, the rear elevational view thereof being identical;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof; and,
 FIG. 5 is a left side elevational view thereof, the right side elevational view thereof being identical.

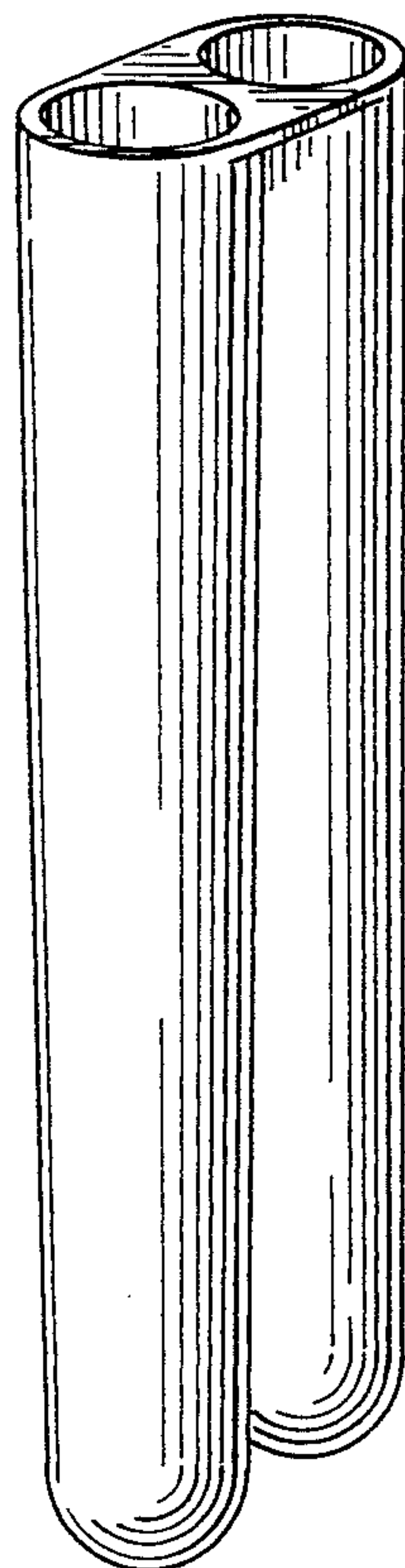

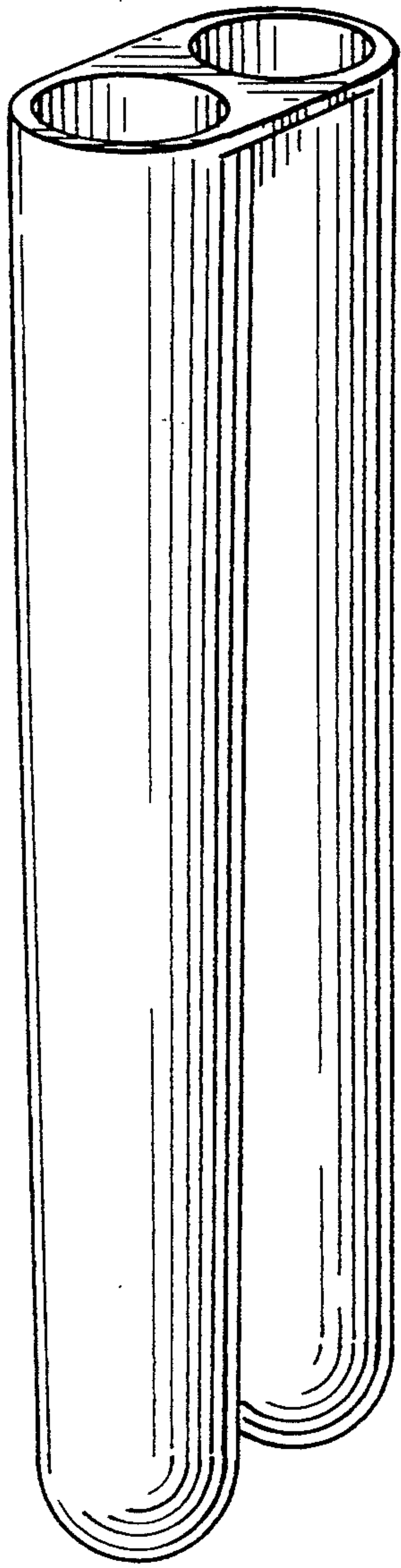

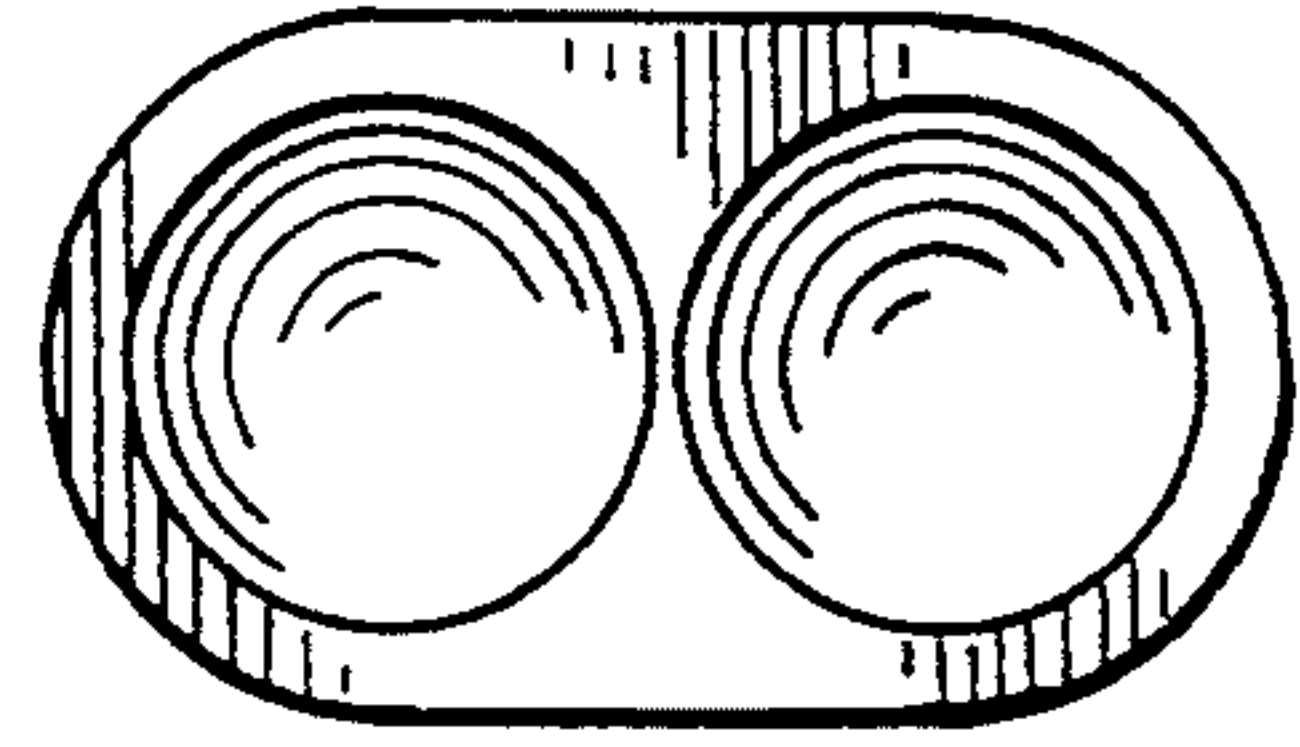

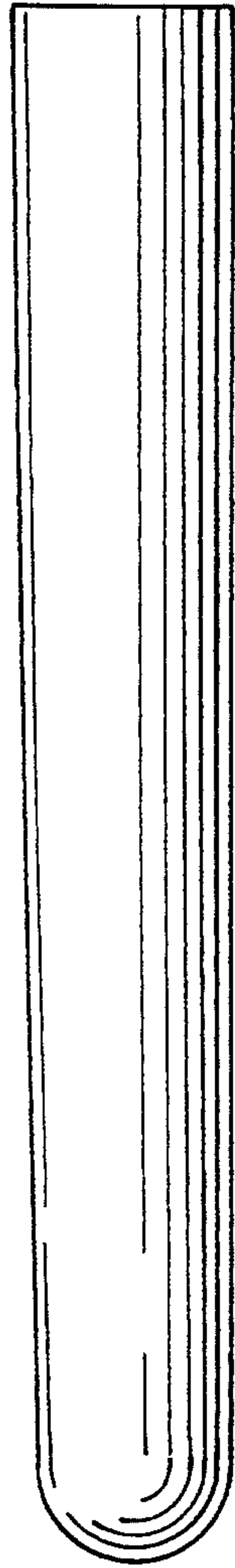

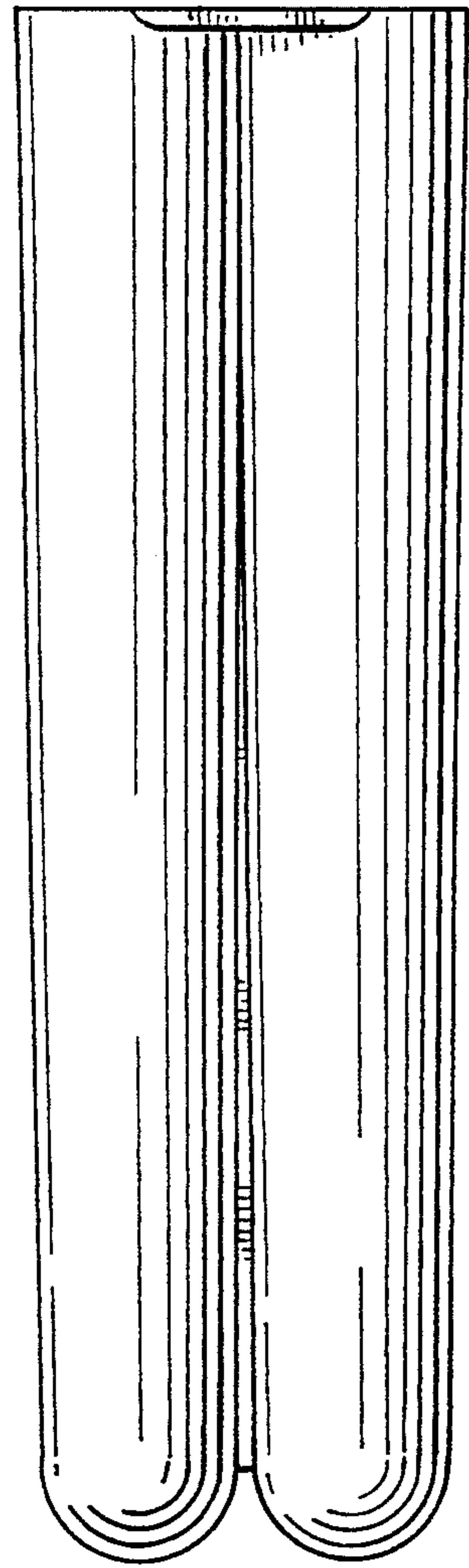
