ply, as shown and described.

### DESCRIPTION

FIG. 1 is a top and front perspective view from above  
of a DC stabilizing power supply, showing my new  
design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a plan view thereof;

FIG. 4 is a left-side elevation view thereof;

FIG. 5 is a right-side elevation view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a rear elevation view thereof.

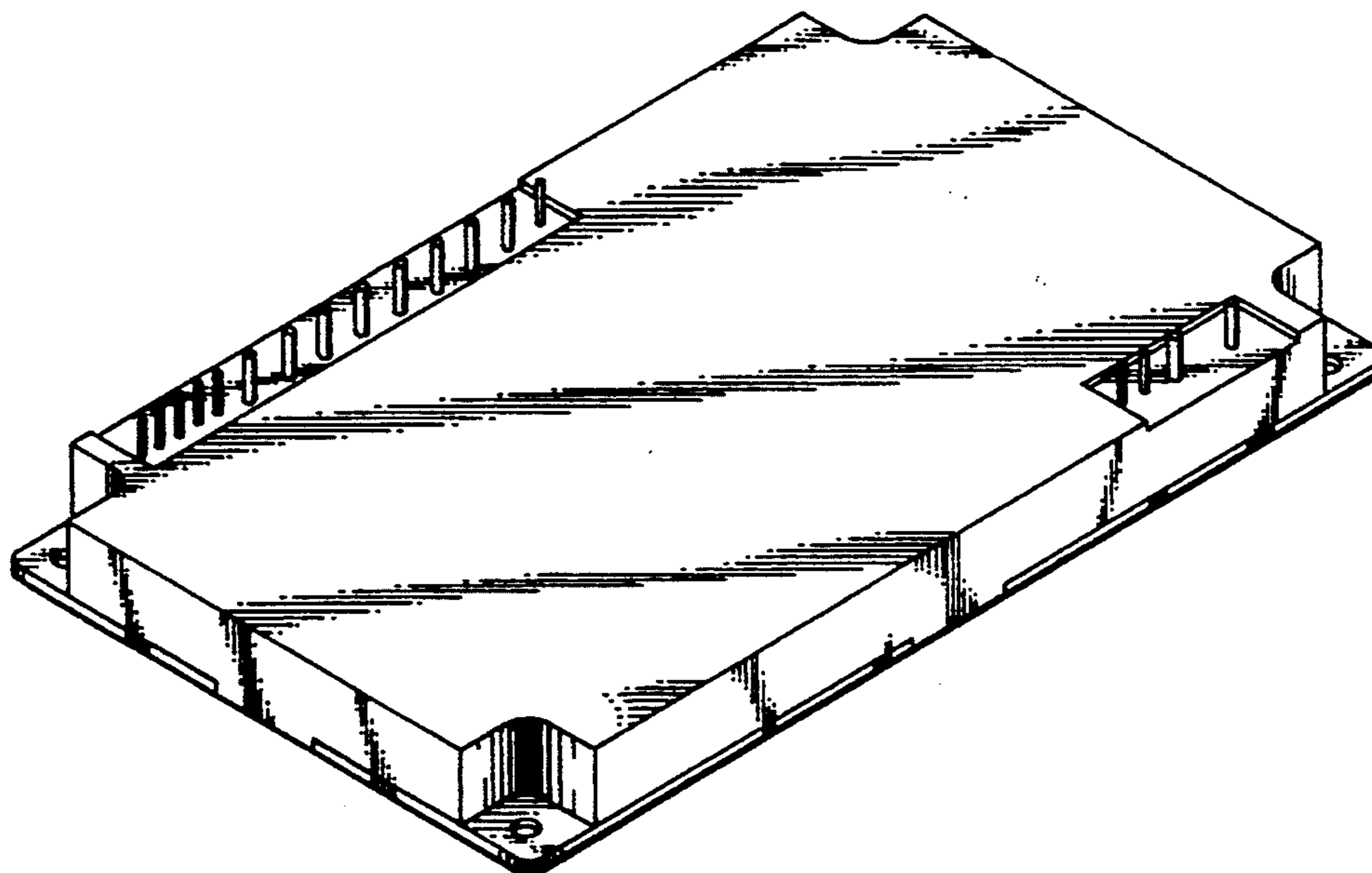

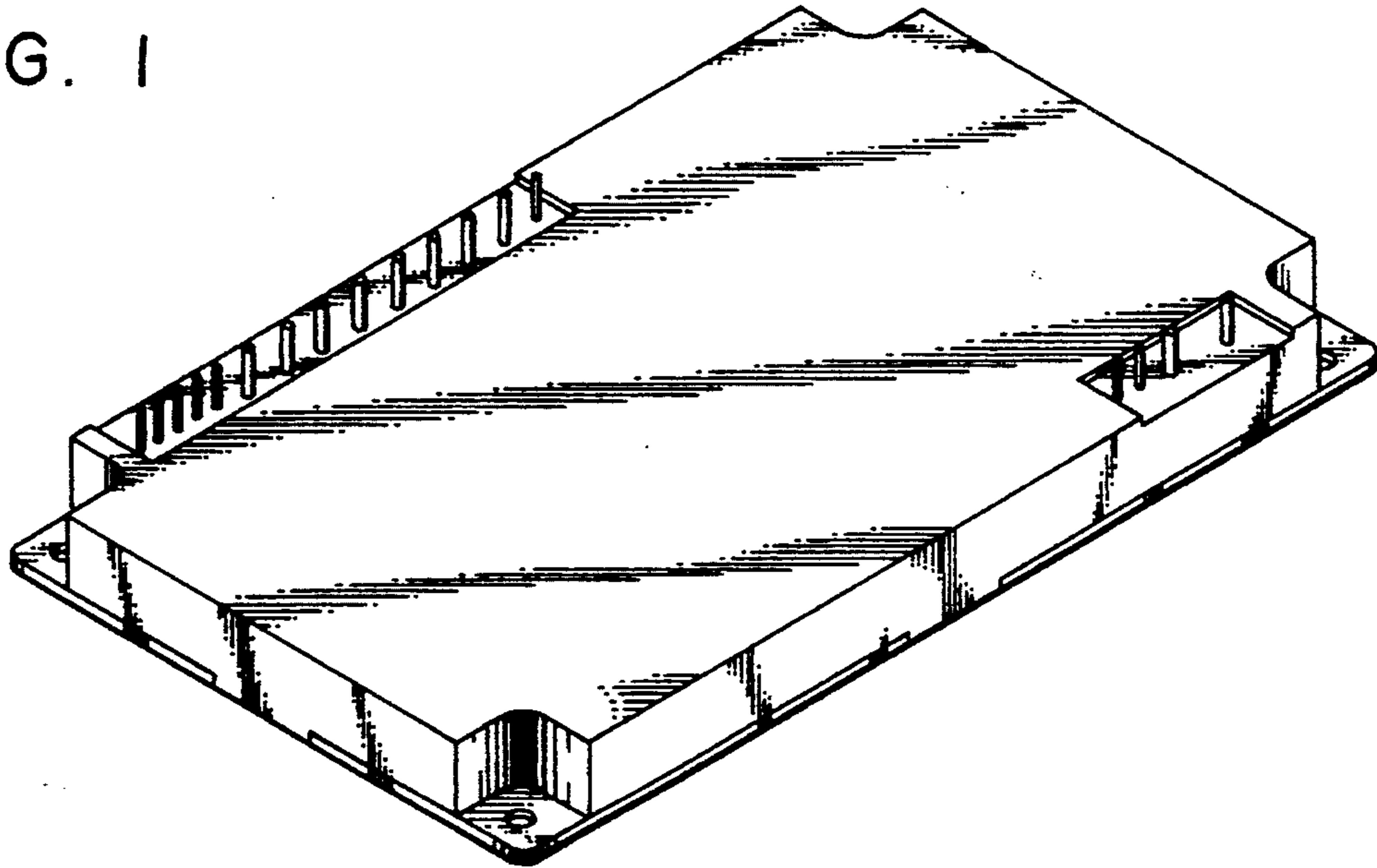

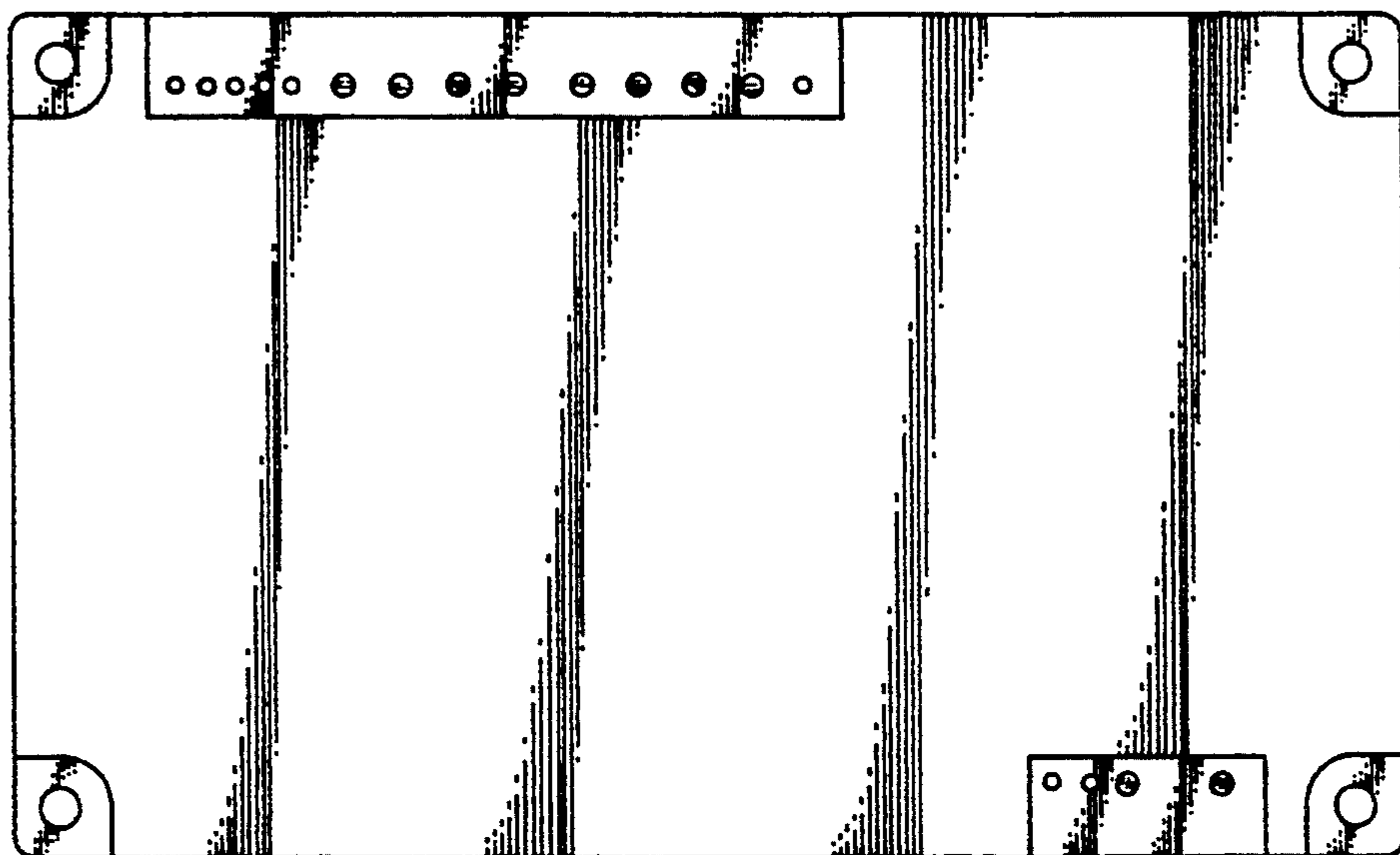

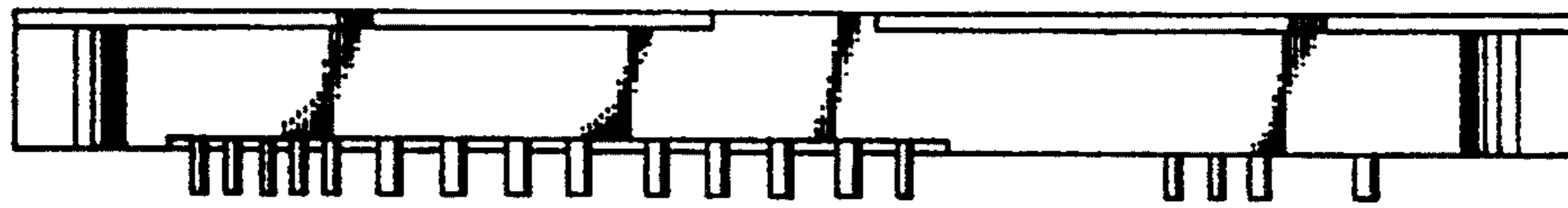

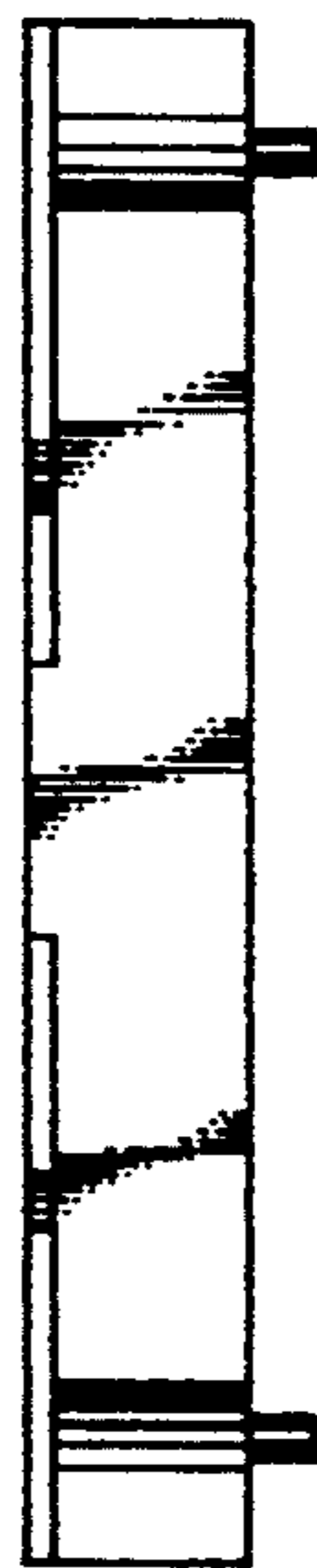

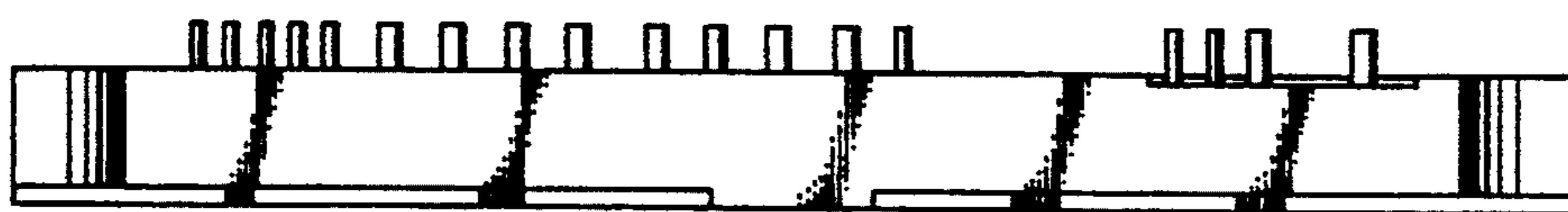
