DESCRIPTION

FIG. 1 is a front, top, and right side perspective view showing my new design for a portable telephone in an opened position;

FIG. 2 is a front elevational view thereof;

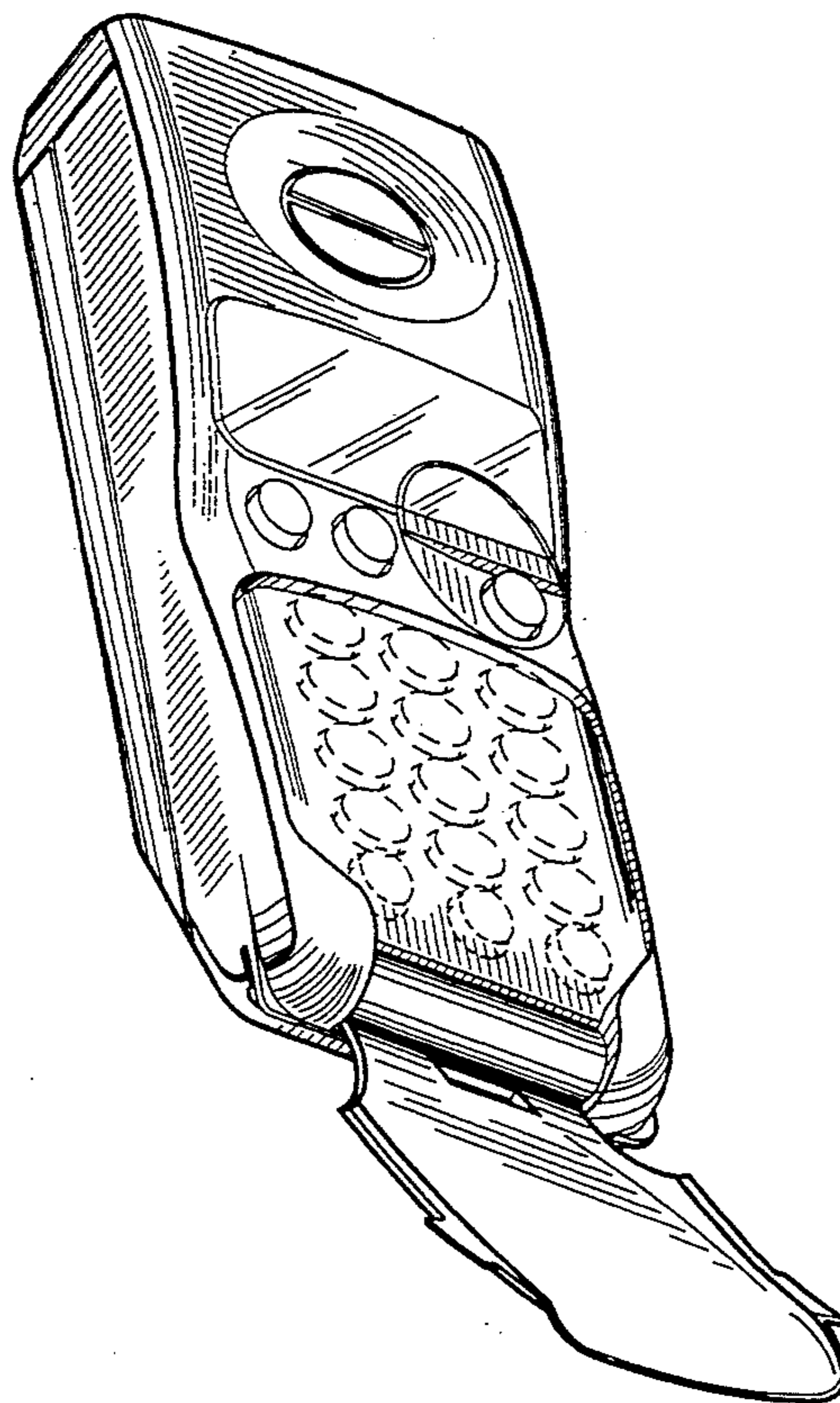
FIG. 3 is a rear elevational view thereof;

The broken line disclosure in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.



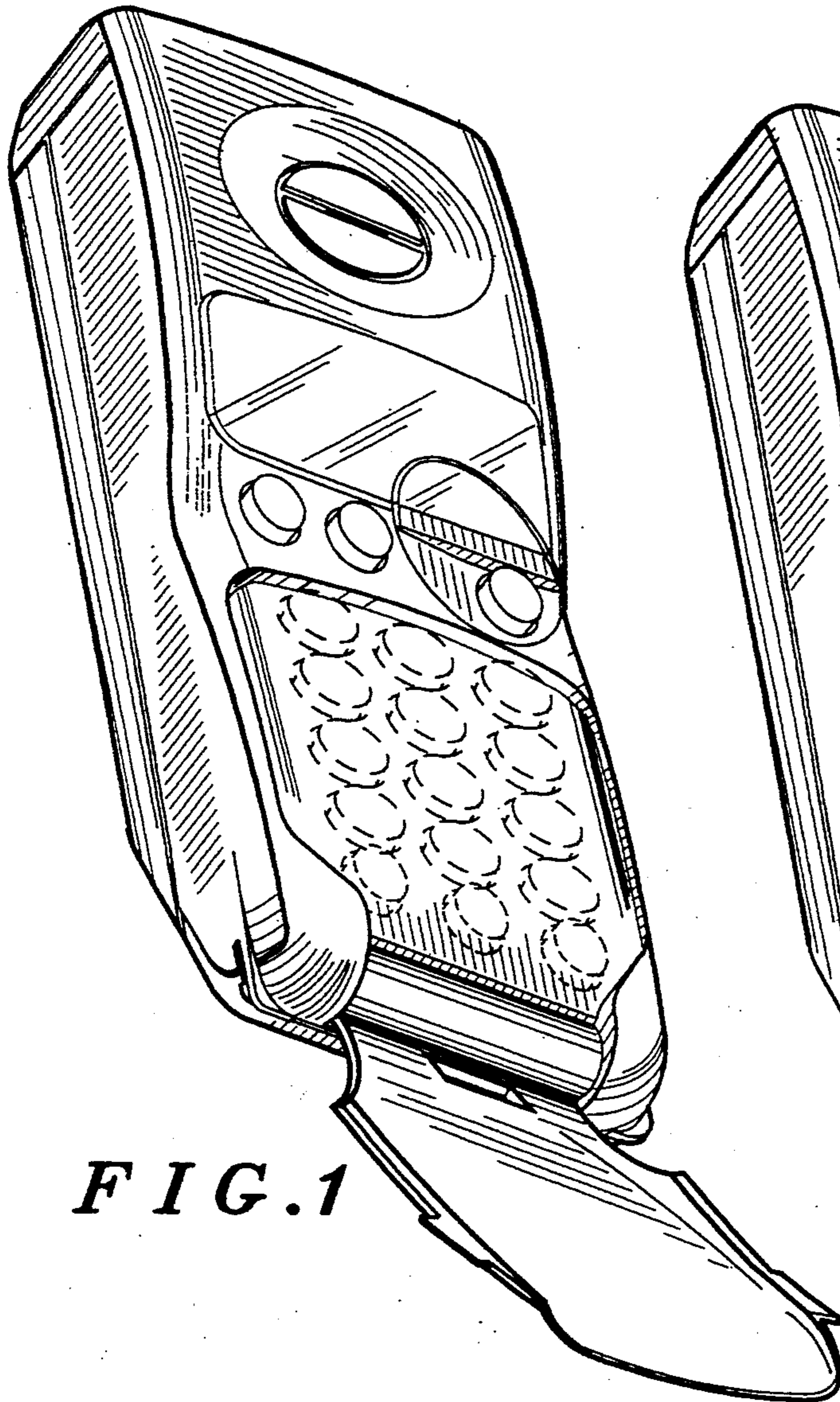

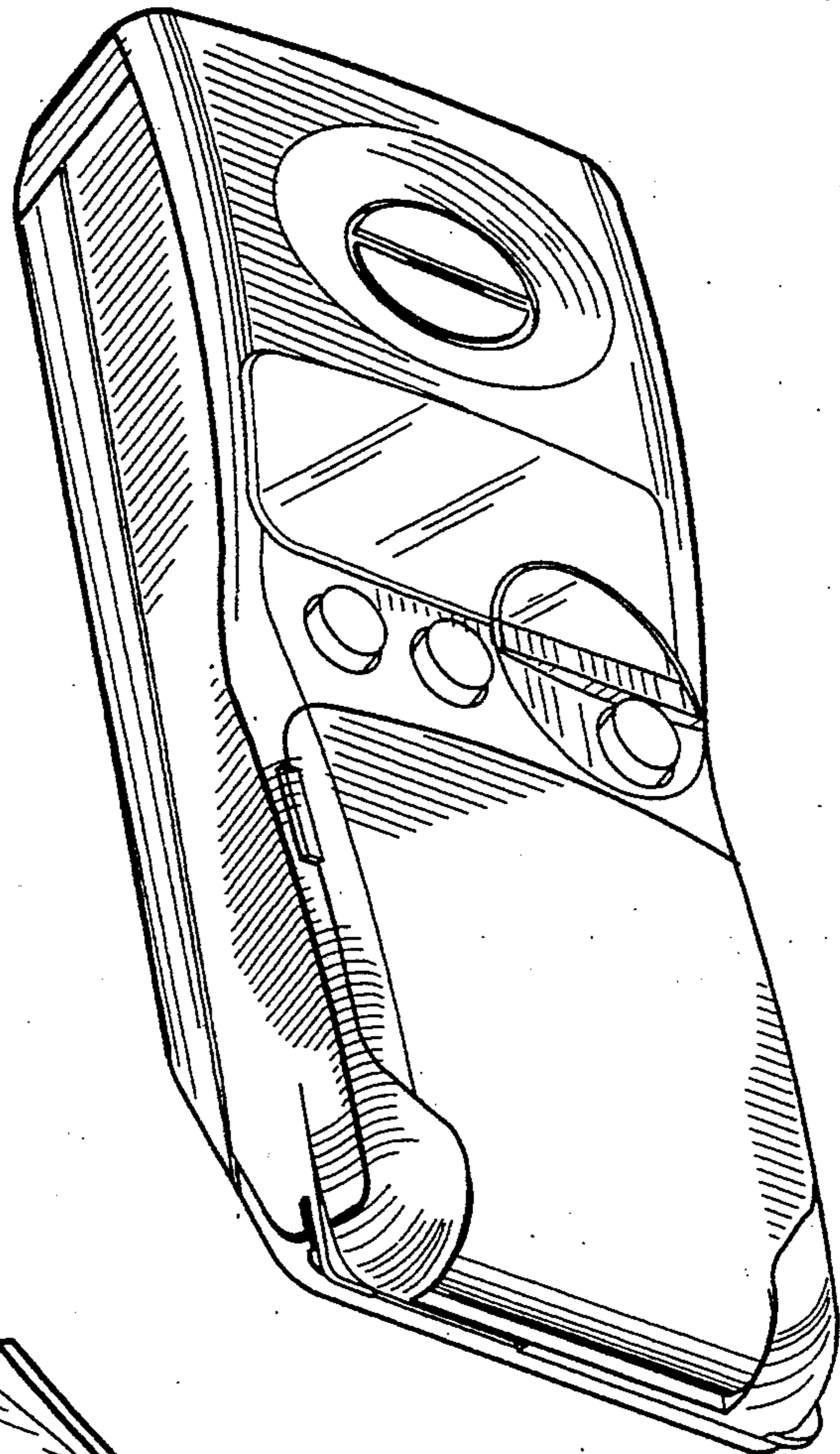

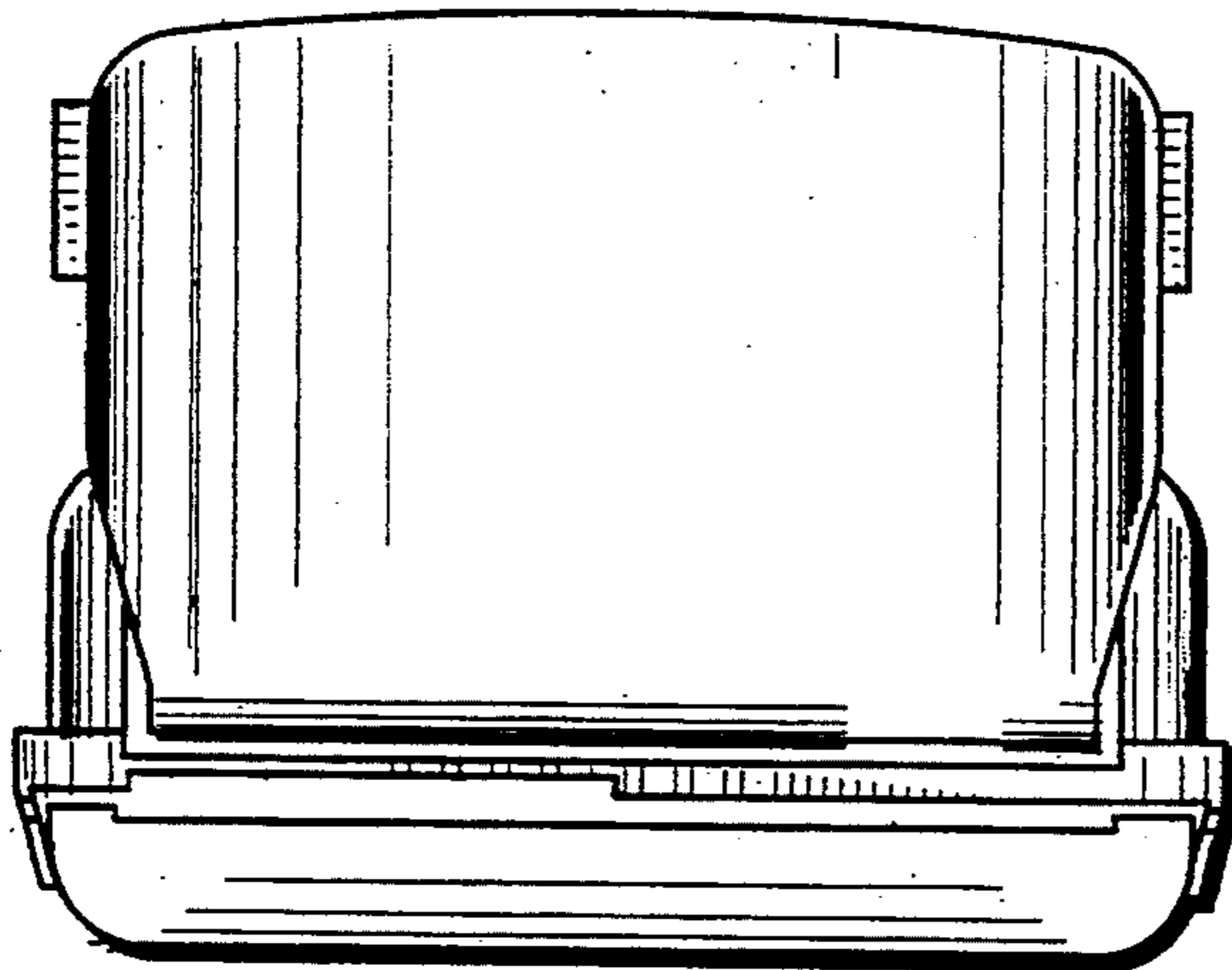
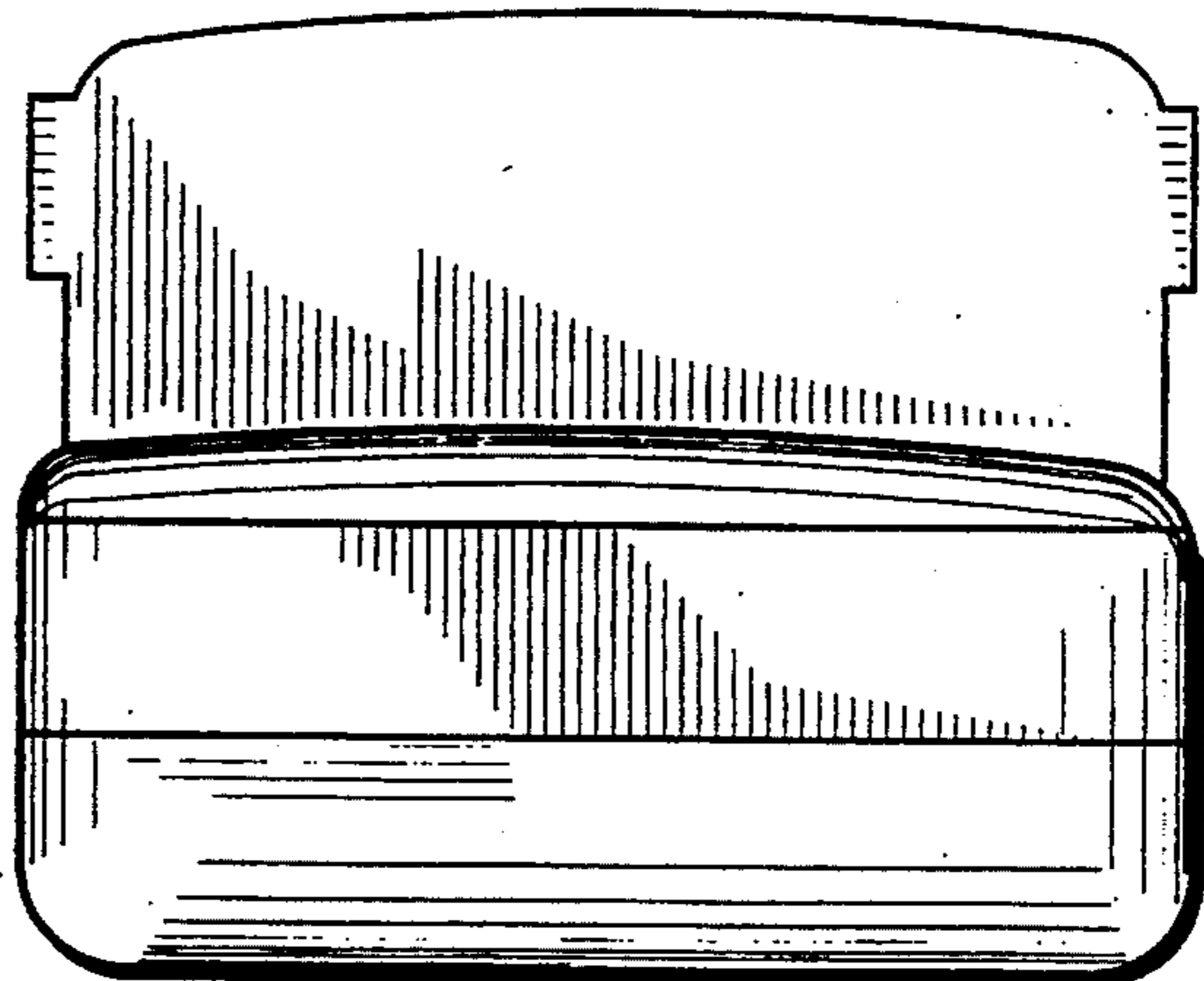

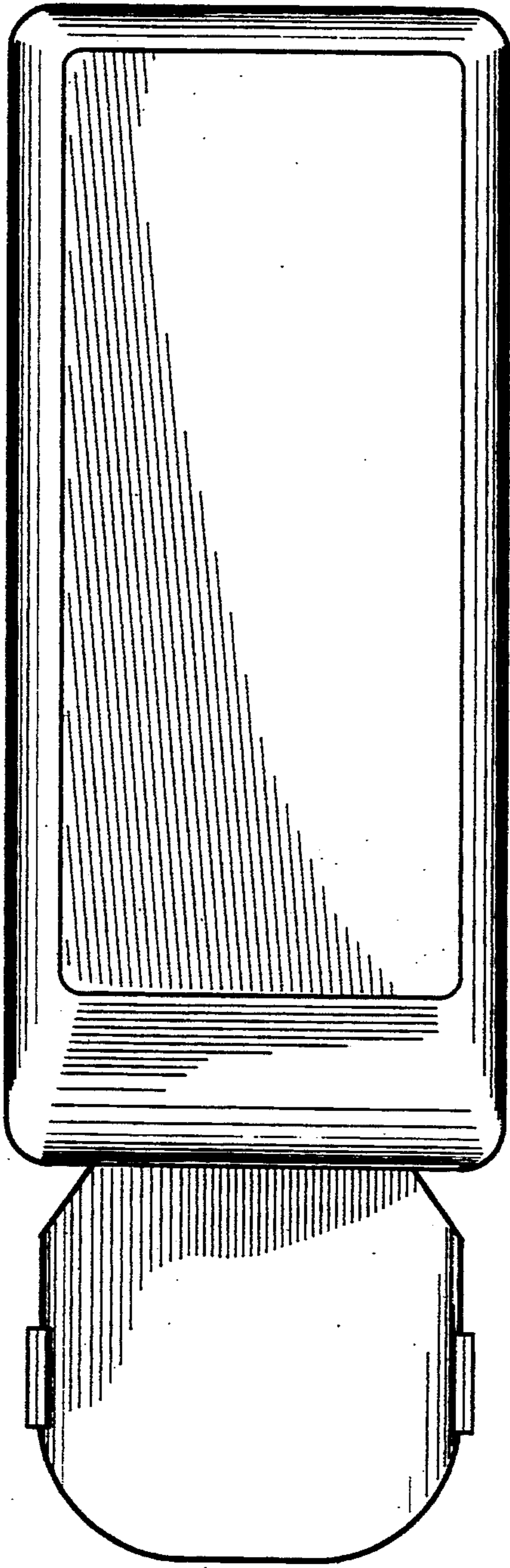
