The ornamental design for a weight lifting safety stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a weight lifting safety stand embodying my design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom view thereof.
The broken line portions of the drawing are for illustrative purposes only and forms no part of the claimed design.

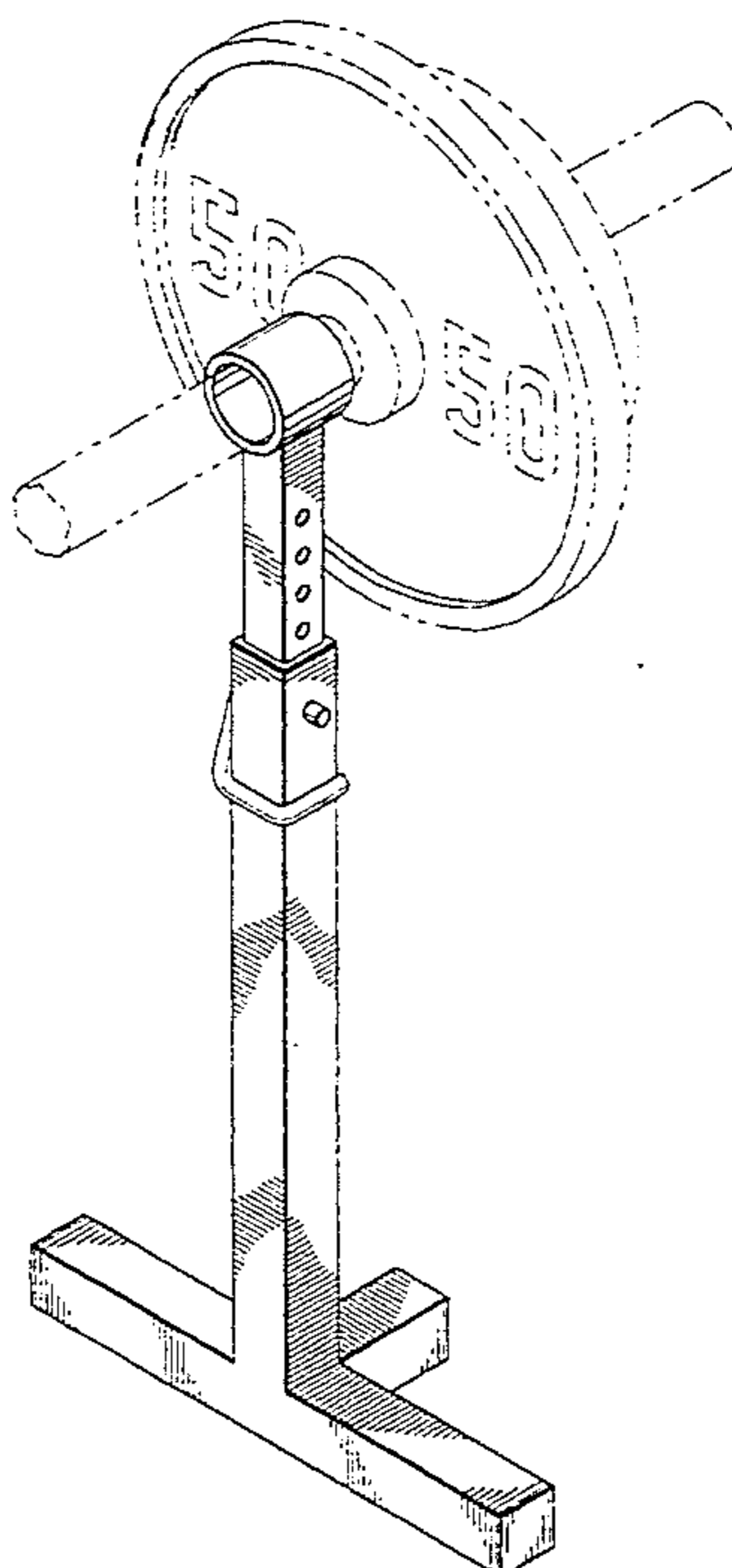

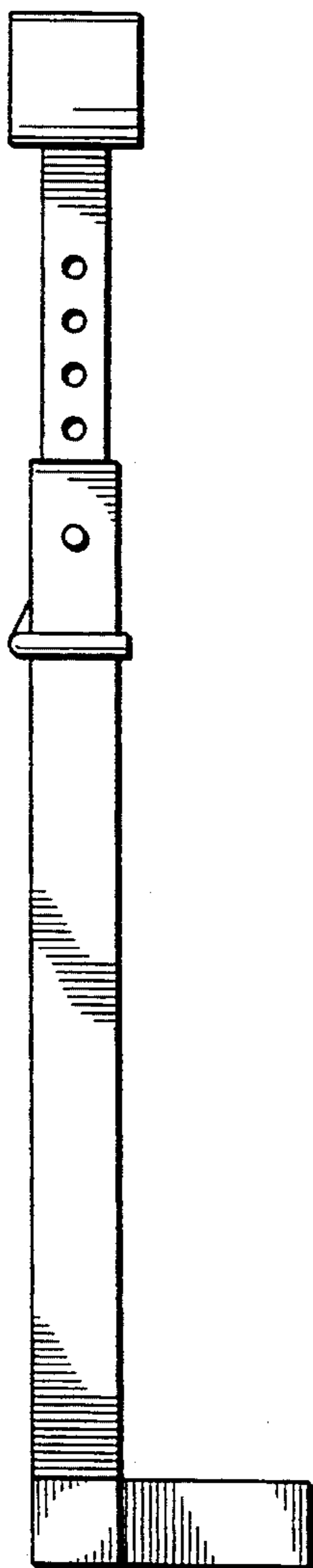
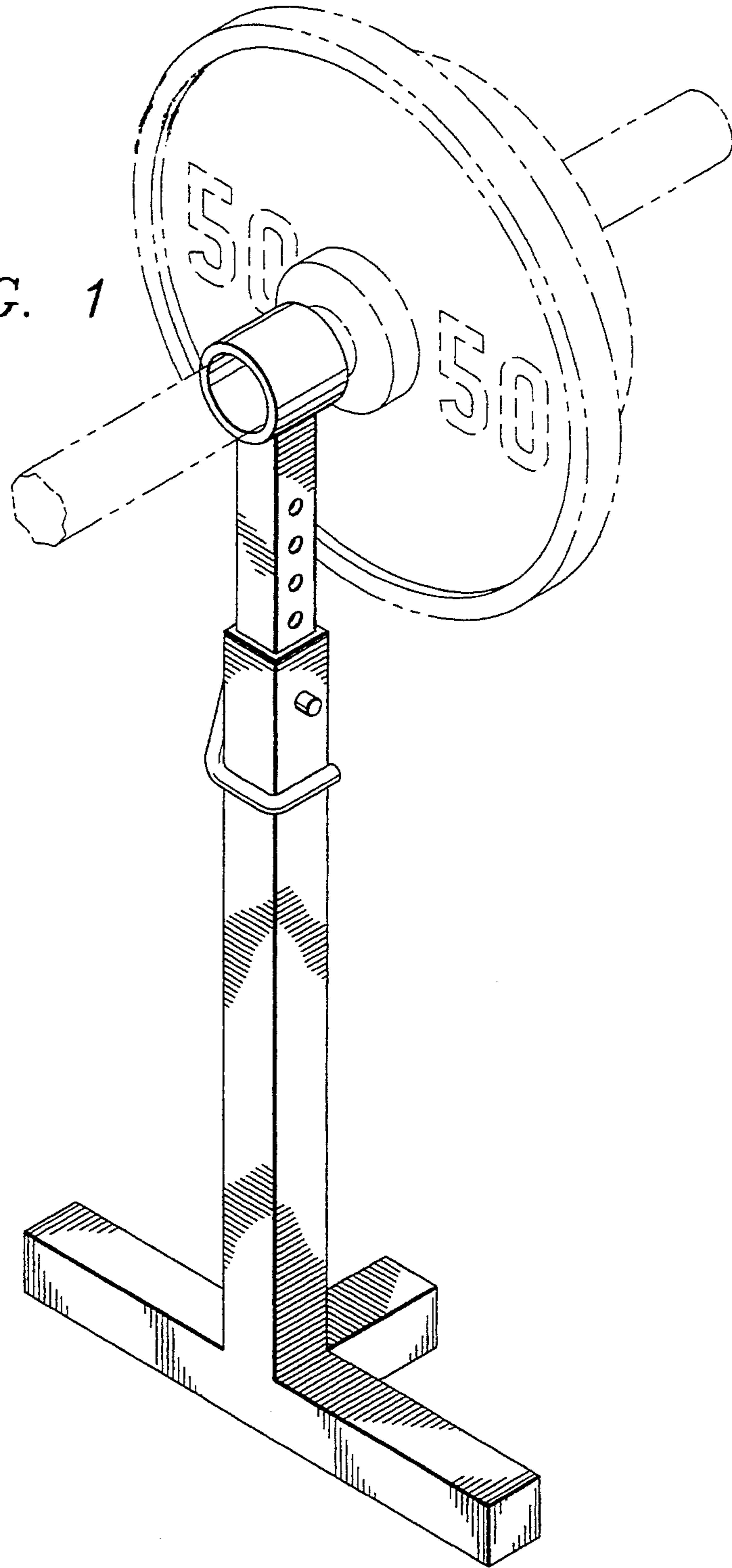

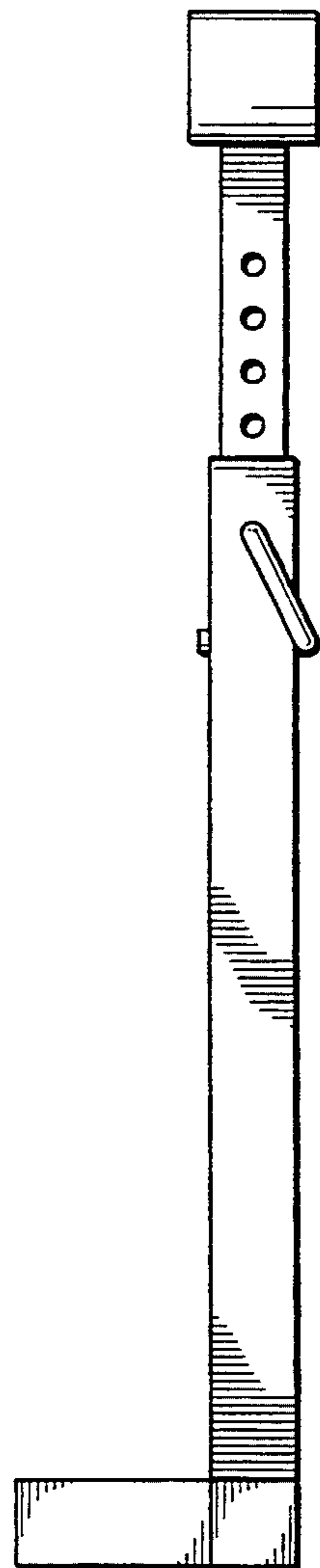

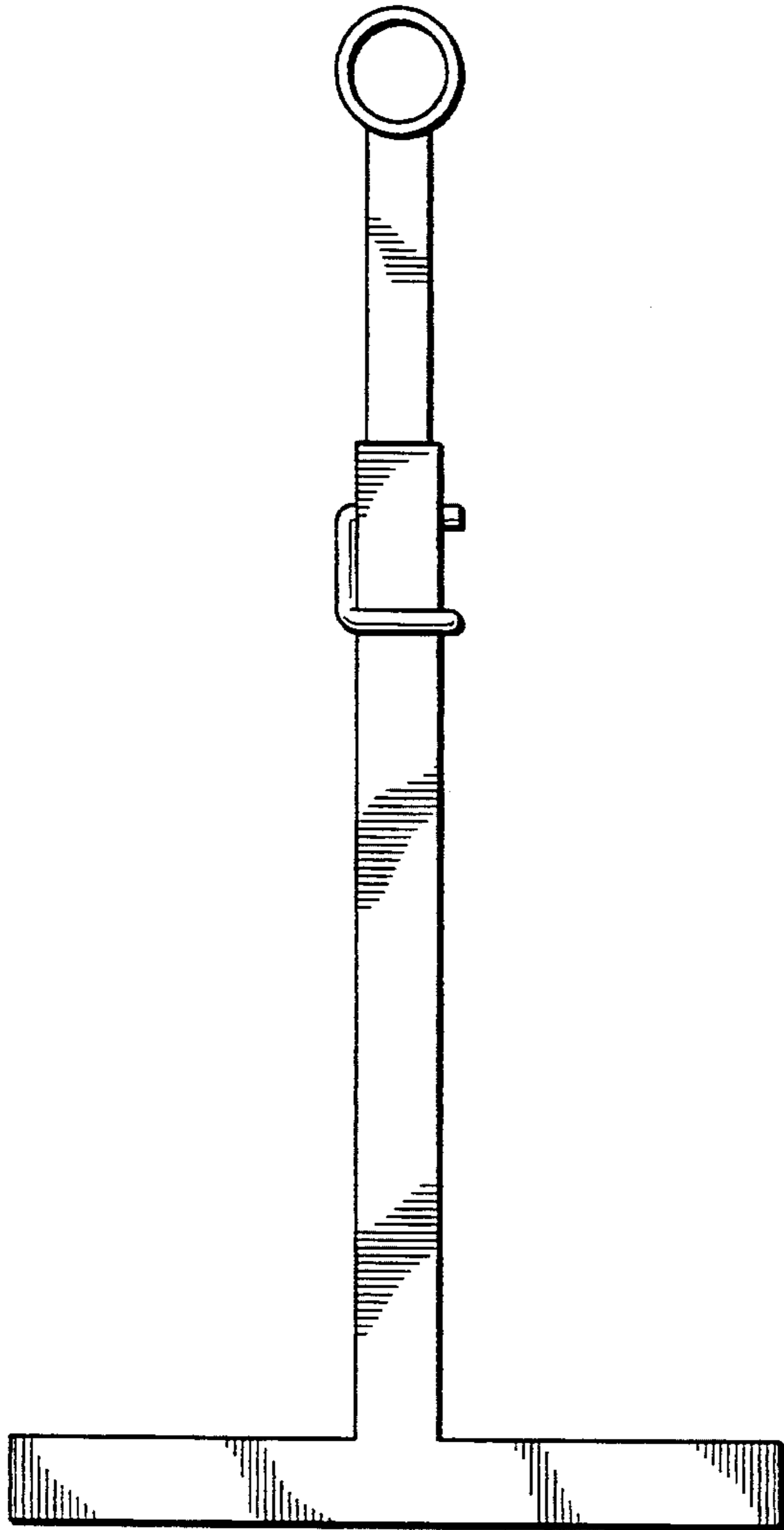

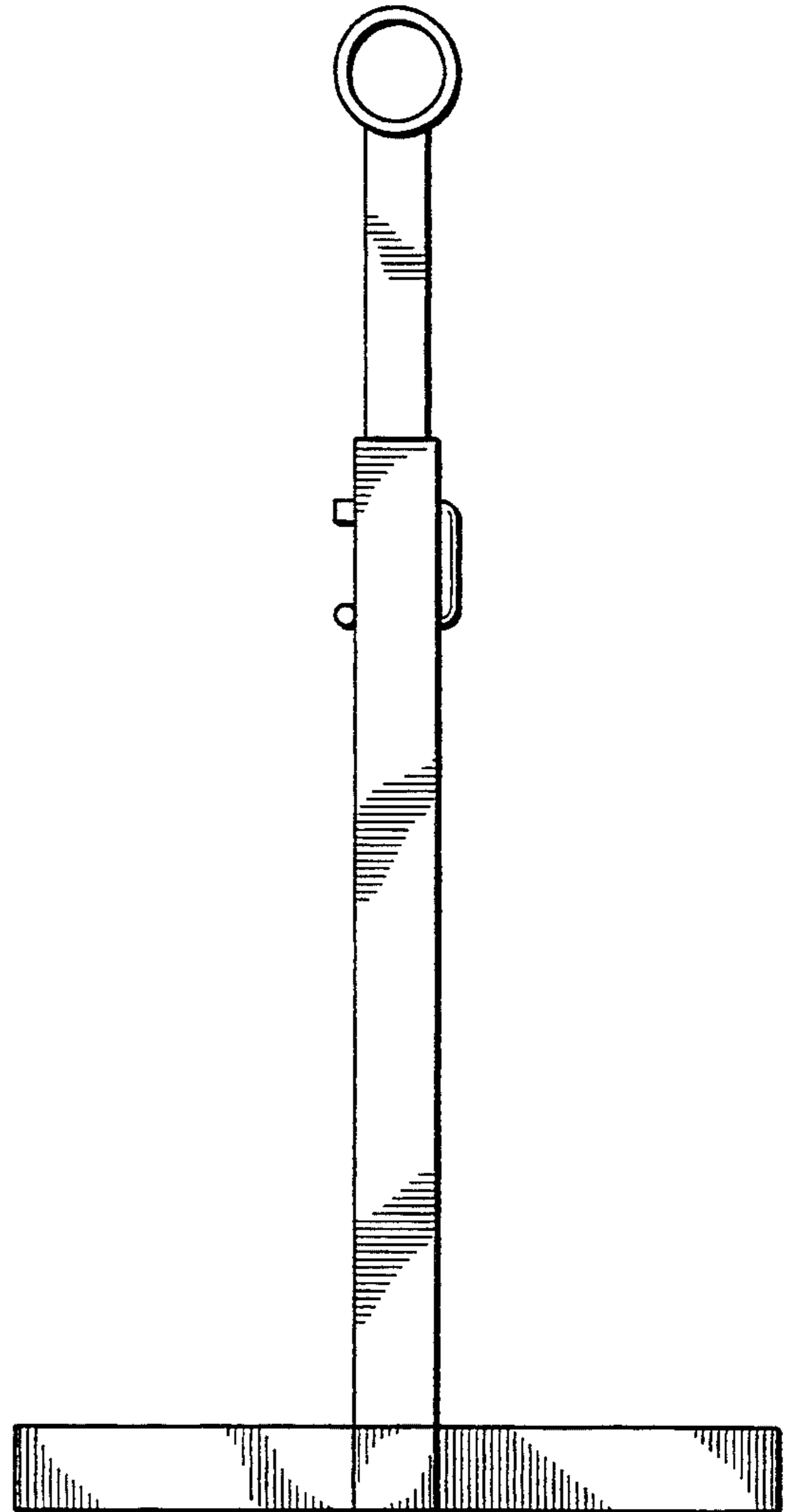

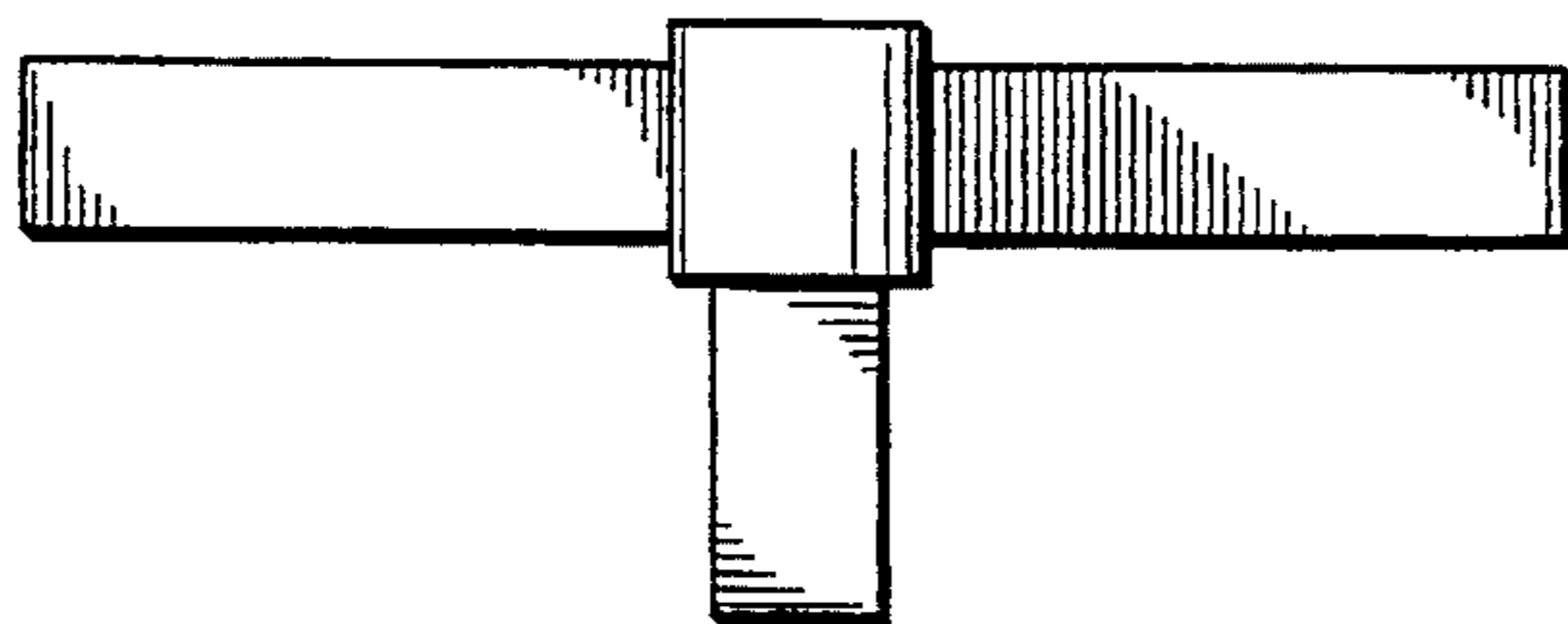

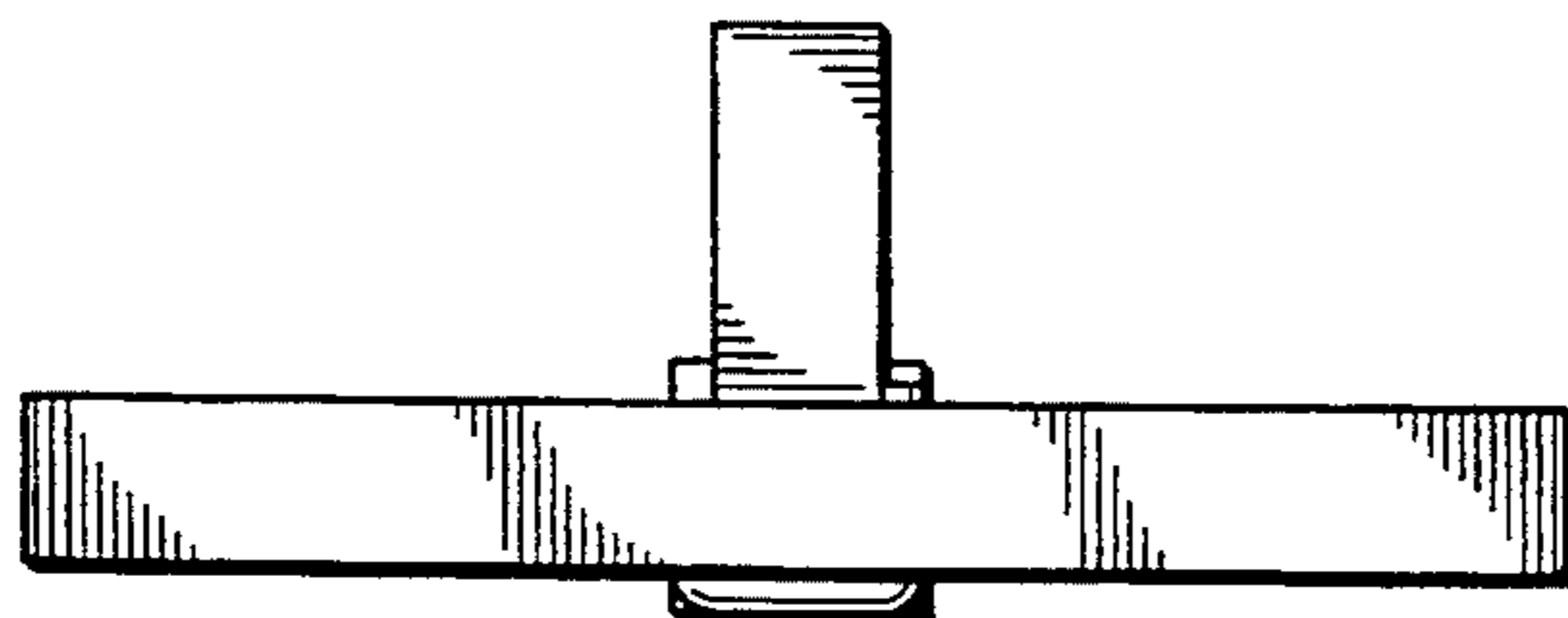
