[57] **CLAIM**

The ornamental design for the compartmented food tray for a ball stadium, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the compartmented food tray for a ball stadium showing my new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

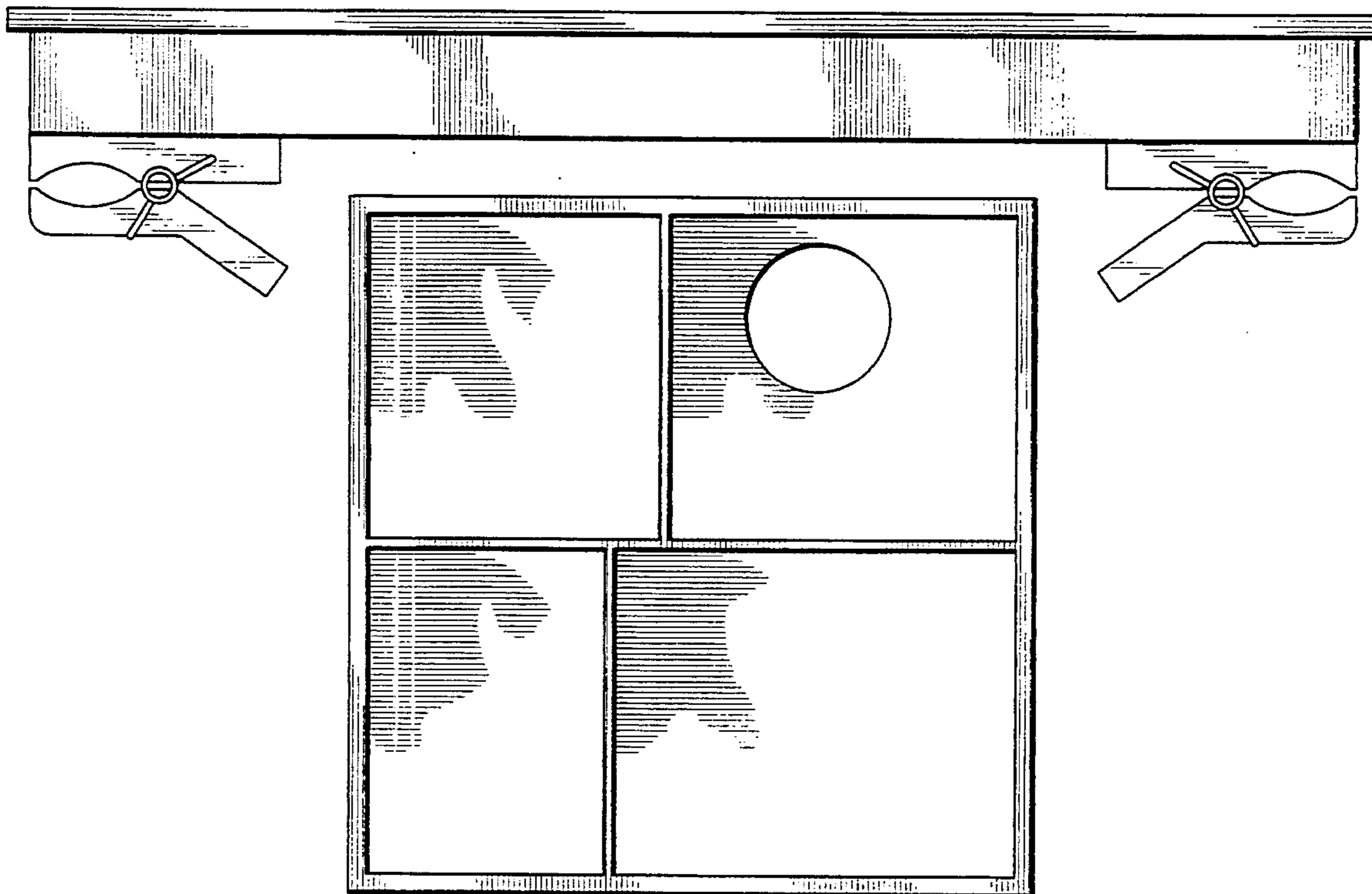

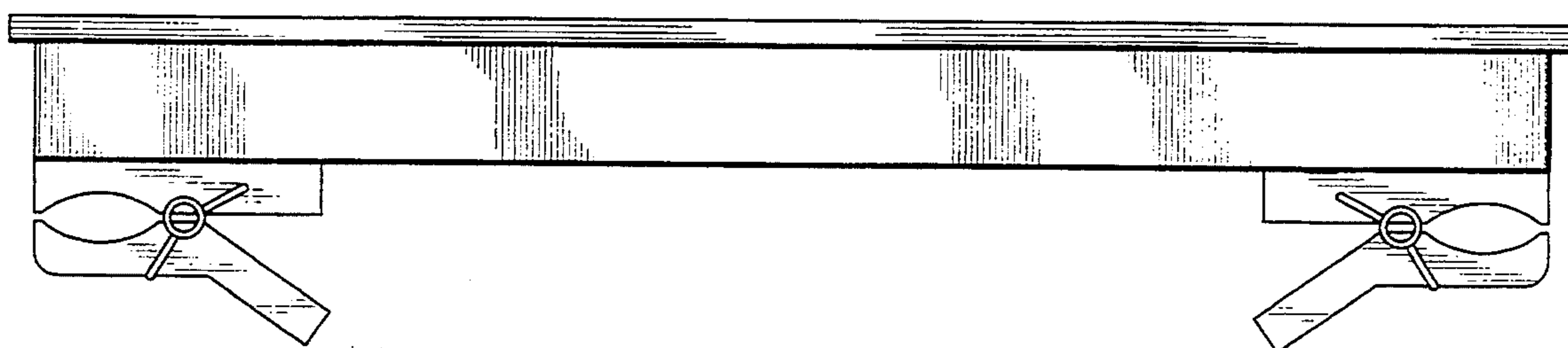

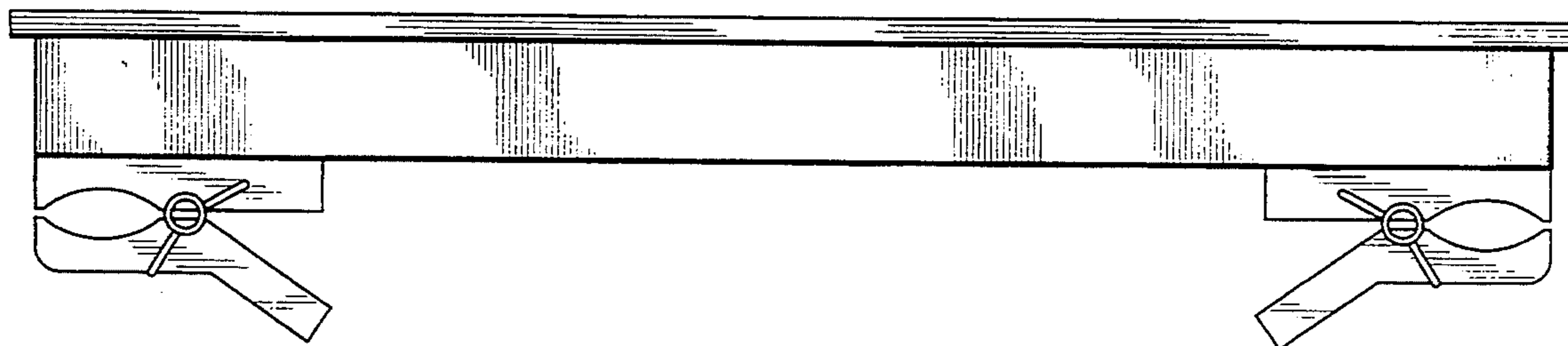

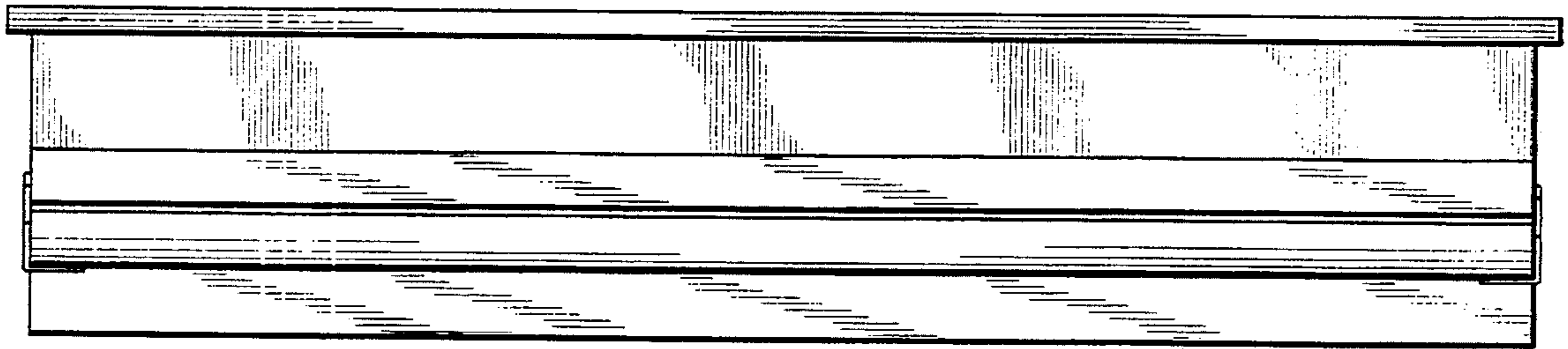

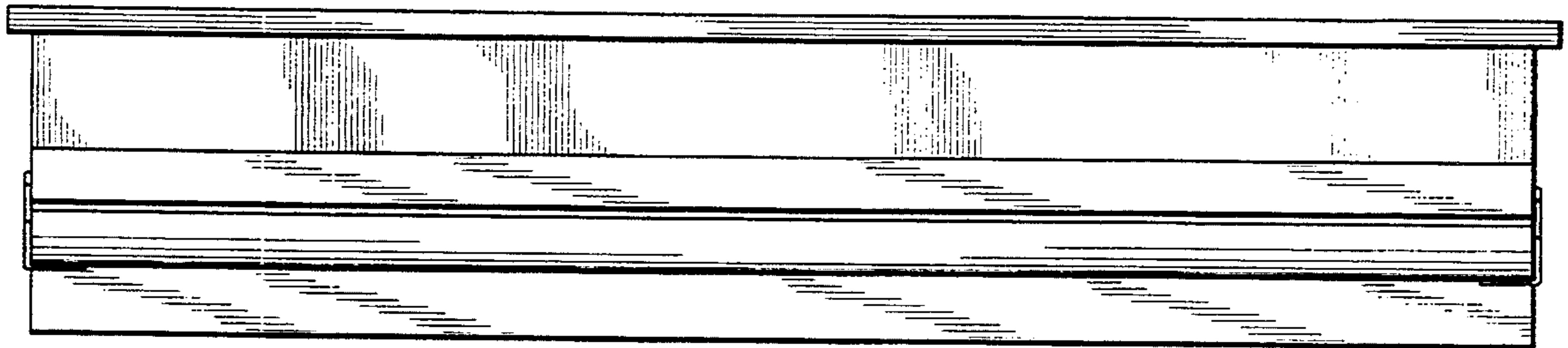

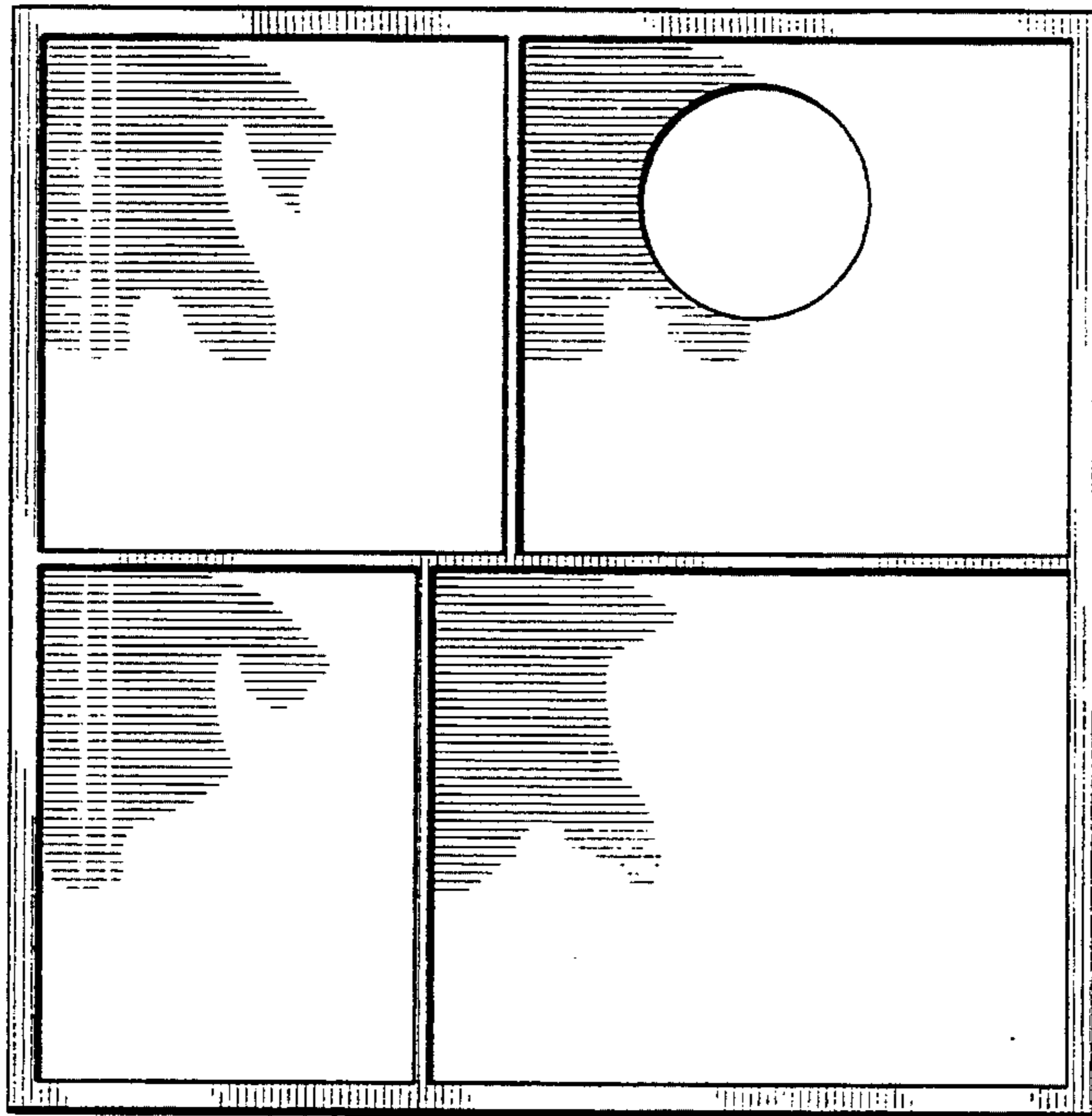
