The ornamental design for a pick for stringed instruments, as shown and described.

### DESCRIPTION

FIG. 1 is a side elevational view of a pick for stringed instruments showing my new design;

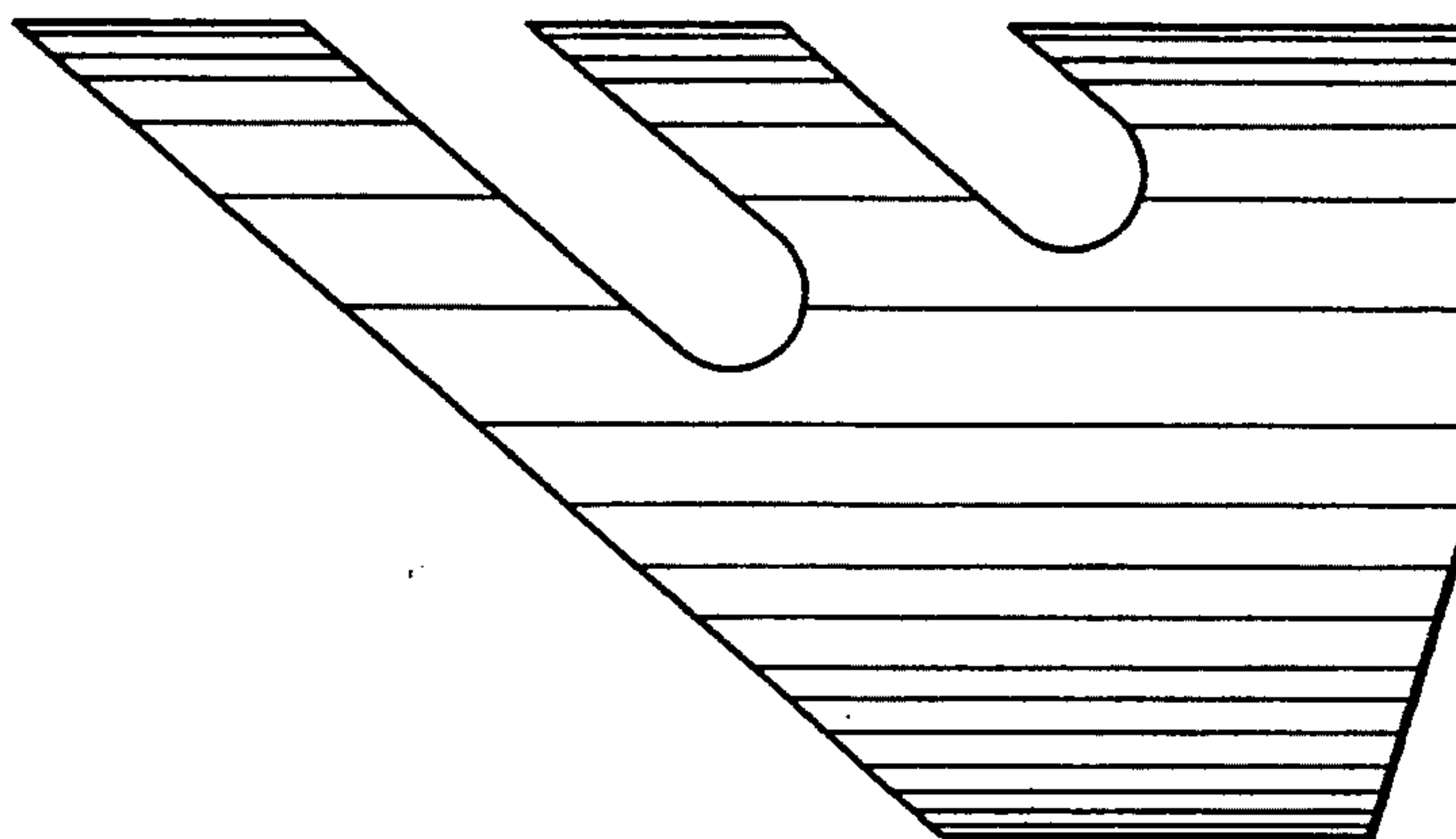
FIG. 2 is a side sectional view thereof;

FIG. 6 is an end view as seen from the right of FIG. 1.



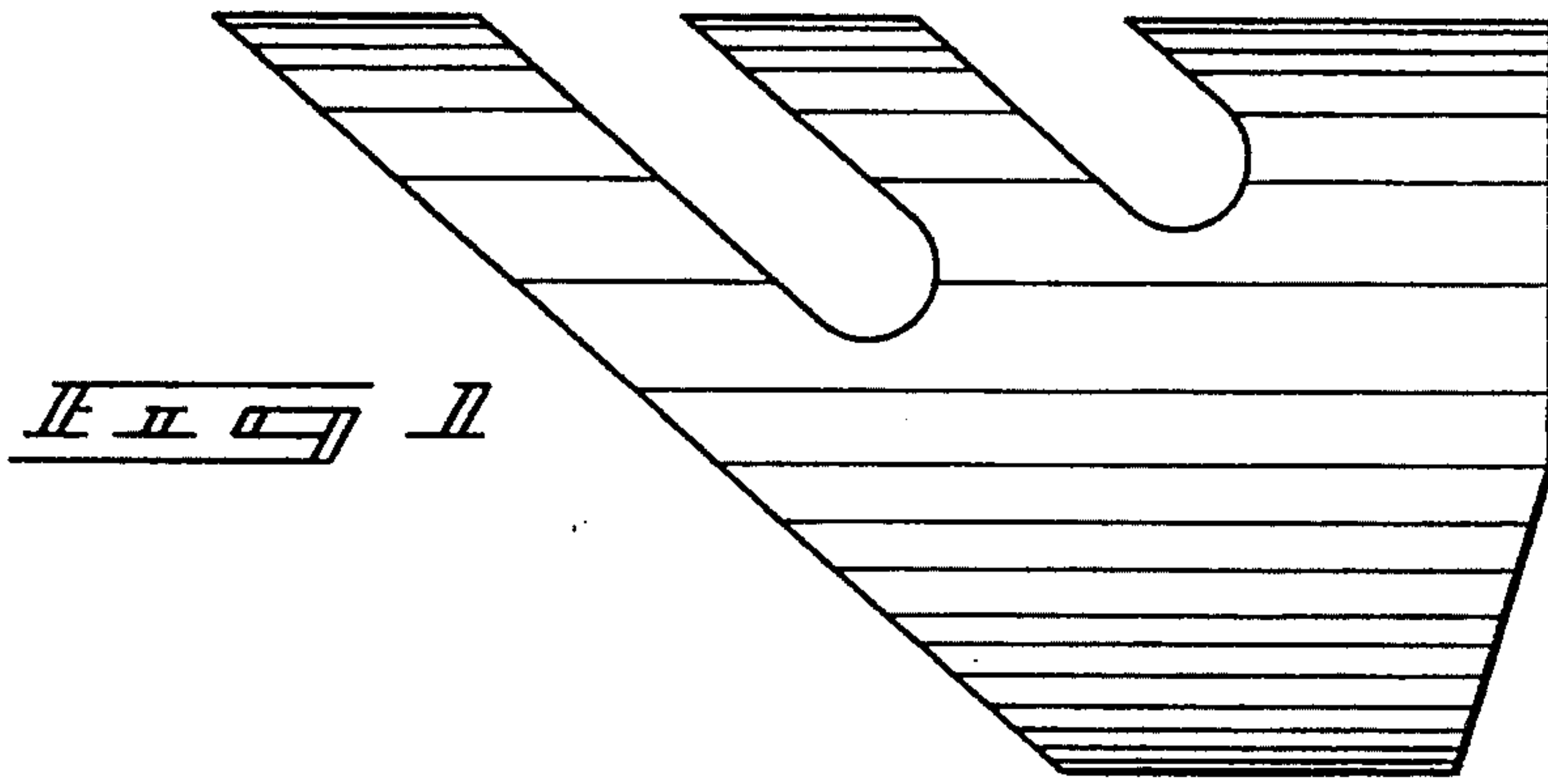

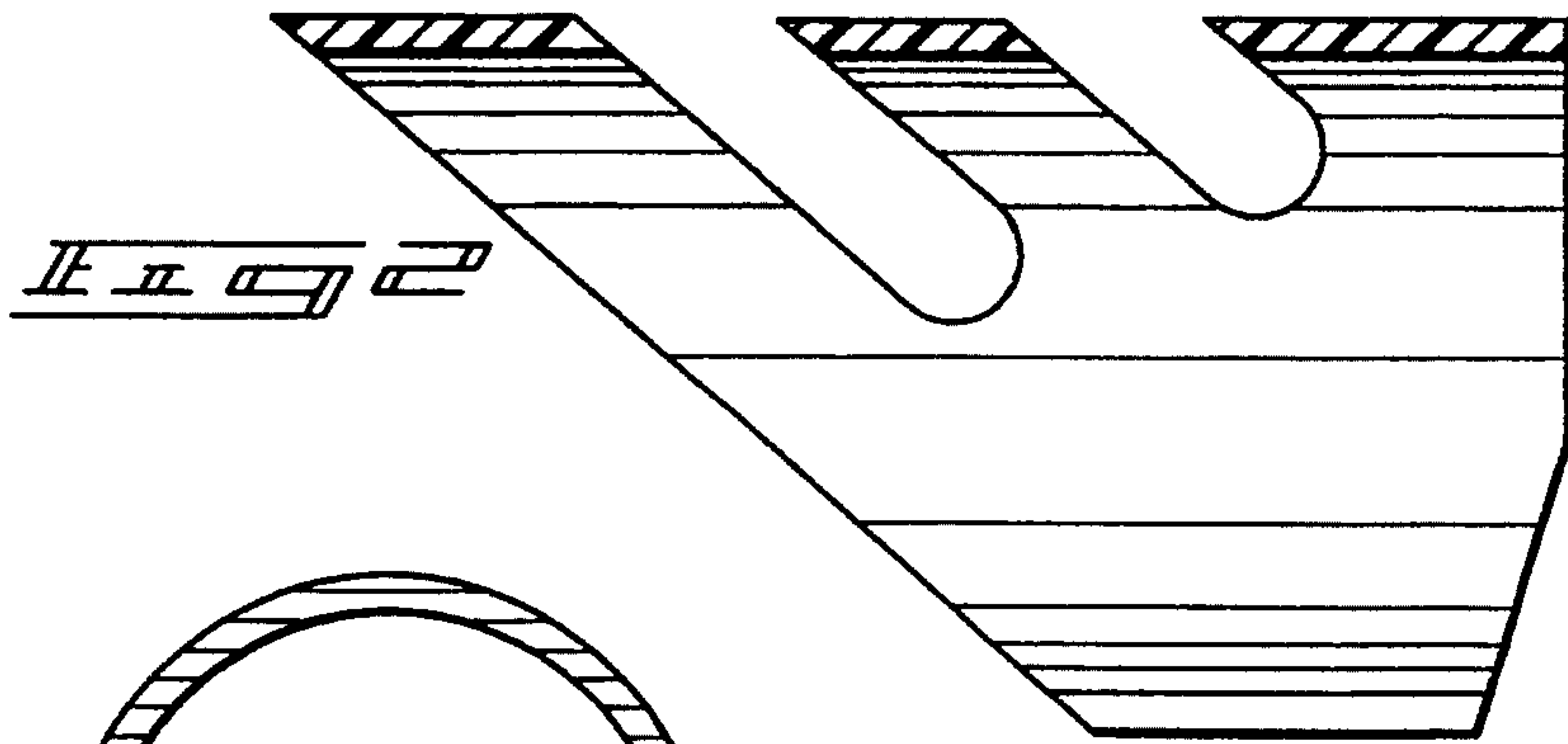

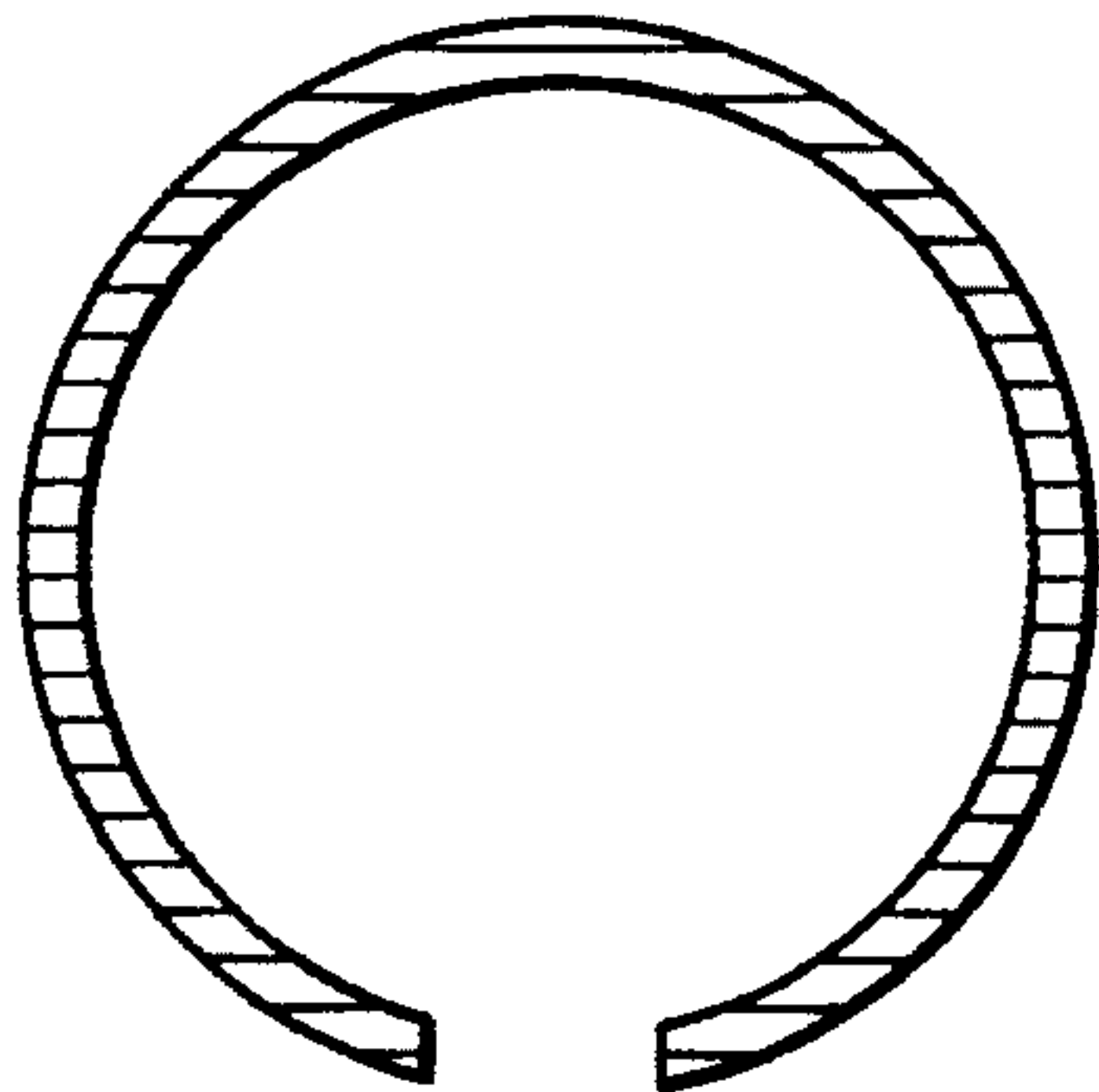

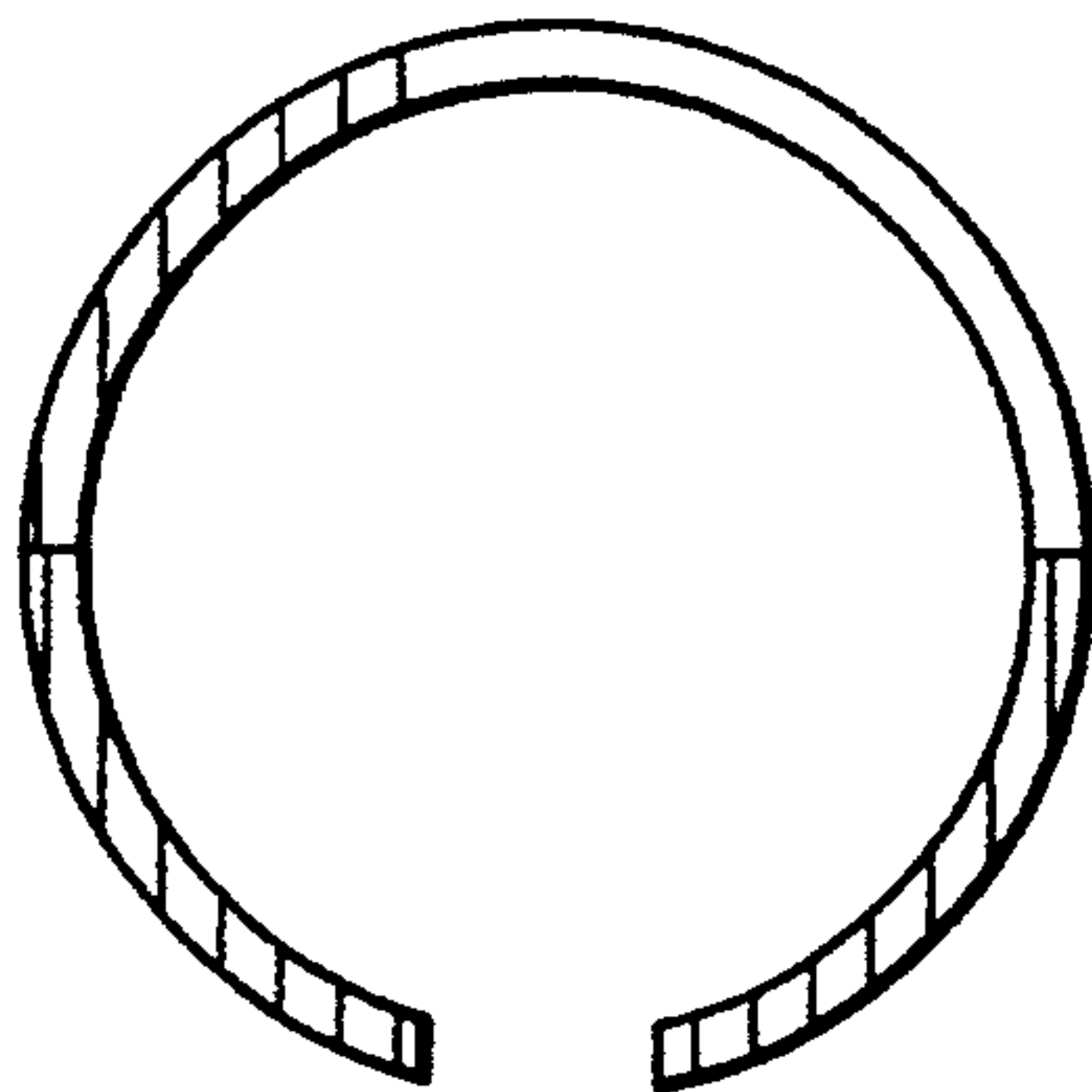

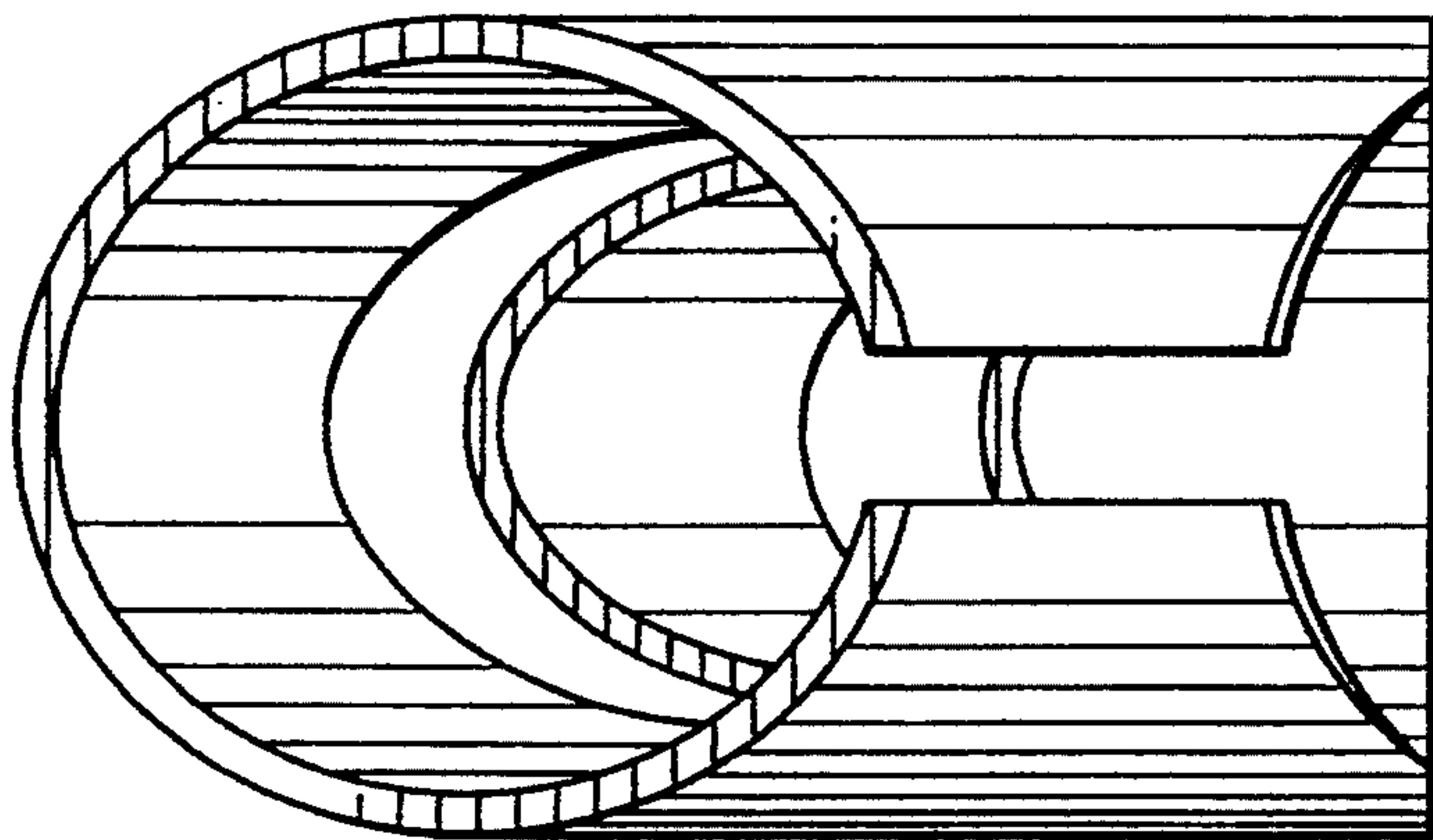
