**DESCRIPTION**

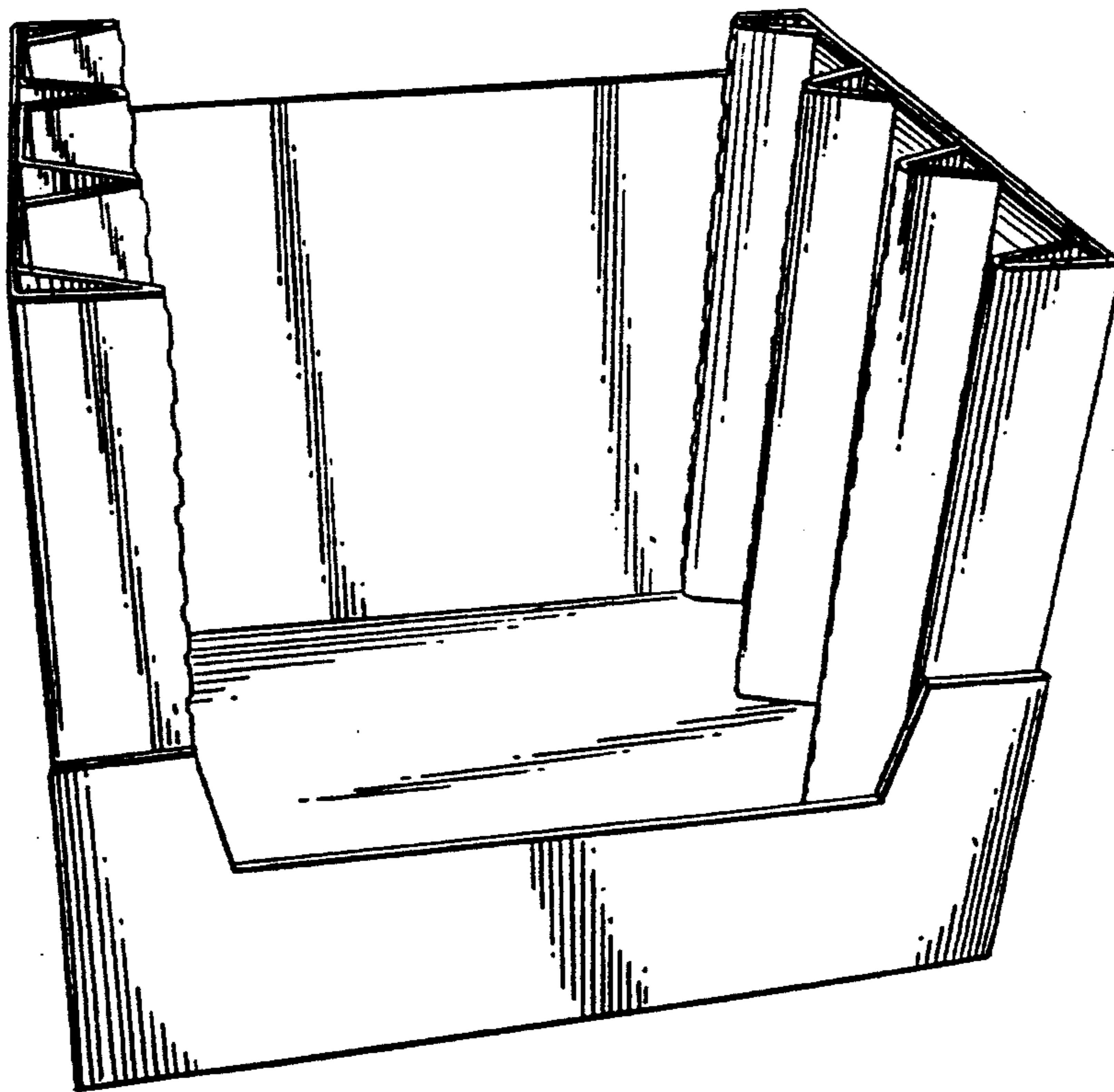
FIG. 1 is a top front perspective view of a combined product shipping and display box showing our new design;

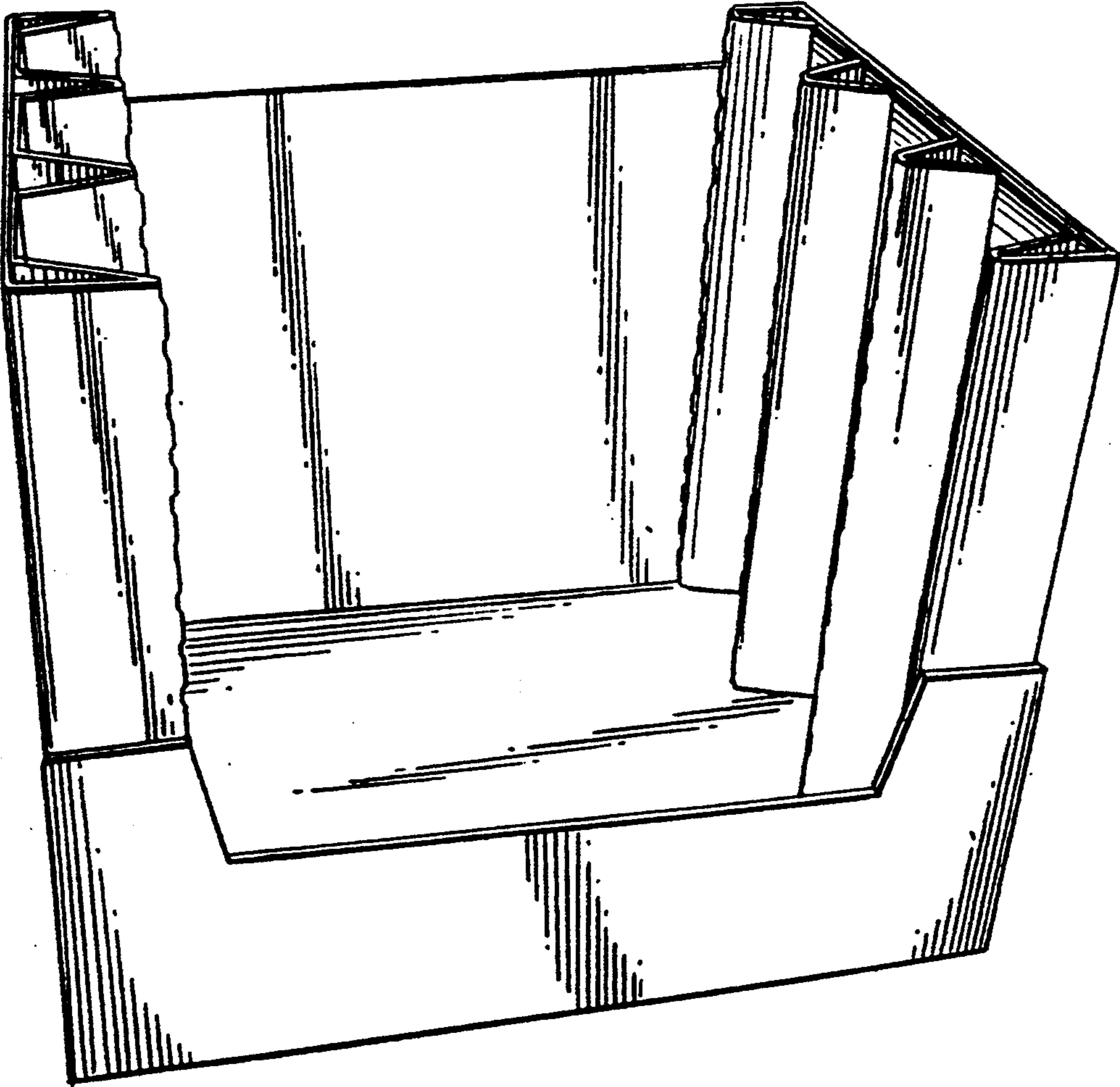

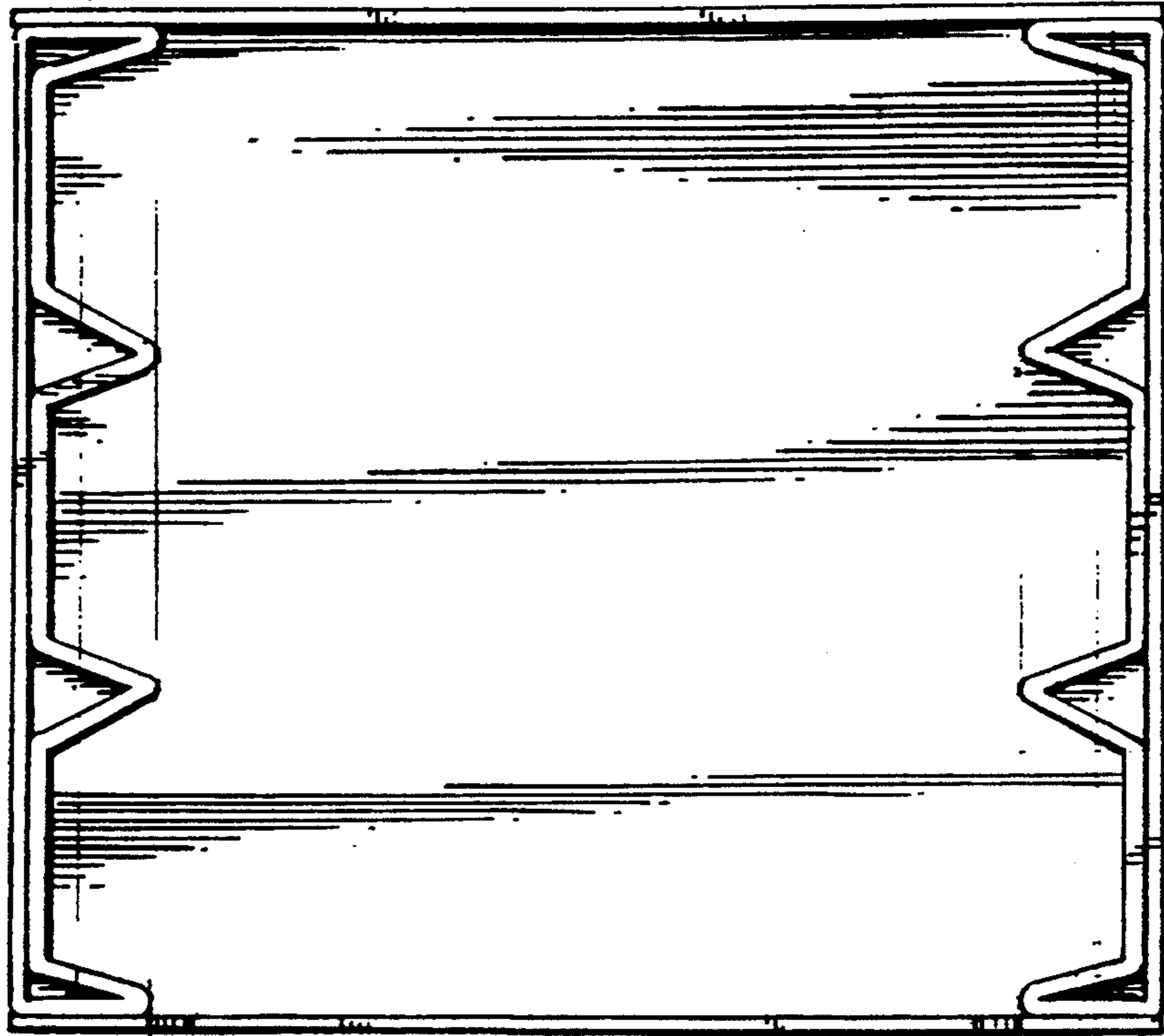
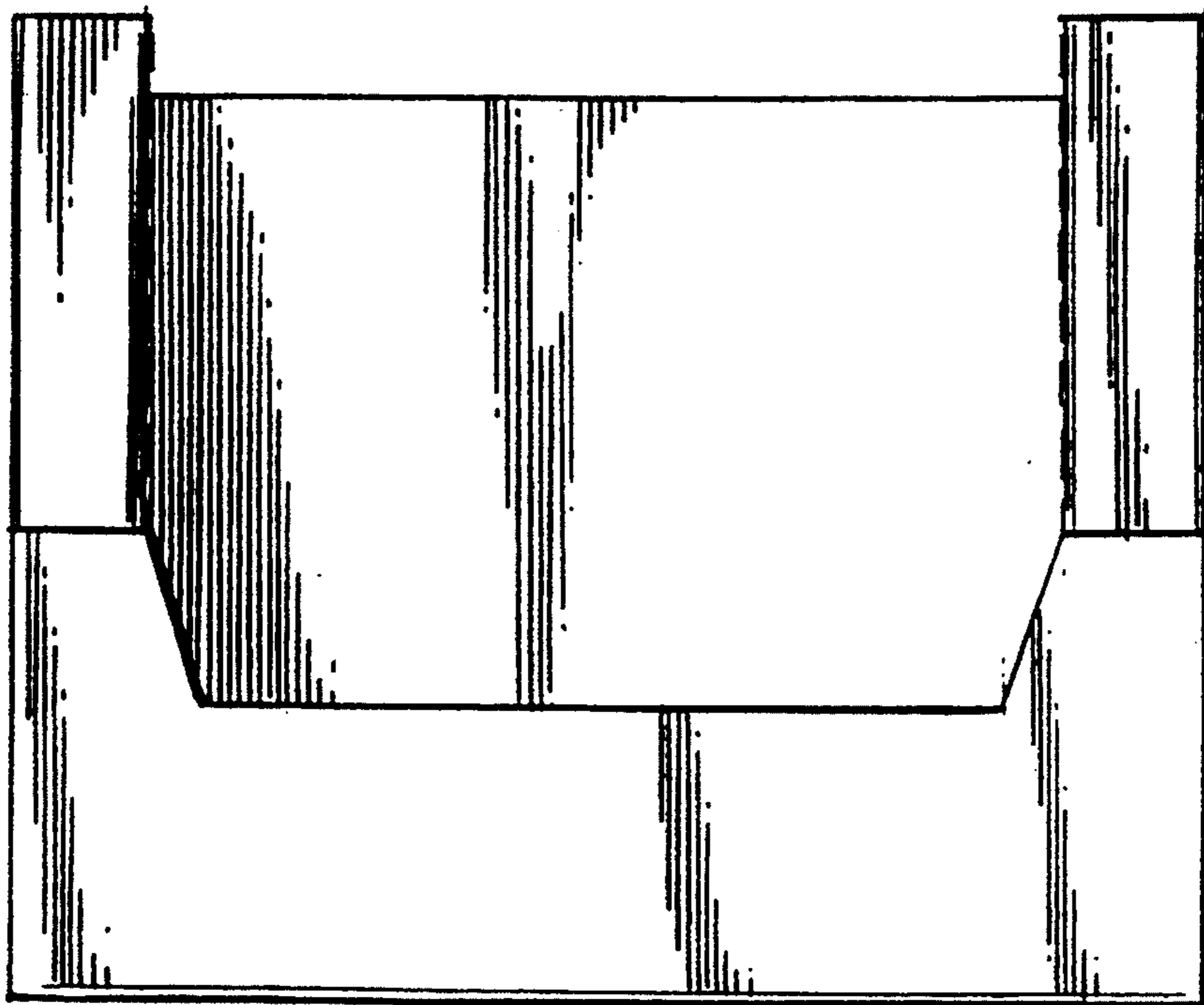
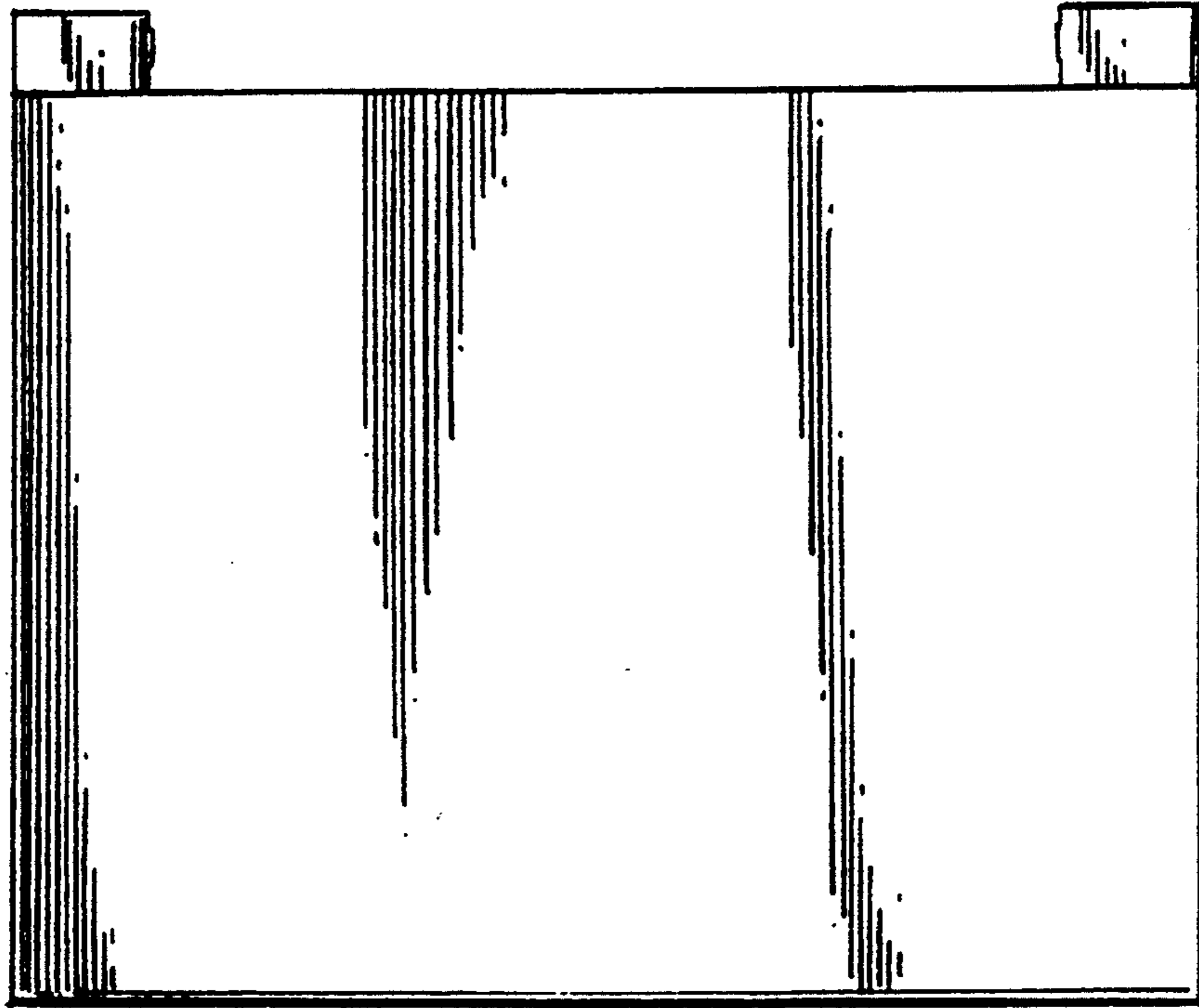
