DESCRIPTION

FIG. 1 is a front elevational view of a knife showing my new design;

 FIG. 14 is another perspective view thereof in the opened position.

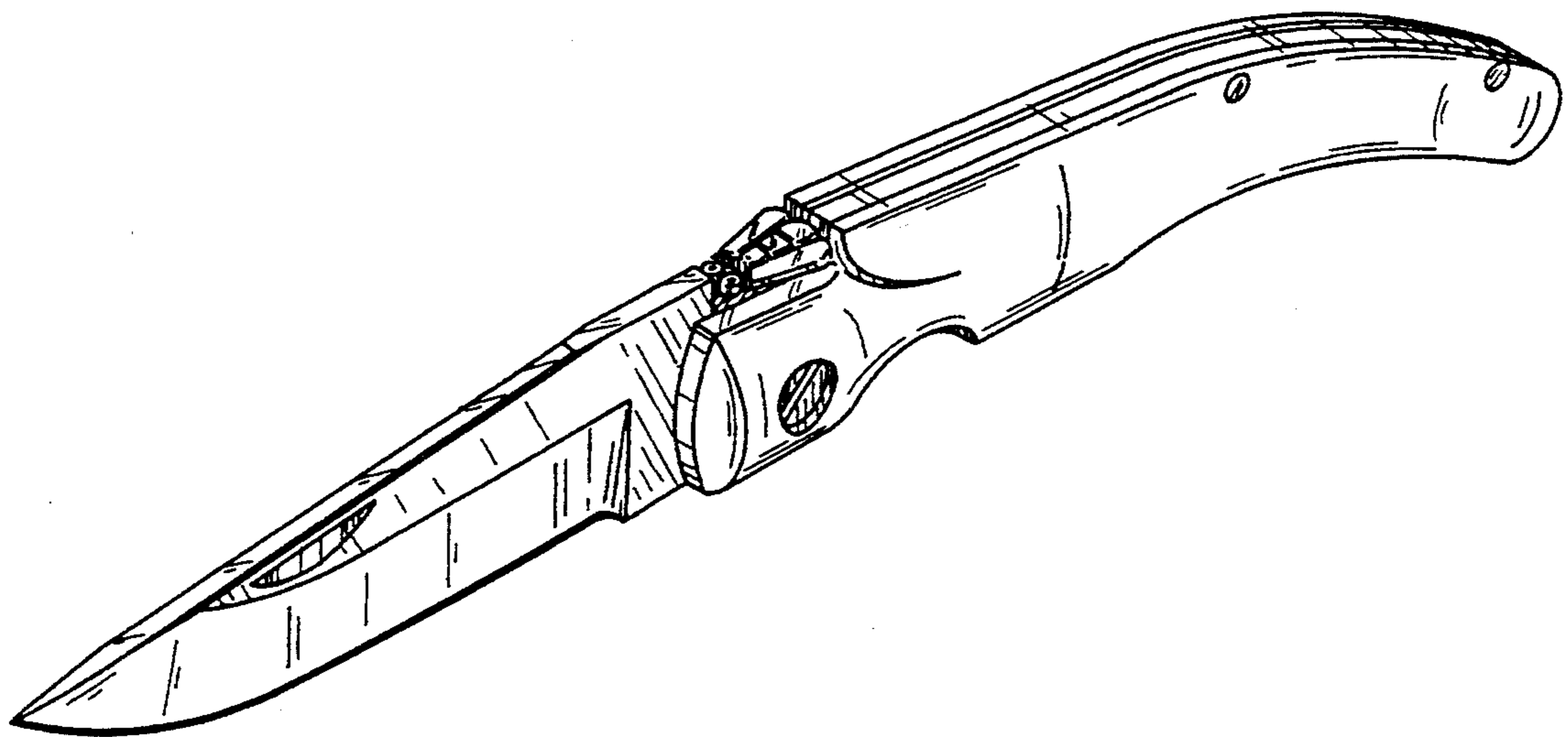

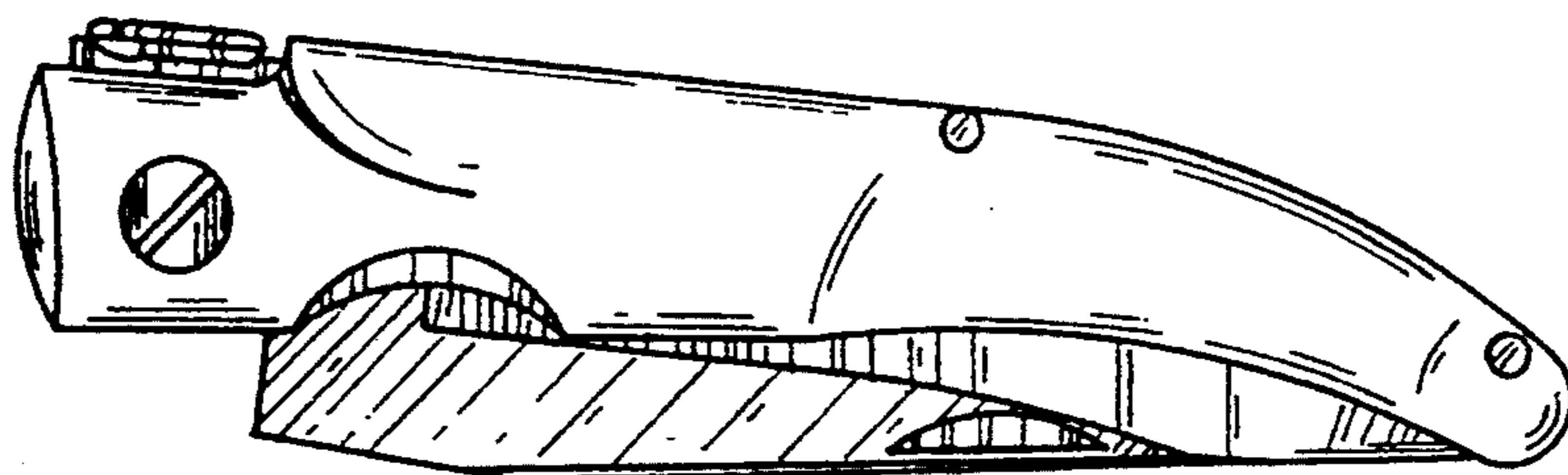

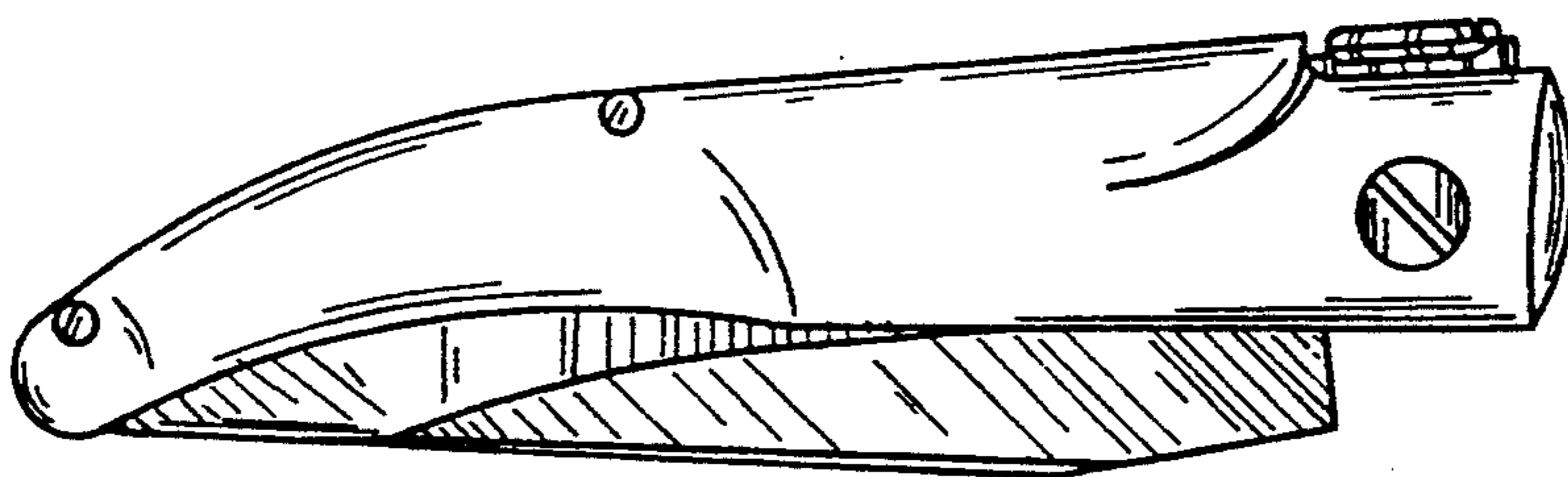

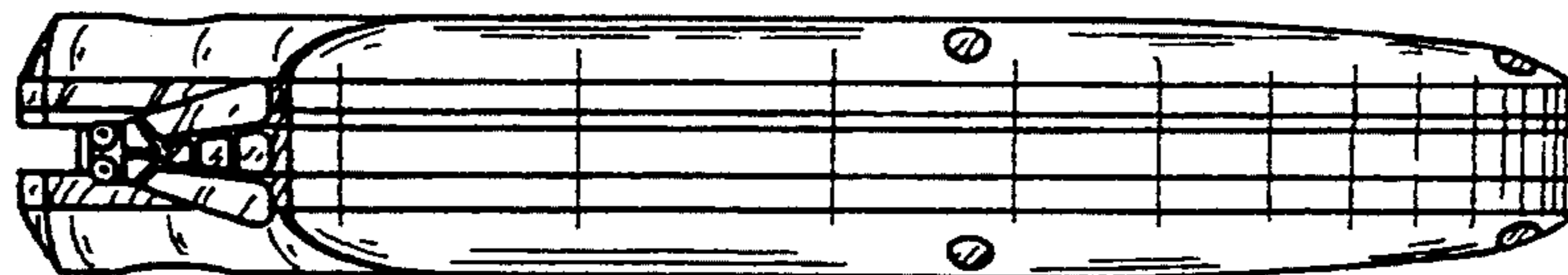

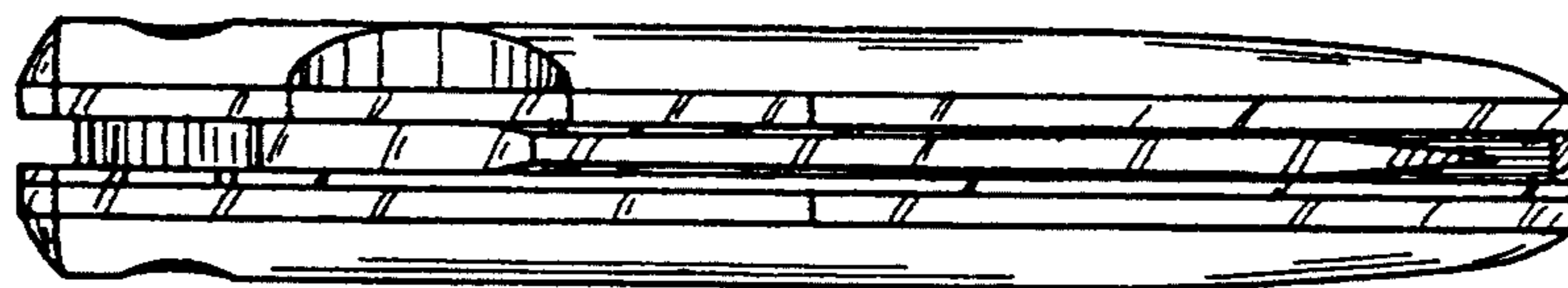

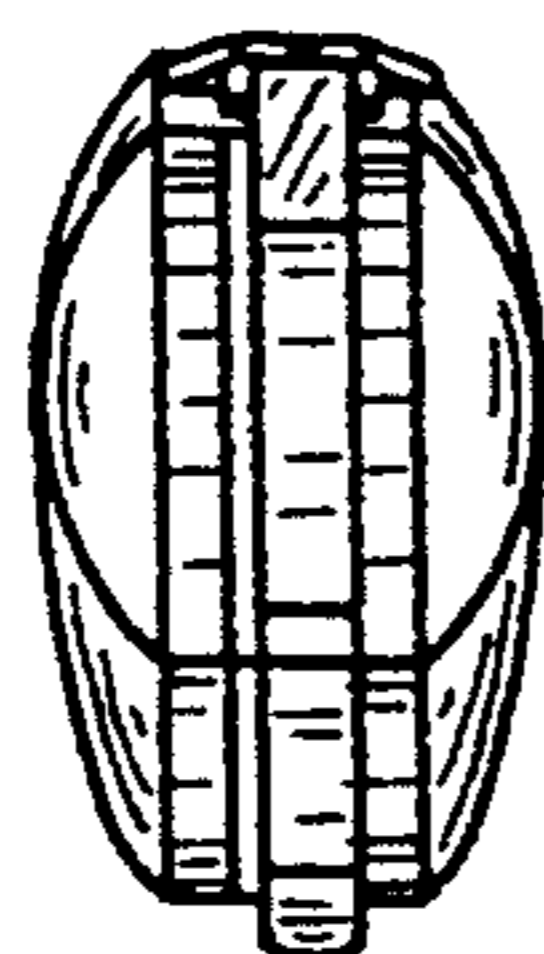

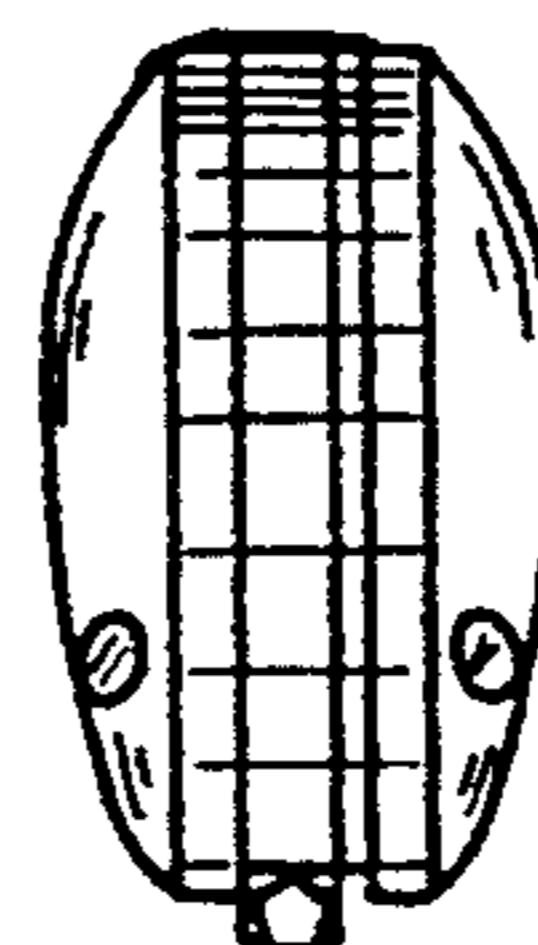

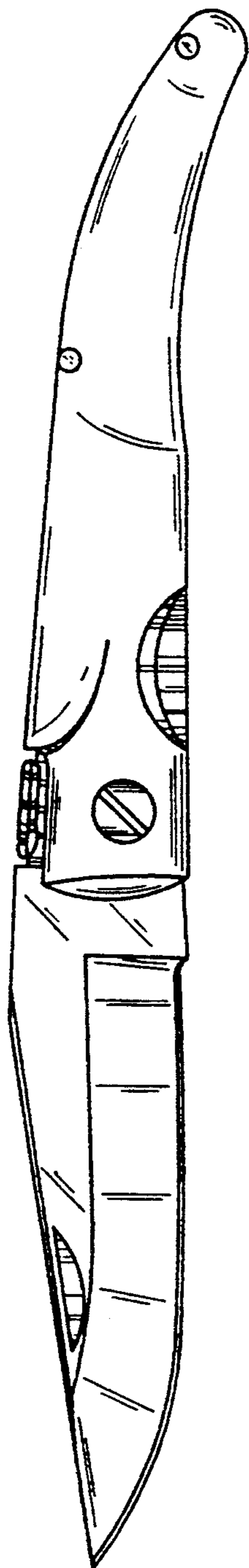

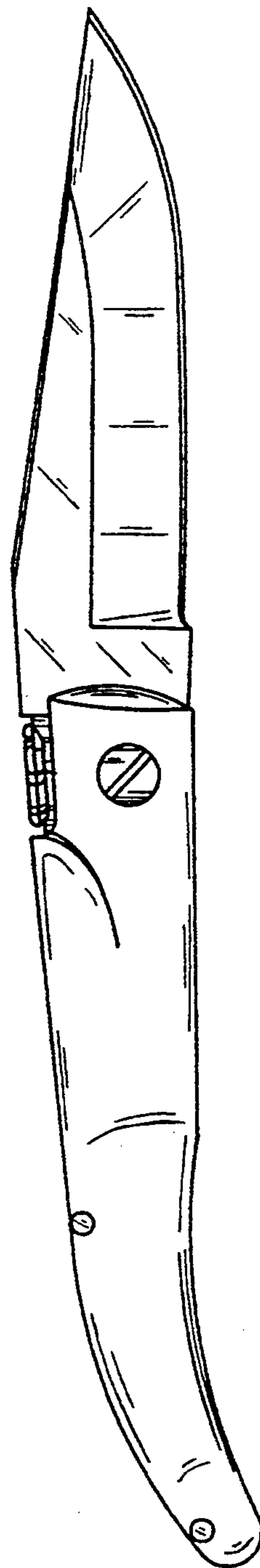

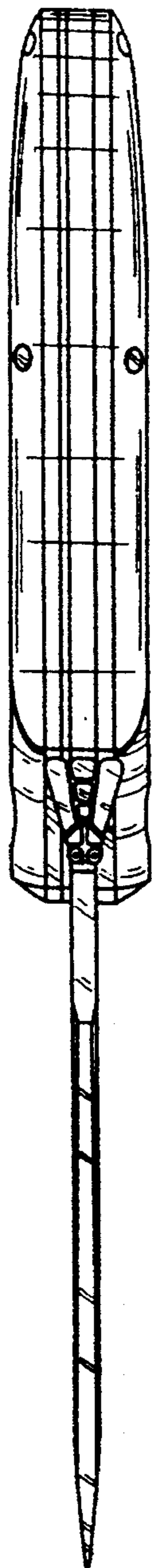

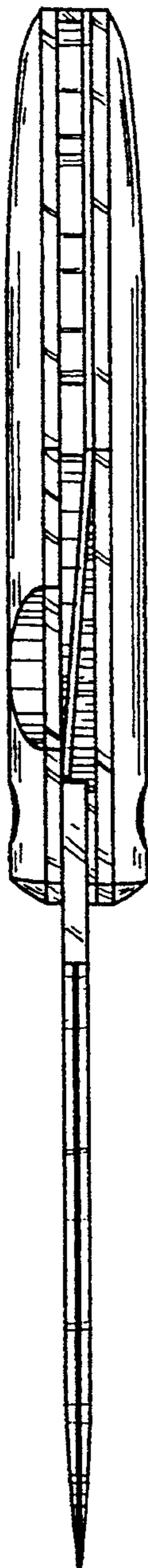

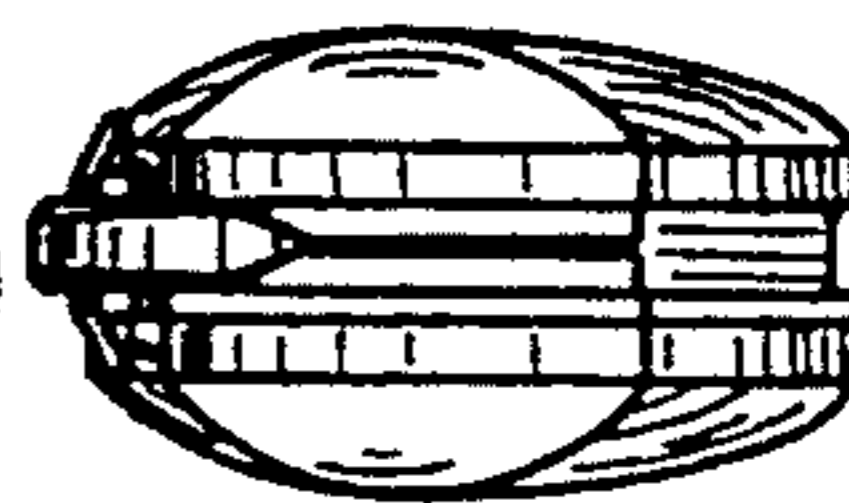
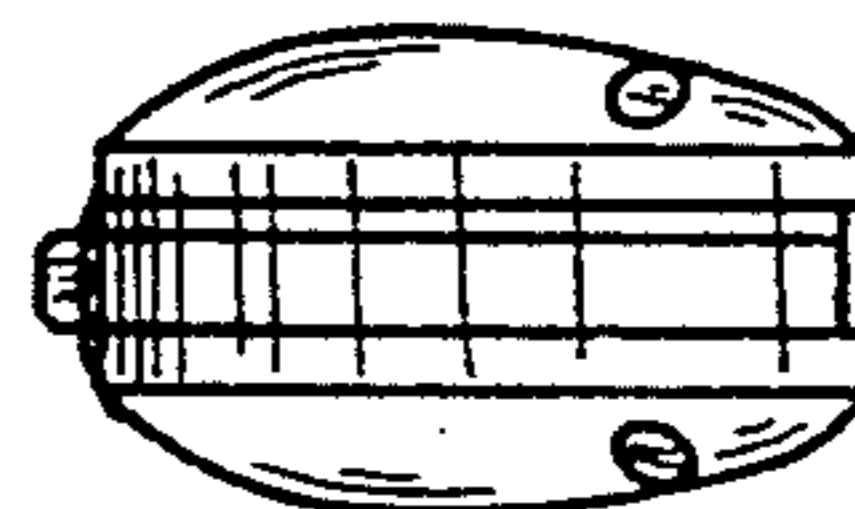

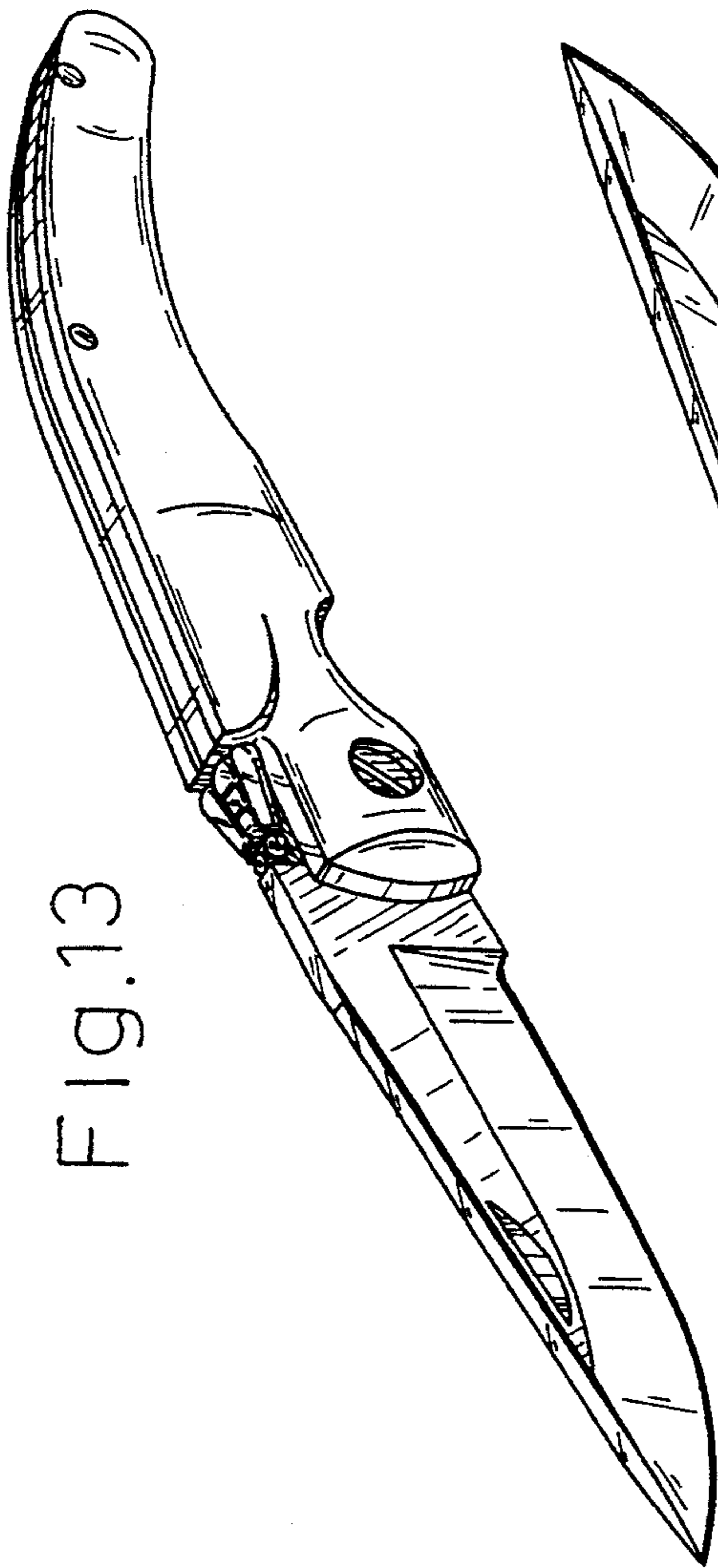
