FIG. 13 is a top, front, left-side perspective of a third embodiment of the curtain clamp assembly showing my new design;

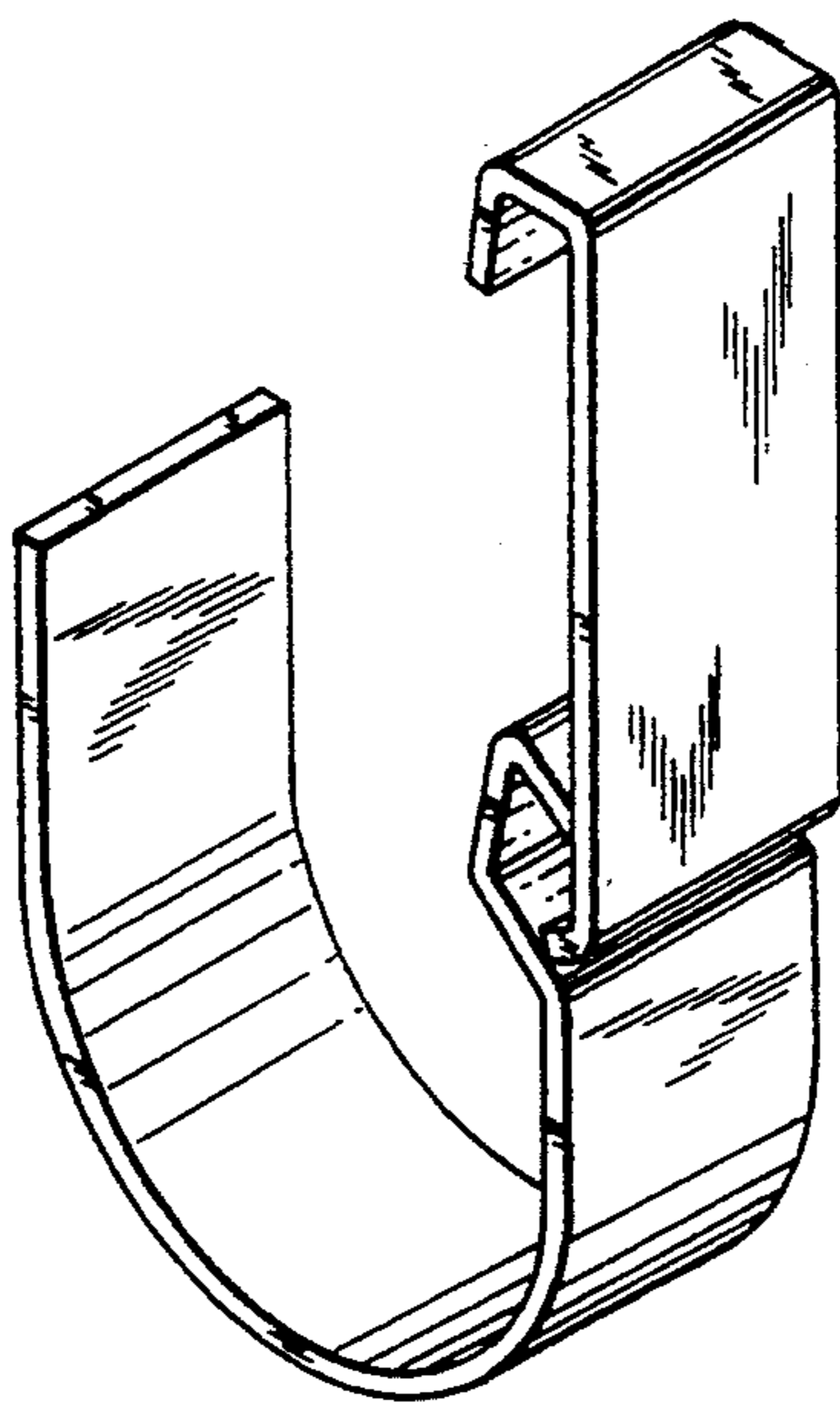
FIG. 14 is a top plan view thereof;

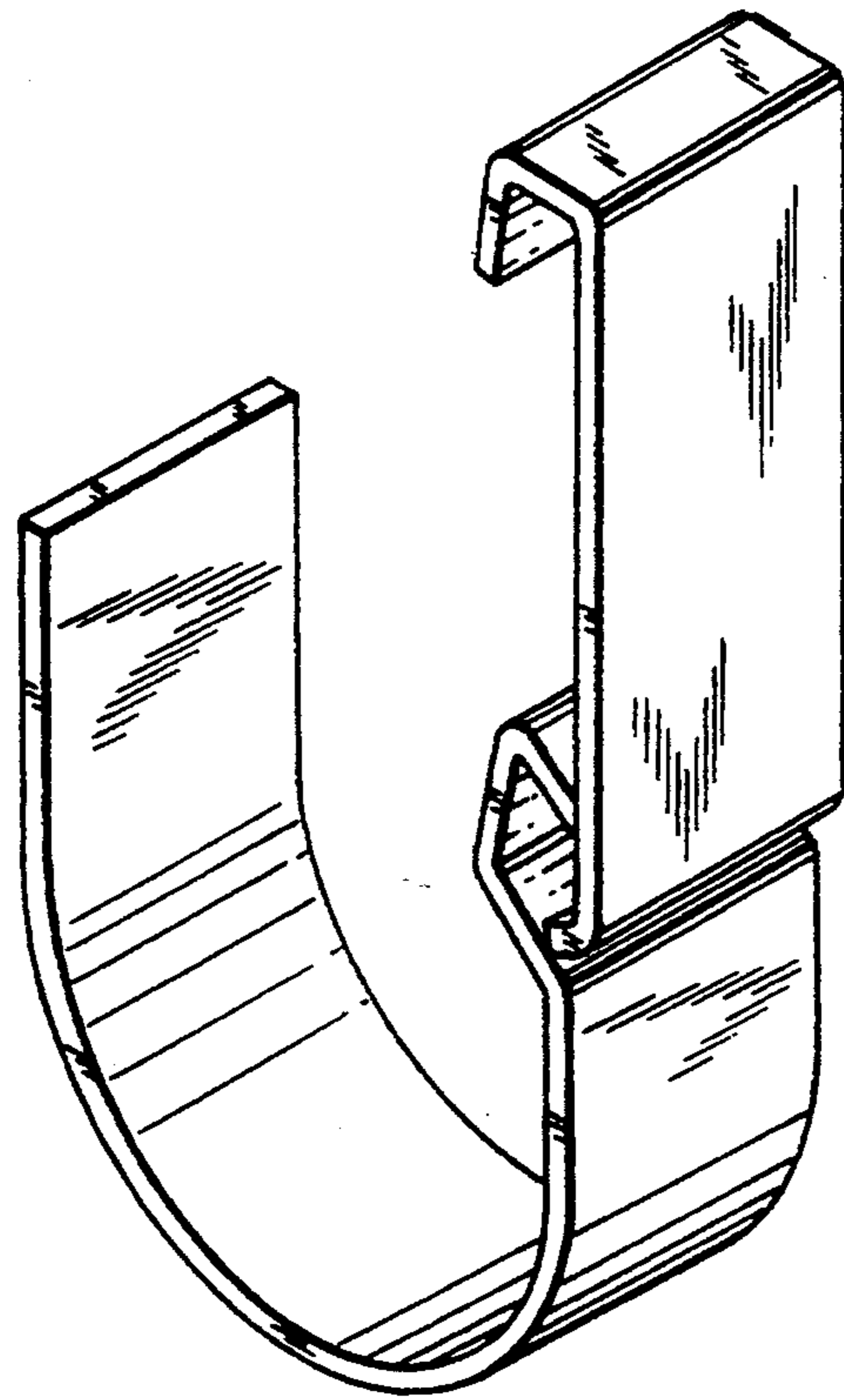
FIG. 15 is a right-side elevational view thereof;

FIG. 16 is a front elevational view thereof;

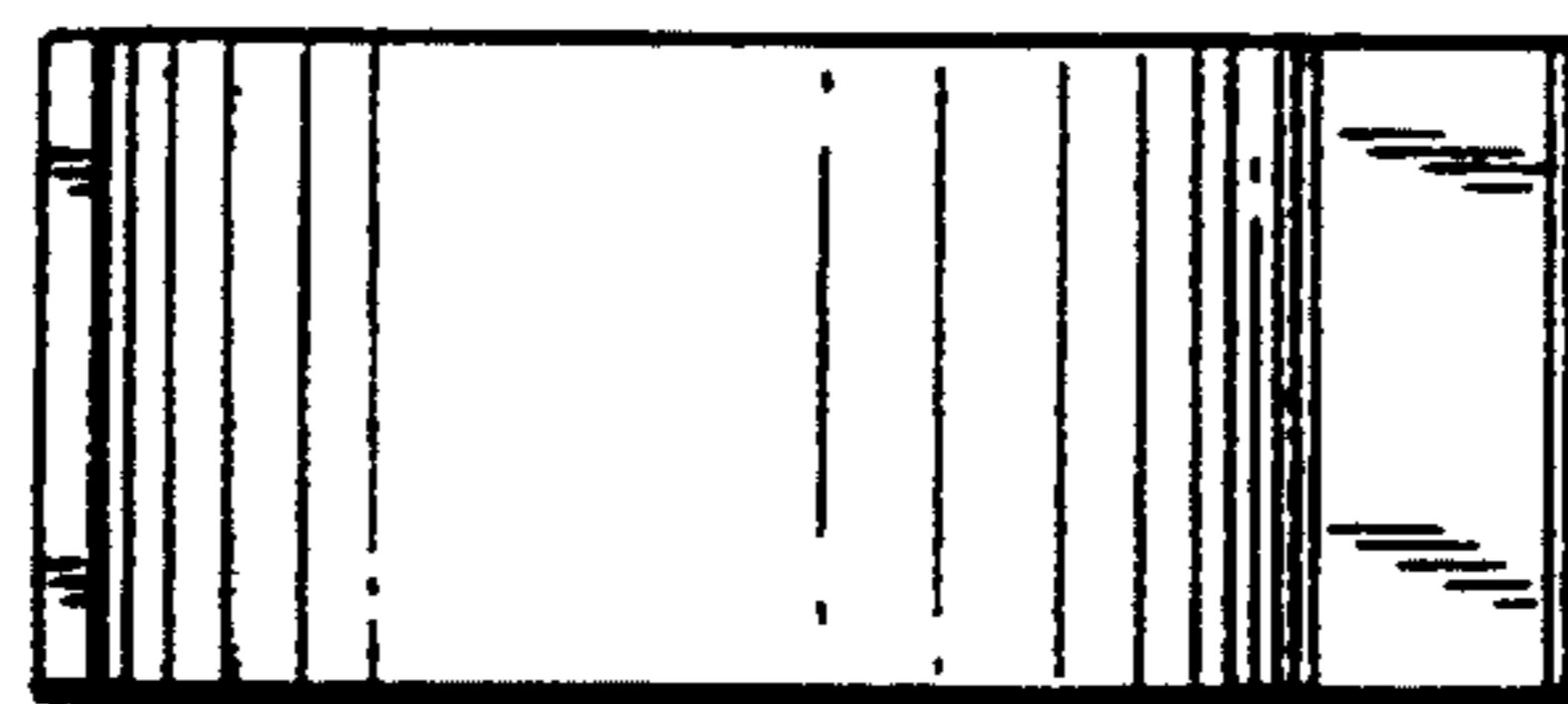
FIG. 17 is a rear elevational view thereof; and,

FIG. 18 is a bottom plan view thereof.

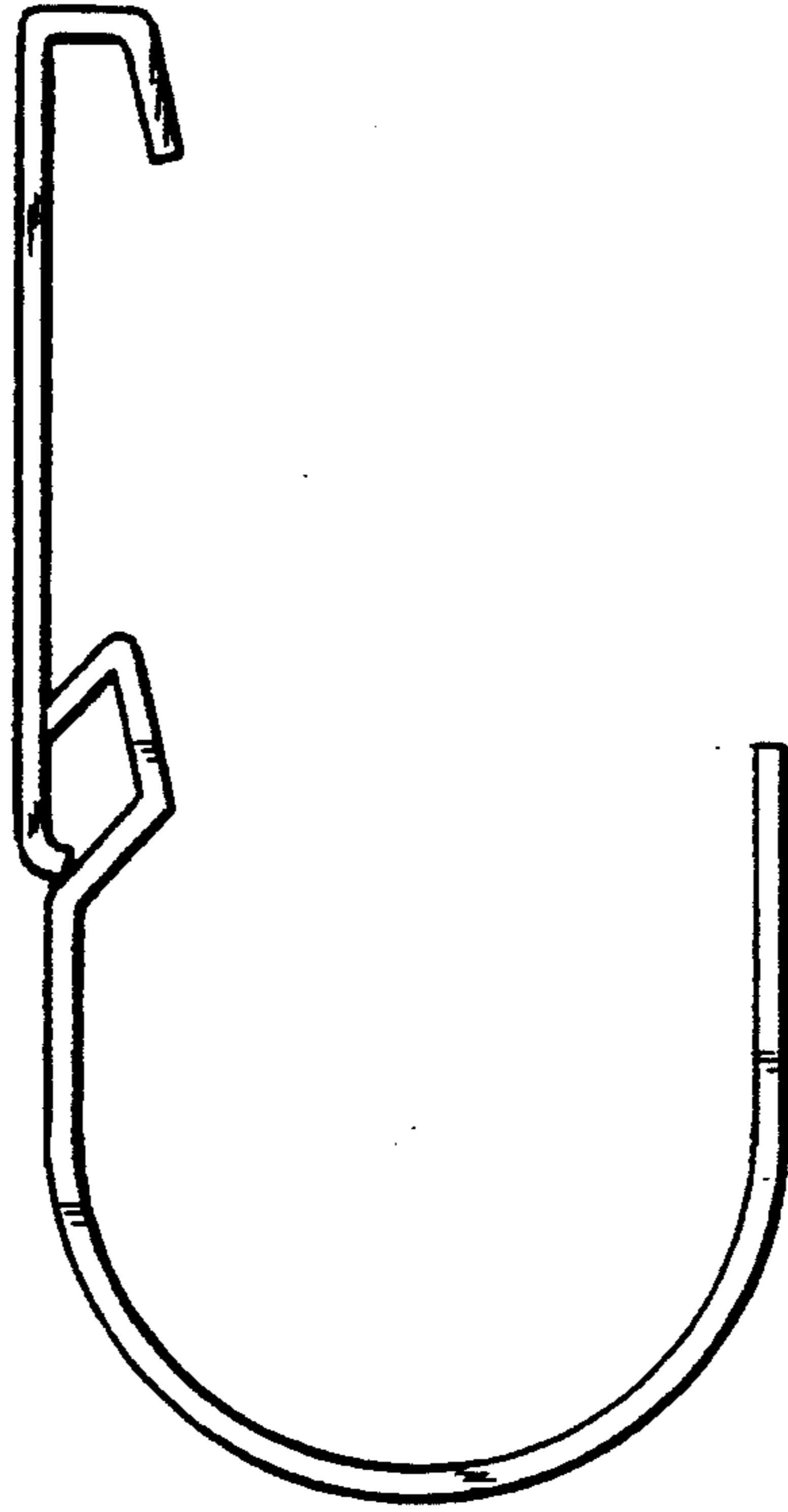




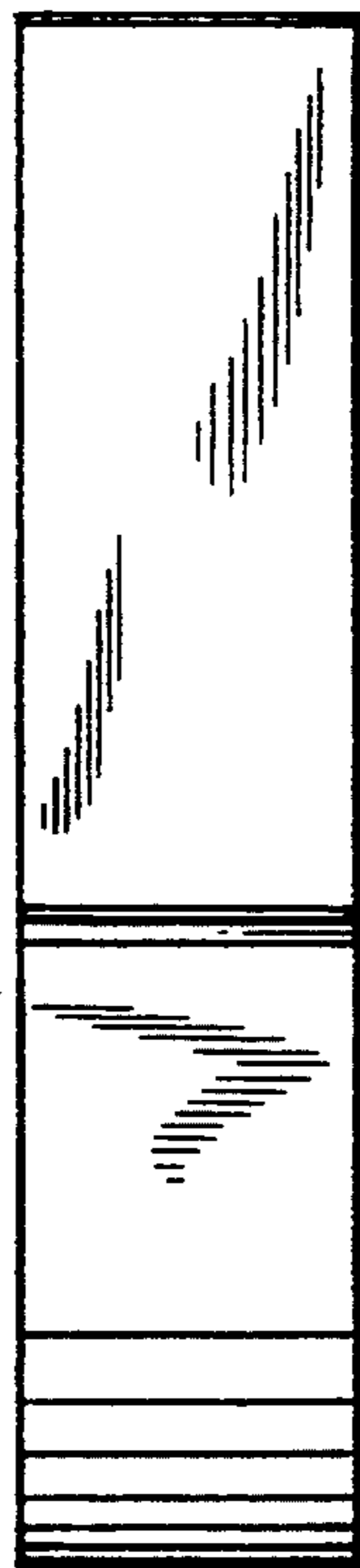

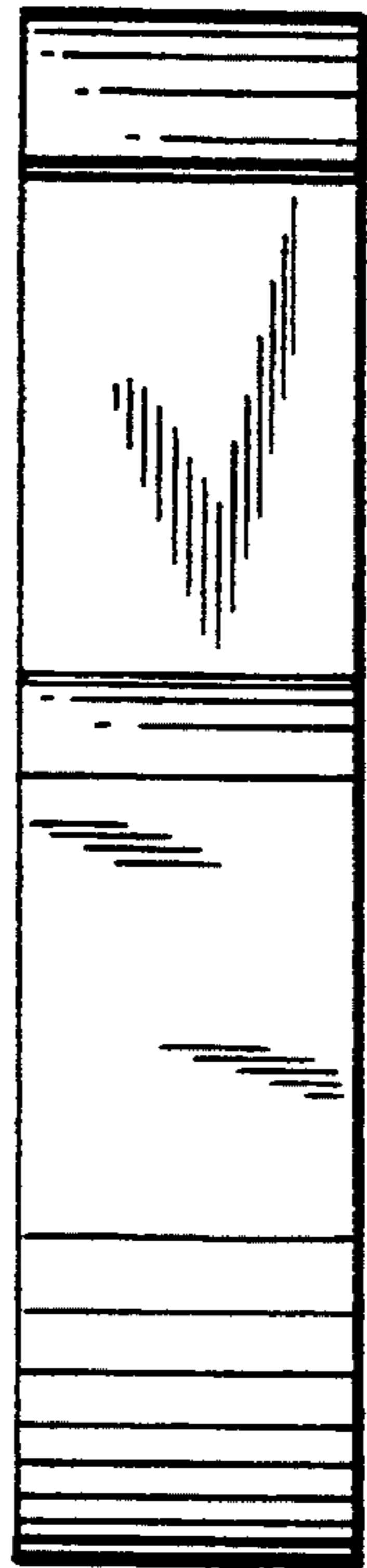

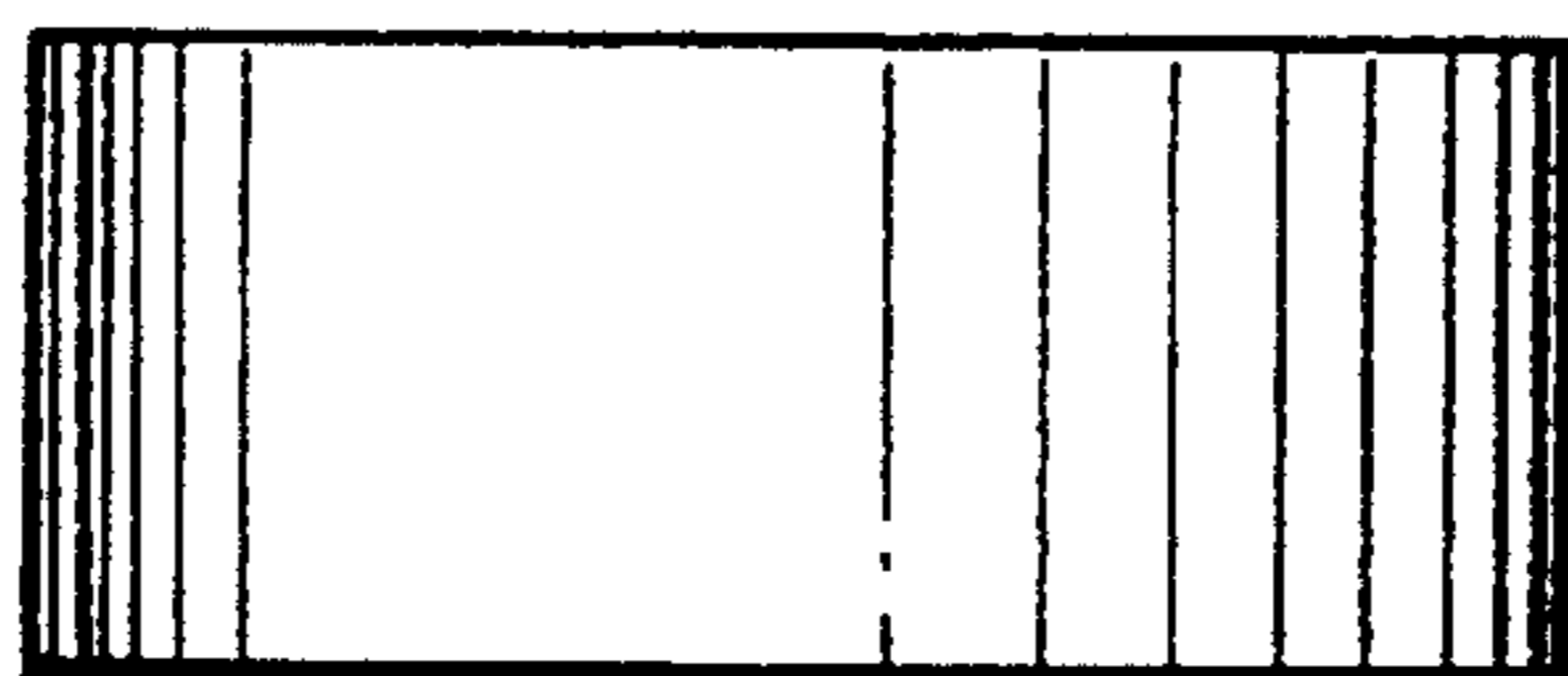

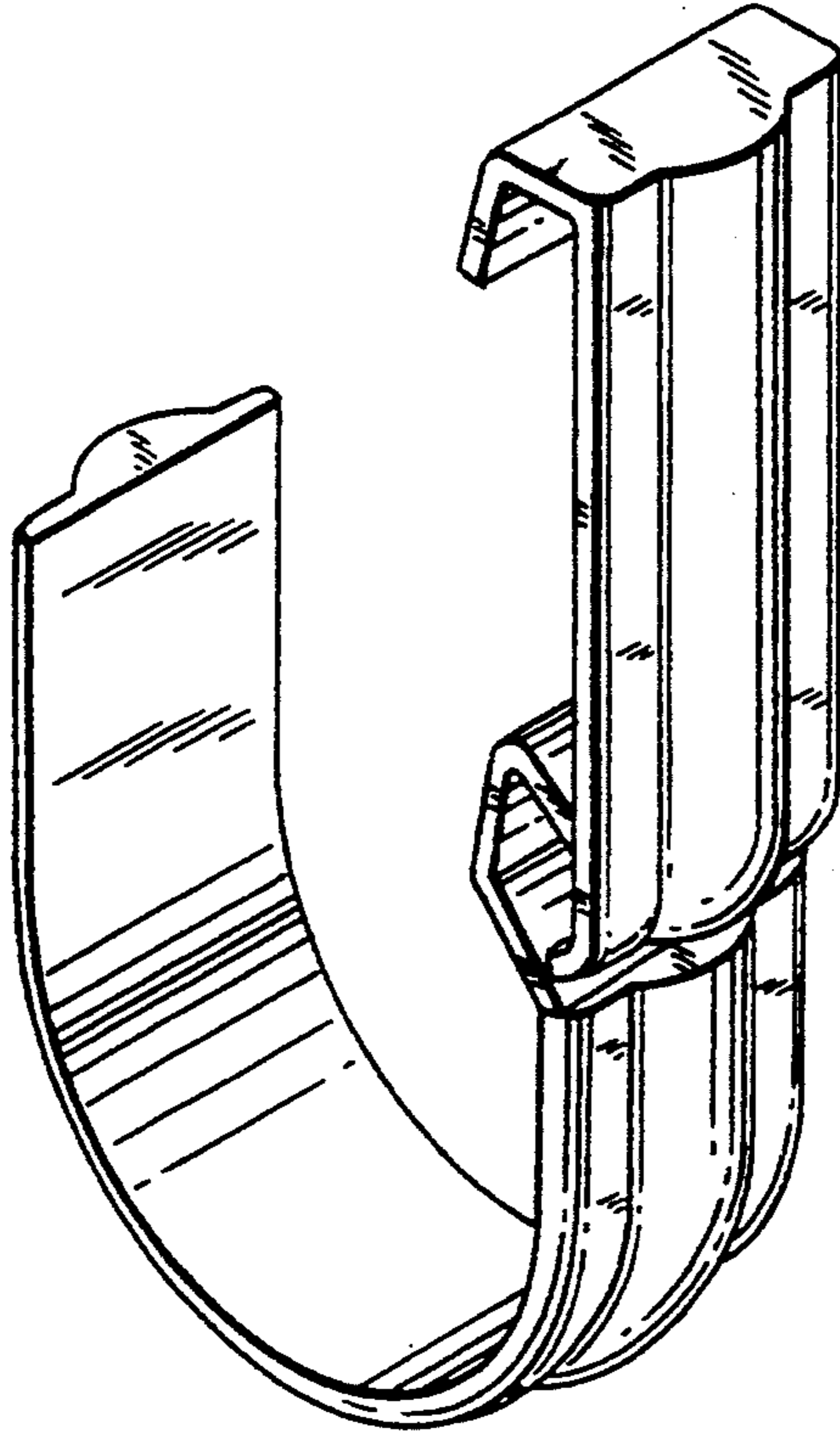

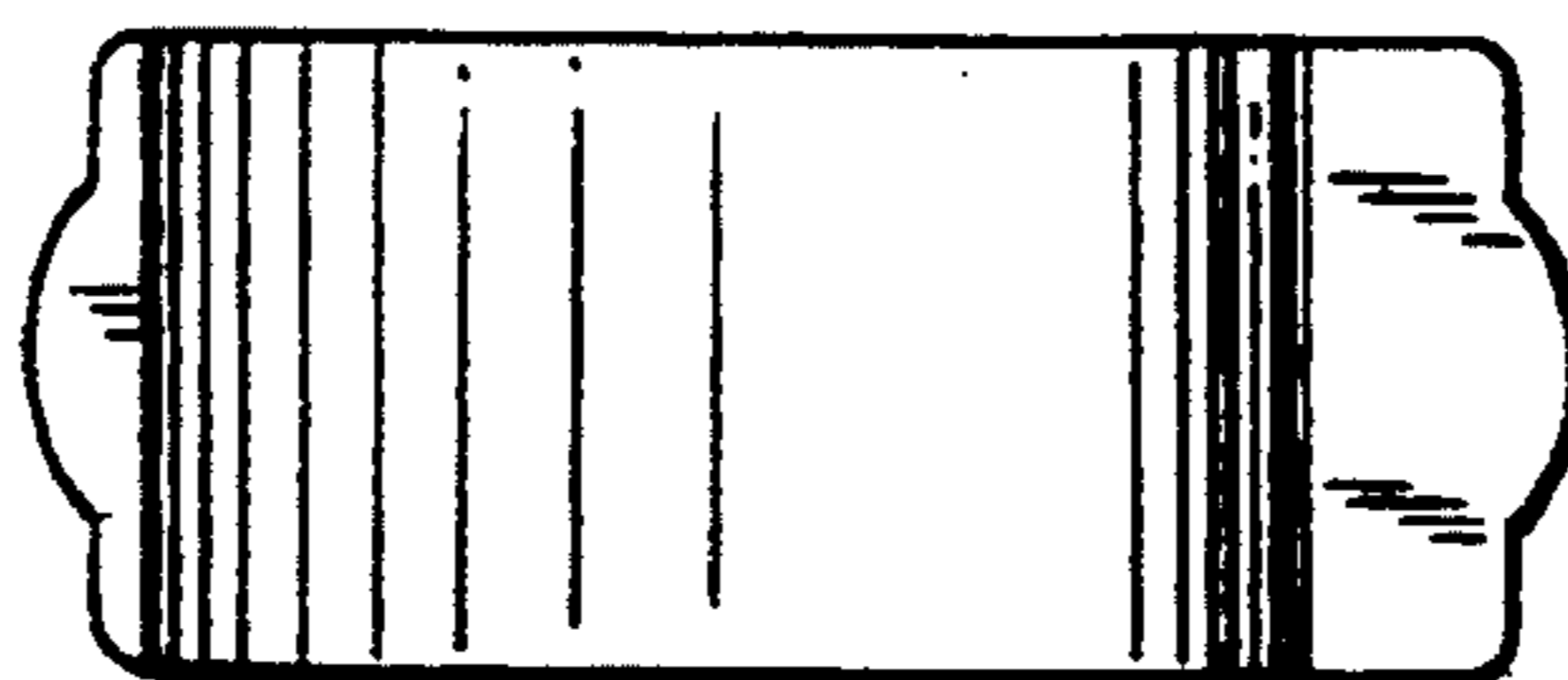

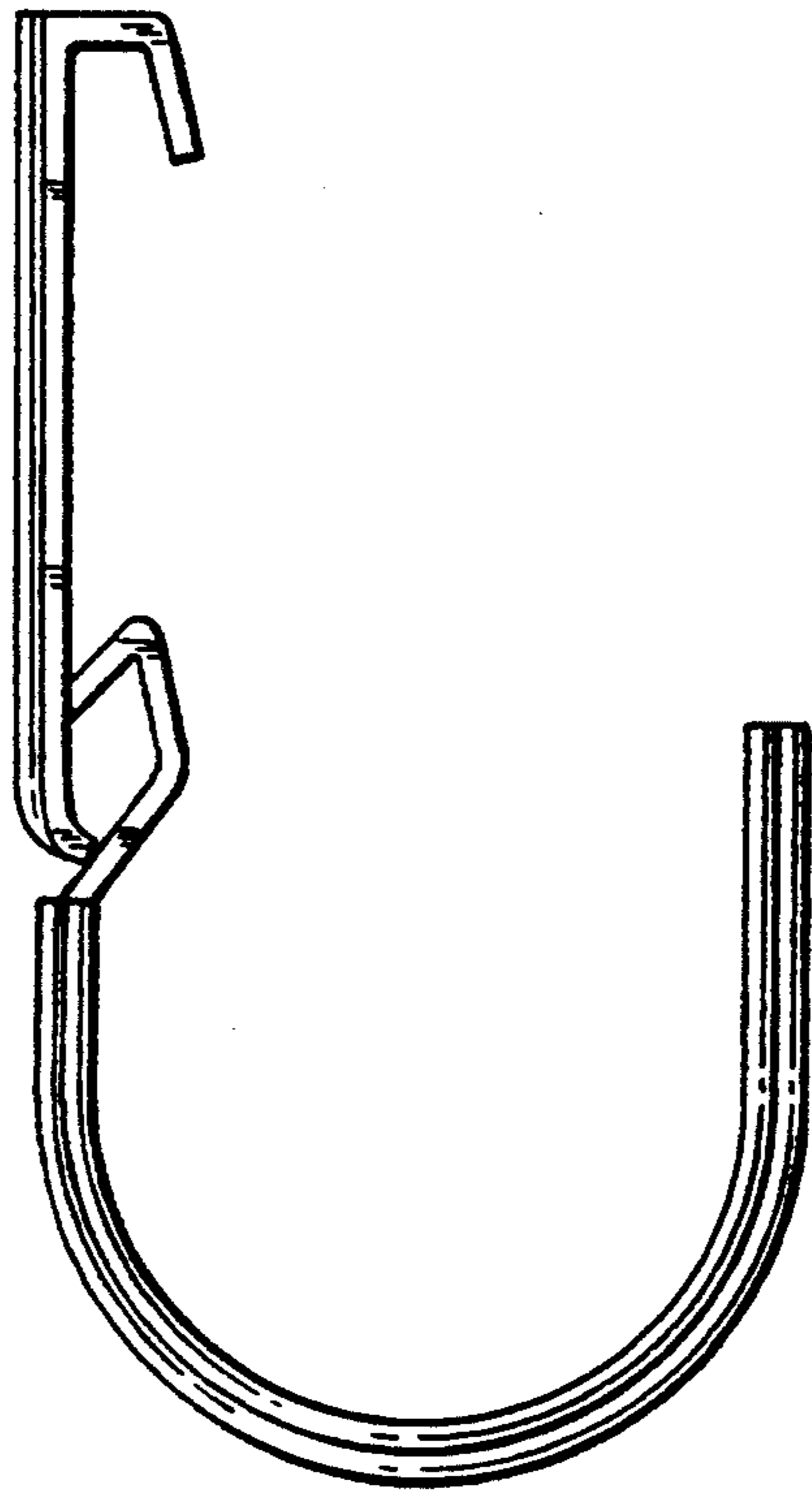

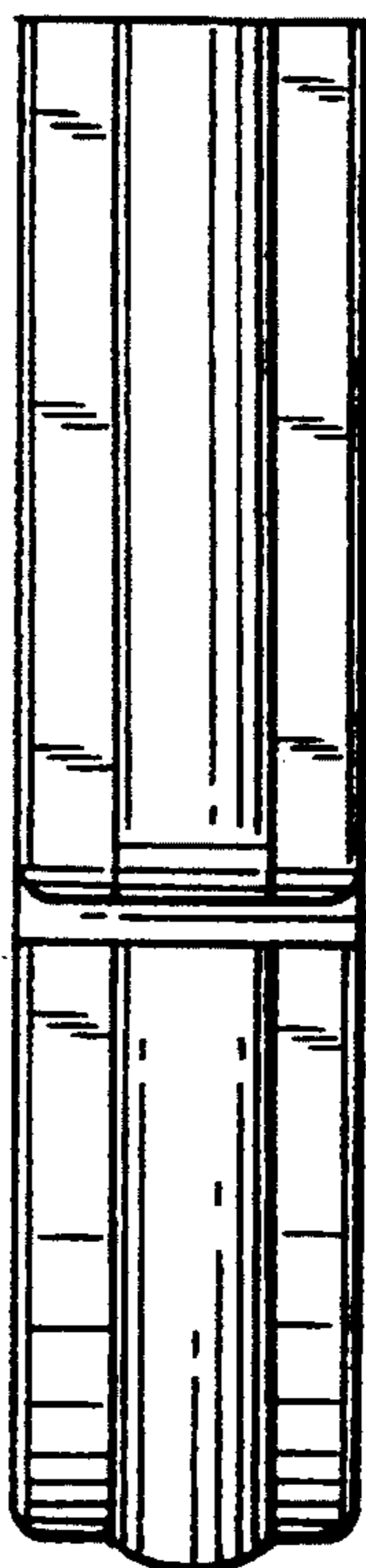

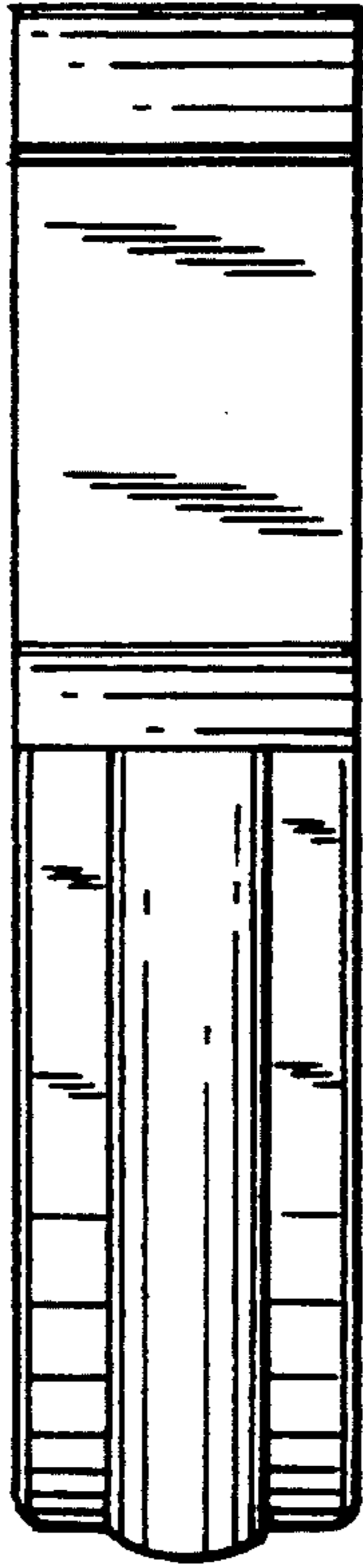

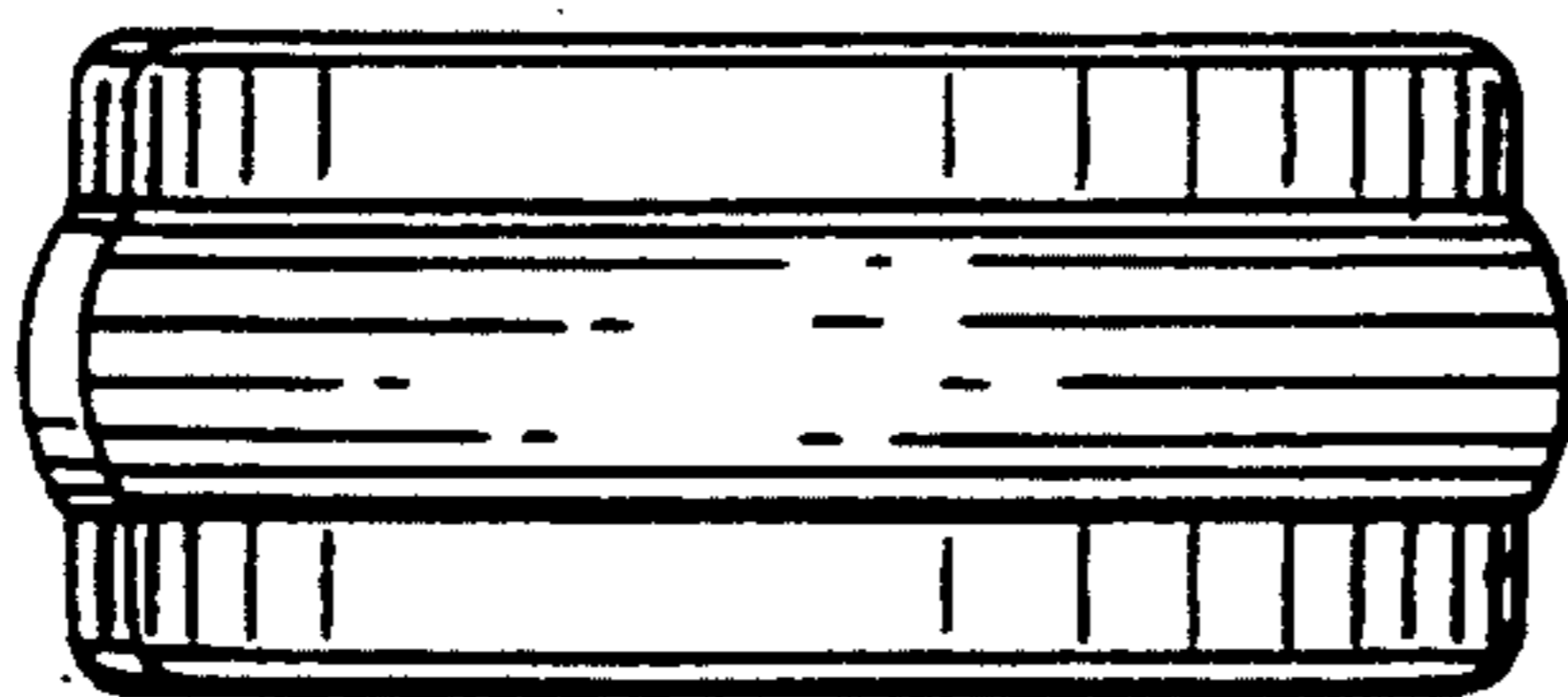

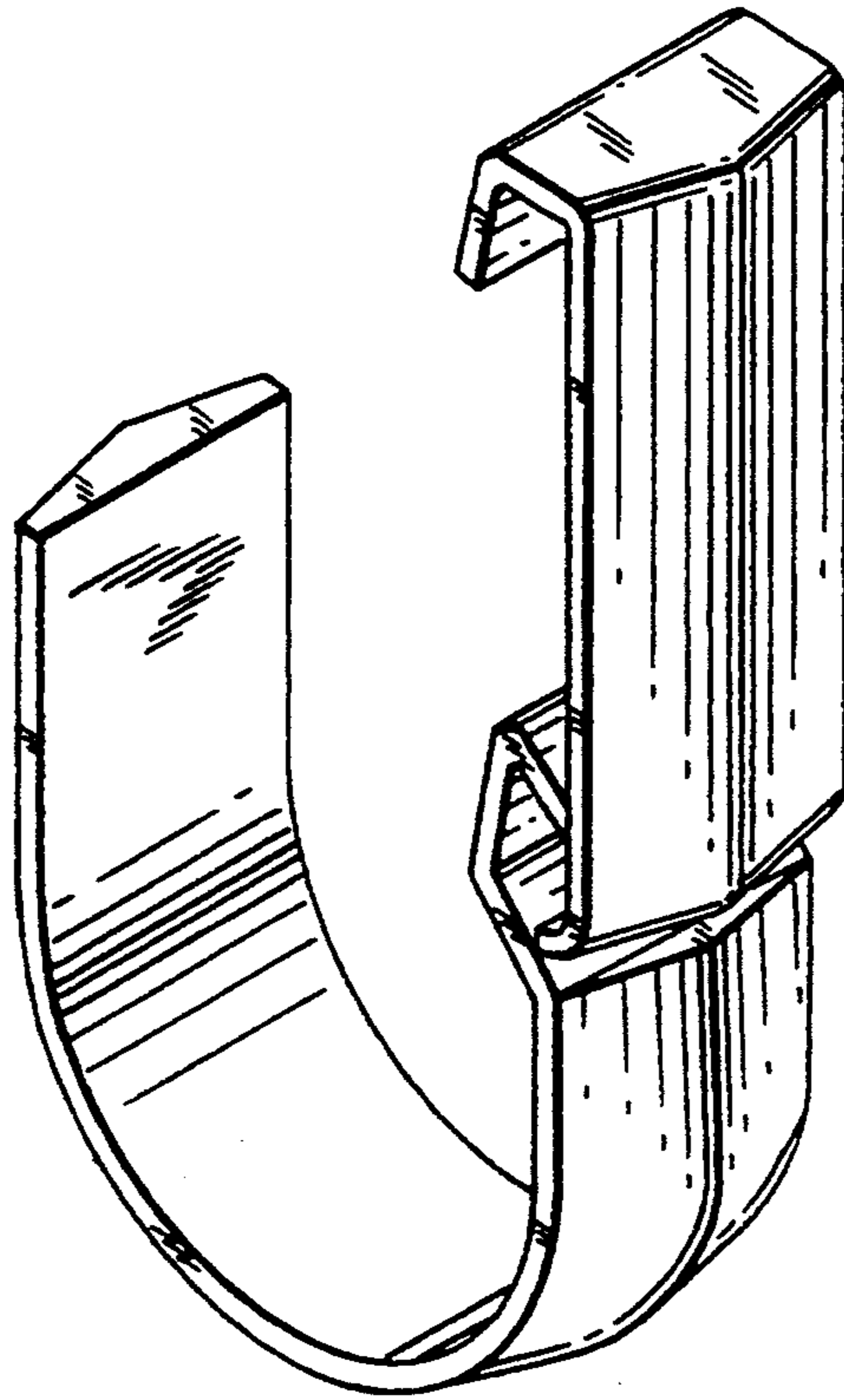

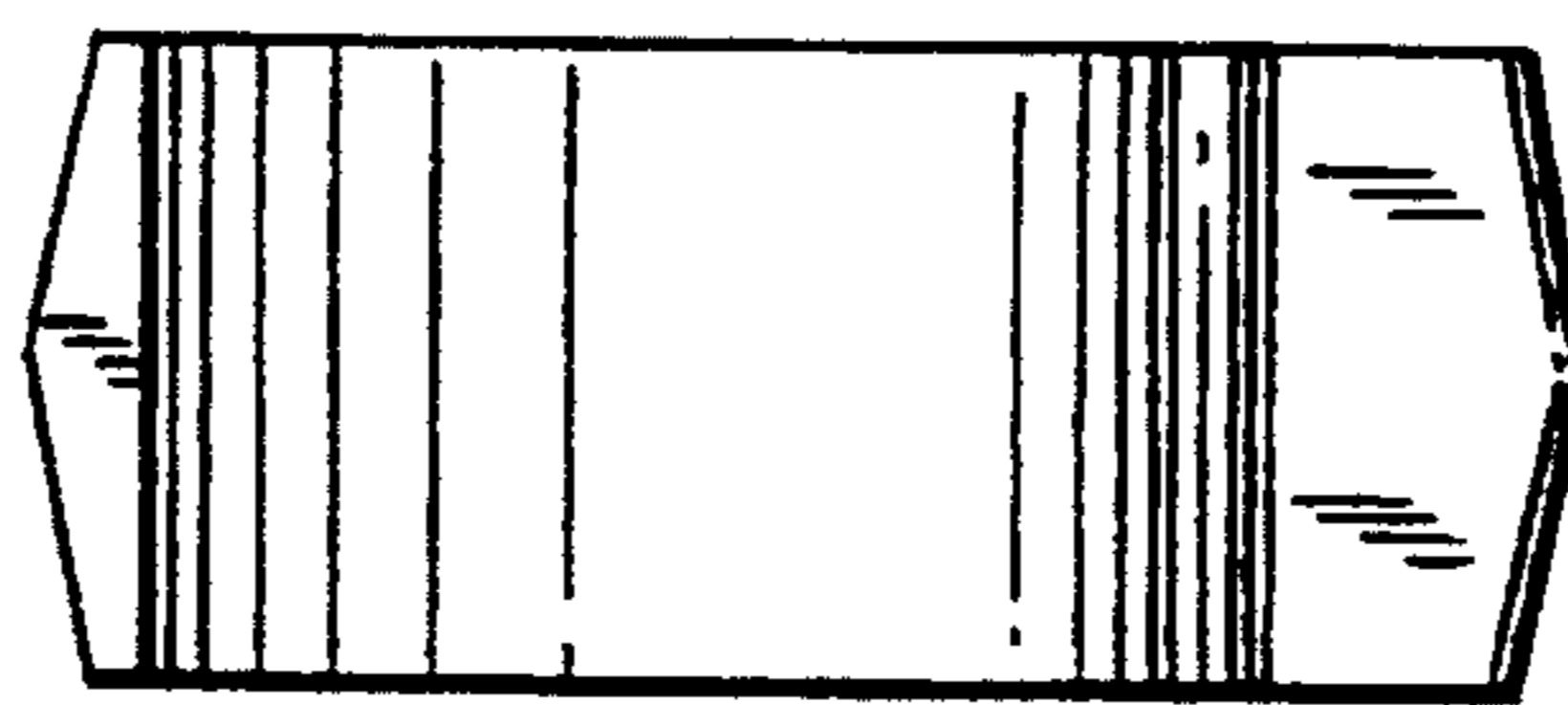

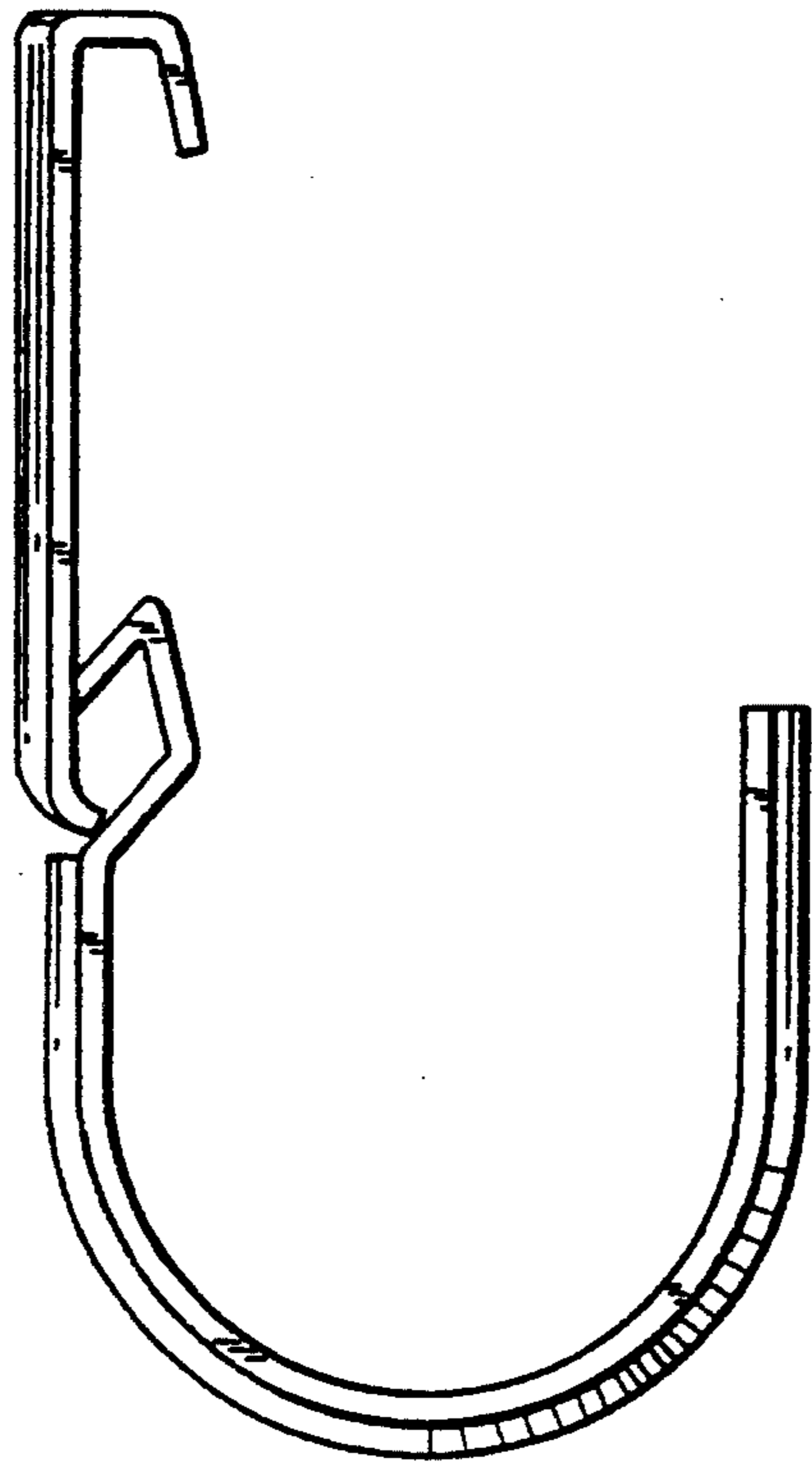

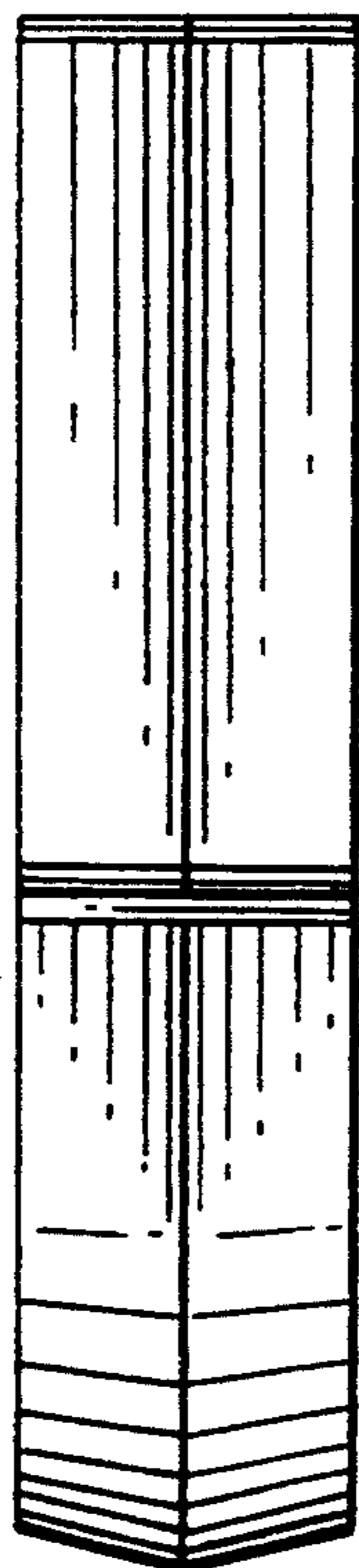

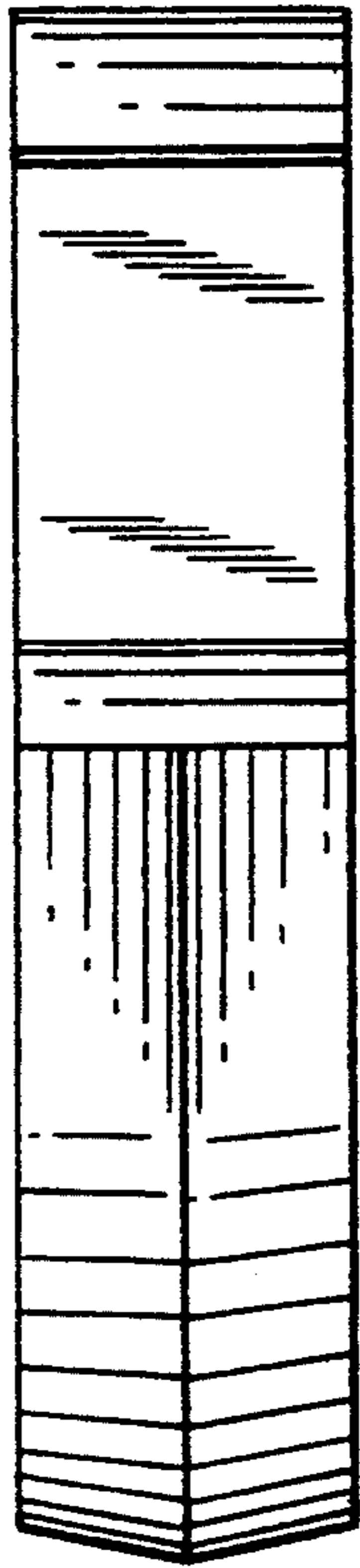




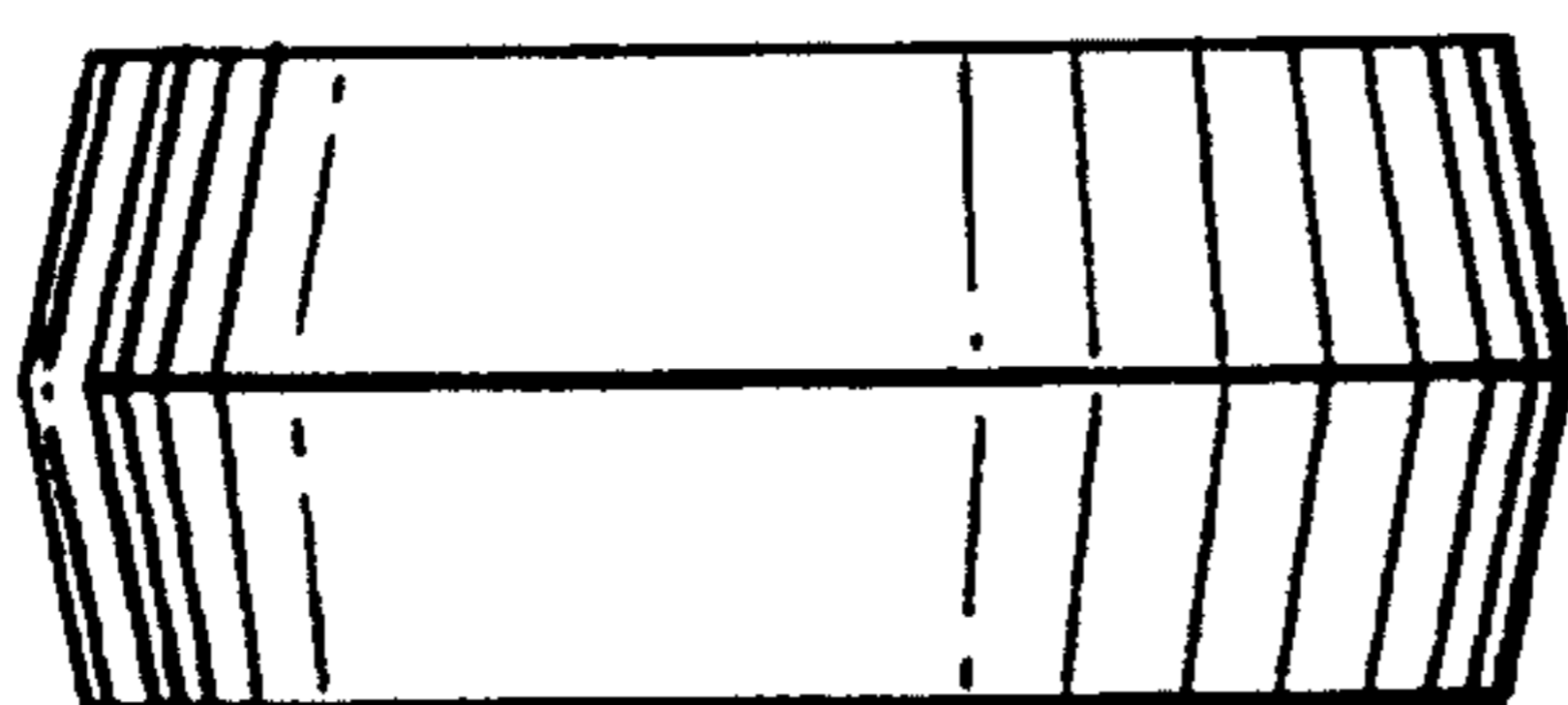
