[57] CLAIM

The ornamental design for a sports car body, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a sports car body showing our new design;

FIG. 2 is a perspective view of the front and one side thereof;

FIG. 3 is a side view therof, it being understood that the opposite side is a mirror image of that shown;

FIG. 4 is a perspective view of the rear and one side thereof;

FIG. 5 is a rear view thereof;

FIG. 6 is a top perspective view thereof with the side doors in open condition;

FIG. 7 is an enlarged fragmentary side perspective view thereof with the side door in open condition;

FIG. 8 is a rear perspective view of FIG. 7;

FIG. 9 is a greatly enlarged fragmentary side view thereof showing the door handle in greater detail;

FIG. 10 is a greatly enlarged fragmentary view of the side opposite to that shown in FIG. 3 showing the lower scoop in greater detail;

FIG. 11 is an enlarged fragmentary view of the lower front end thereof in greater detail;


FIG. 12 is an enlarged fragmentary view of the lower rear end thereof in greater detail;


FIG. 13 is a greatly enlarged fragmentary front view thereof showing the headlight in greater detail;

The broken line showing of environmental structure in the drawings is for illustrative purposes only and forms no part of the claimed design.

























