FIG. 1 is a front elevational view of an image forming apparatus showing my new design;

FIG. 7 is a perspective view thereof.

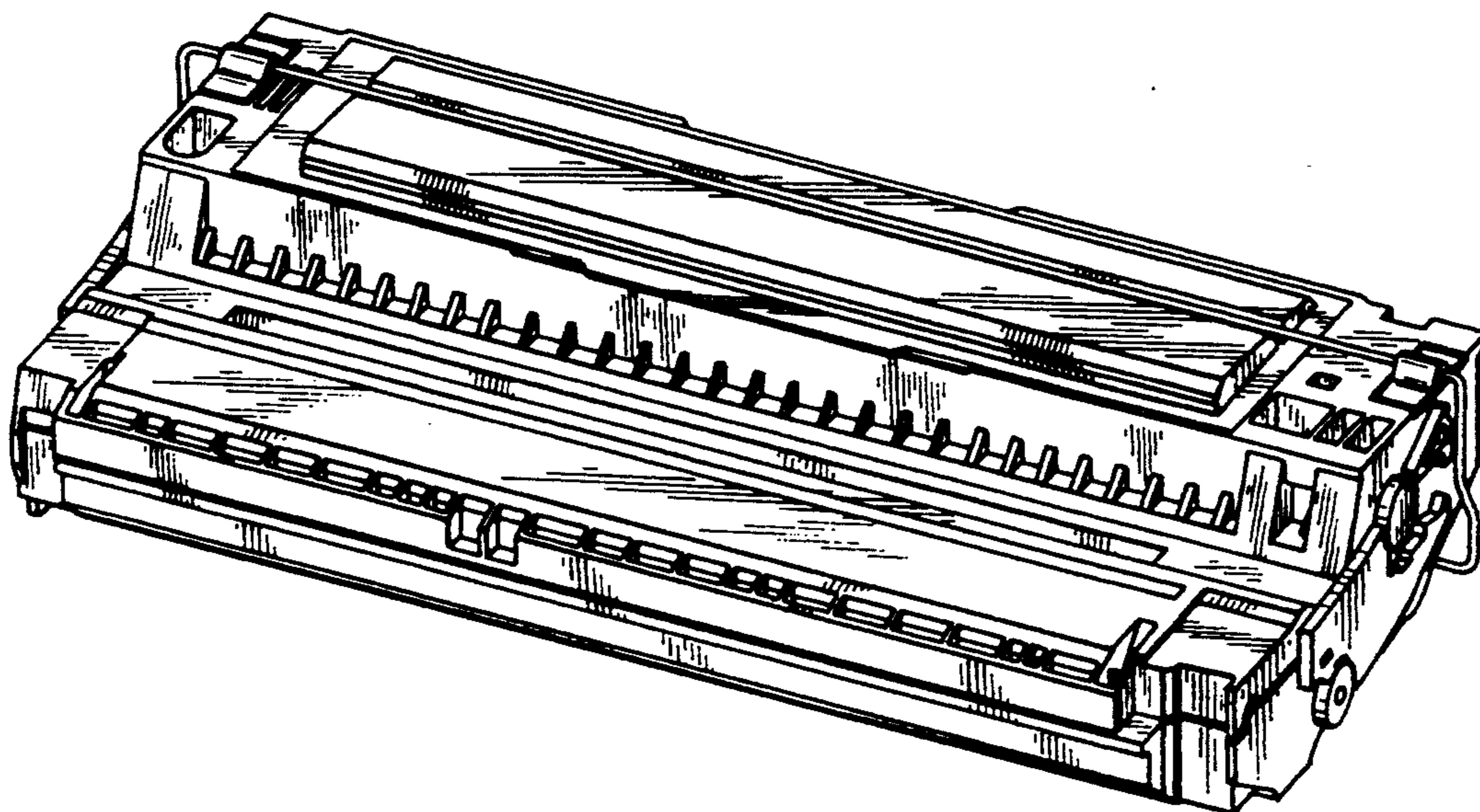

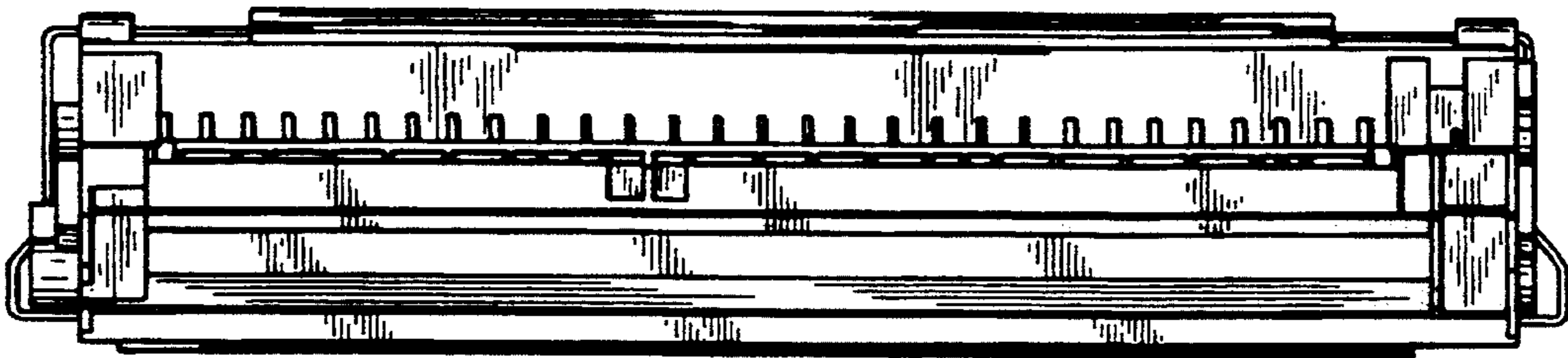

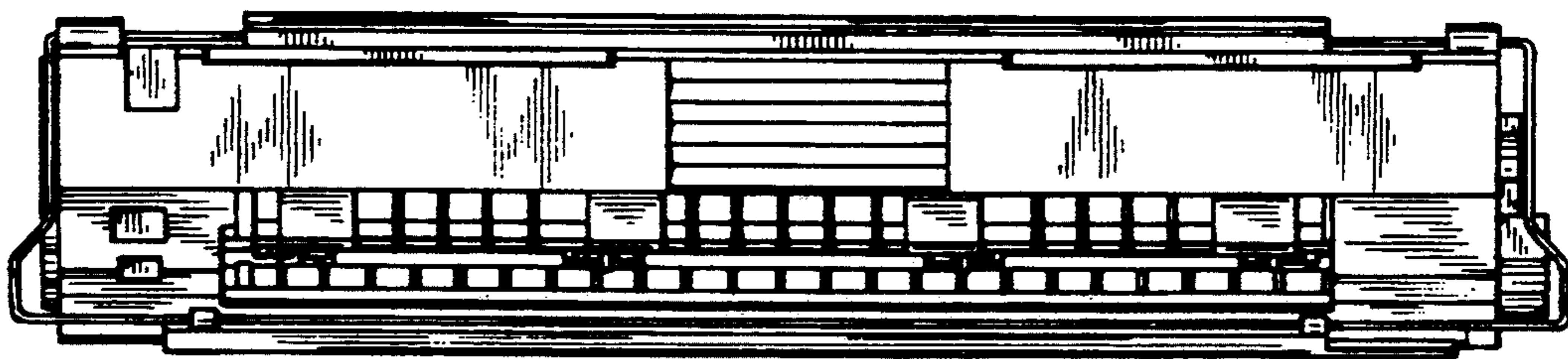

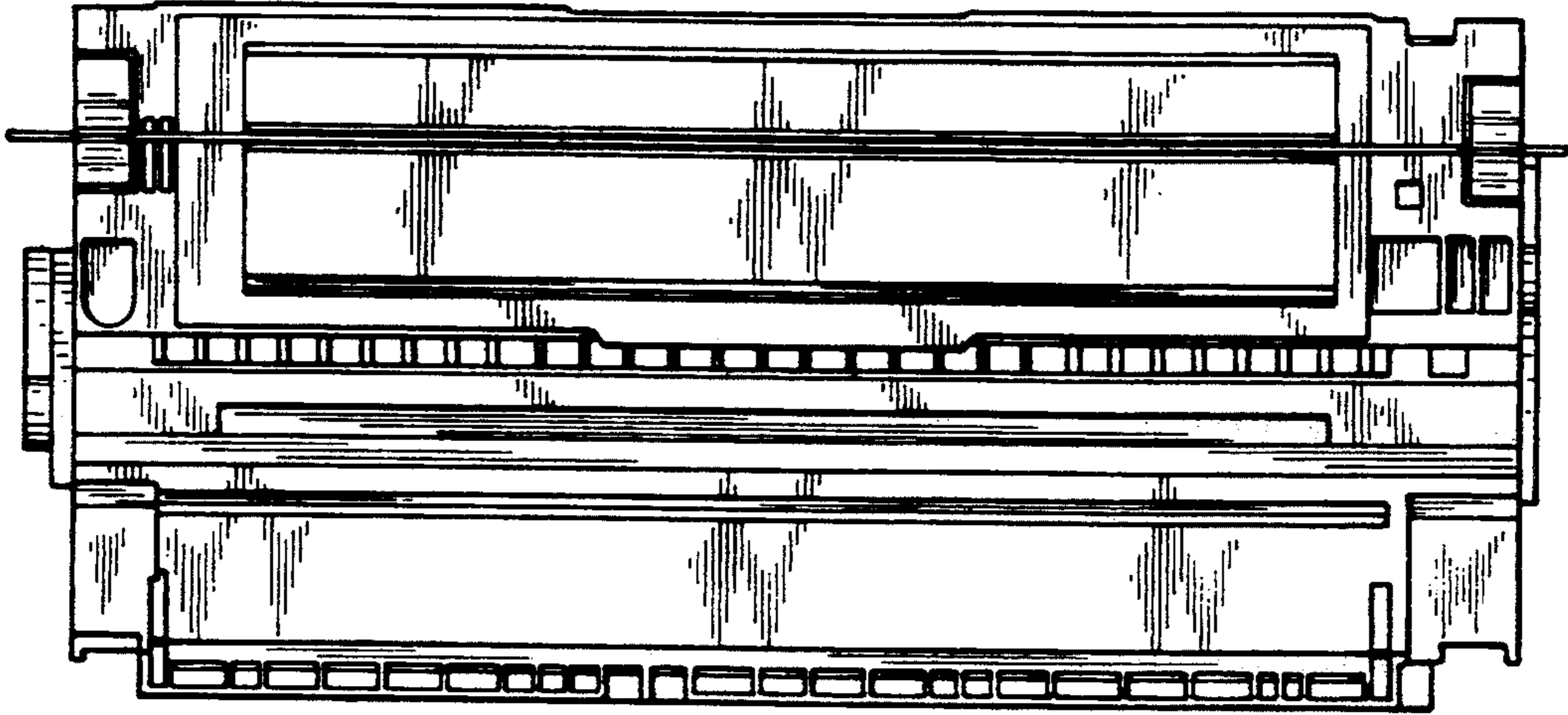

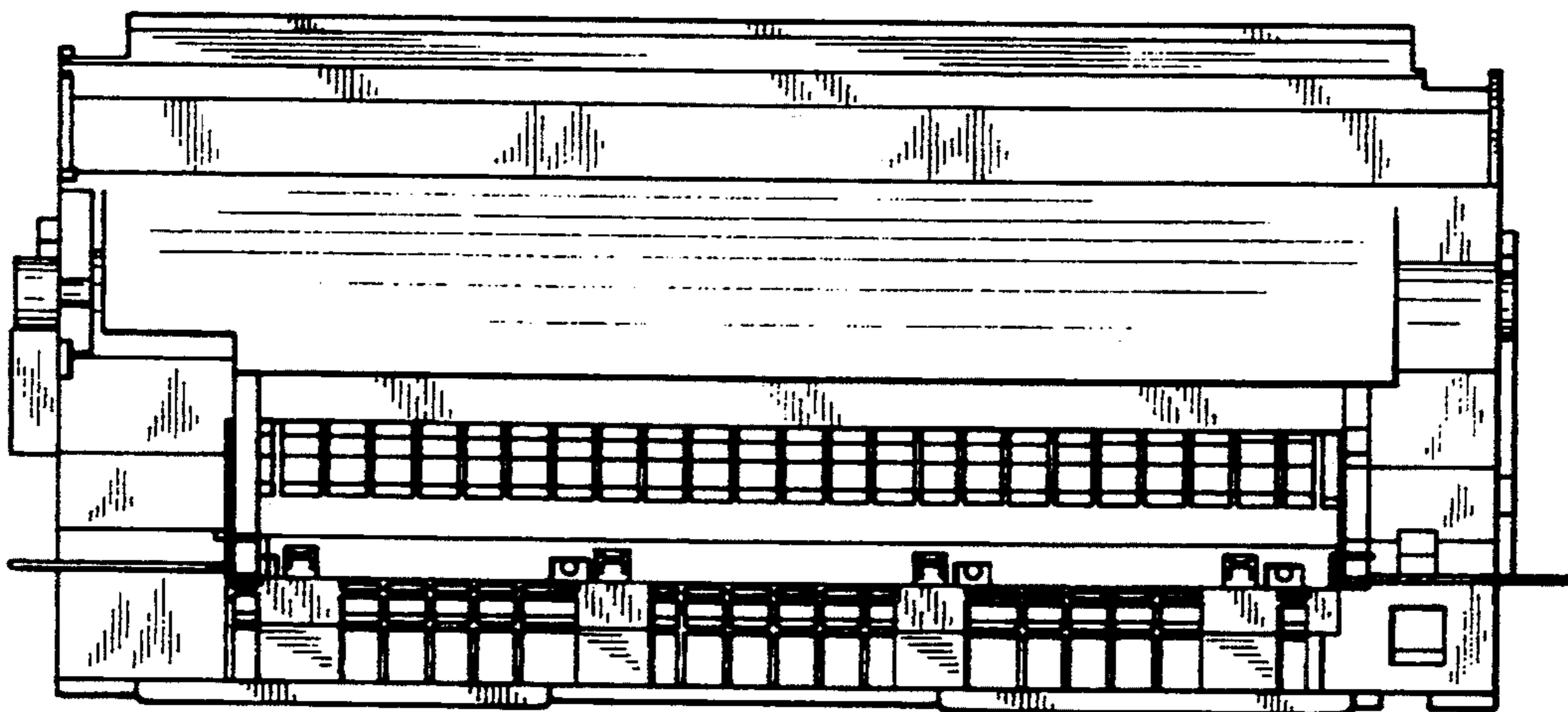

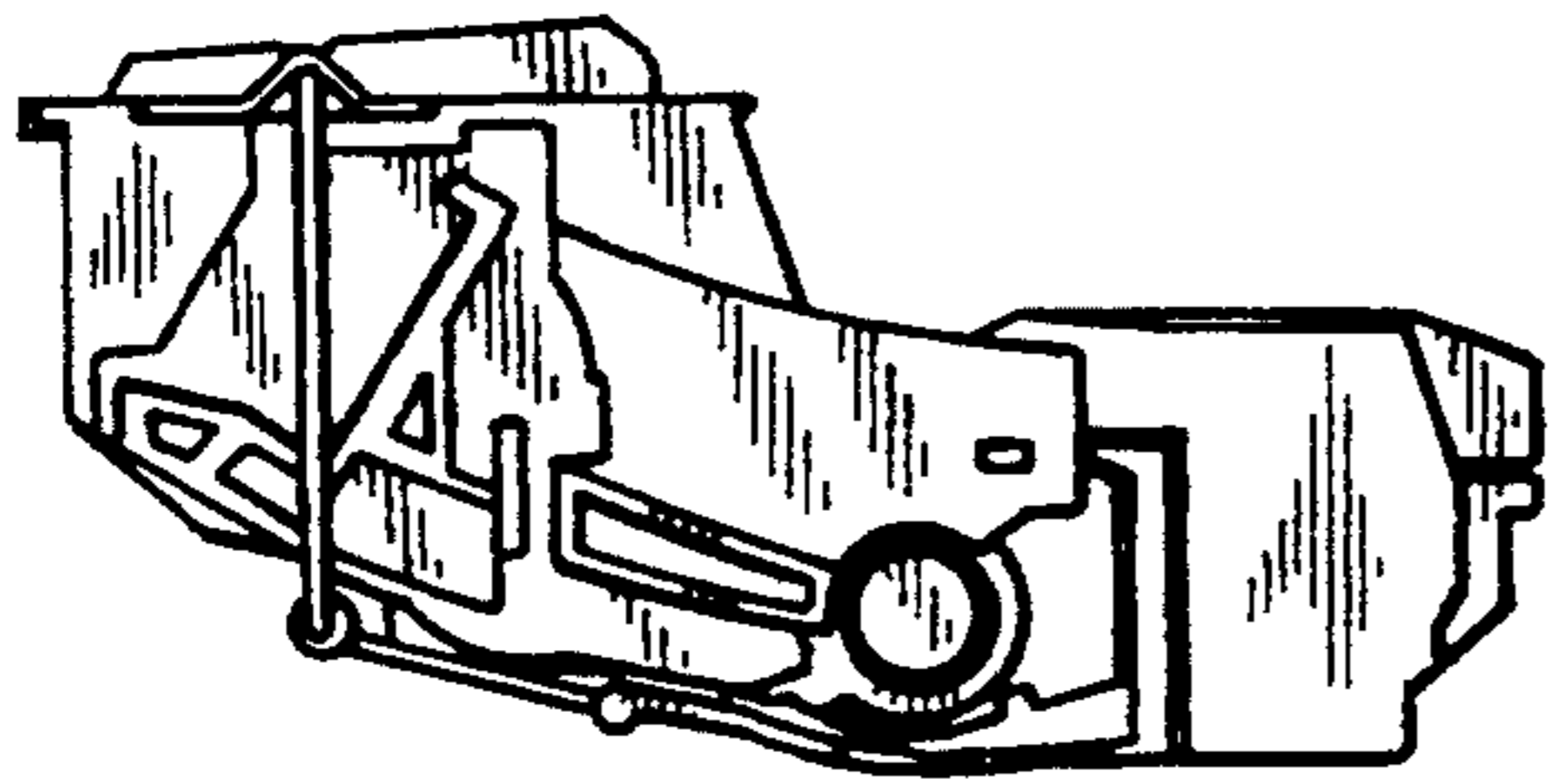

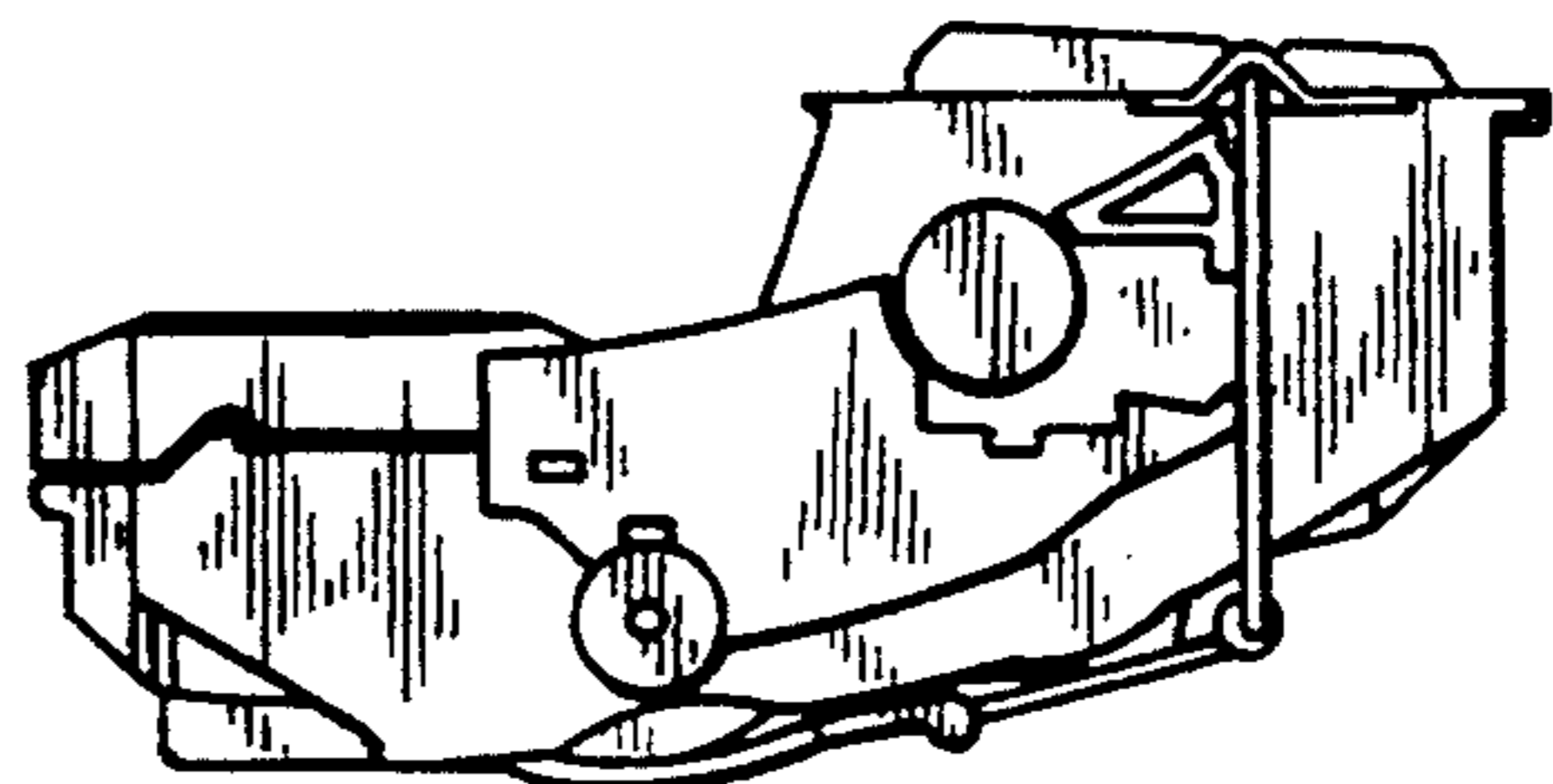
