FIG. 2 is a side perspective view thereof;

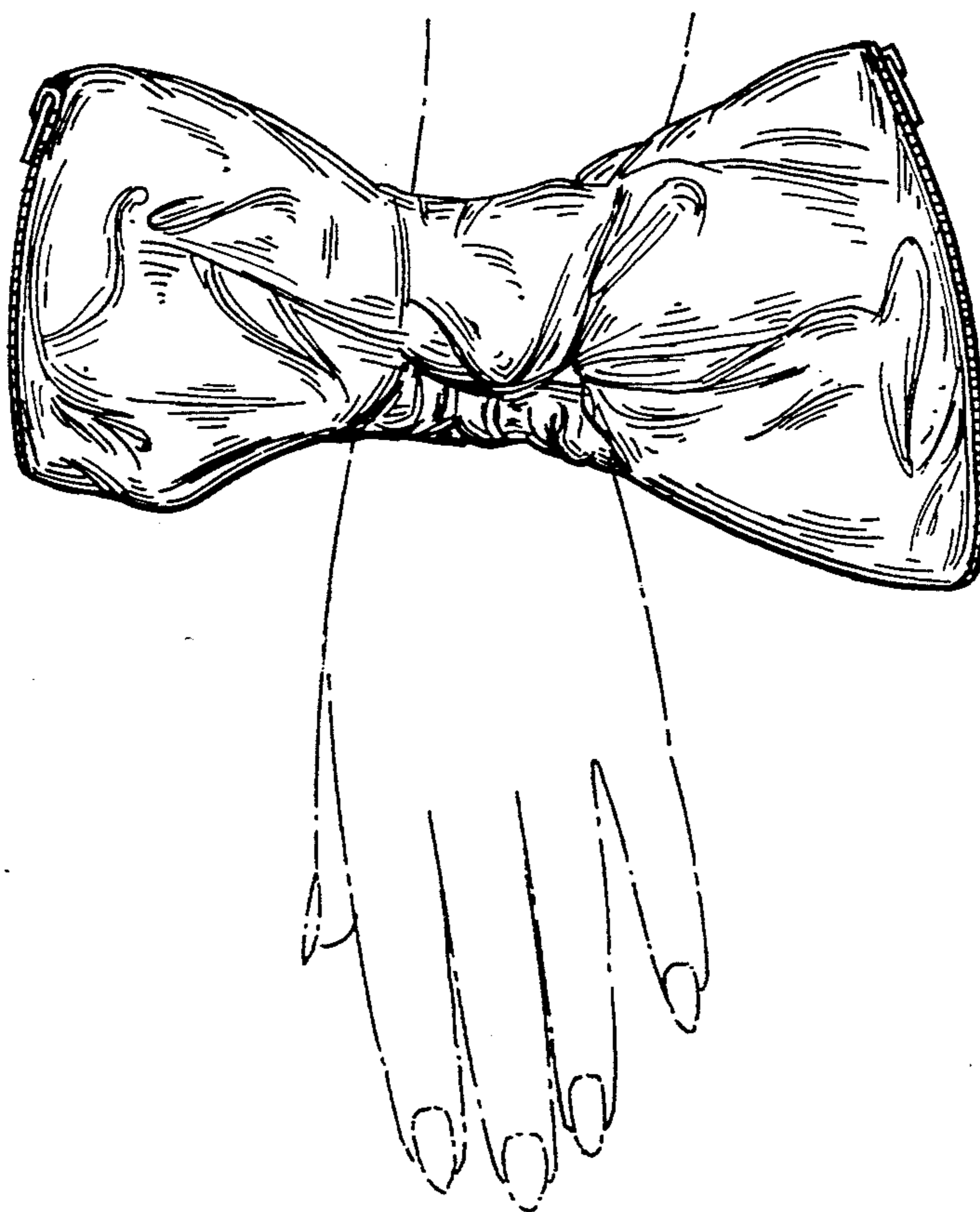
FIG. 3 is a front elevational view thereof;

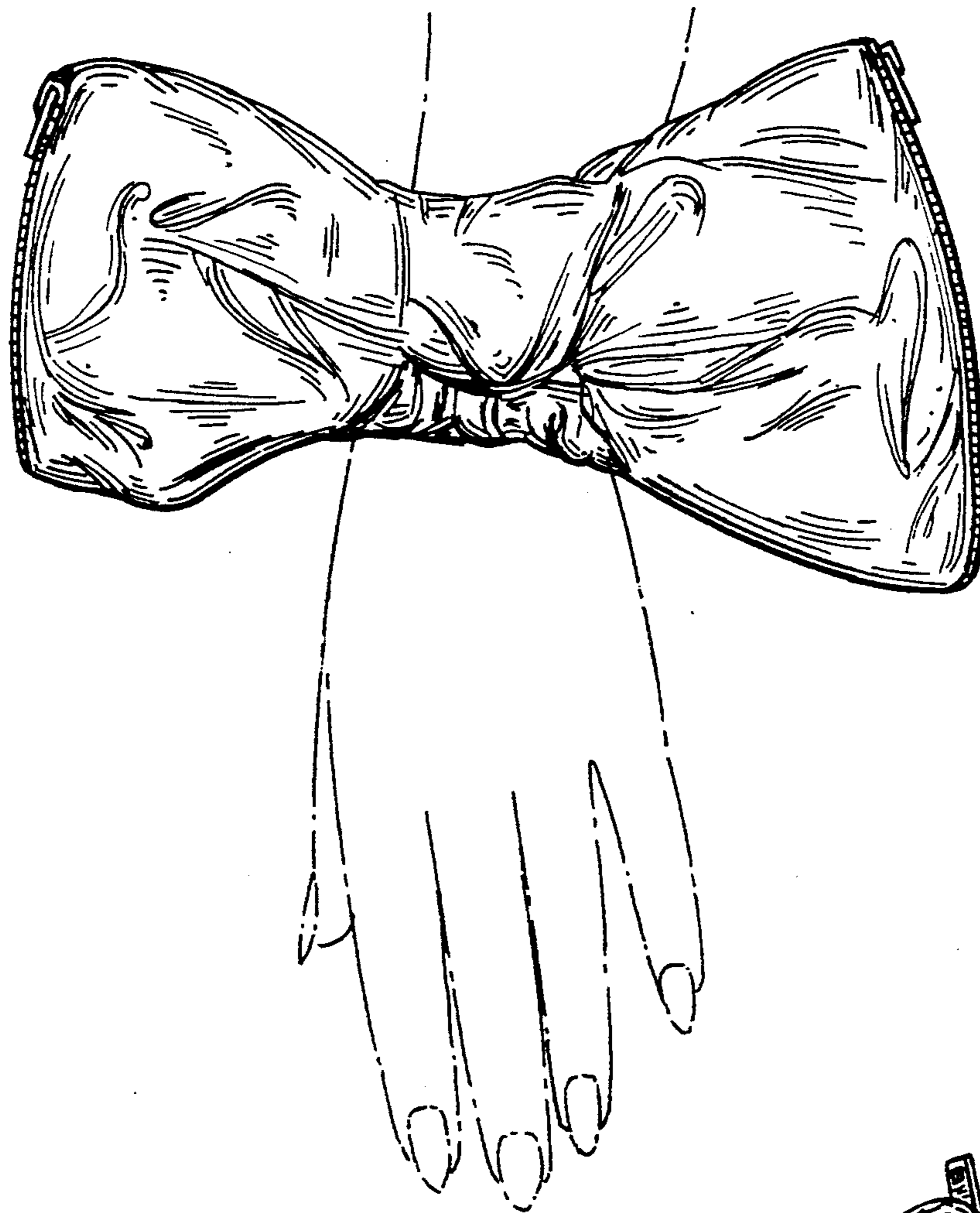
FIG. 4 is a side elevational view thereof; the opposite side elevational view is a mirror image;

FIG. 5 is a top plan view thereof; and,

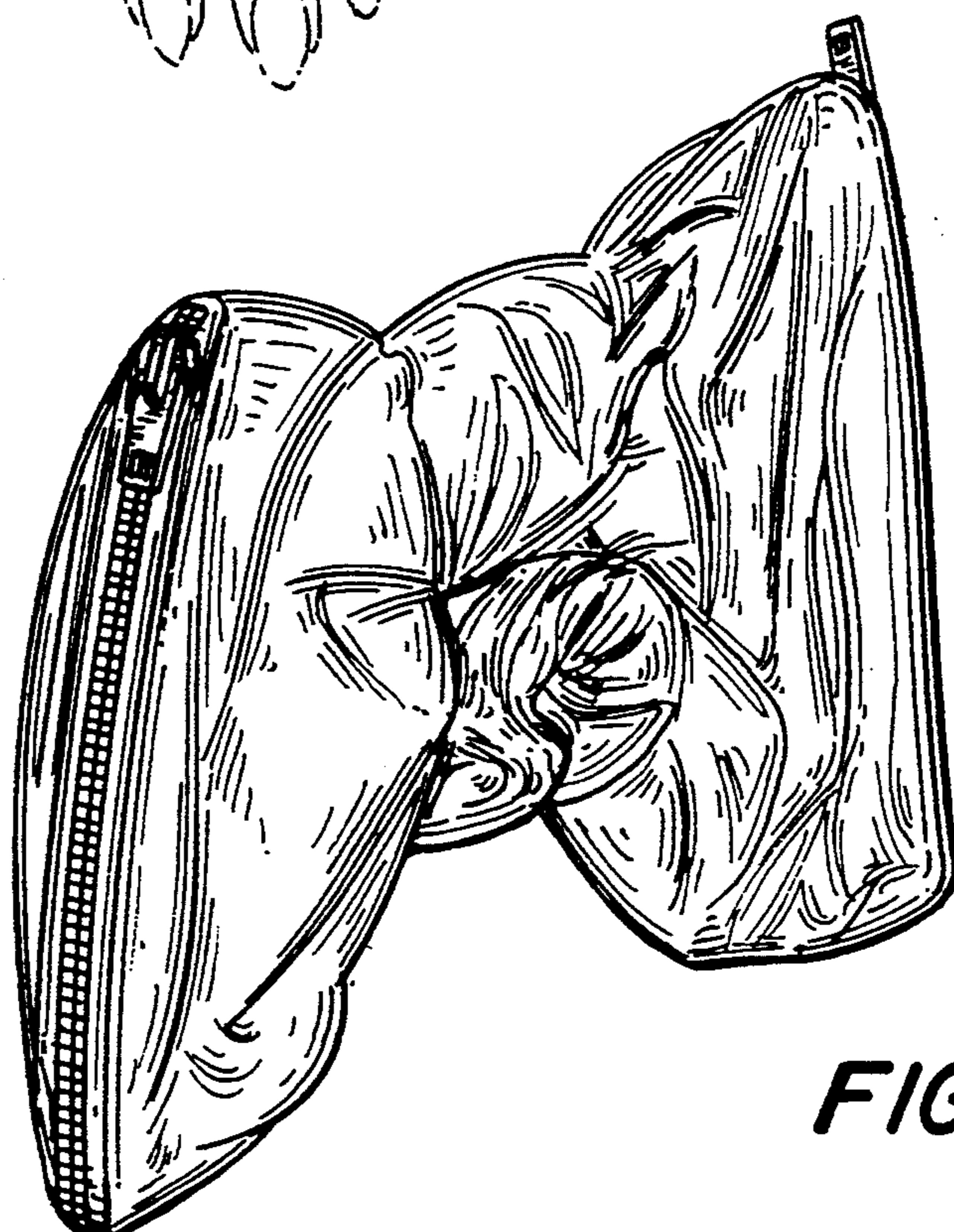
FIG. 6 is a bottom plan view thereof.

The broken line showing of the human form in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.



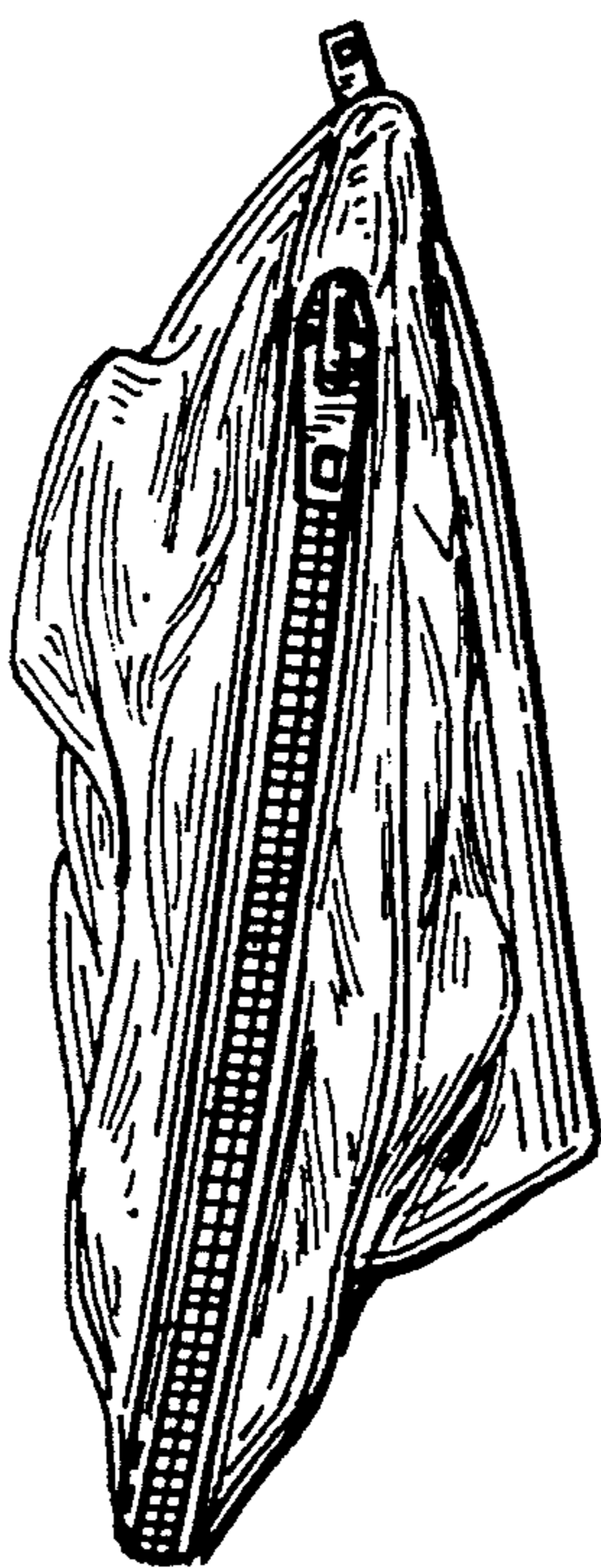
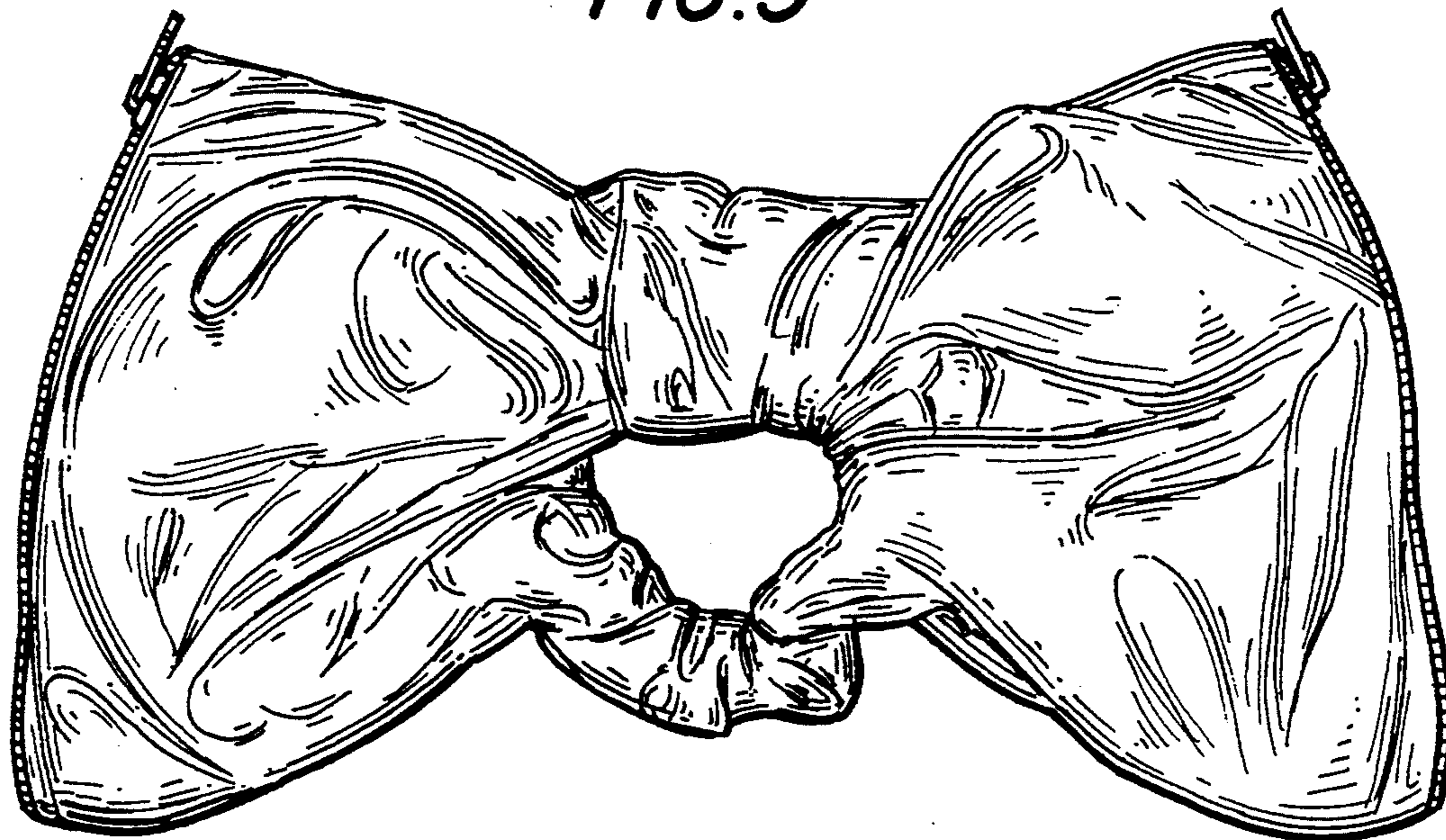
