[57] **CLAIM**

The ornamental design for a swivel chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of the swivel chair of the present invention;

FIG. 2 is a side perspective view of the chair illustrated in FIG. 1, the opposite being a mirror image thereof;

FIG. 3 is a front perspective view of the chair illustrated in FIG. 1;

FIG. 4 is a top view of the chair illustrated in FIG. 1;

FIG. 5 is a rear perspective view of the chair illustrated in FIG. 1;

FIG. 6 is a perspective view of another embodiment of a swivel chair of the present invention;

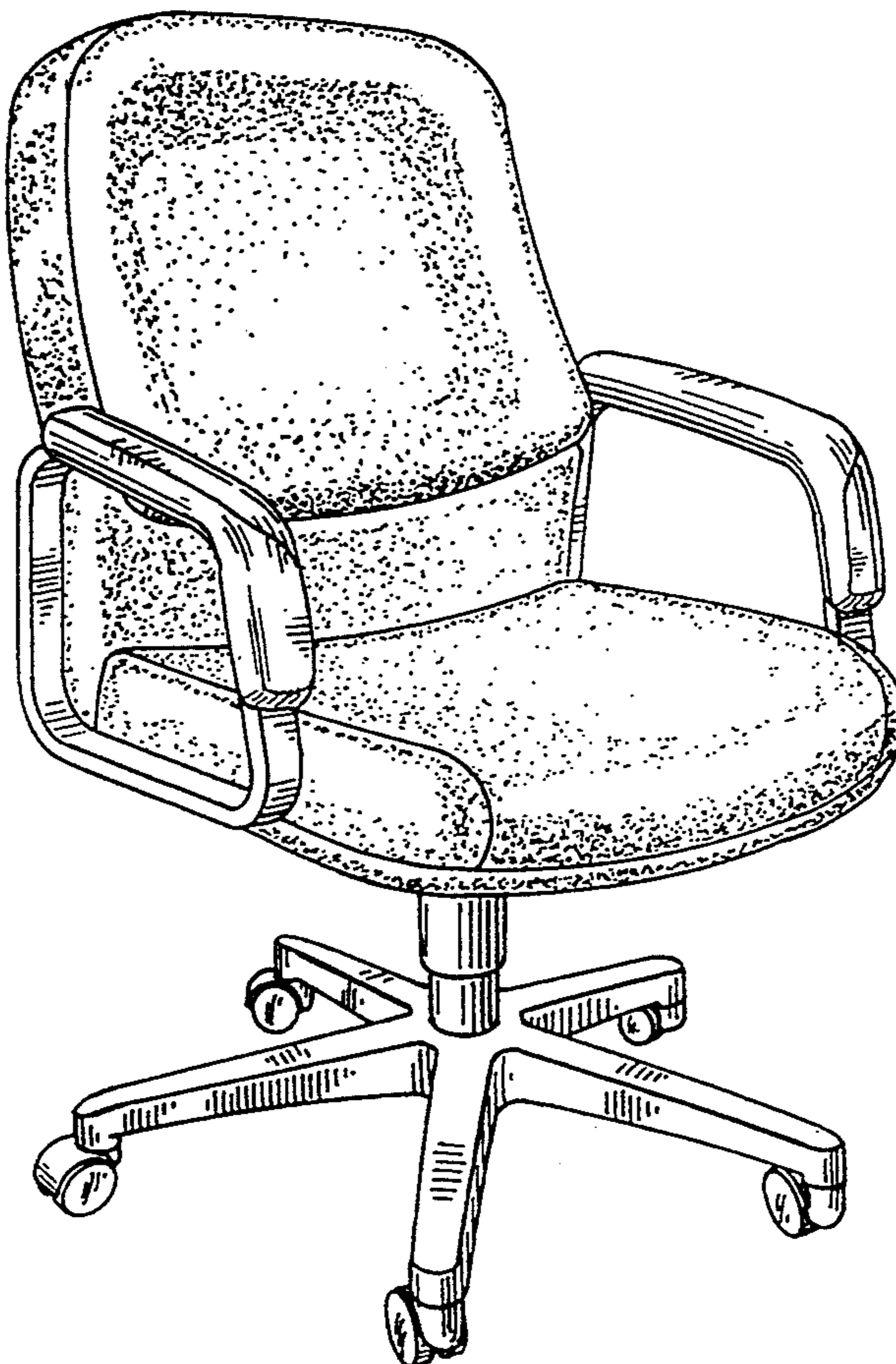
FIG. 7 is a side perspective view of the chair illustrated in FIG. 6, the opposite side being a mirror image thereof;

FIG. 10 is a rear perspective view of the chair illustrated in FIG. 6.



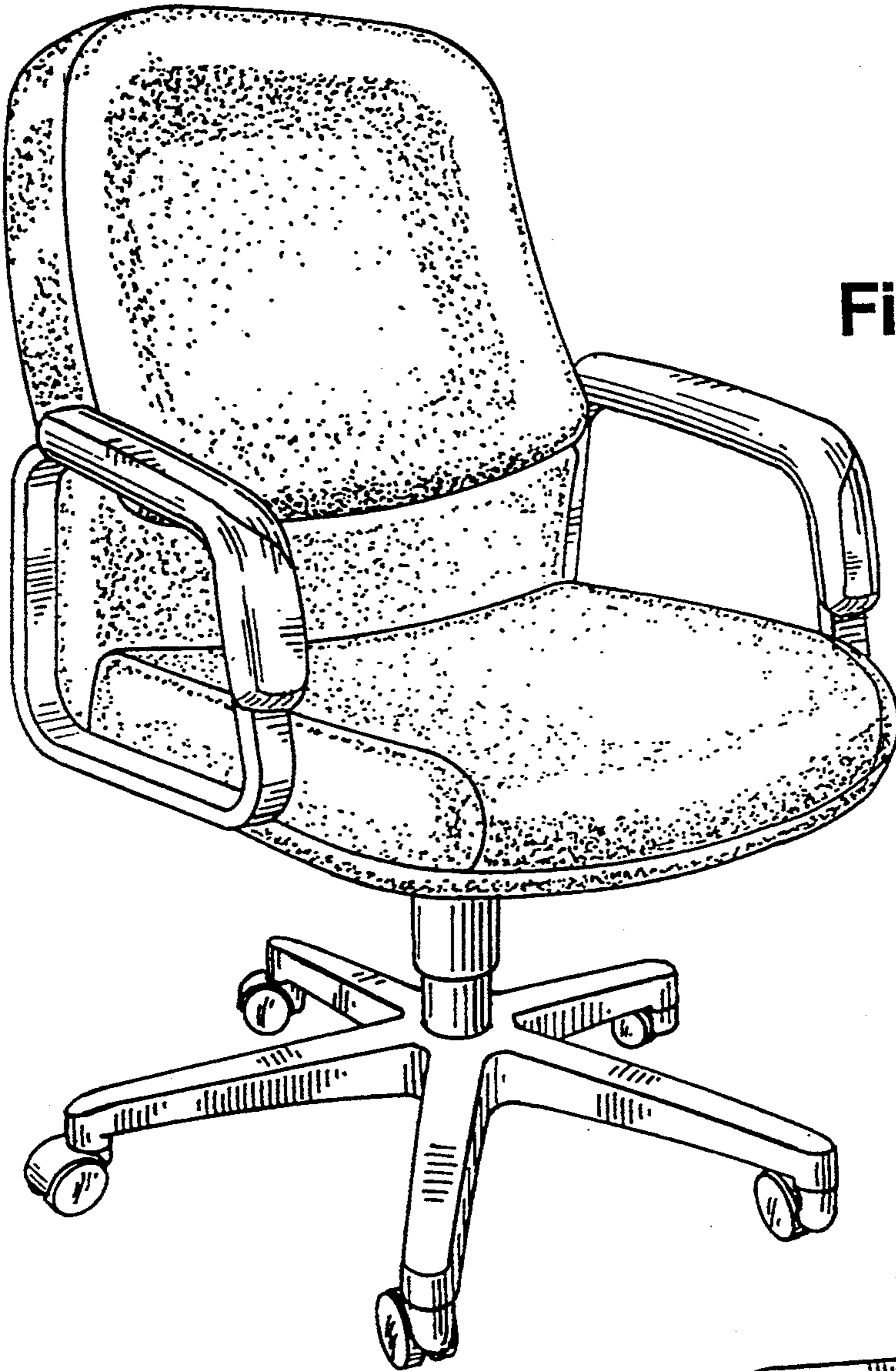

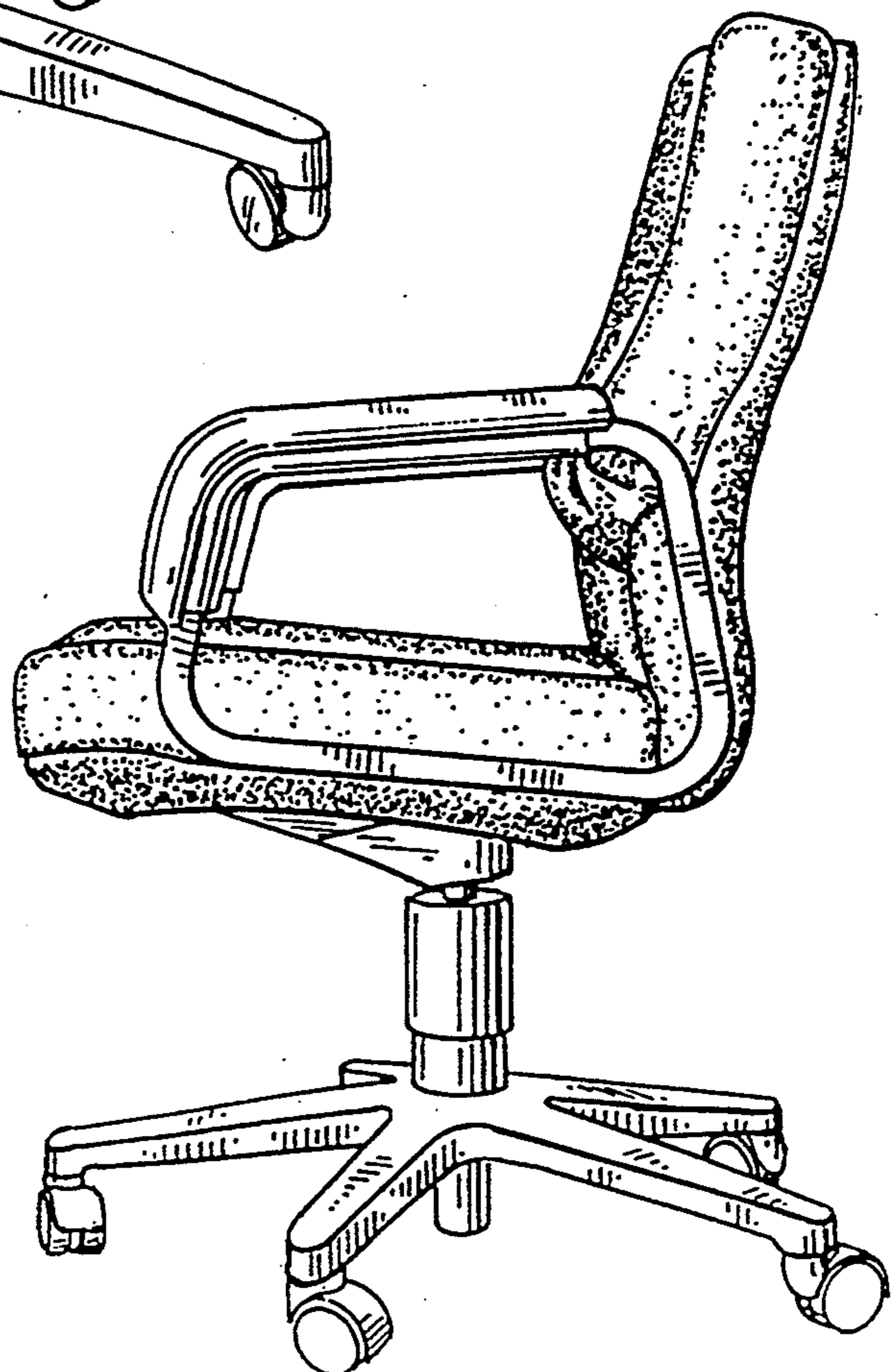

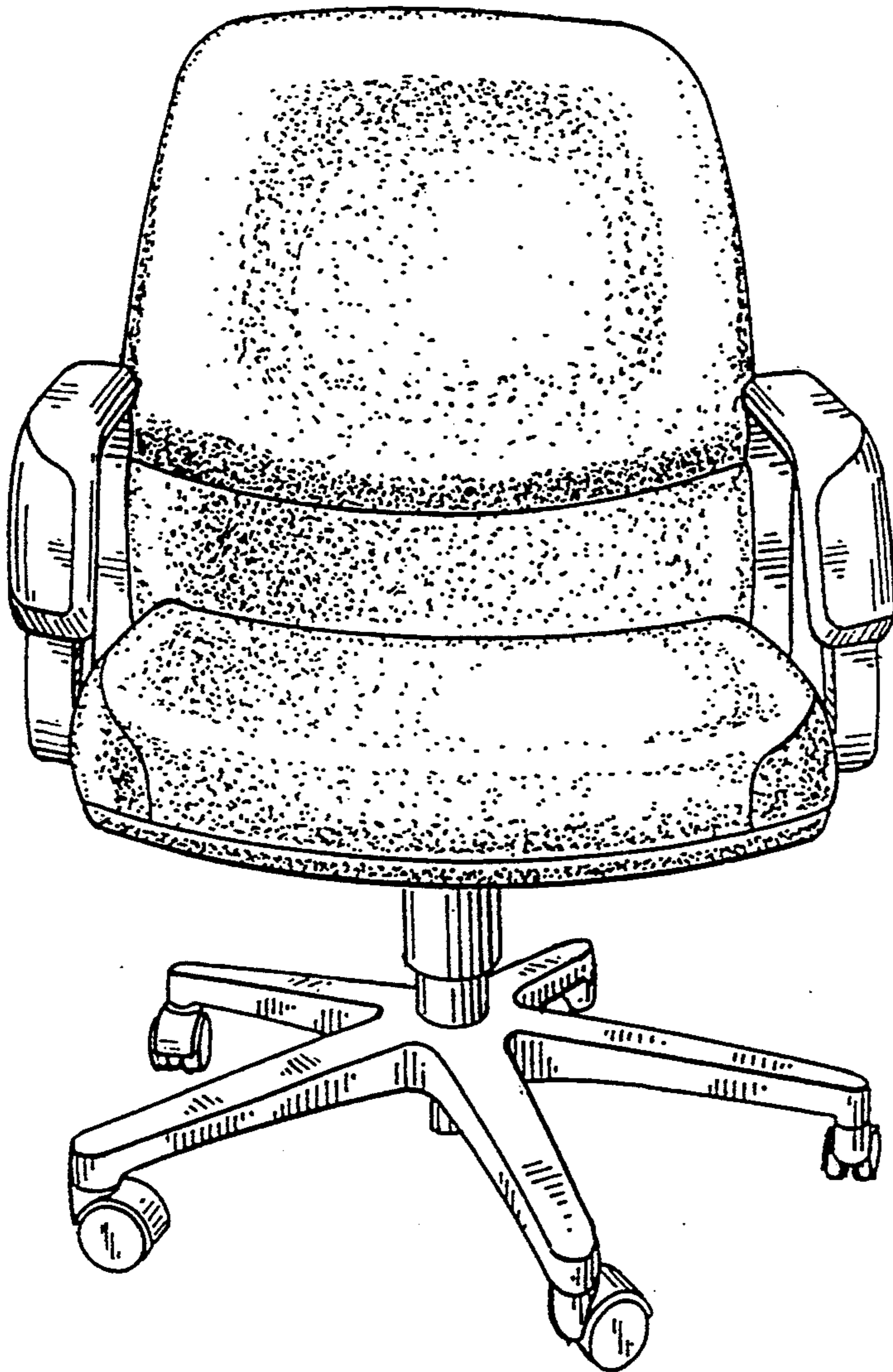

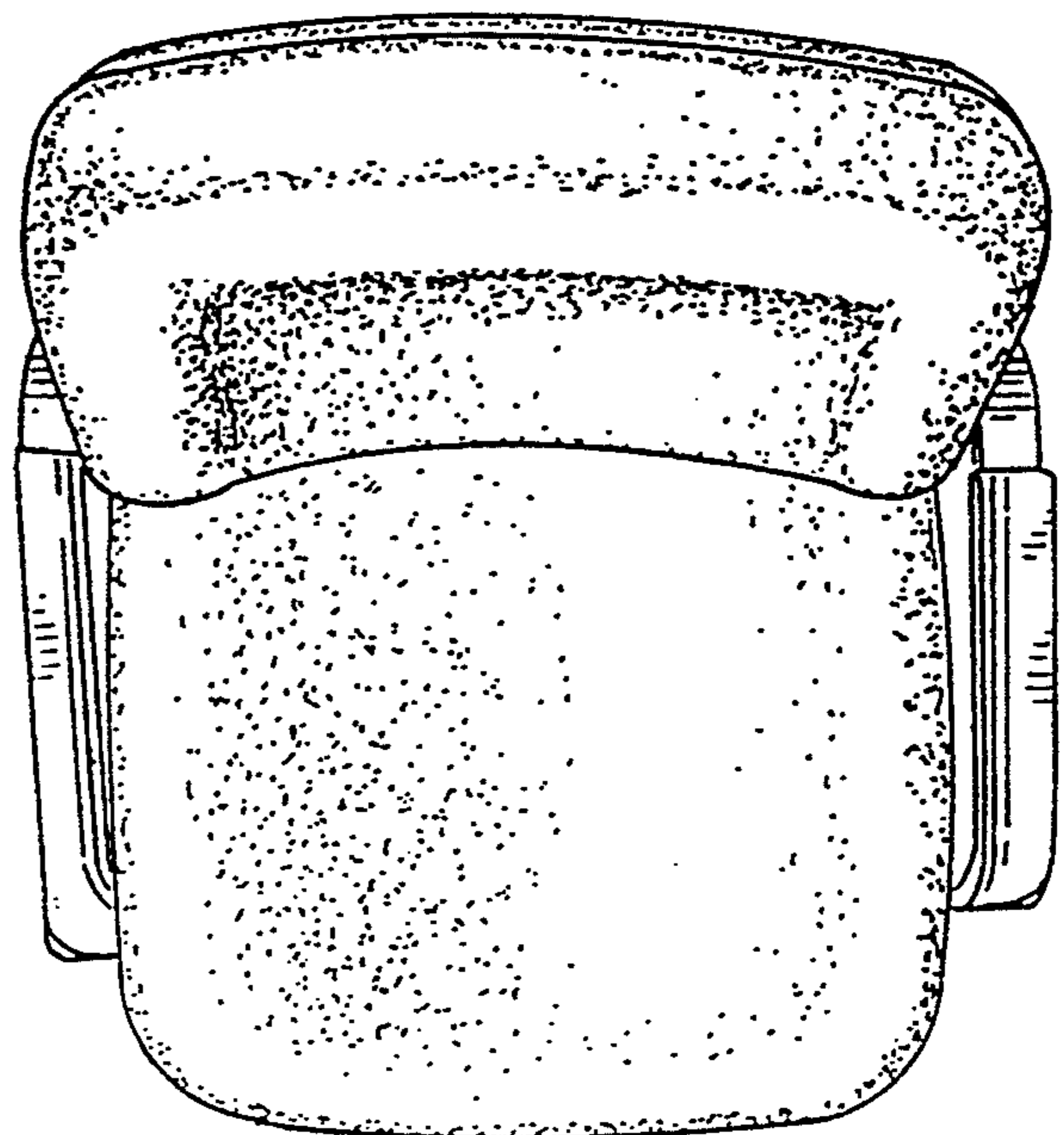
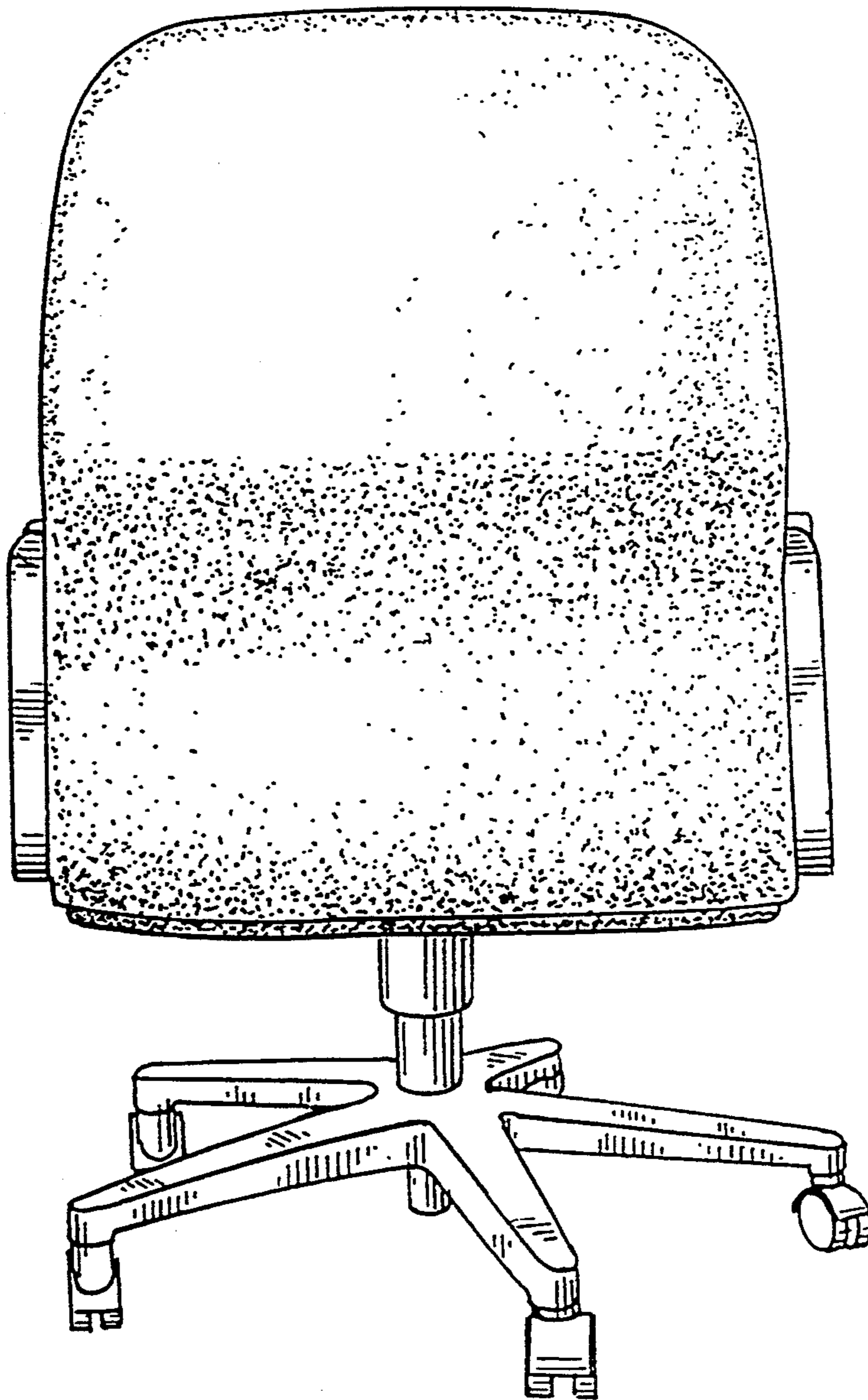

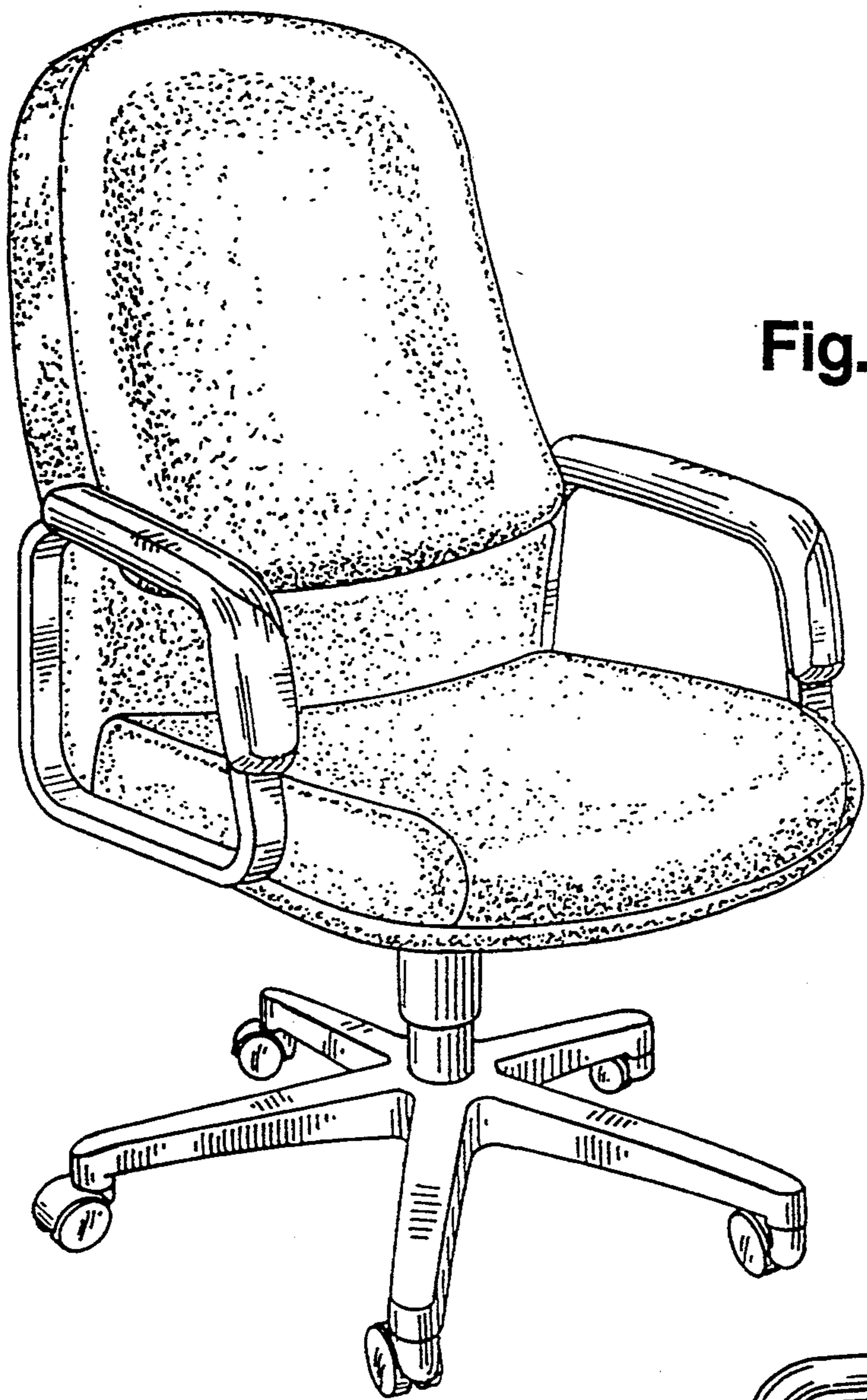

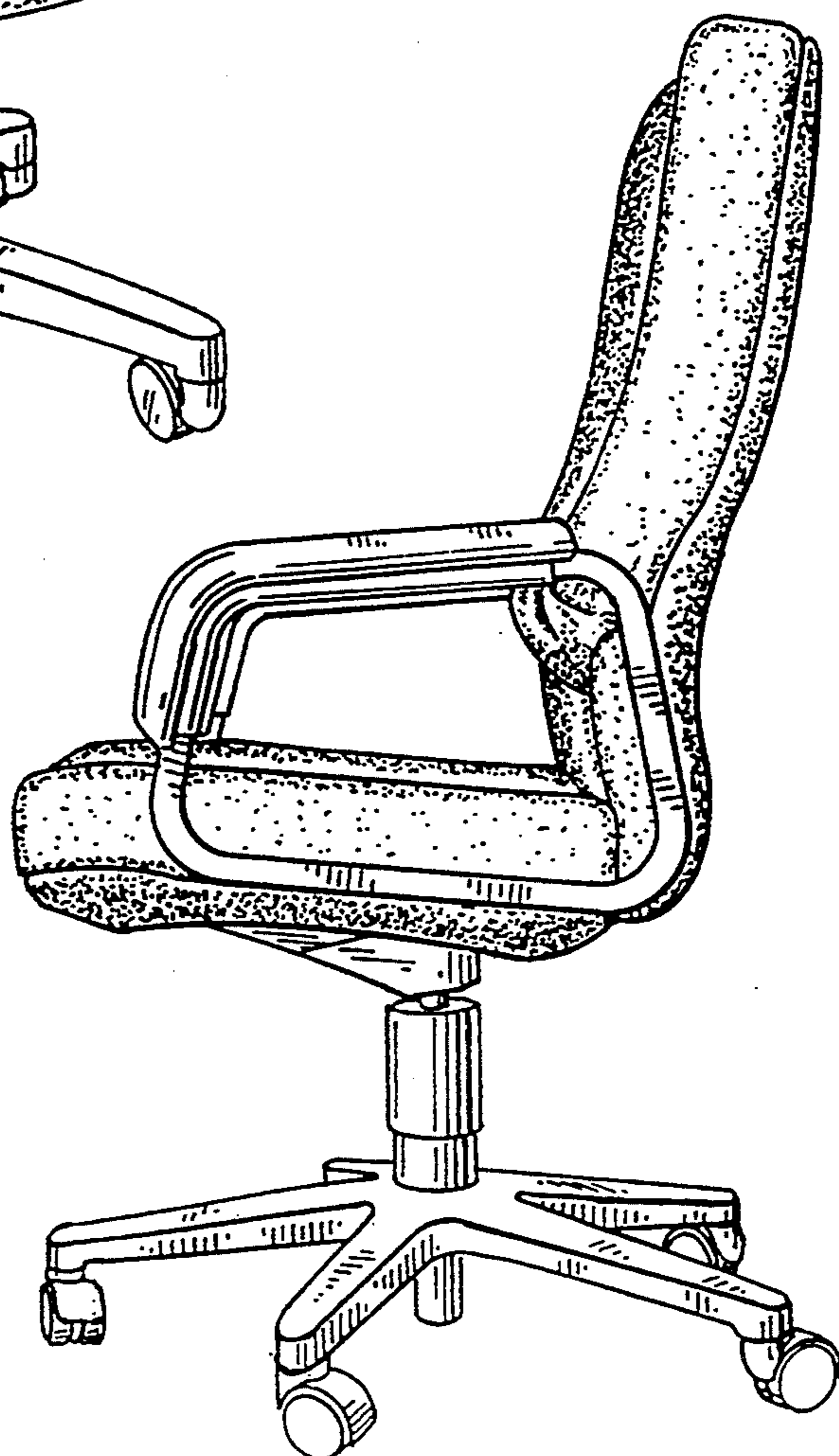

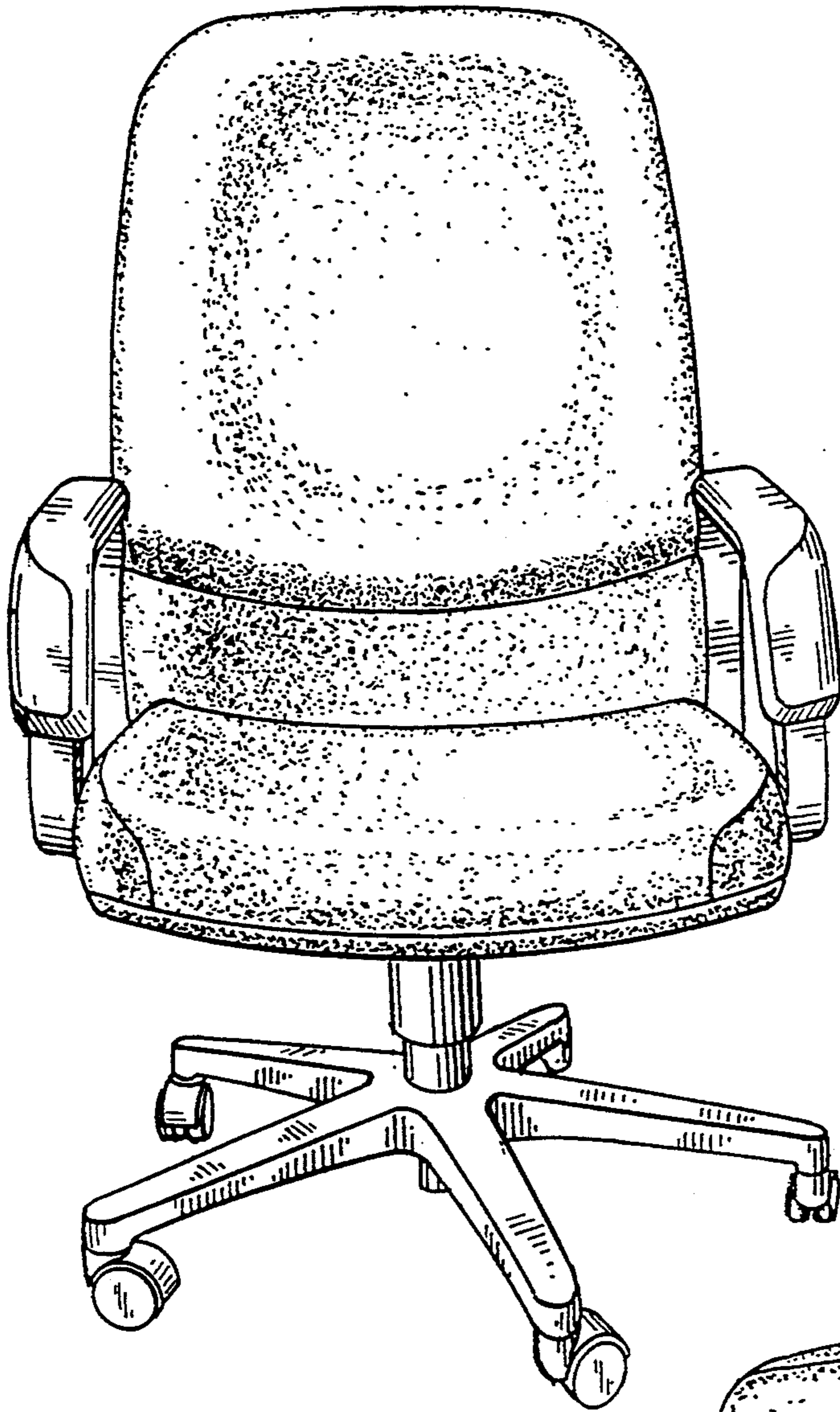

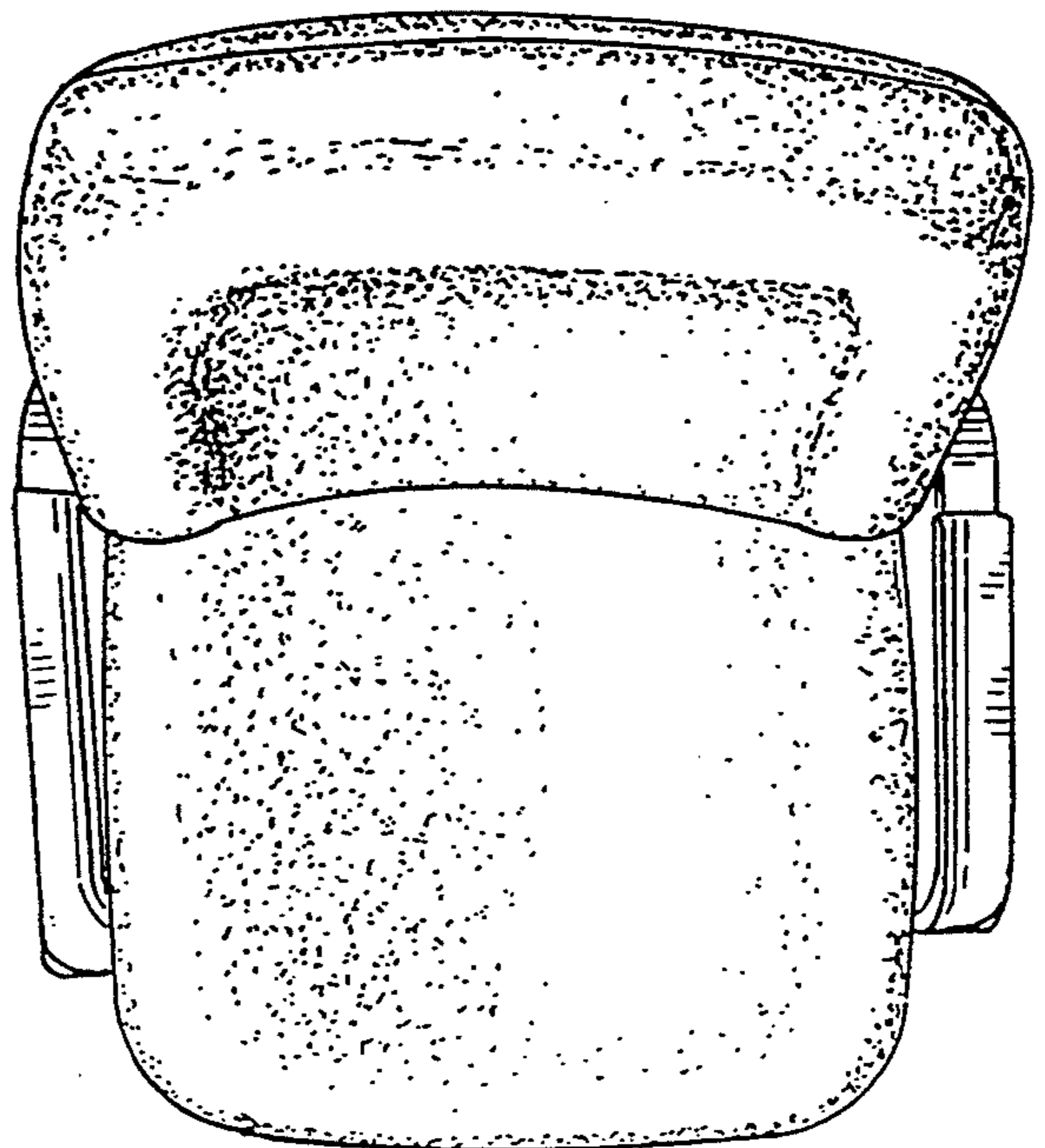
