FIG. 12 is a perspective view, as seen from the front, top and right side thereof.

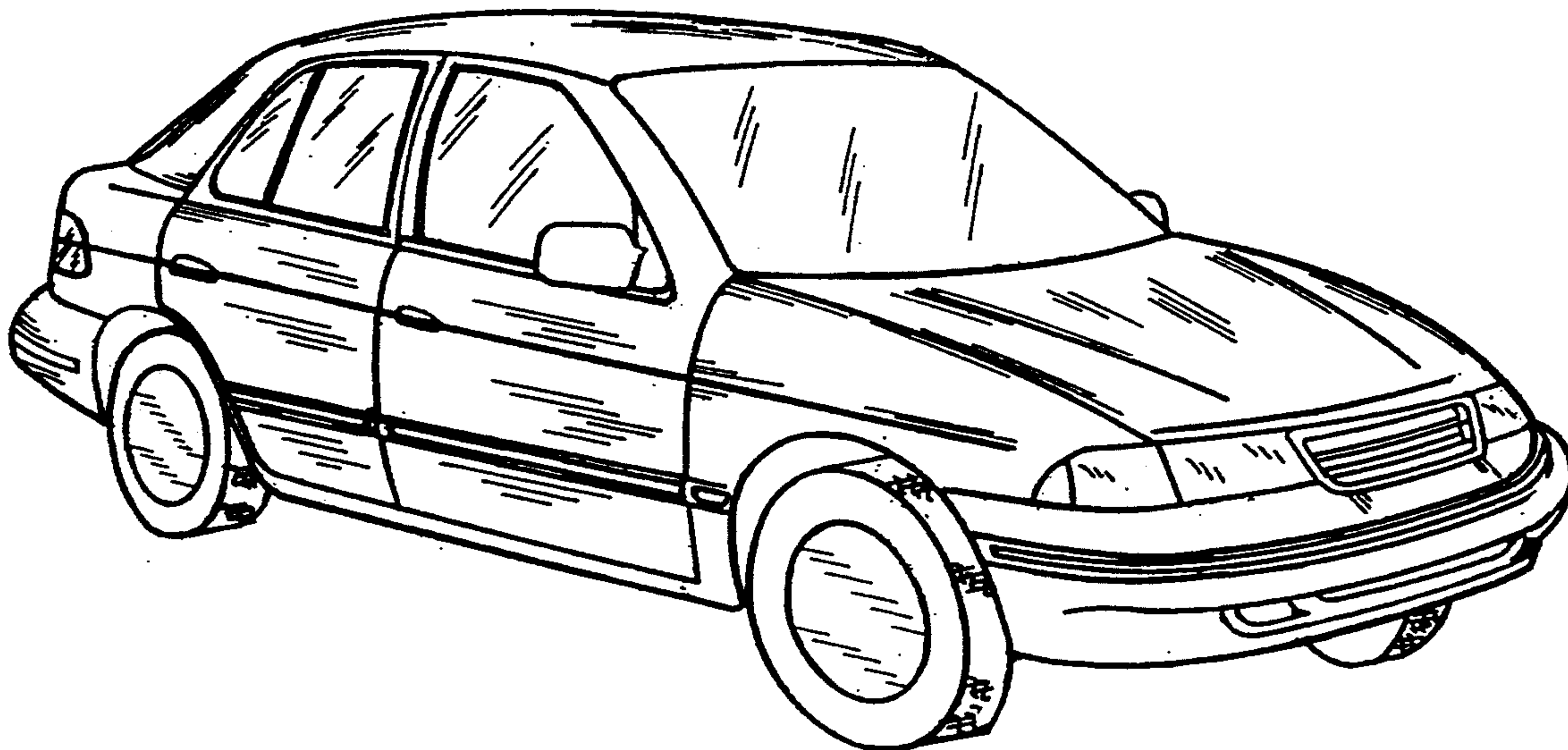

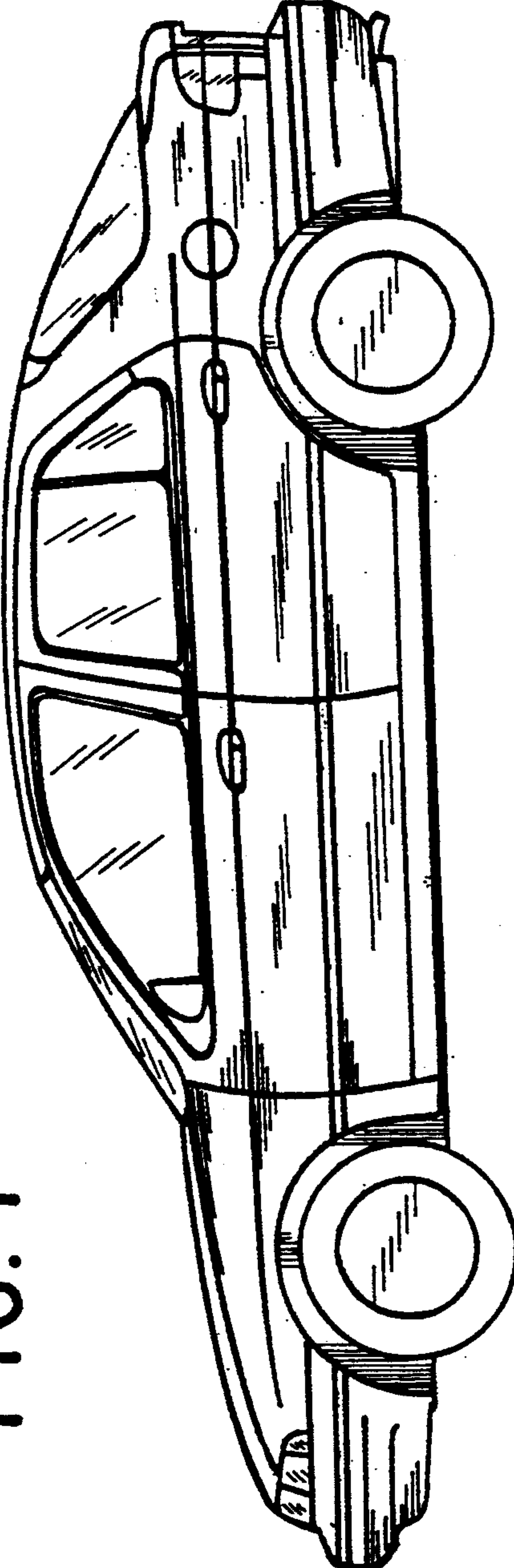

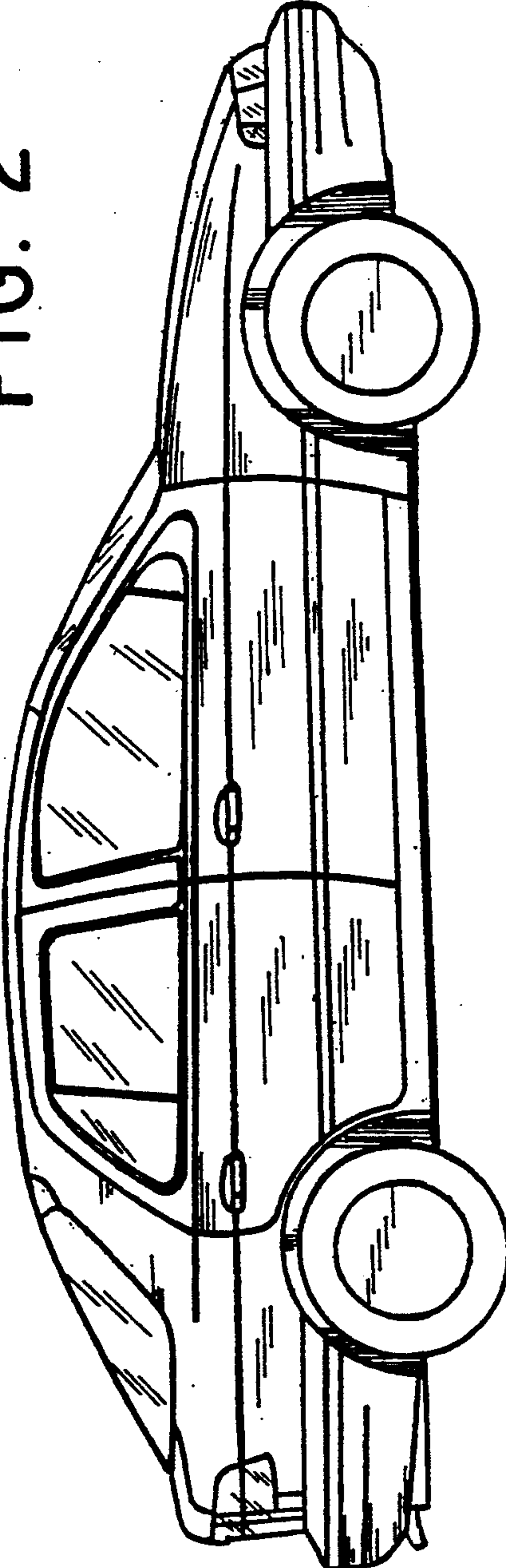

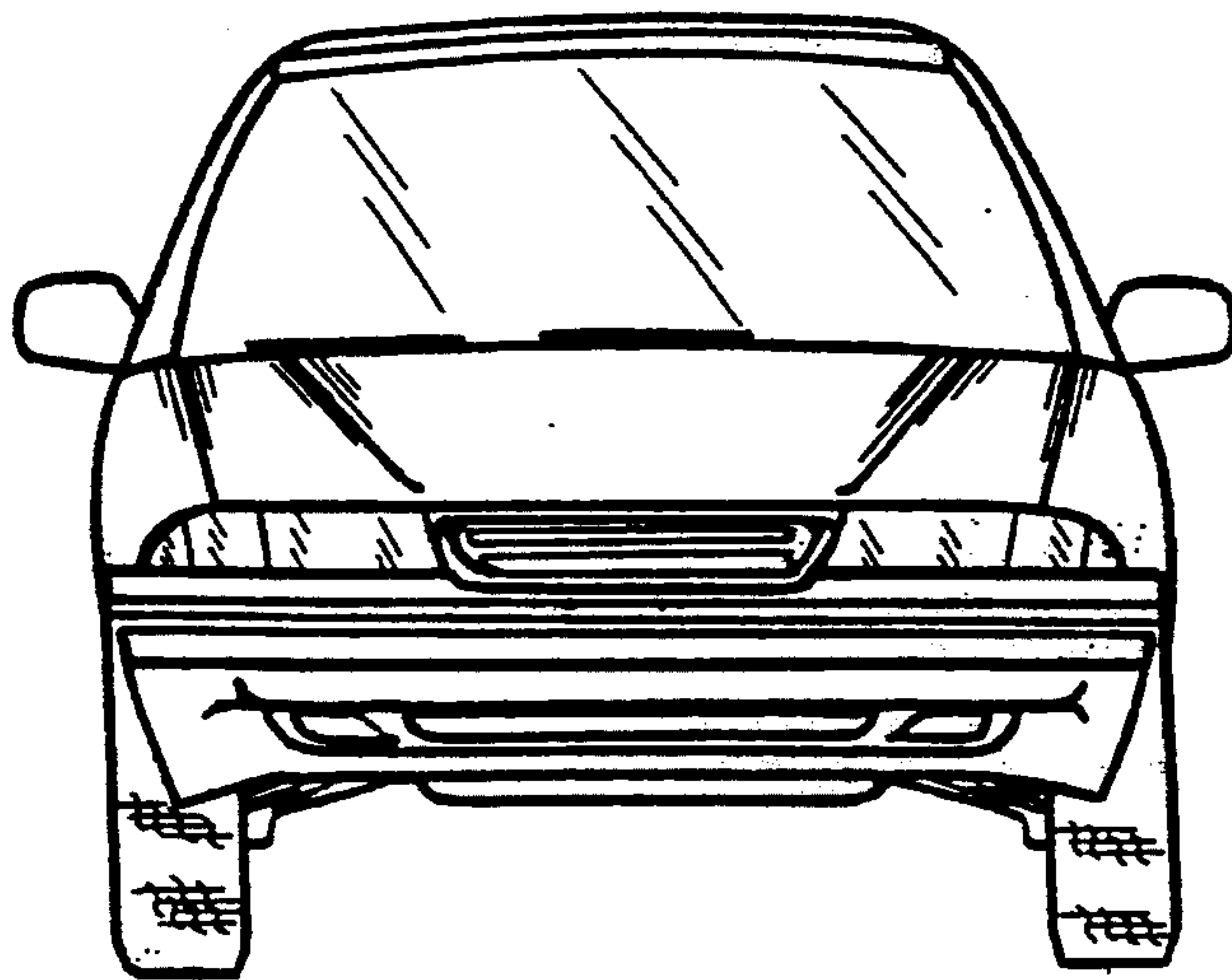

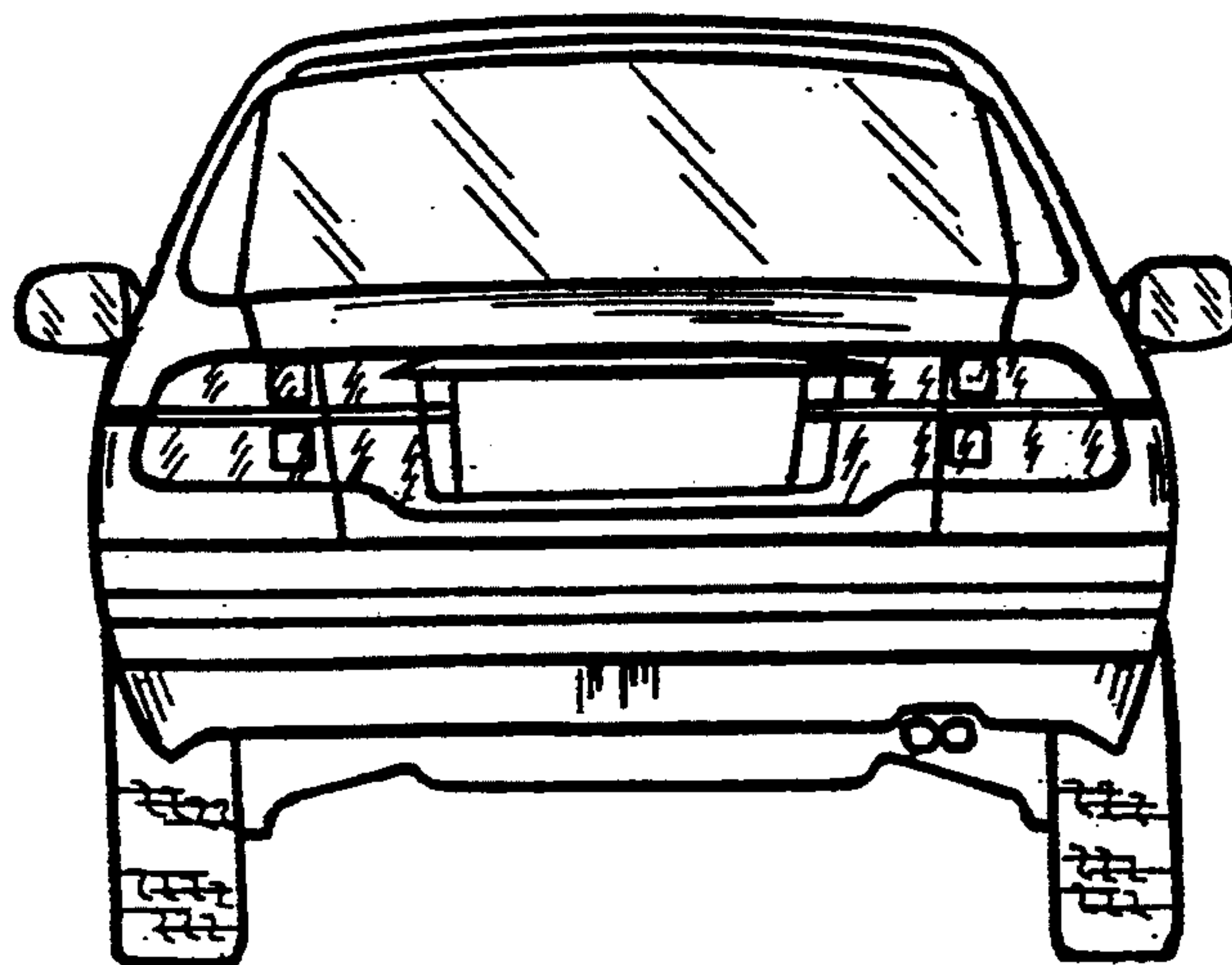

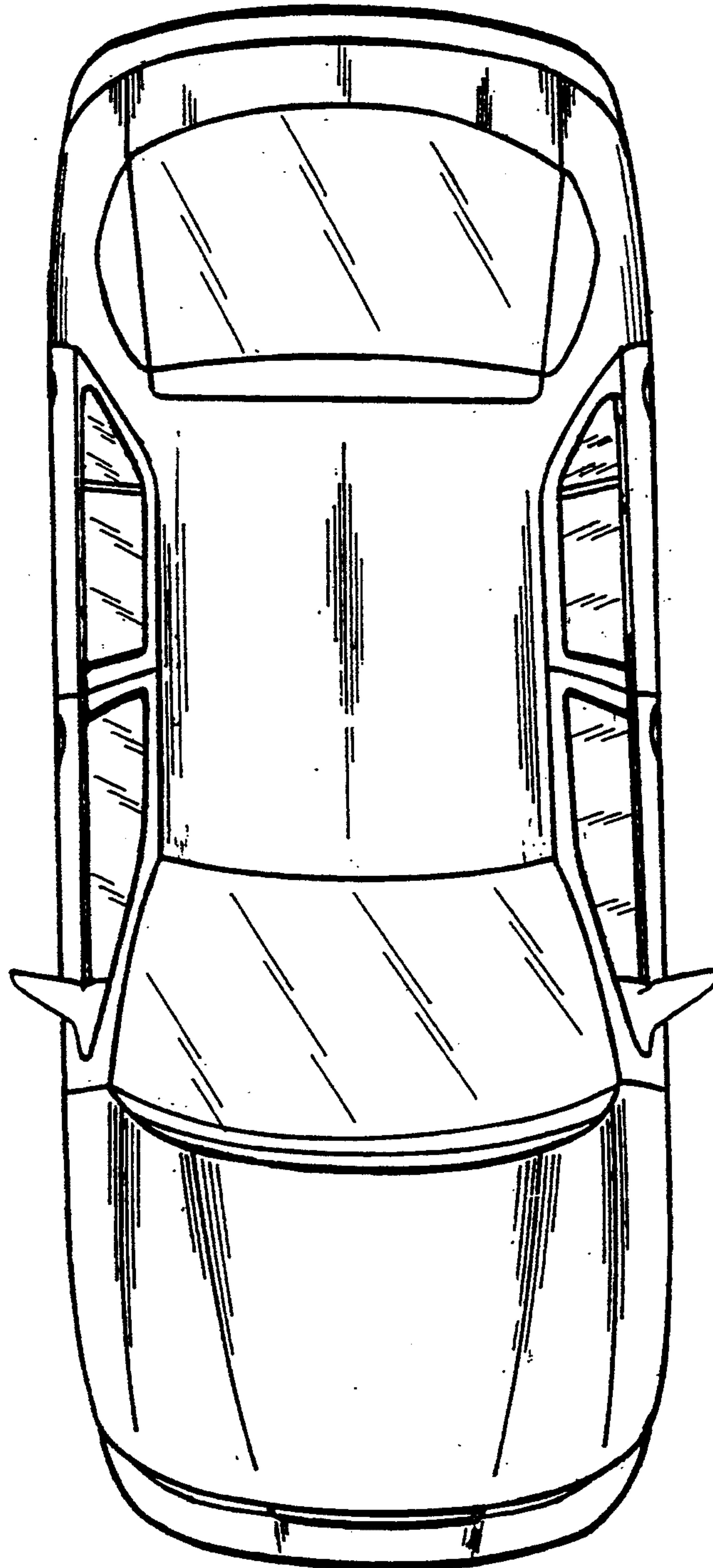

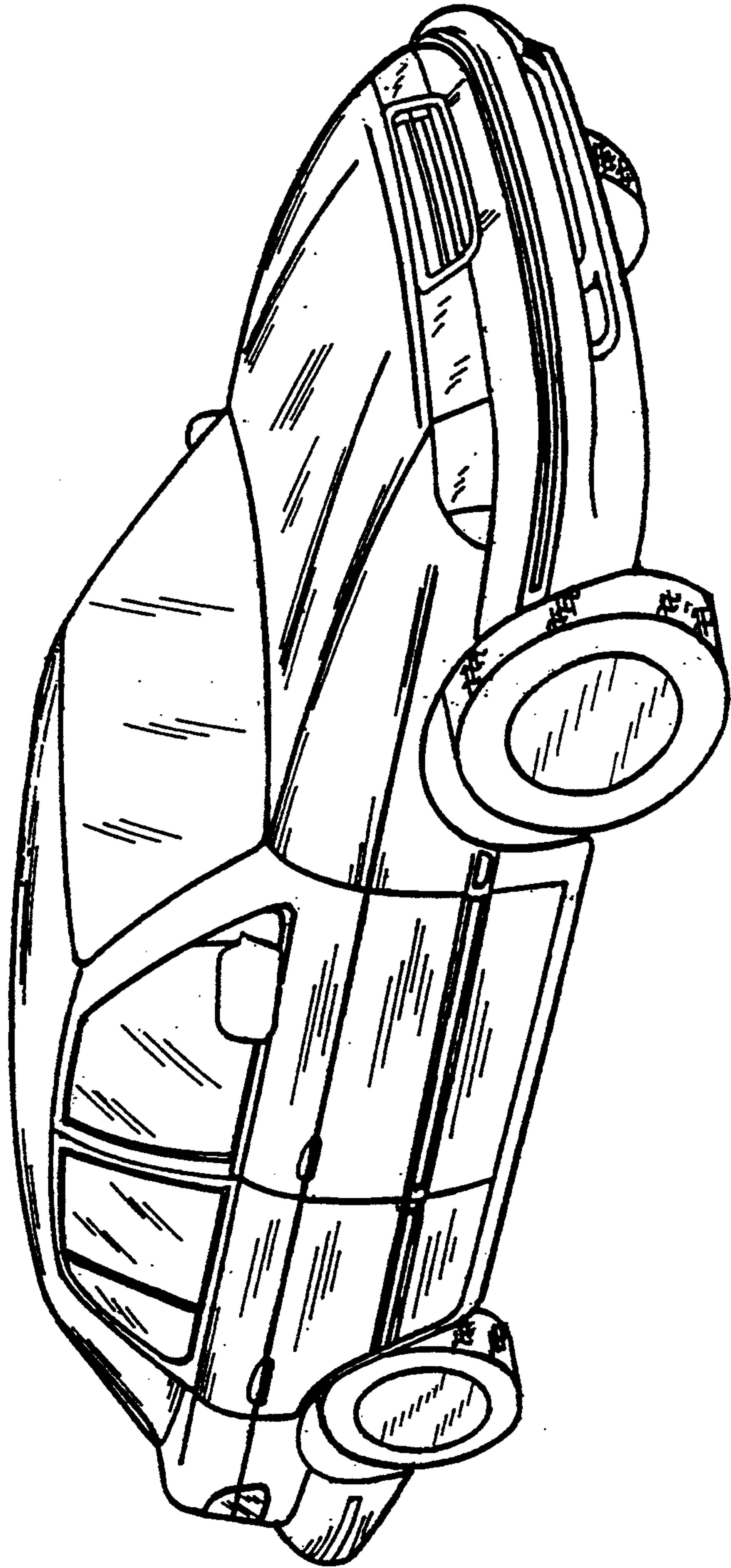

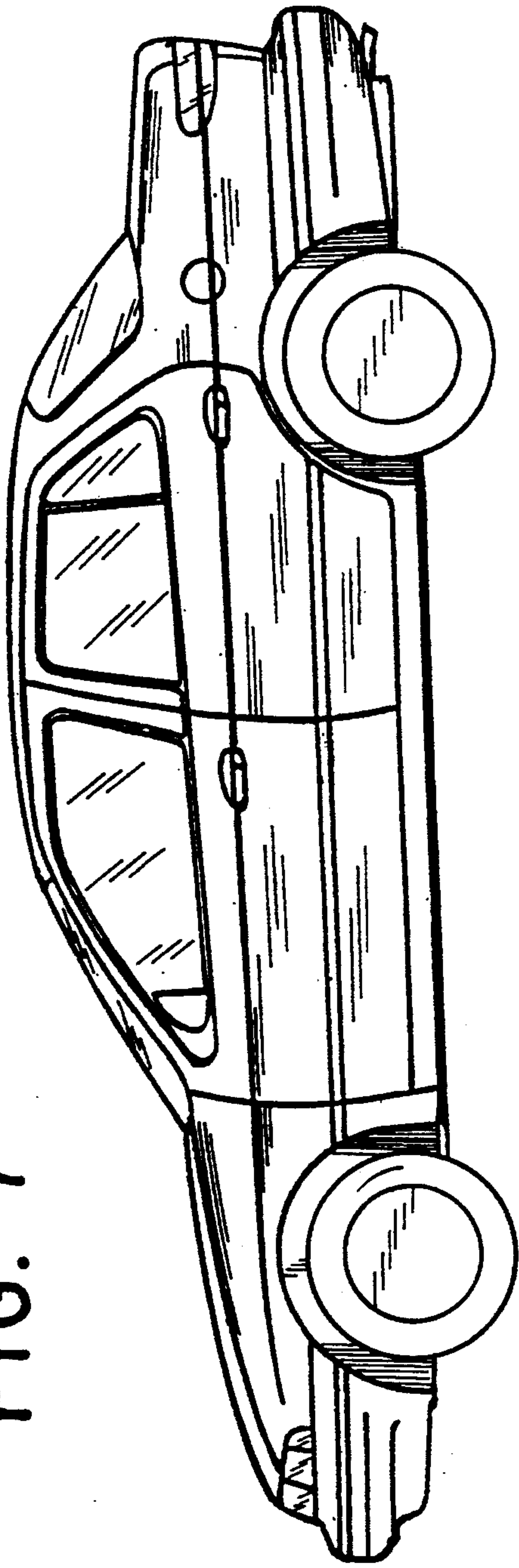

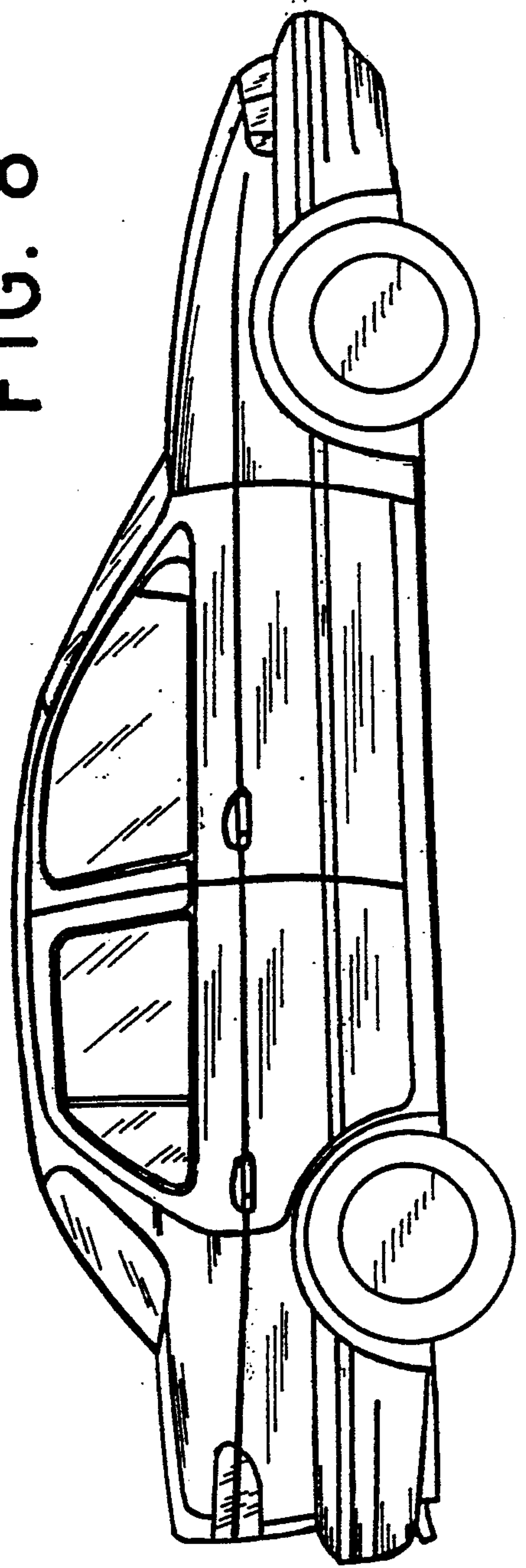

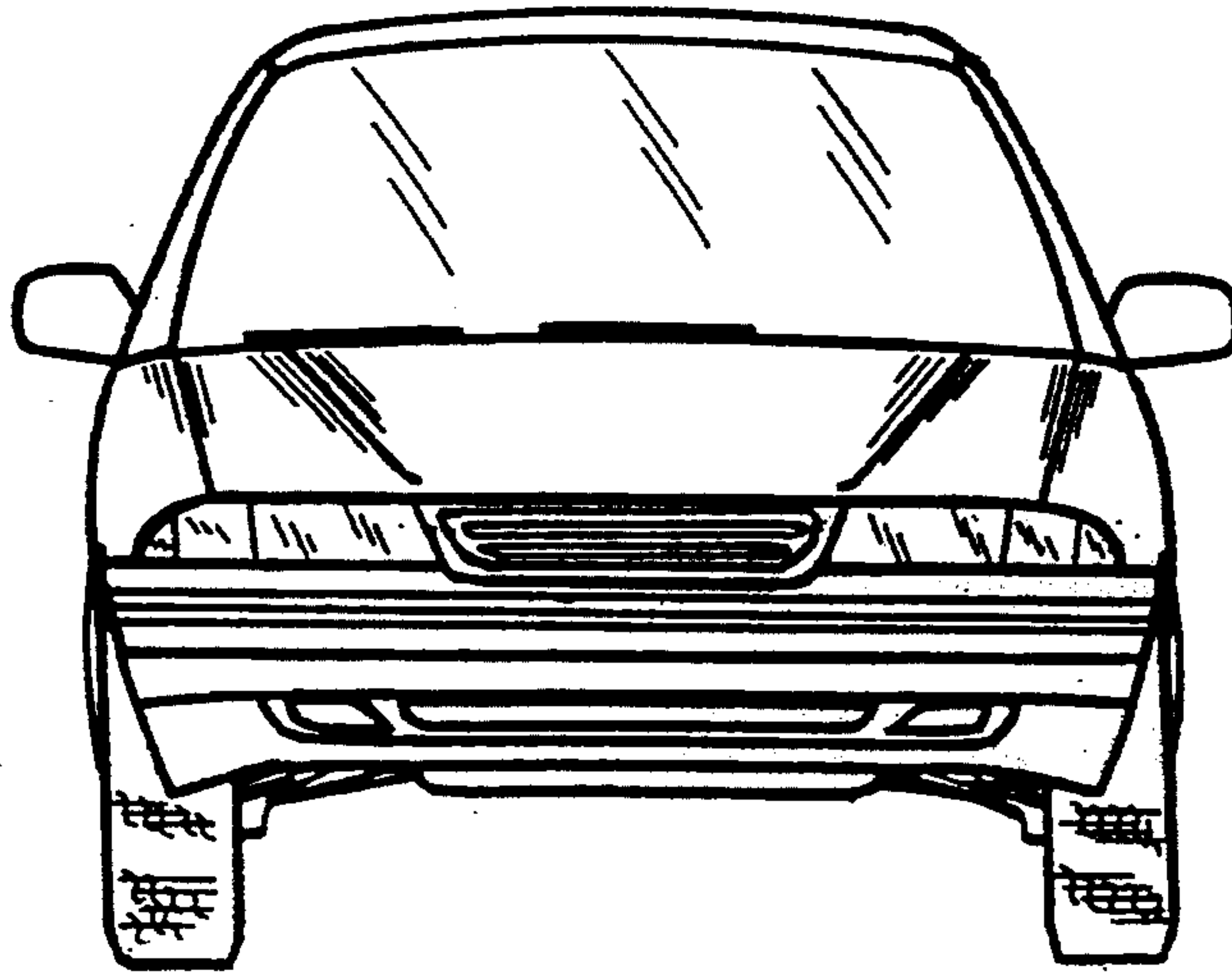

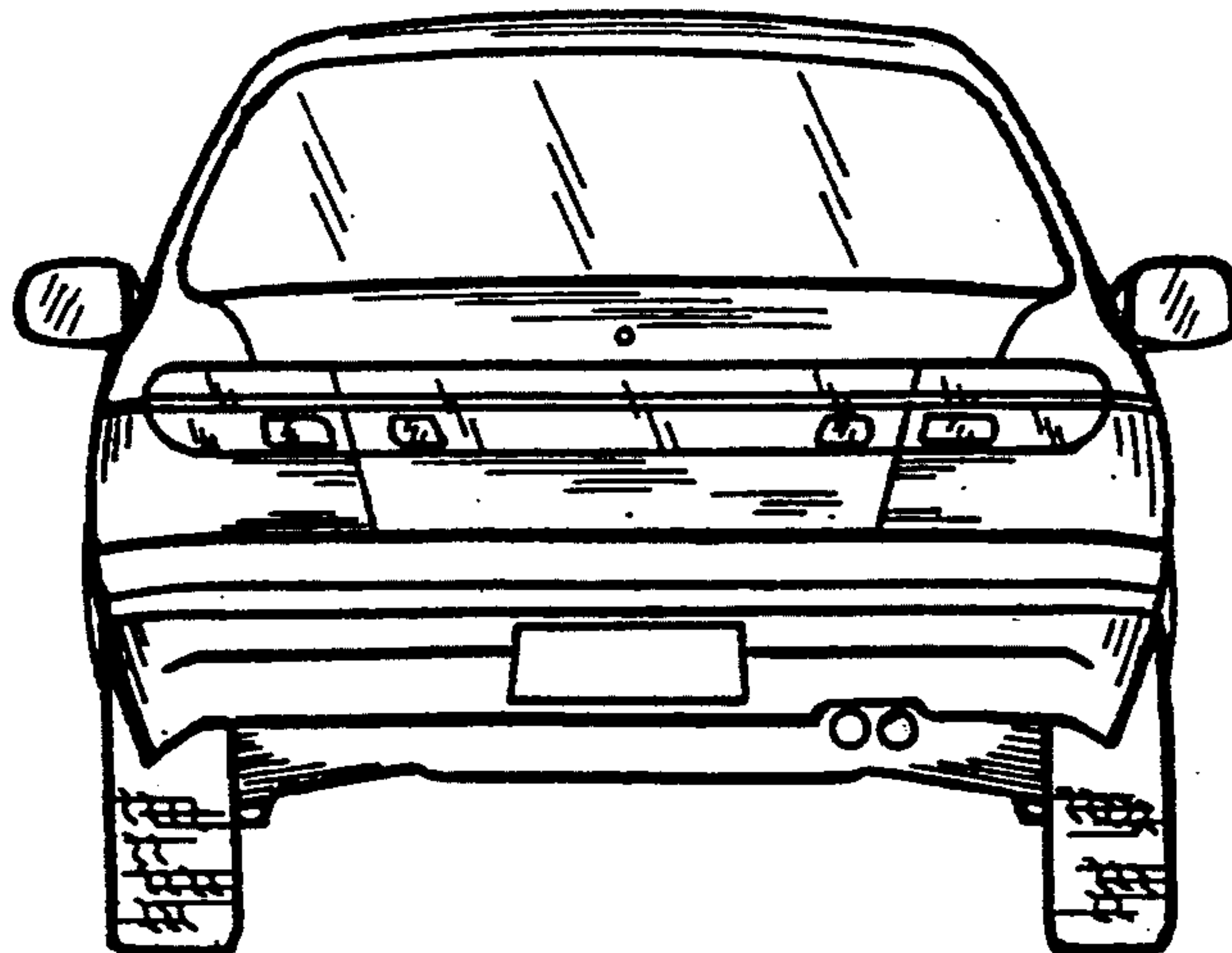

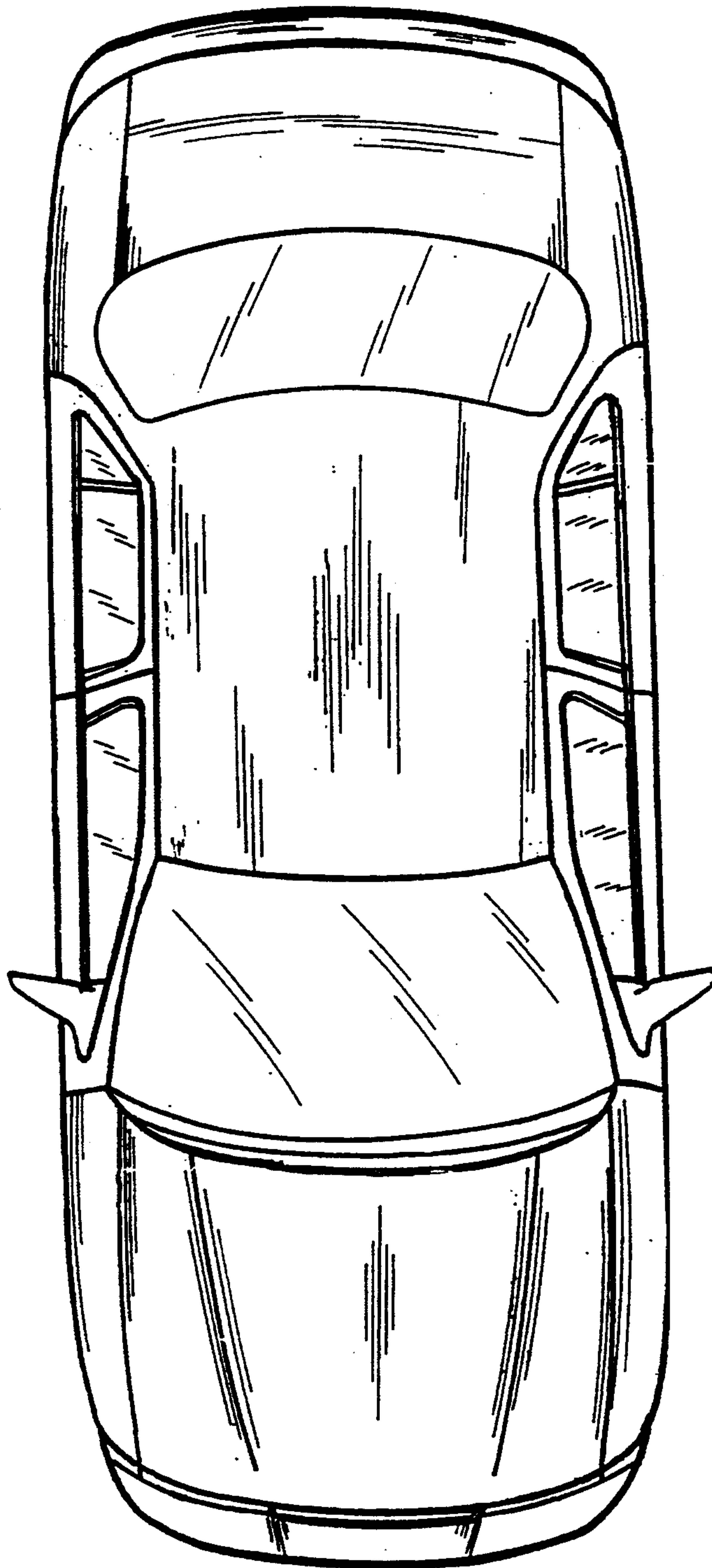
