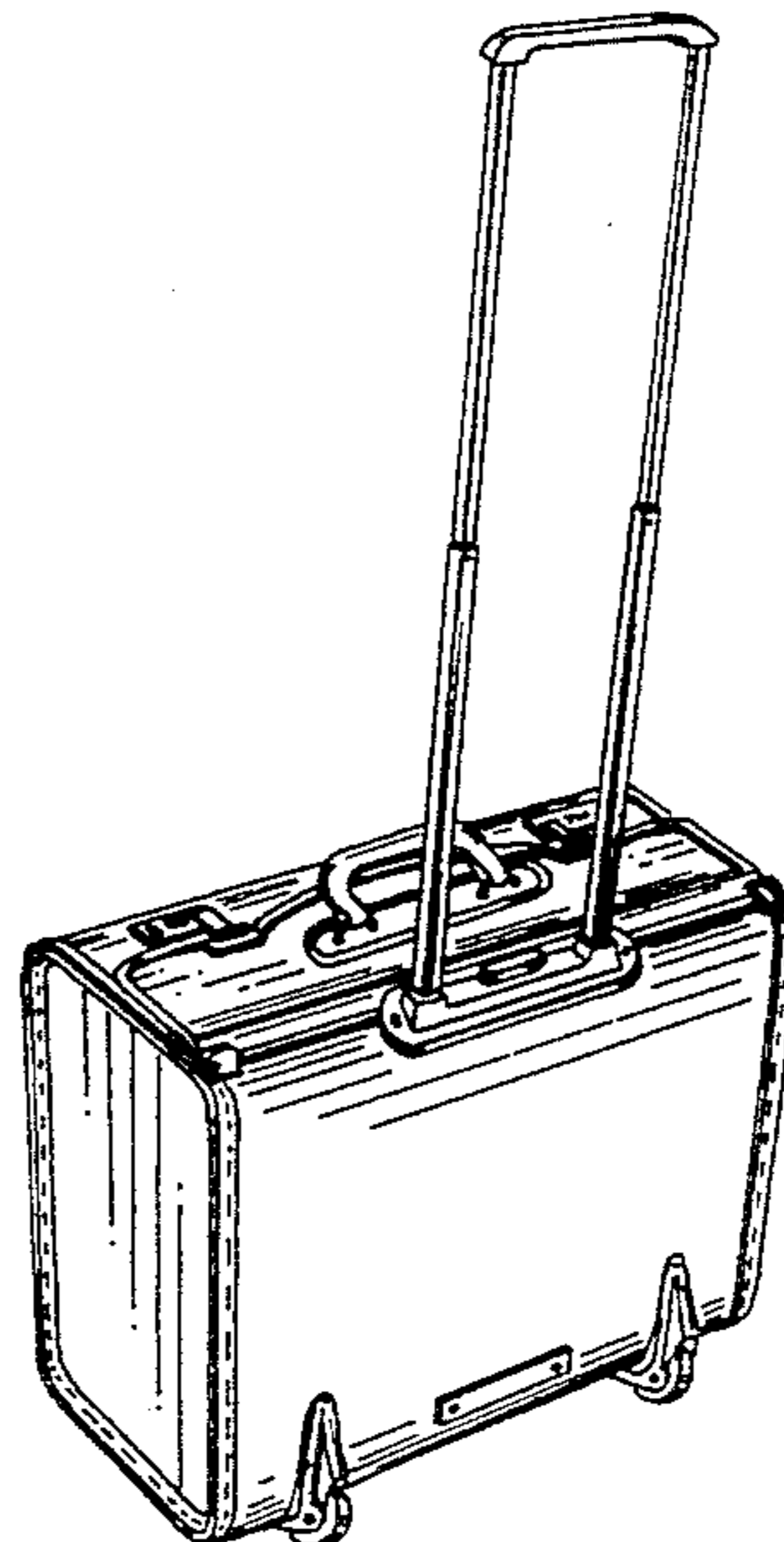
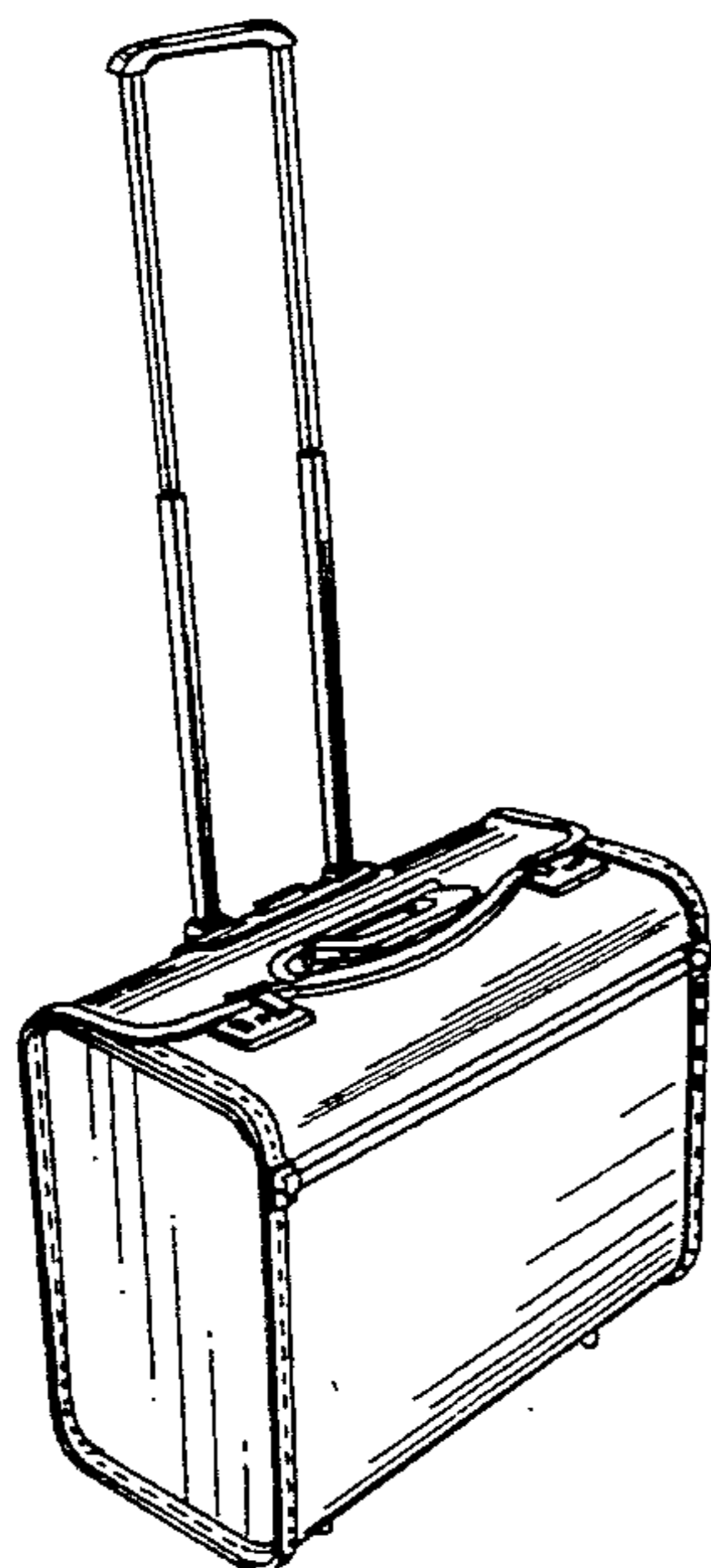
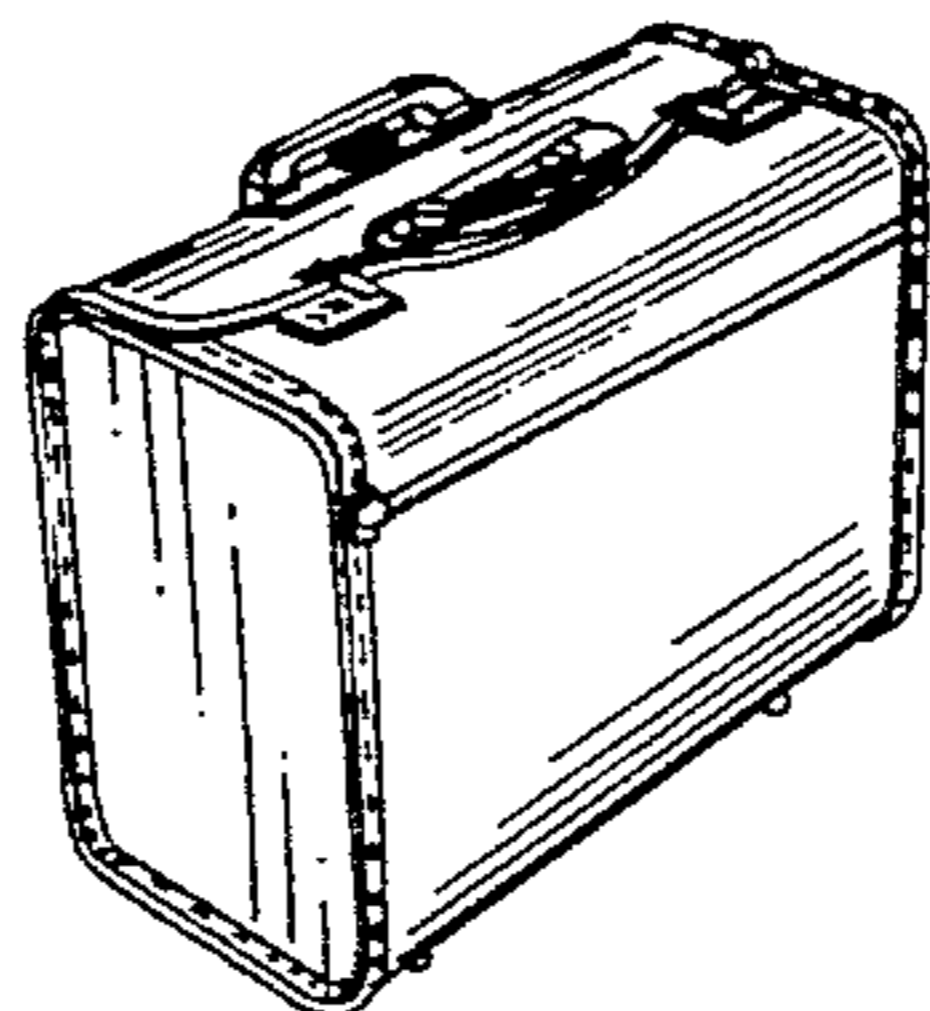

DESCRIPTION

FIG. 1 is a front perspective view of a carrying case with built-in cart showing our new design;
 FIG. 2 is a front perspective view thereof, the handle in an extended position;

 FIG. 4 is a front elevational view of FIG. 2;
 FIG. 5 is a right side elevational view of FIG. 2;

 FIG. 9 is a left side elevational view of FIG. 2.



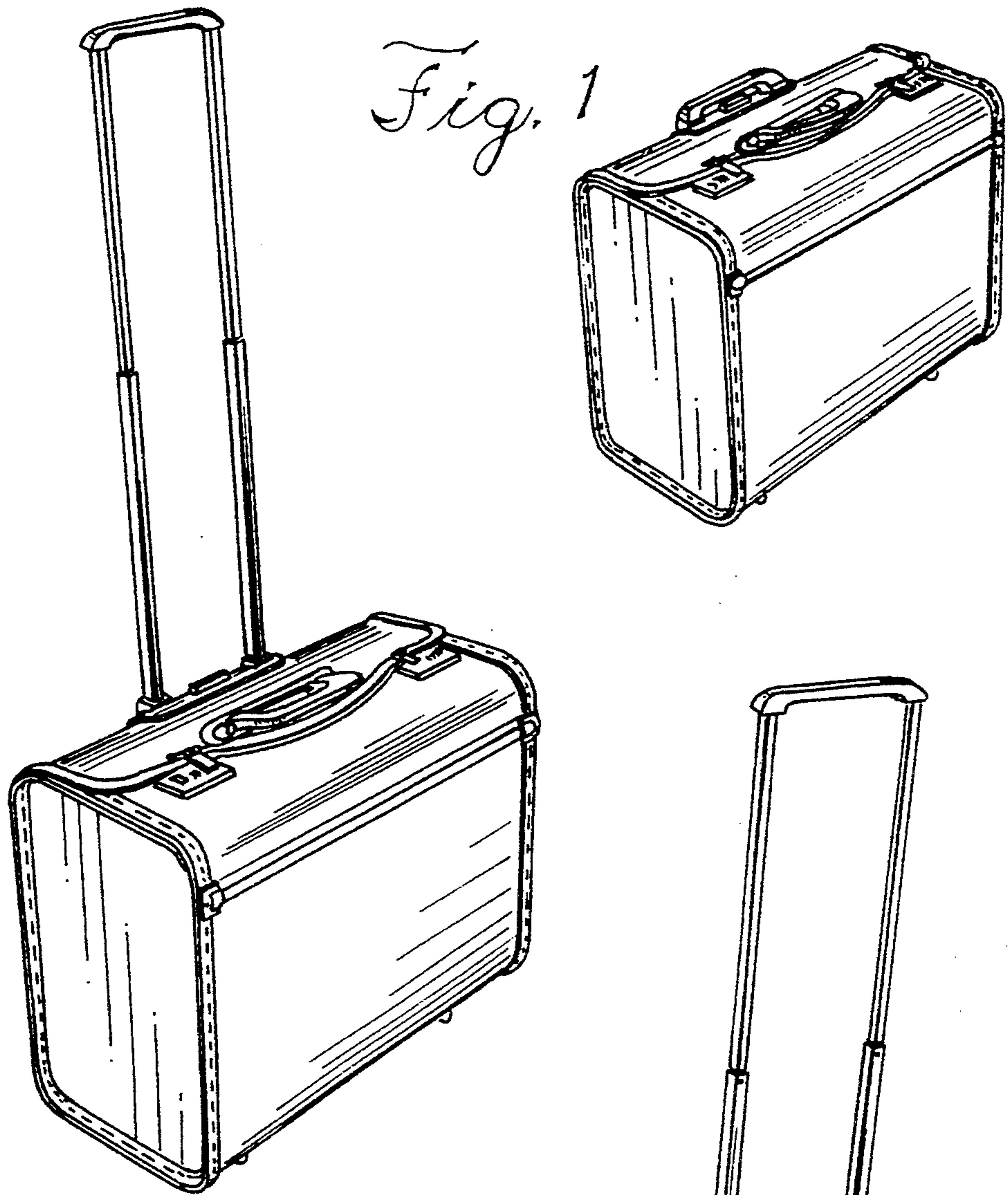

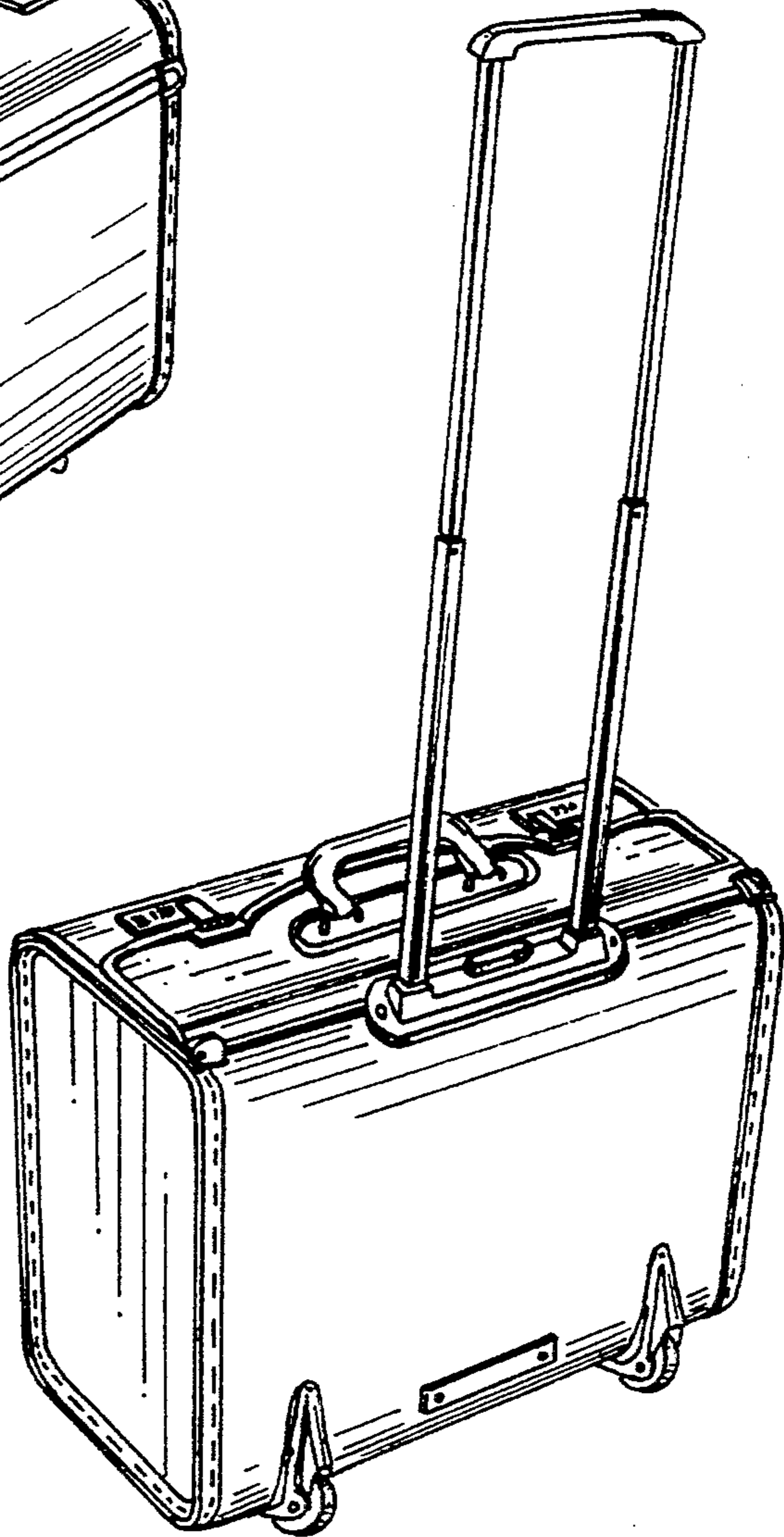

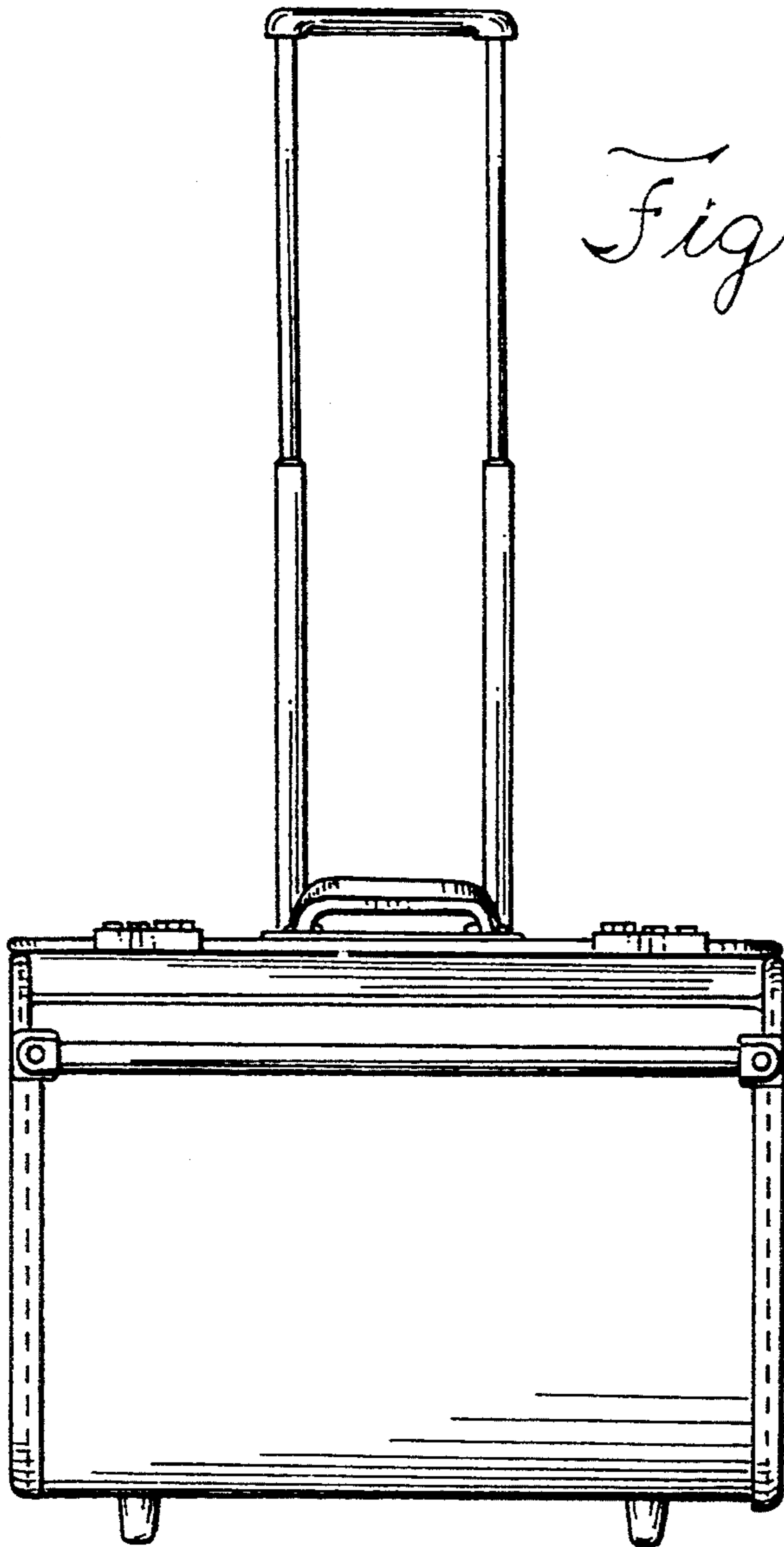

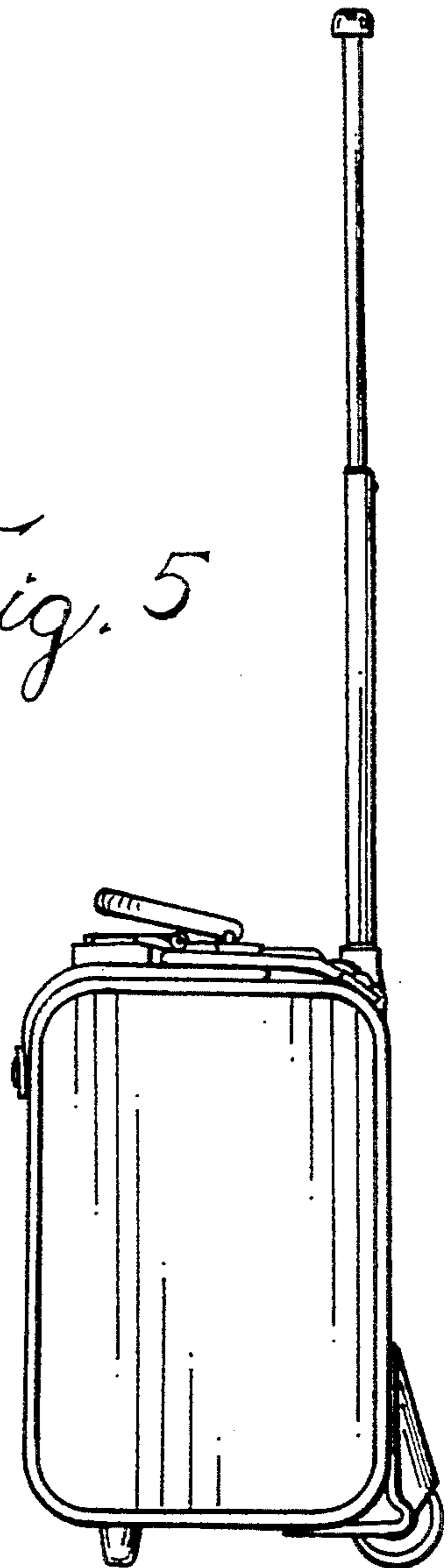

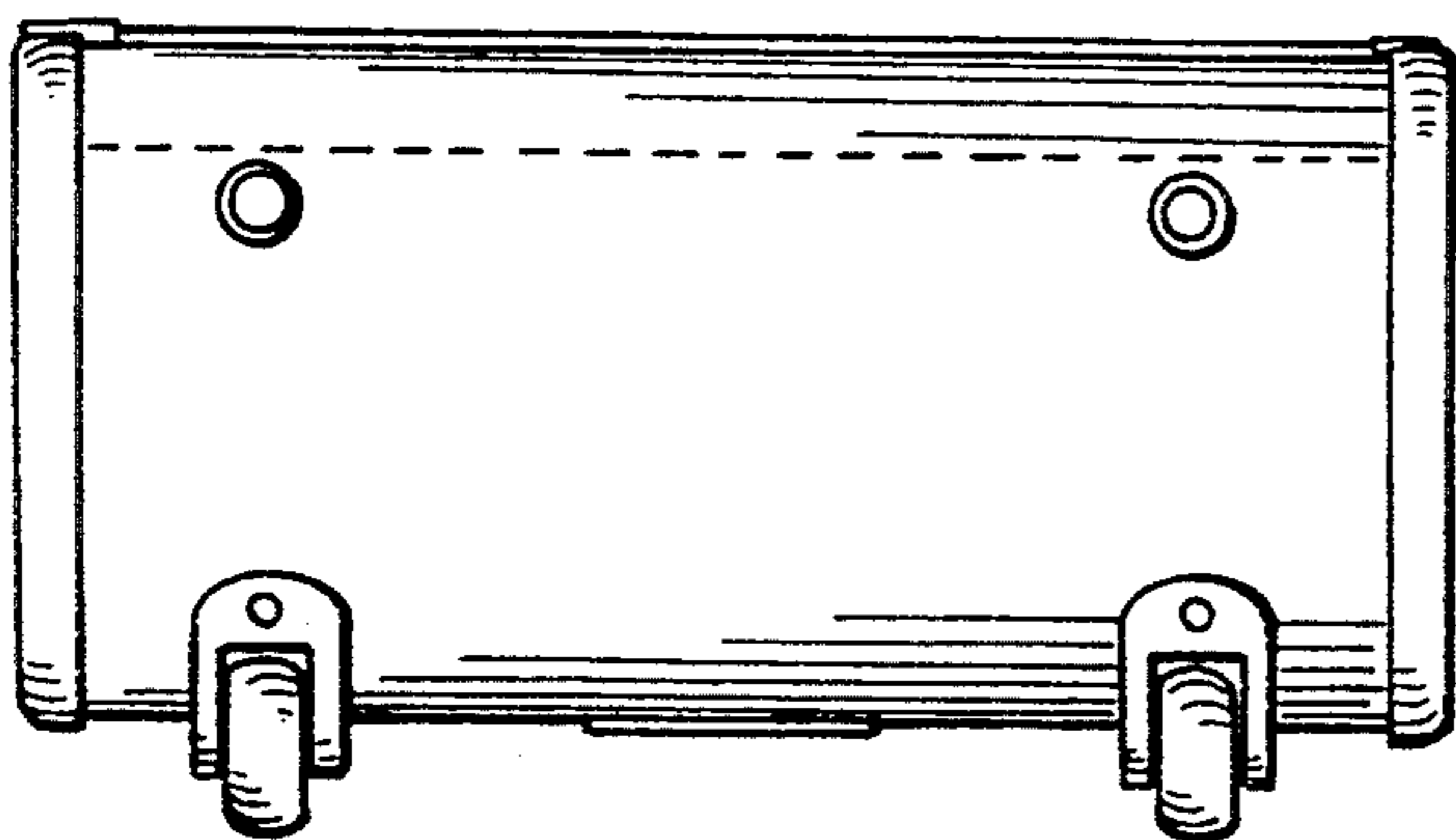

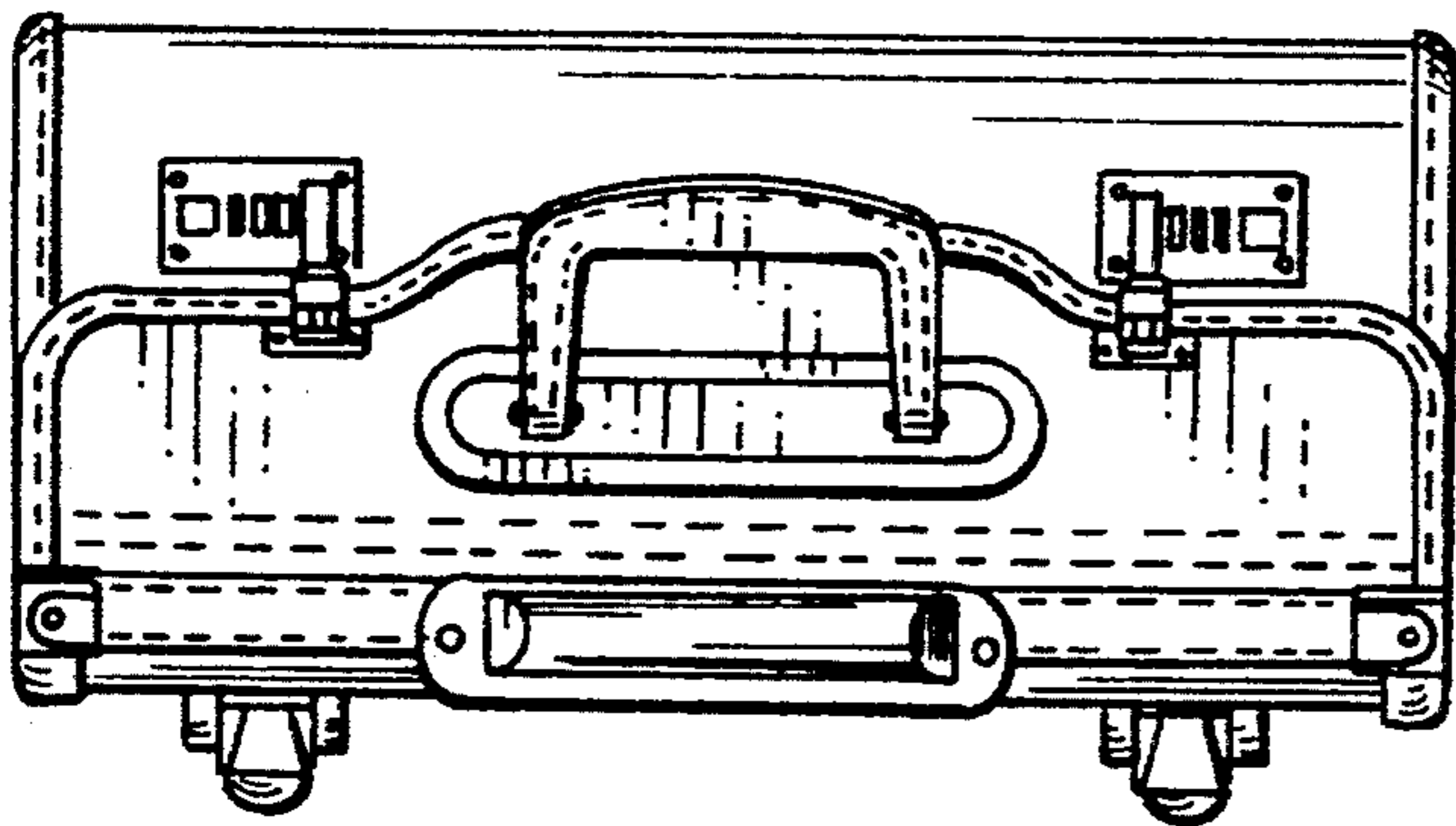

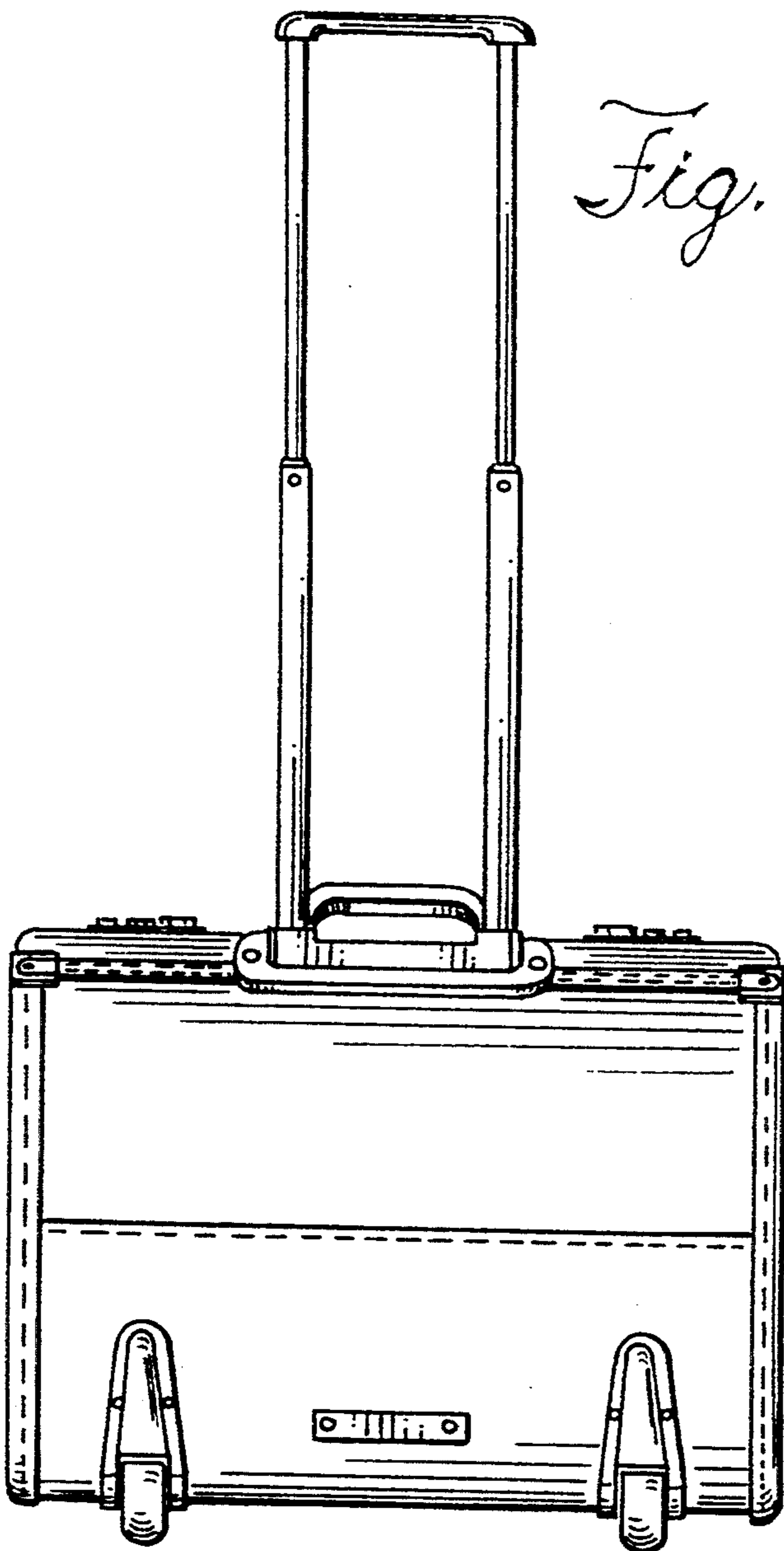

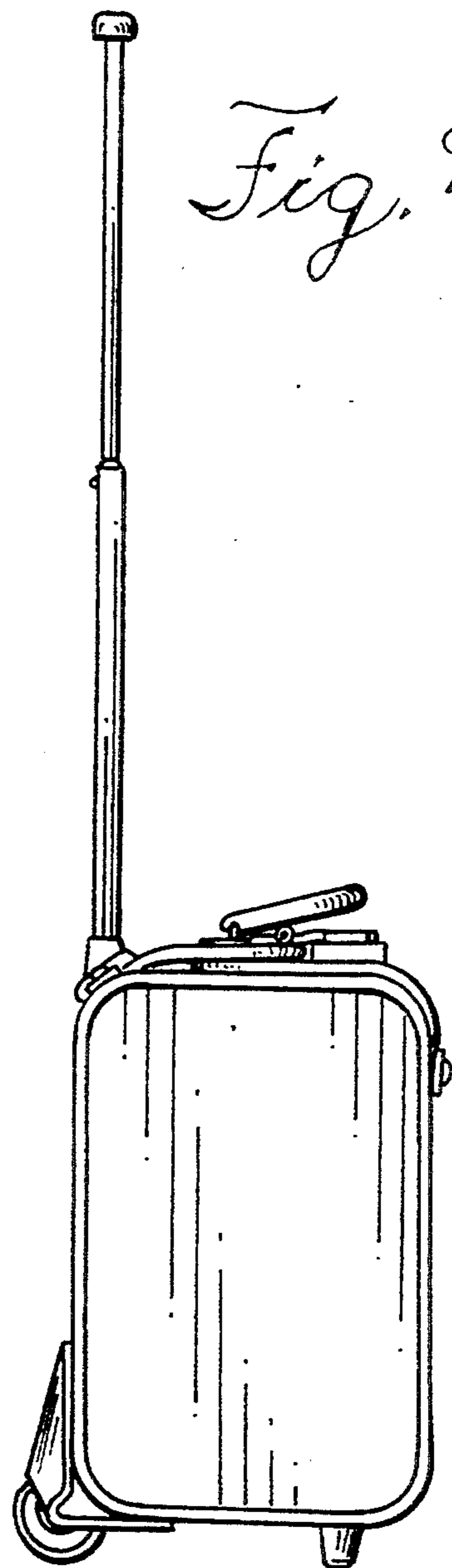
