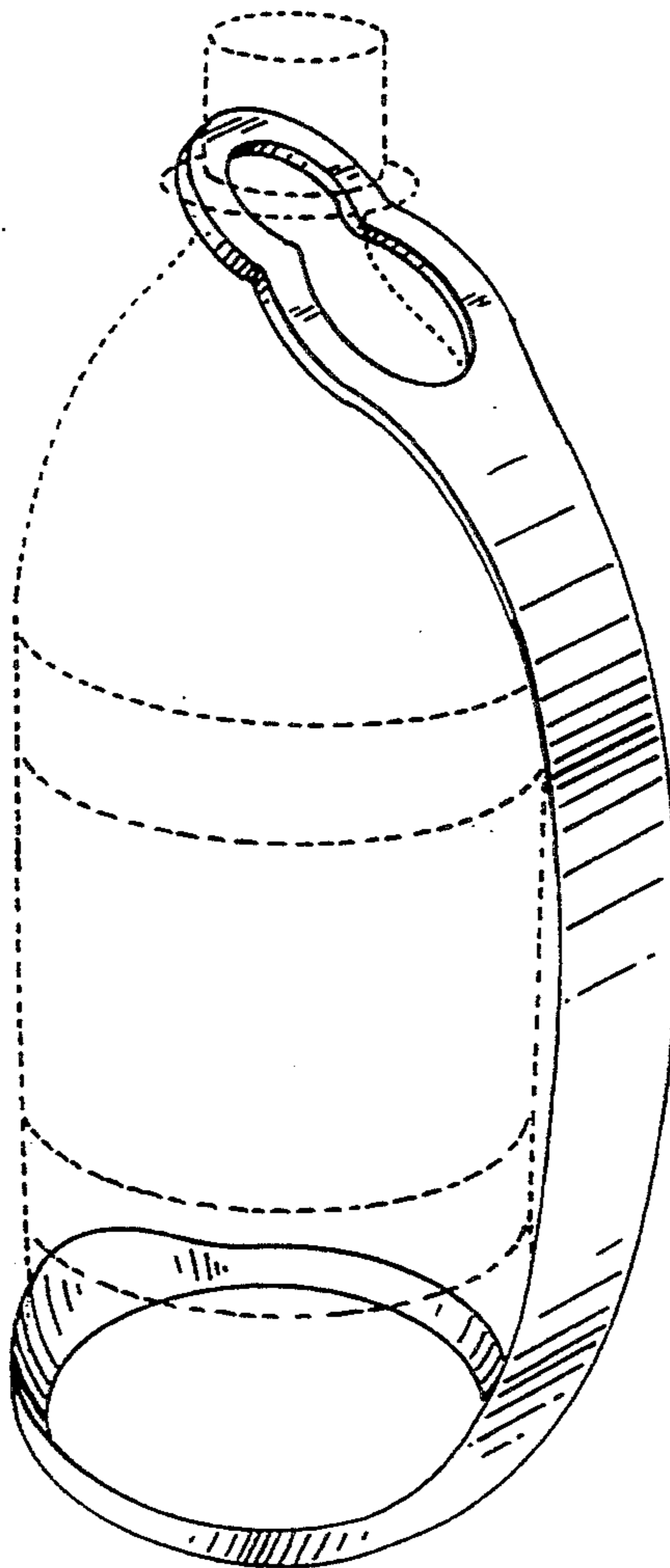

The broken line showing of the bottle is for illustrative purposes only and forms no part of the claimed design.



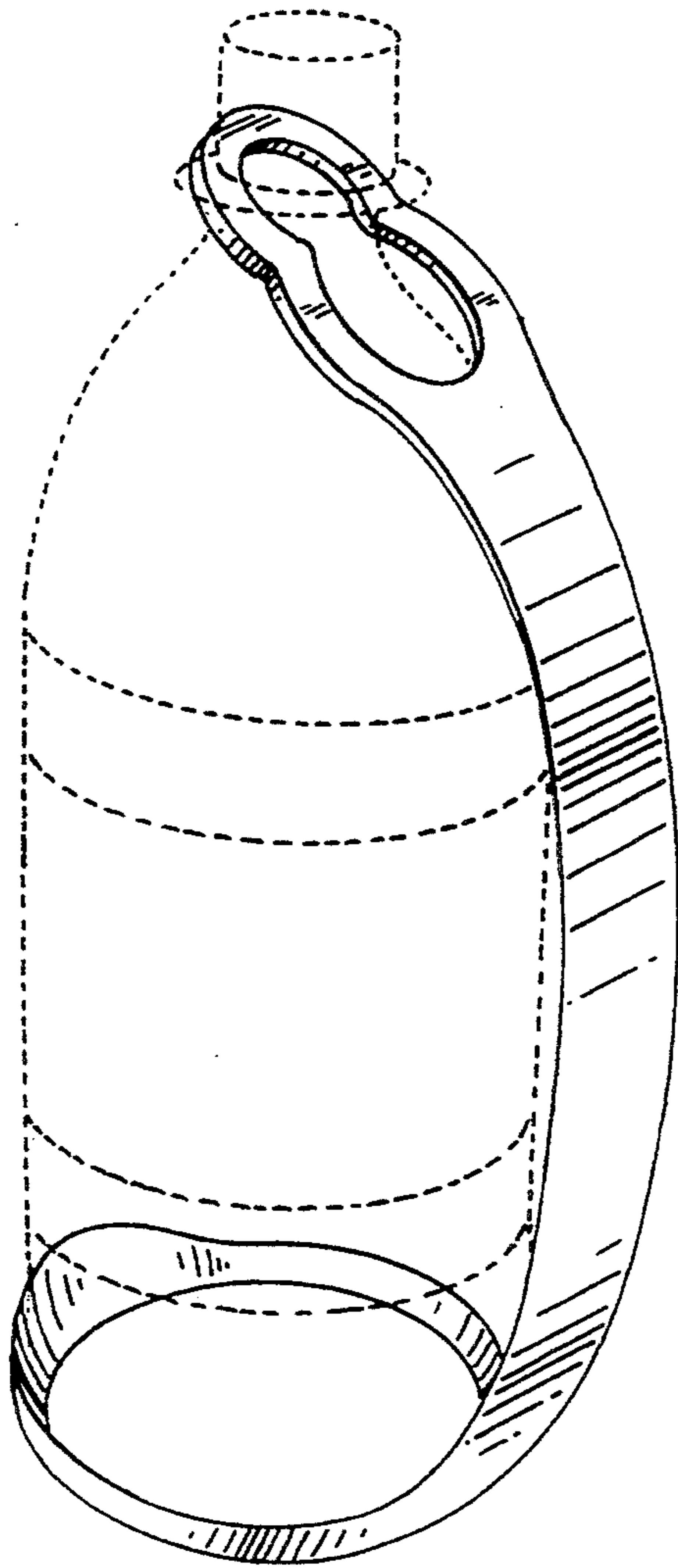

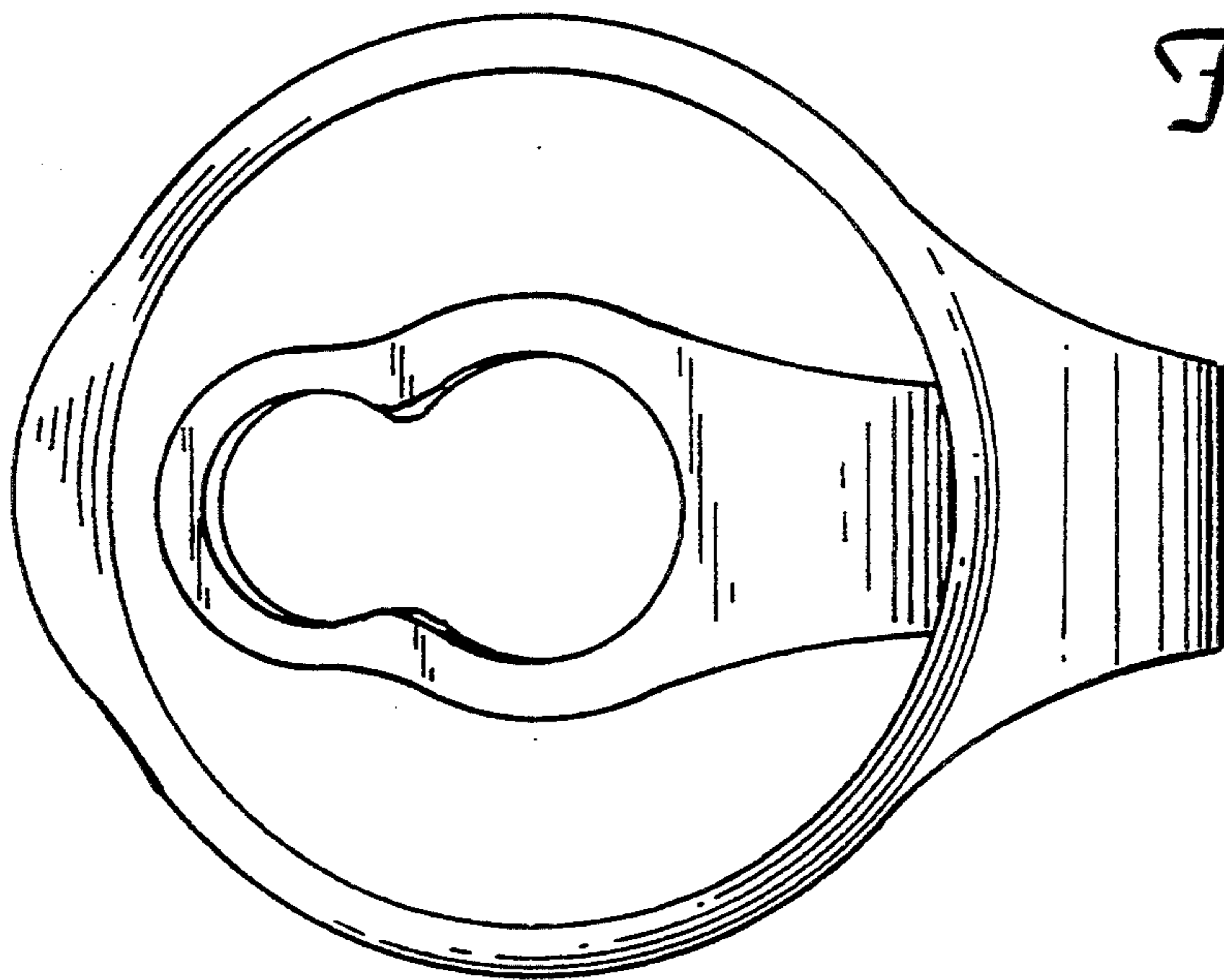

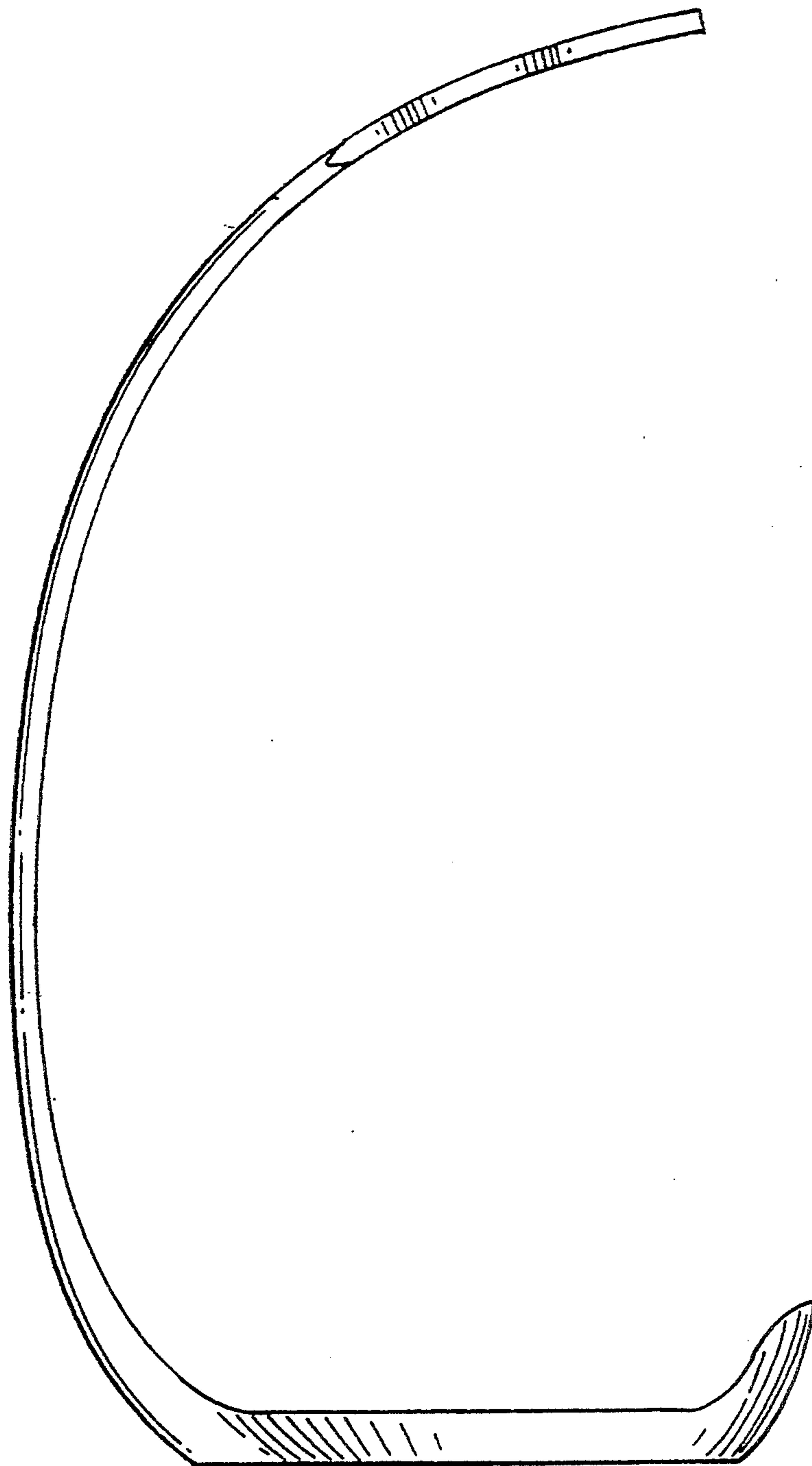

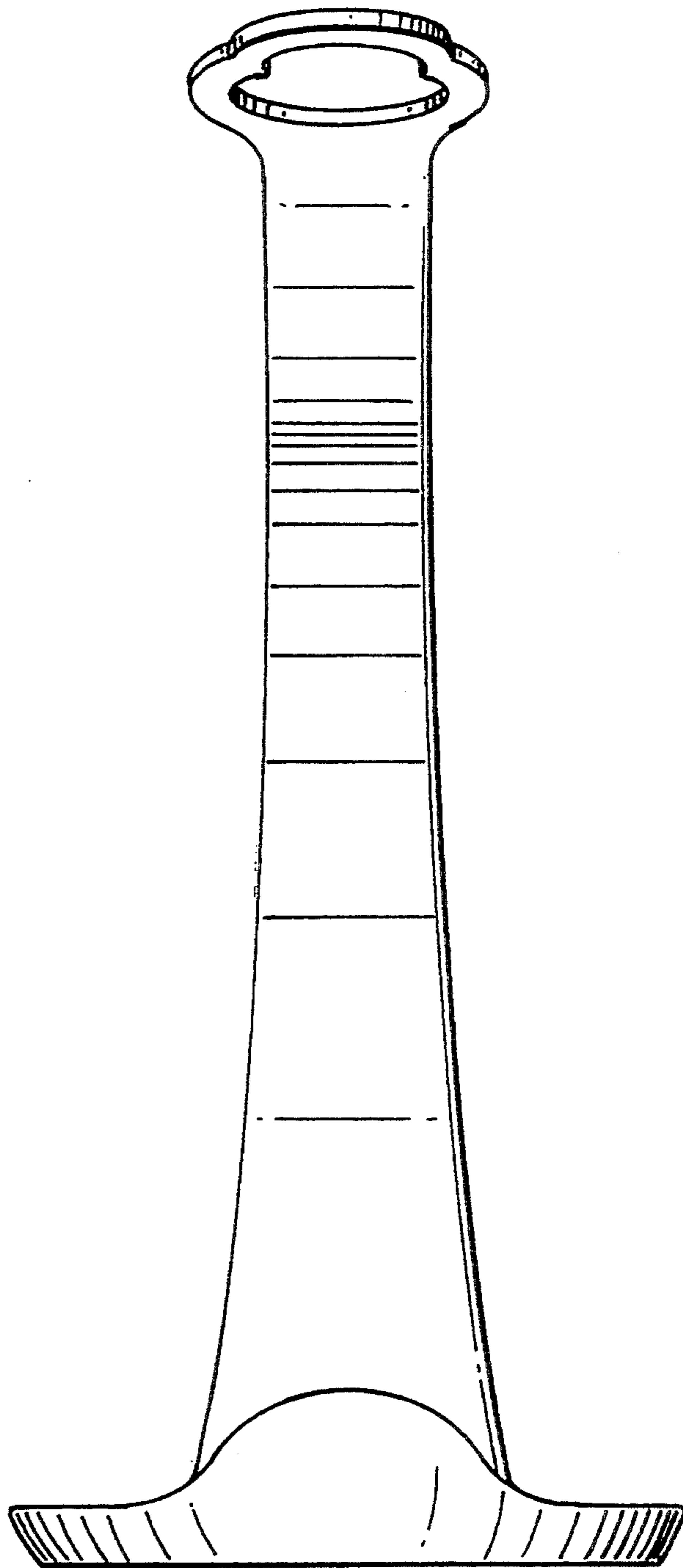
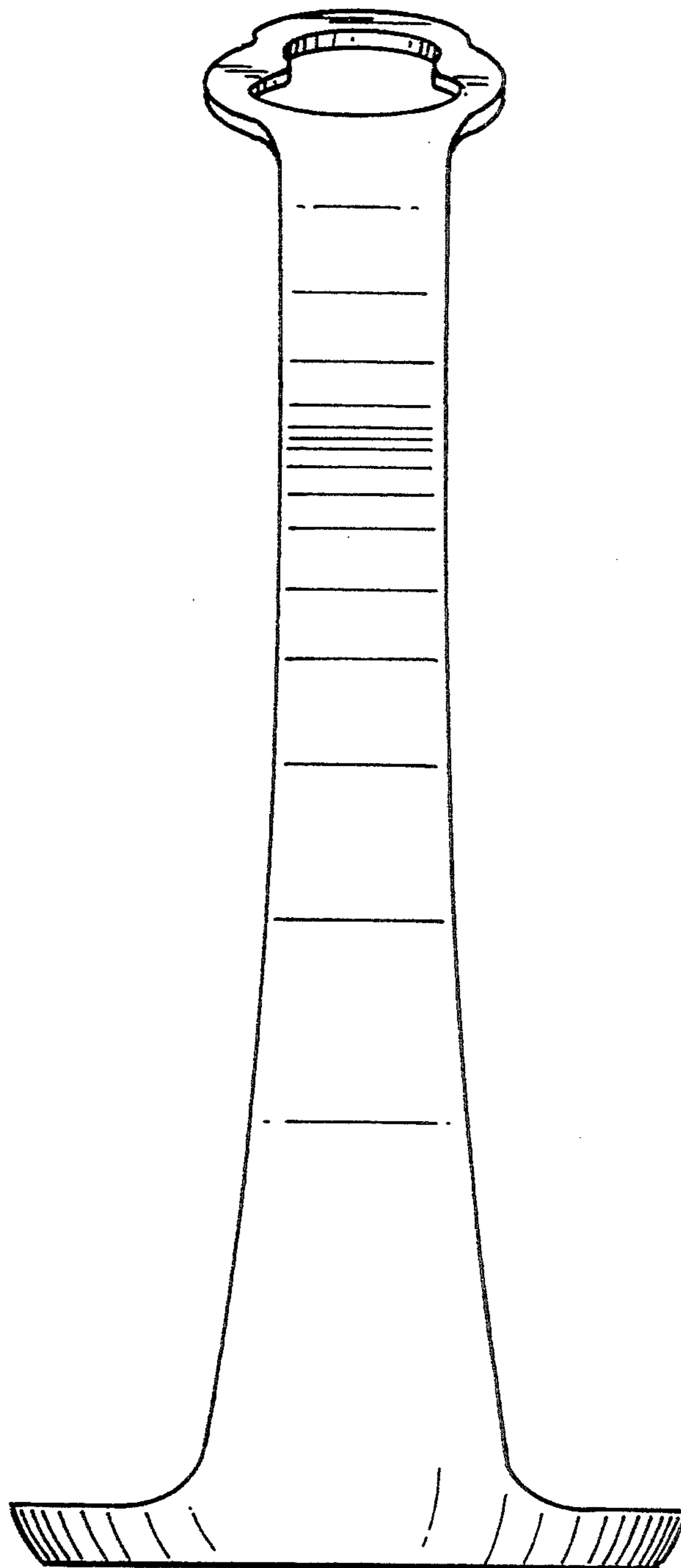

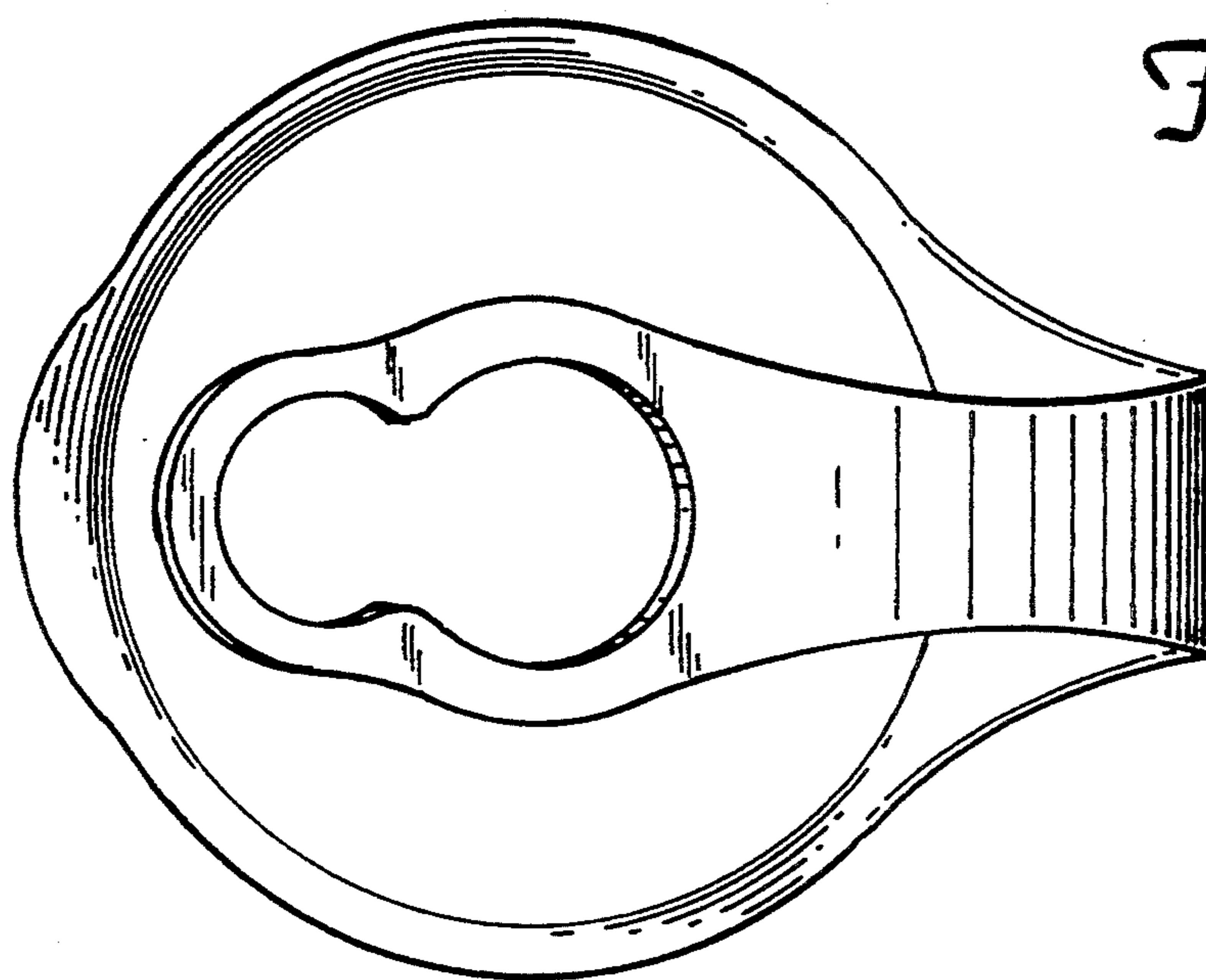
