[57] CLAIM

The ornamental design for a game toy, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view, taken from the top and left side of our game toy, with a portion shown in phantom lines for environmental purposes only; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a rear view thereof; and, FIG. 6 is a bottom plan view thereof.

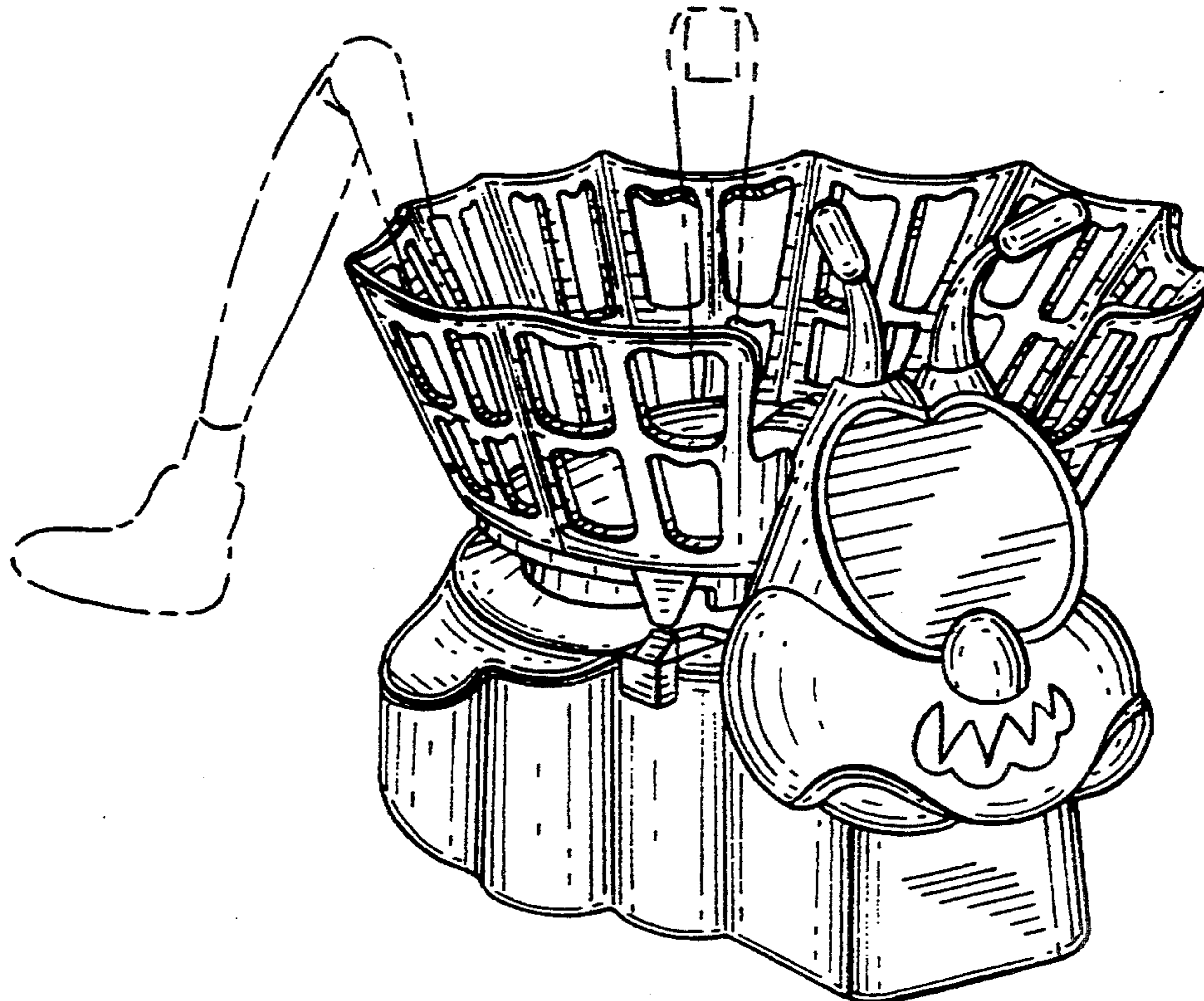

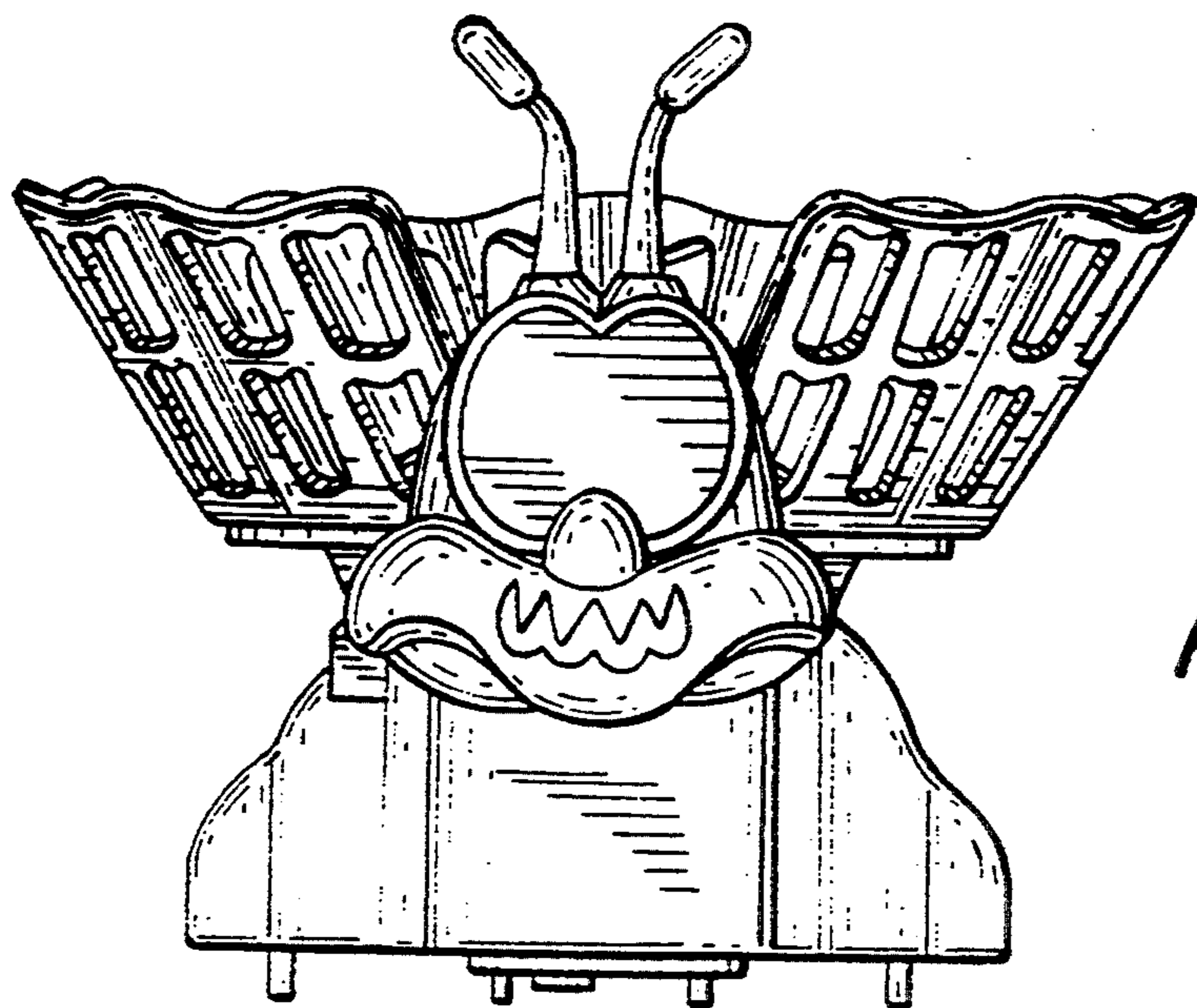
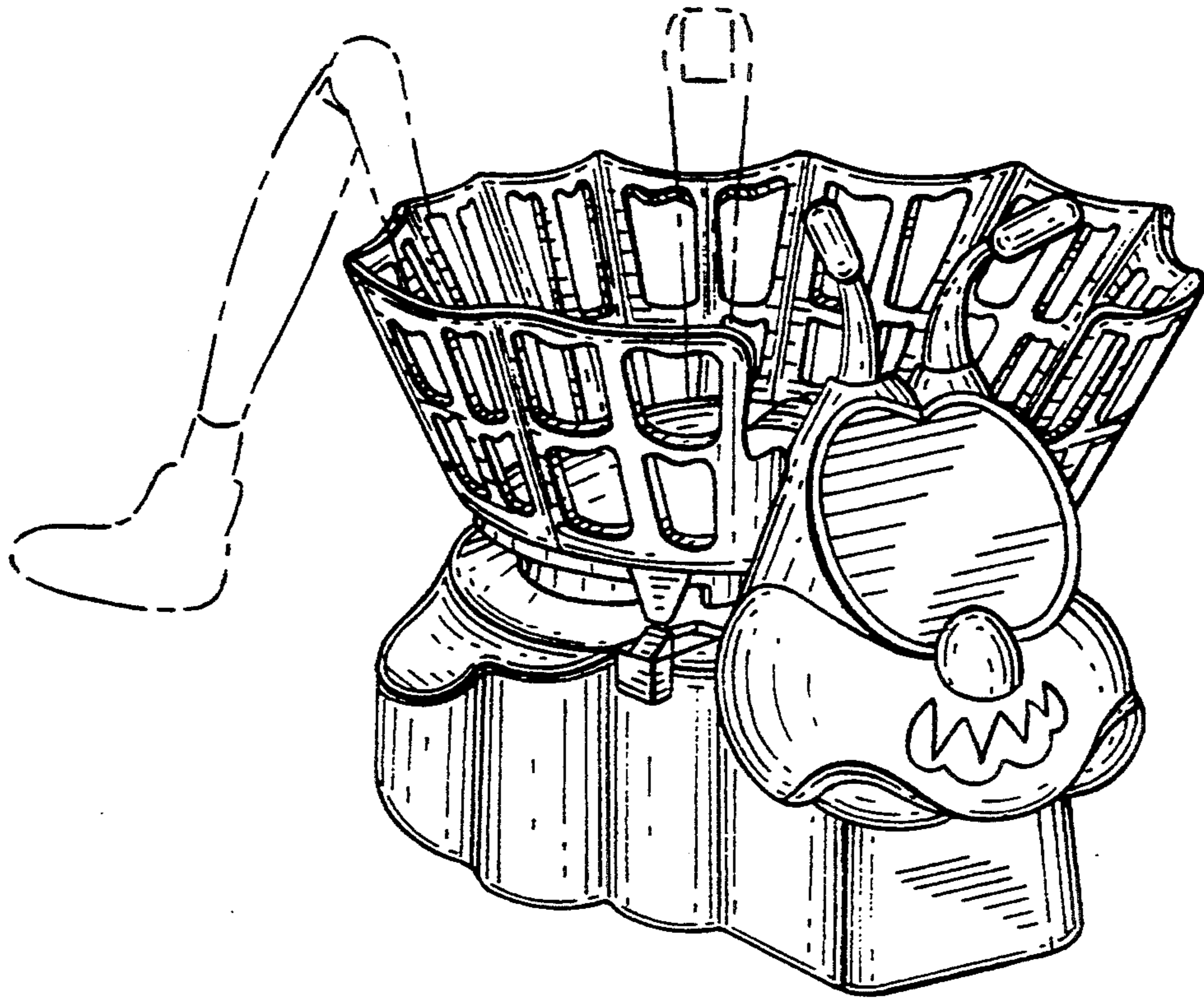

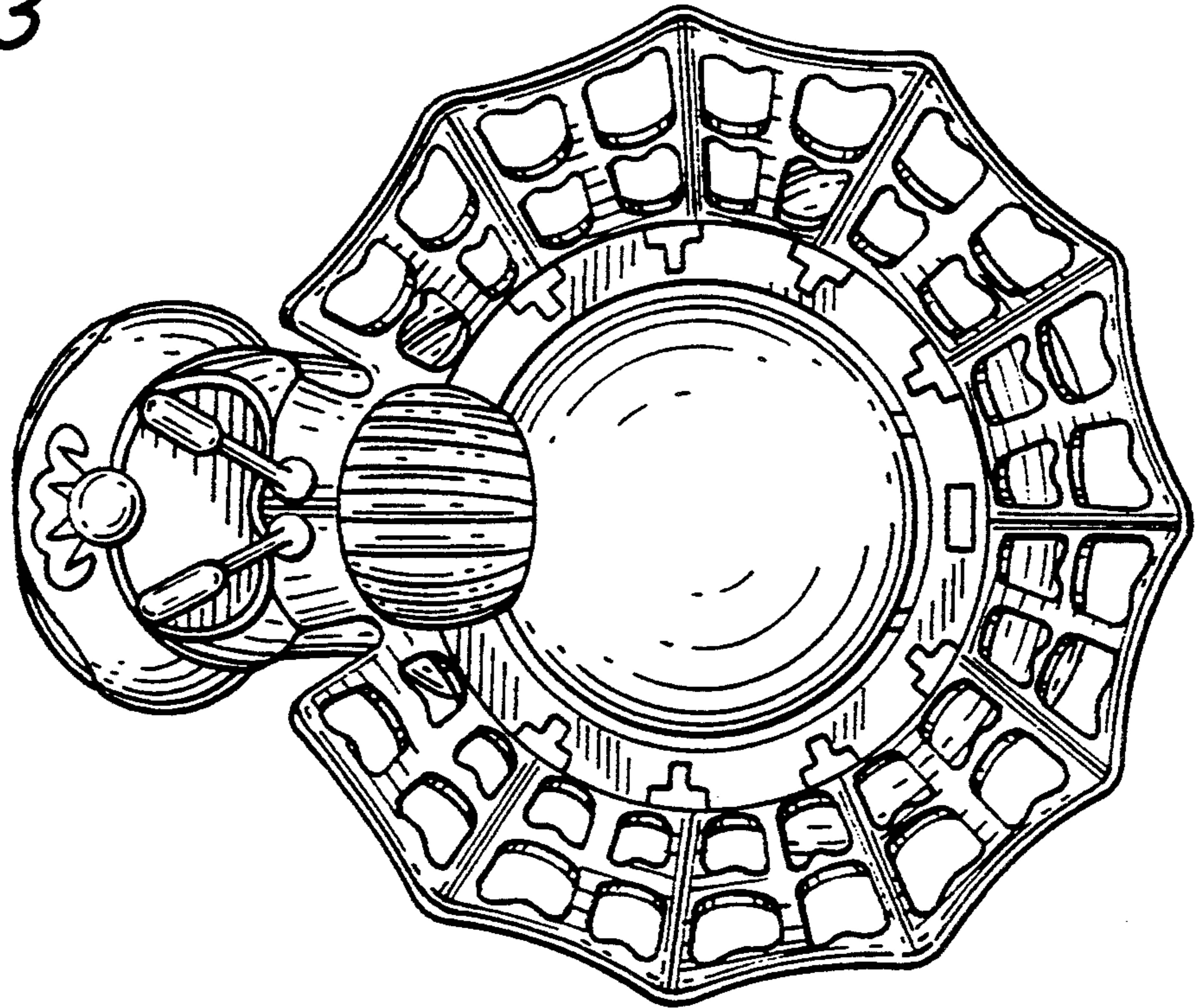

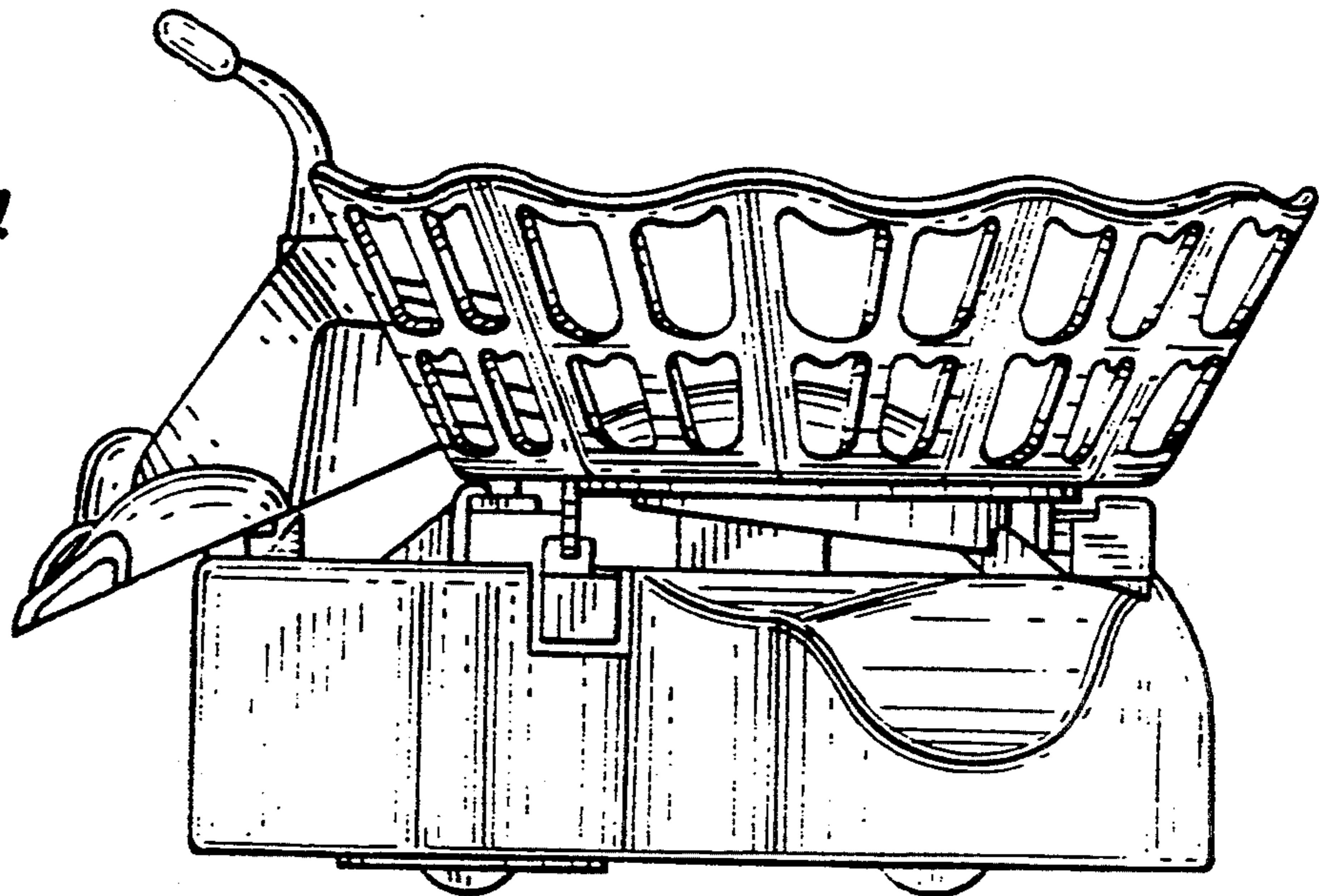

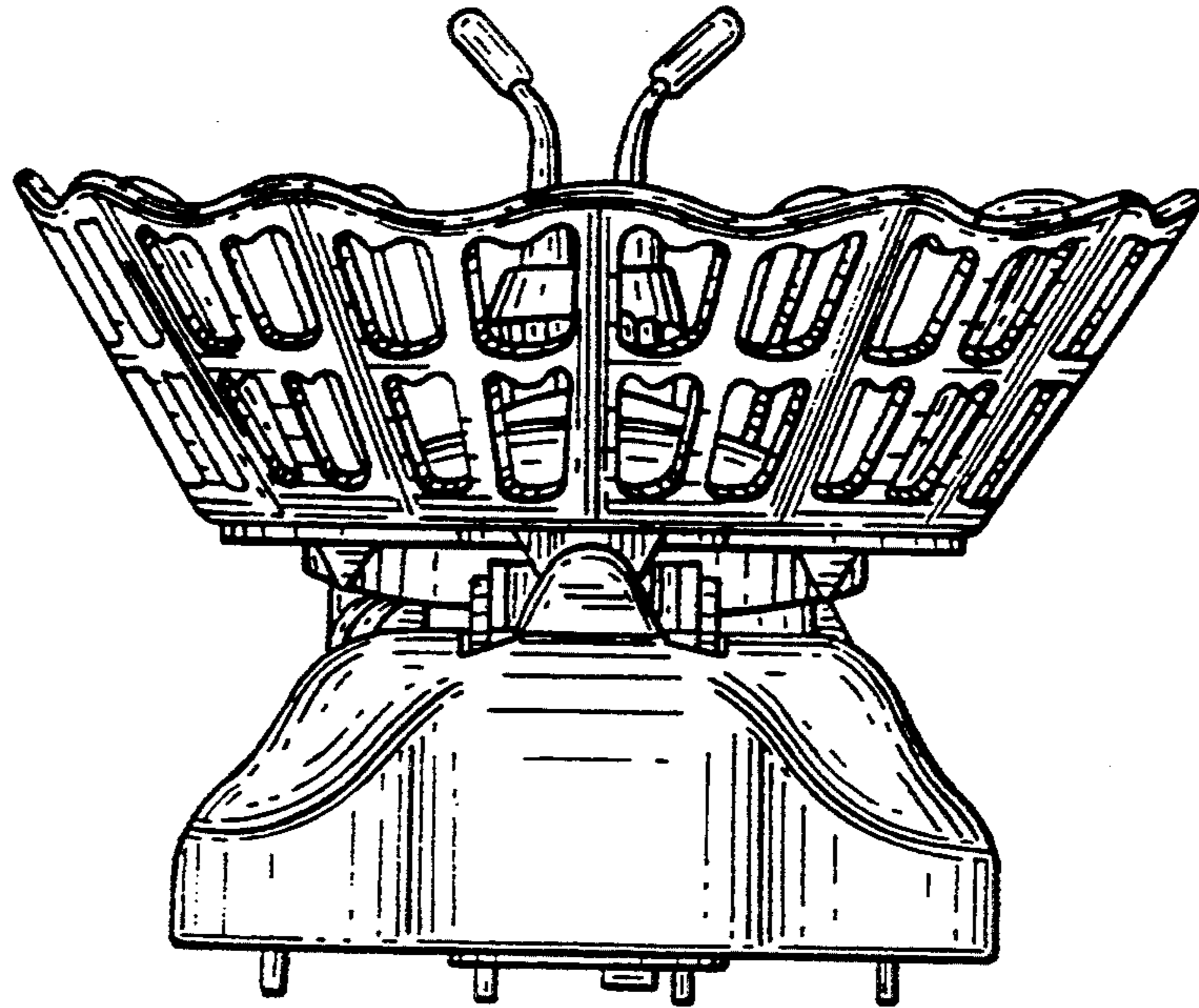
