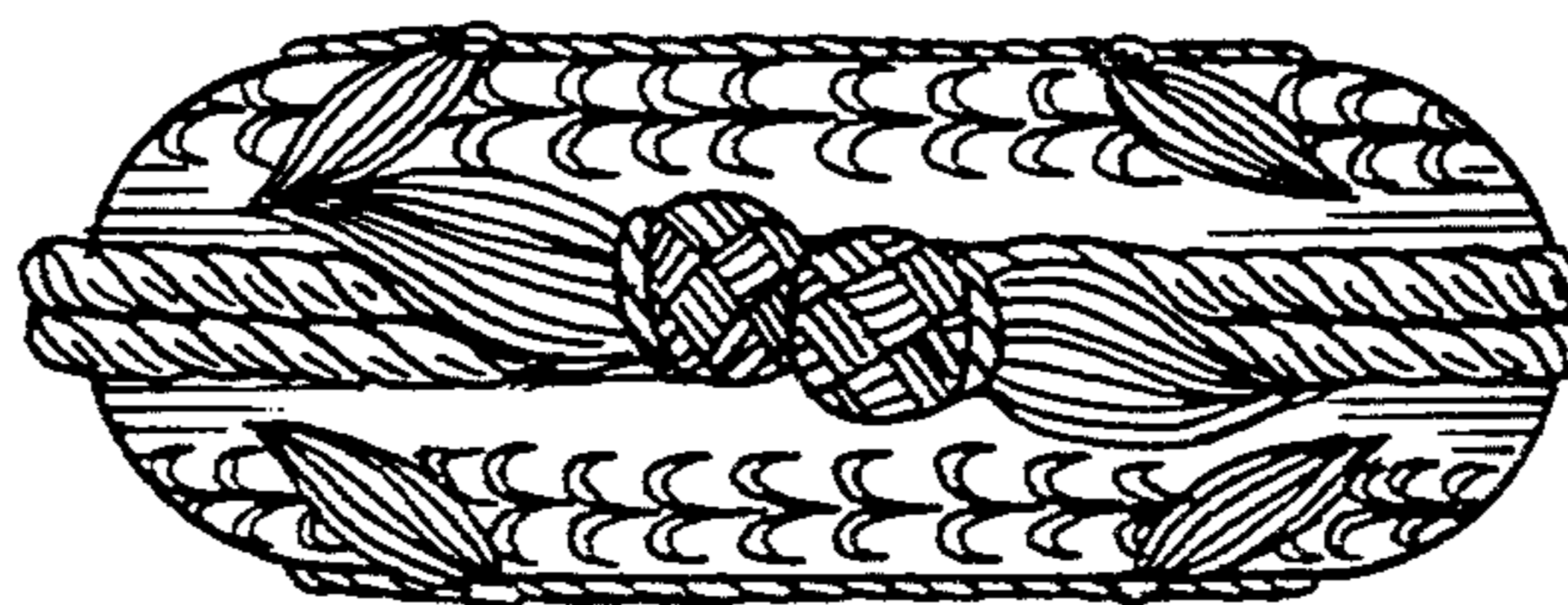
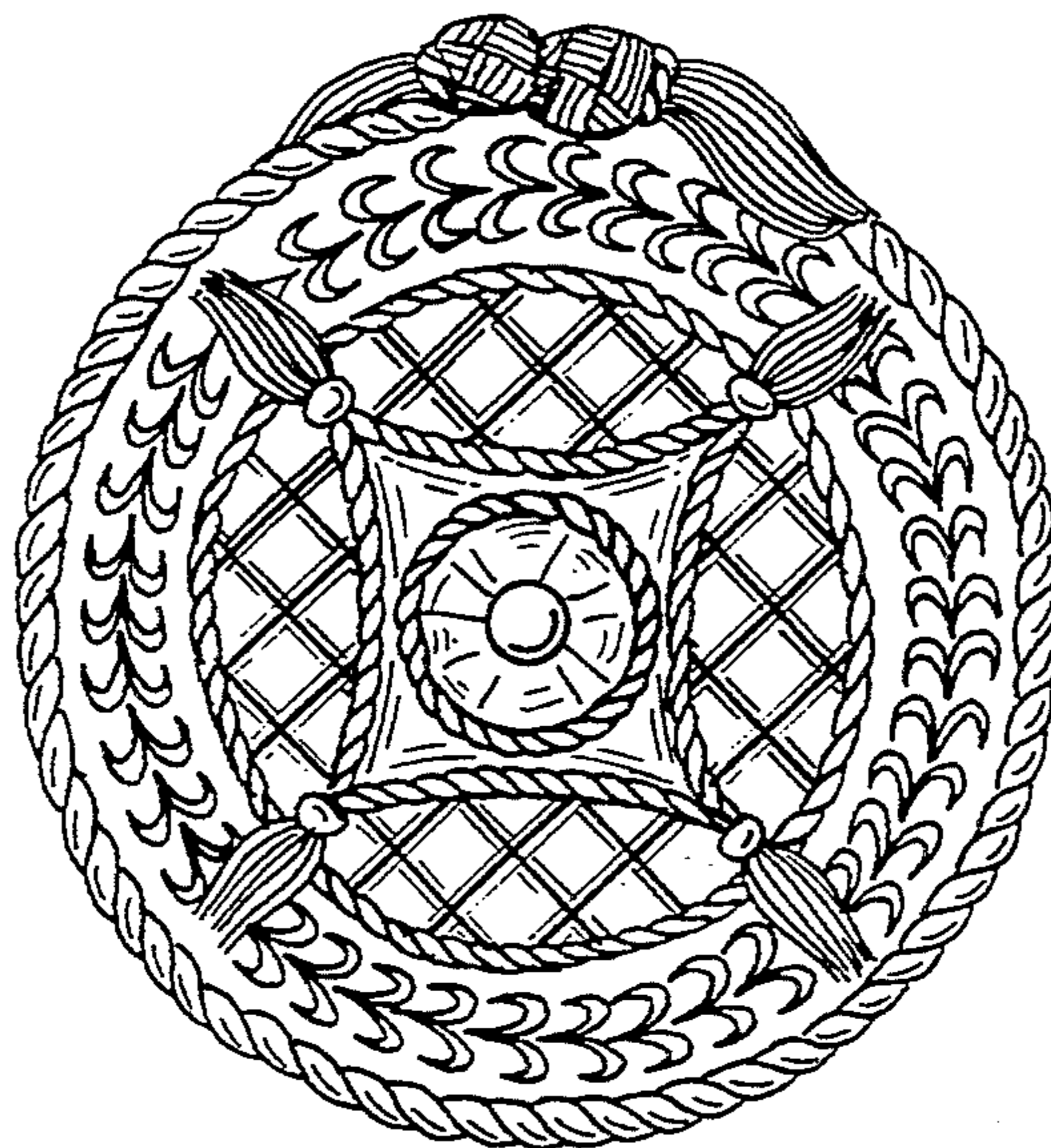

The ornamental design for a compact design, as shown and described.

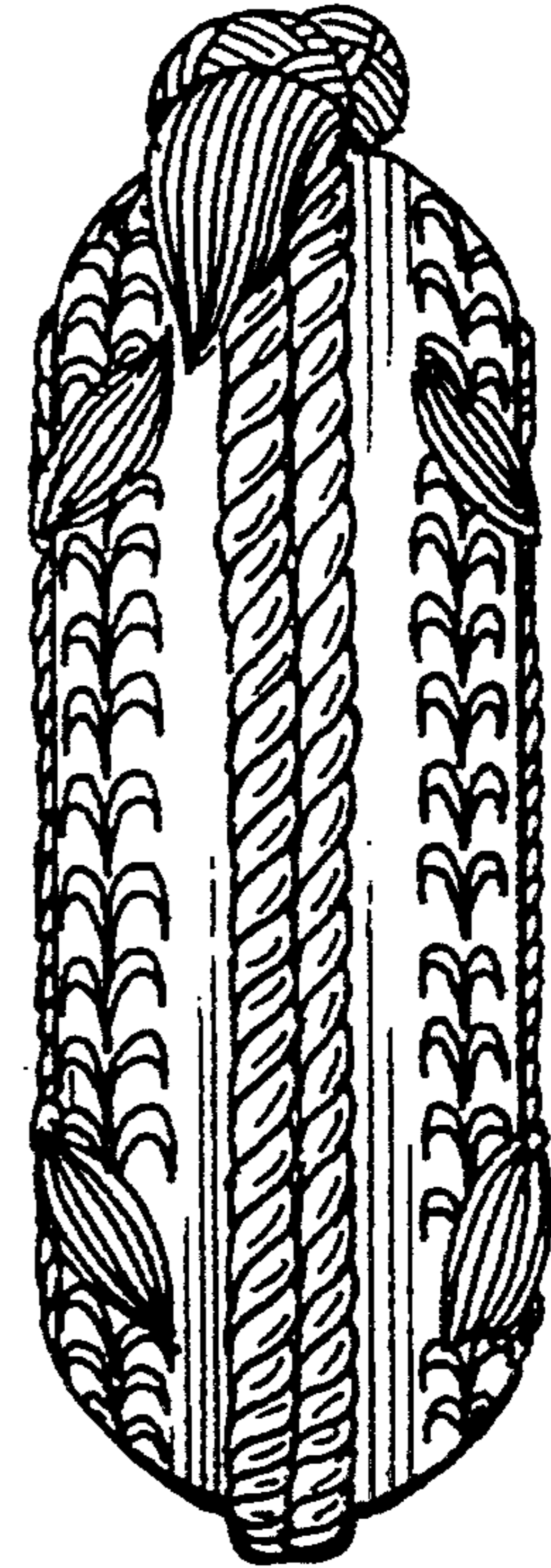
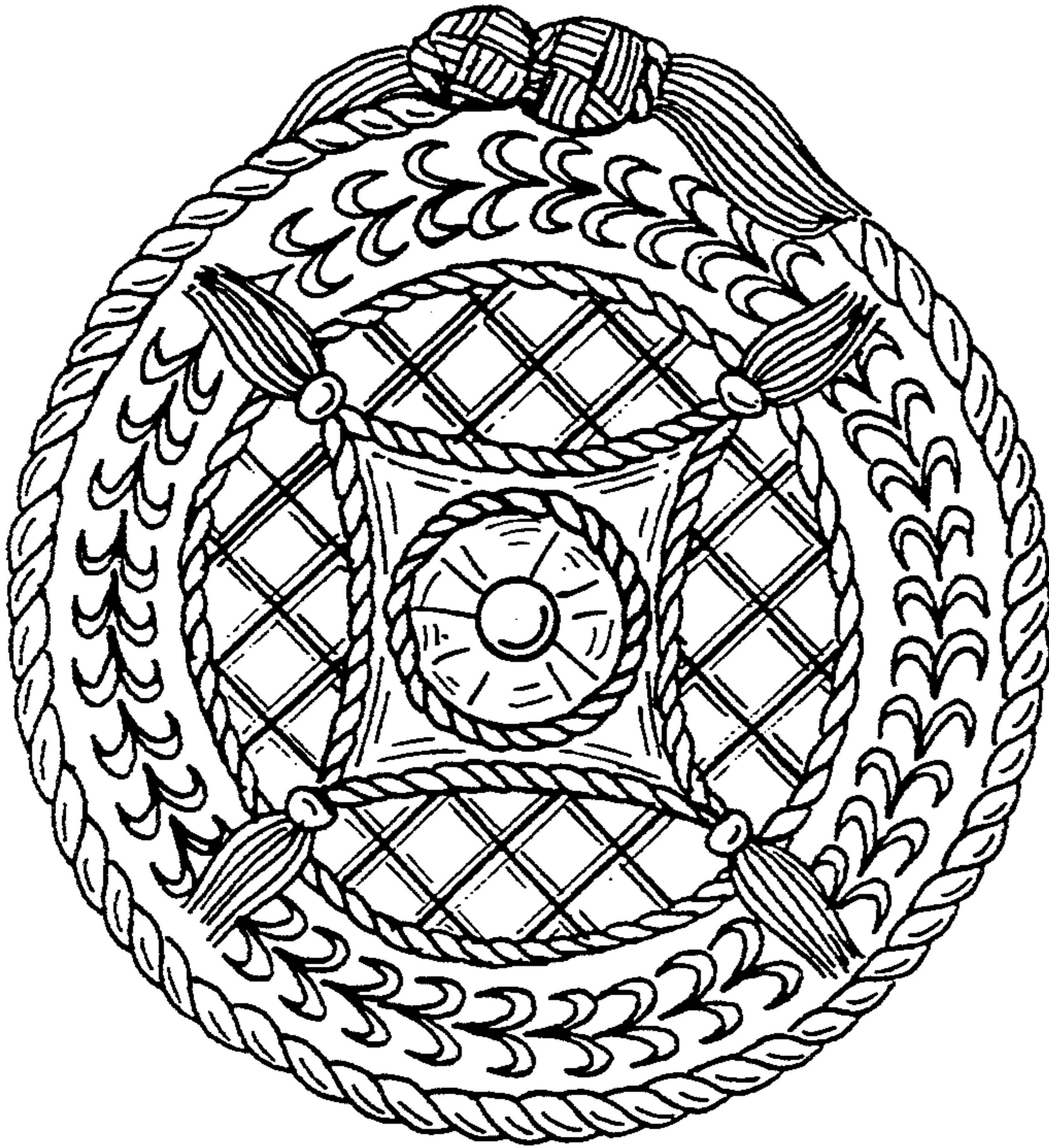
### DESCRIPTION

 FIG. 6 is another side elevational view thereof, as seen from the bottom in FIG. 1.

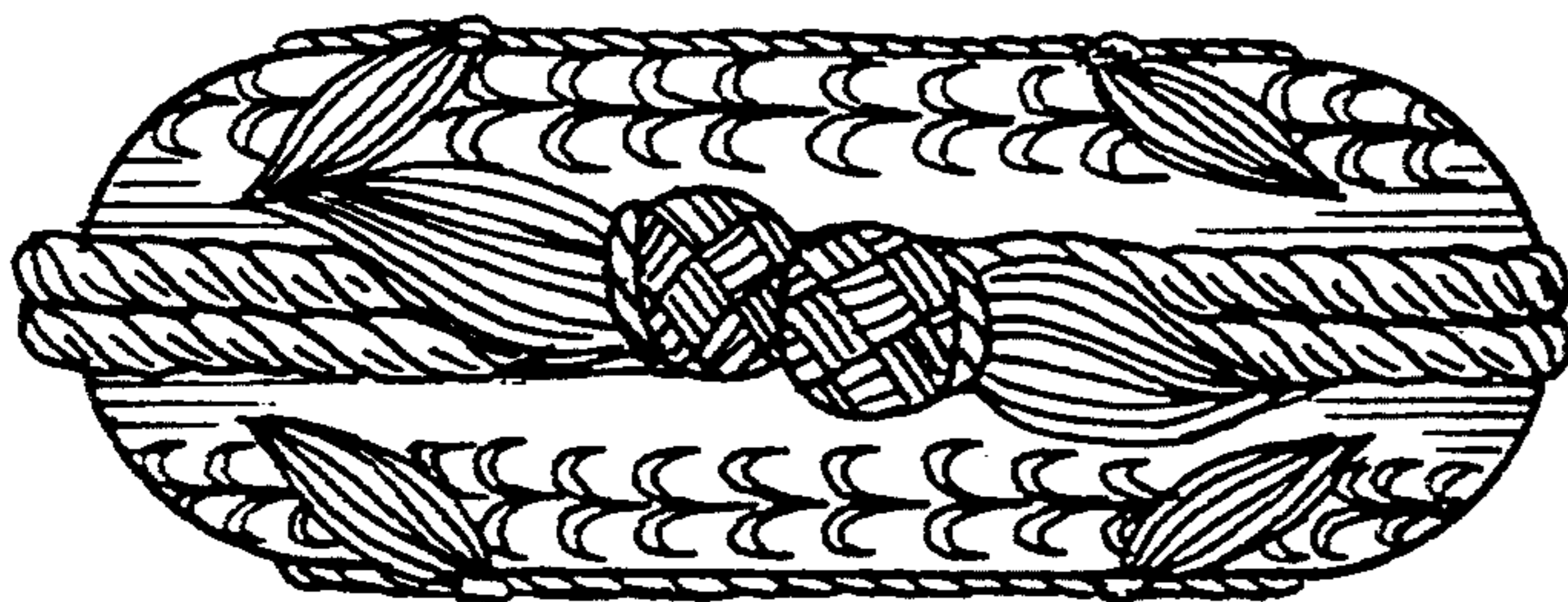

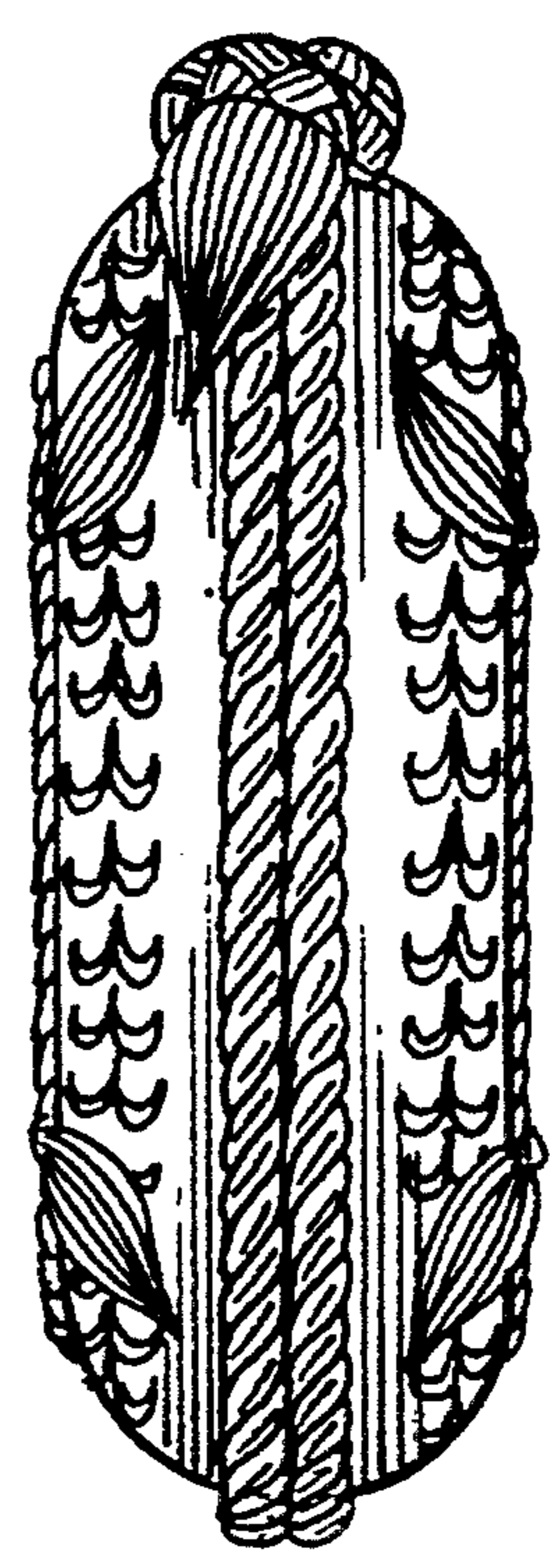
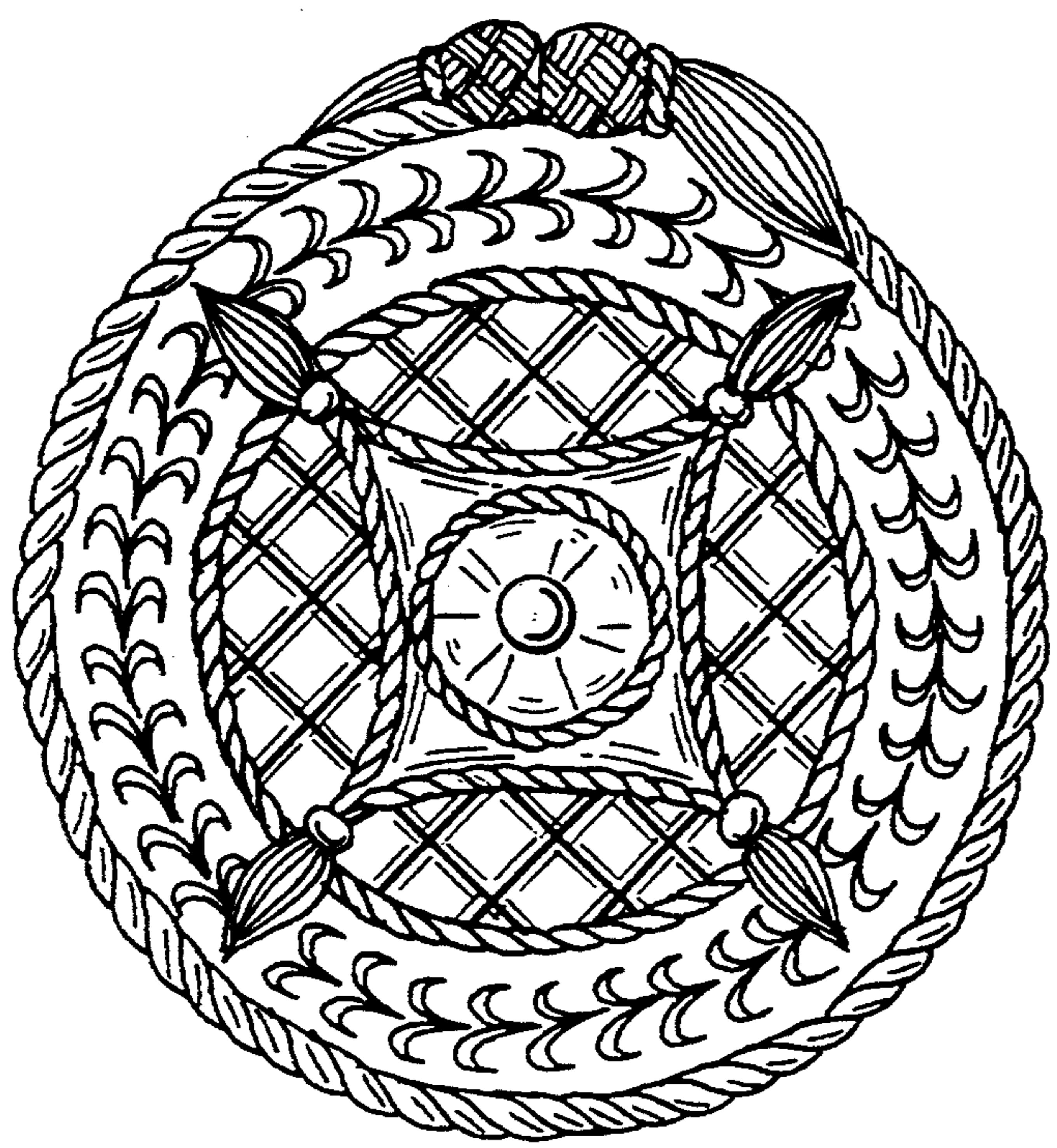
