DESCRIPTION

 FIG. 18 is a bottom plan view thereof.

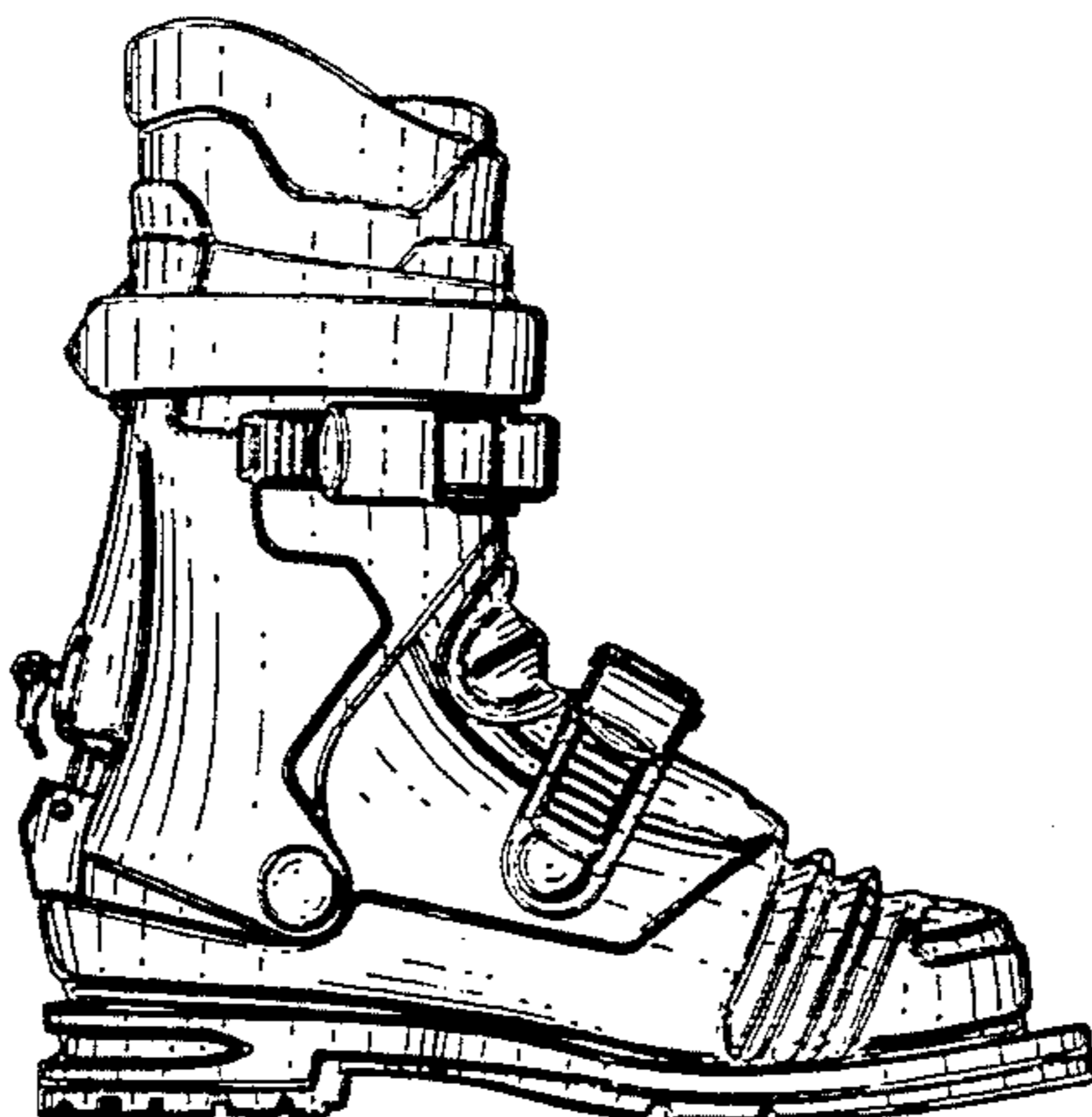
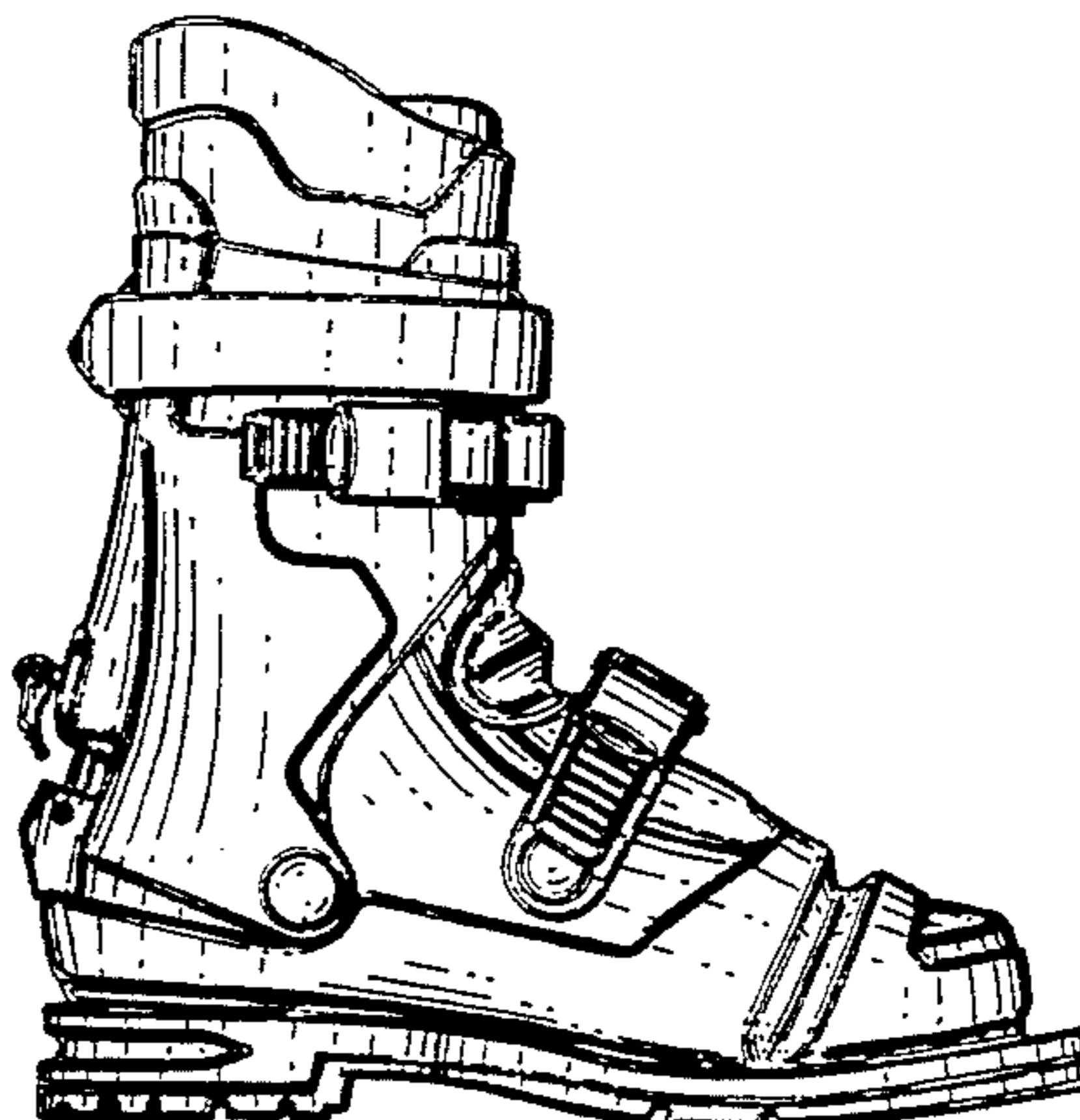

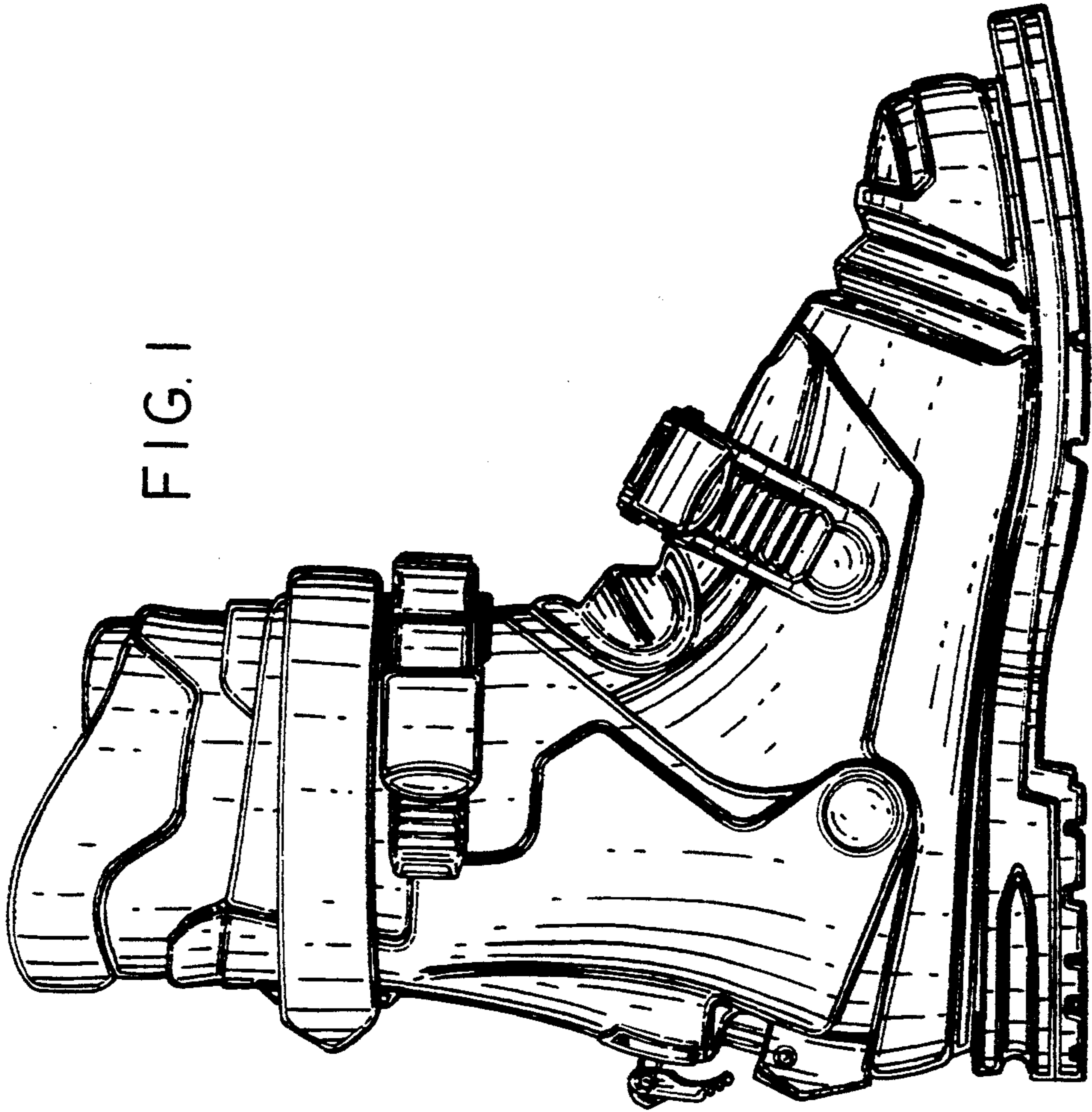
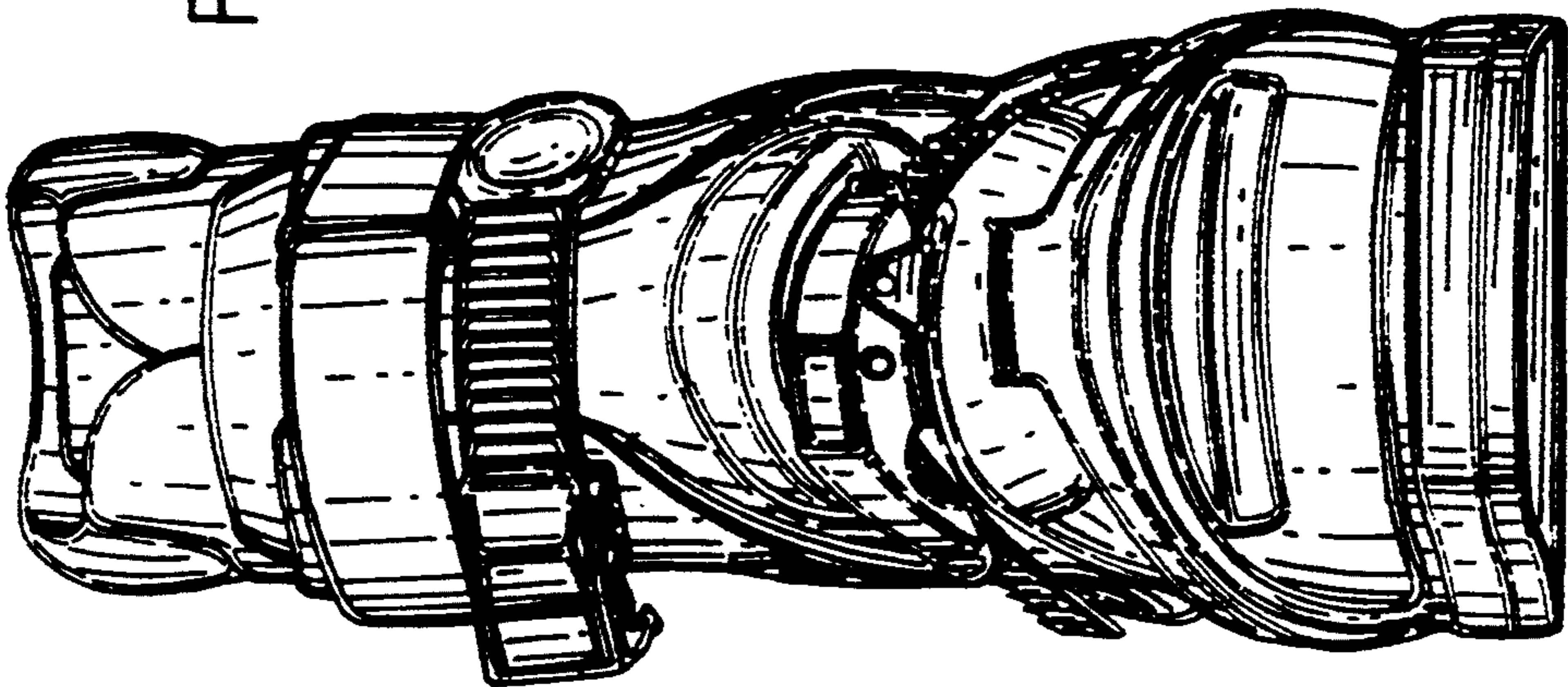

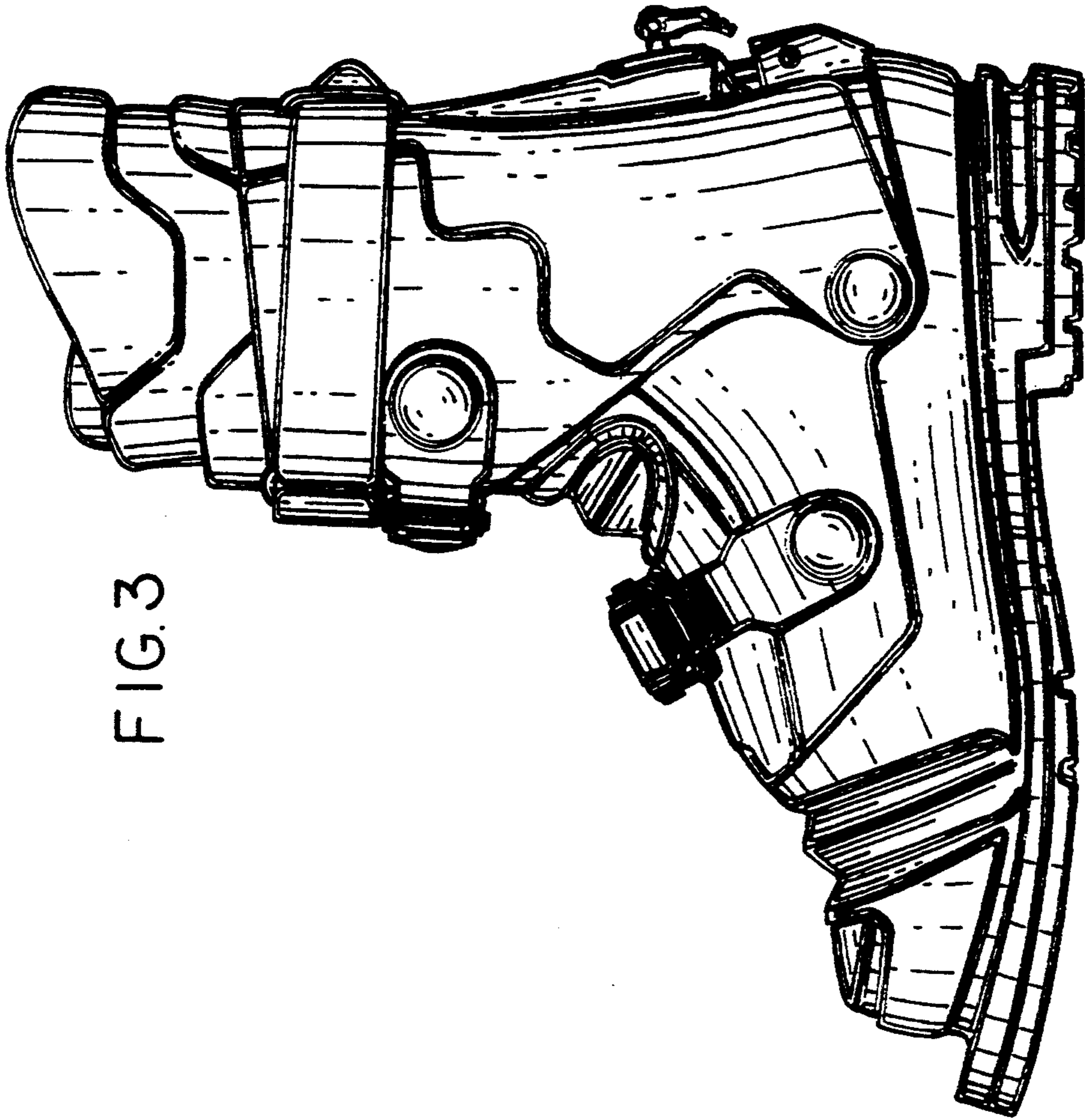

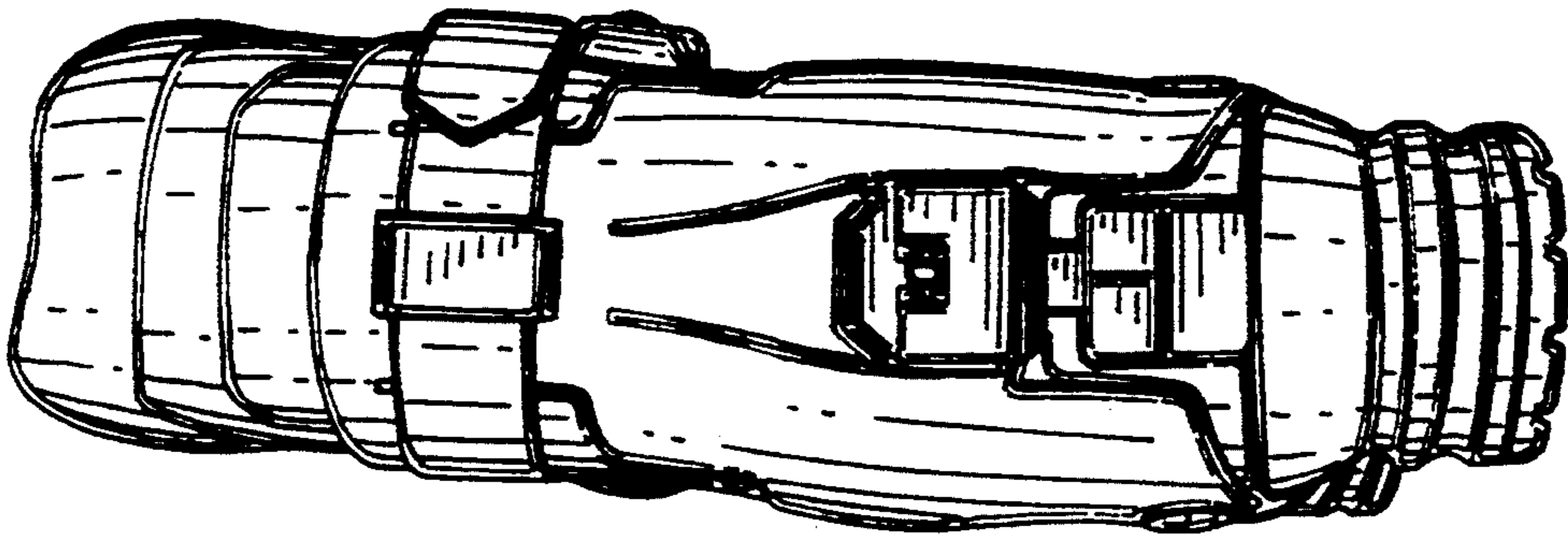

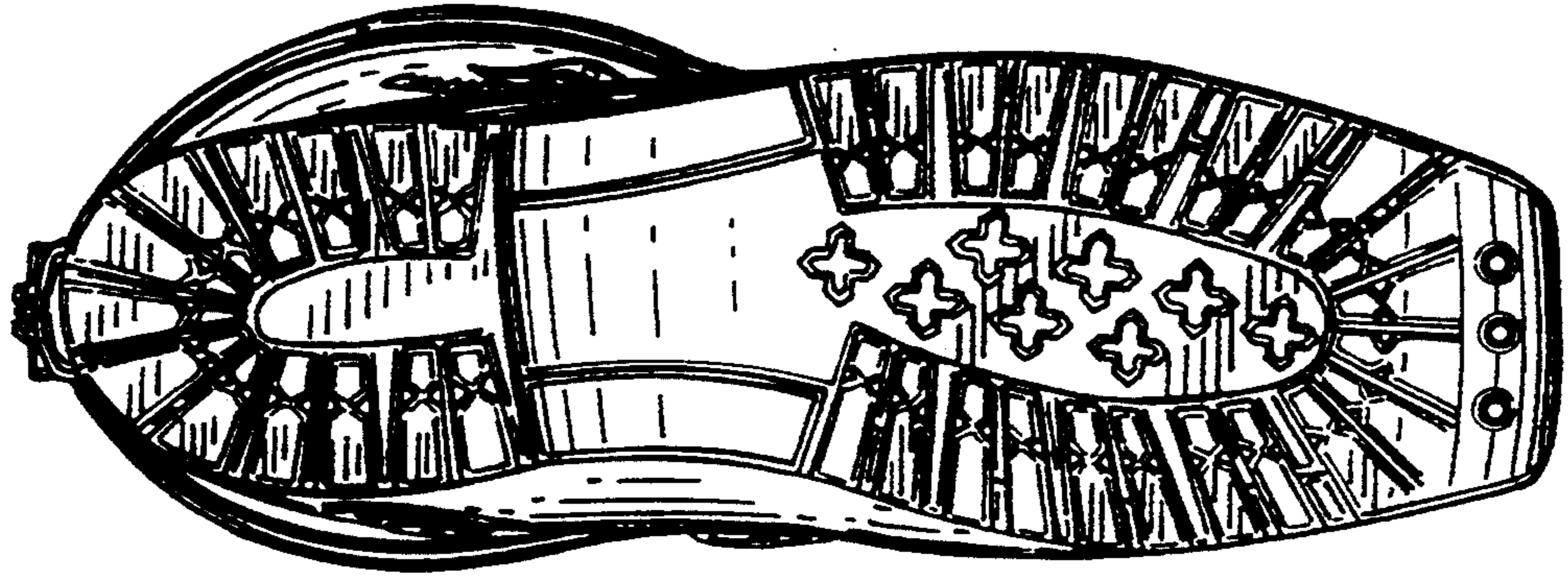

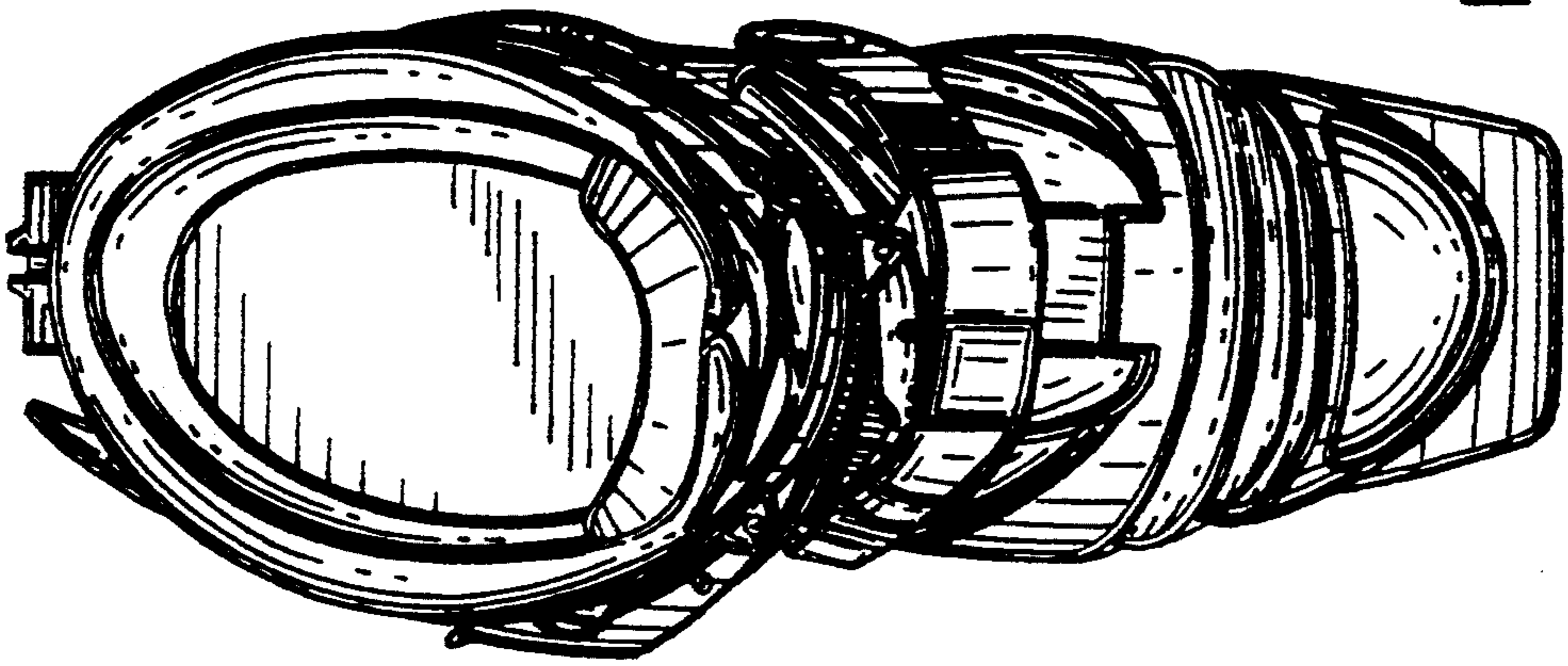

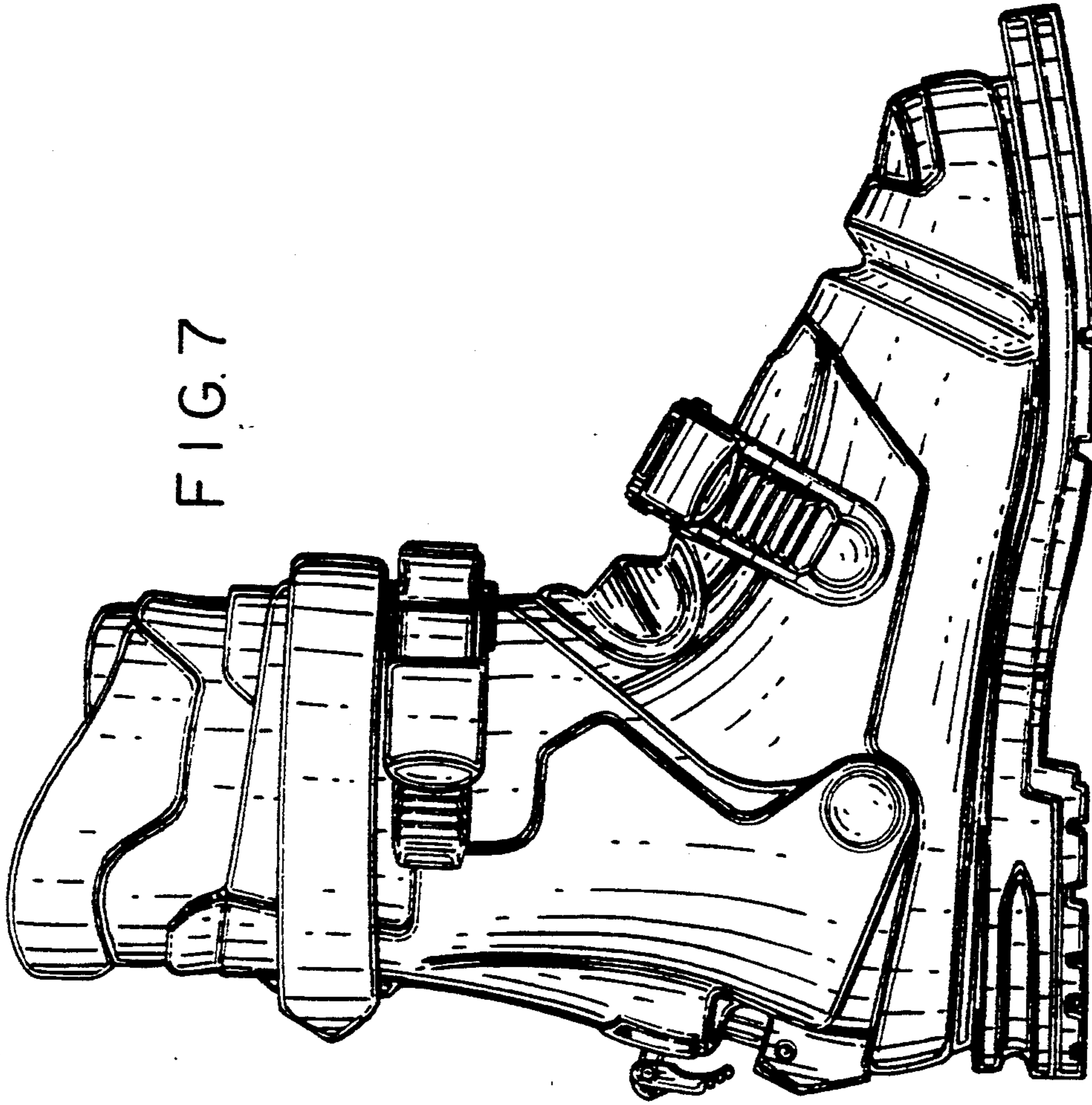

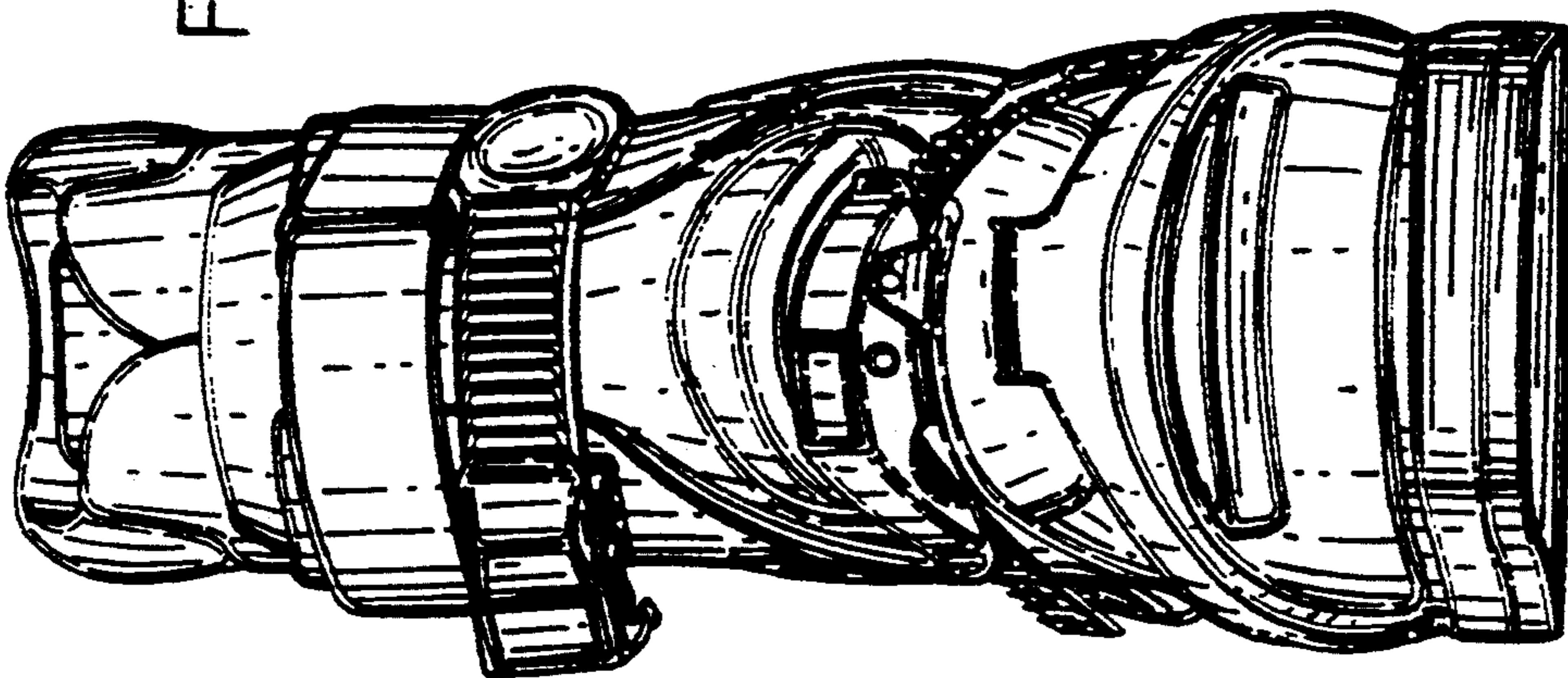

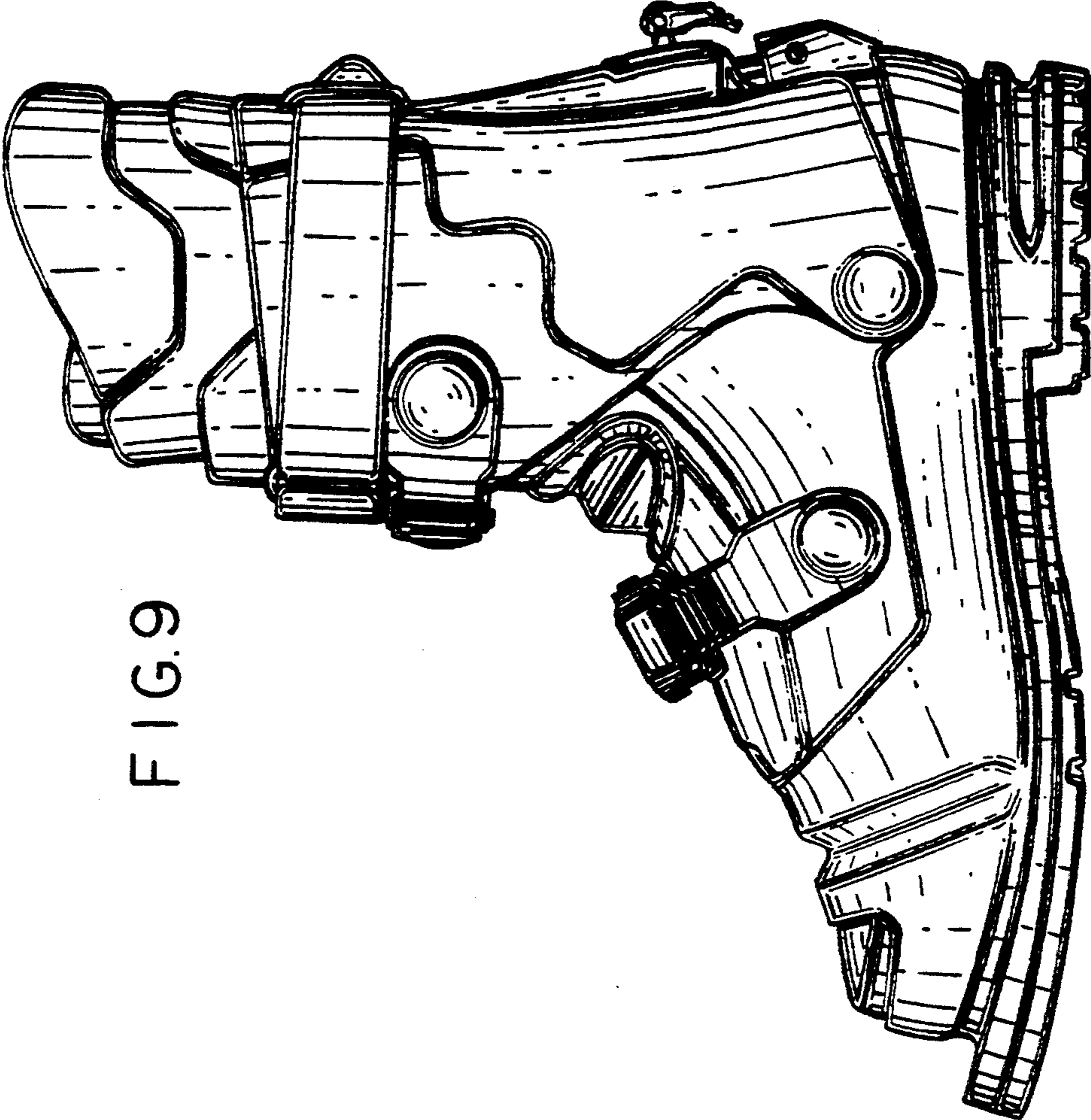

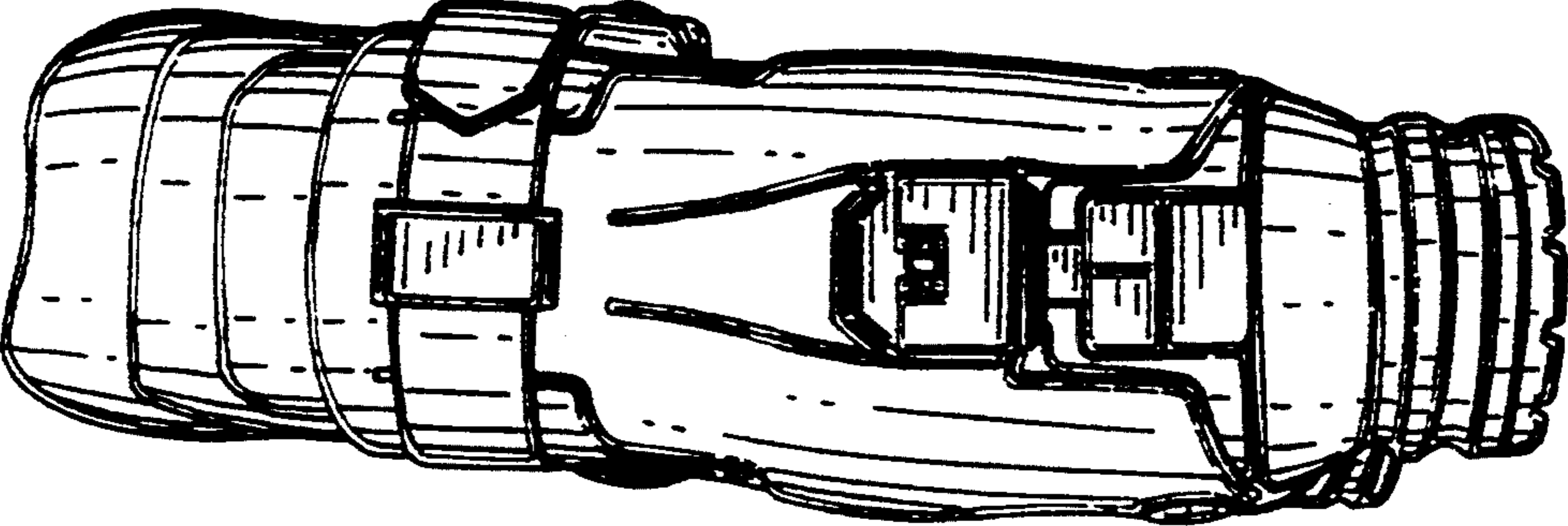

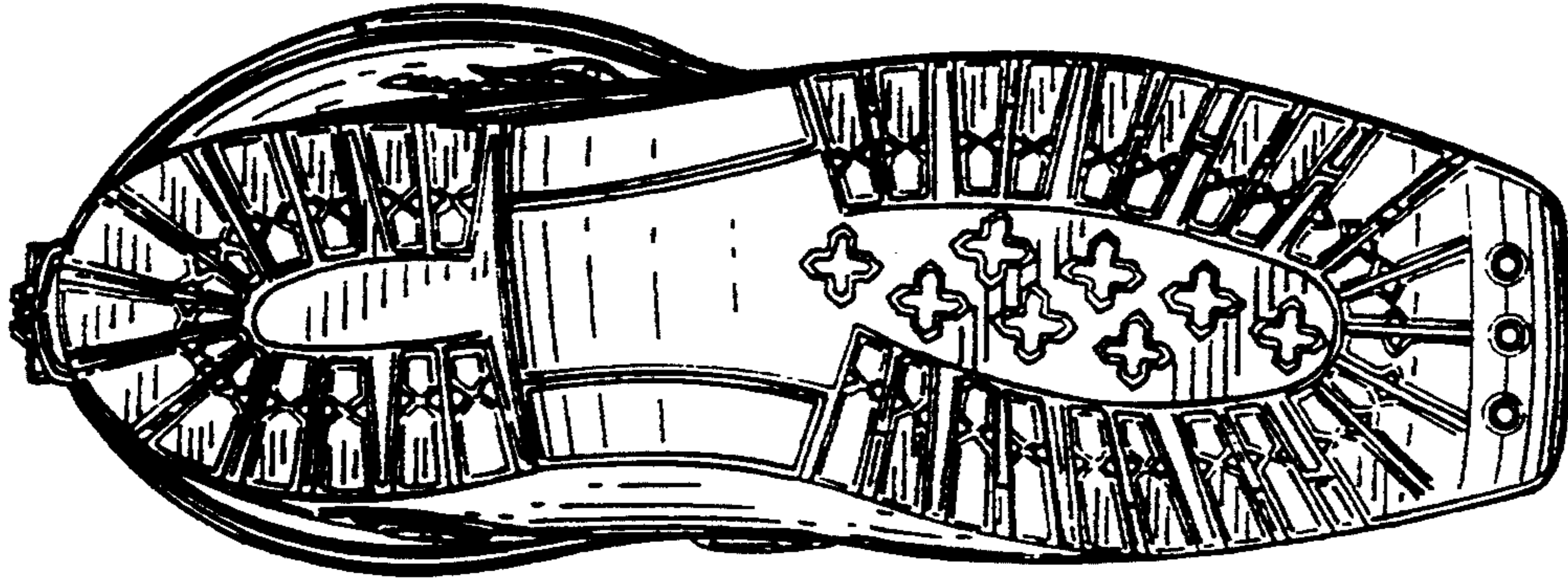

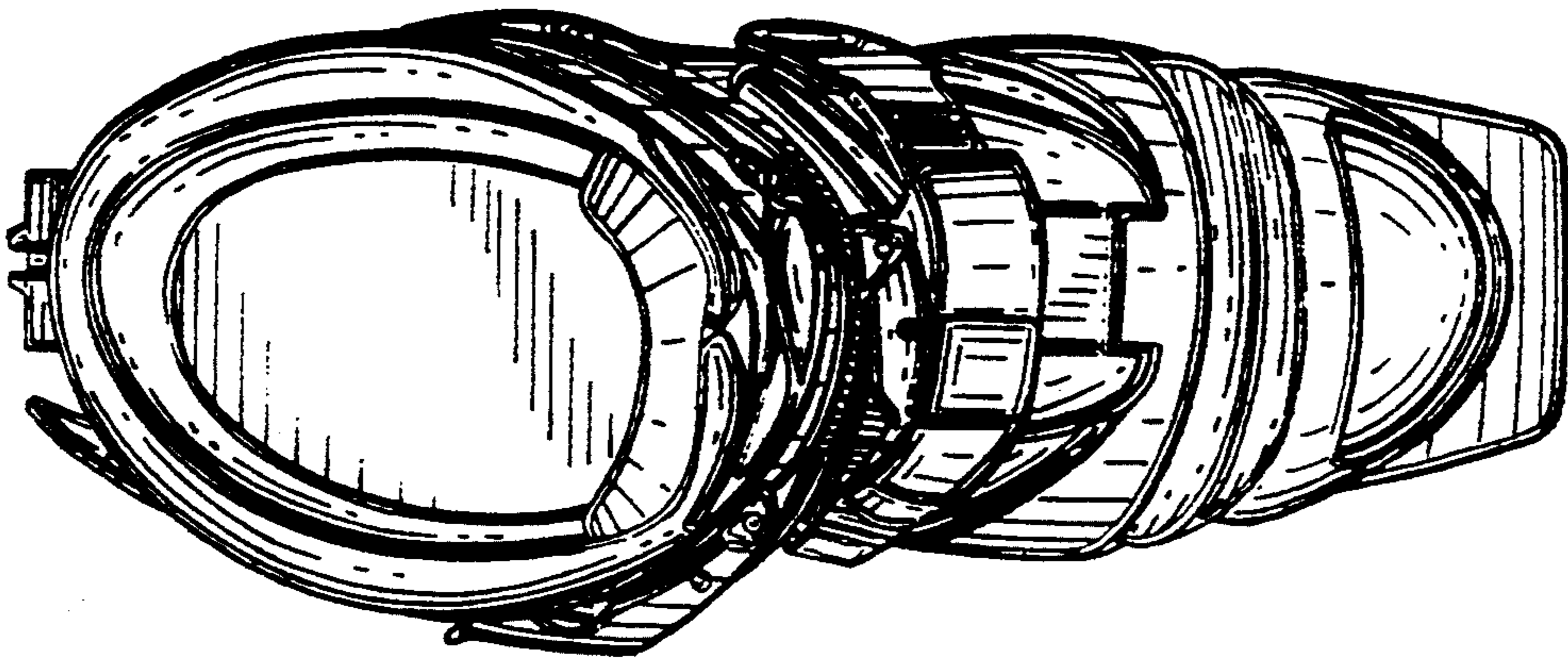

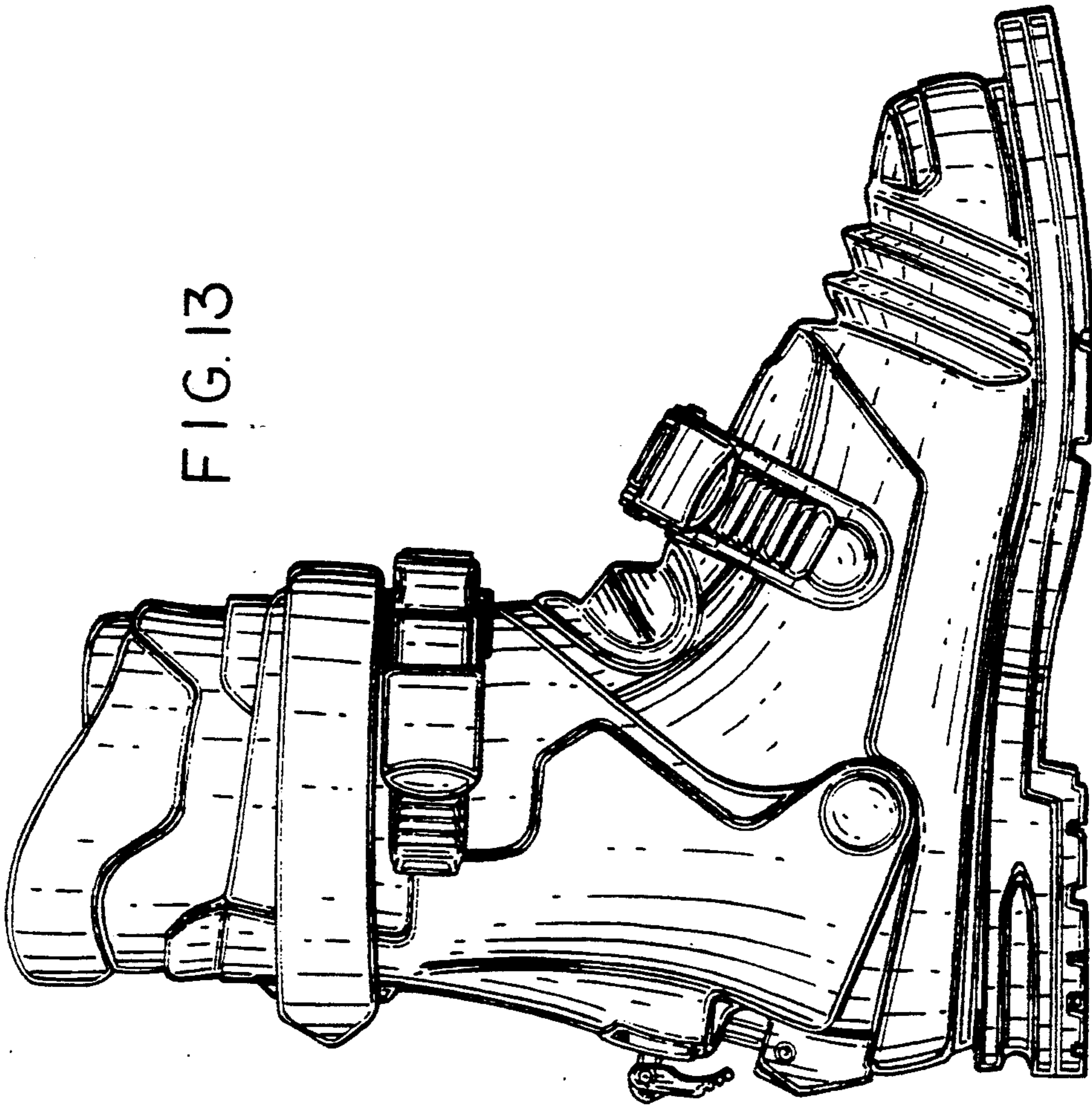
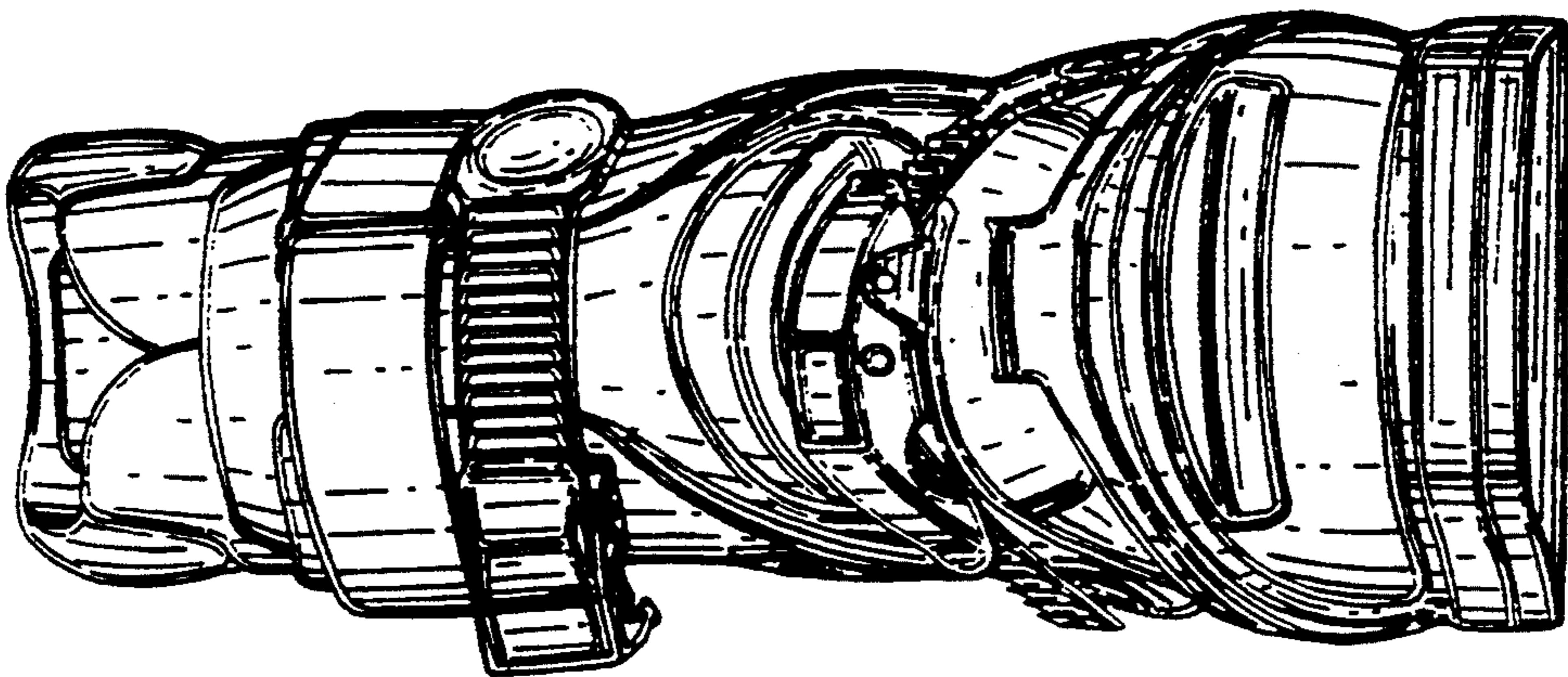

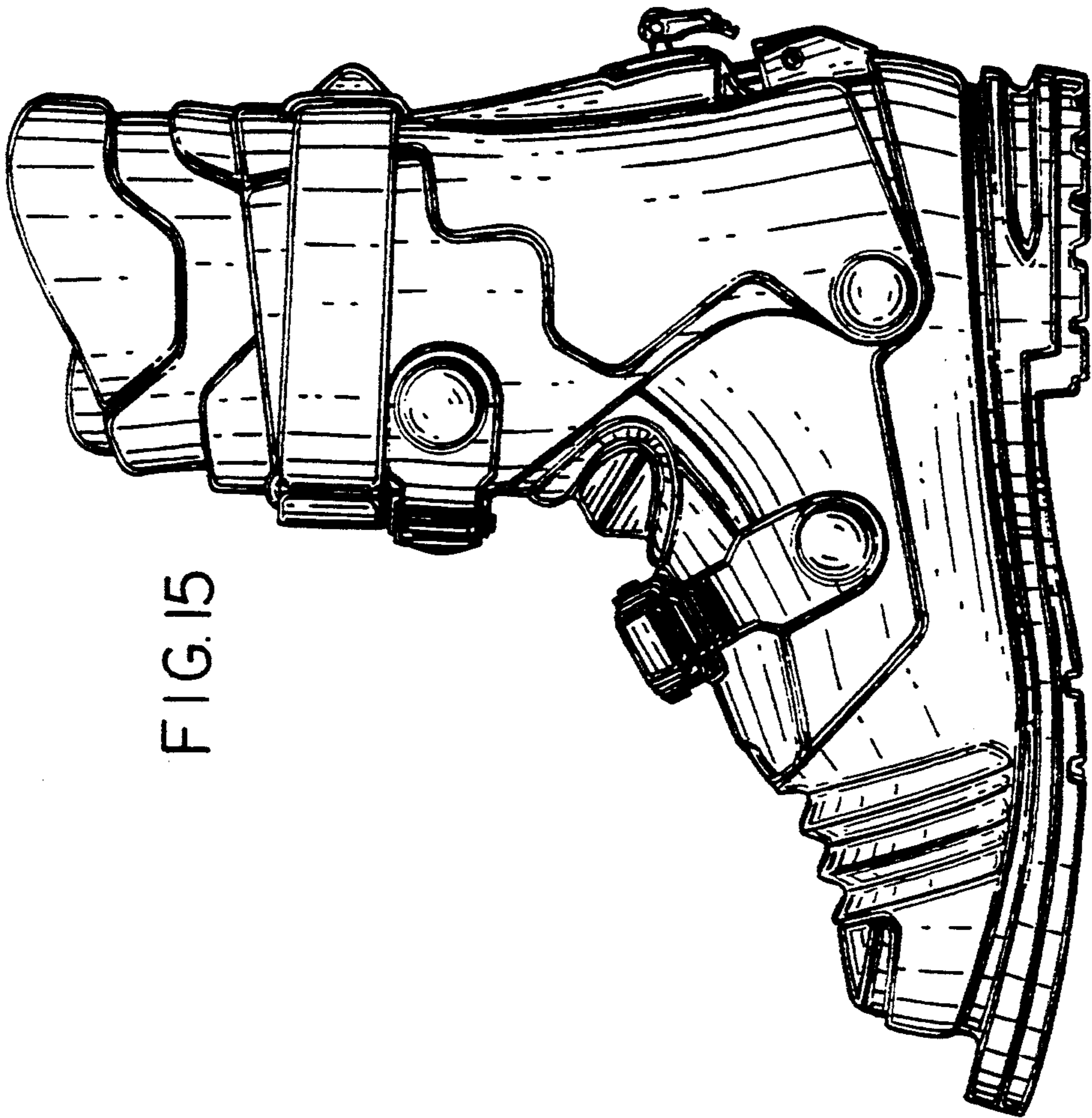

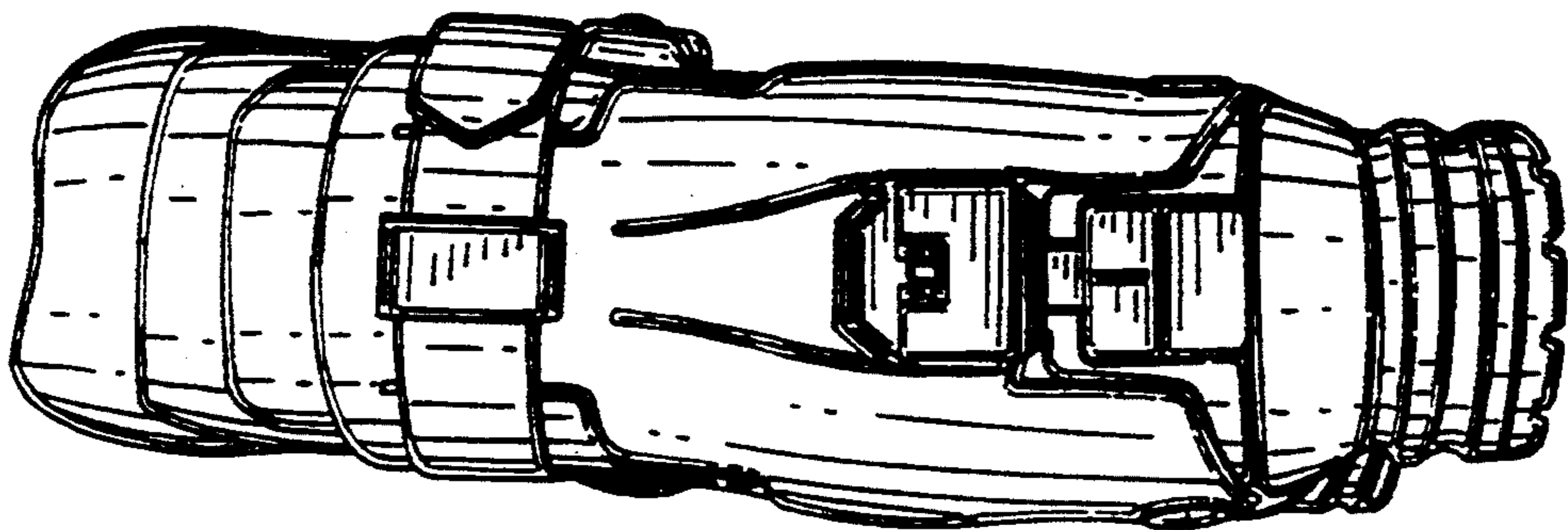

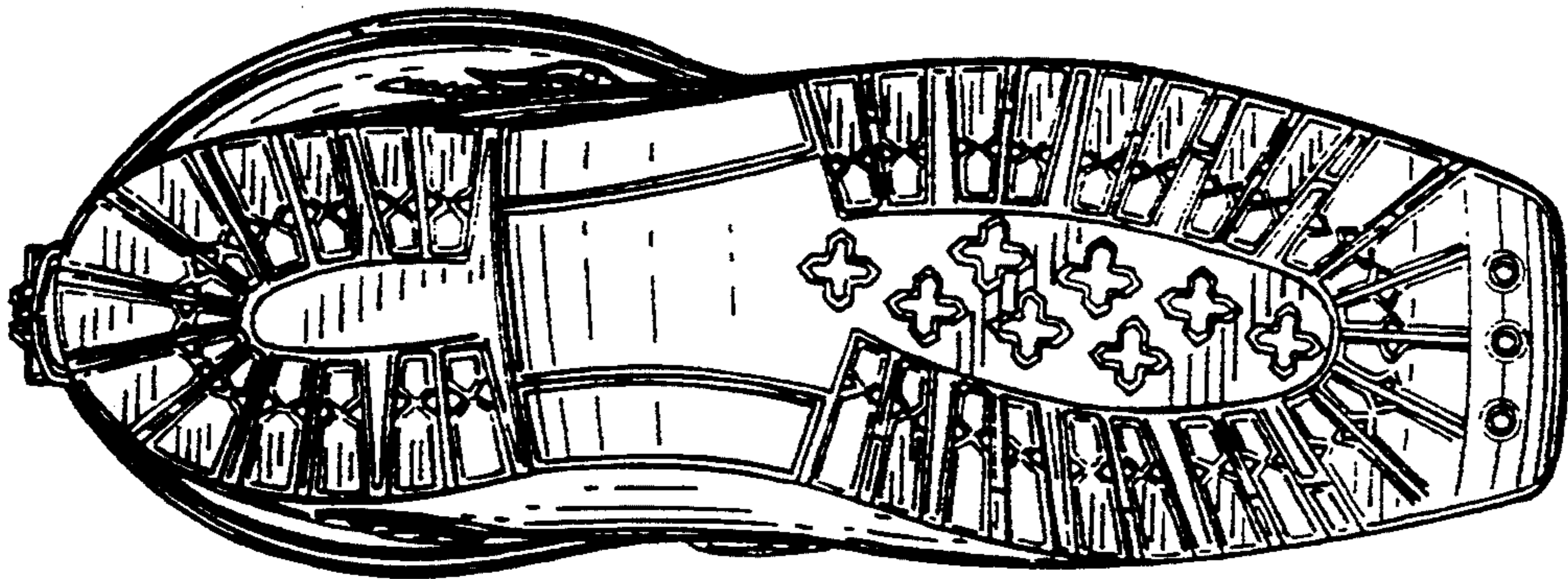
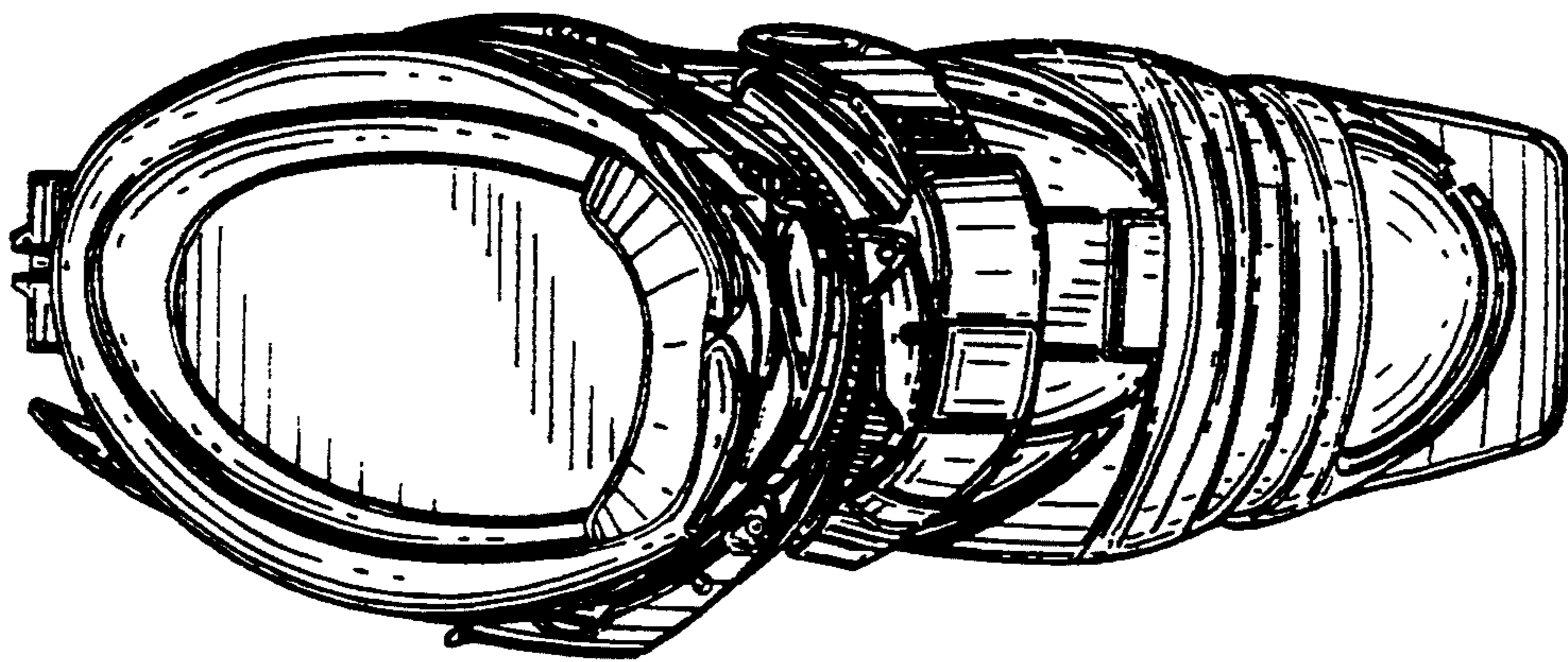


FIG. 17 FIG. 18
