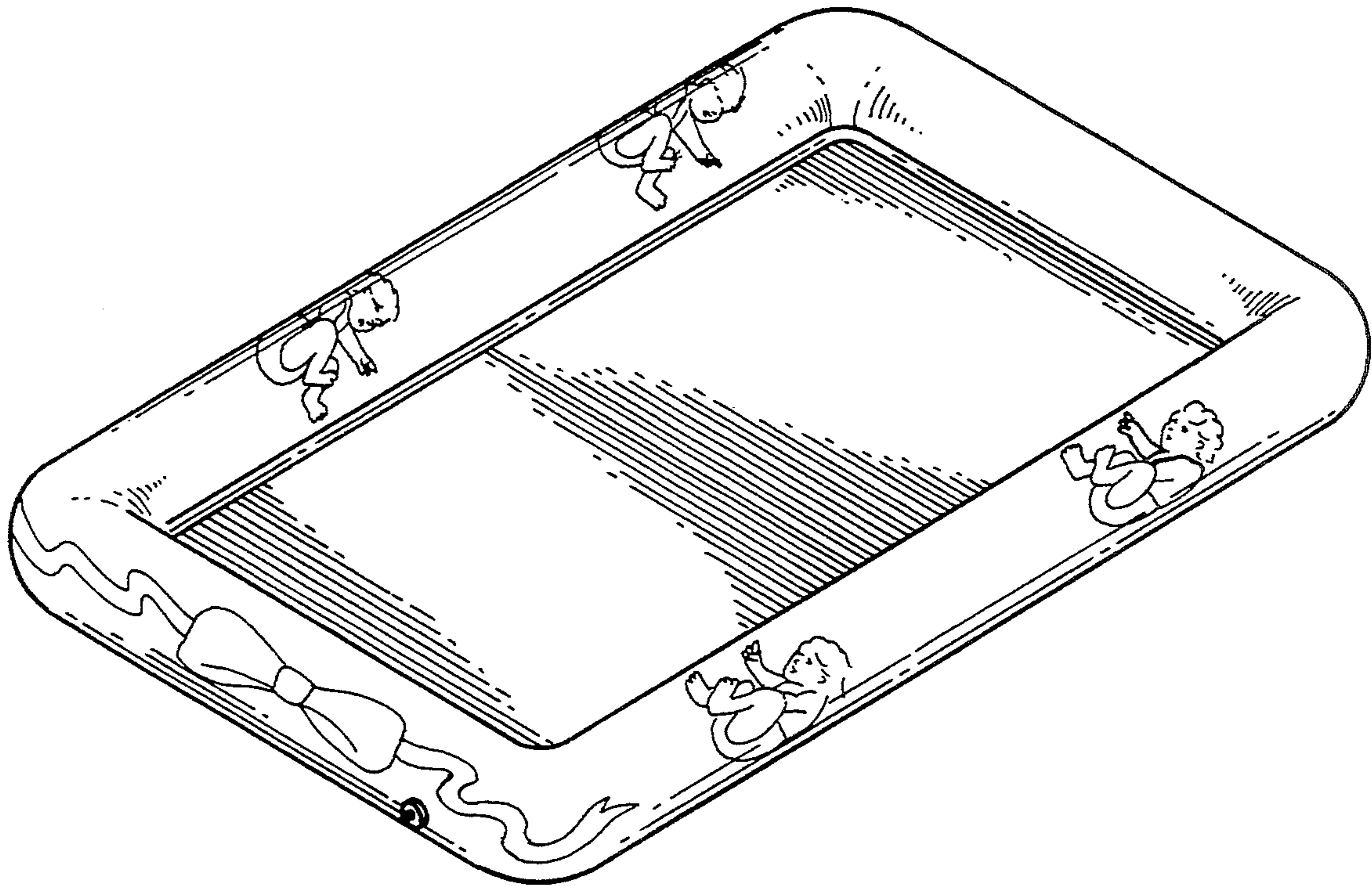

[57] **CLAIM**

The ornamental design for an inflatable portable infant bed, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the inflatable portable infant bed in the inflated condition embodying the design of the present invention;

 FIG. 7 is a bottom view thereof.



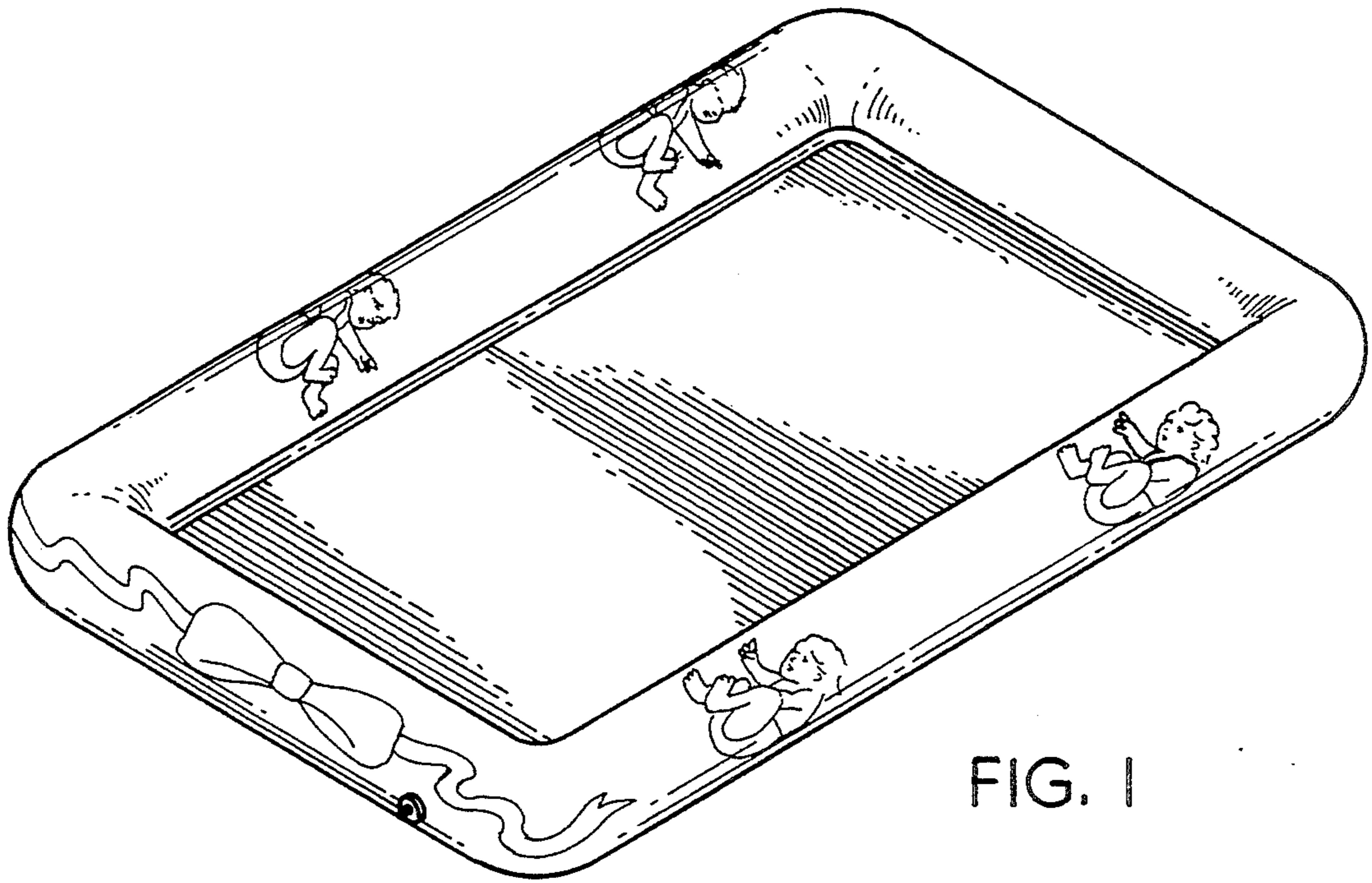

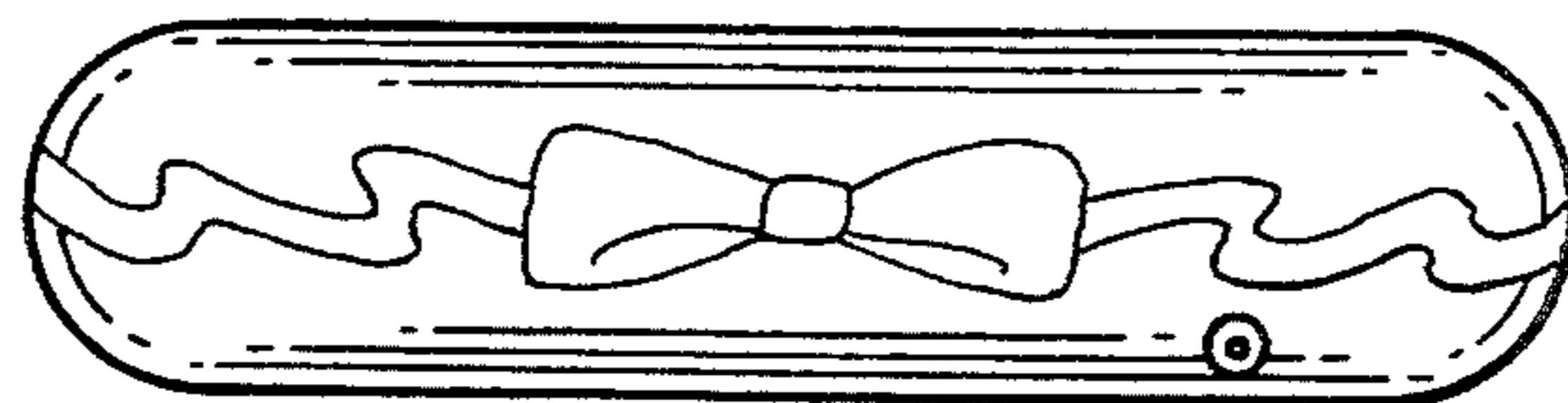

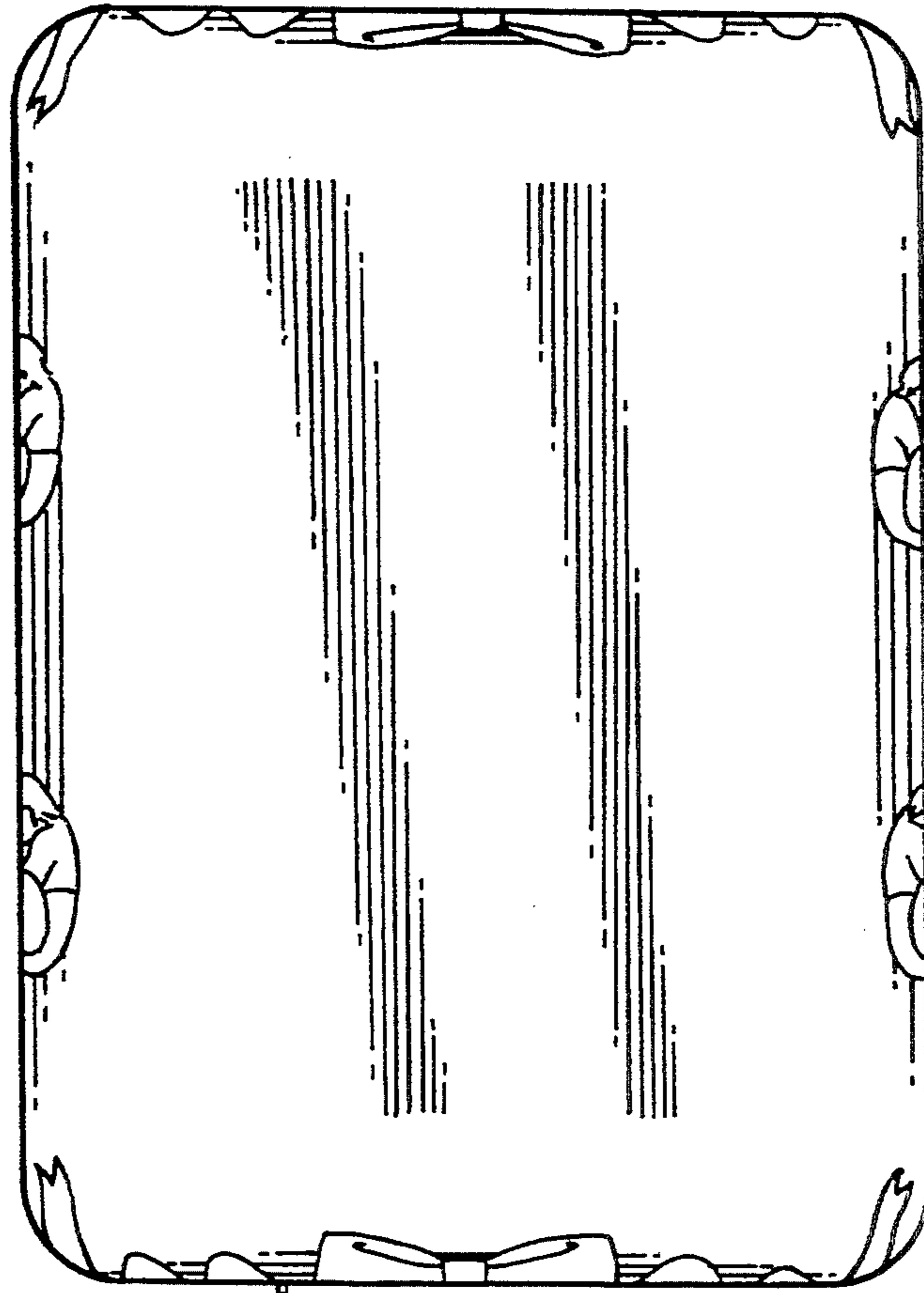

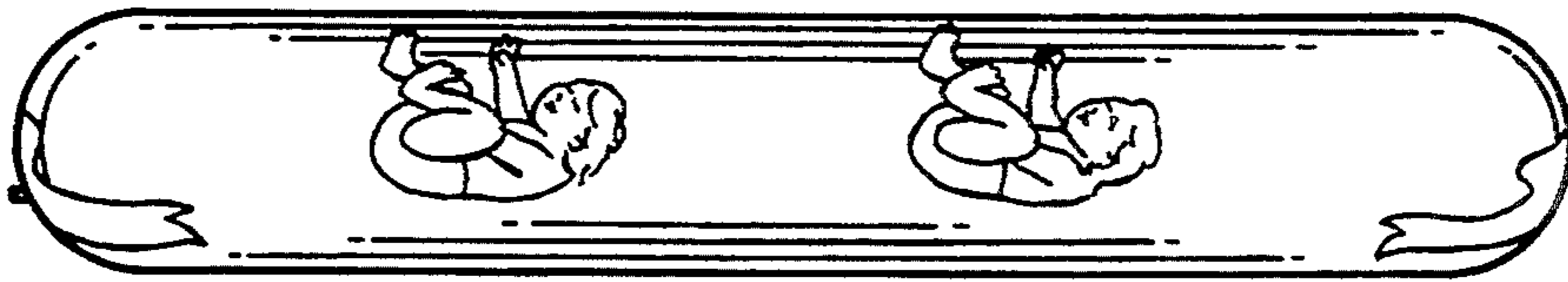

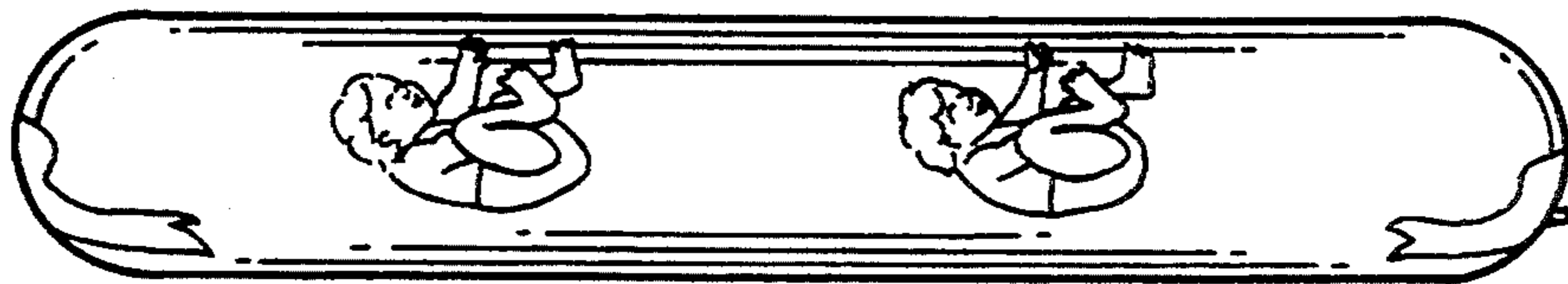

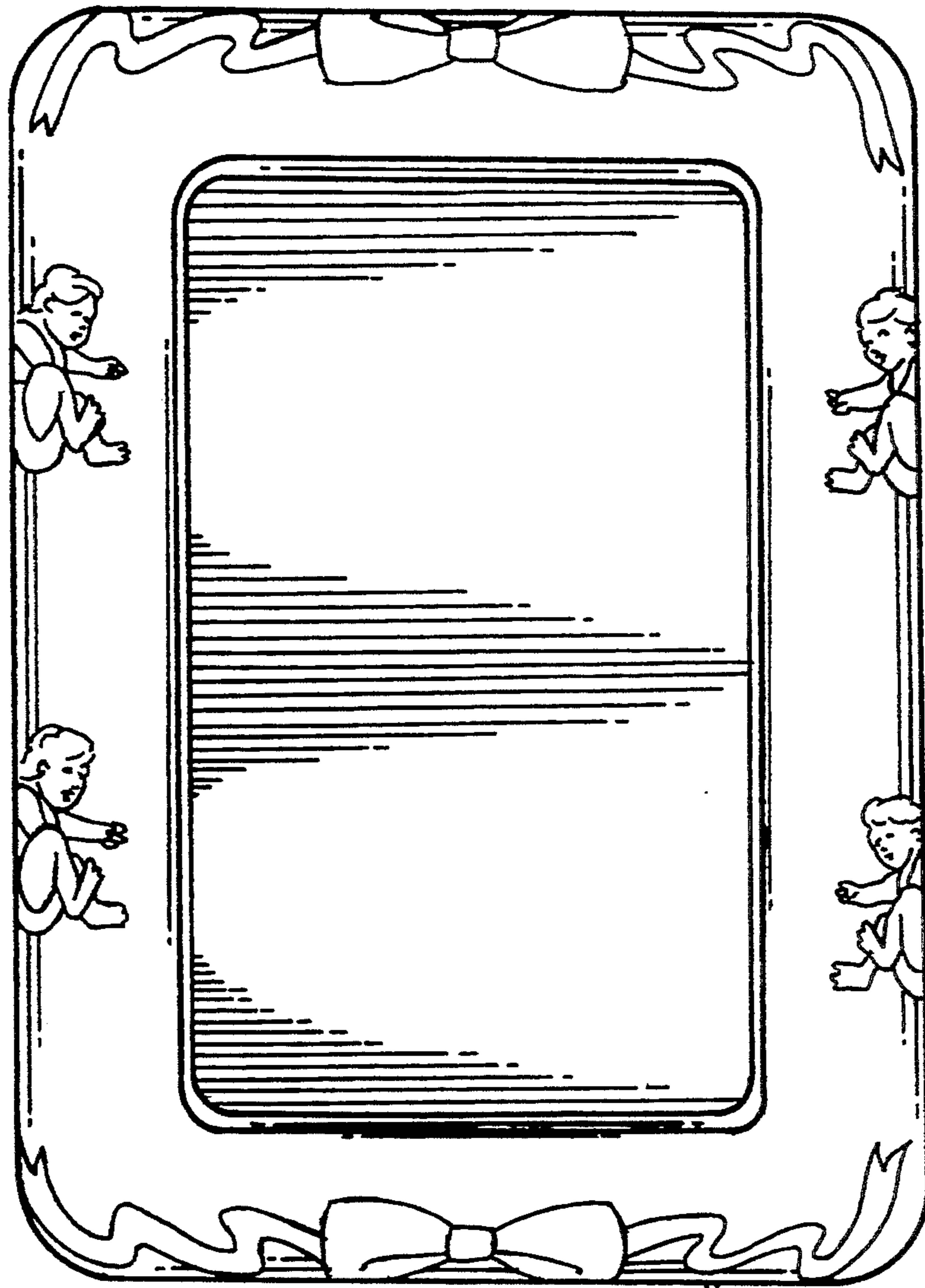

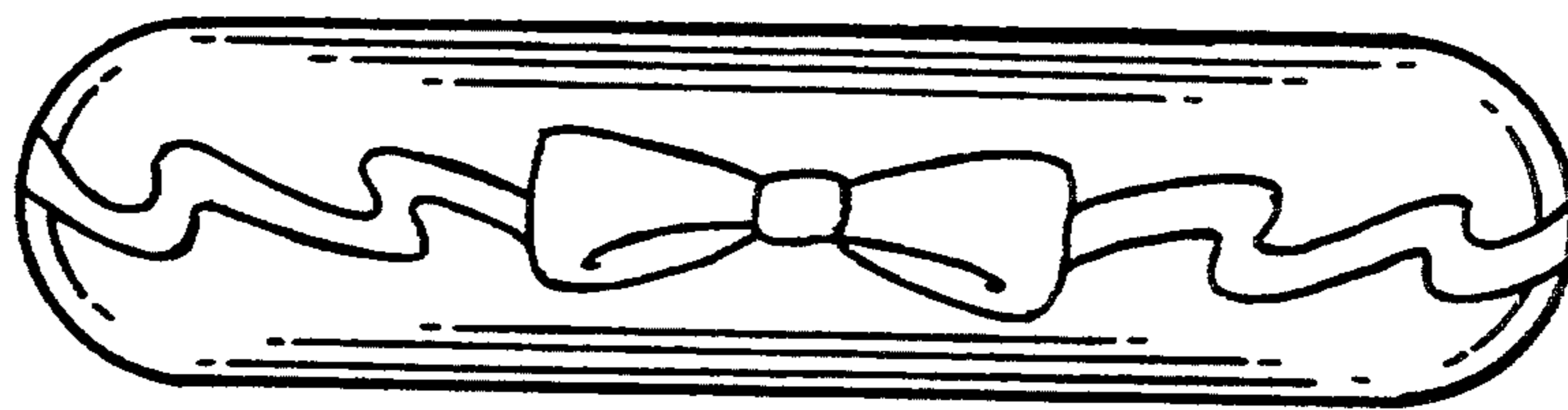
