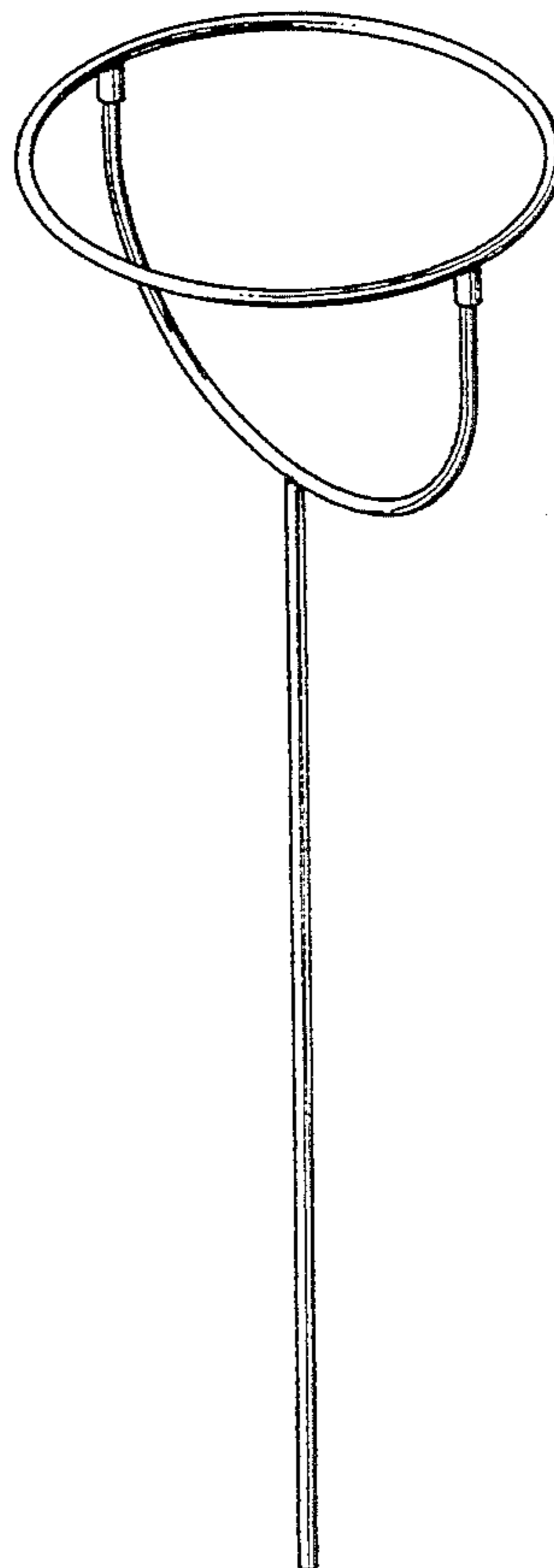

[57] **CLAIM**

The ornamental design for a flower pot holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a flower pot holder showing one embodiment of my new design; FIG. 2 is a perspective view of a flower pot holder showing a second embodiment of my new design; FIG. 3 is a side-elevational view of the flower pot holder of FIG. 1, the opposite side being a mirror image; FIG. 4 is another side-elevational view of the flower pot holder of FIG. 1, the other opposite side being a mirror image; FIG. 5 is a side-elevational view of the flower pot holder of FIG. 2, the opposite side being a mirror image; FIG. 6 is another side-elevational view of the flower pot holder of FIG. 2, the other opposite side being a mirror image; FIG. 7 is a top plan view of the flower pot holder of FIG. 1; FIG. 8 is a top plan view of the flower pot holder of FIG. 2; FIG. 9 is a bottom plan view of the flower pot holder of FIG. 1; and, FIG. 10 is a bottom plan view of the flower pot holder of FIG. 2.



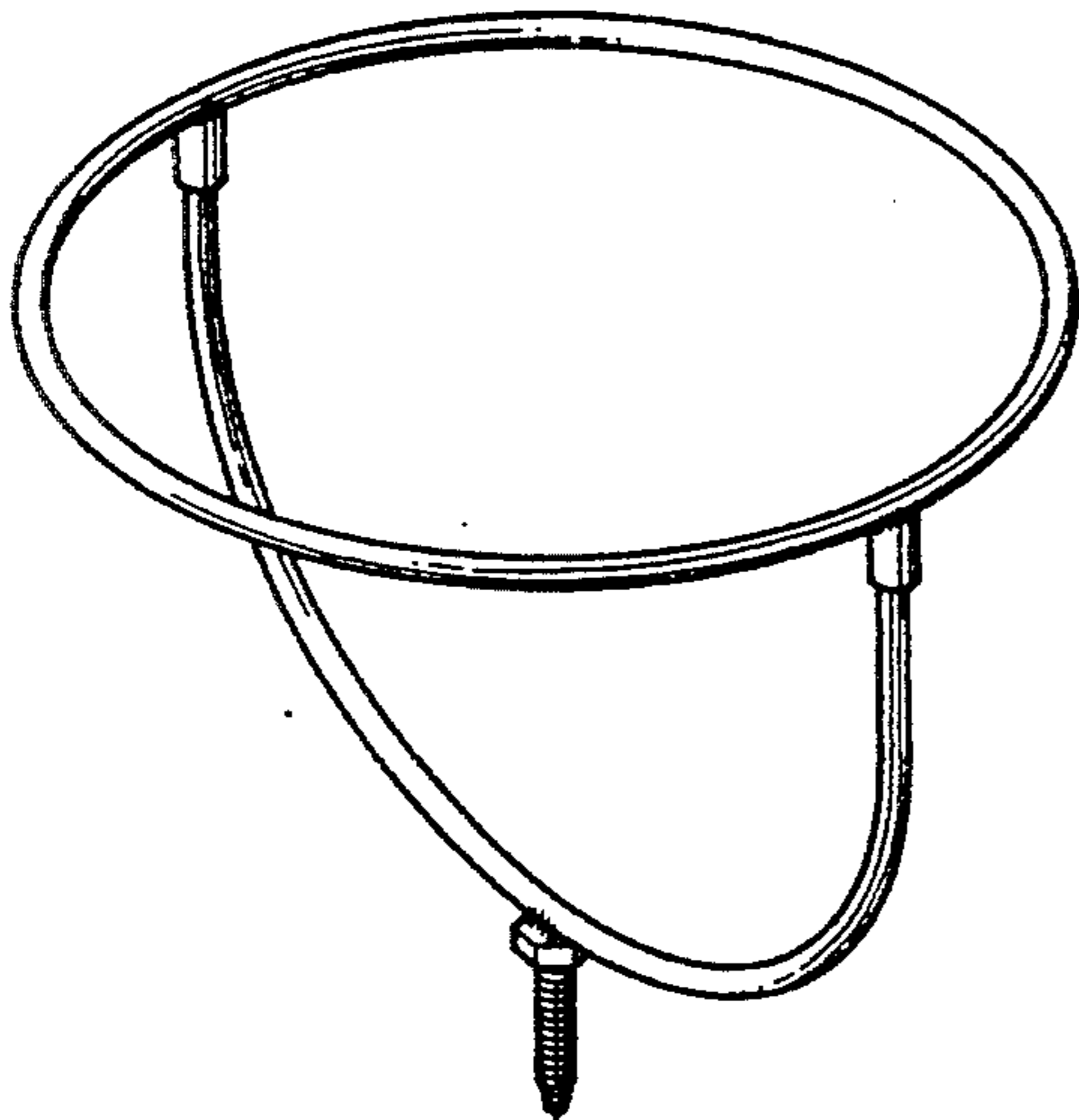

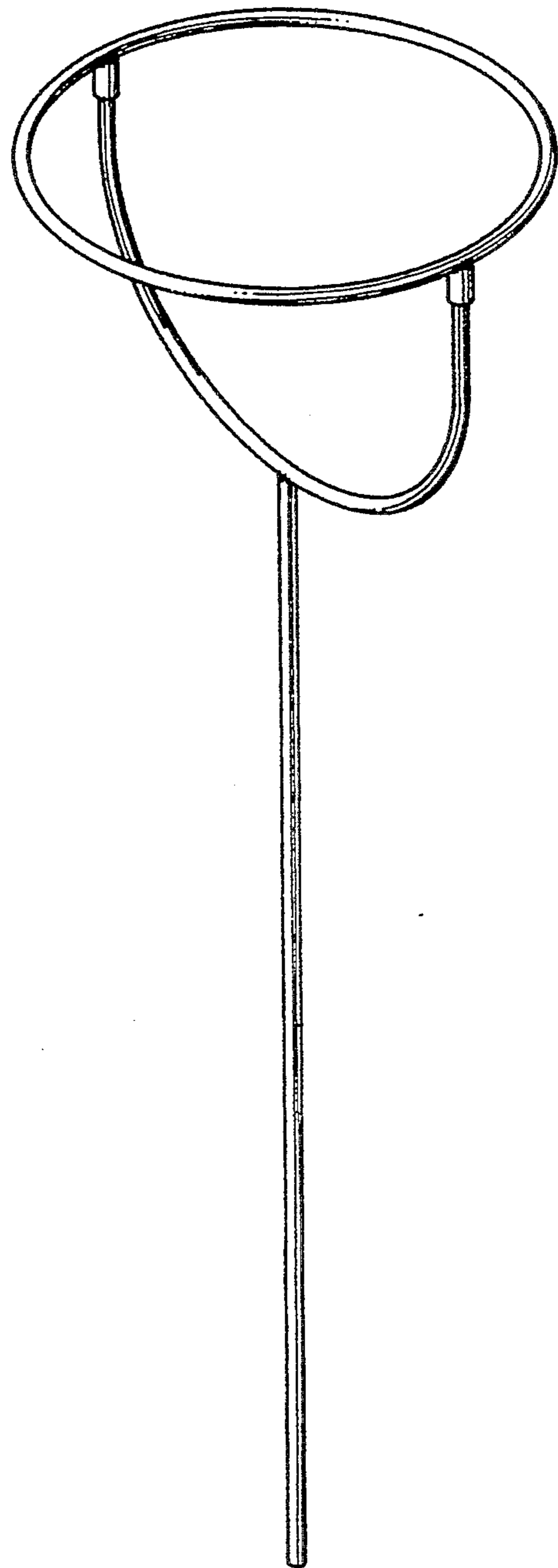

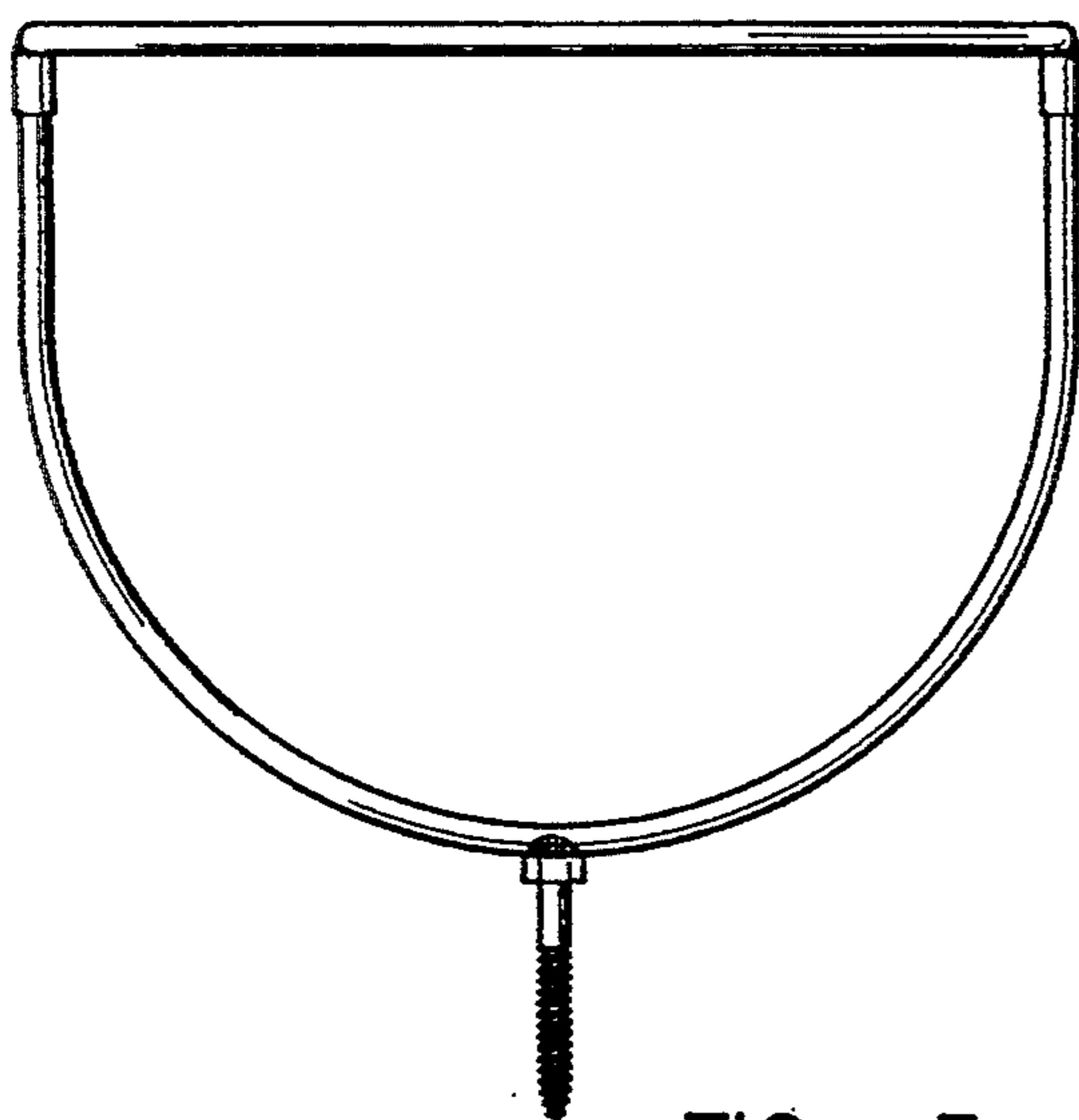

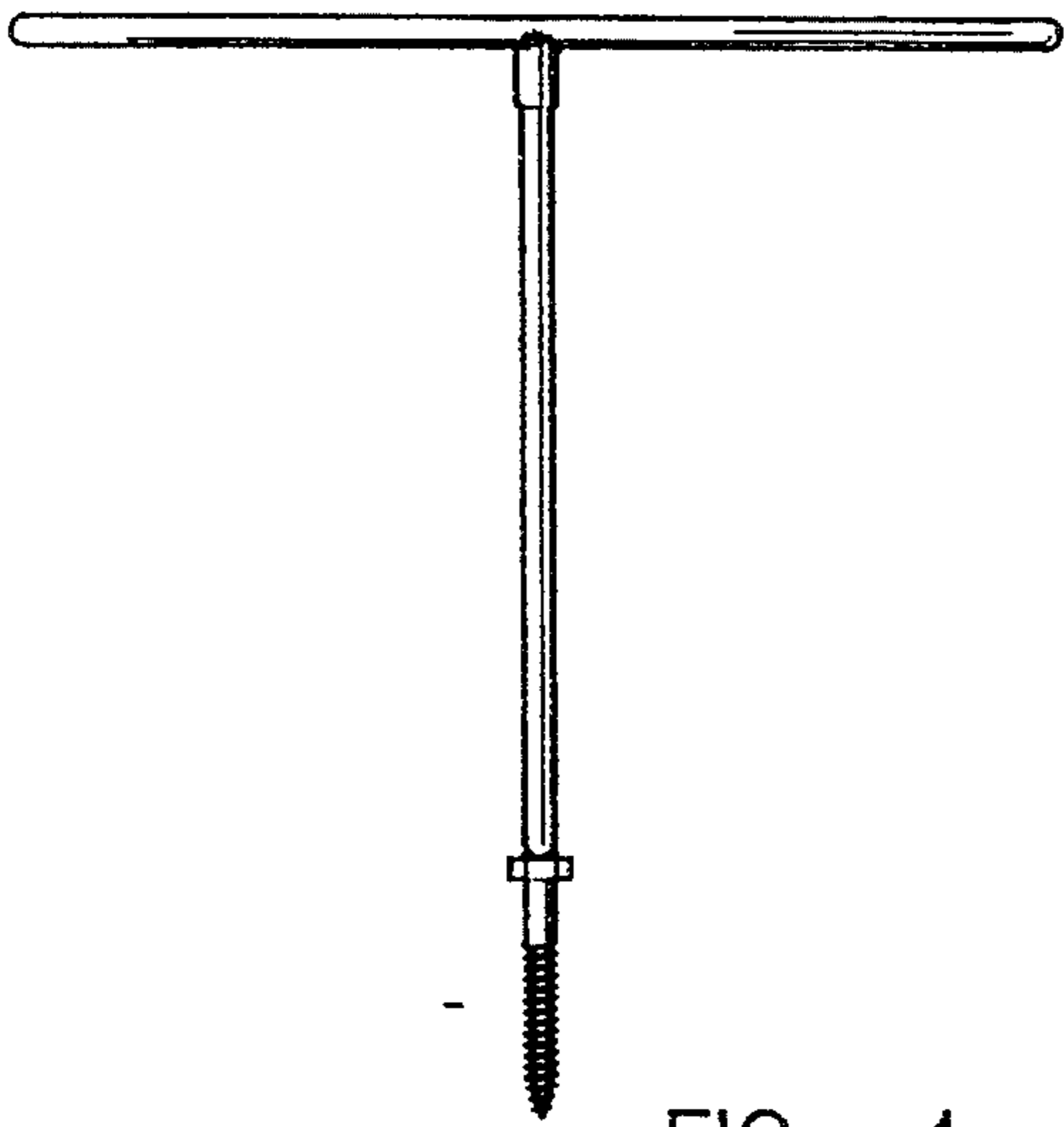

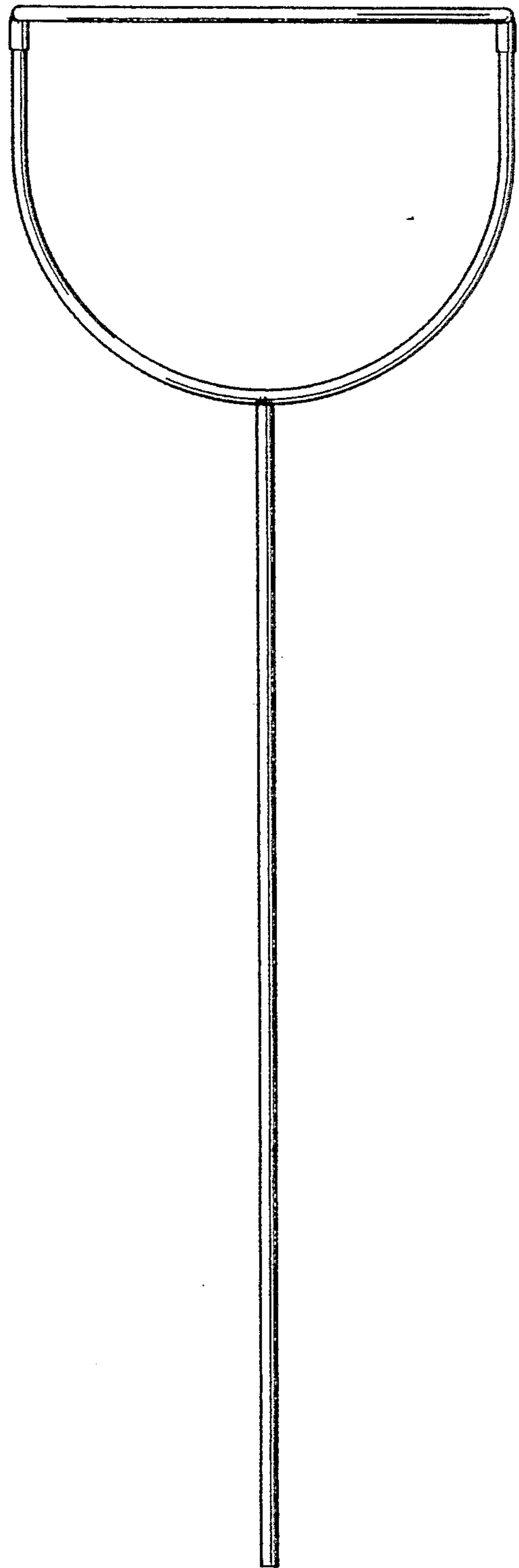

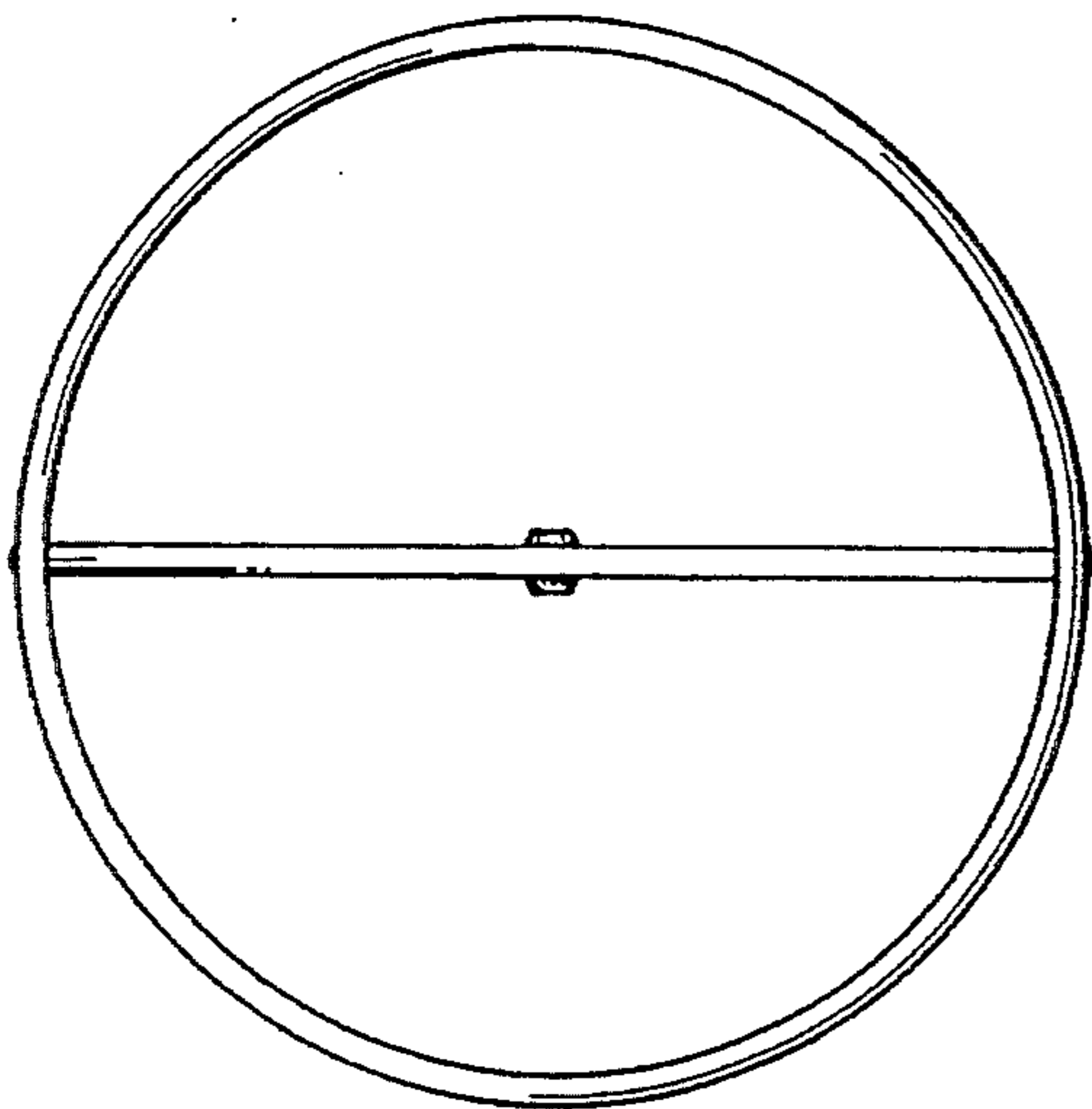

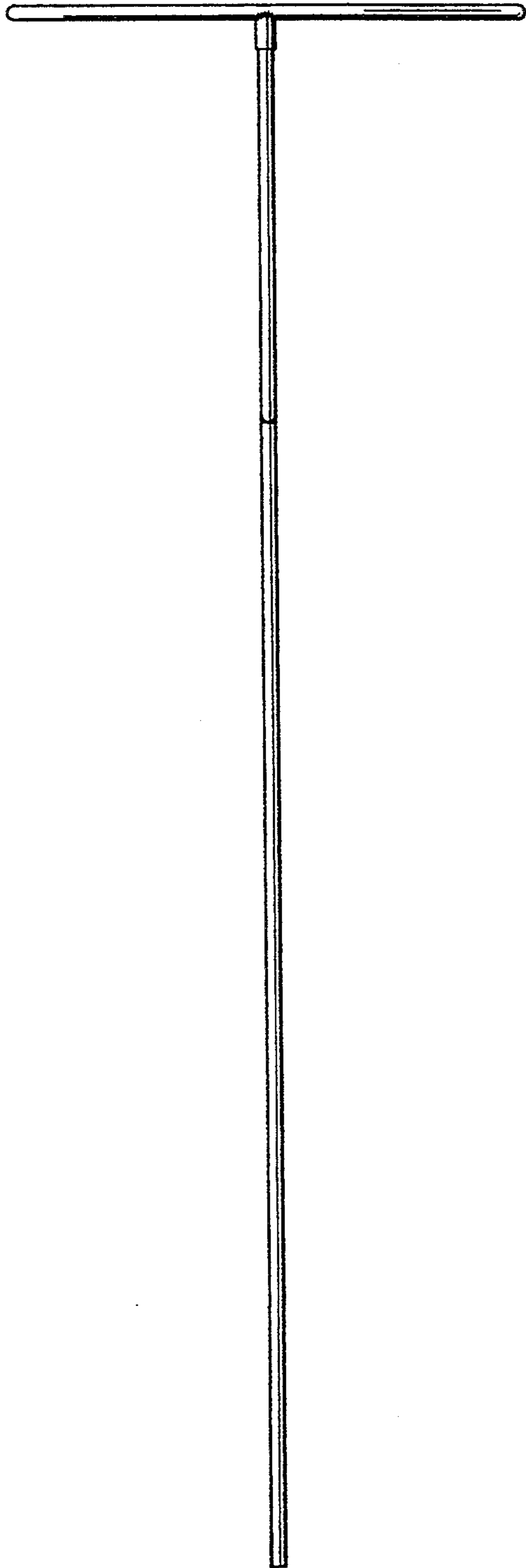

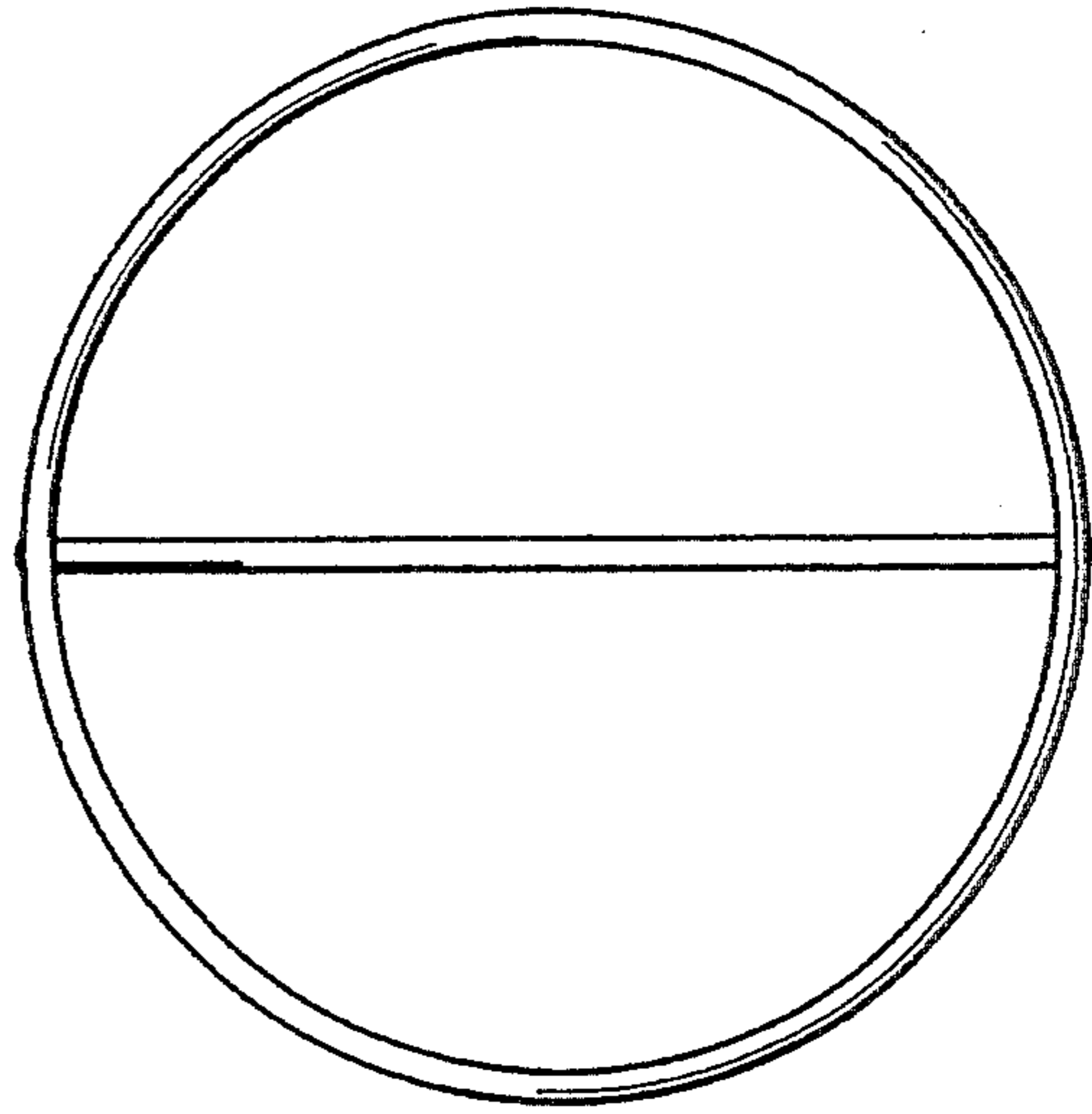

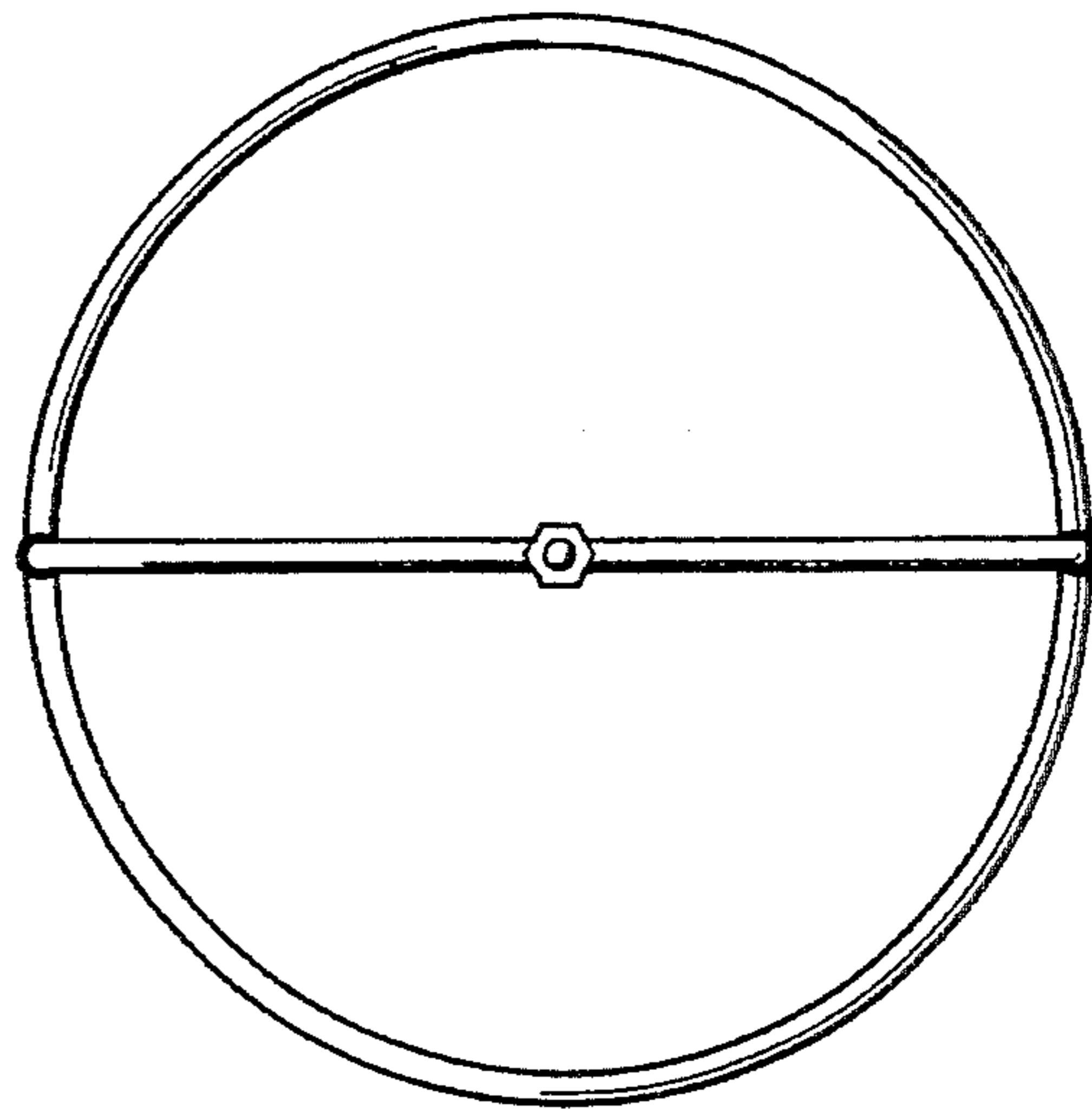

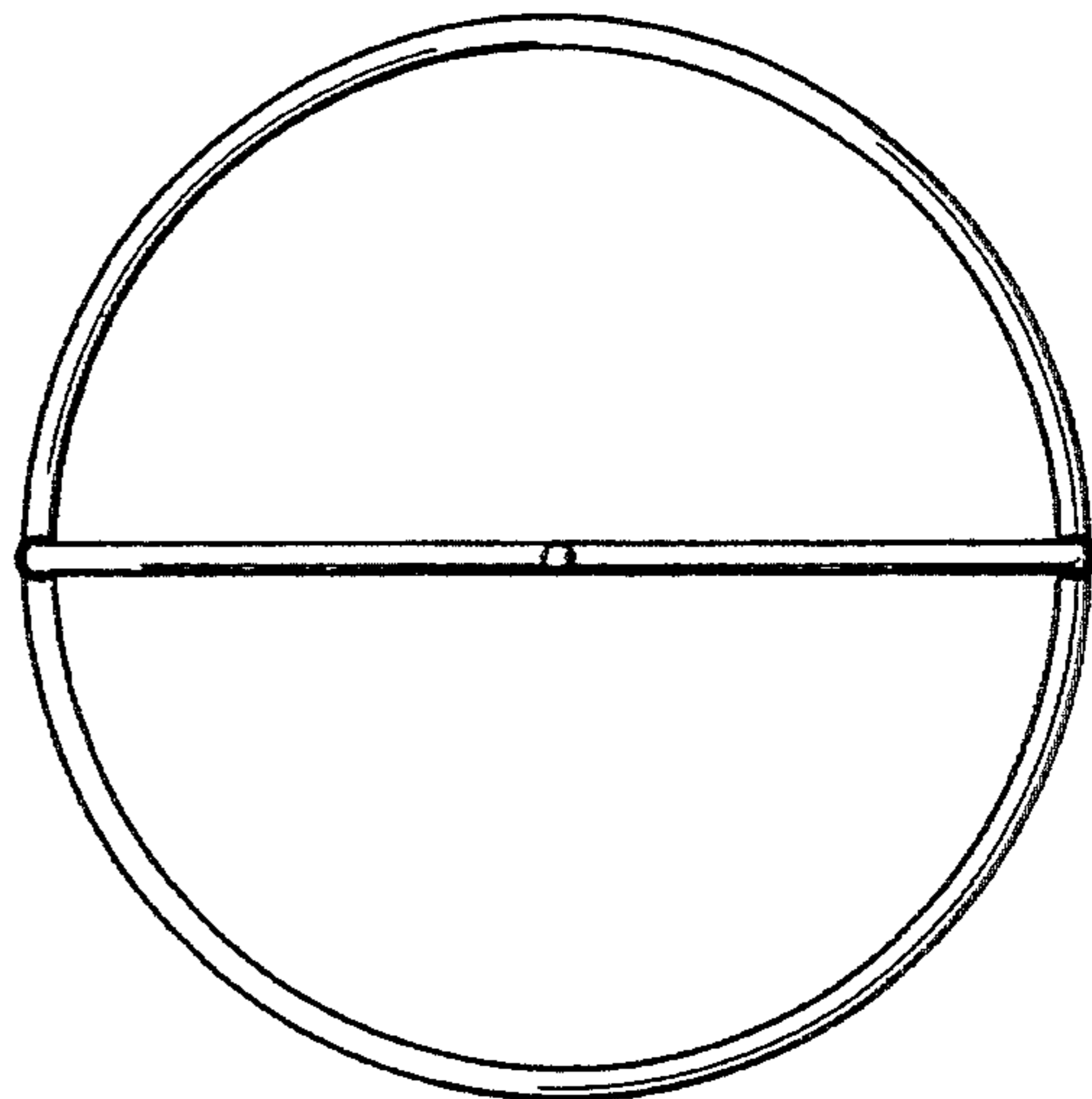
