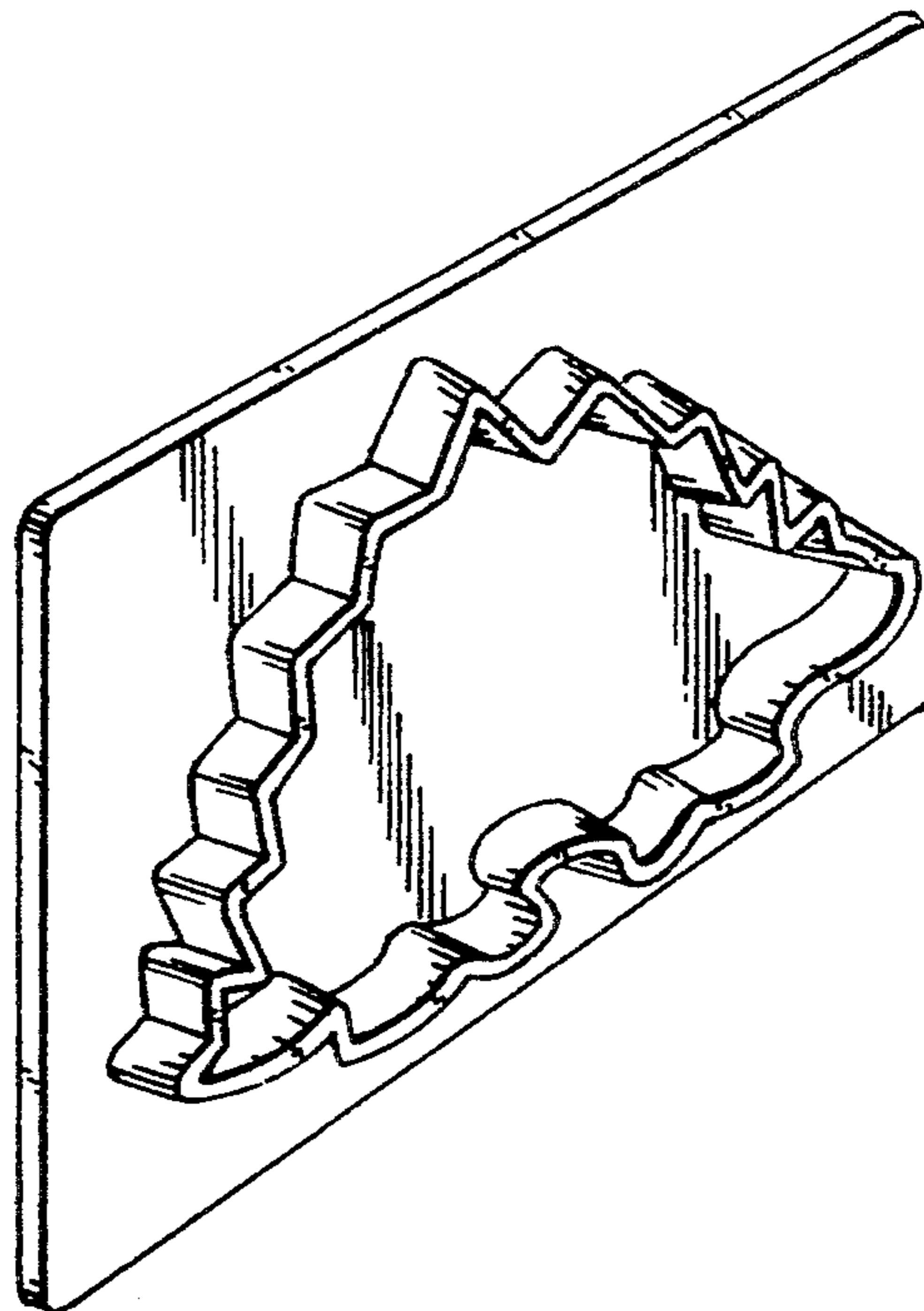

[57] **CLAIM**

The ornamental design for cutter for a dinosaur shaped food product, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cutter for a dinosaur shaped food product showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a cross-sectional view thereof taken along line 7-7 of FIG. 2; FIG. 8 is a rear elevational view thereof; FIG. 9 is a perspective view of an alternate embodiment of FIG. 1; FIG. 10 is a front elevational view of FIG. 9, the opposite side being unornamented; FIG. 11 is a perspective view of an alternate embodiment of FIG. 1; FIG. 12 is a front elevational view of FIG. 11, the opposite side being unornamented; FIG. 13 perspective view of an alternate embodiment of FIG. 1; and, FIG. 14 is a front elevational view of FIG. 13, the opposite side being unornamented.



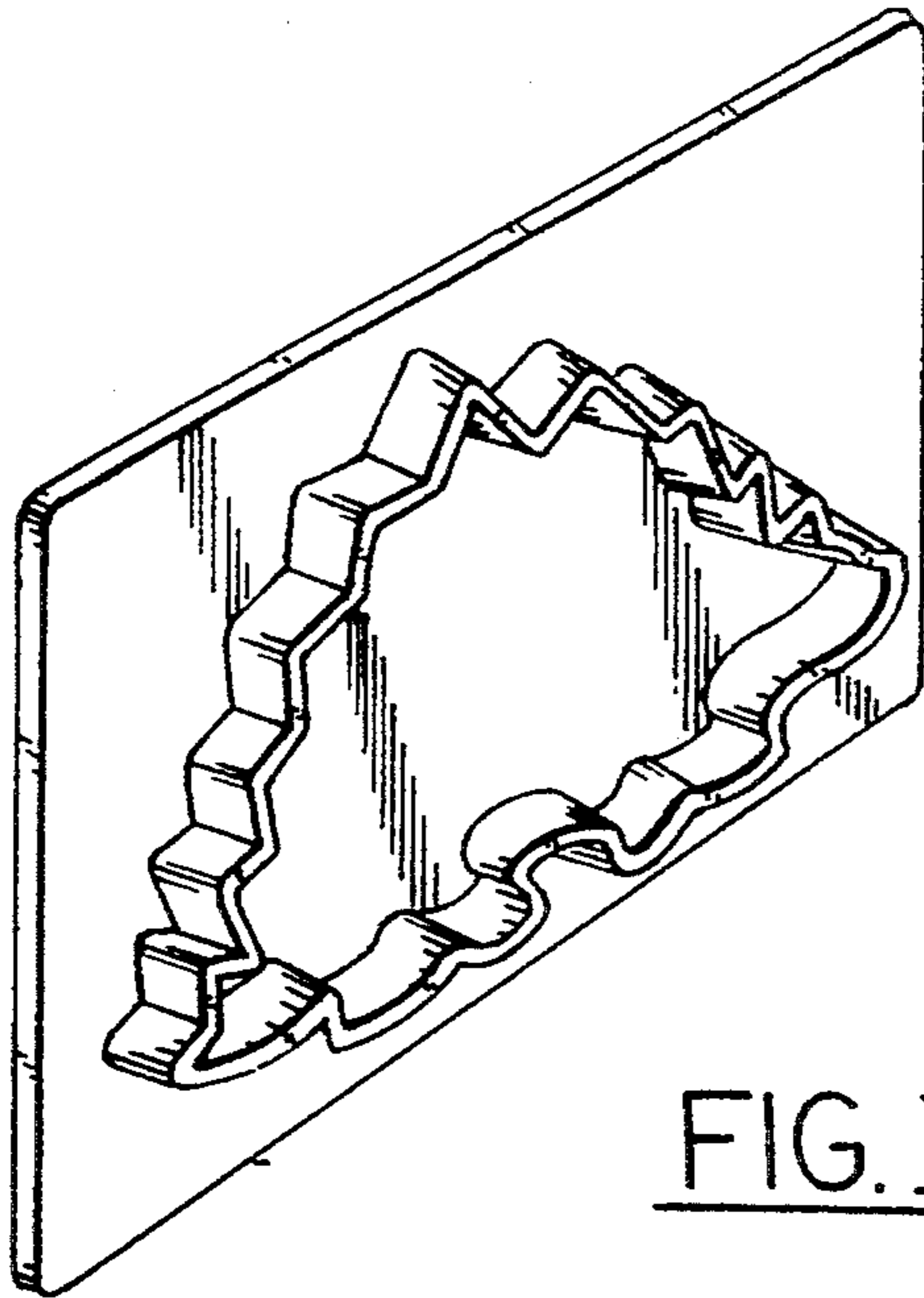

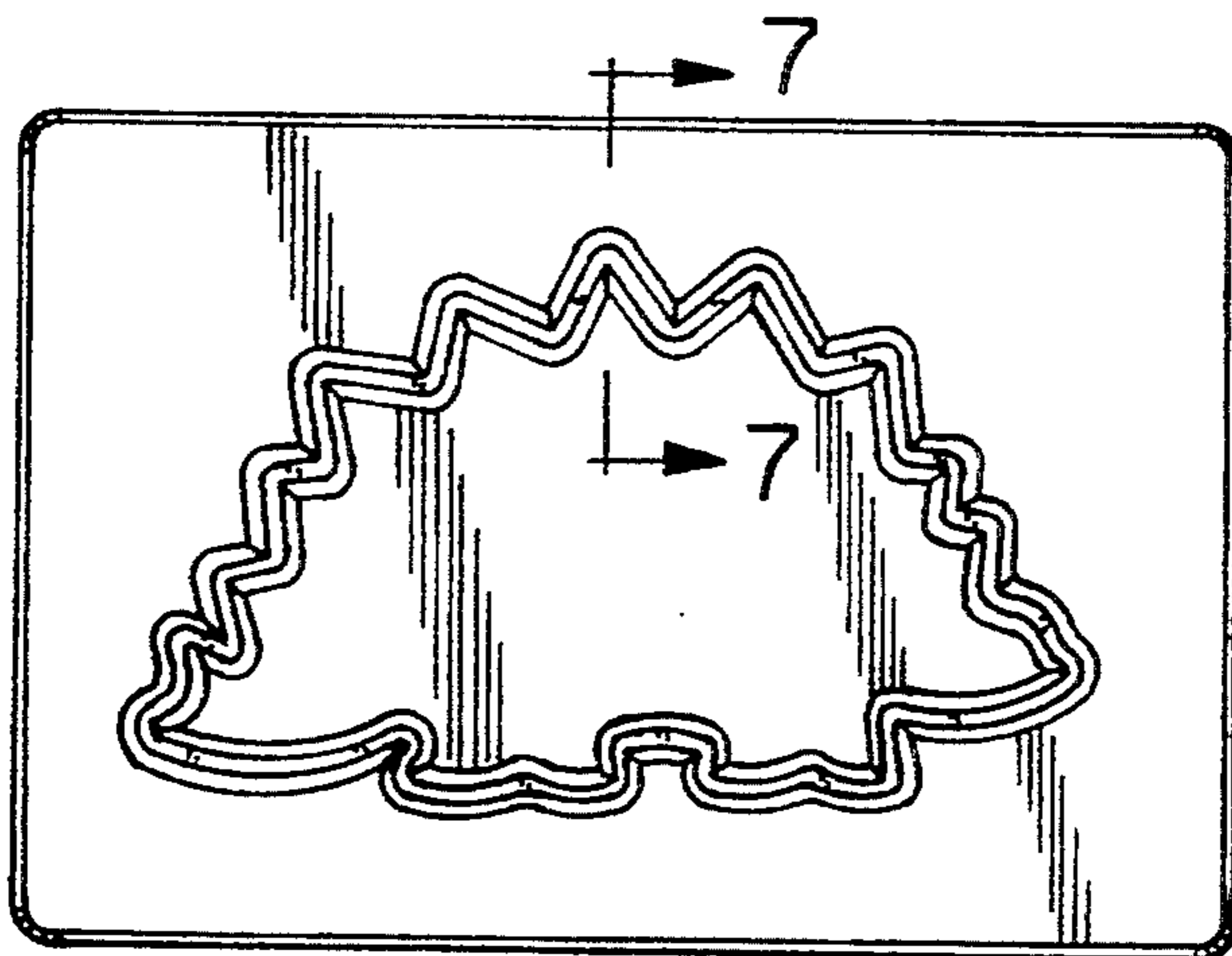

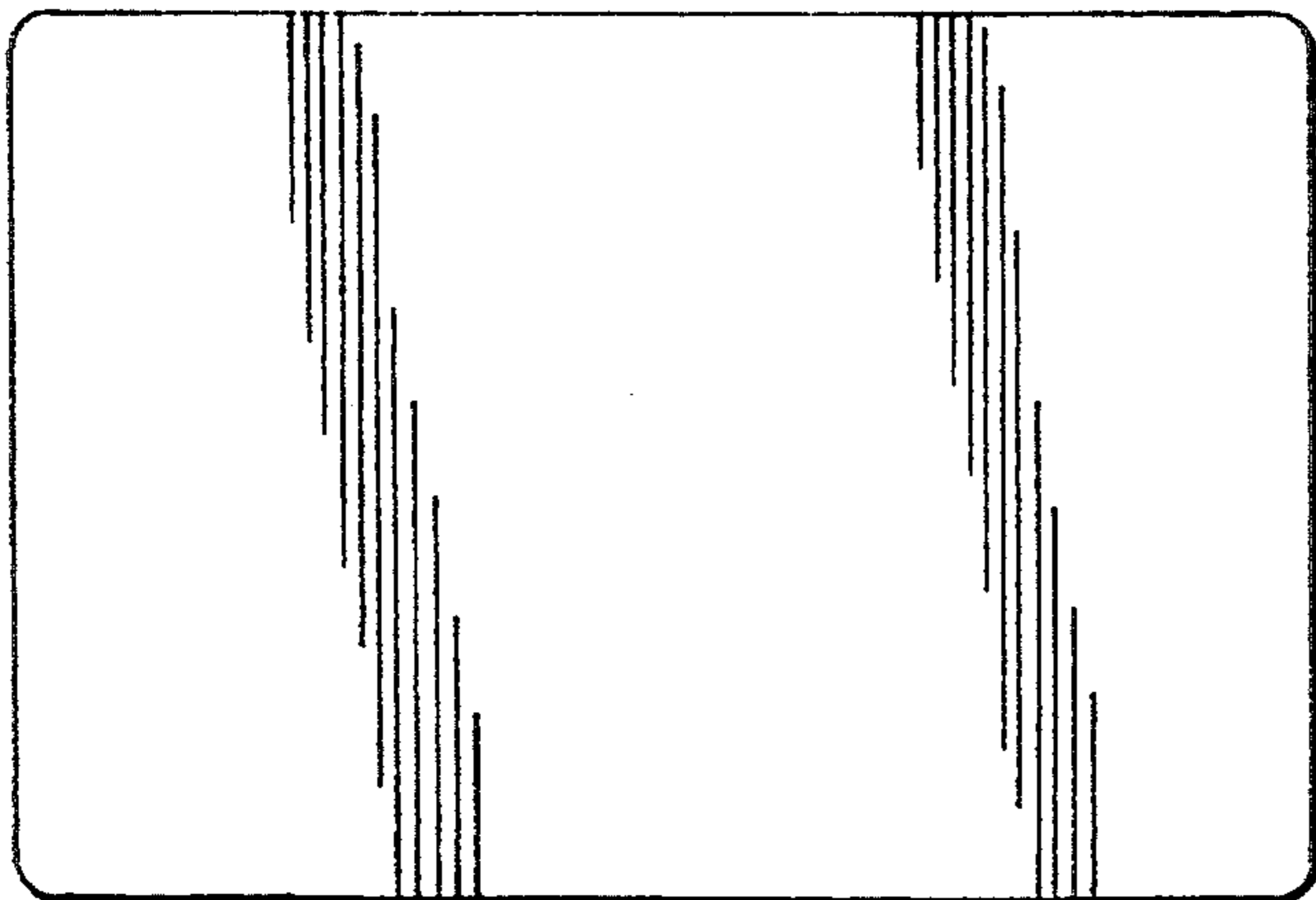

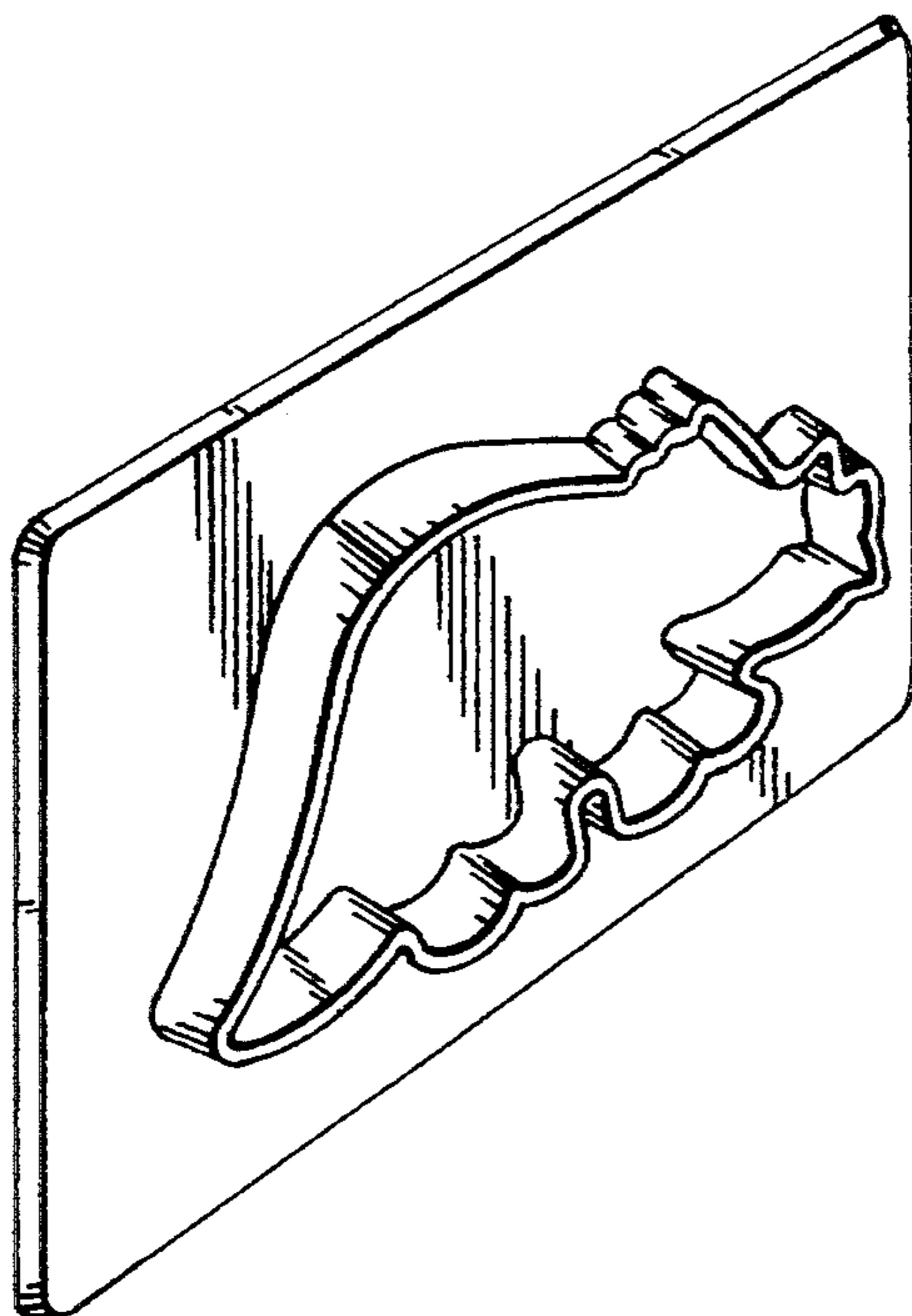

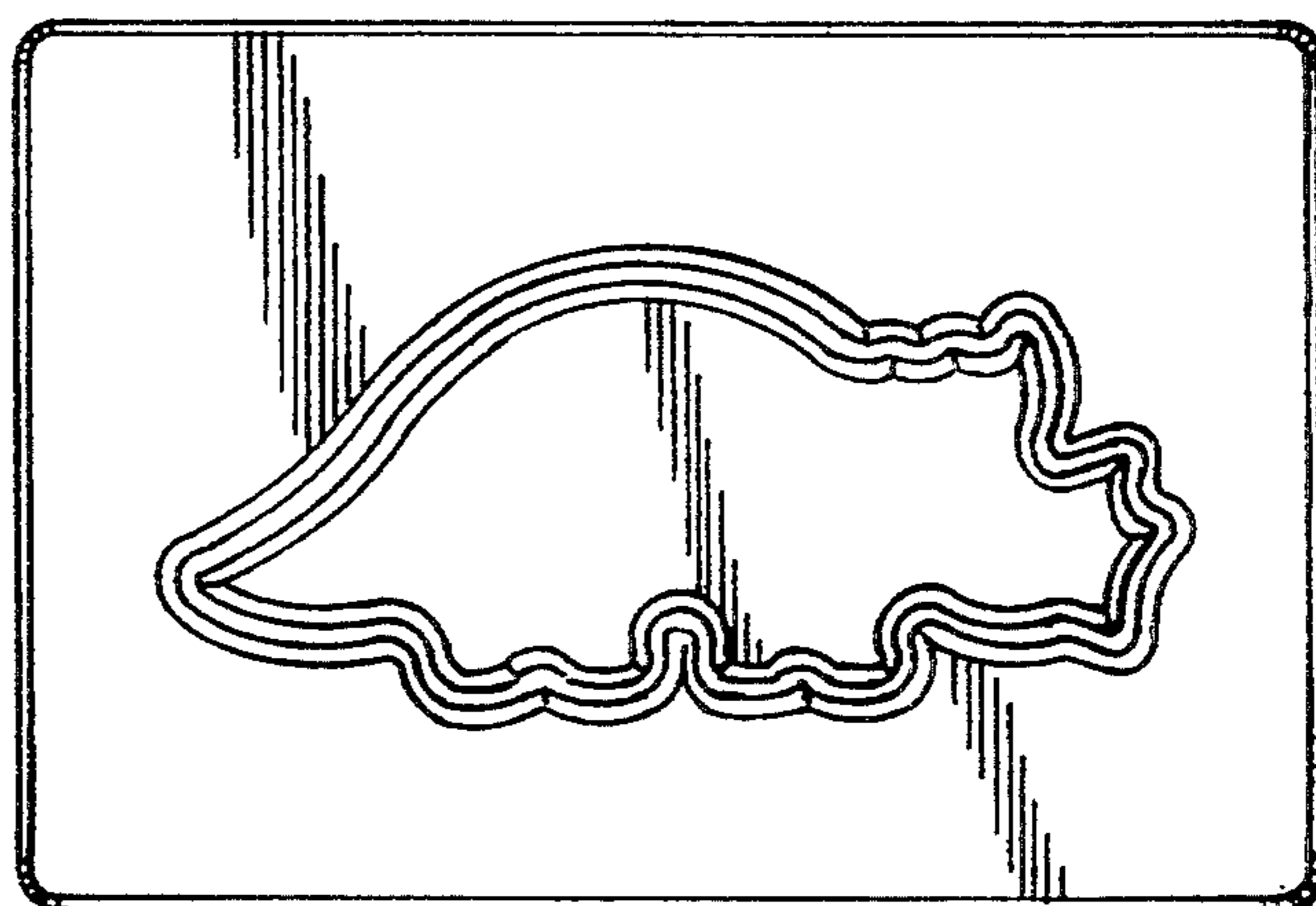

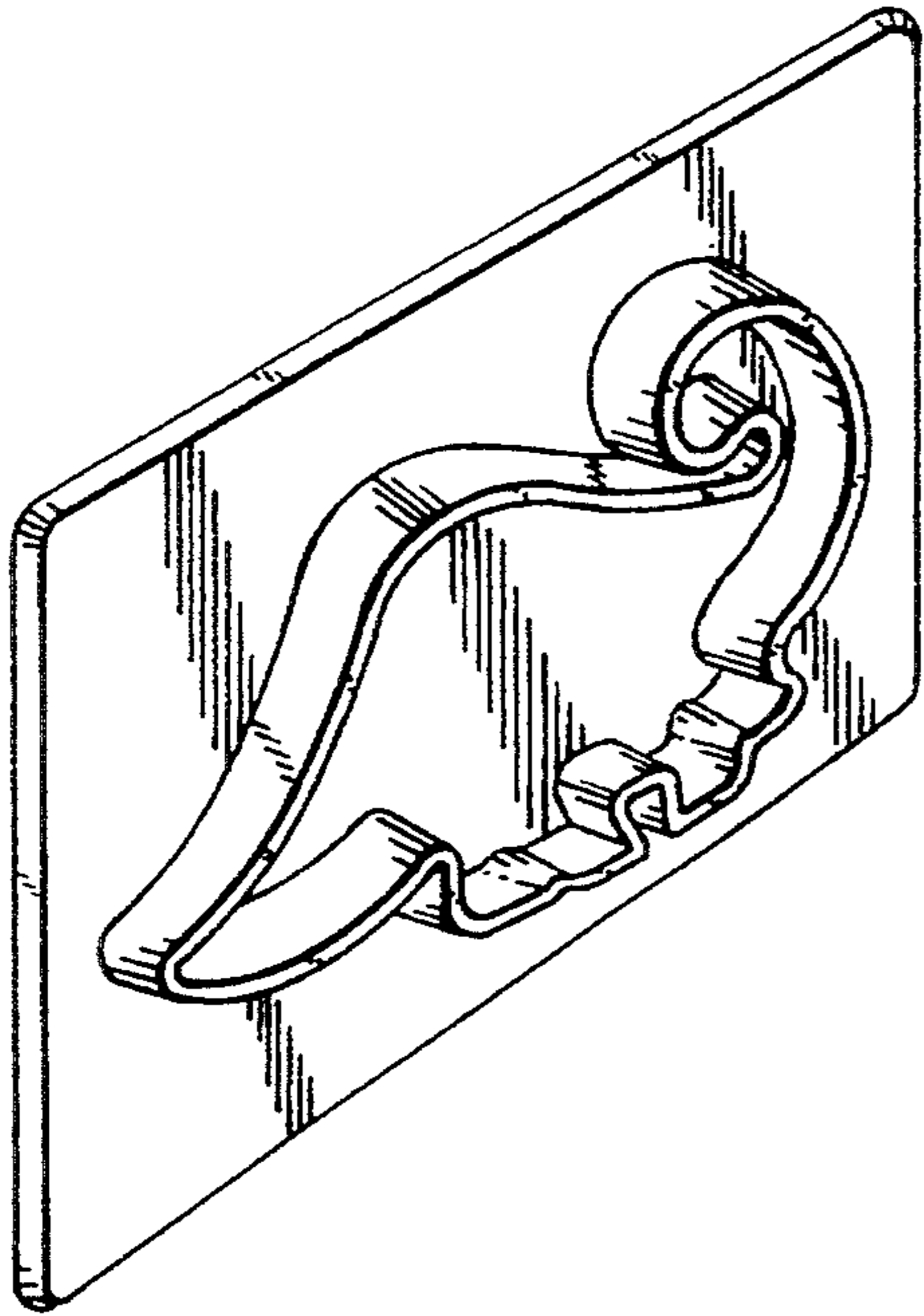

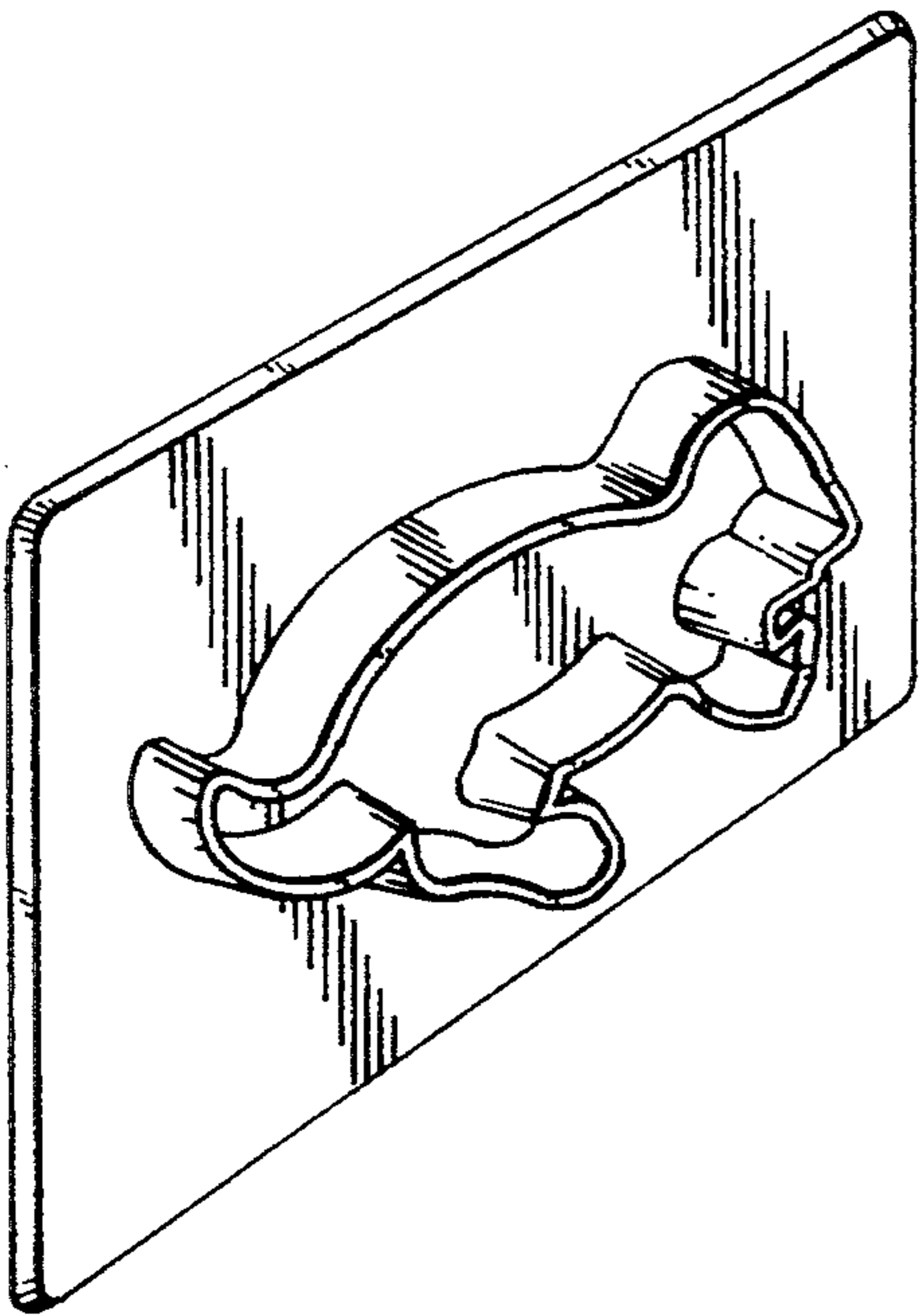
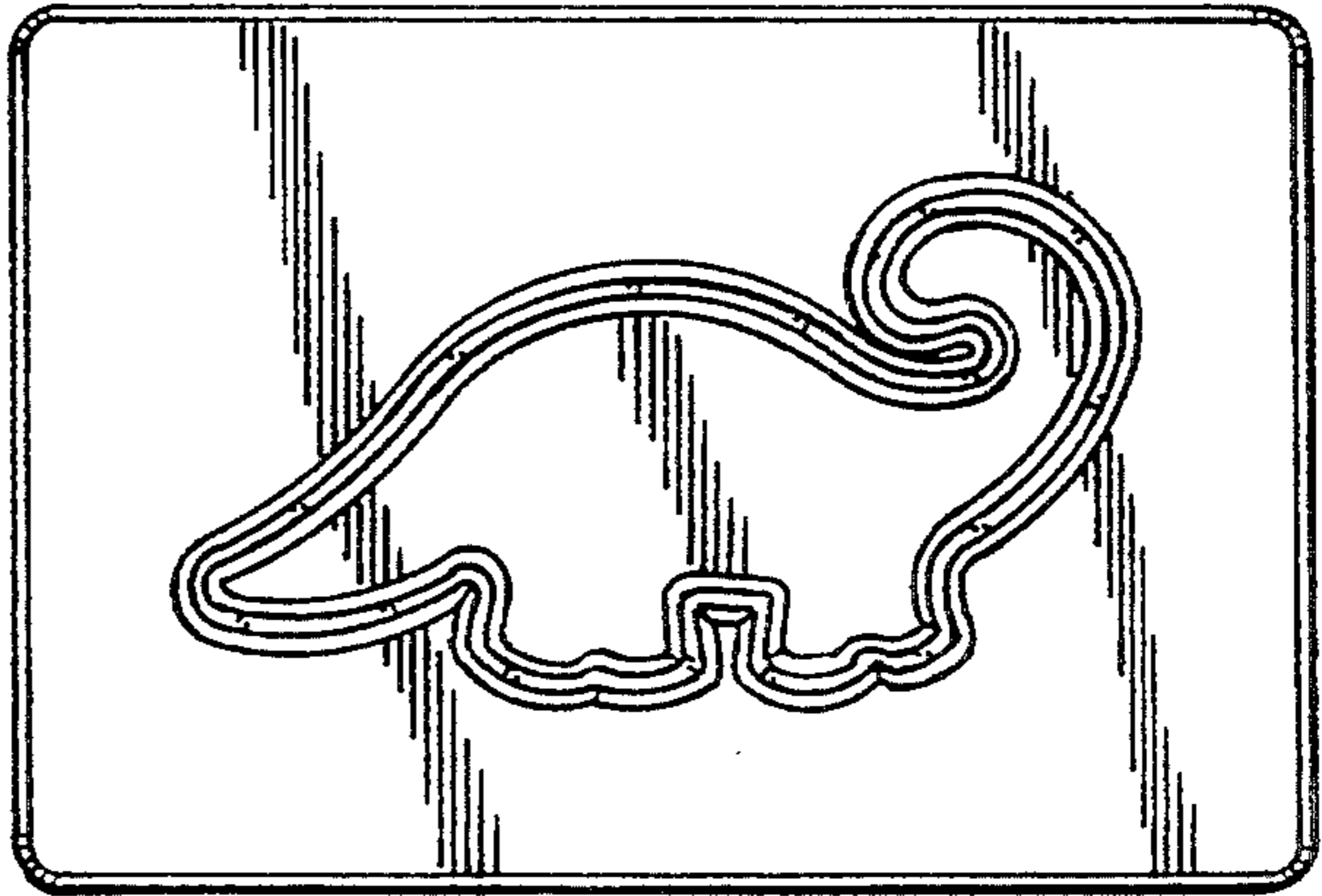
