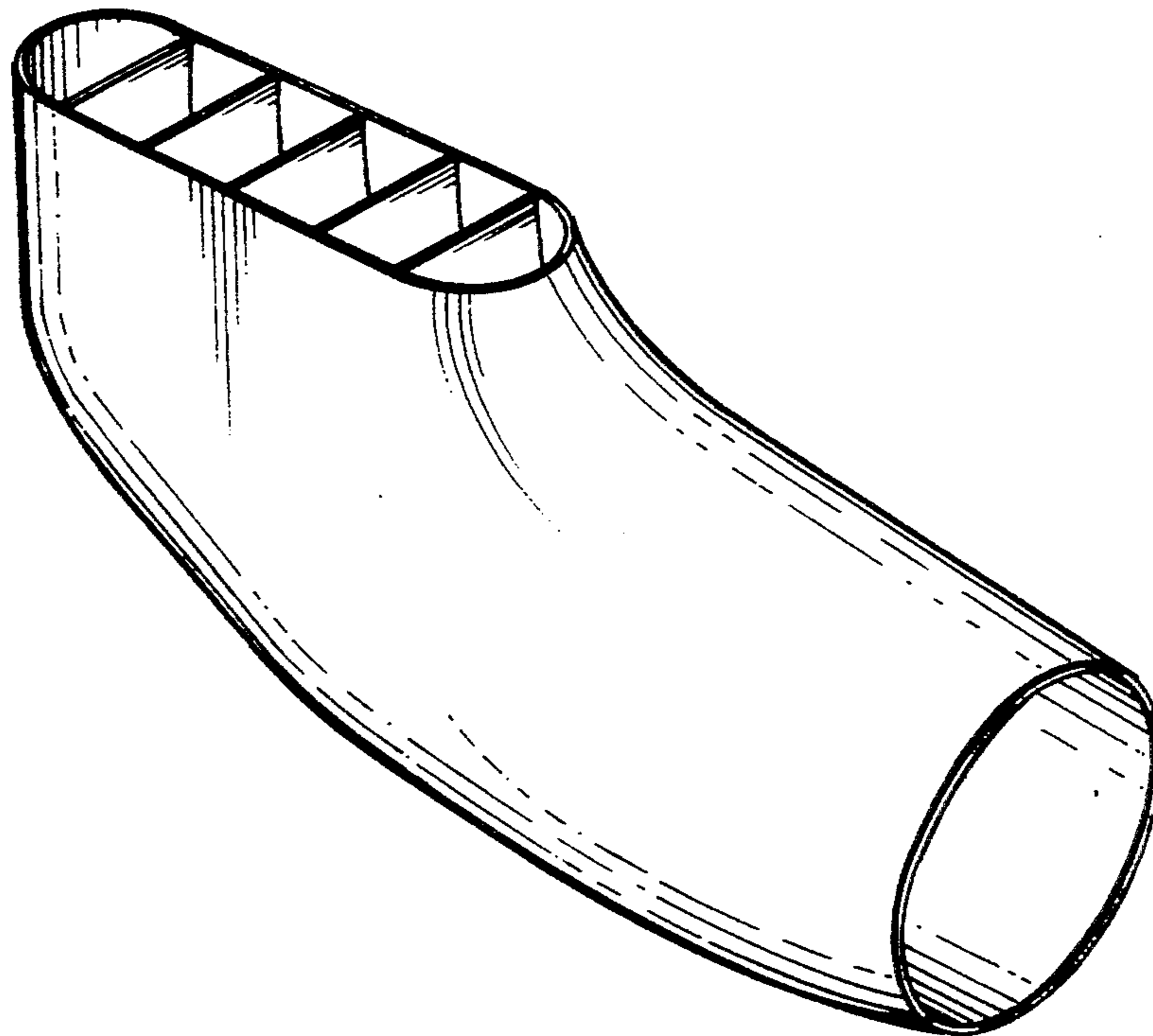

 FIG. 6 is a front view of the duct.



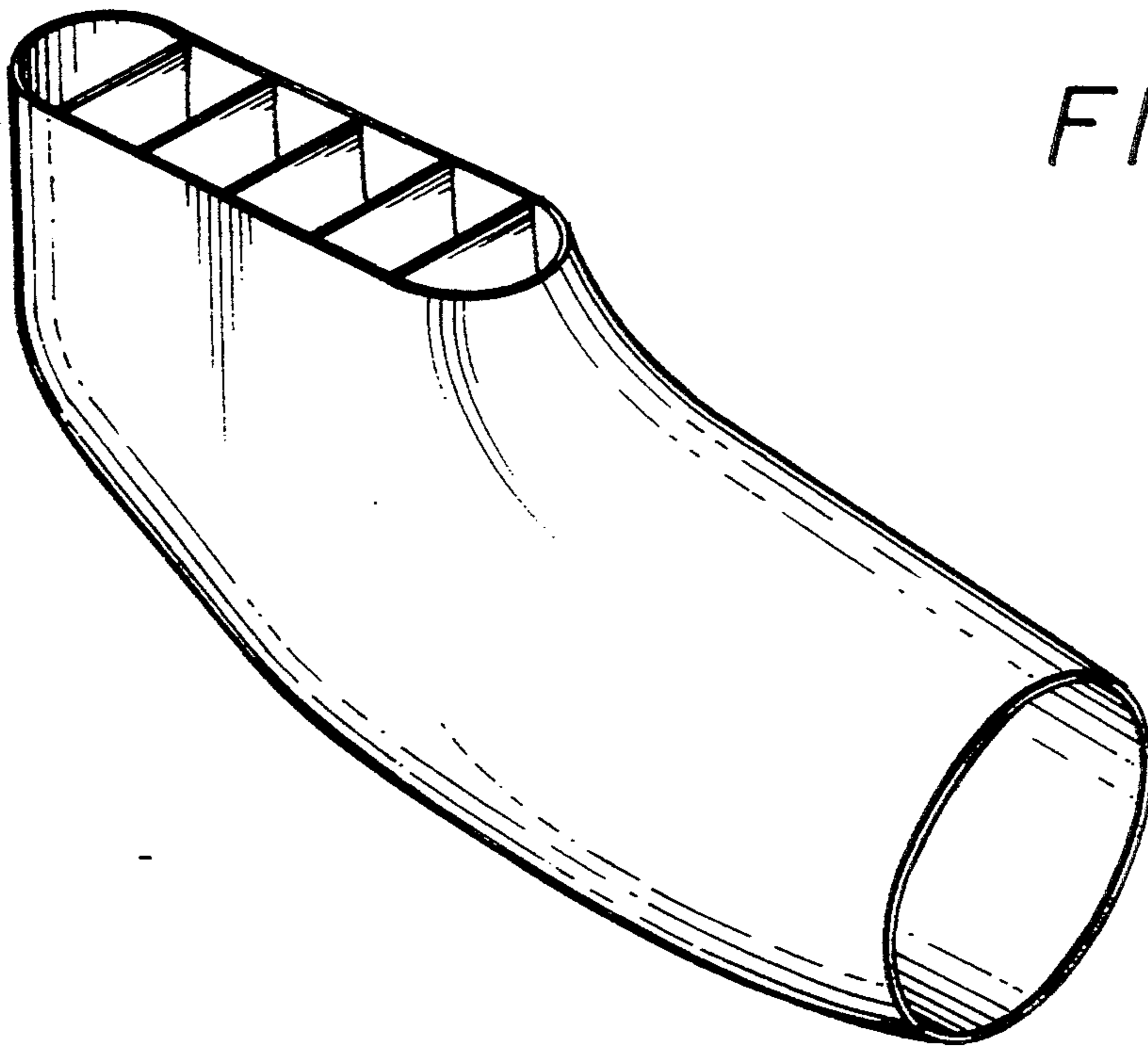

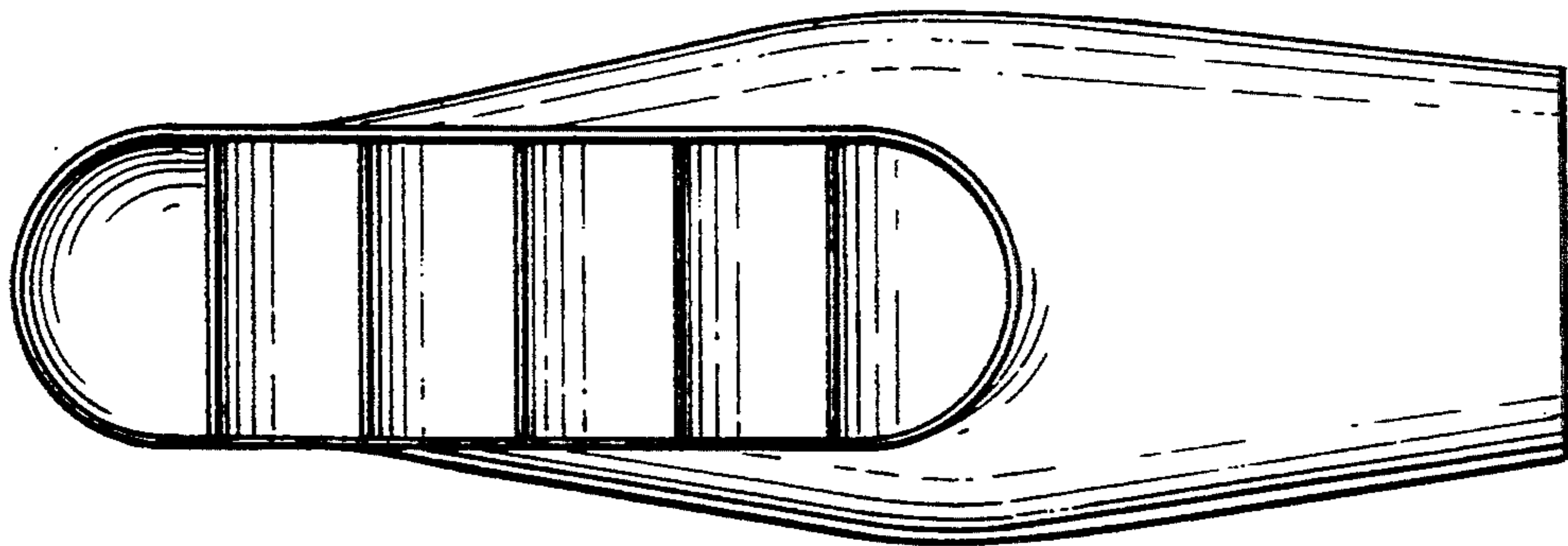

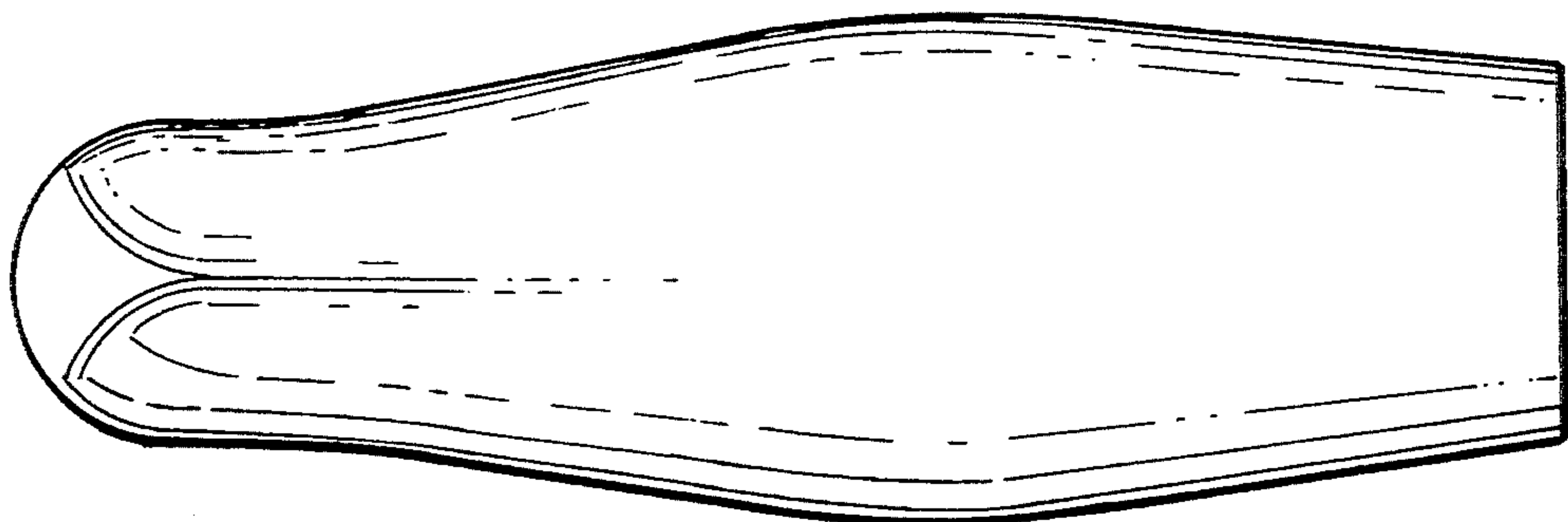

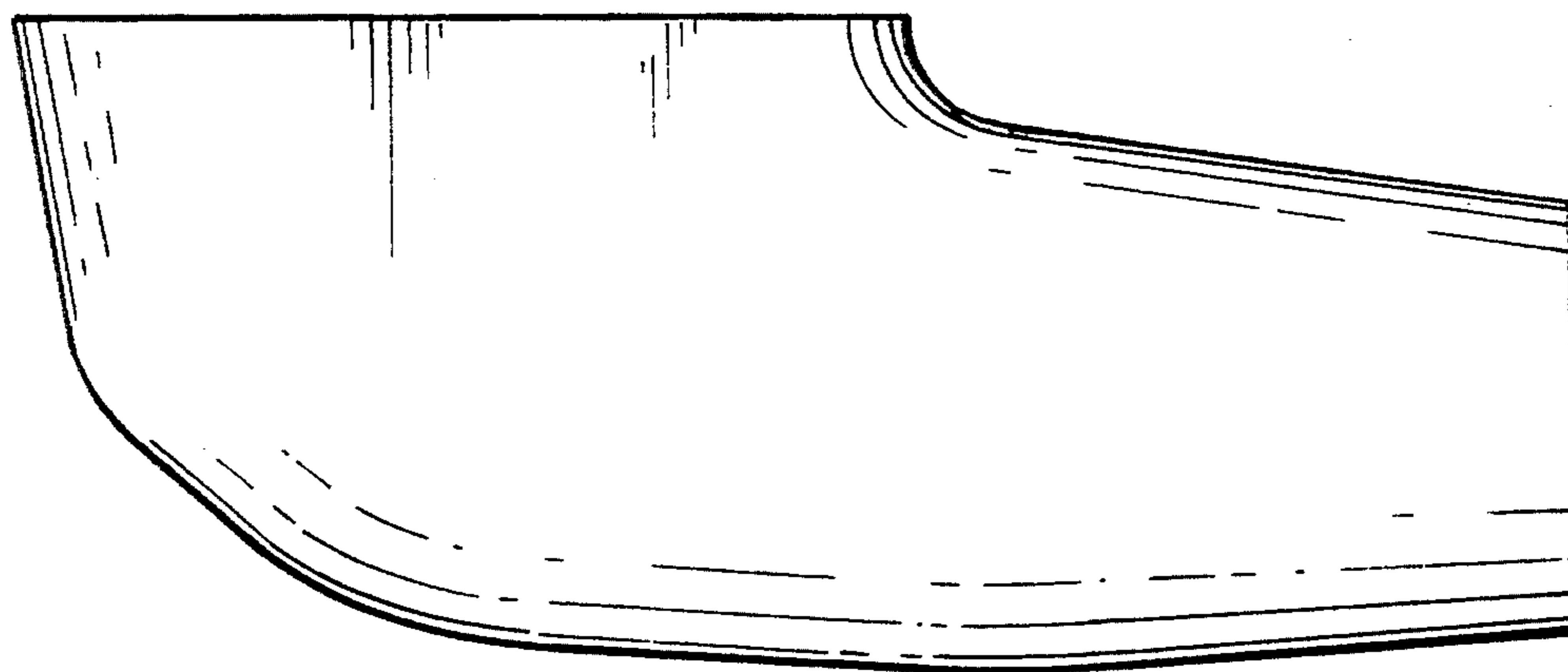

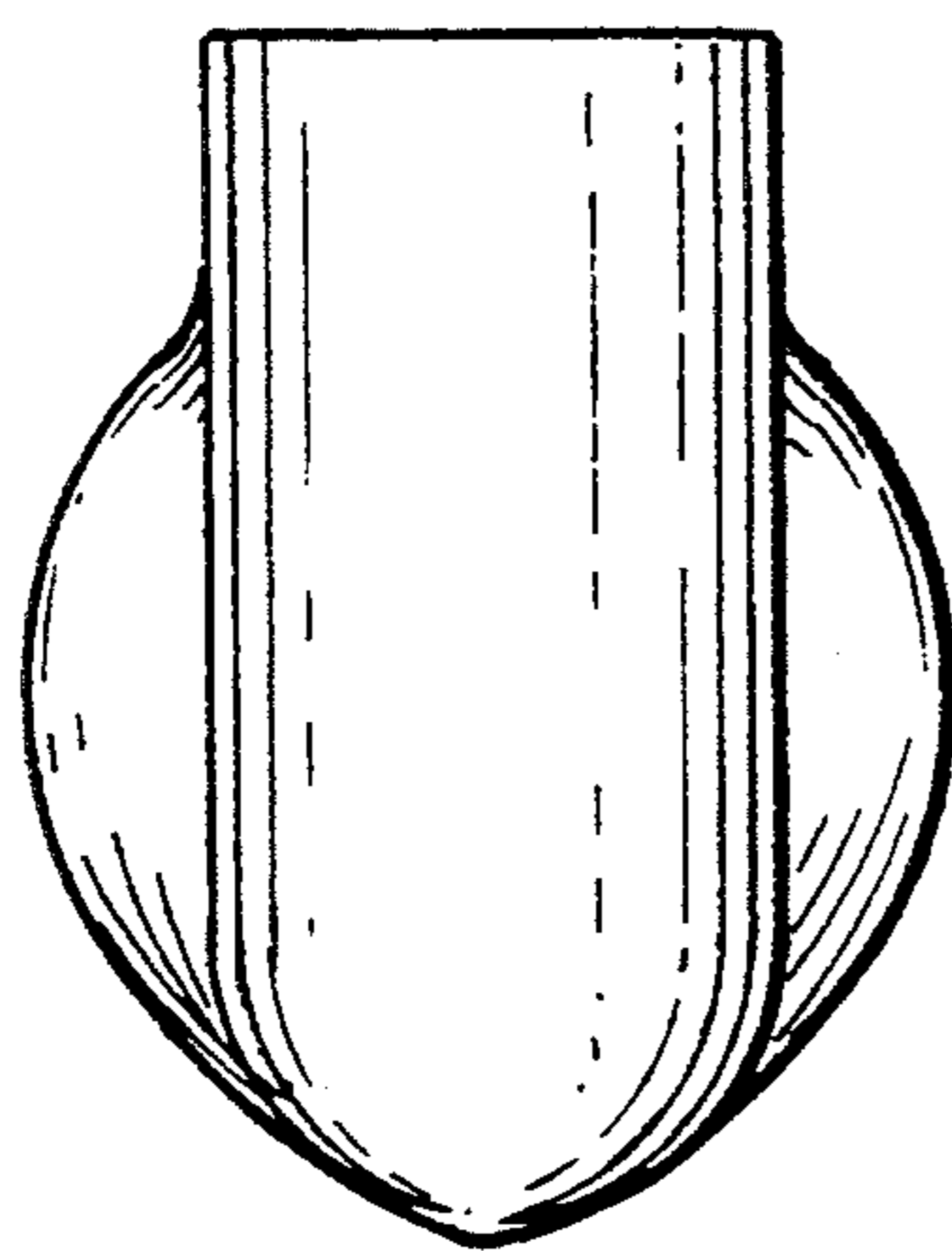
