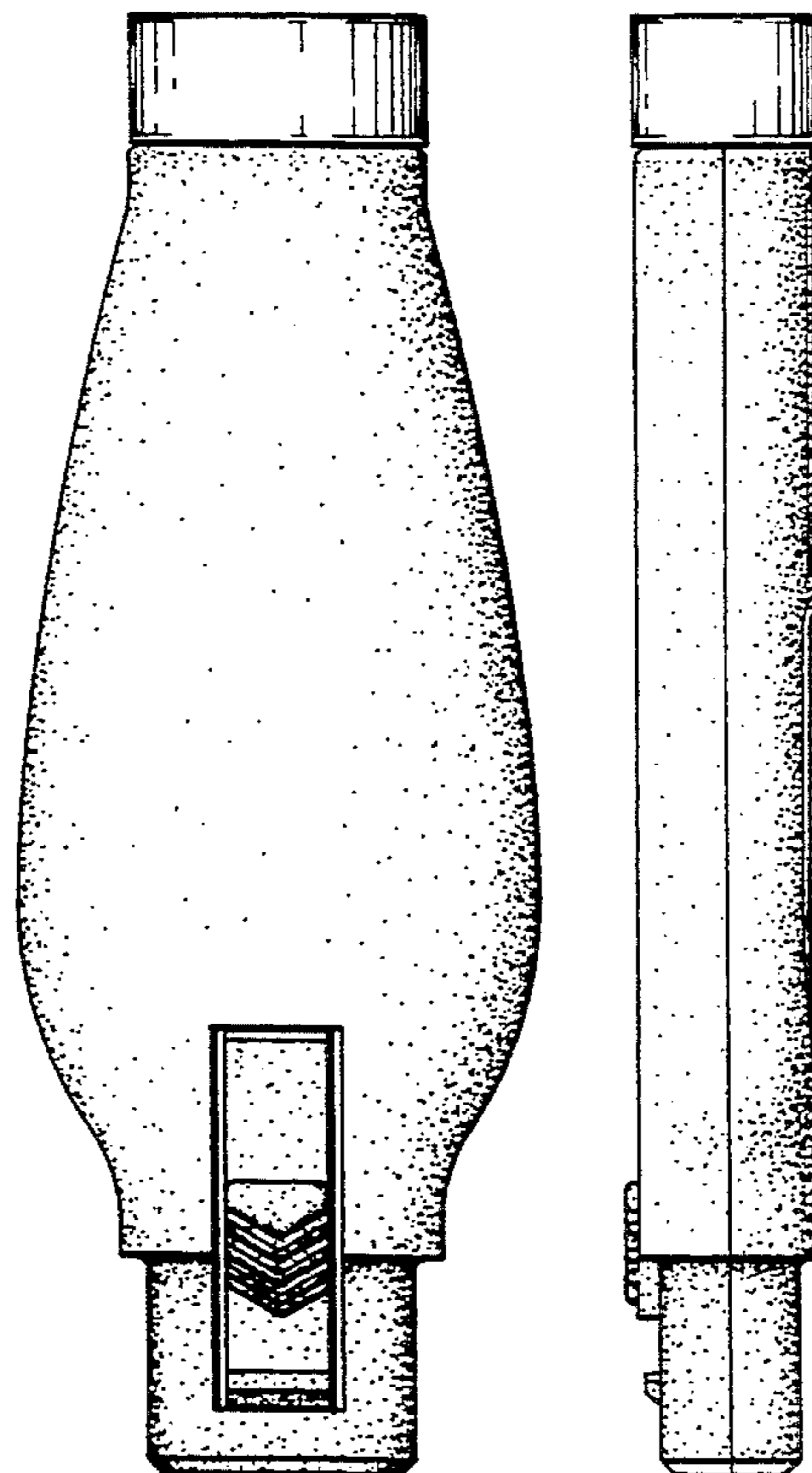

[57] CLAIM

The ornamental design for a headset/amplifier interface adaptor, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a headset/amplifier interface adaptor showing our new design; FIG. 2 is a side elevational view thereof, the opposite side being a mirror image; FIG. 3 is a bottom view thereof; FIG. 4 is a front view thereof; and, FIG. 5 is a back view thereof.



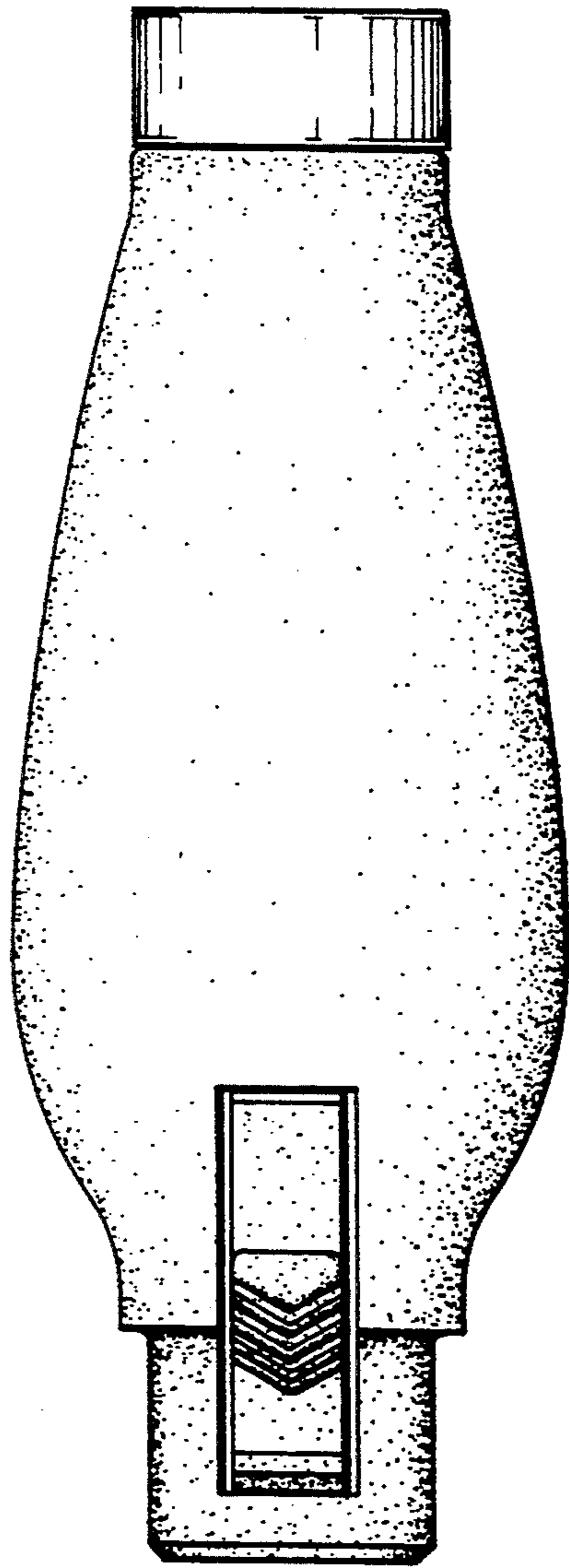

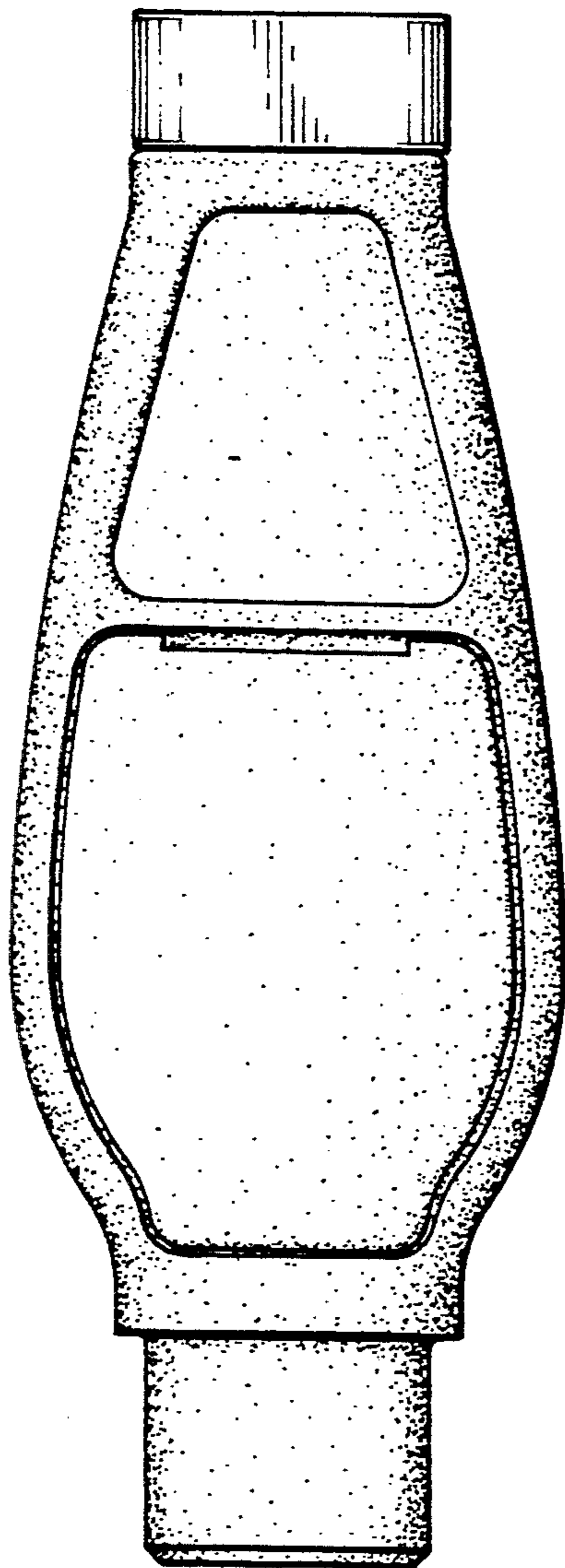

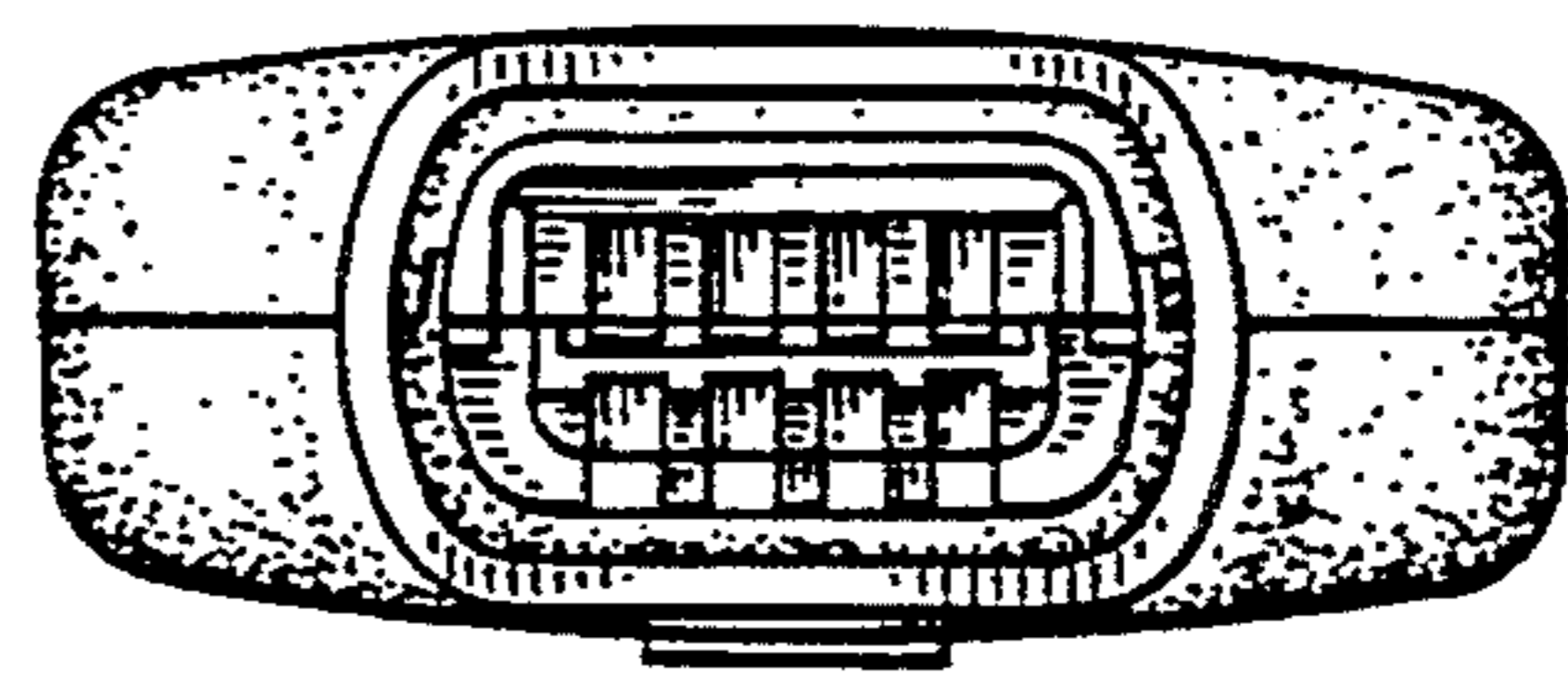

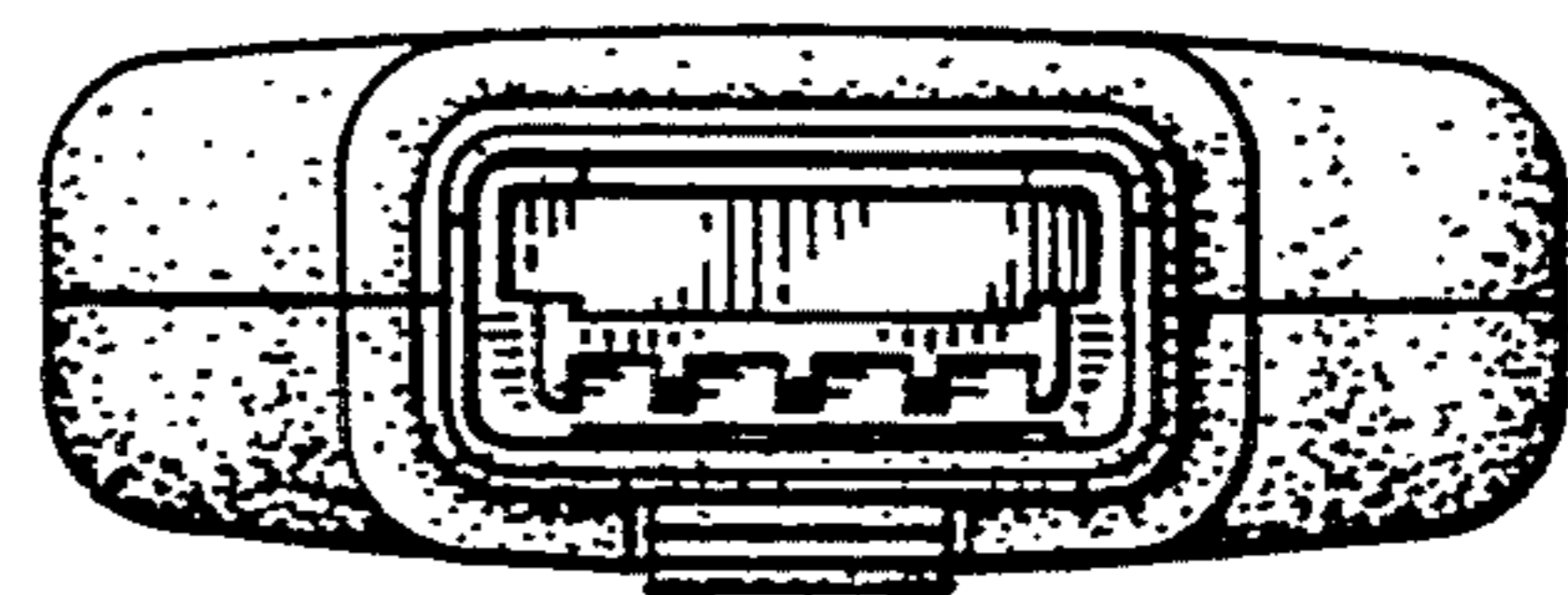
