

The ornamental design for a loudspeaker, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a loudspeaker showing my design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a front elevational view thereof and is a front elevational view of FIG. 13;  
 FIG. 4 is a rear elevational view thereof and is a rear elevational view of FIG. 8;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a left side elevational view thereof;  
 FIG. 7 is a right side elevational view thereof;  
 FIG. 8 is a top plan view of an alternate embodiment of the loudspeaker shown in FIG. 1;  
 FIG. 9 is a front elevational view of FIG. 8;  
 FIG. 10 is a bottom plan view of FIG. 8;  
 FIG. 11 is a left side elevational view of FIG. 8;  
 FIG. 12 is a right side elevational view of FIG. 8;  
 FIG. 13 is a top plan view of an alternate embodiment of the loudspeaker shown in FIG. 1, the bottom view being a mirror image;  
 FIG. 14 is a left side elevational view of FIG. 13;  
 FIG. 15 is a right side elevational view of FIG. 13; and,  
 FIG. 16 is a rear elevational view of FIG. 13.

































