FIG. 5 shows a top view of the present invention; and, FIG. 6 shows a bottom view of the present invention.

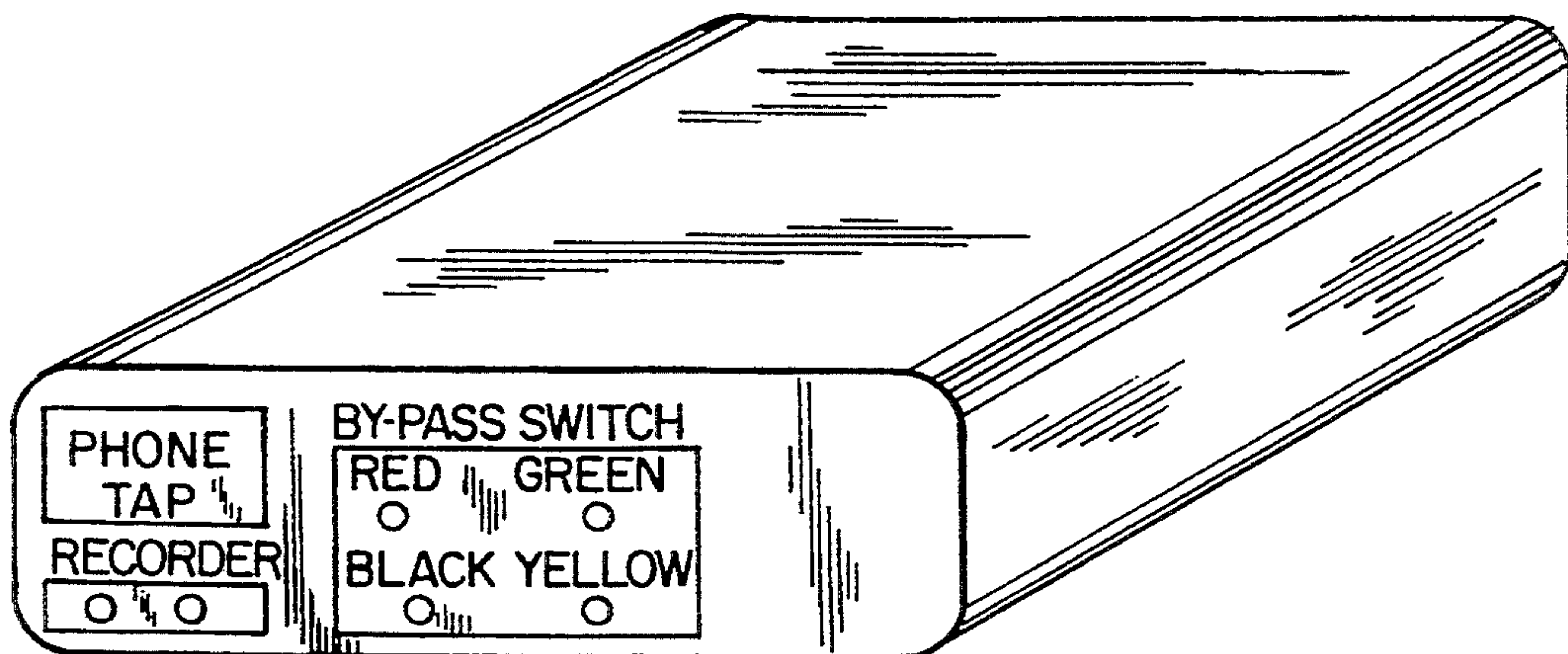
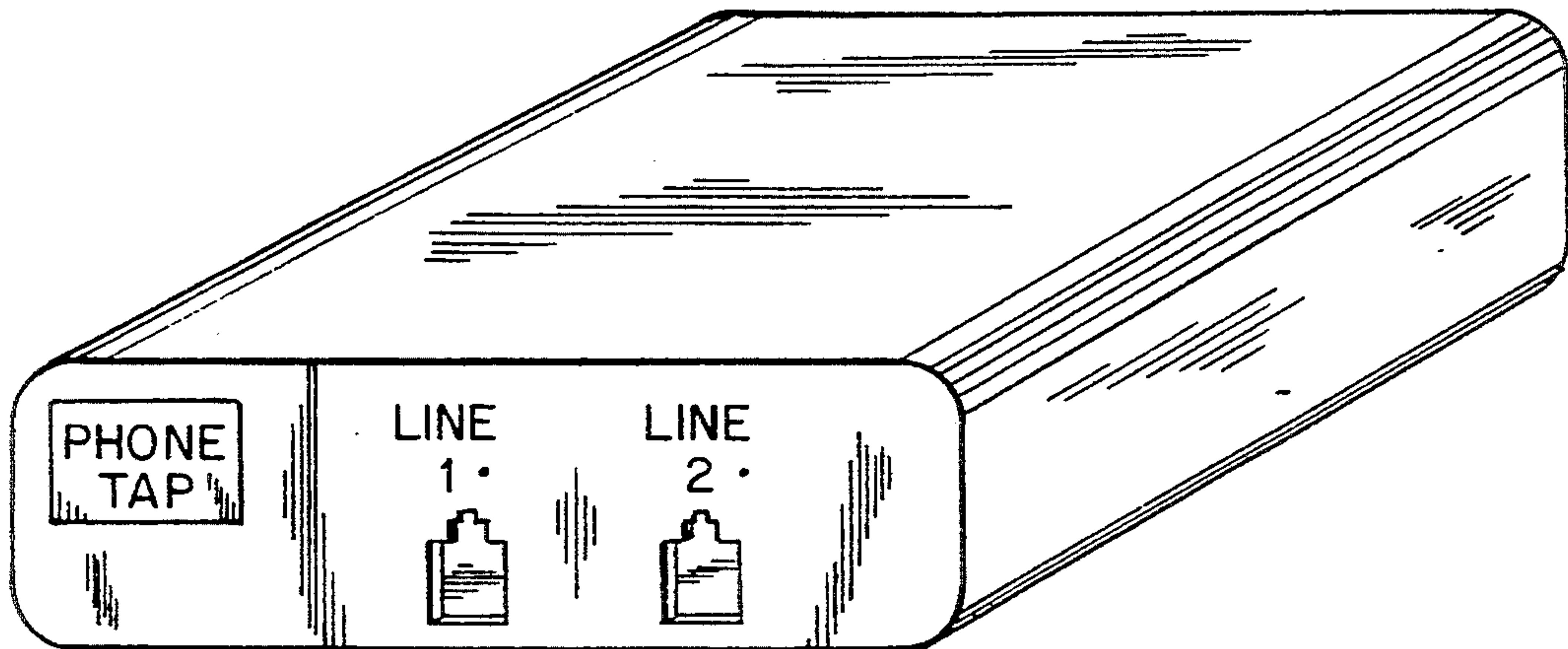

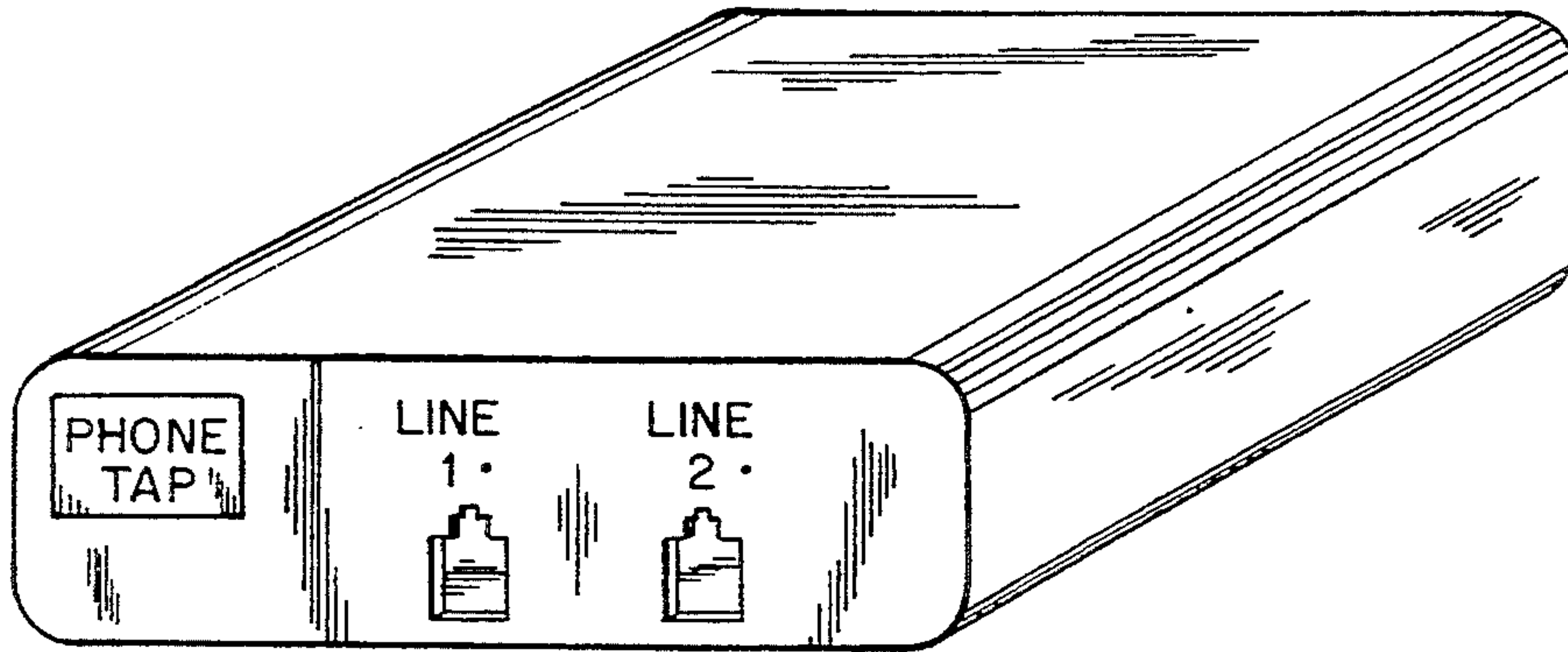

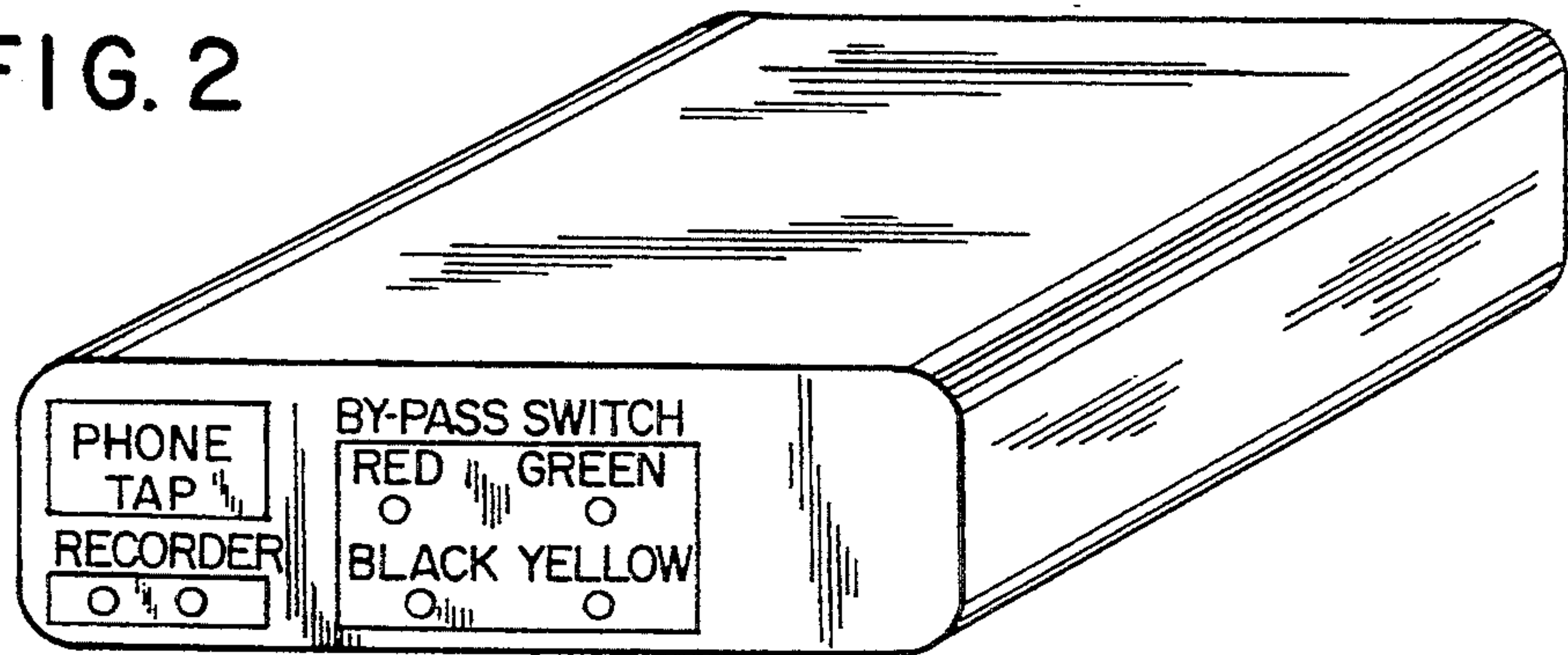

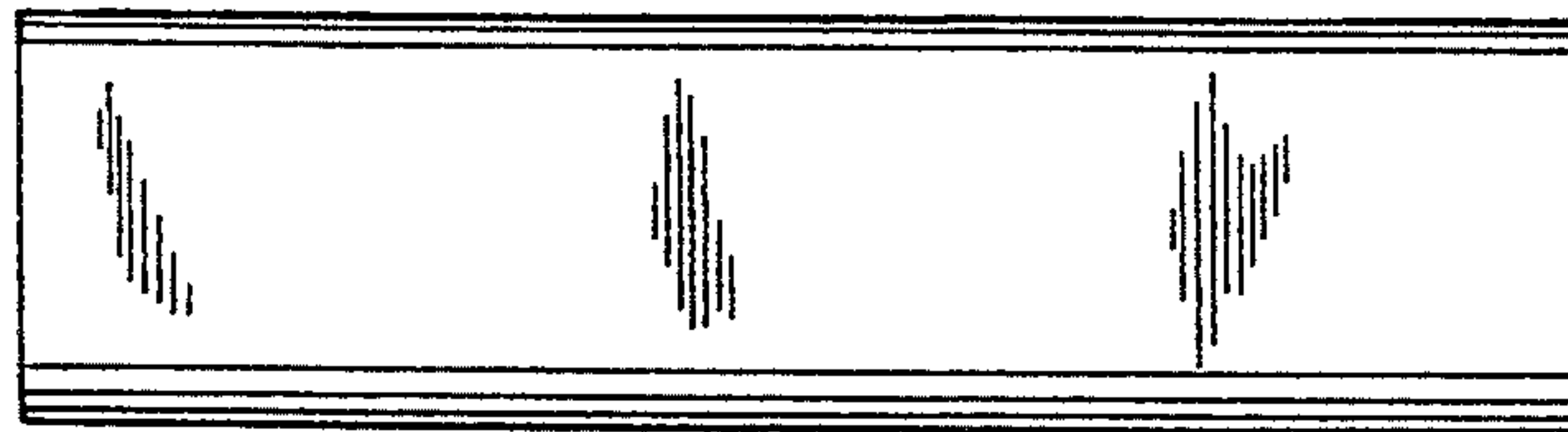

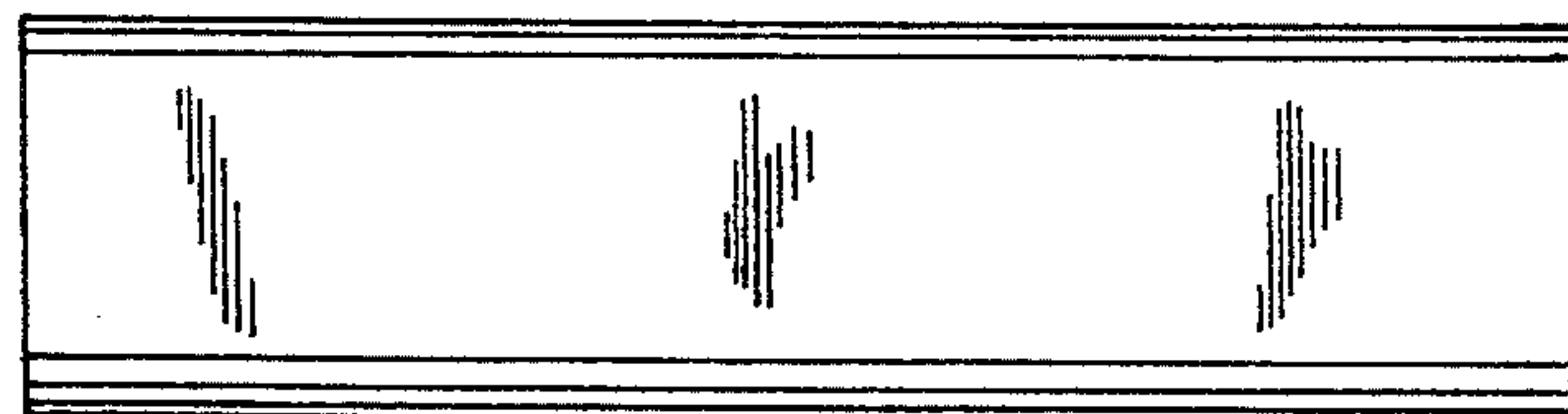

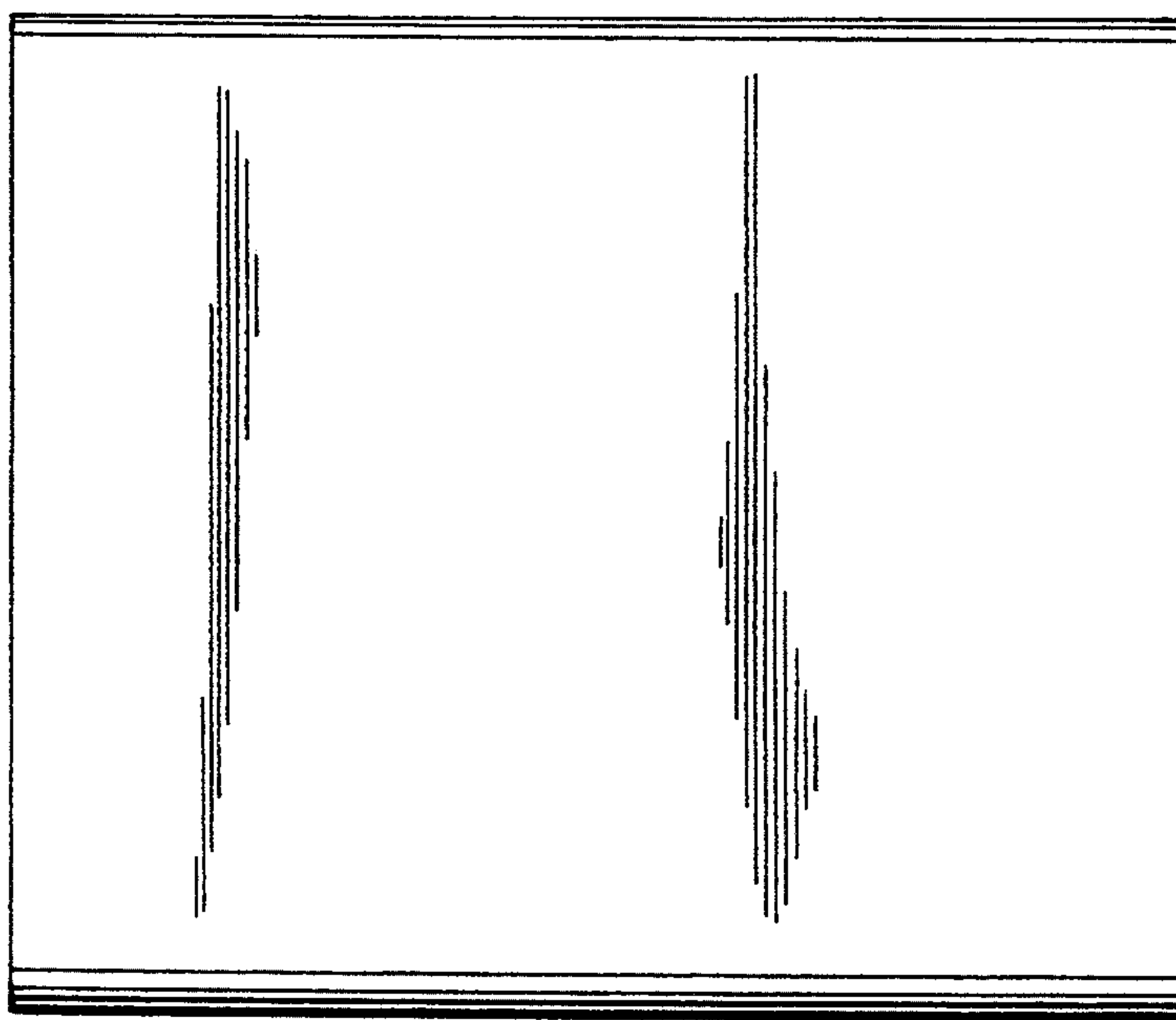
