DESCRIPTION

FIG. 1 is a top left front perspective view of a card file showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 7 is a top left front perspective view of the alternate embodiment of a card file showing our new design;

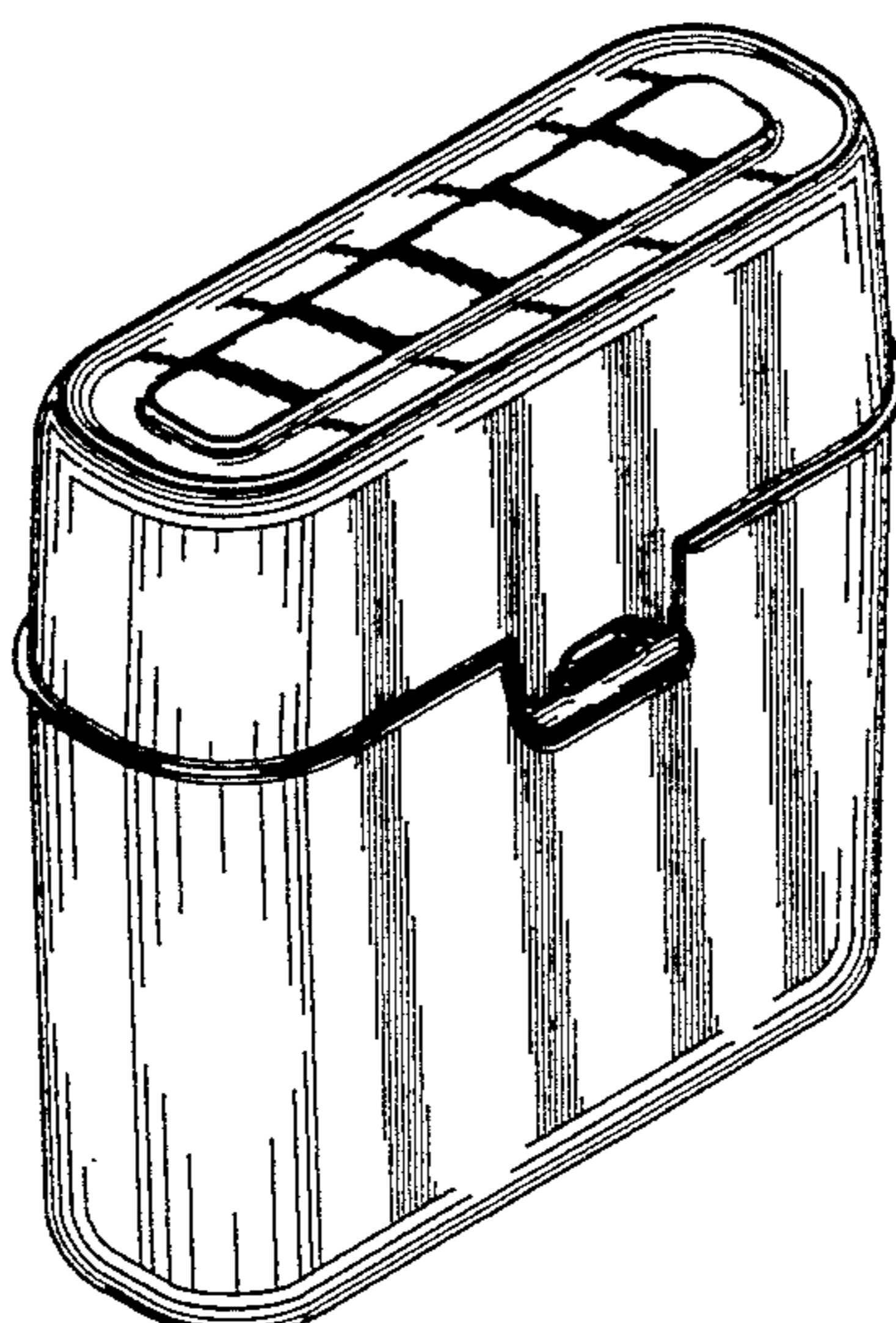
FIG. 8 is a front elevational view of the alternate embodiment;

FIG. 12 is a bottom plan view of the alternate embodiment.



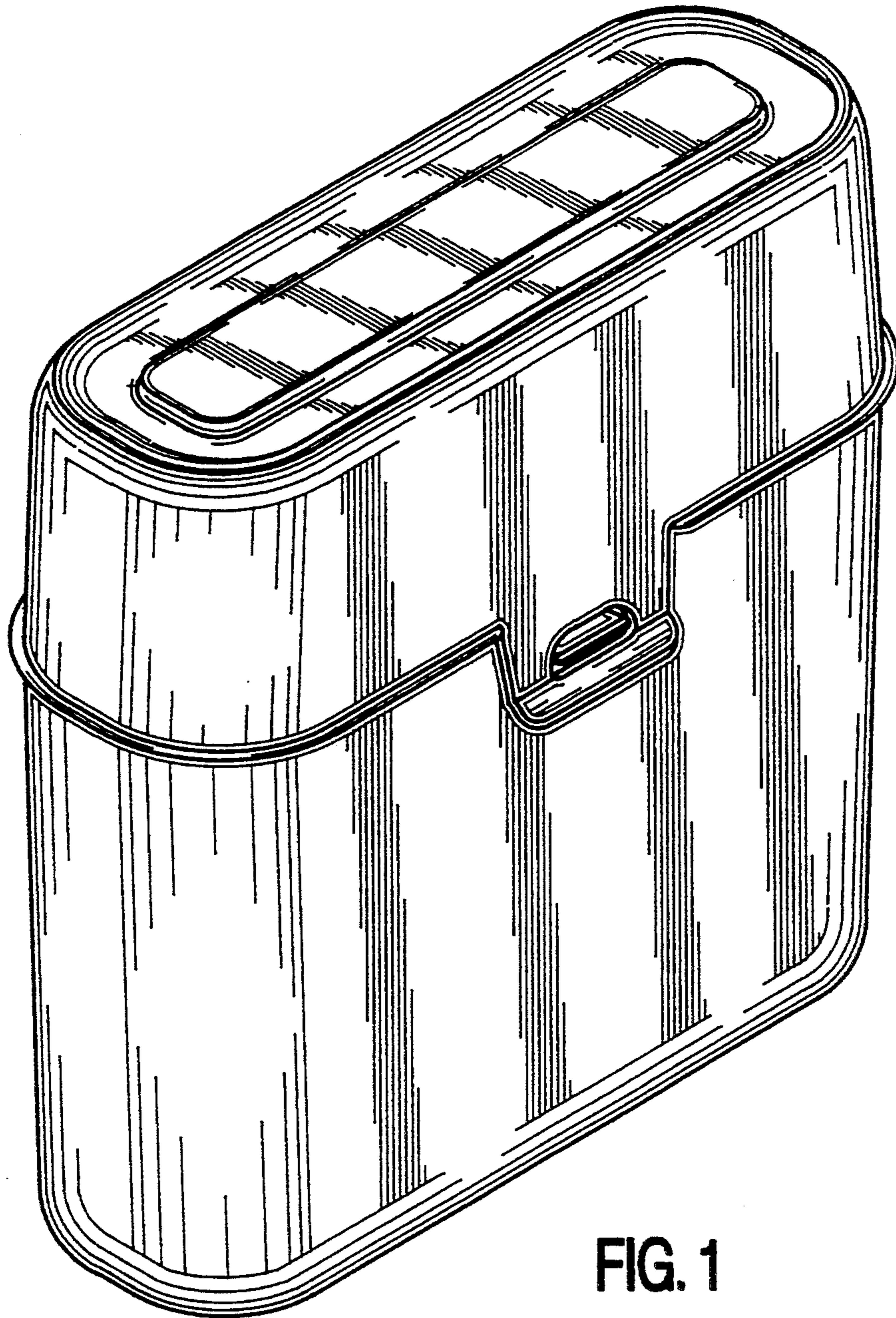

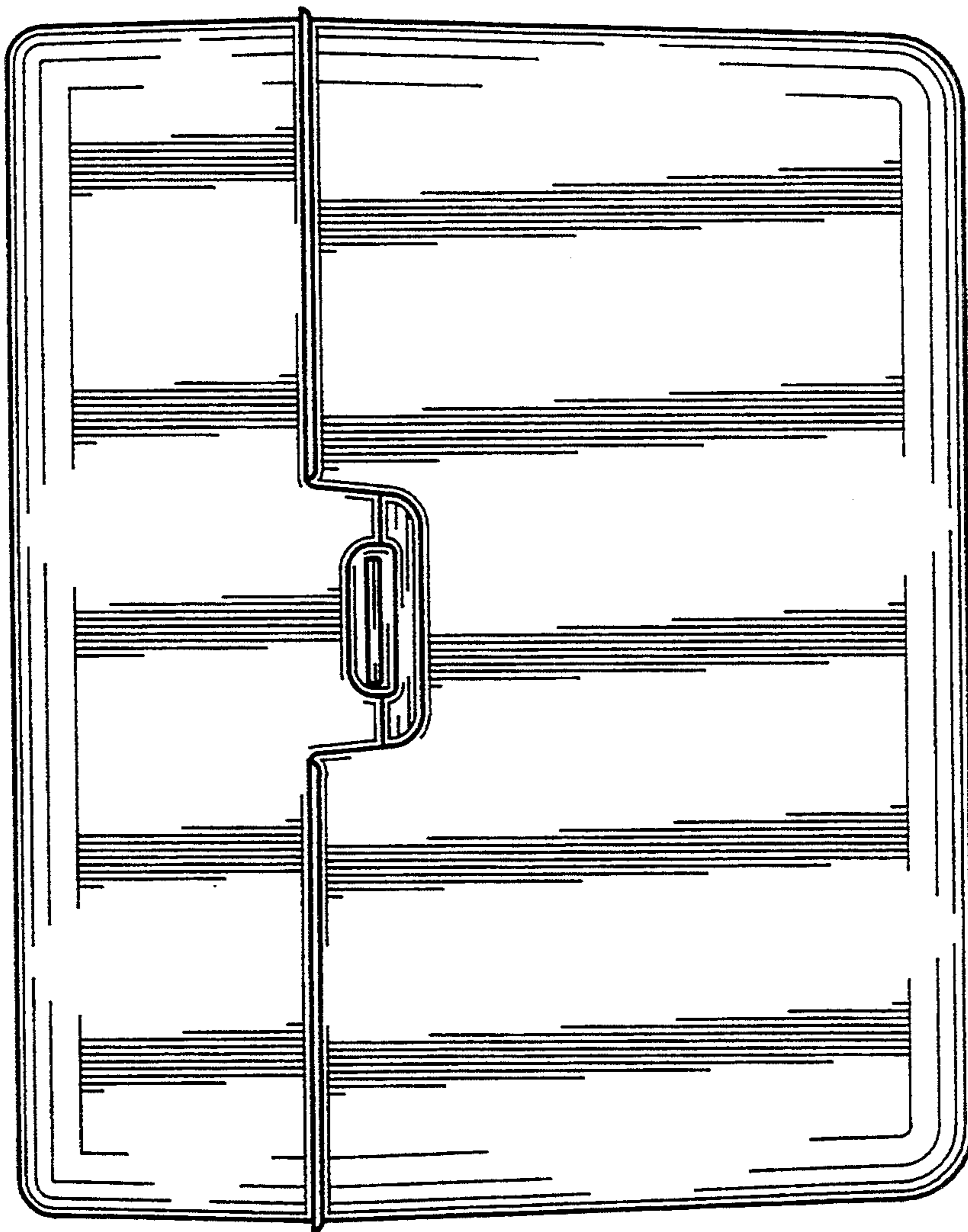

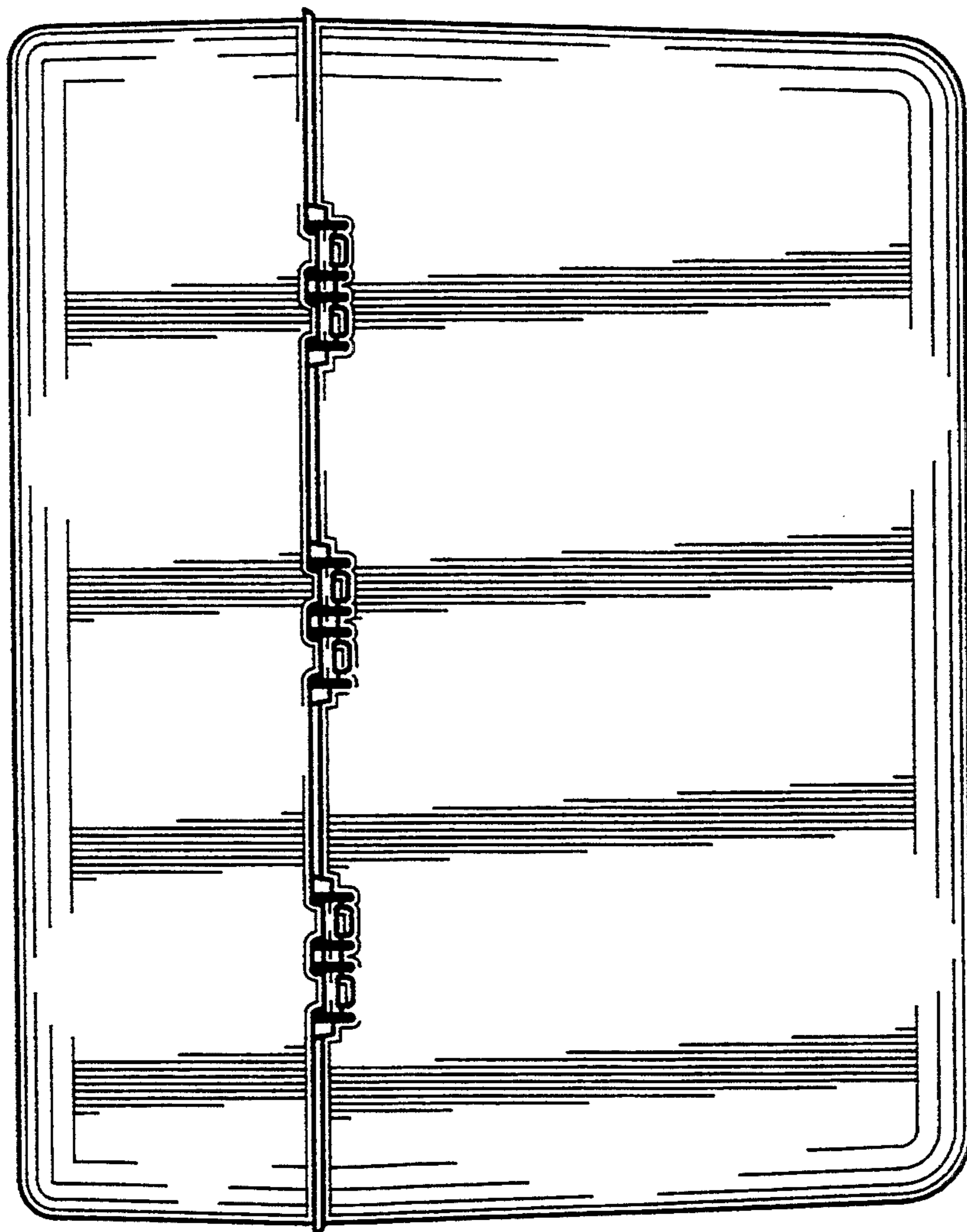

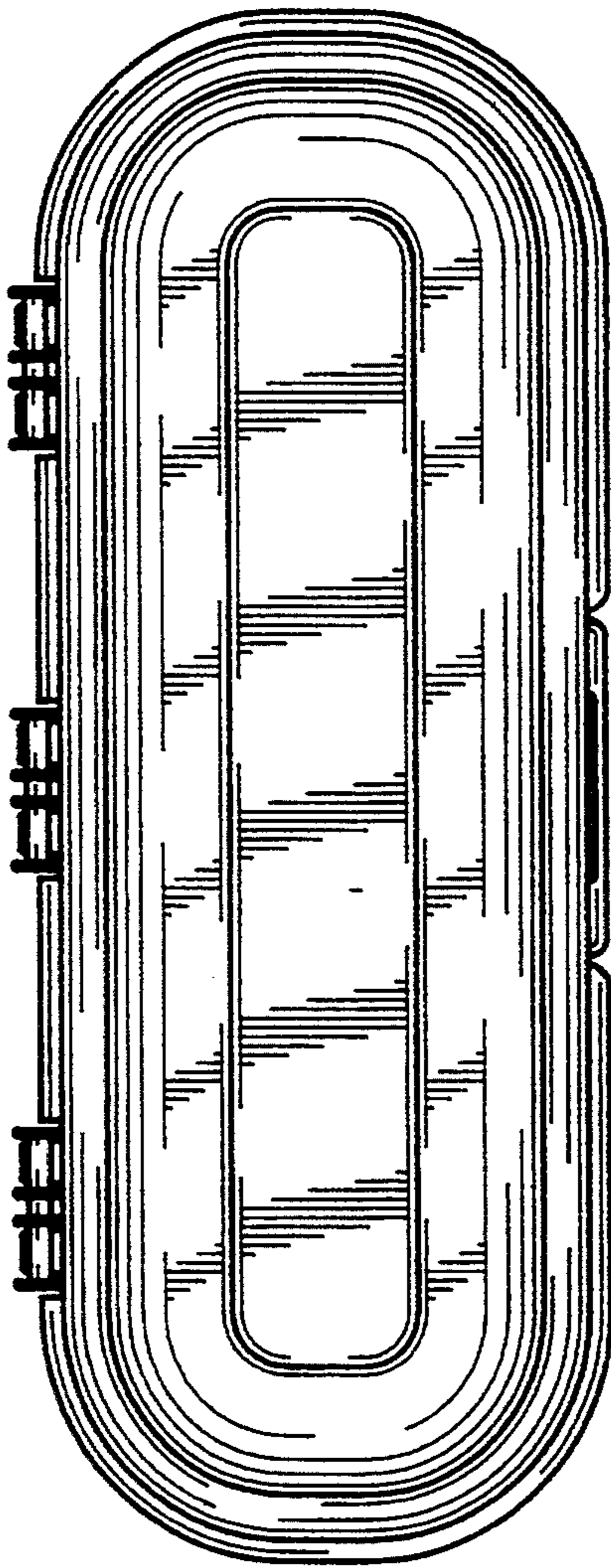

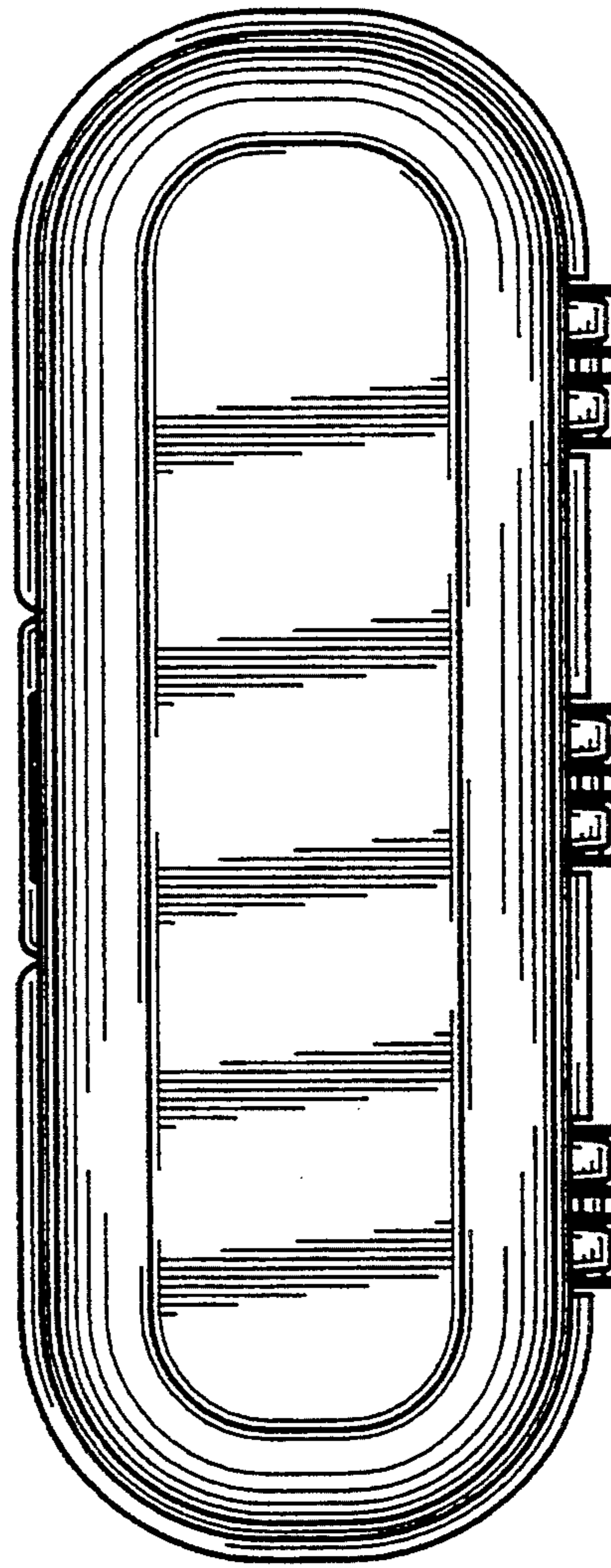

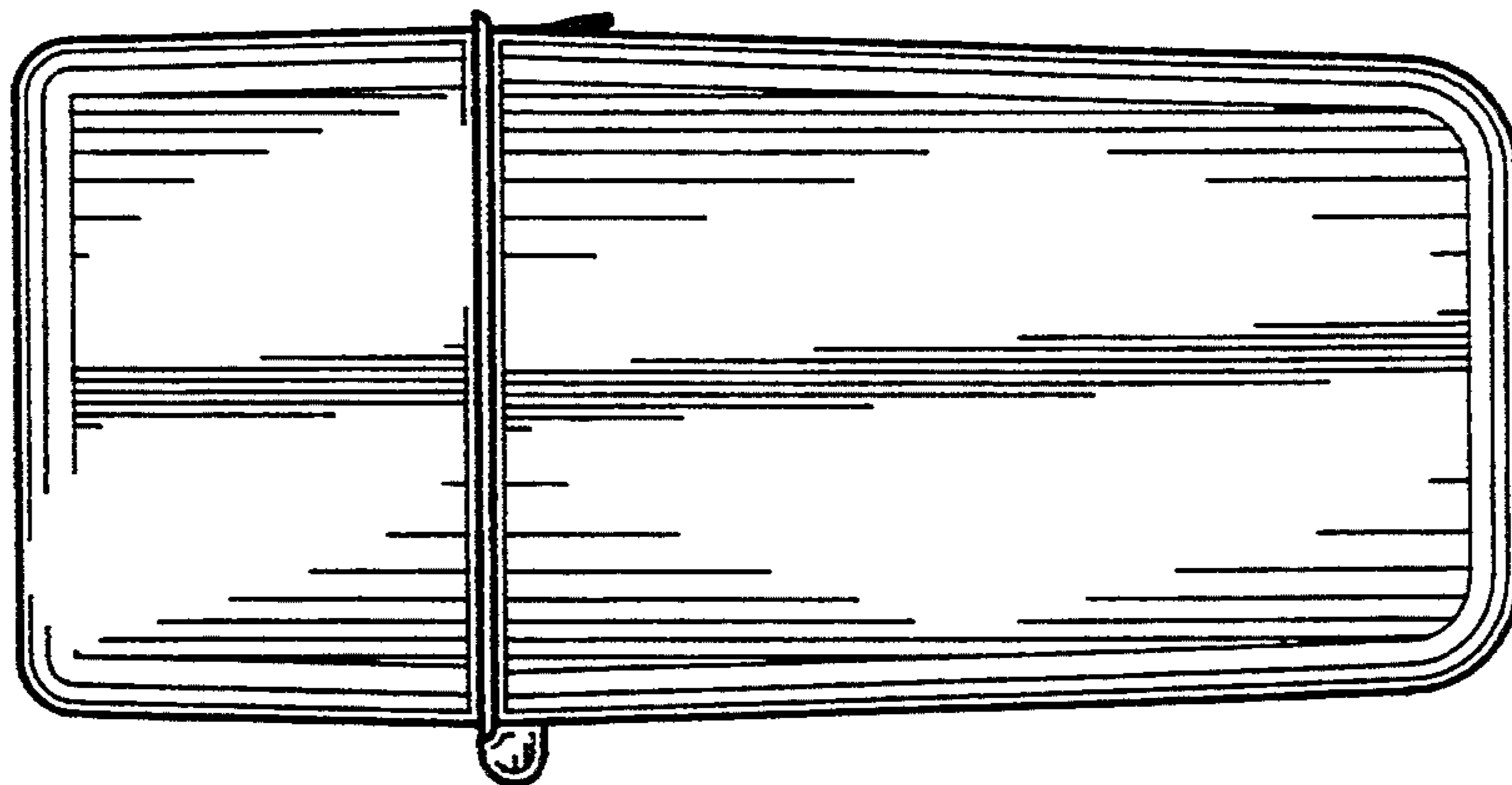

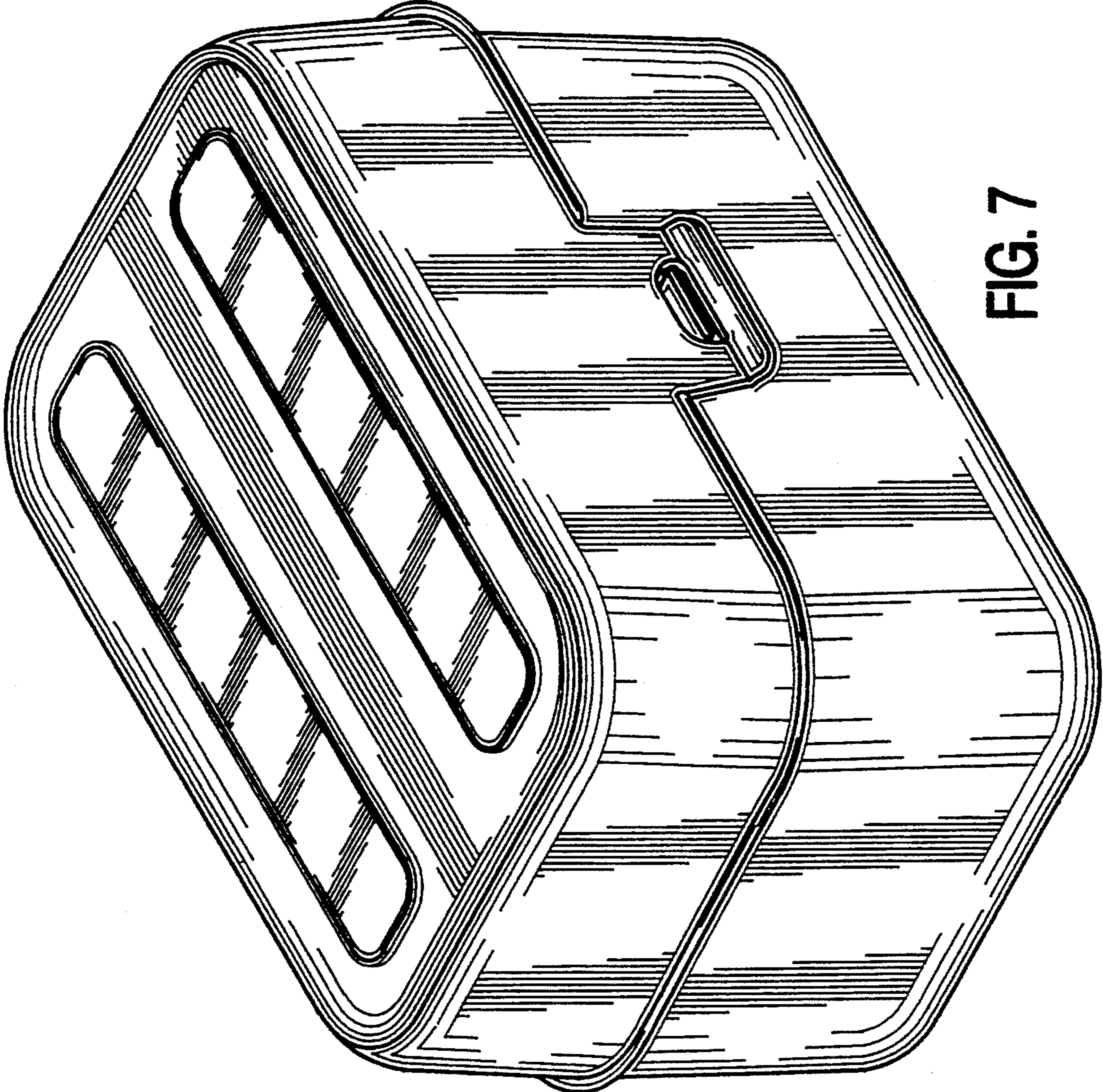

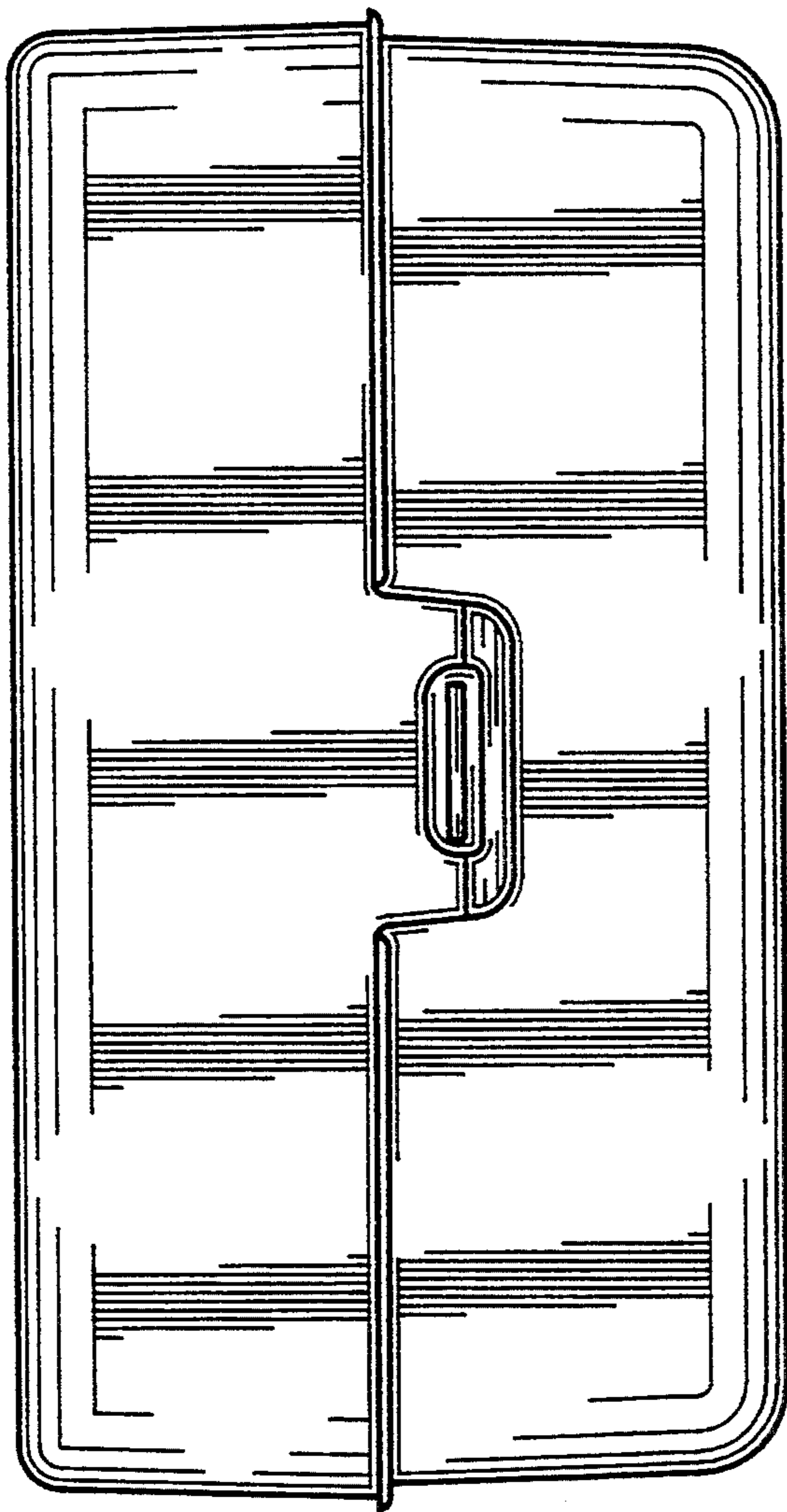

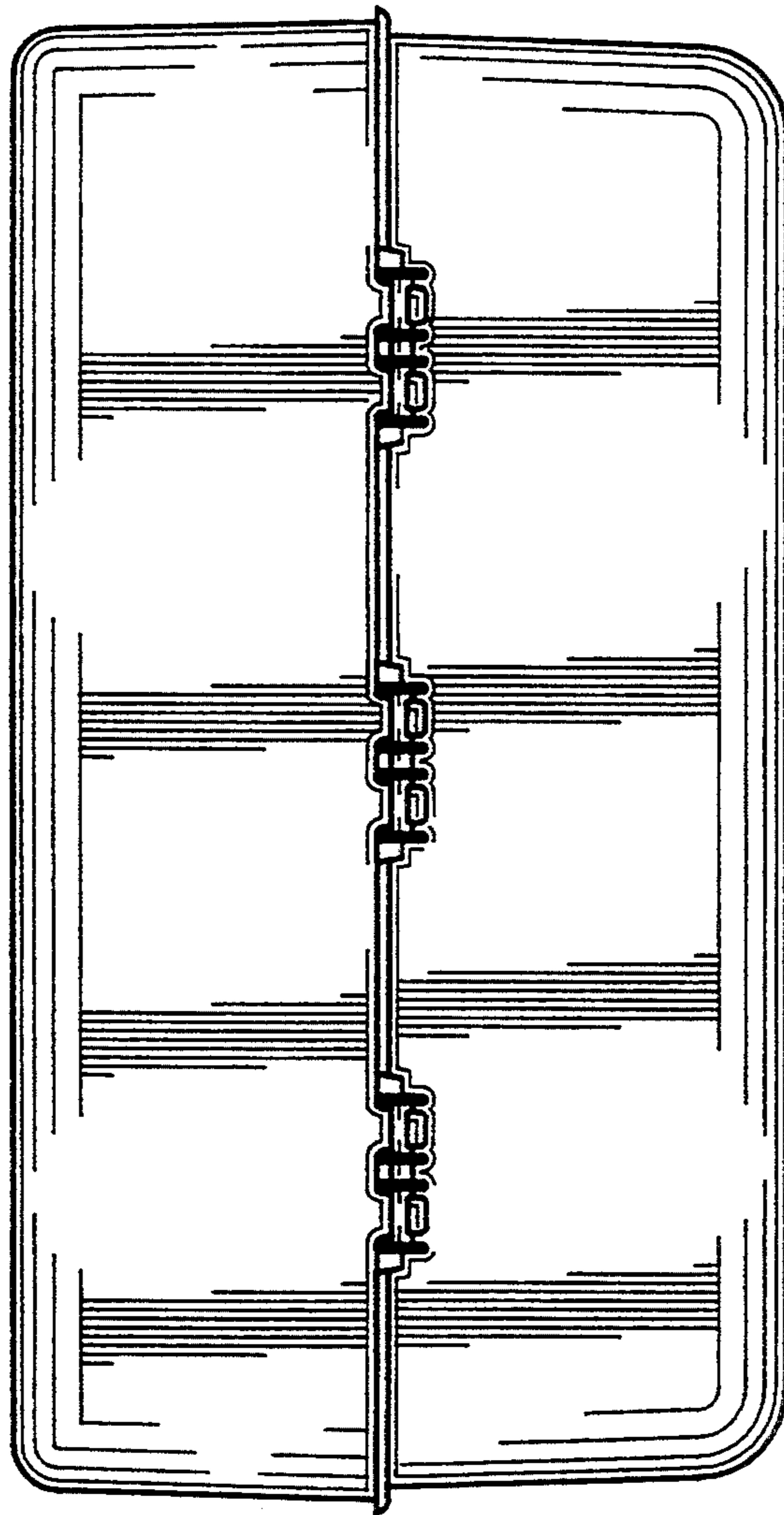

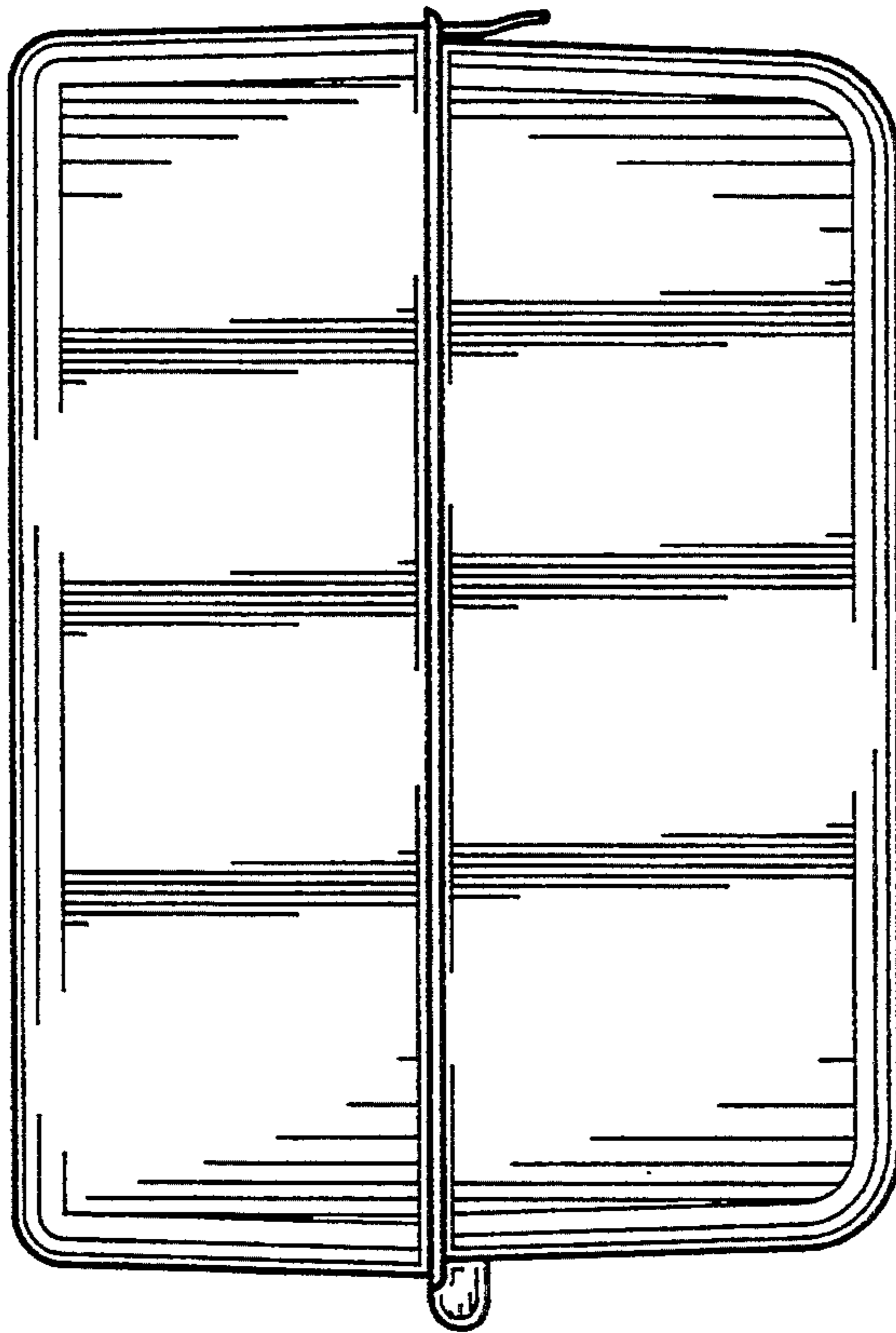

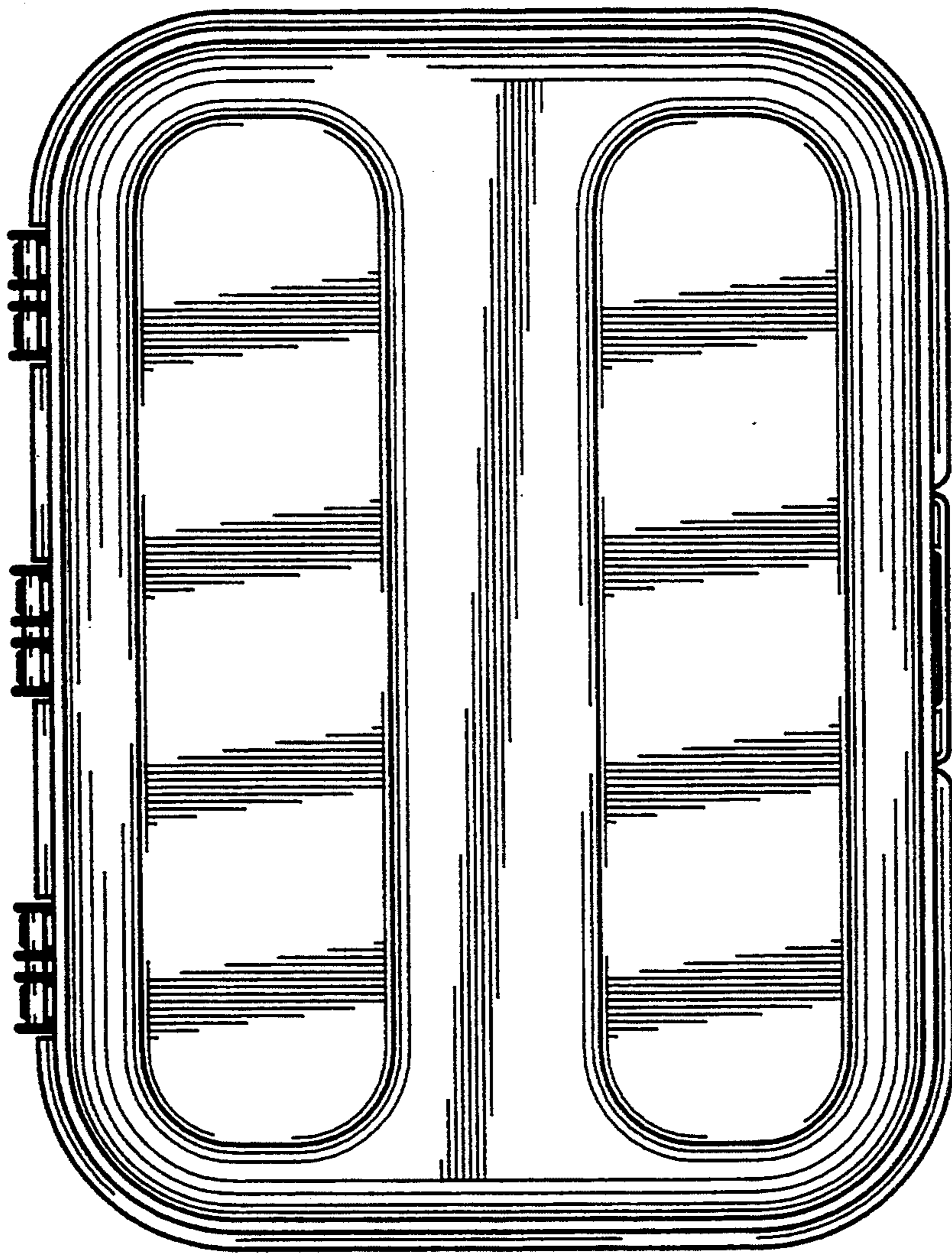

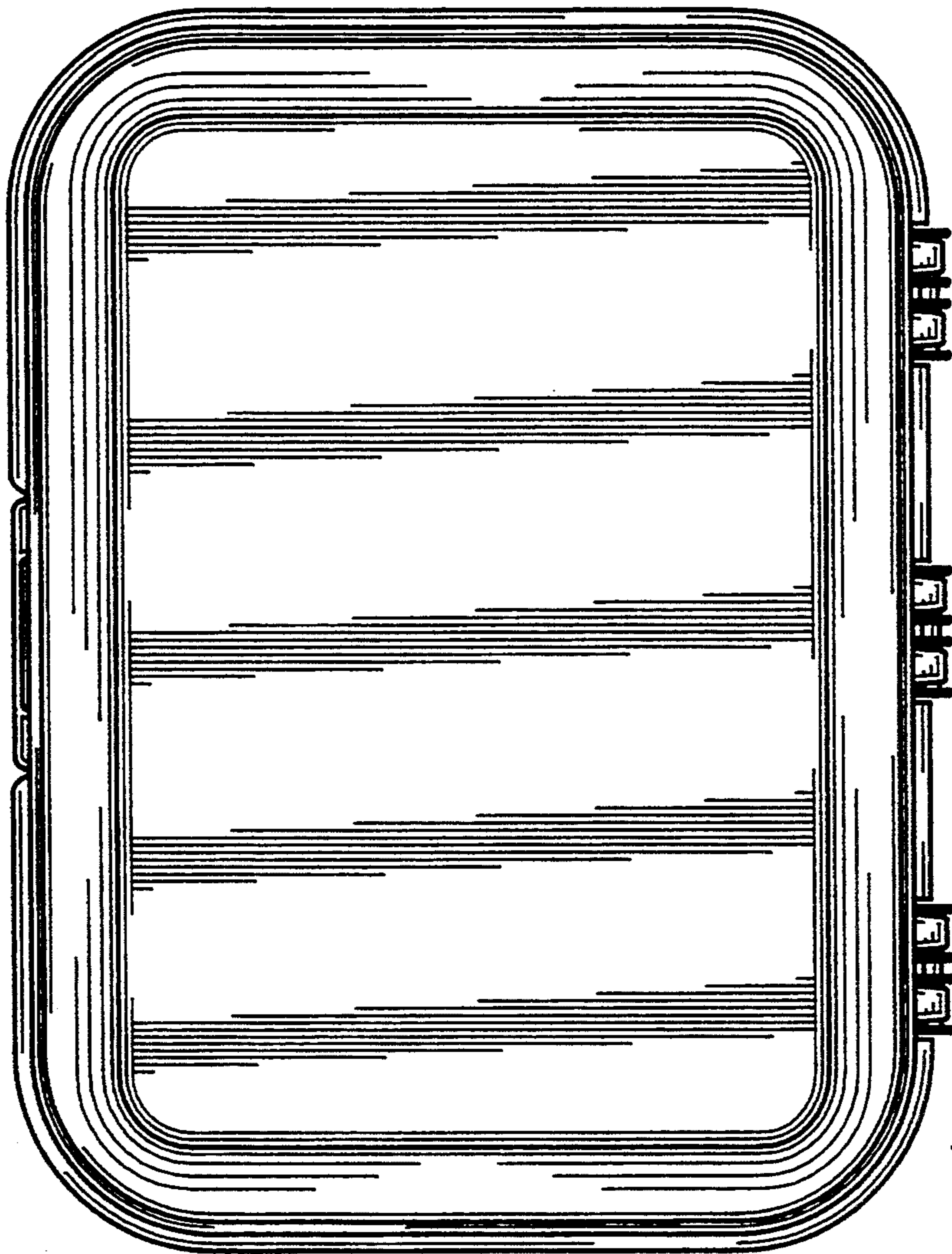
