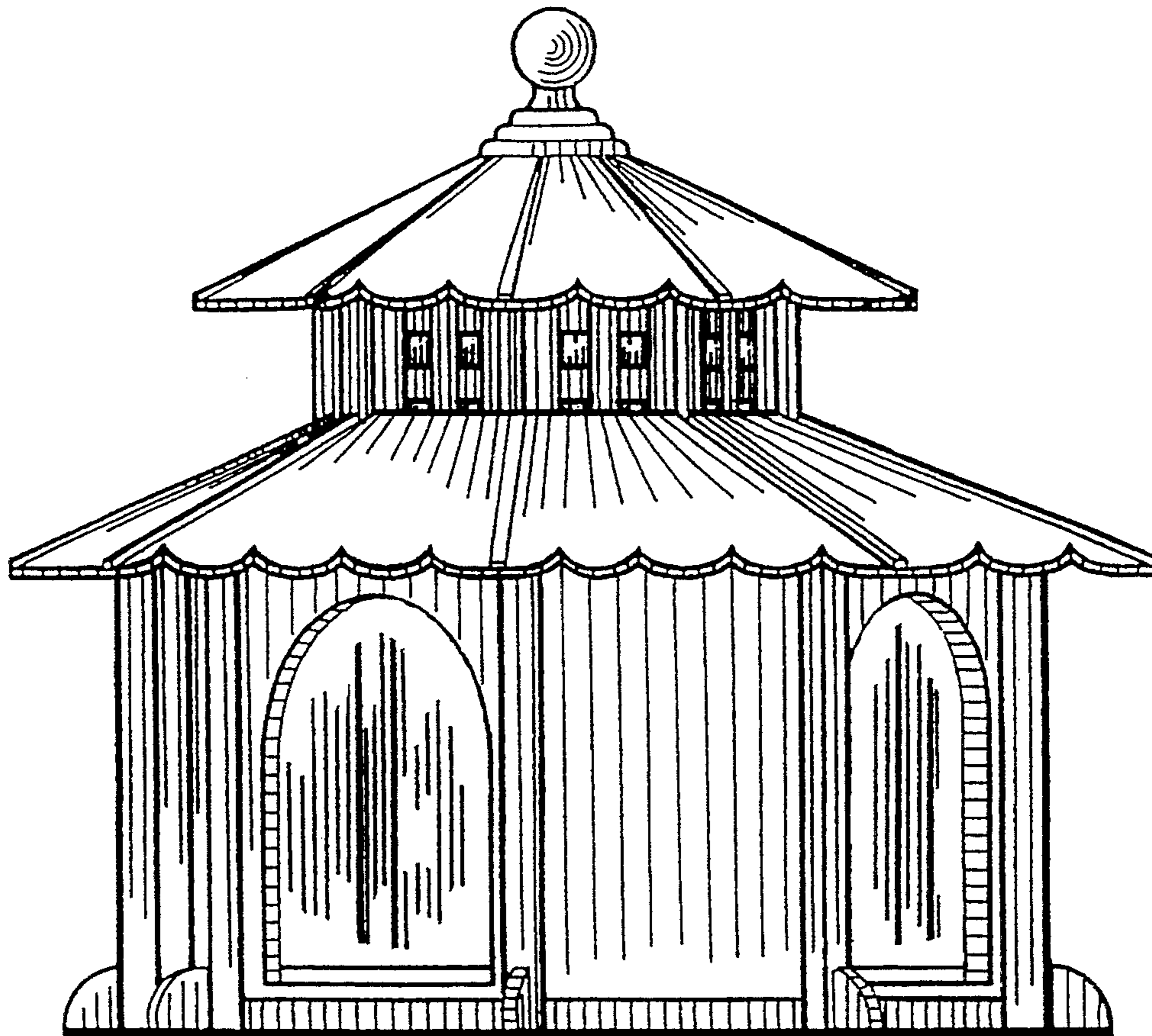

side being a mirror image of FIG. 5.



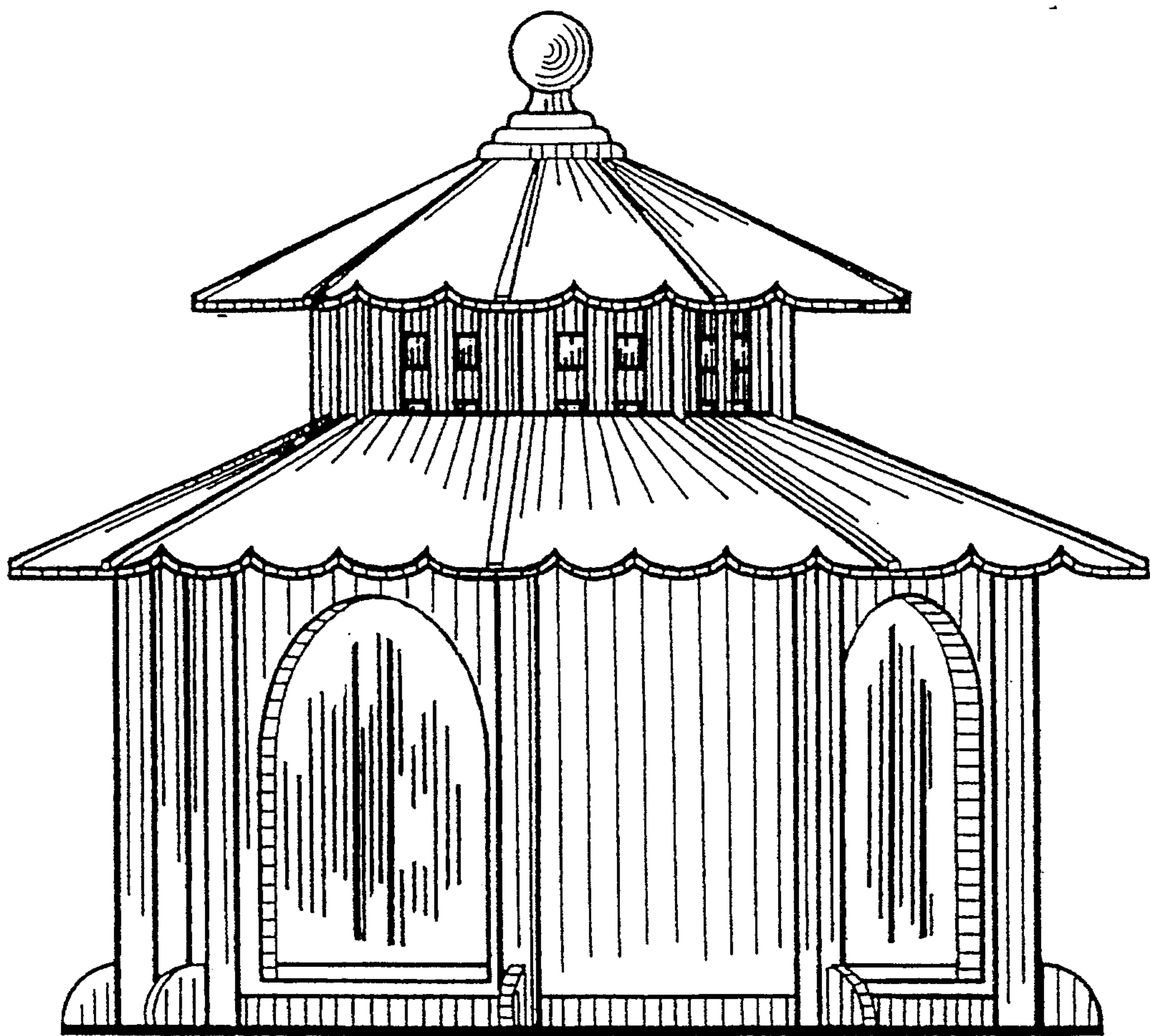

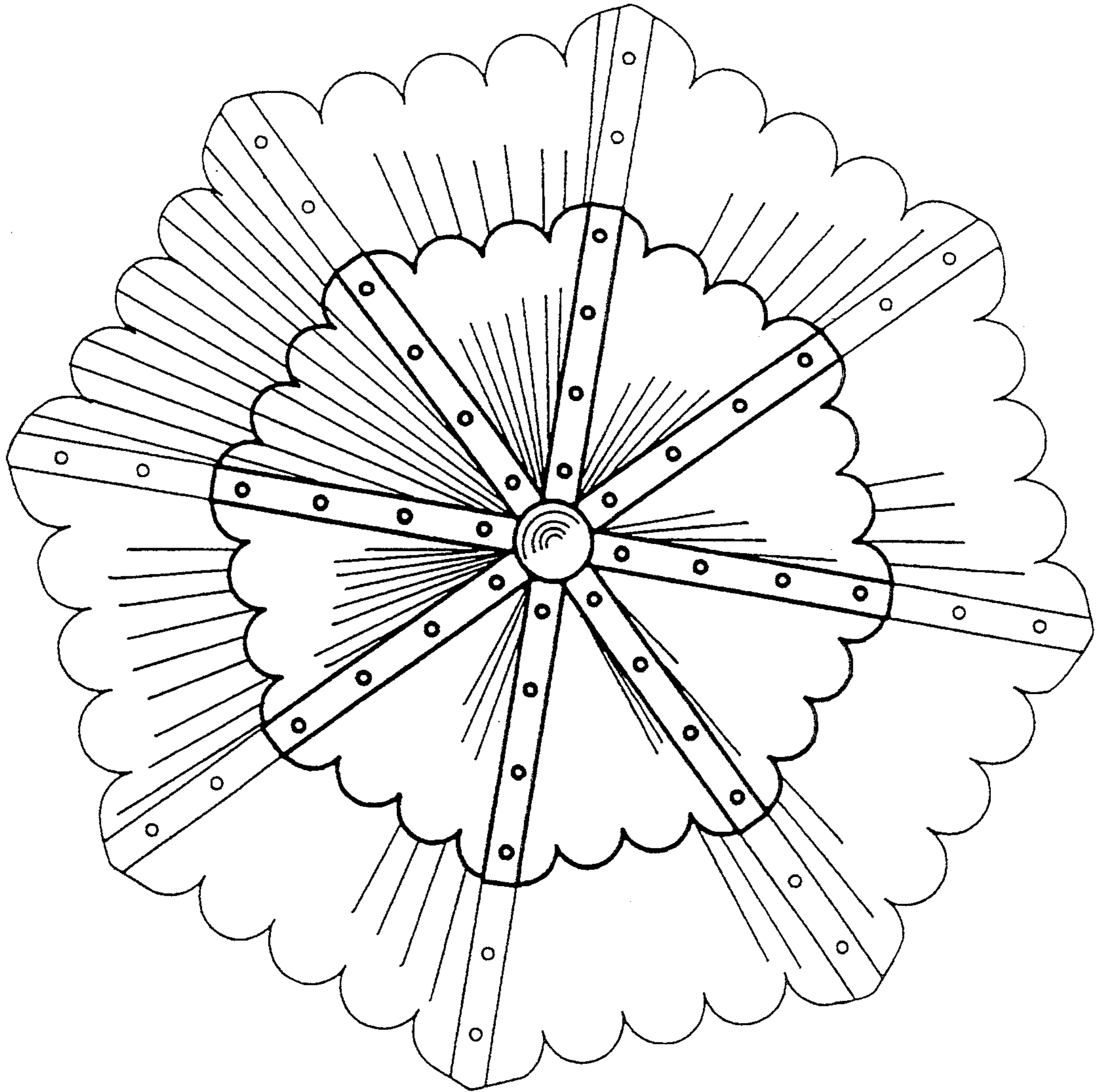

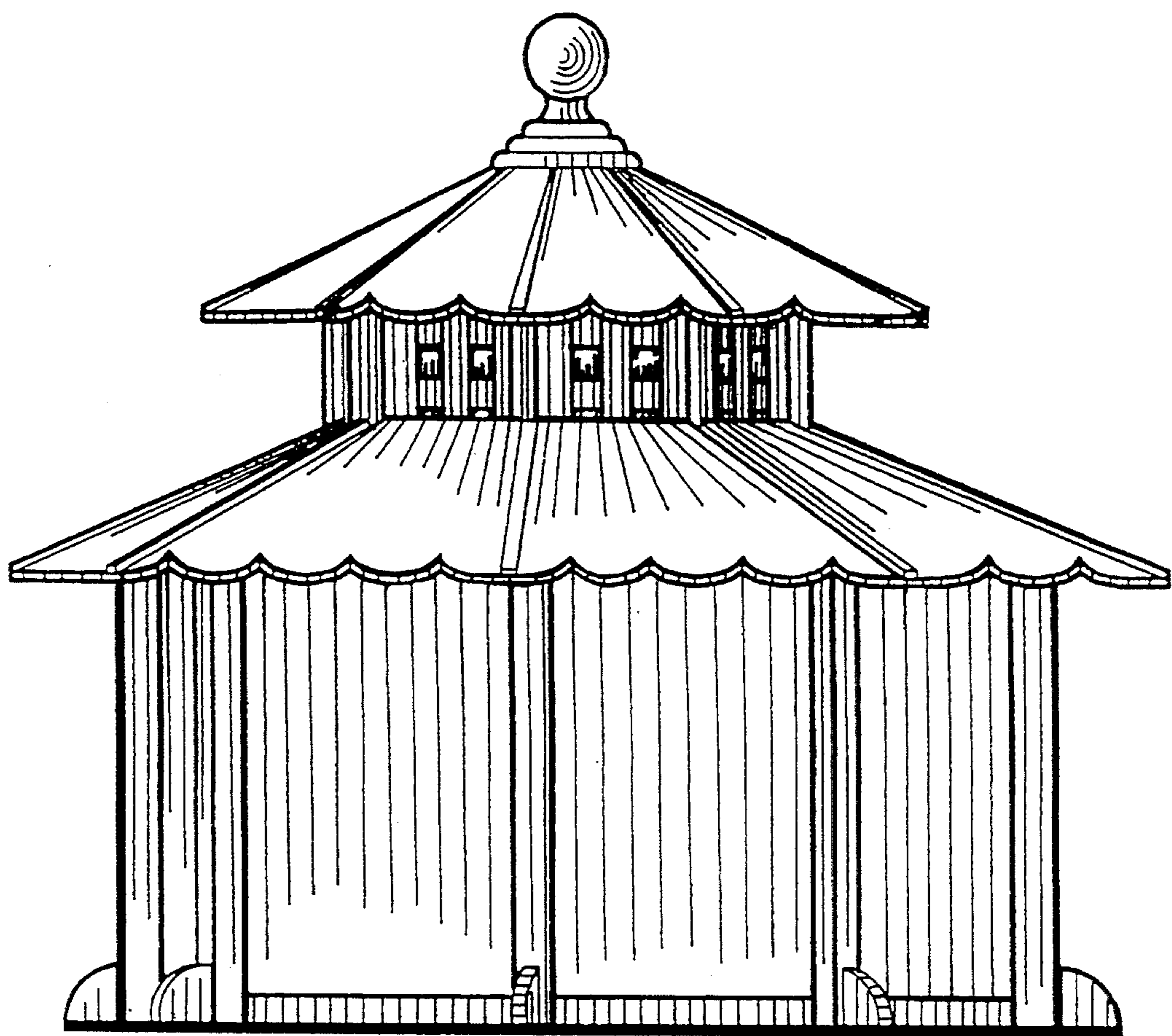

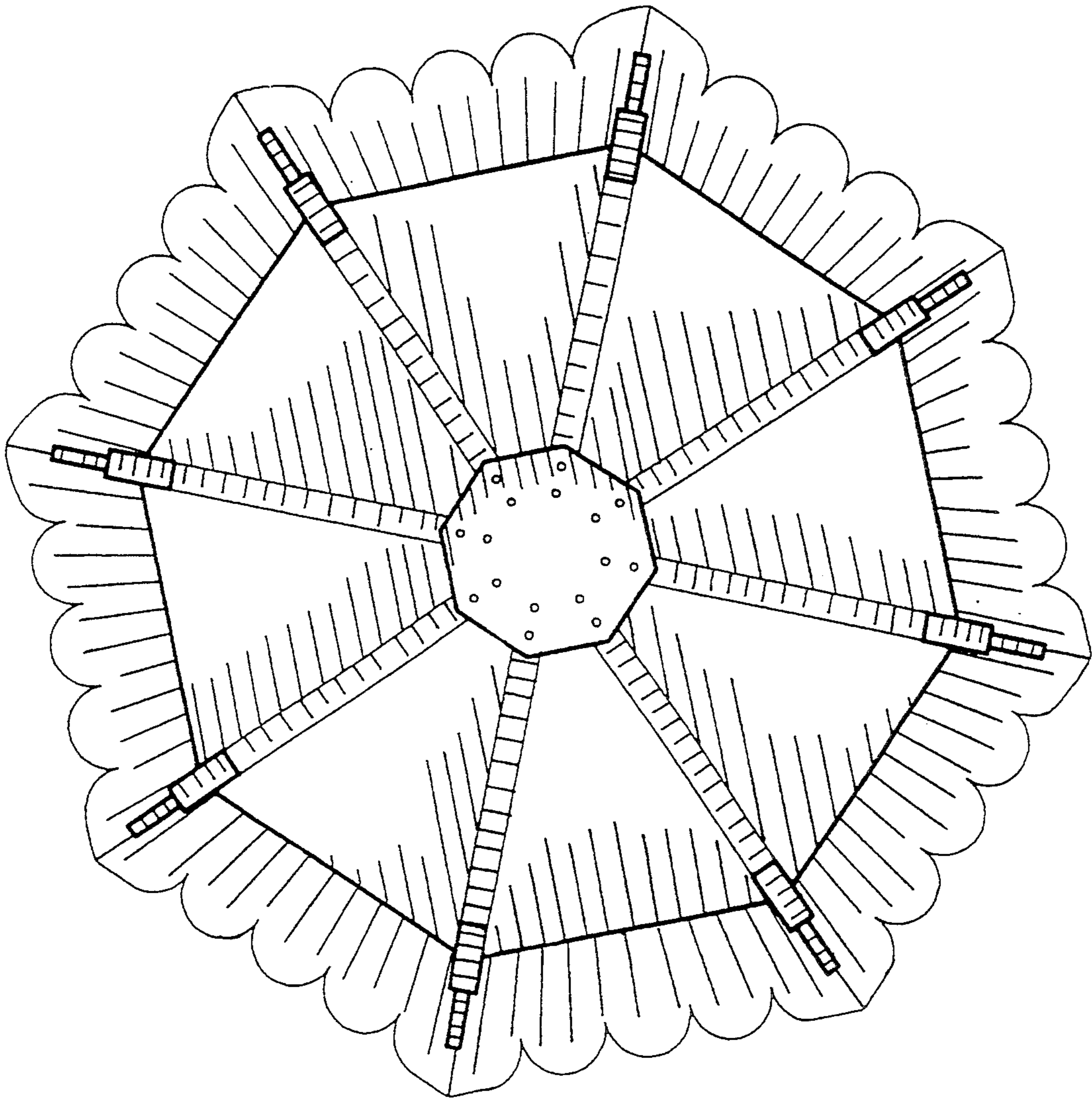

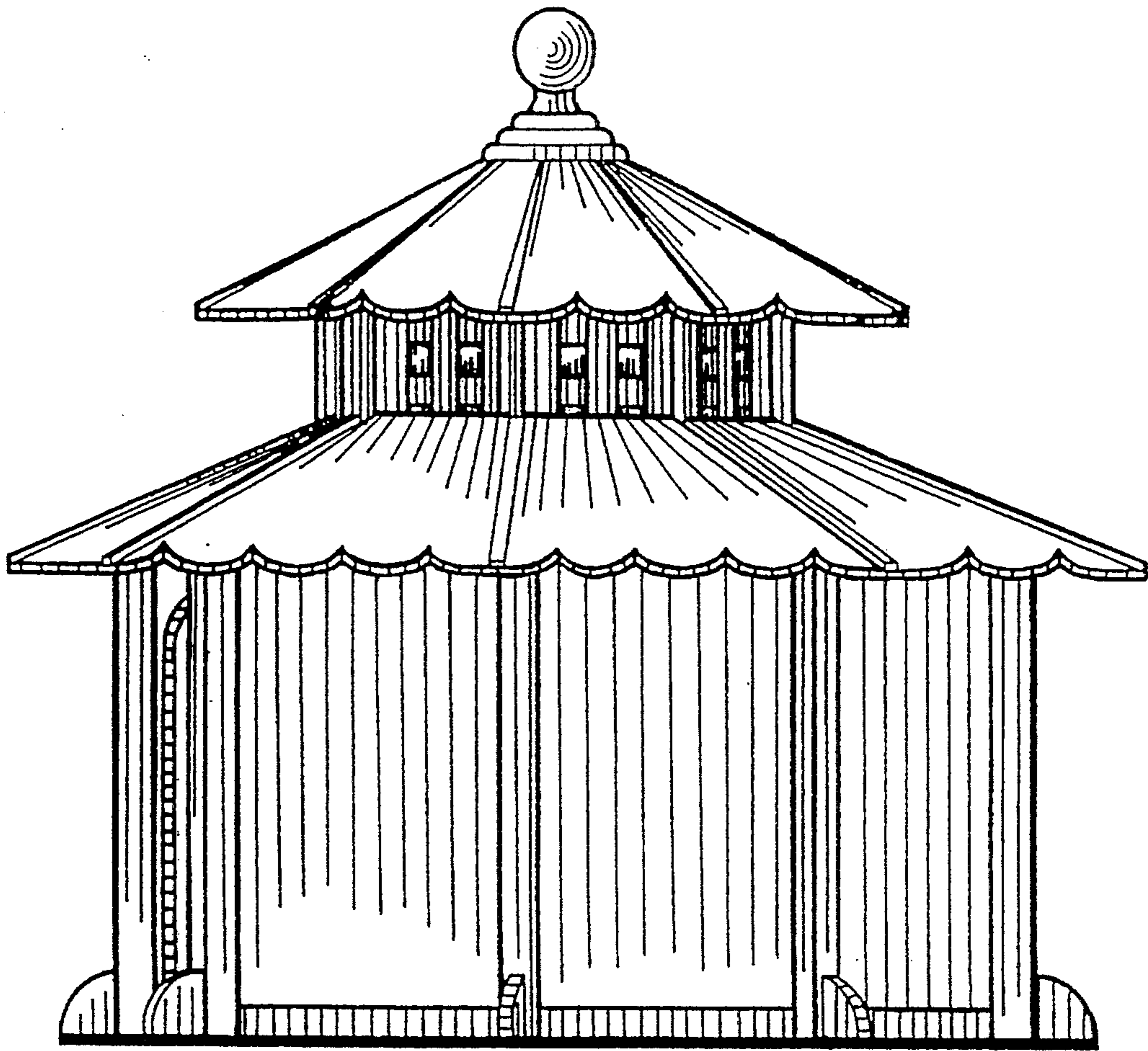
