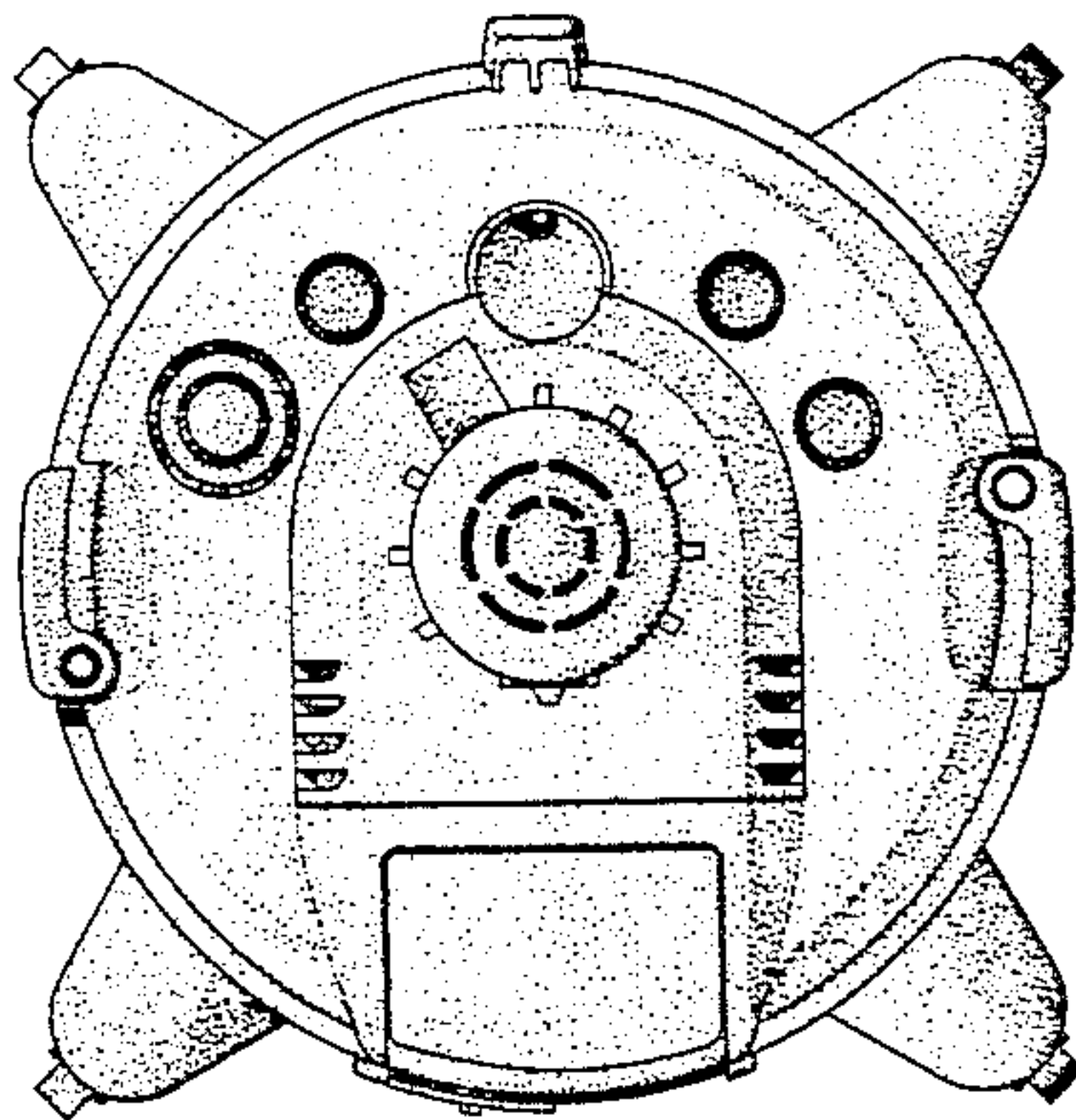
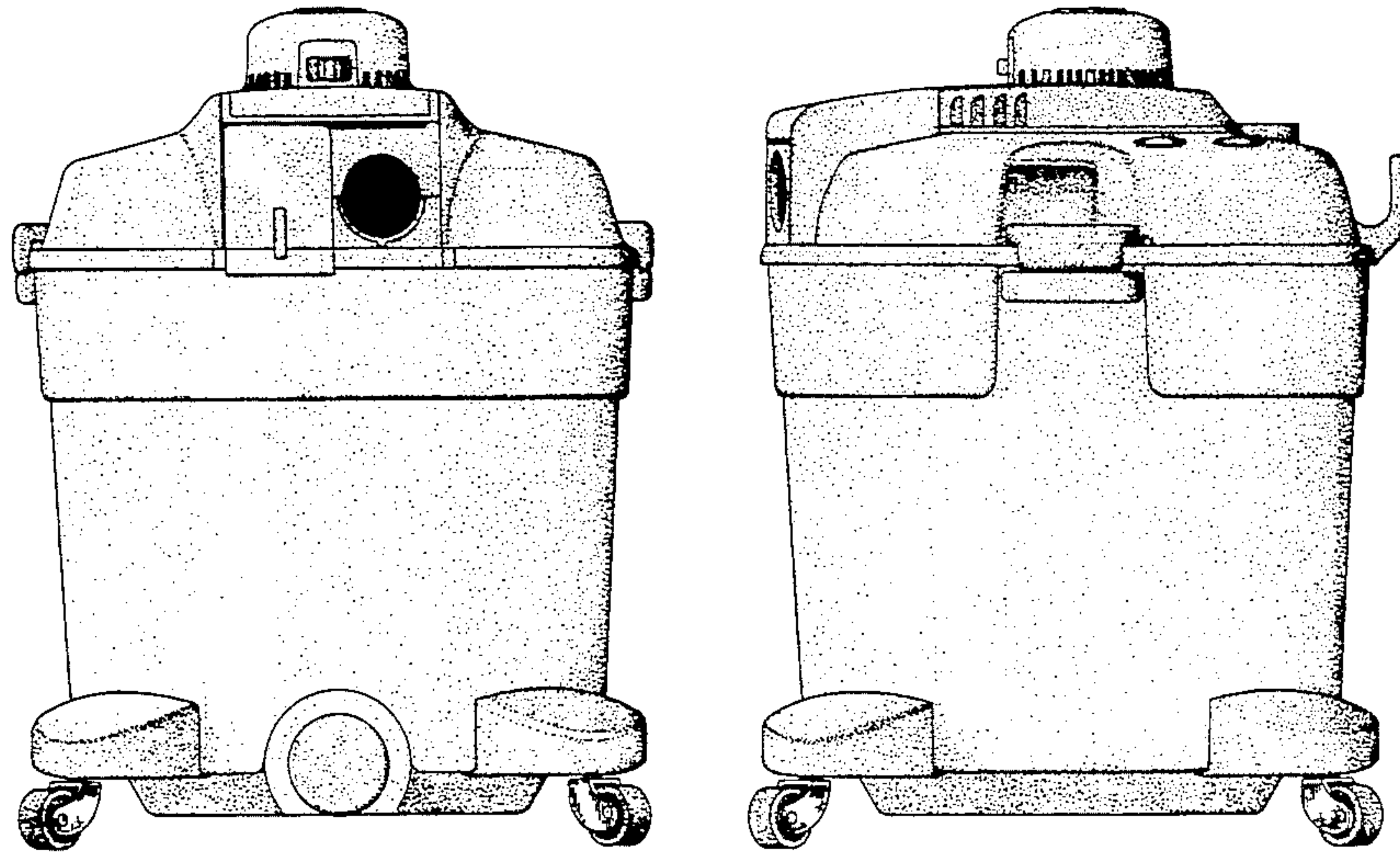

[57] CLAIM

The ornamental design for a combined wet and dry vacuum cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a combined wet and dry vacuum cleaner showing our new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; and, FIG. 5 is a rear elevational view thereof.



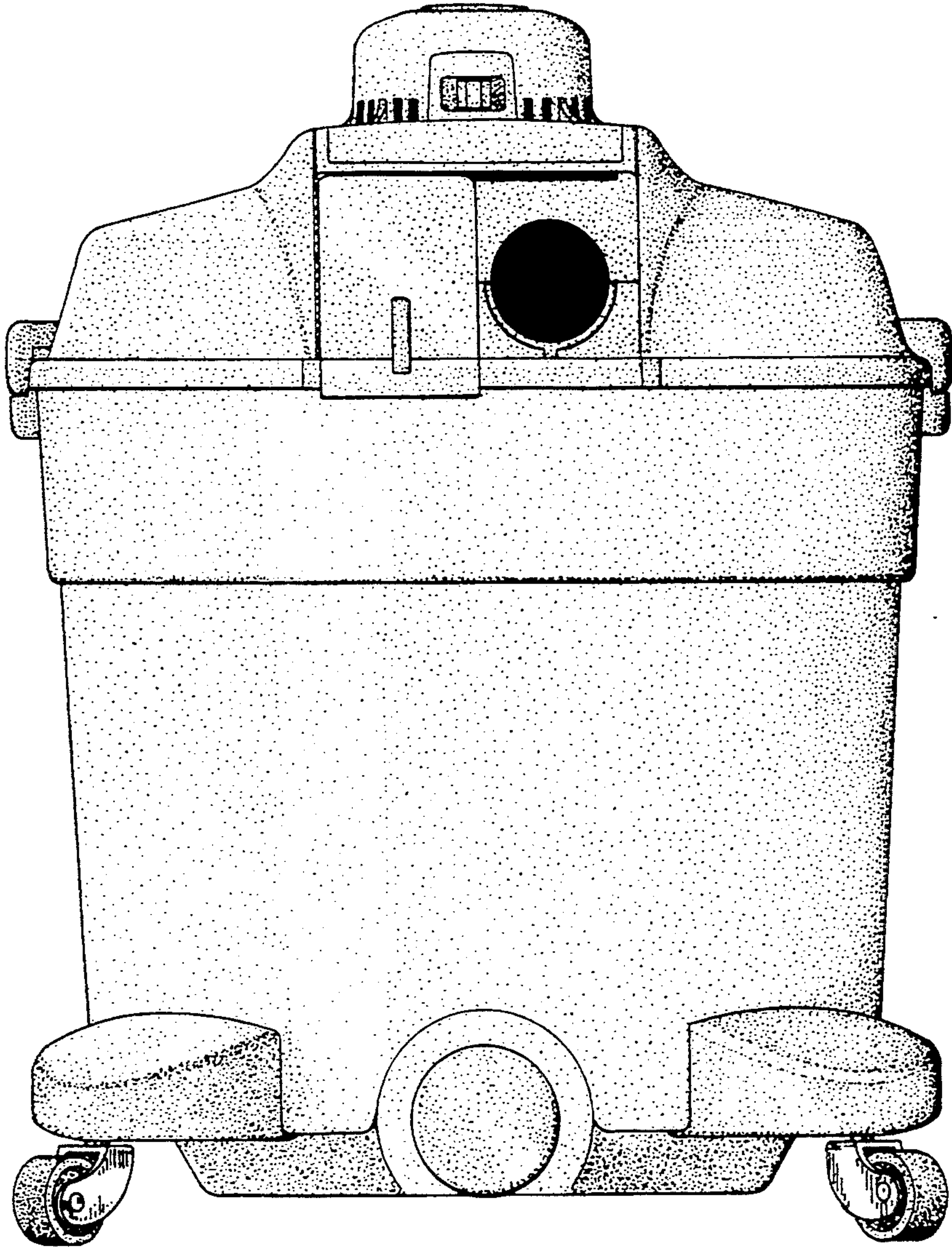

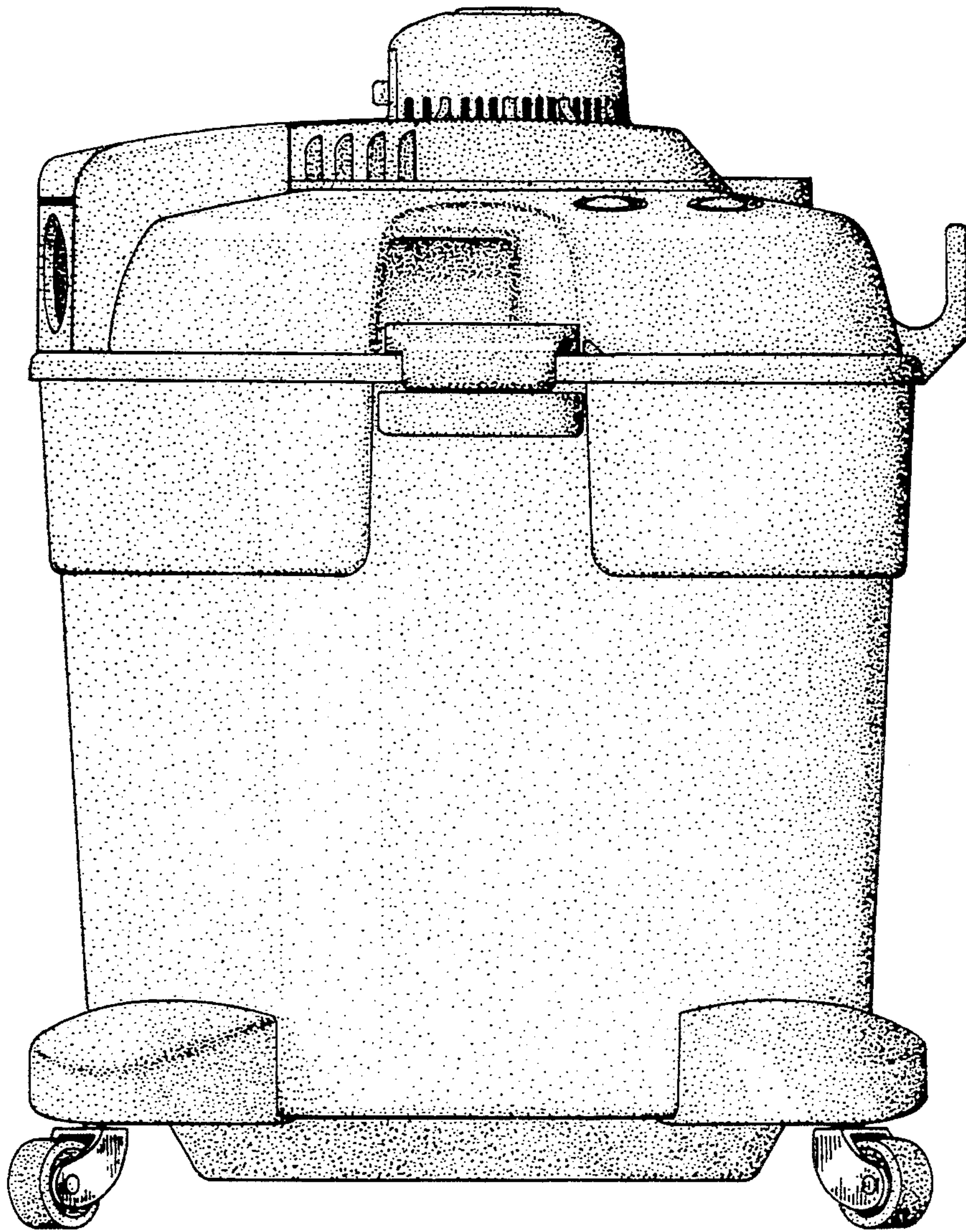

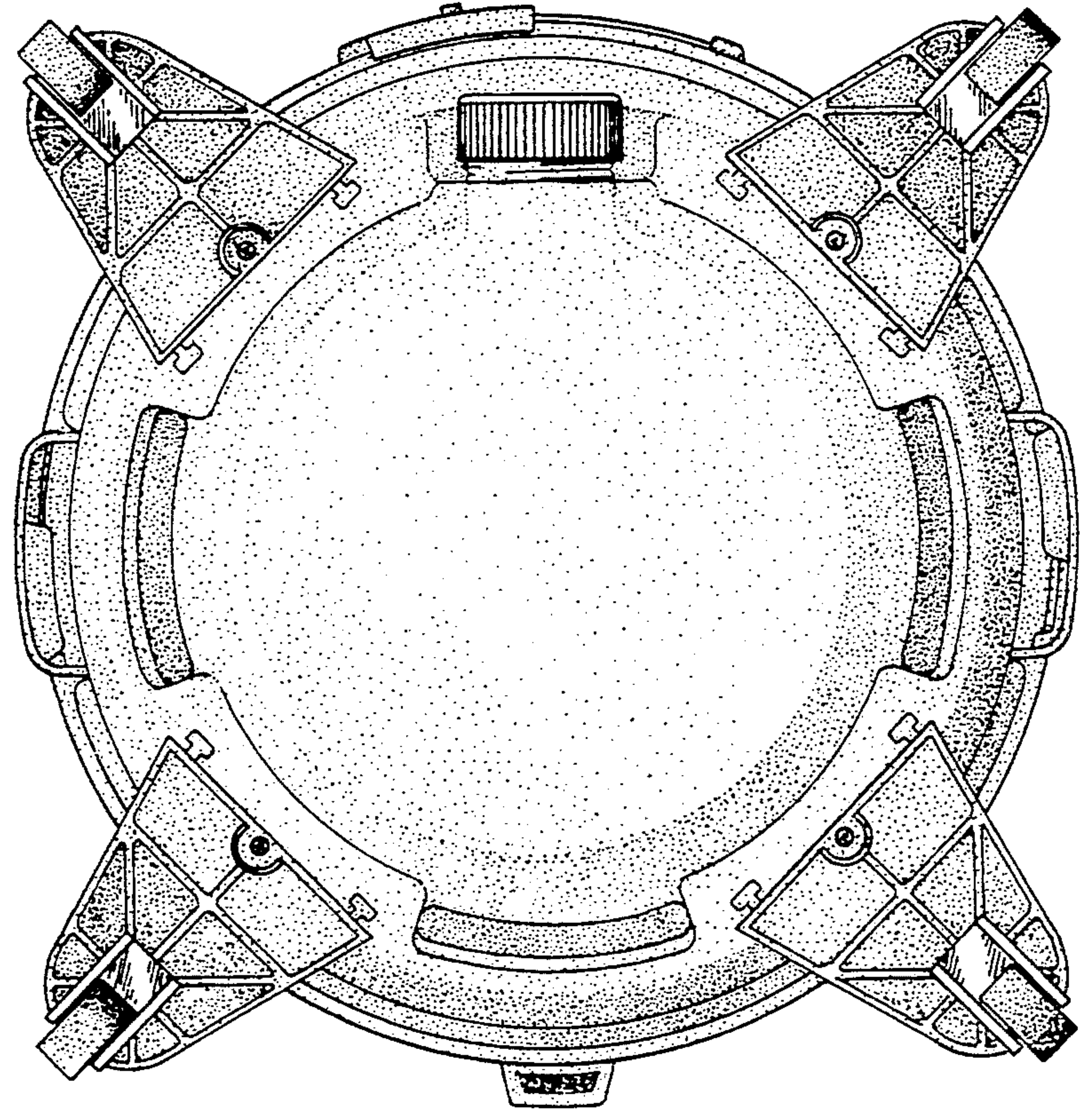
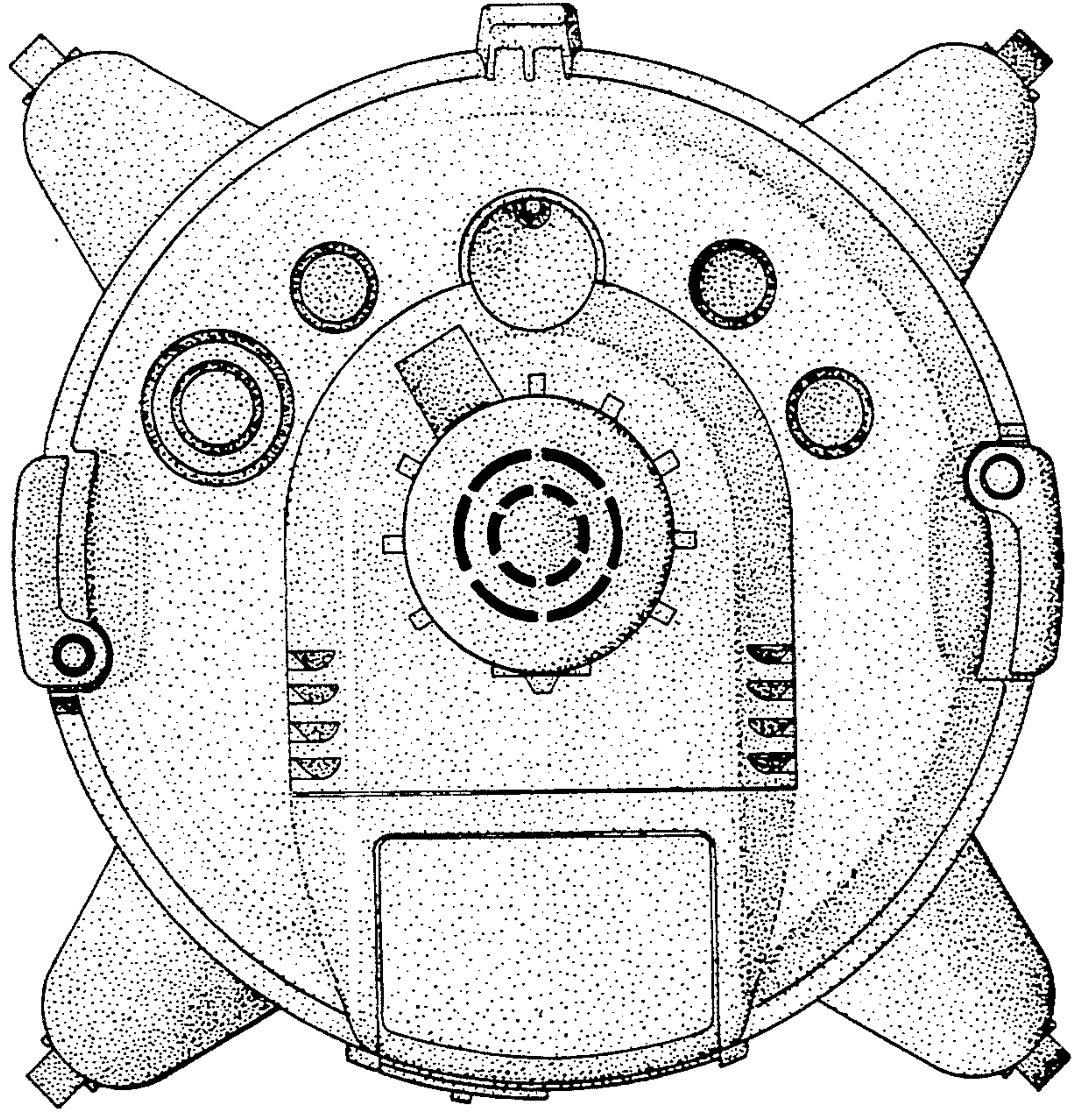

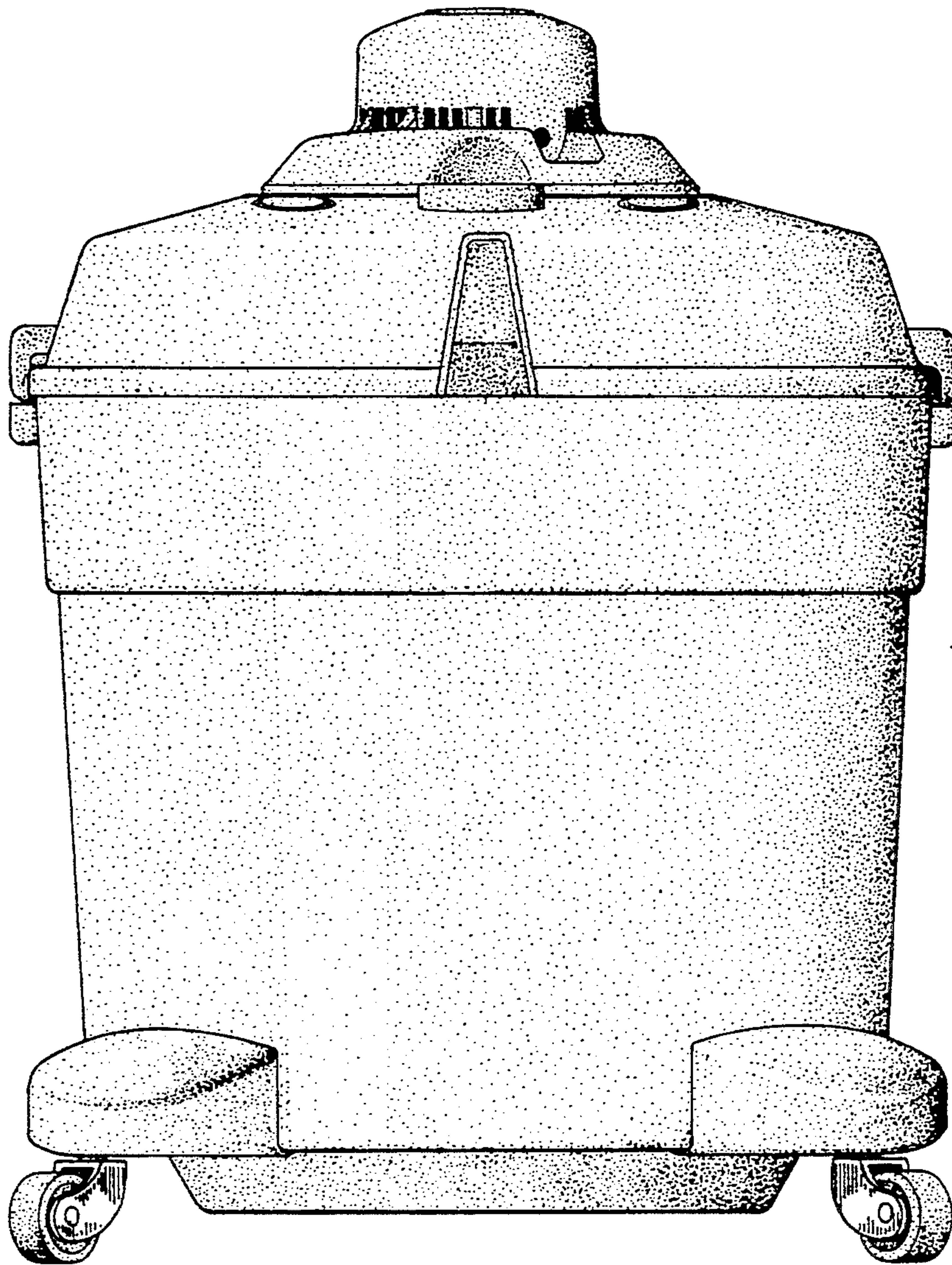
