FIG. 1 is a perspective view of an attachment for a blowing machine showing my new design;
 FIG. 2 is a front elevational view of the attachment shown in FIG. 1; the rear elevational view thereof being a mirror image;

 FIG. 6 is a left side elevational view of FIG. 1.

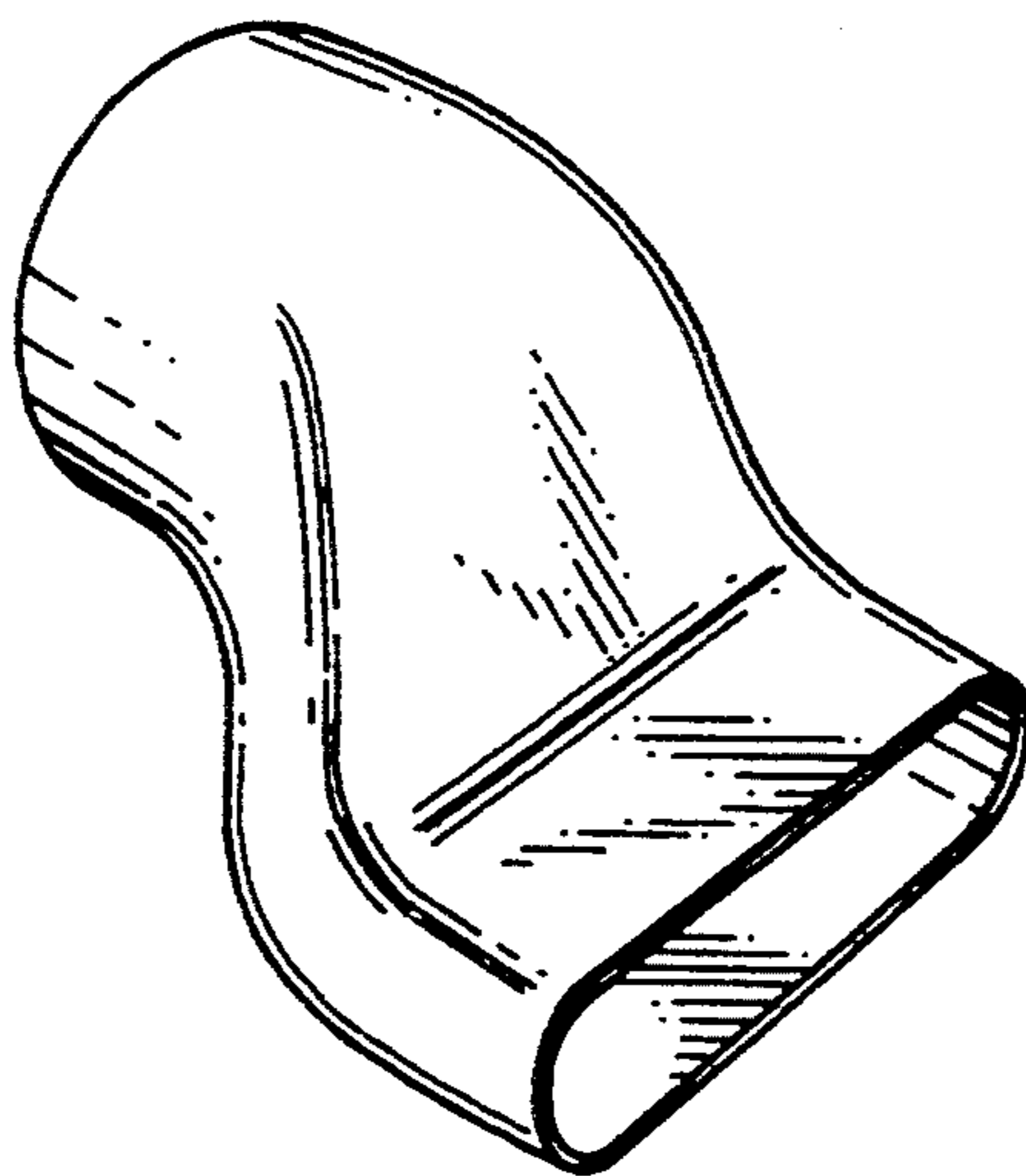

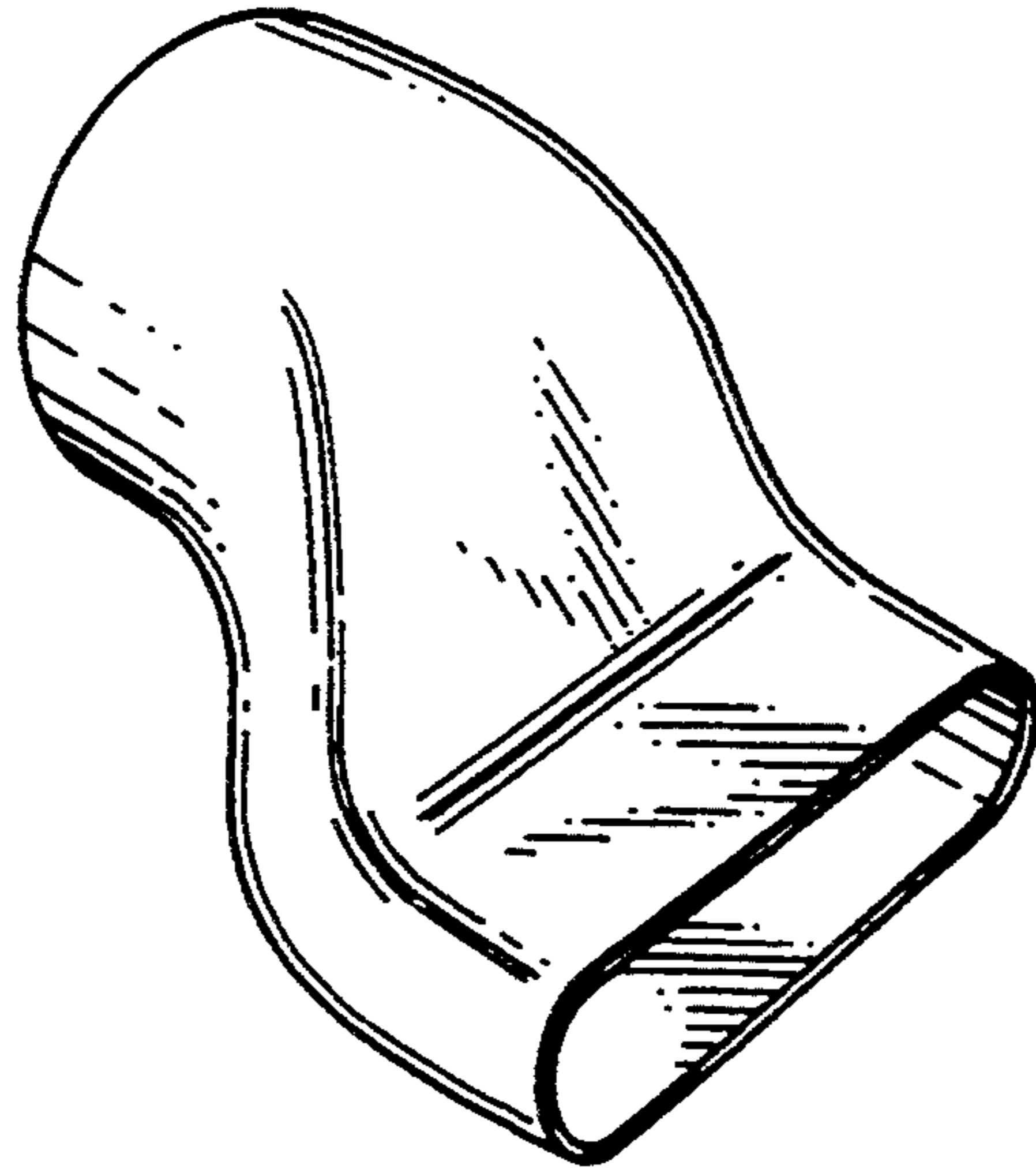

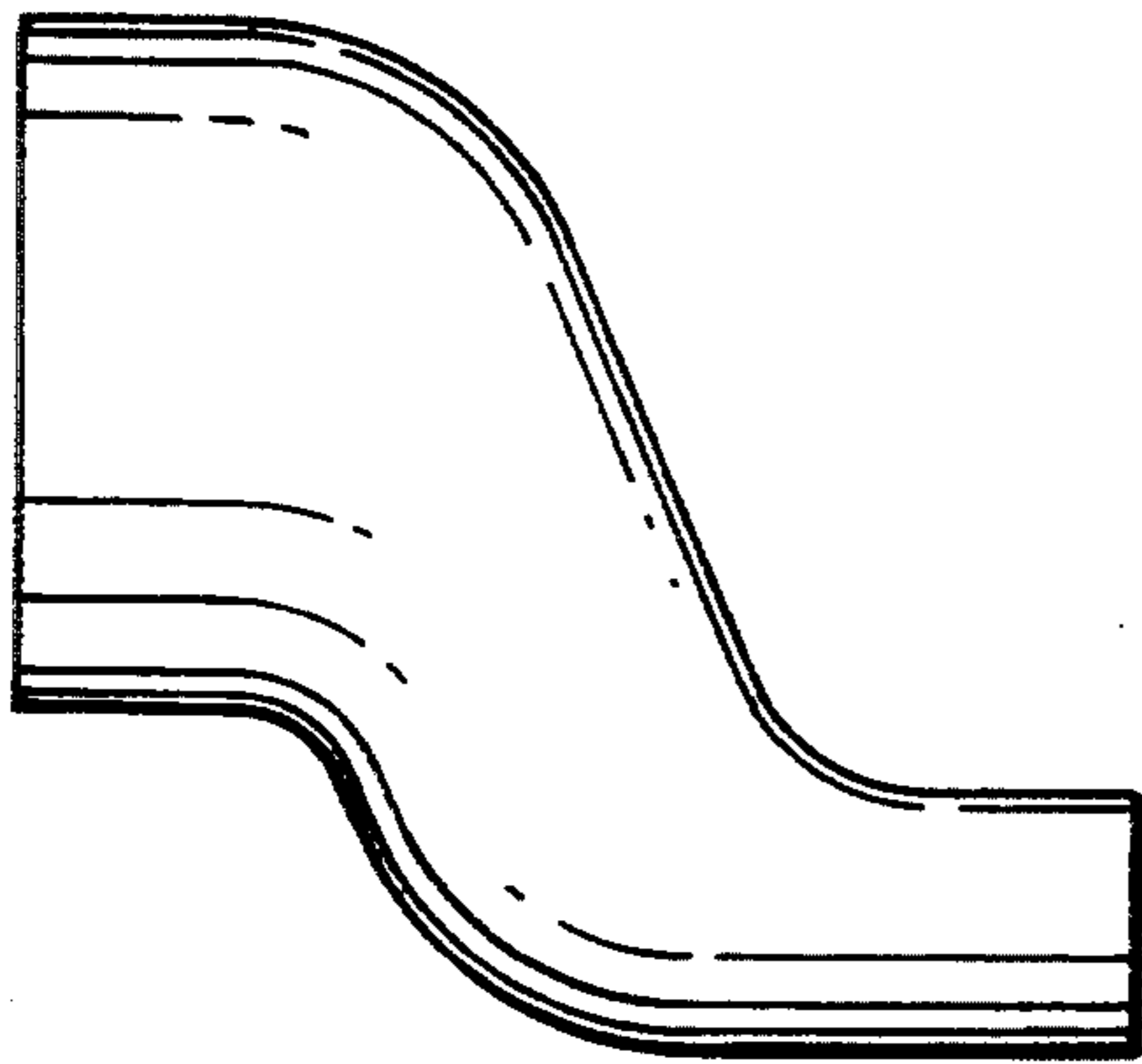

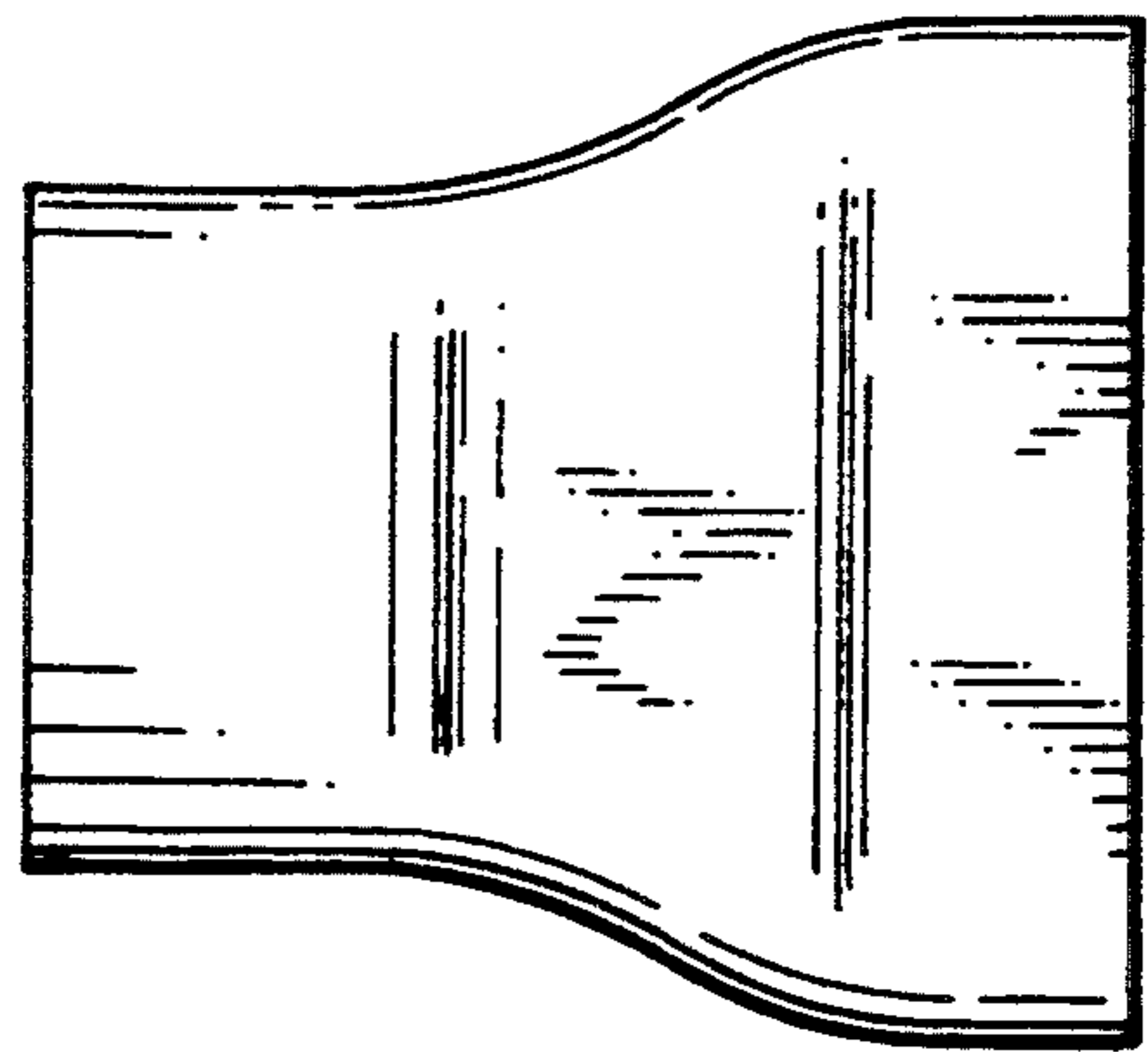

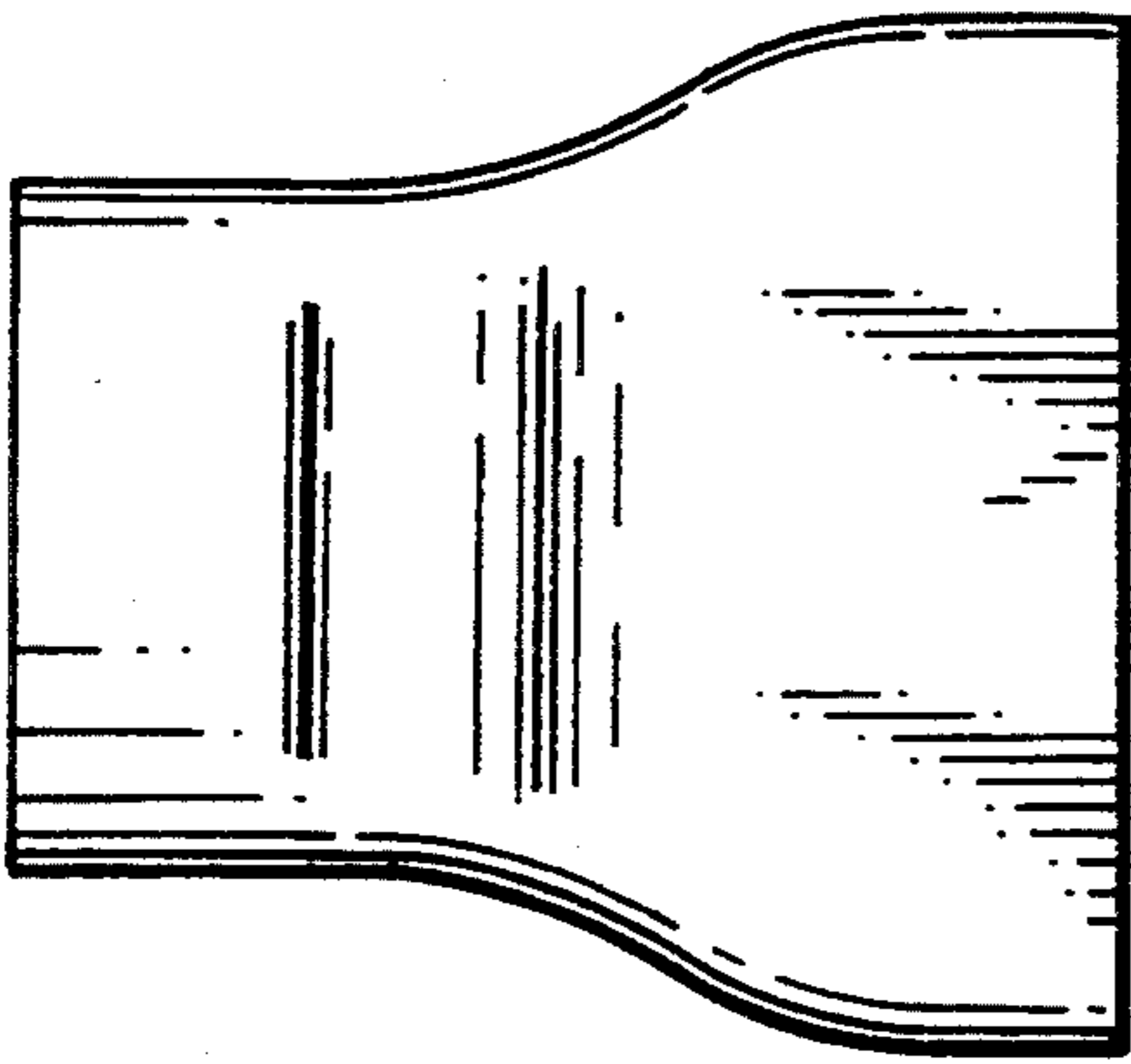

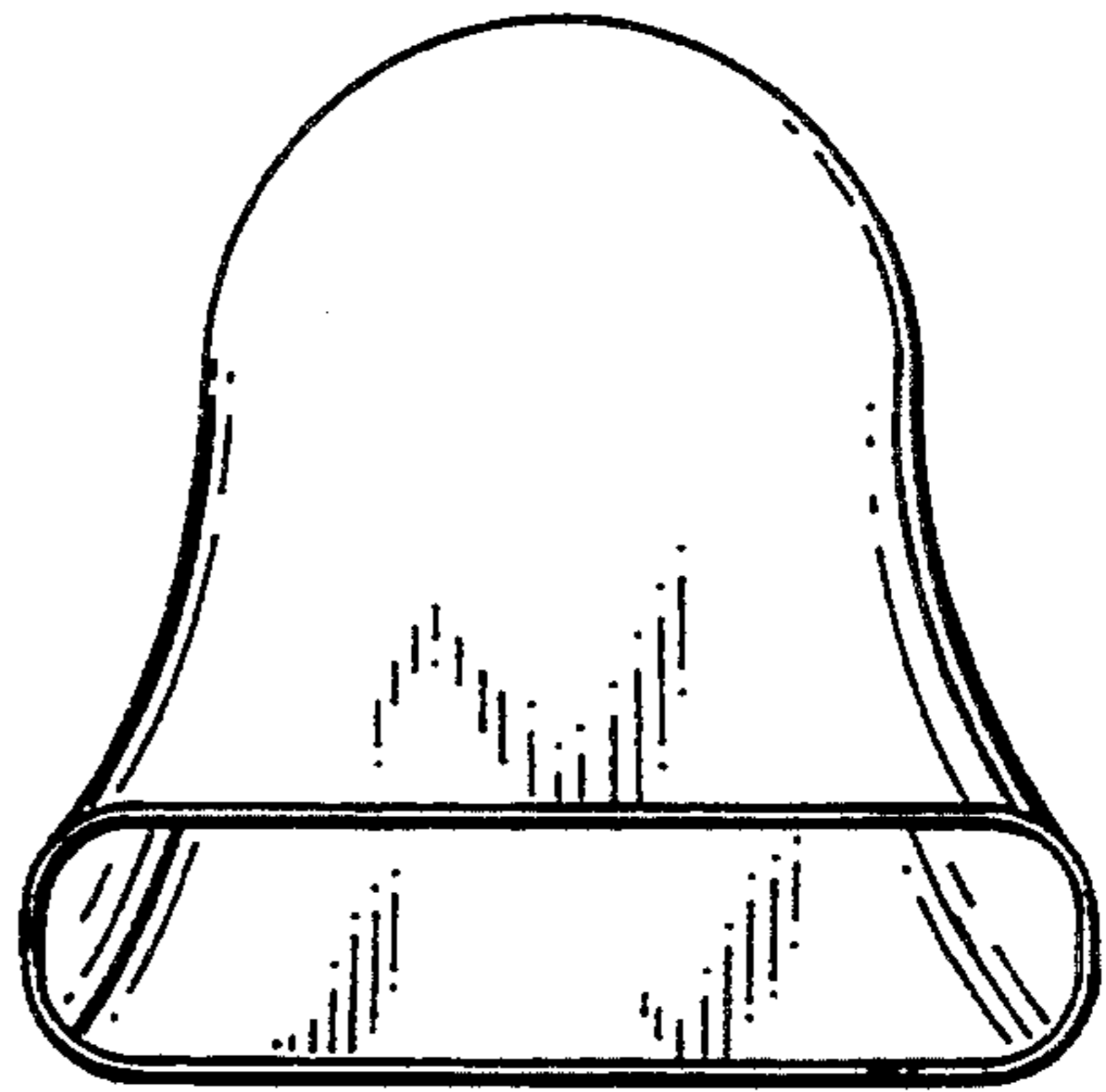
