**DESCRIPTION**

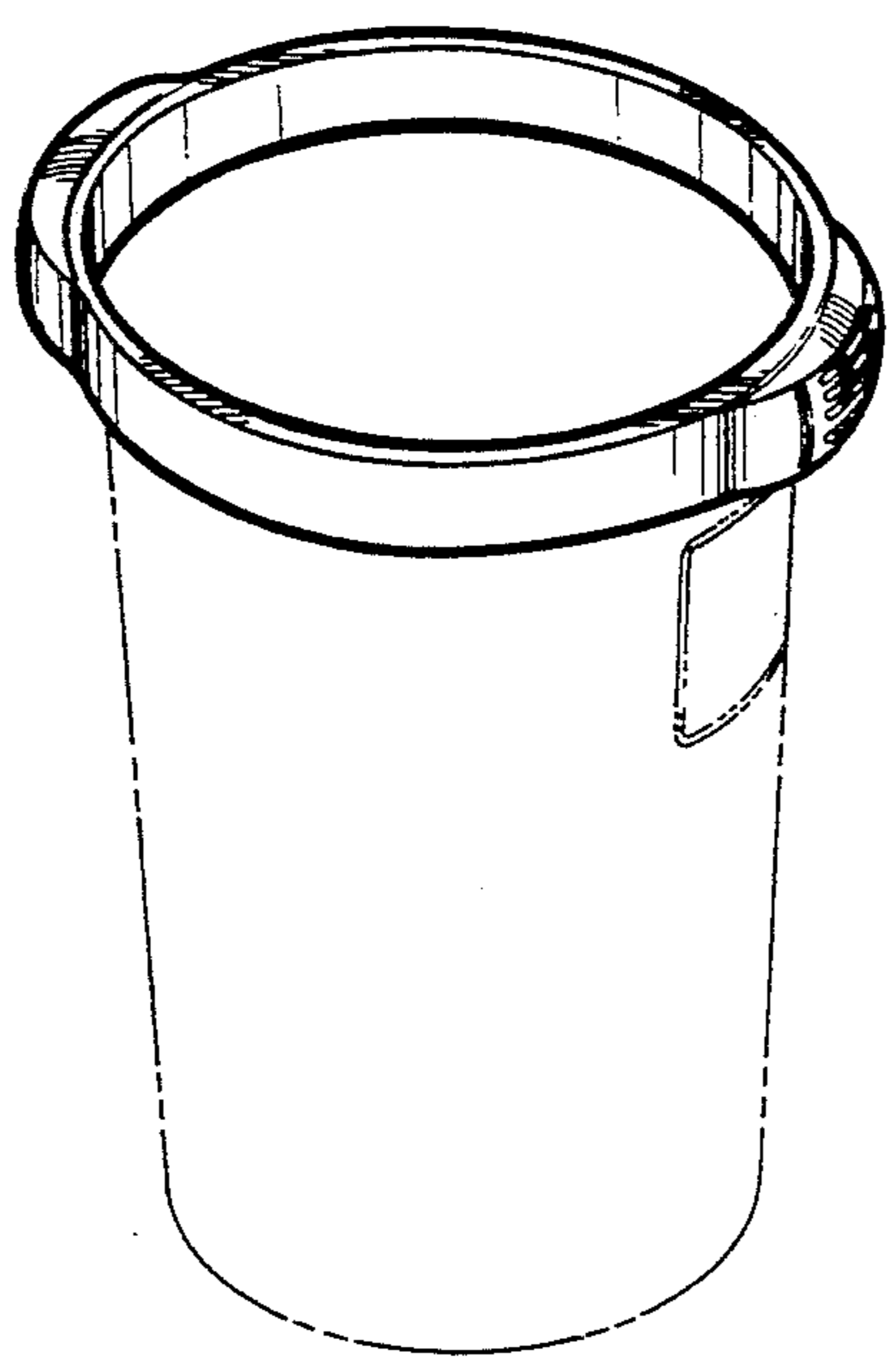
FIG. 1 is a top right front perspective view of a rim and handle for trash container showing my new design. The broken lines are for illustrative purposes only and form no part of the claimed design;

FIG. 2 is a right side elevational view thereof; the left side elevational view being a mirror image;

FIG. 5 is a front view thereof, the rear being a mirror image.



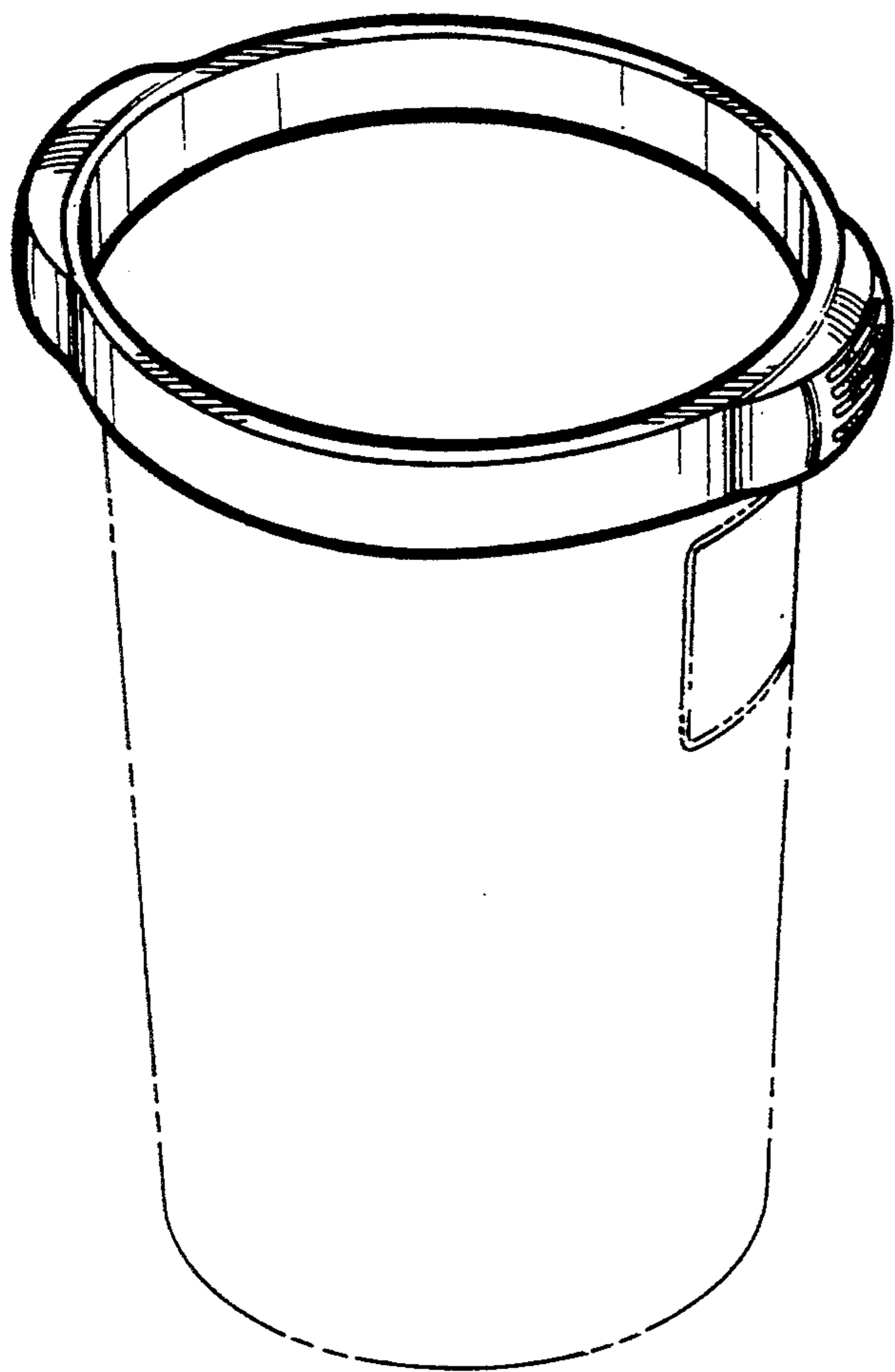

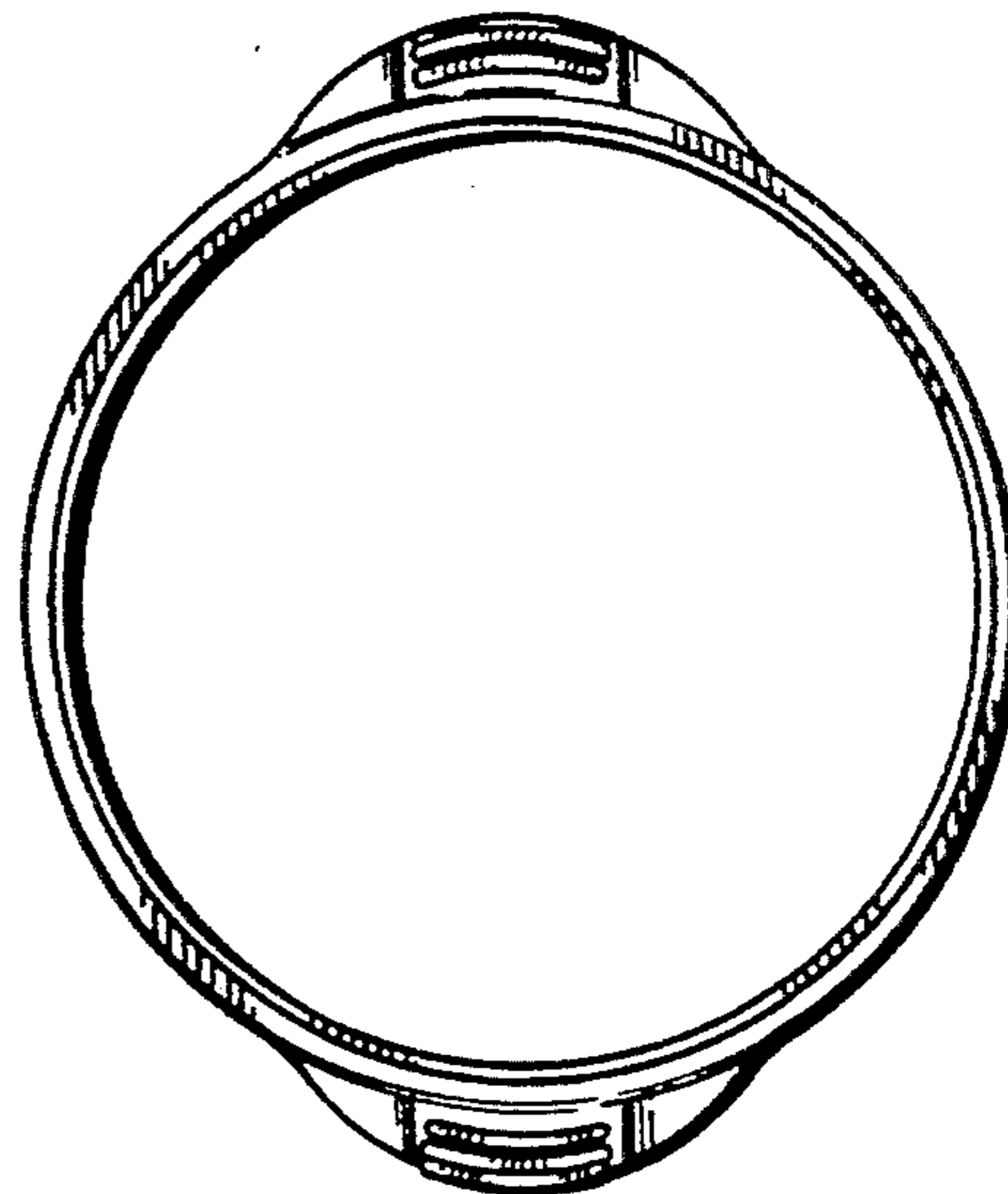

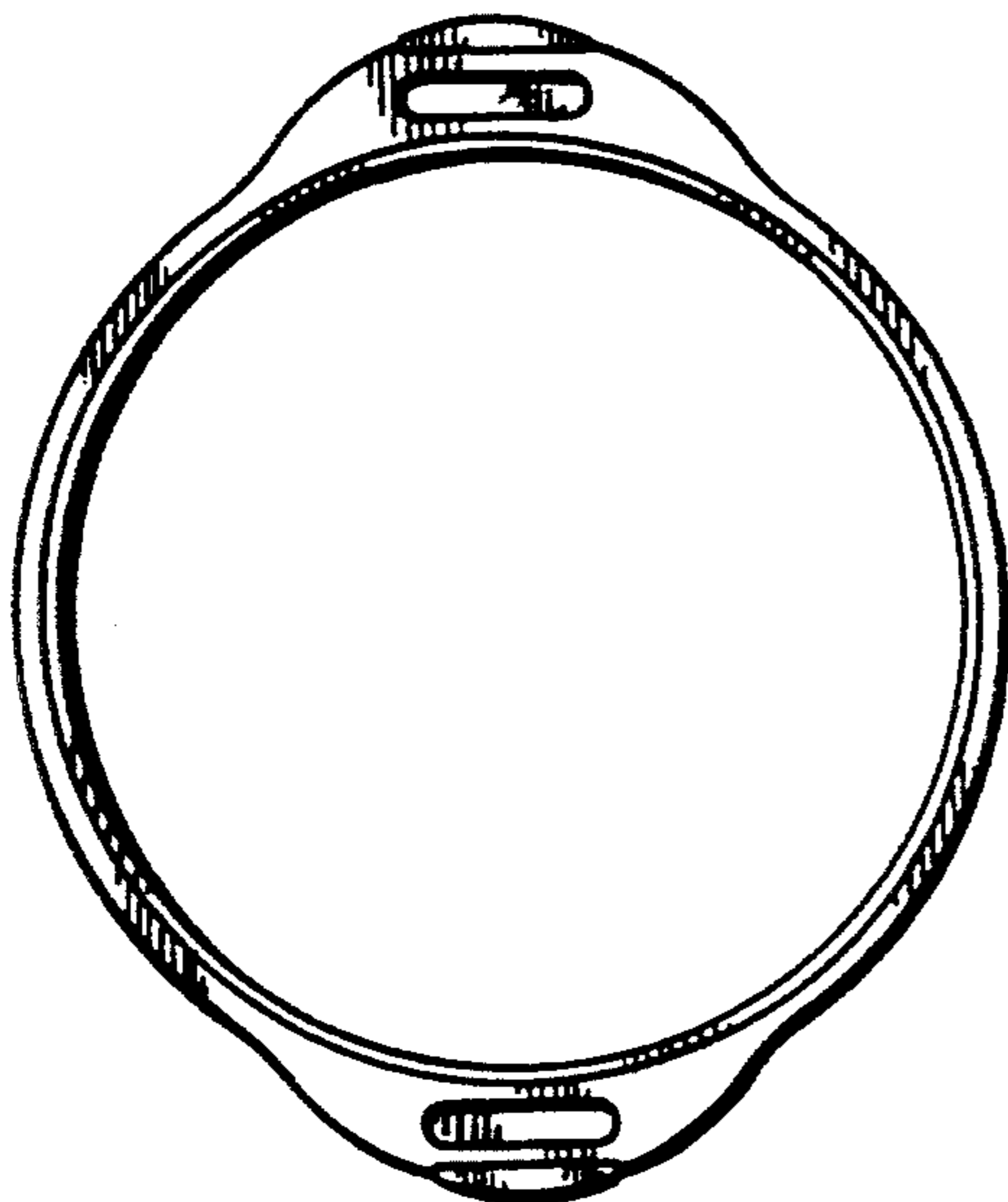

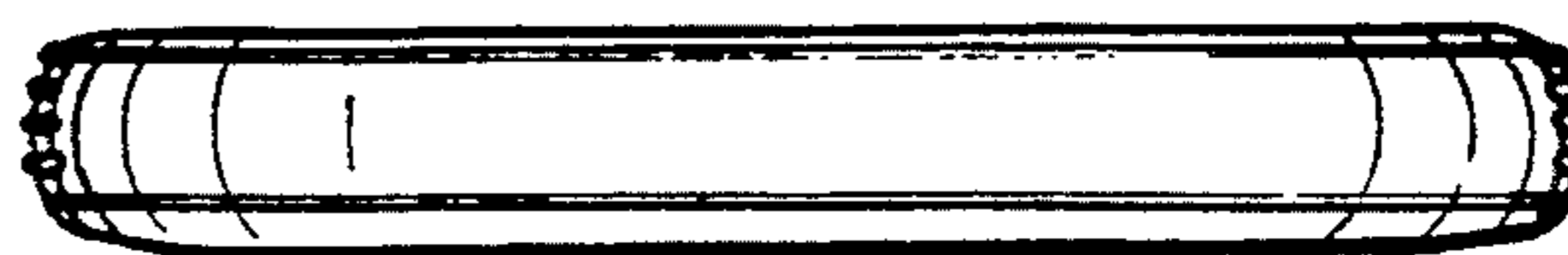
