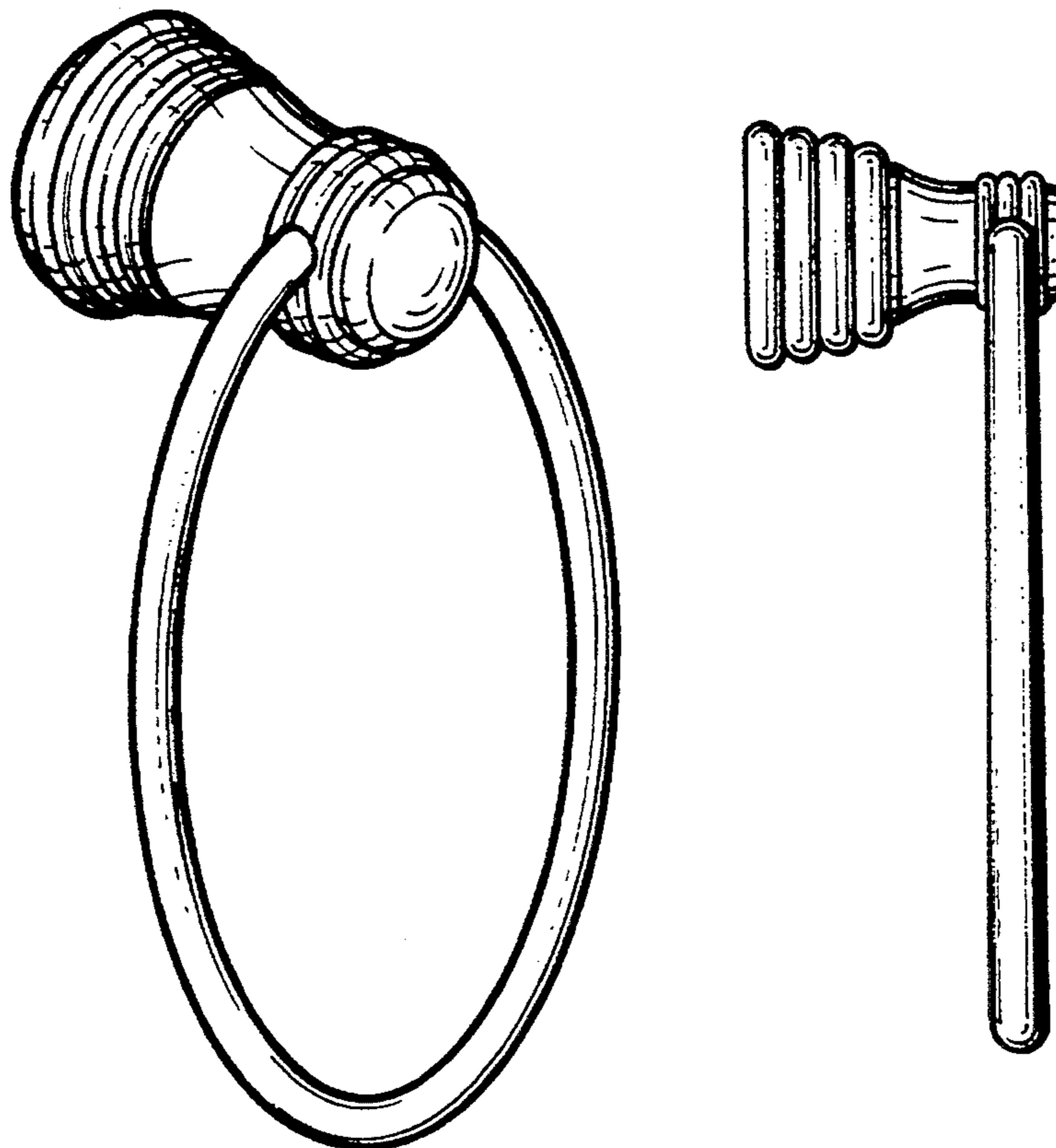

DESCRIPTION

FIG. 1 is a side perspective view of a towel ring showing our new design;

 FIG. 7 is a bottom plan view thereof.



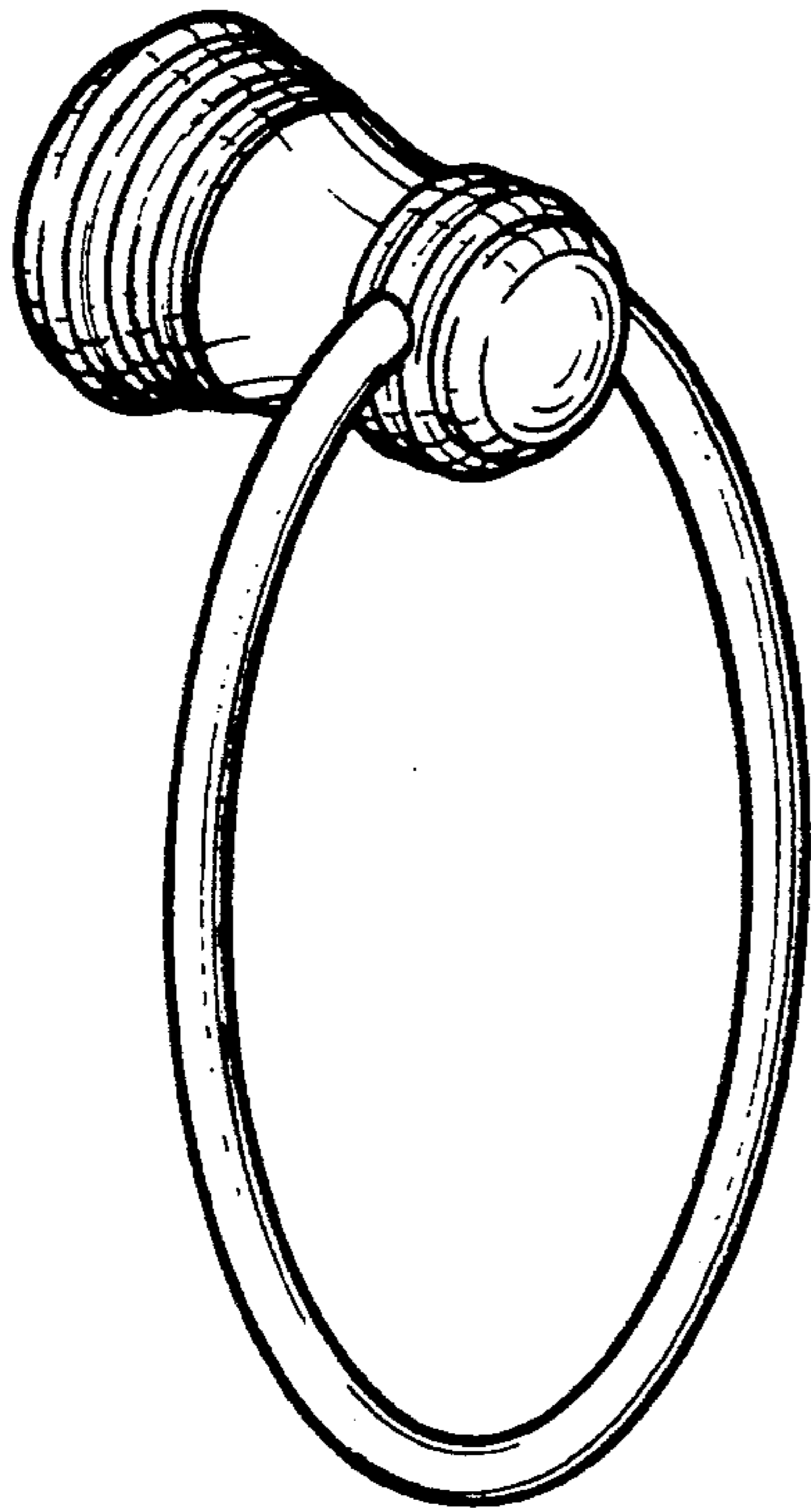

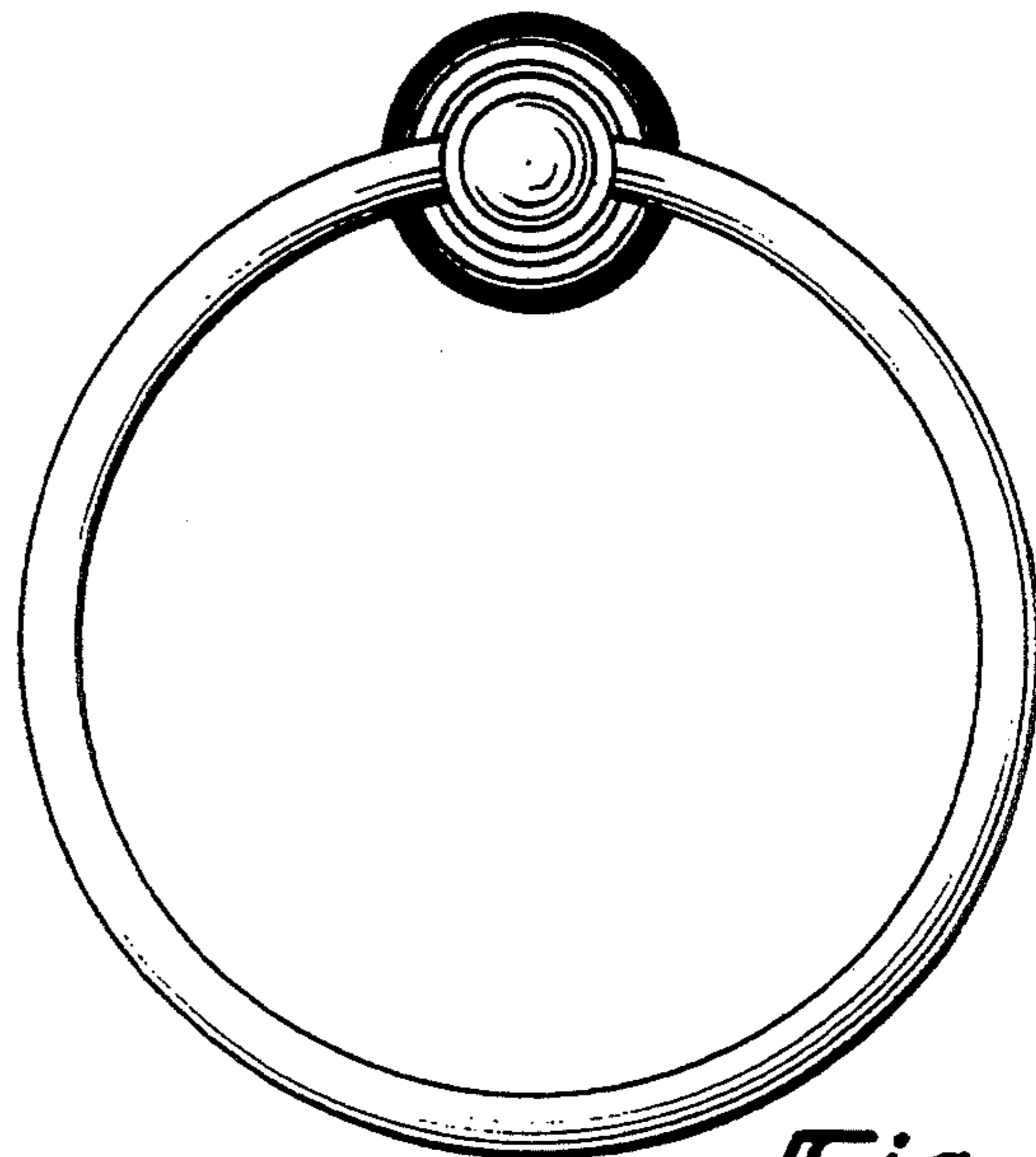

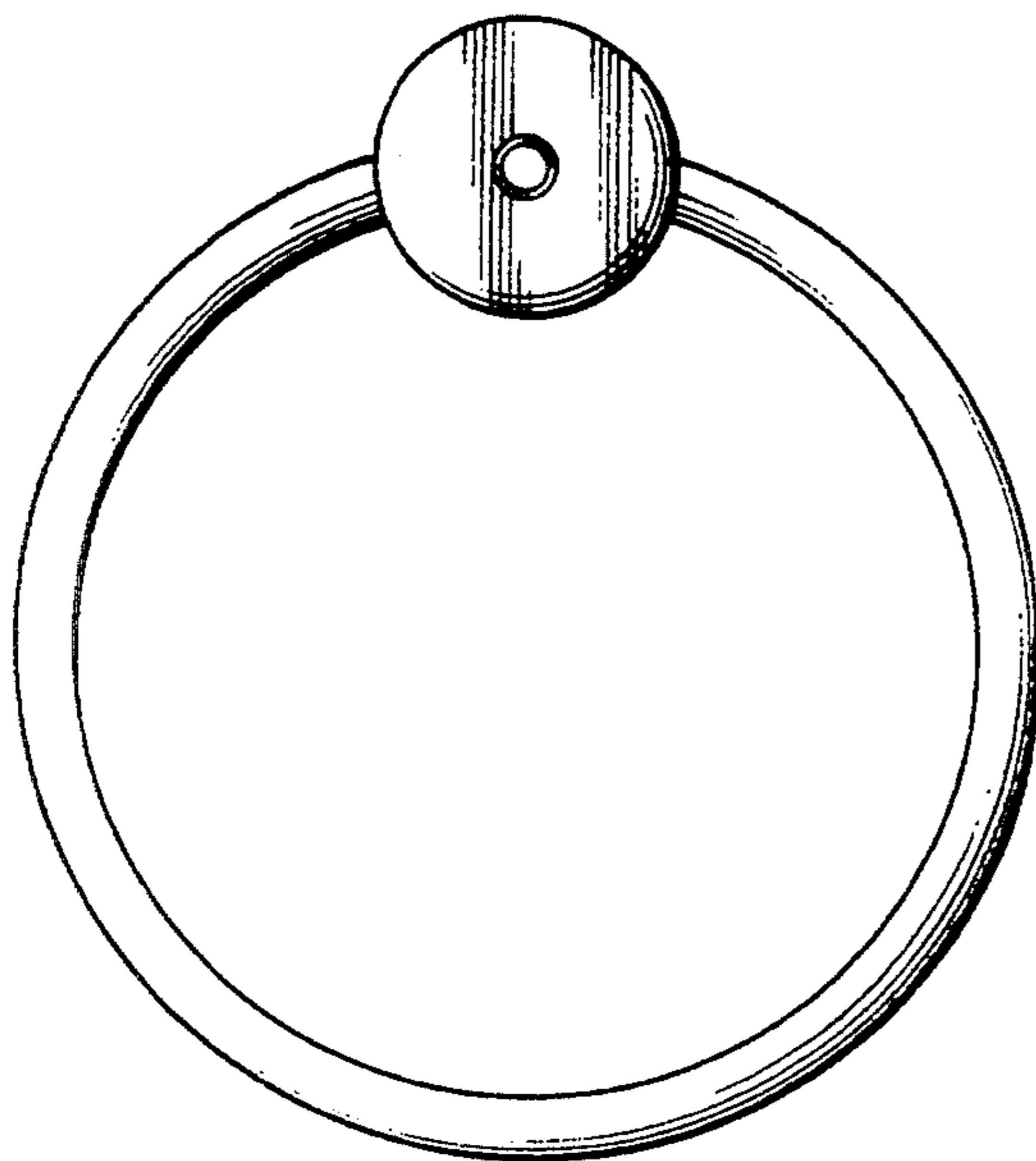

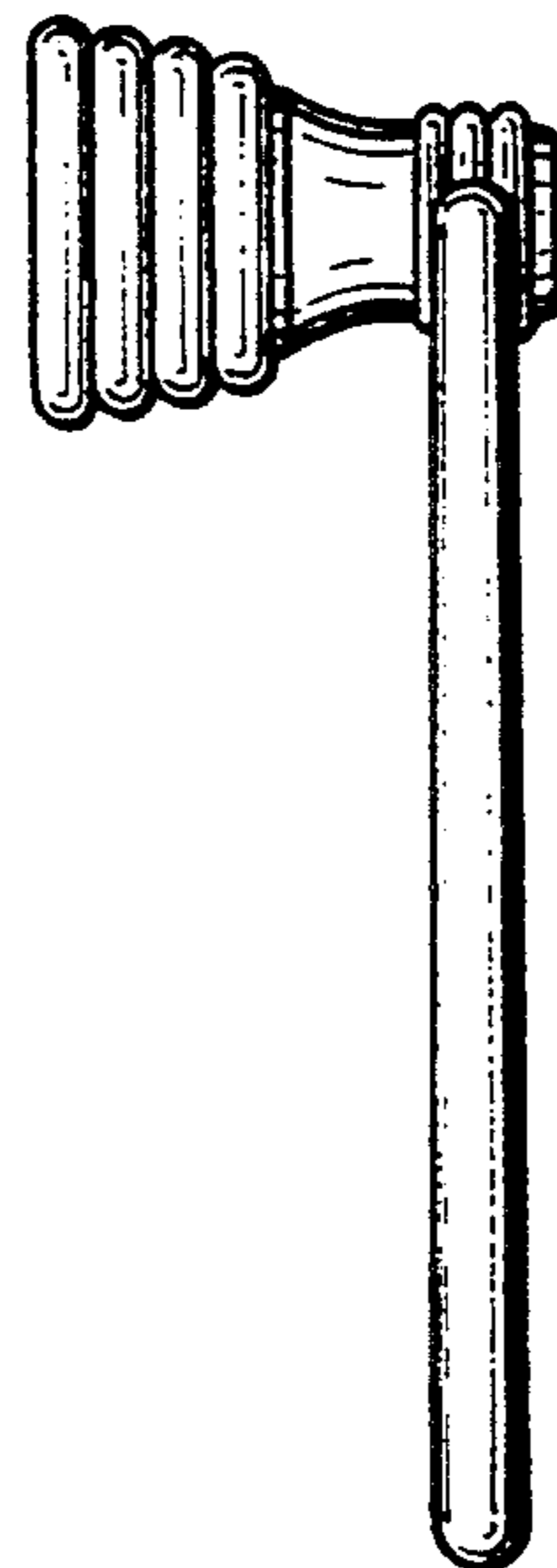

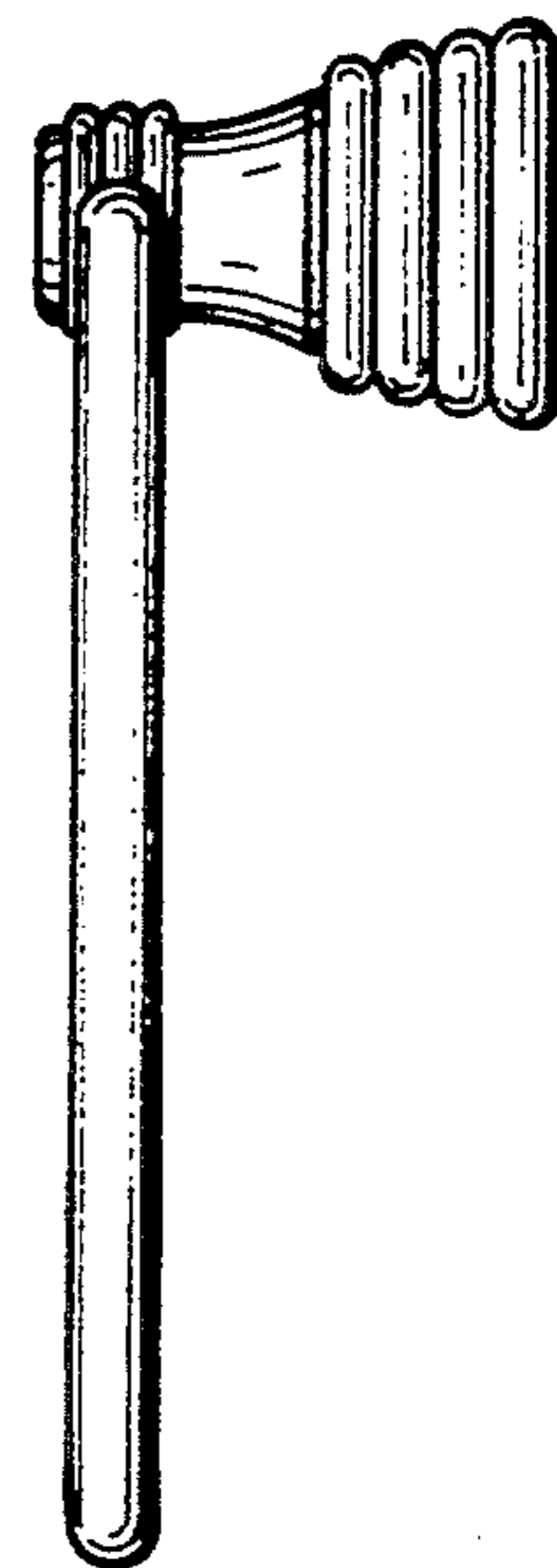

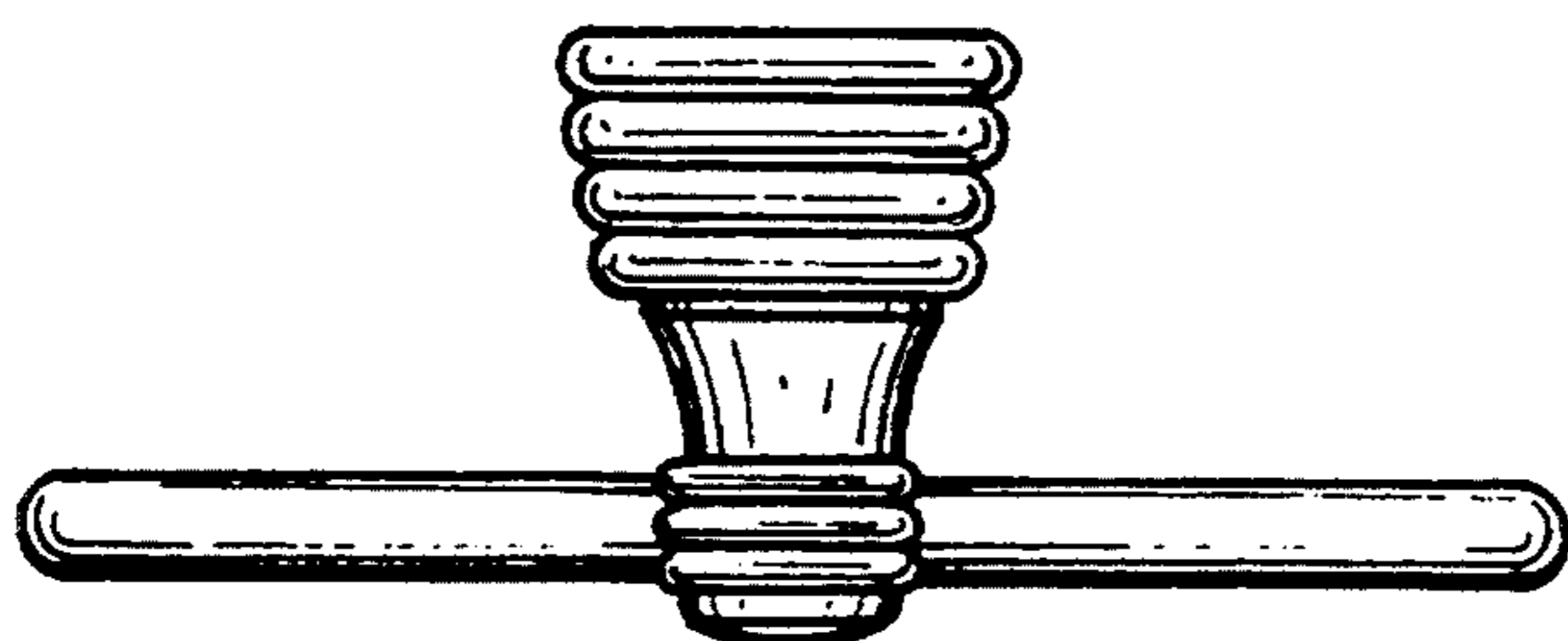

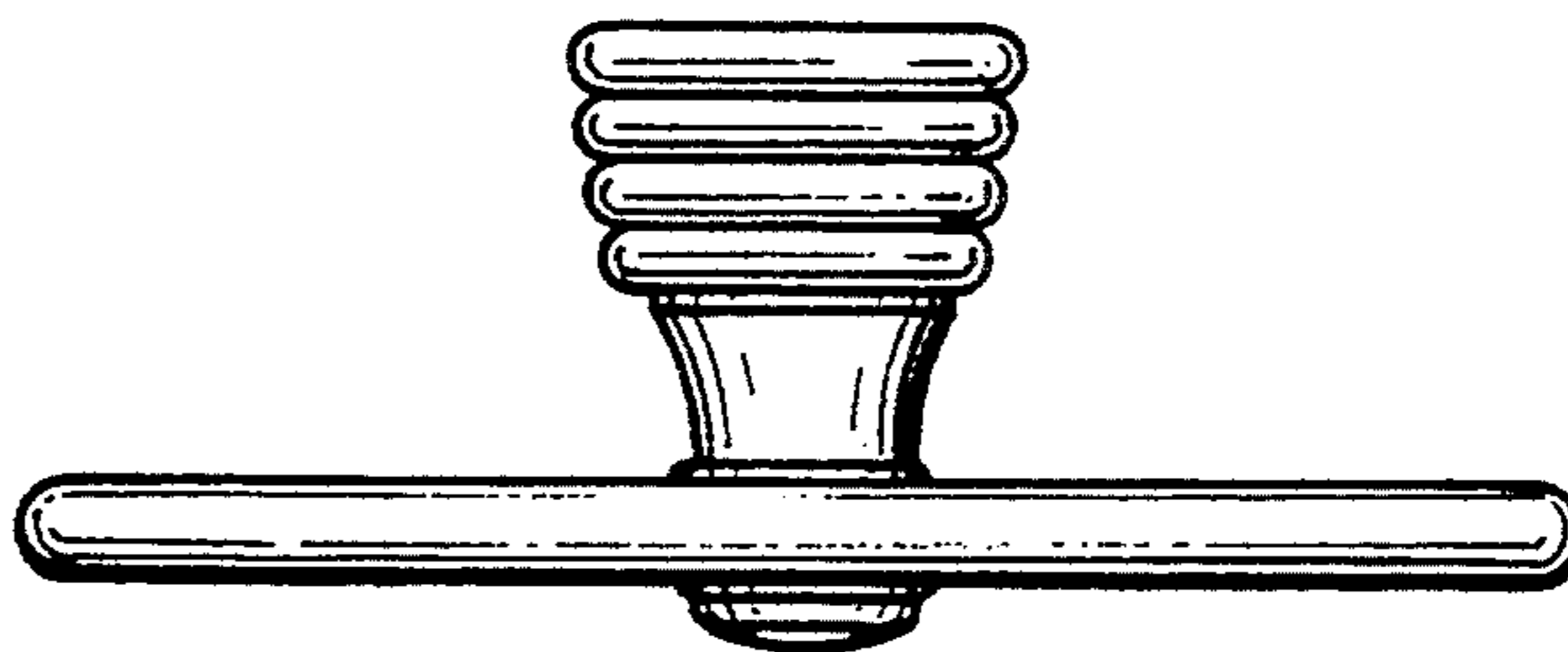
