The ornamental design for a remote control unit, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a remote control unit showing my new design;

FIG. 2 is a top plan view of an alternate embodiment;

FIG. 3 is a bottom plan view of the embodiments shown in FIGS. 1 and 2;

FIG. 4 is a side elevation view thereof, the opposite side being a mirror image;

FIG. 5 is a front elevation view thereof;

FIG. 6 is a rear elevation view thereof;

FIG. 7 is a top plan view of a third alternate embodiment;

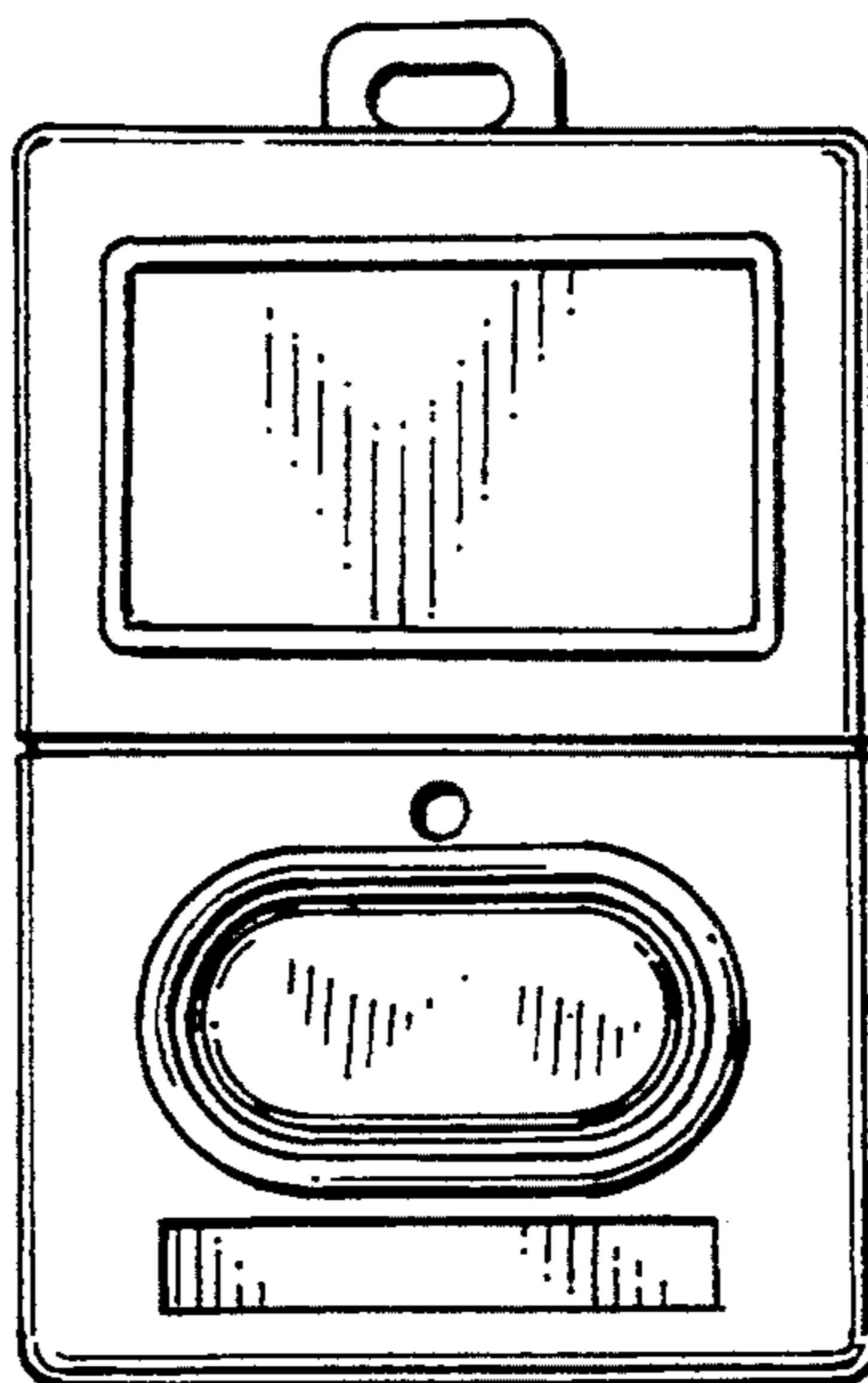
FIG. 8 is a top plan view of a fourth alternate embodiment;

FIG. 12 is a rear elevation view thereof.



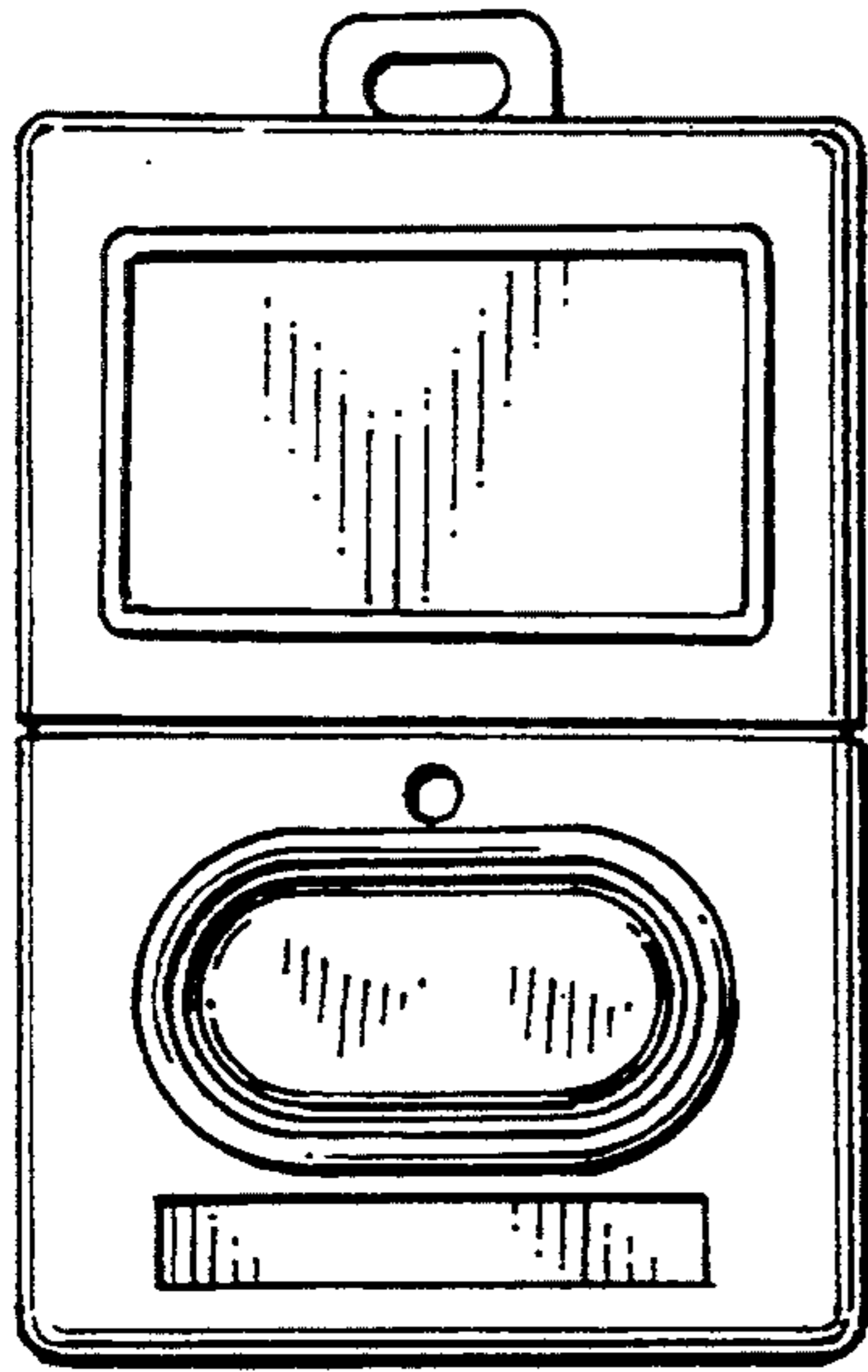

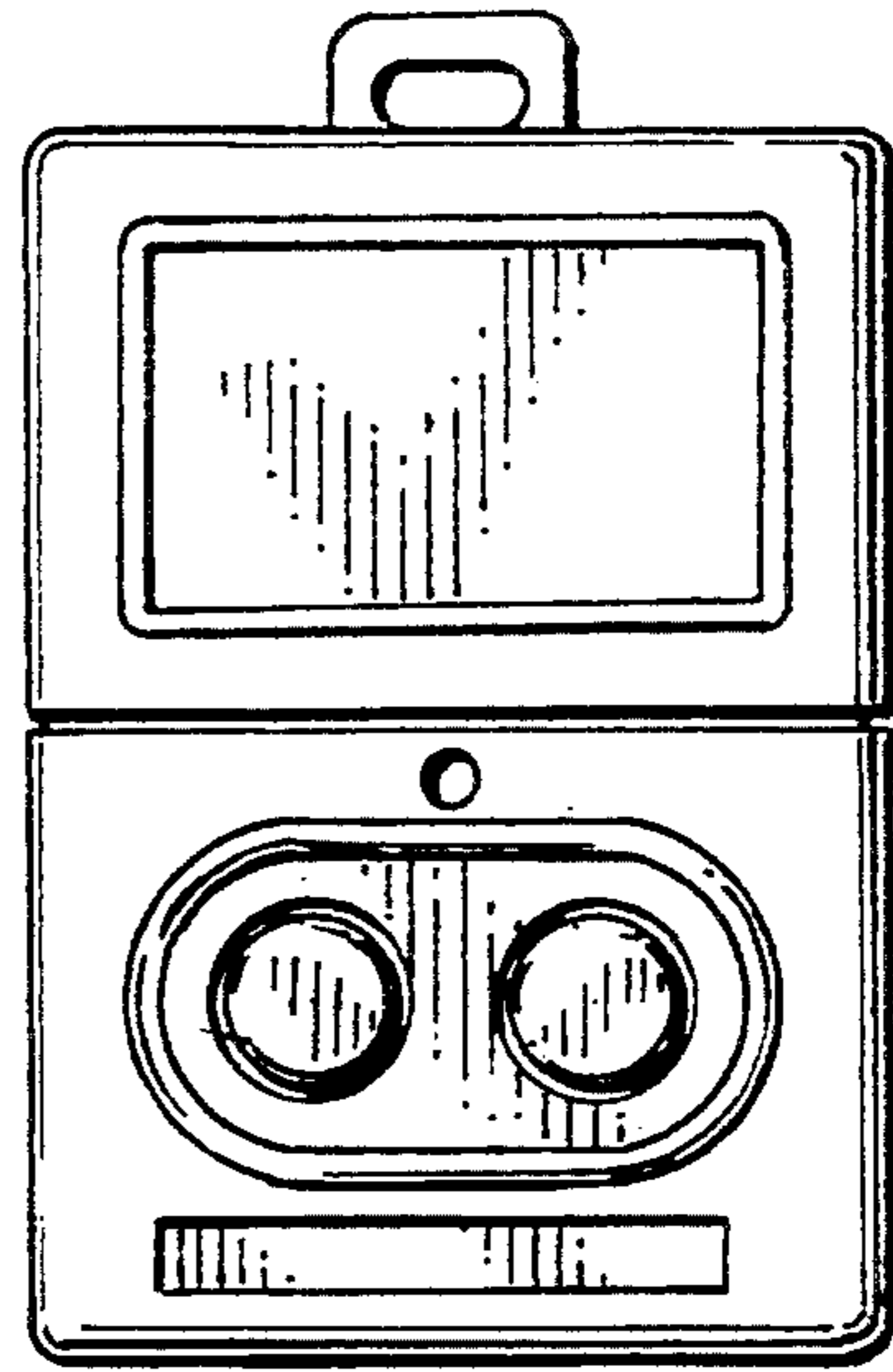

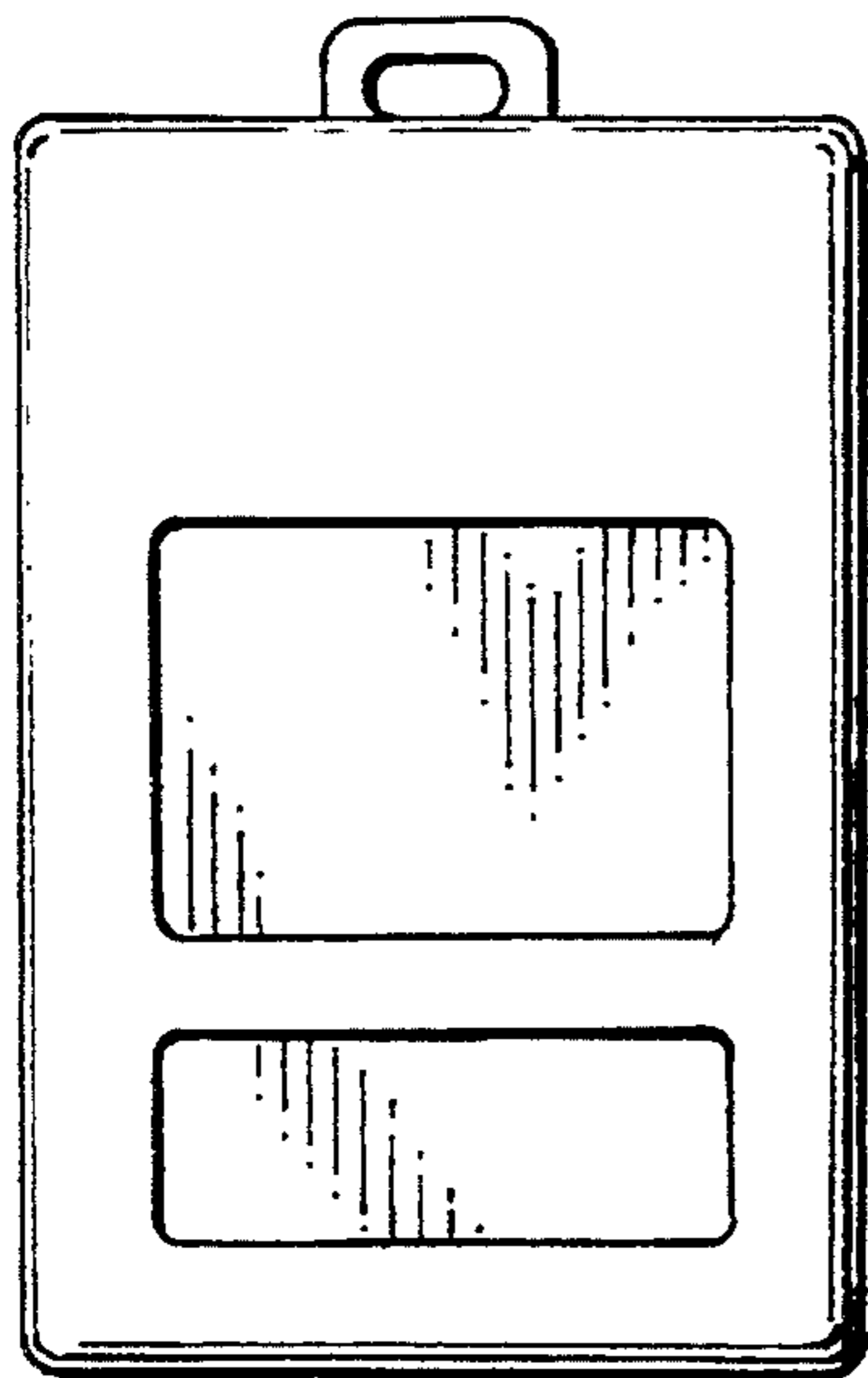

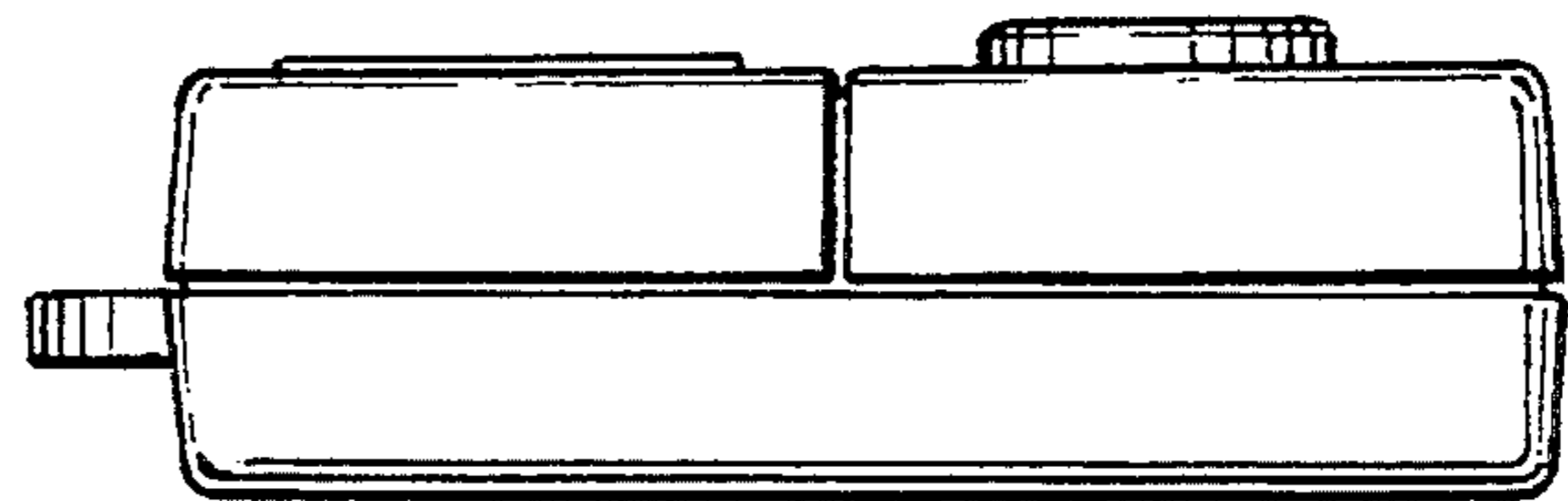

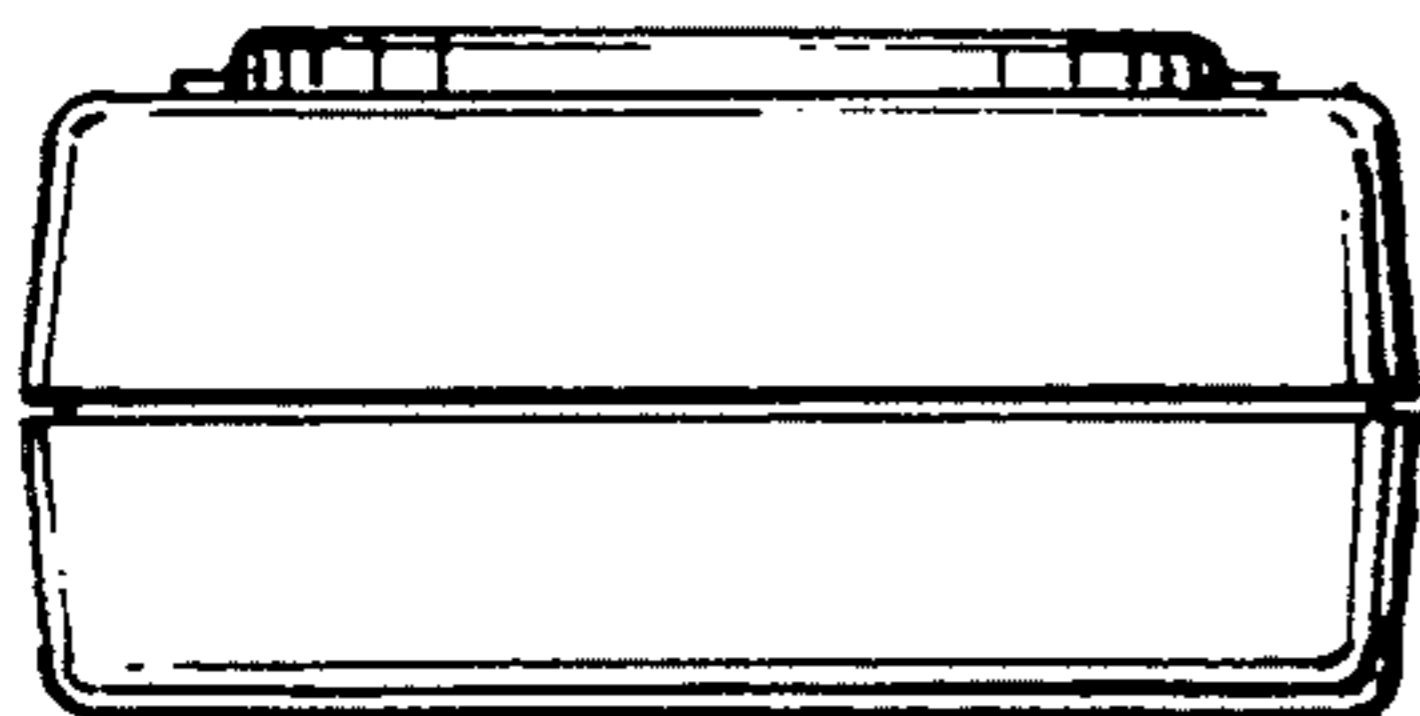

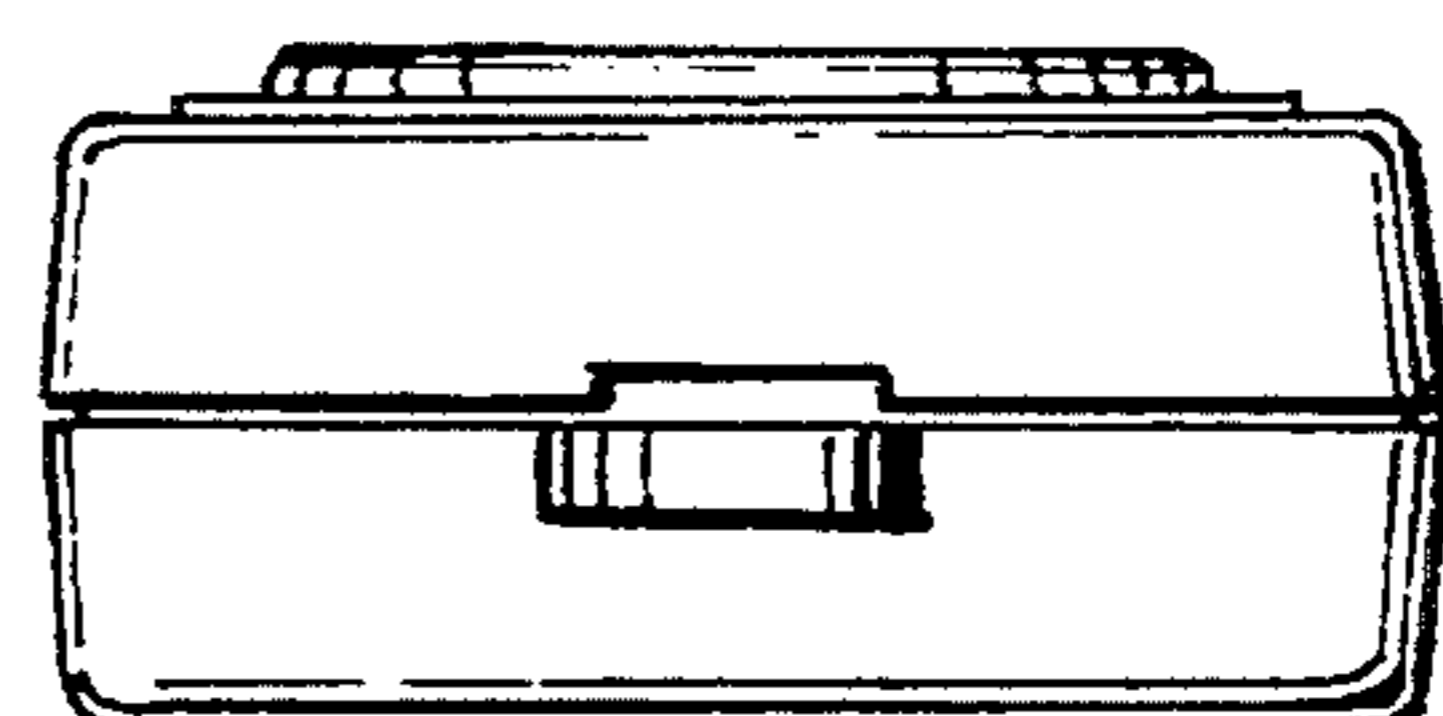

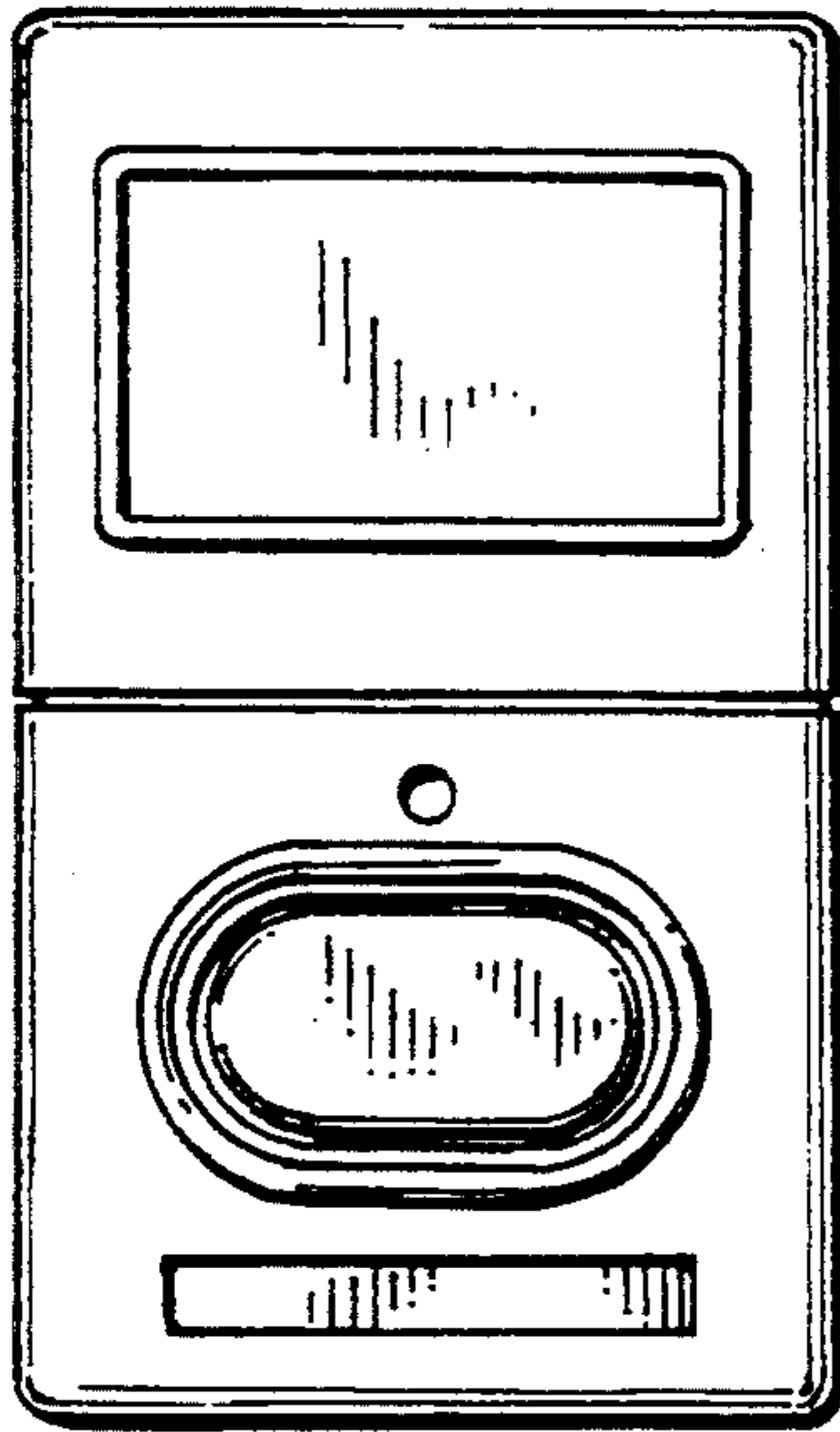

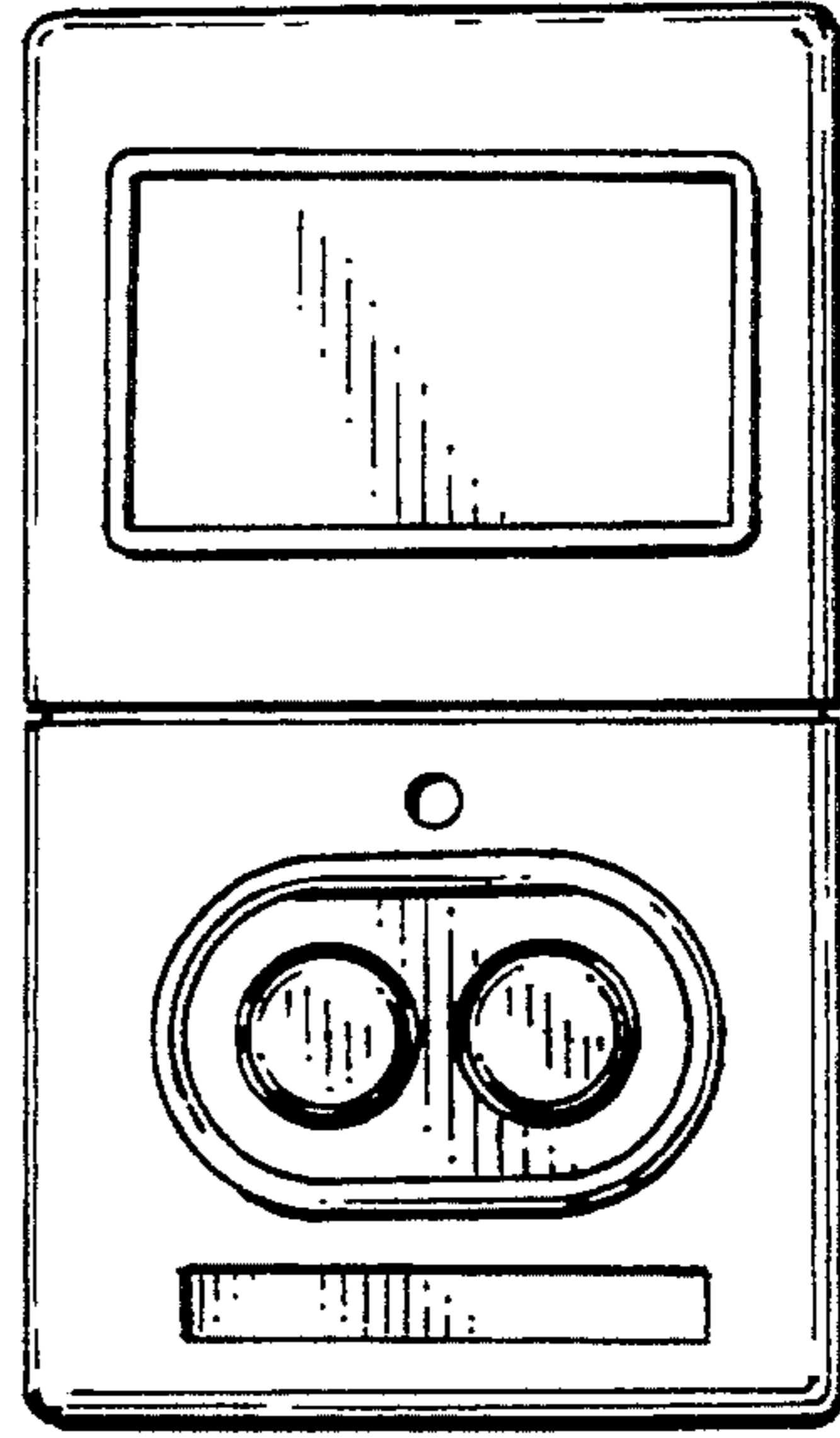

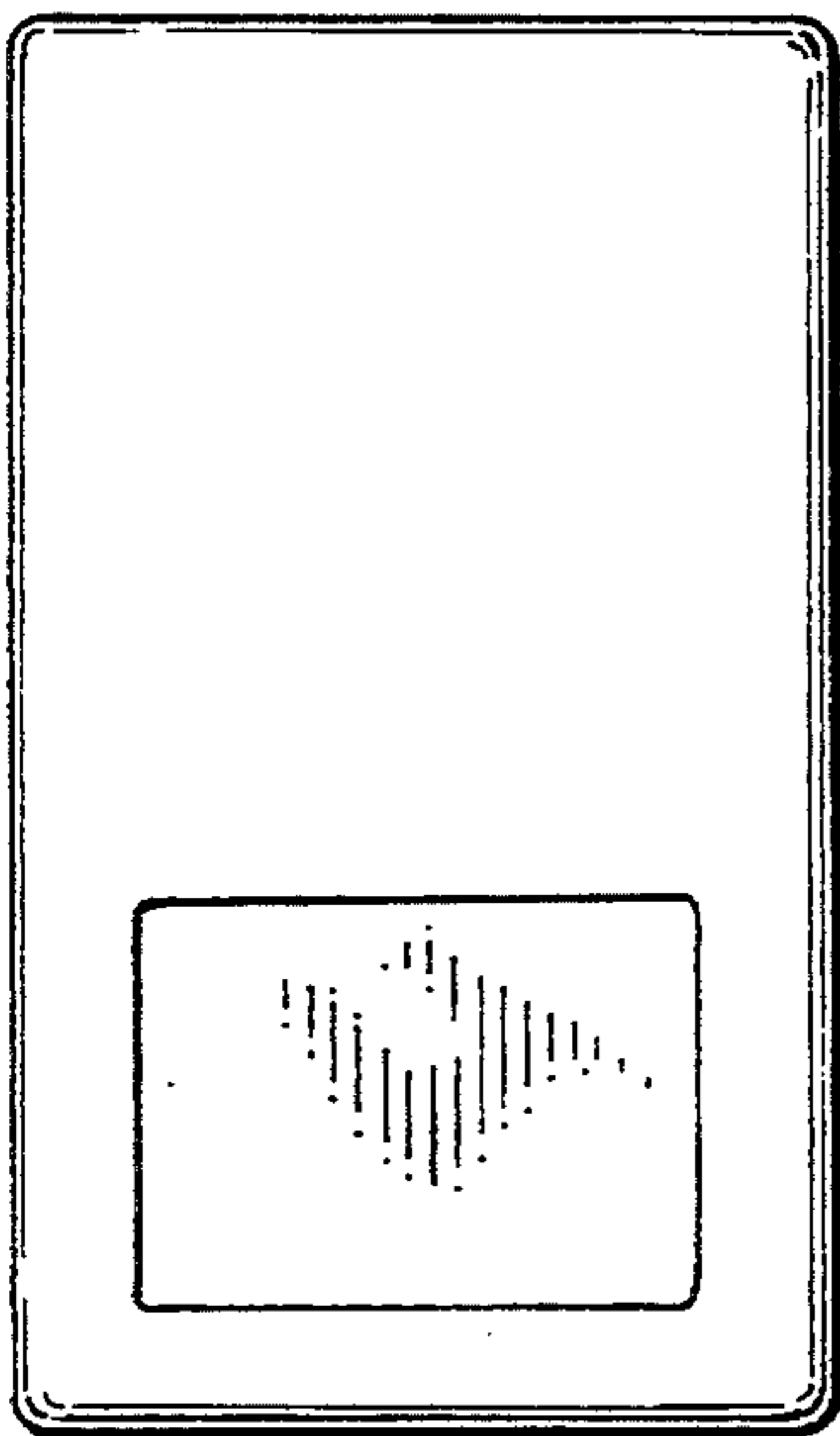

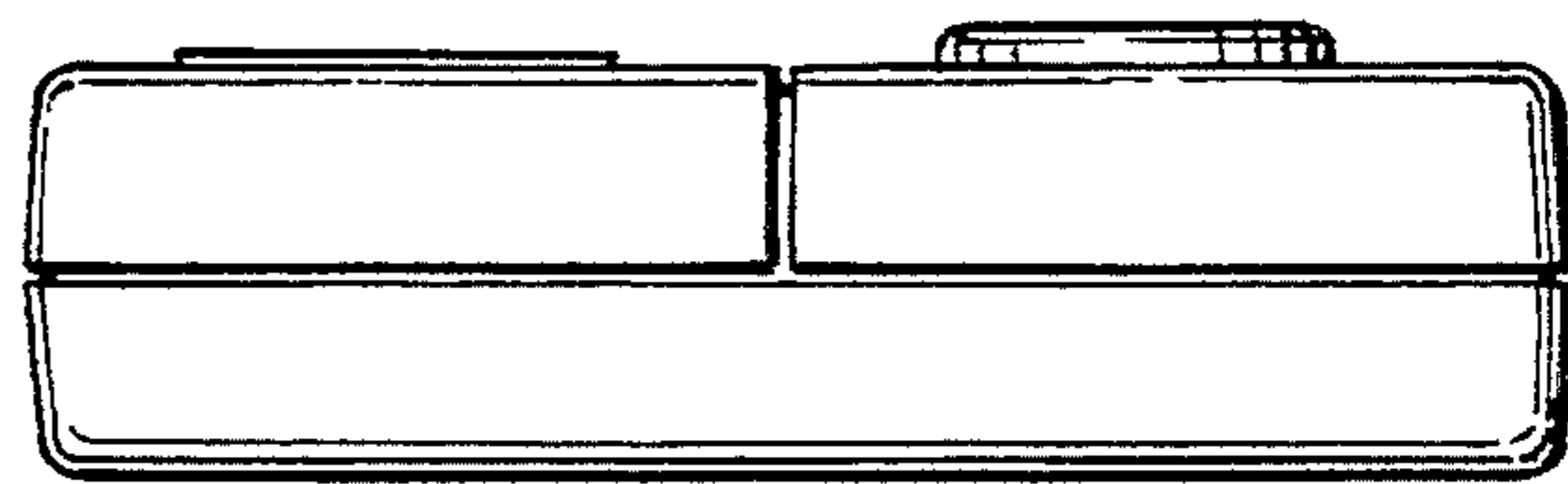

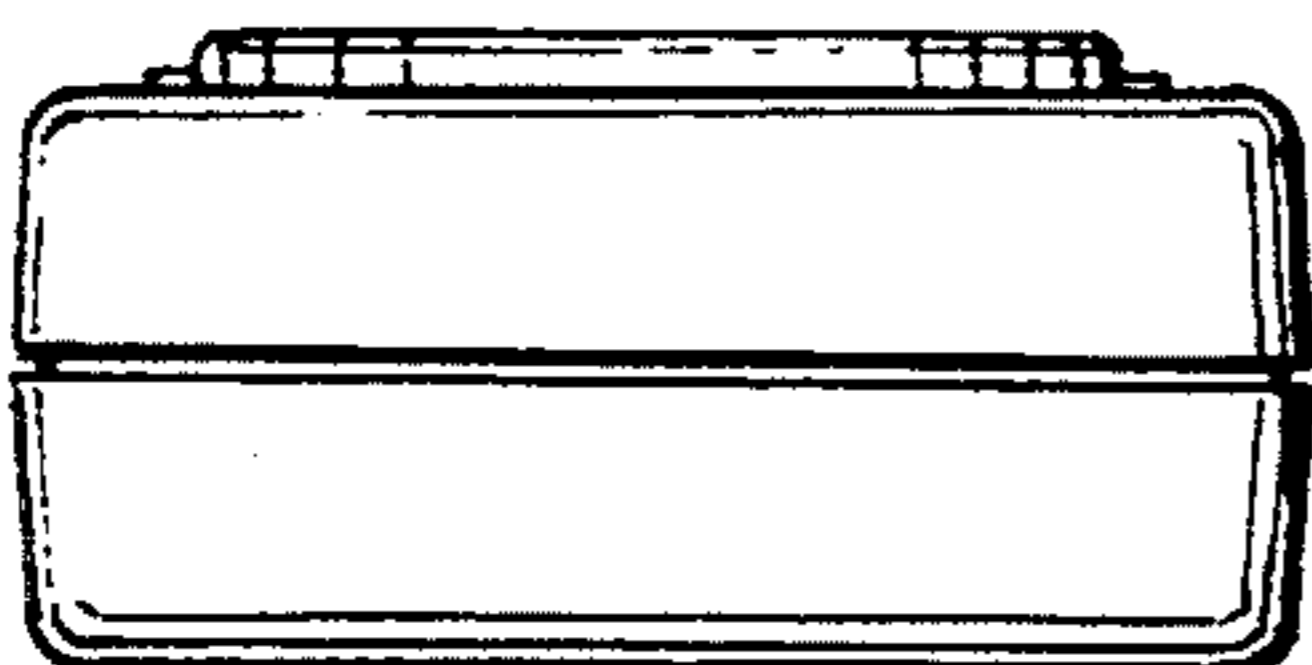

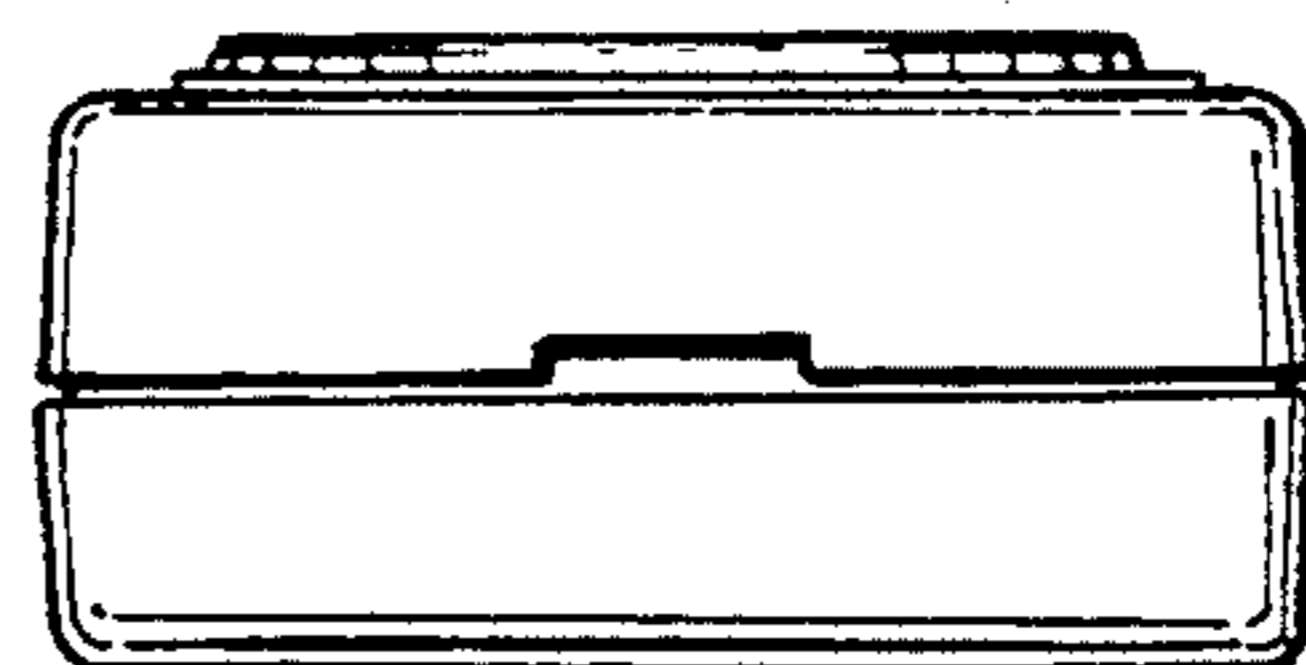
