[57] **CLAIM**

The ornamental design for a handheld vacuum cleaner, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right, top perspective view of a handheld vacuum cleaner, showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a rear elevational view thereof; and, FIG. 7 is a bottom plan view thereof. The cross hatch shading shown in FIGS. 1-7 is understood to repeat throughout the indicated areas. The broken line showing of a power cord is for illustrative purposes only and forms no part of the claimed design.

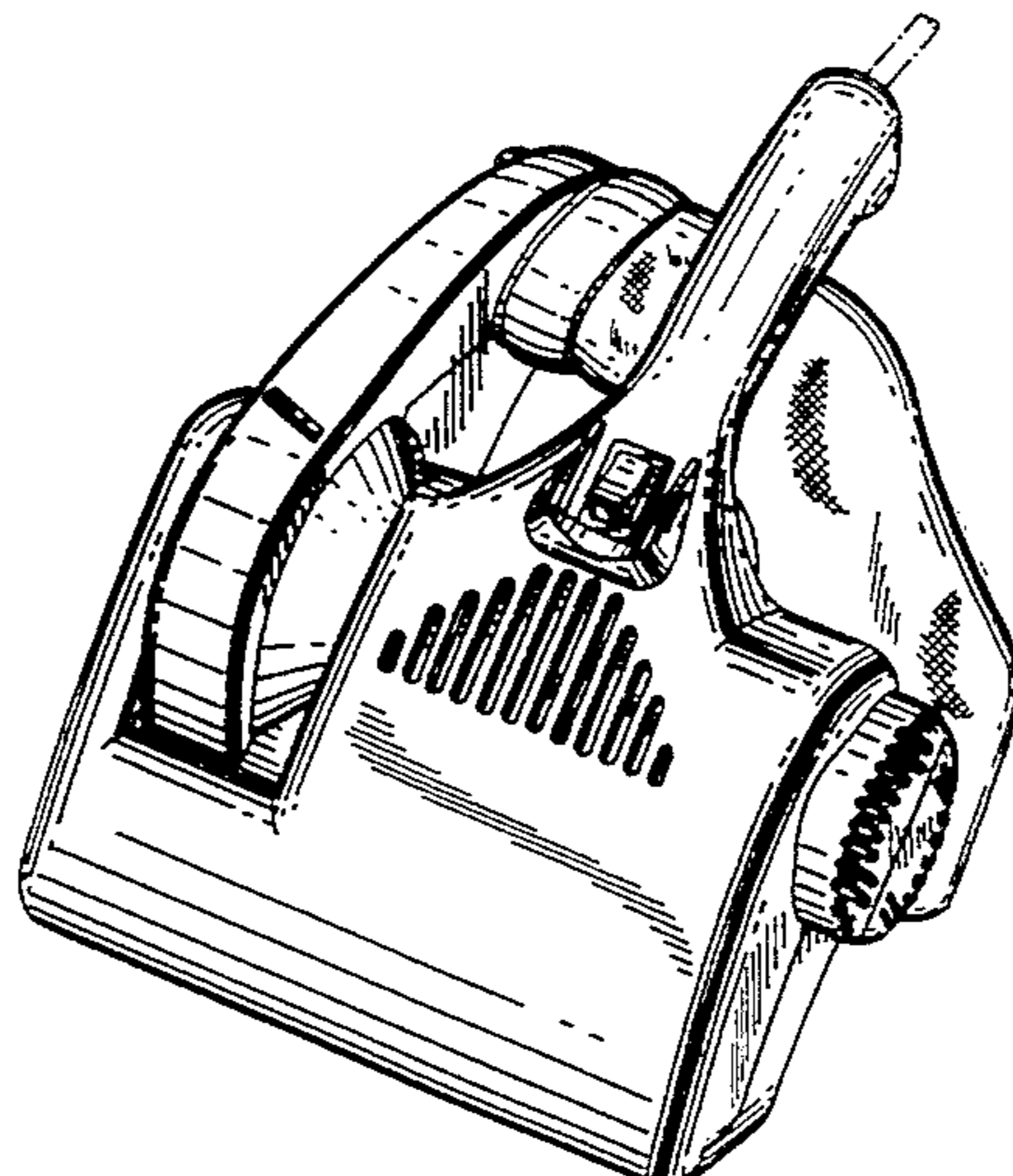

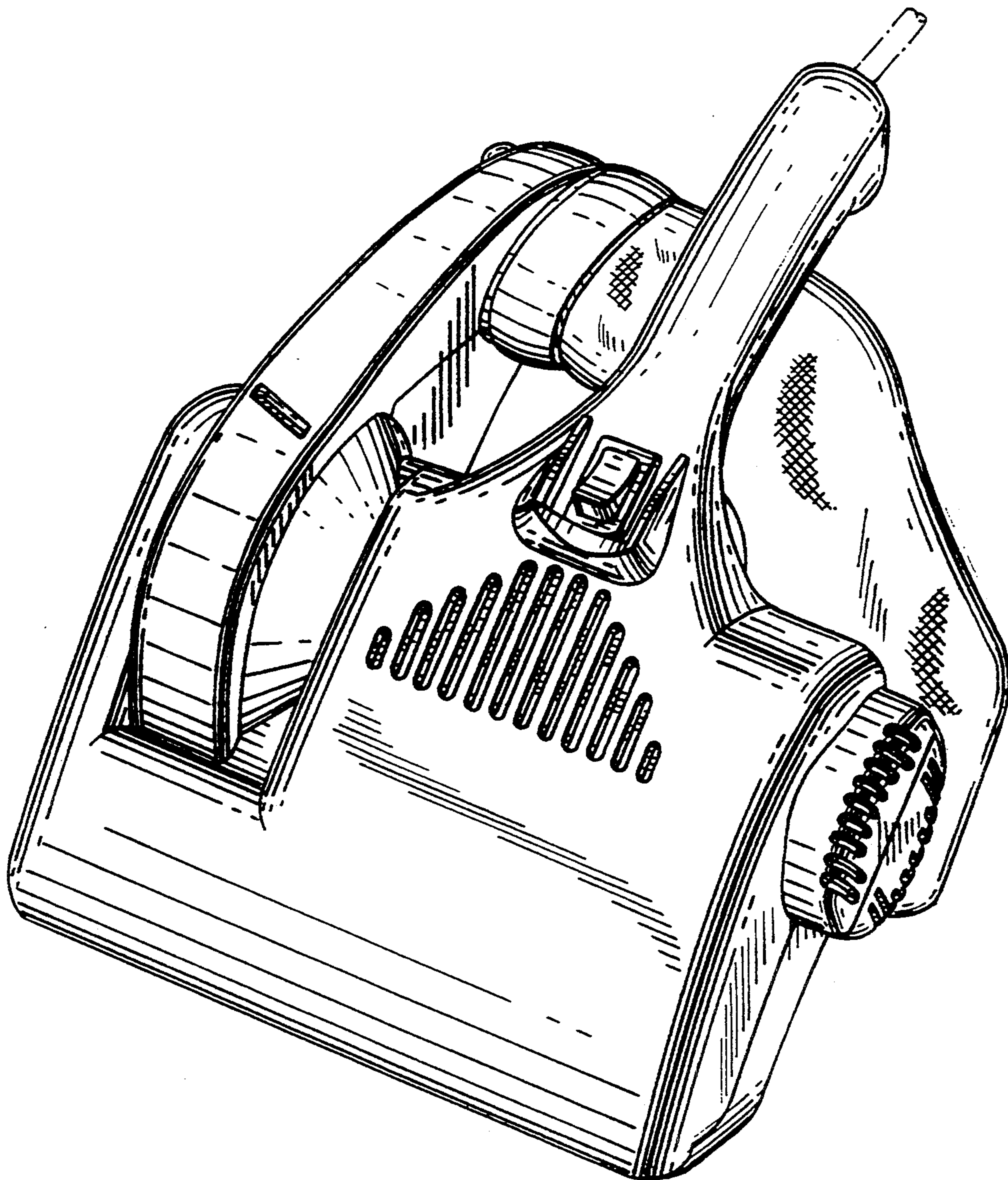
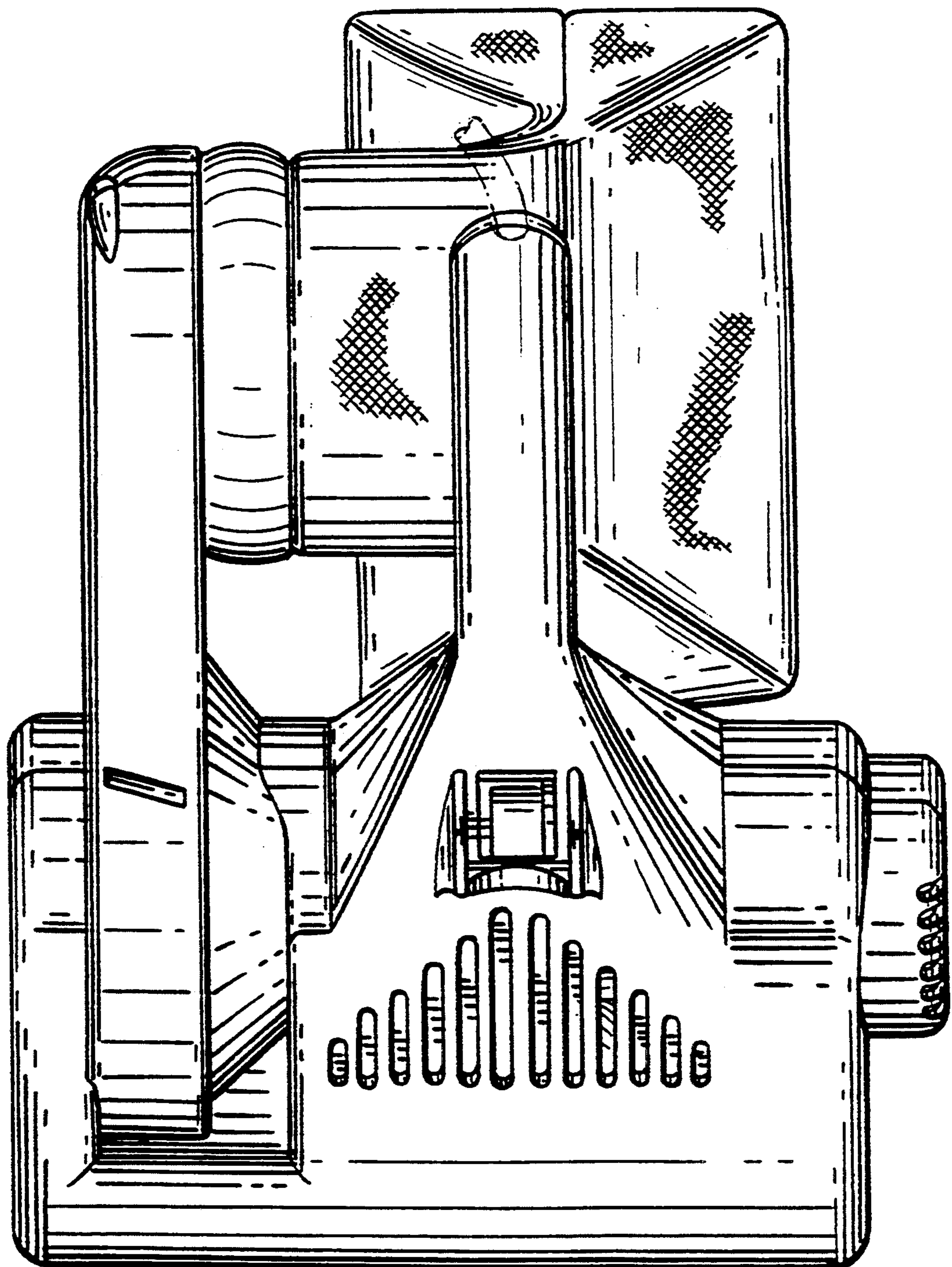

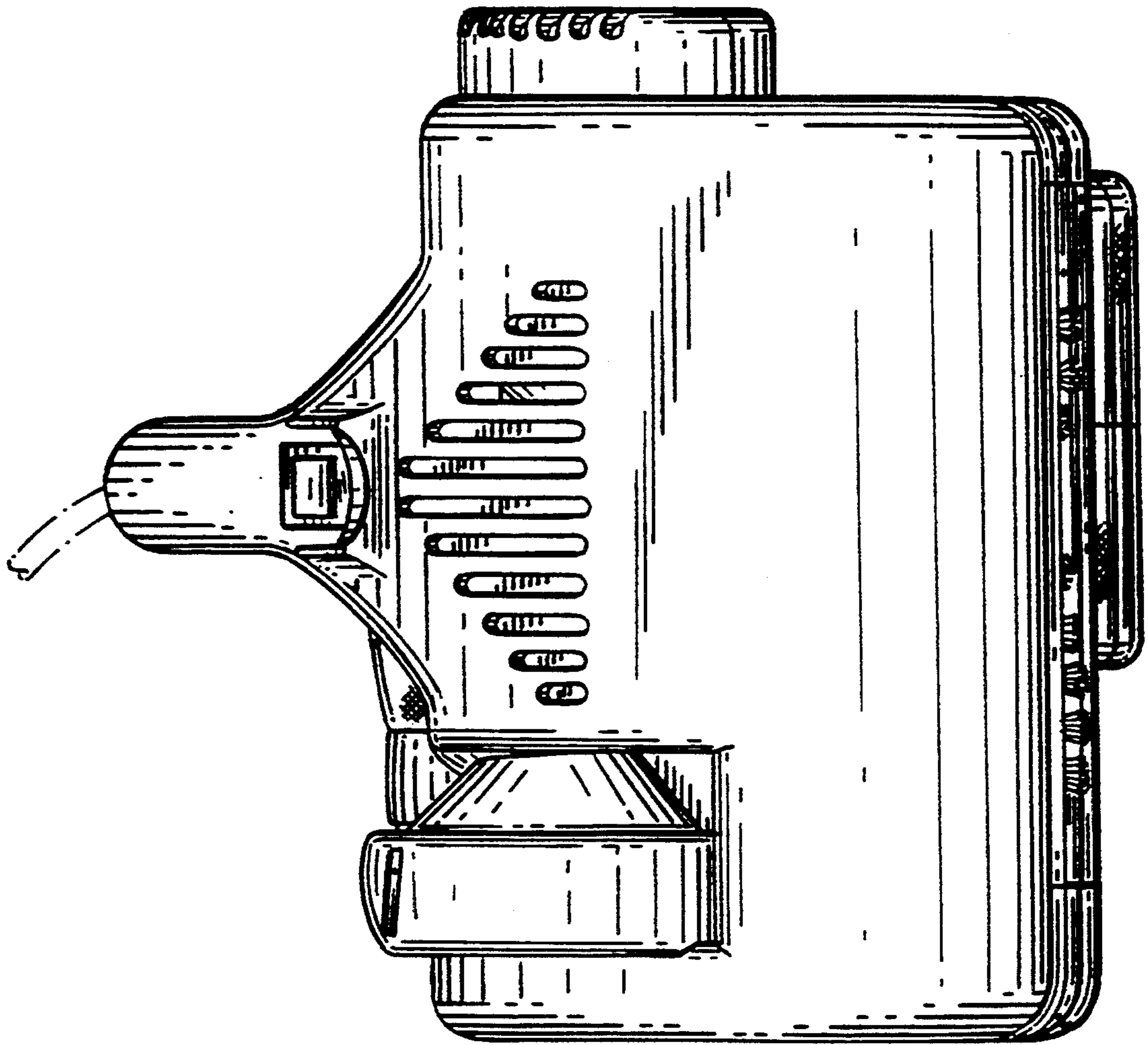
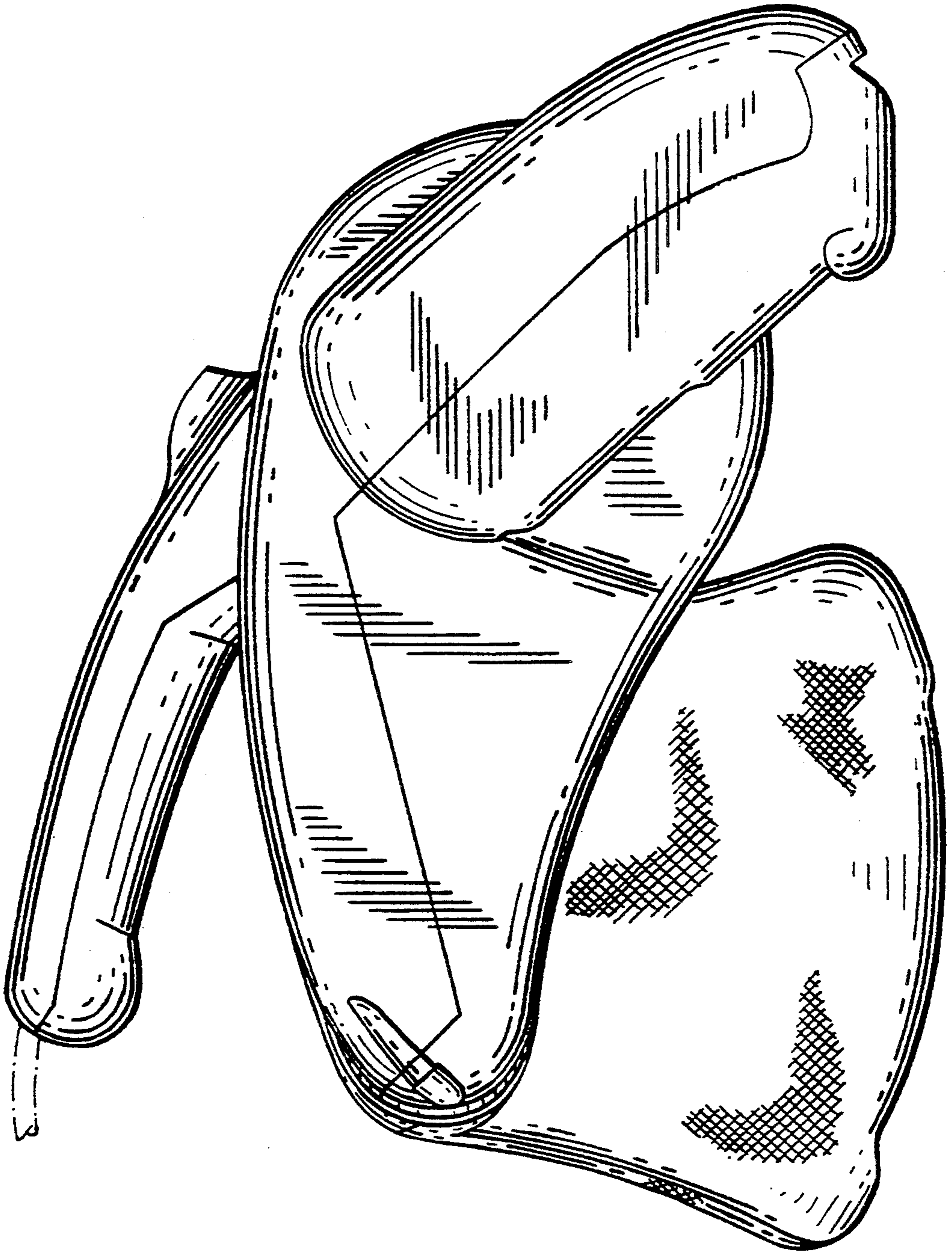

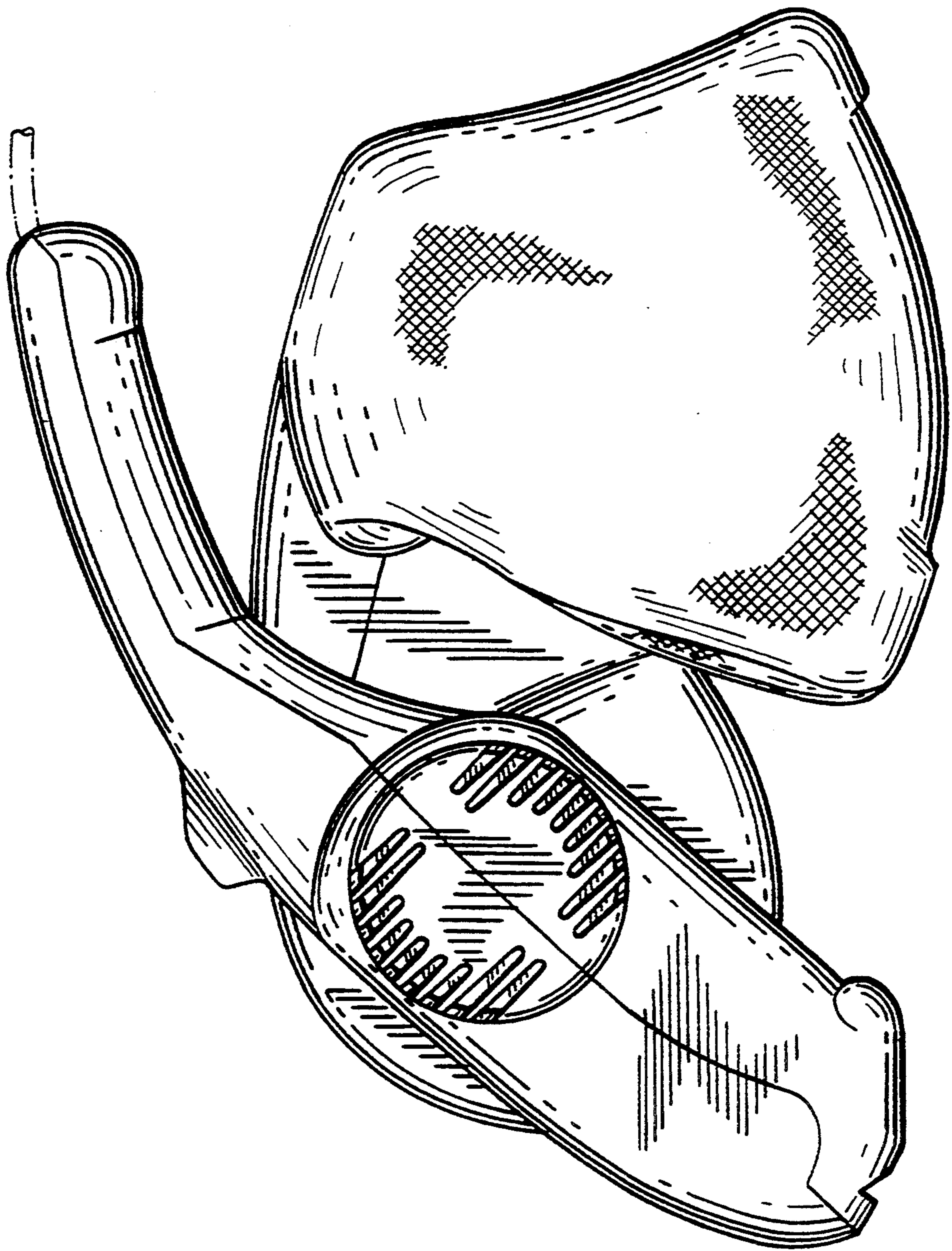

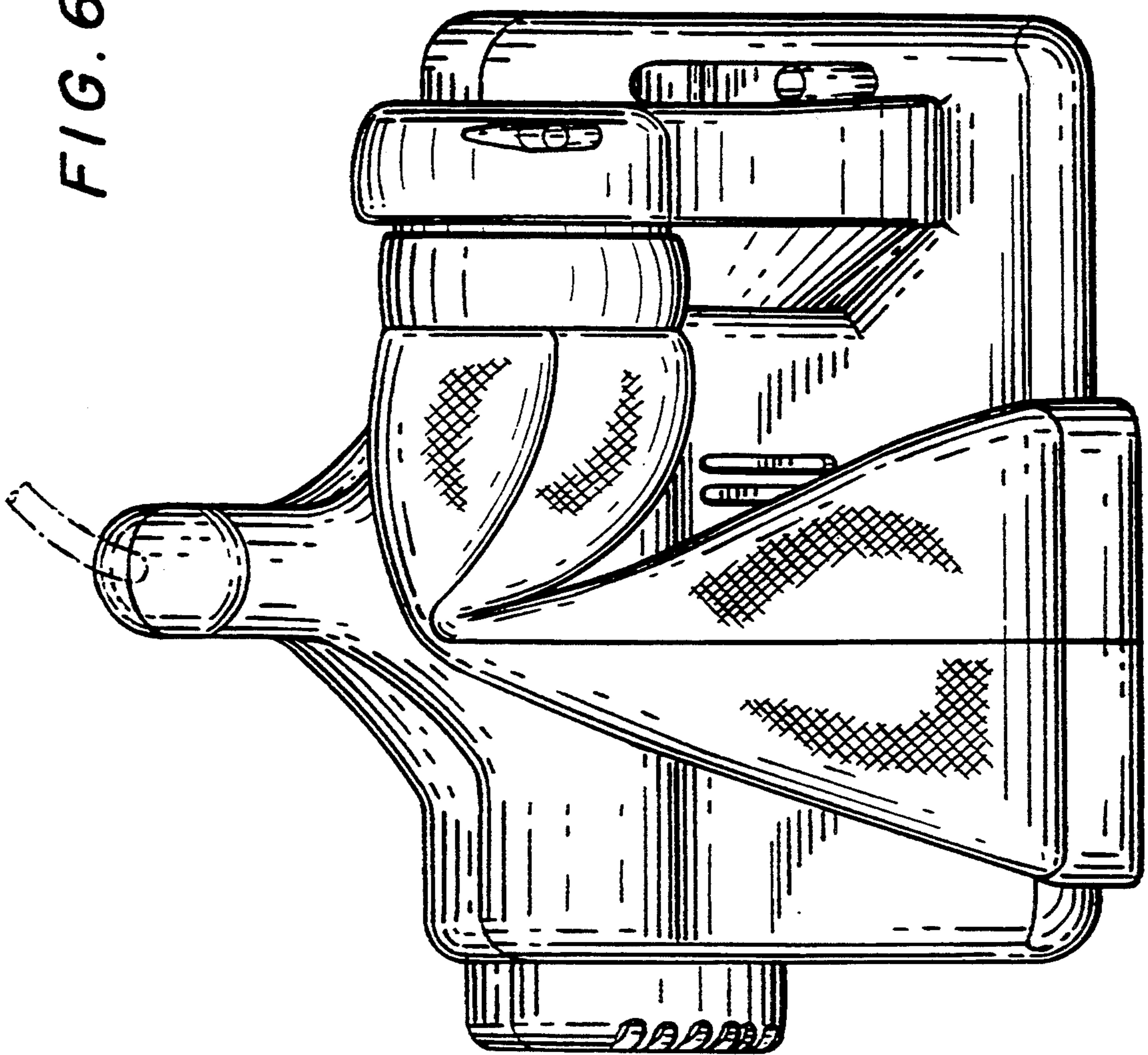
