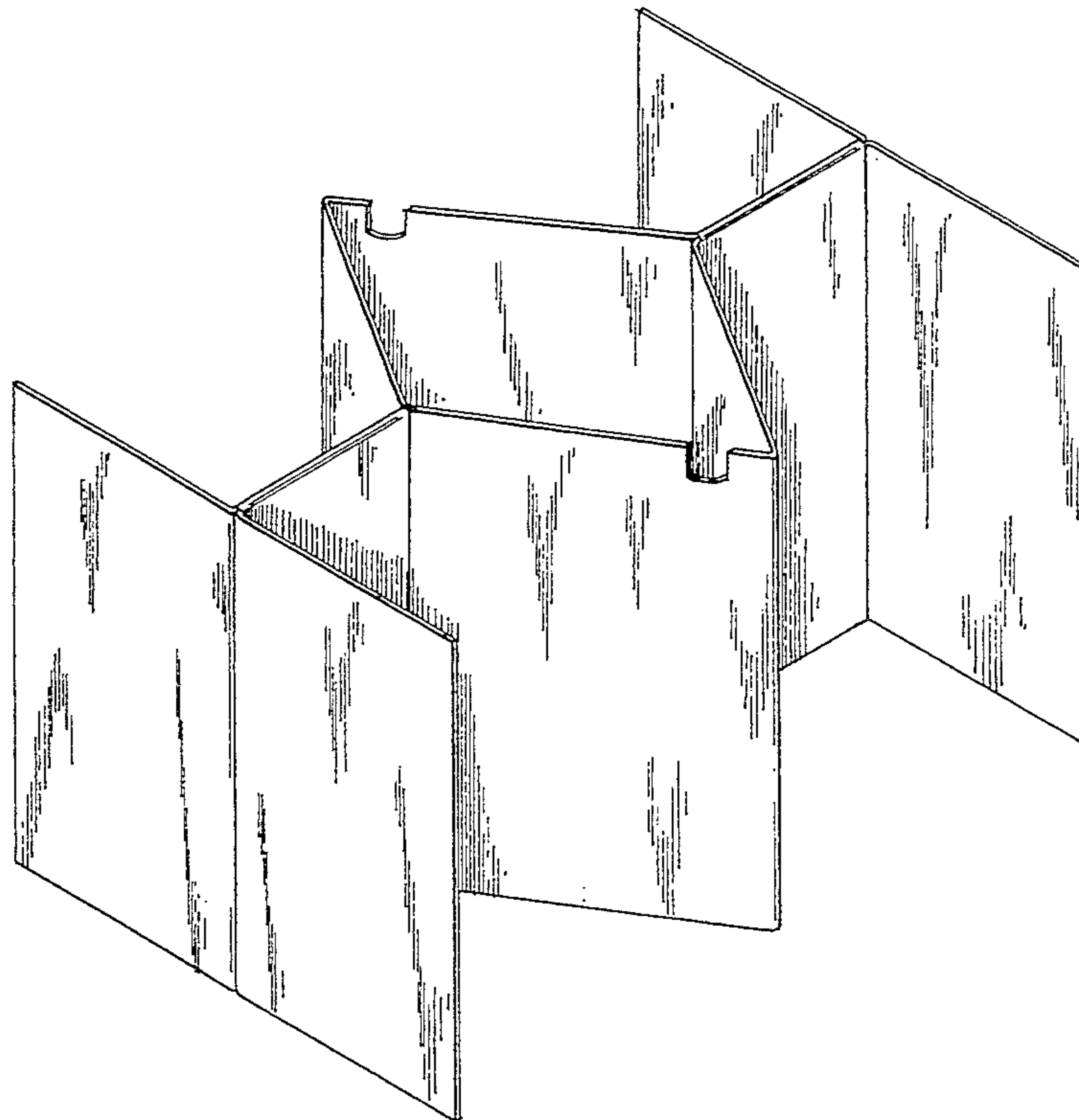

[57] **CLAIM**

The ornamental design for a carton partition unit, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a carton partition unit showing my new design; FIG. 2 is an end elevation view, both end elevation views being identical; FIG. 3 is a side elevation view, both side elevation views being identical; and, FIG. 4 is a bottom plan view.



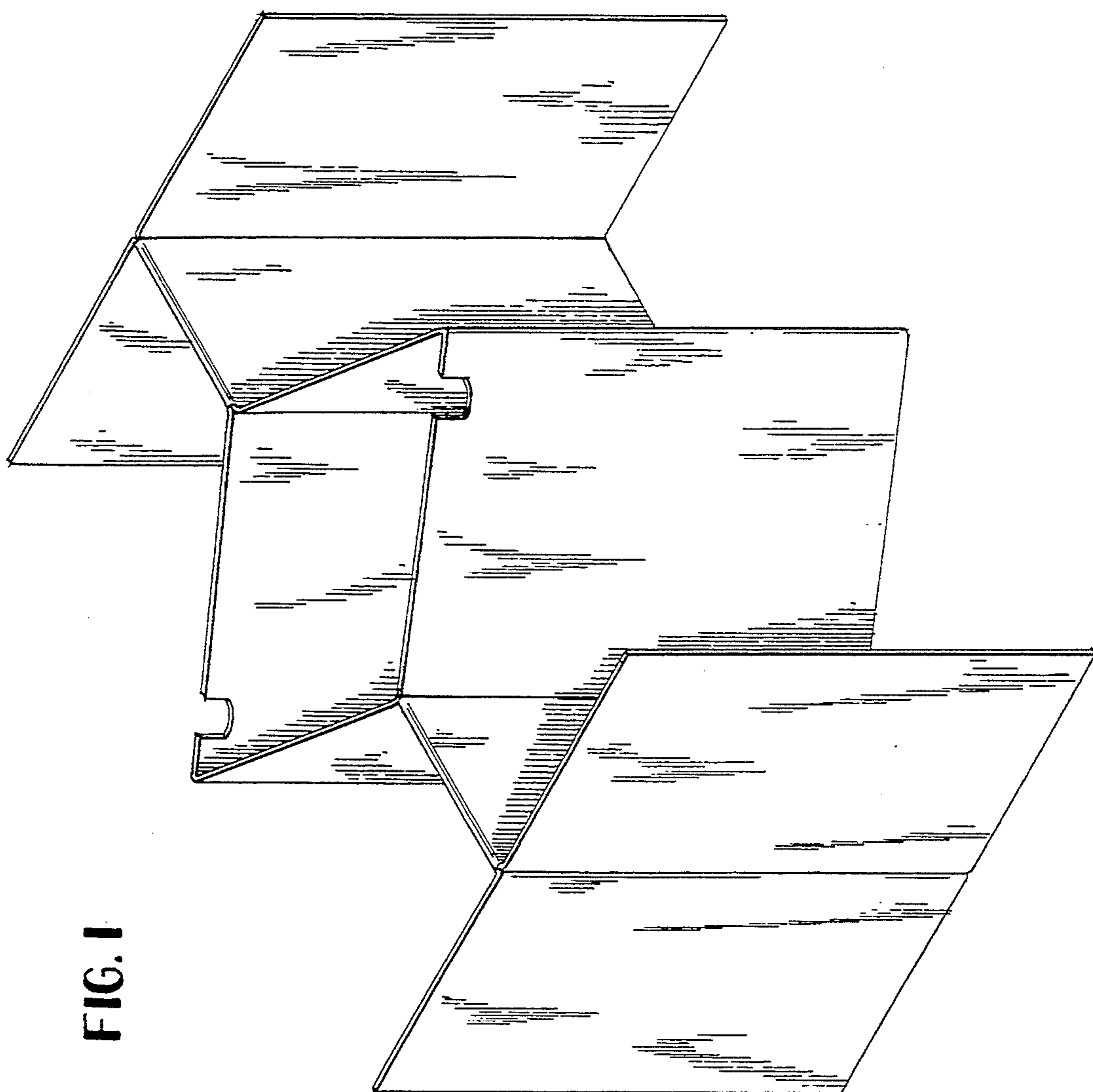

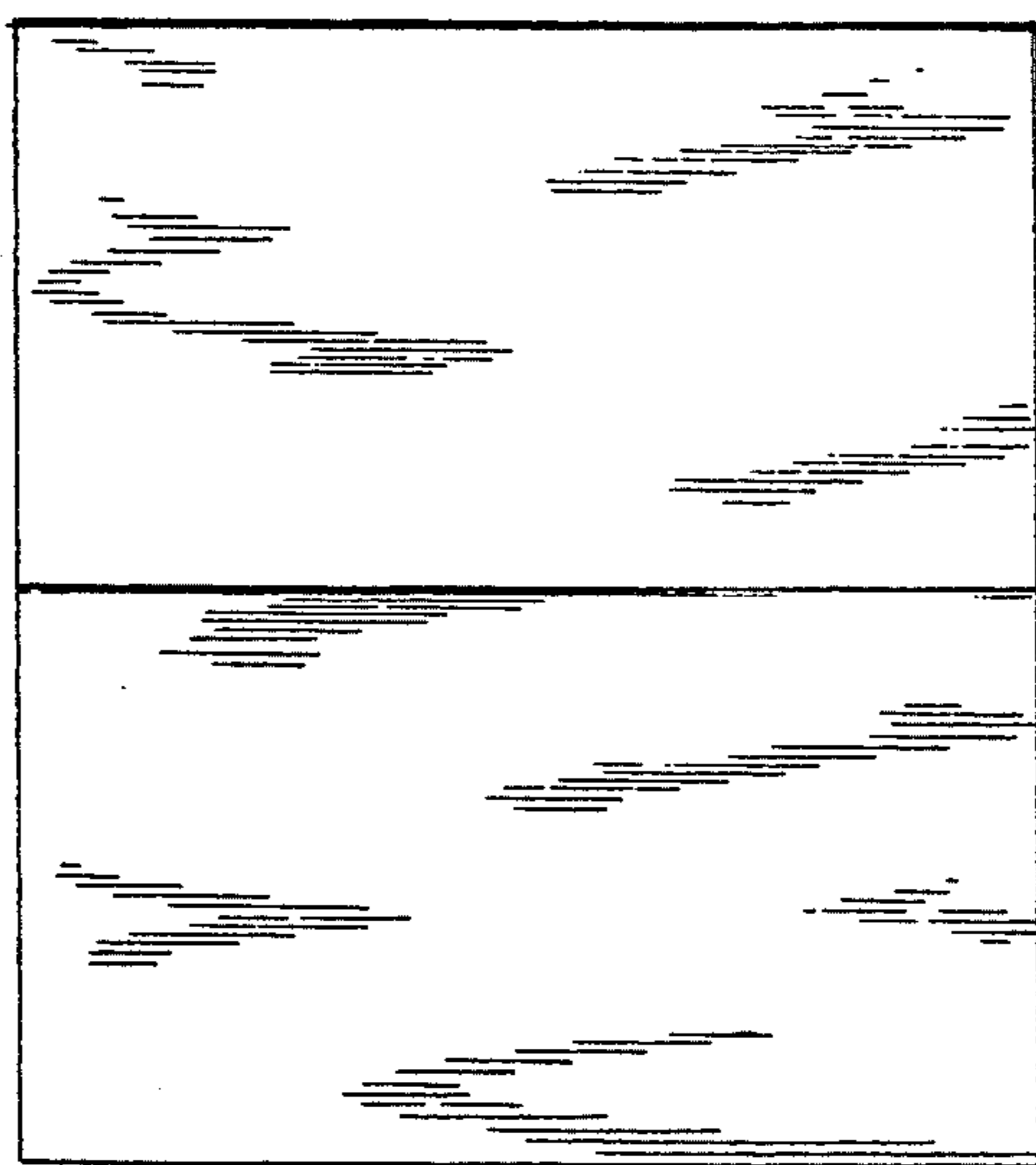

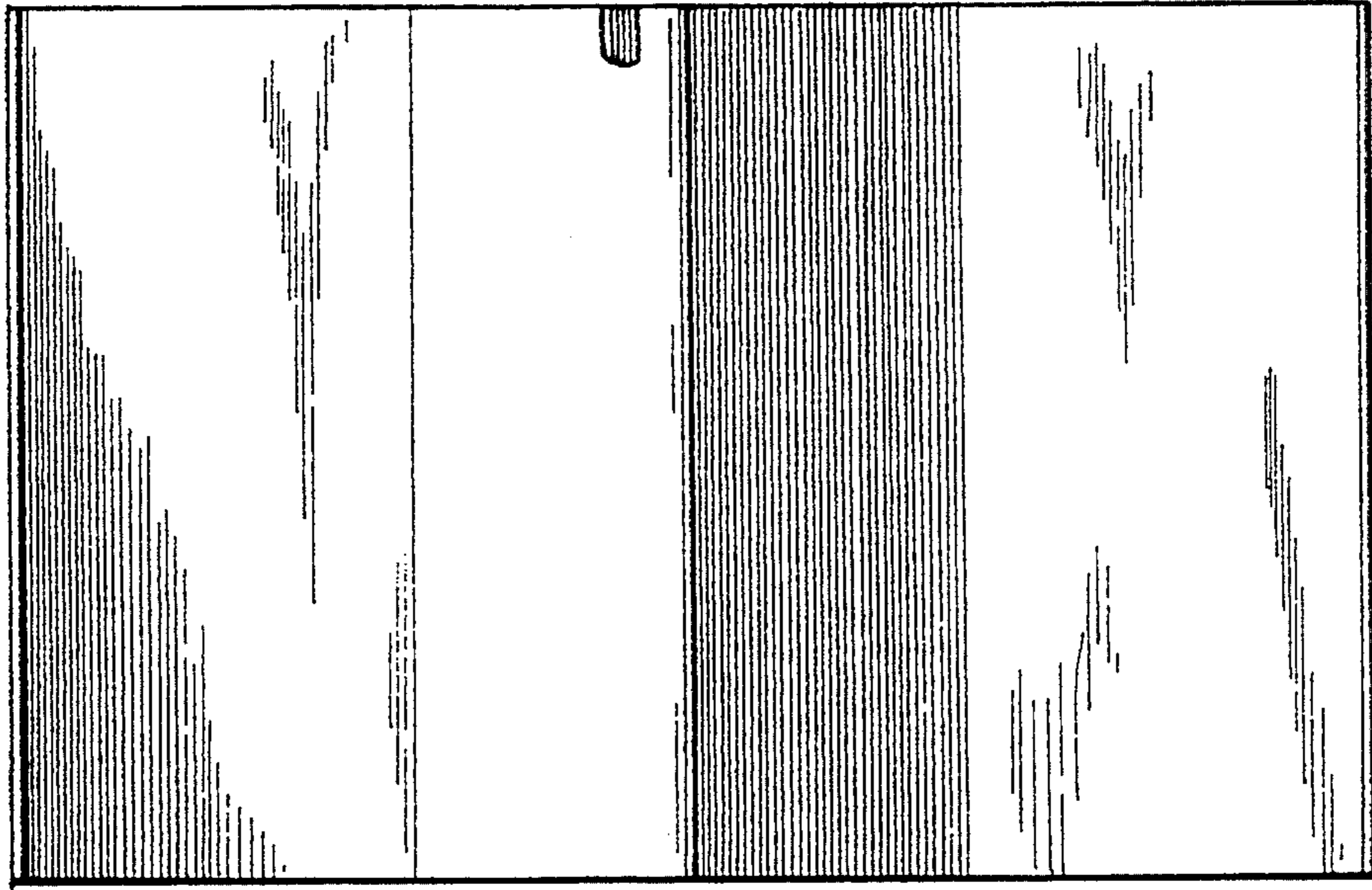

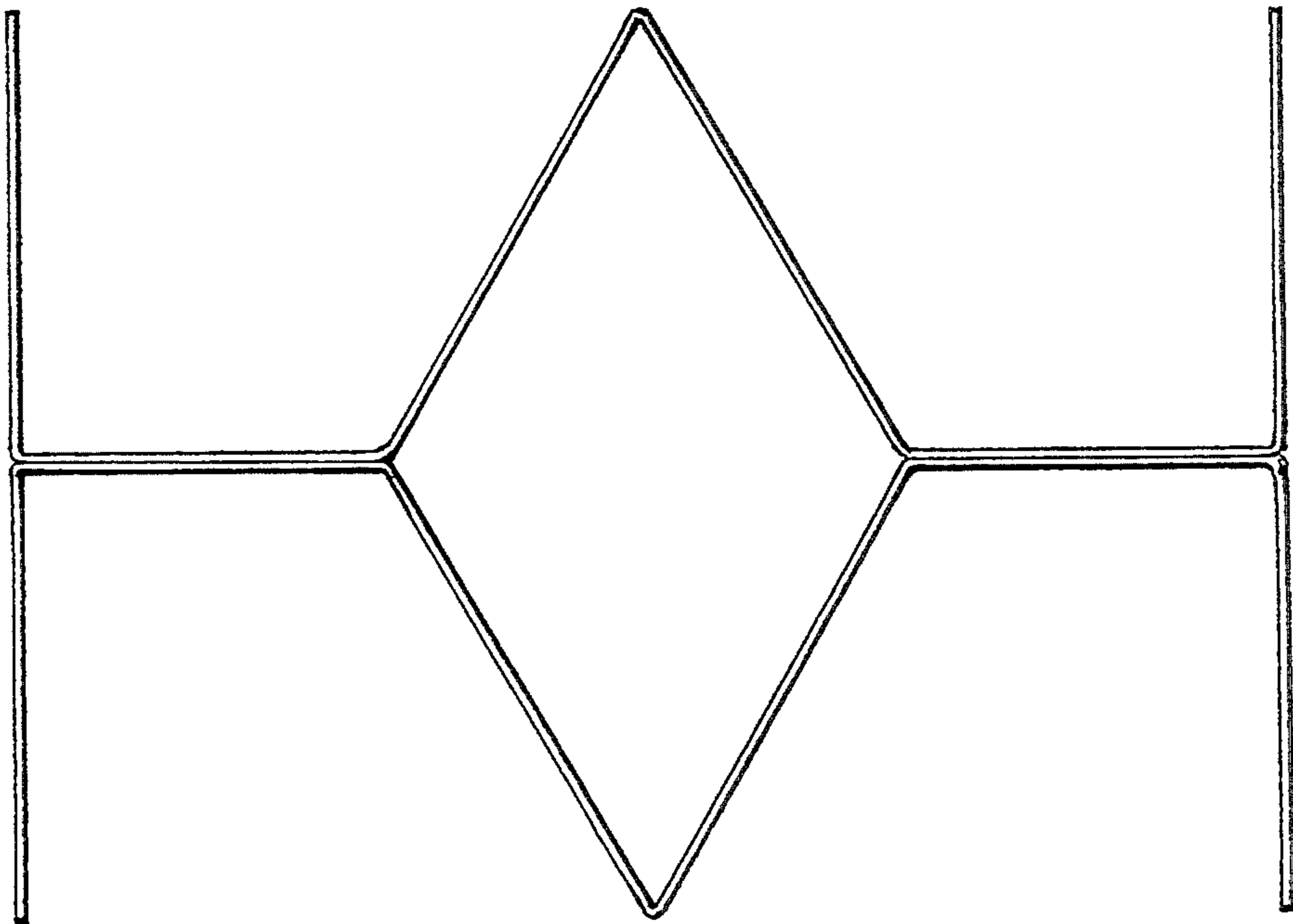
